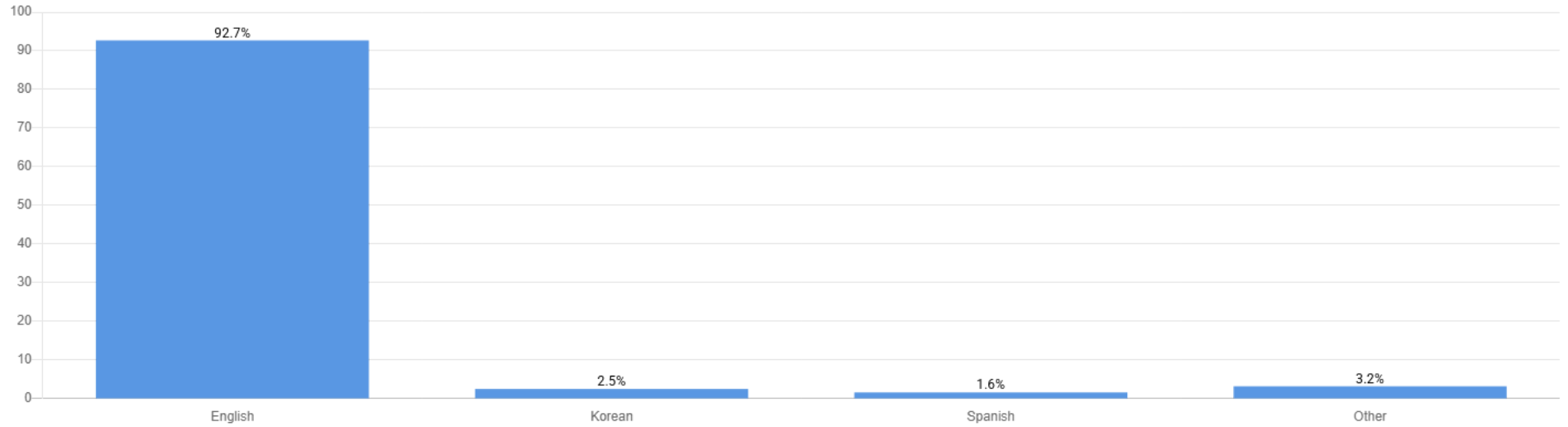

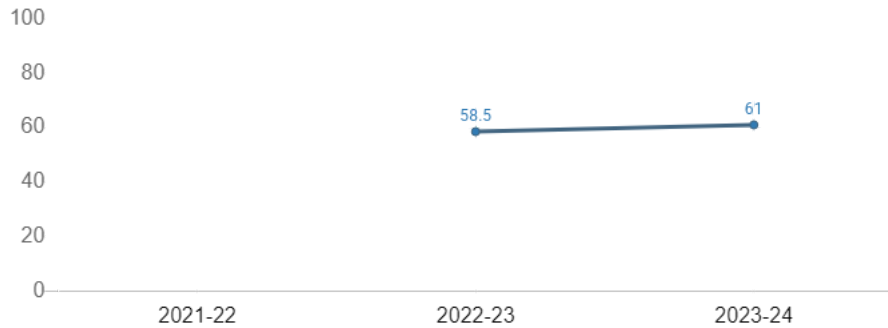

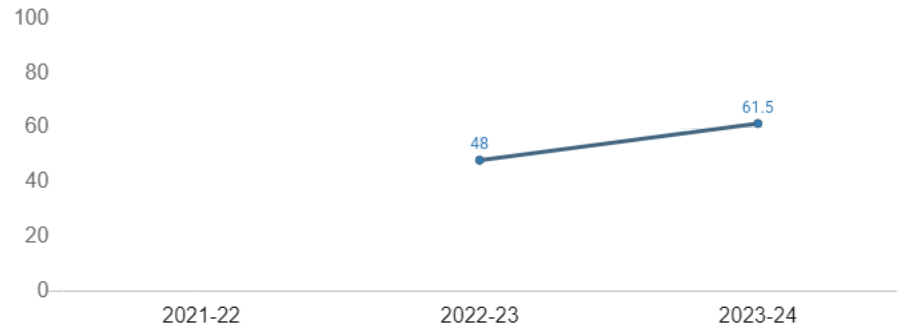

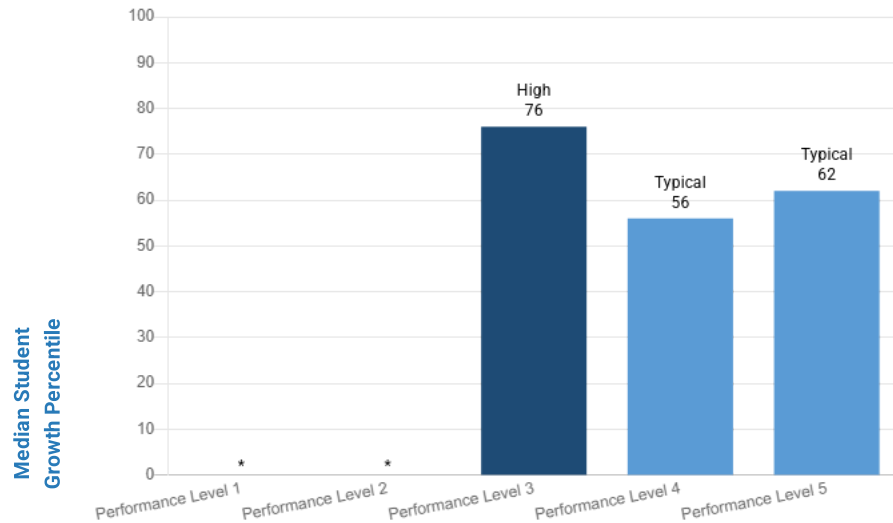

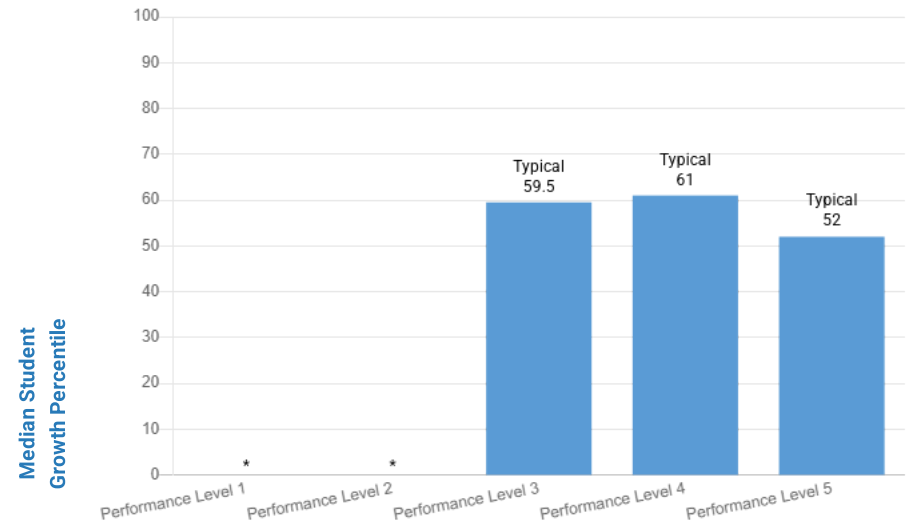

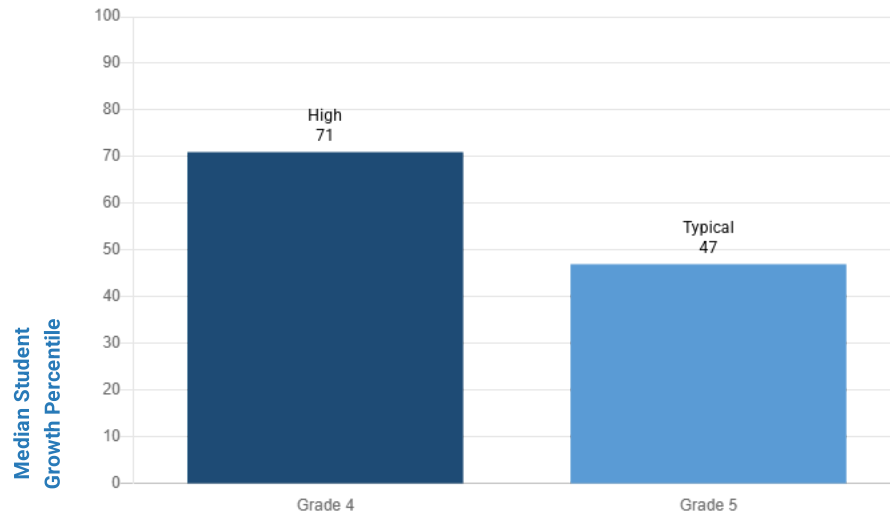

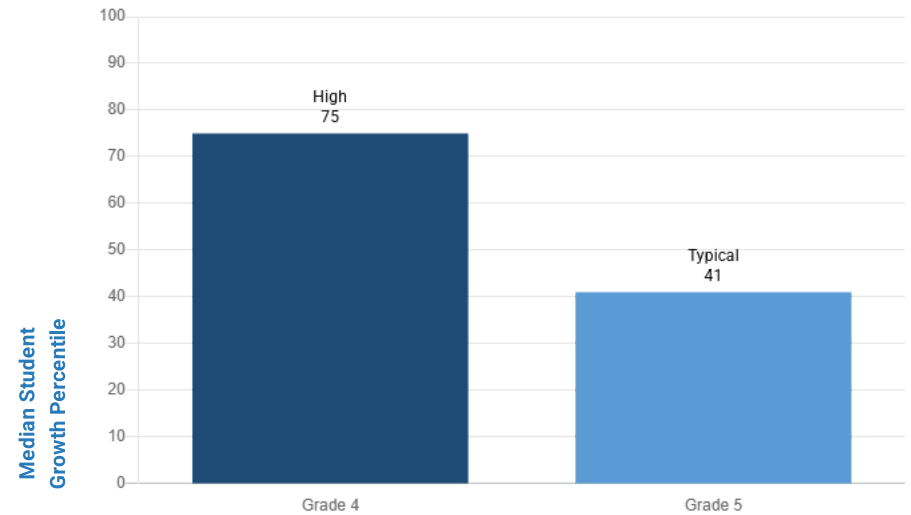

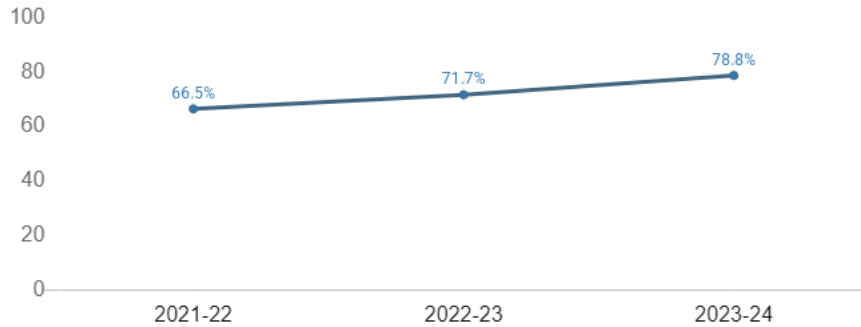

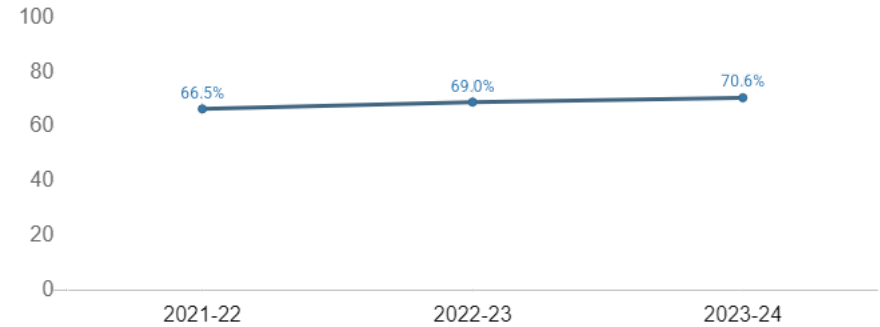
English Language Arts and Mathematics Performance Trends

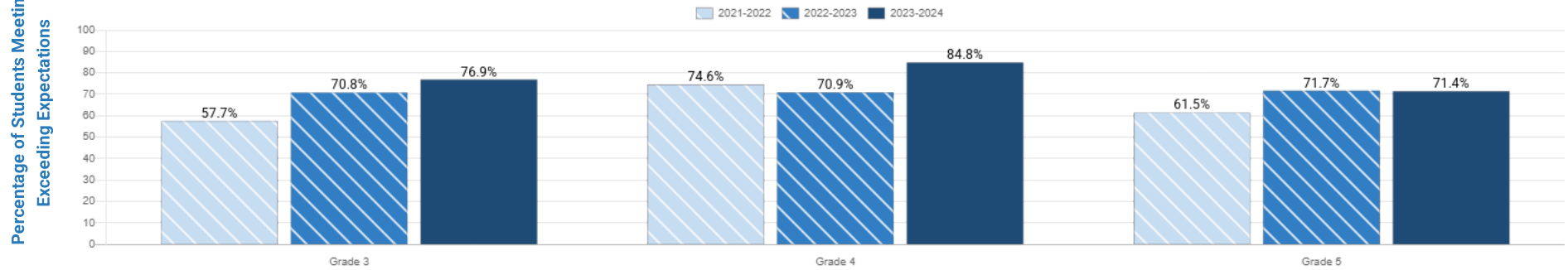

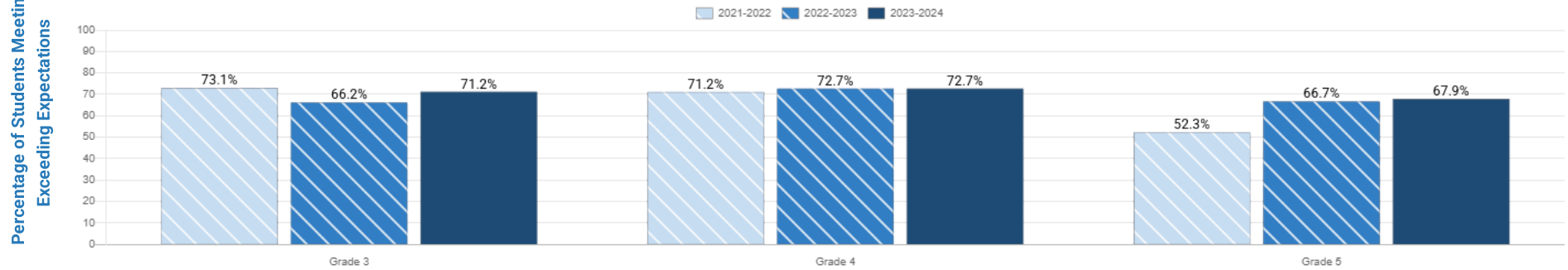

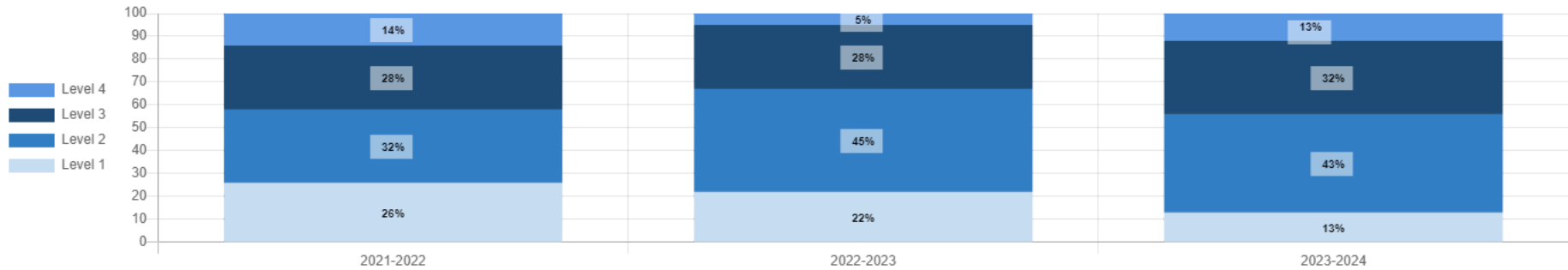

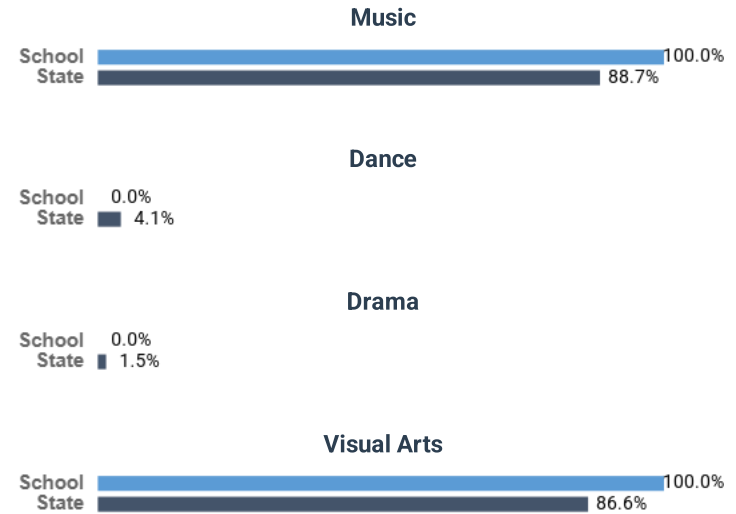

Students enrolled in one or more classes by discipline:



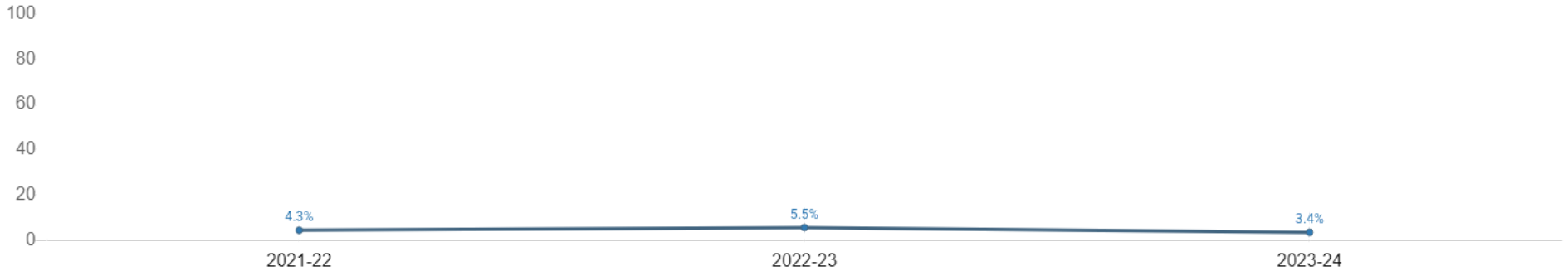

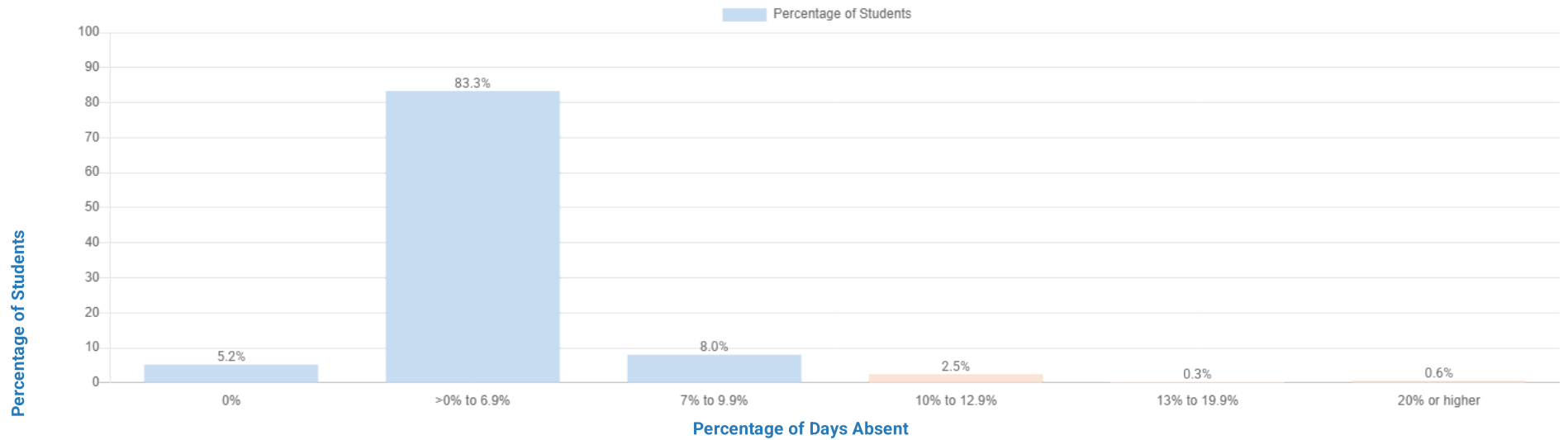

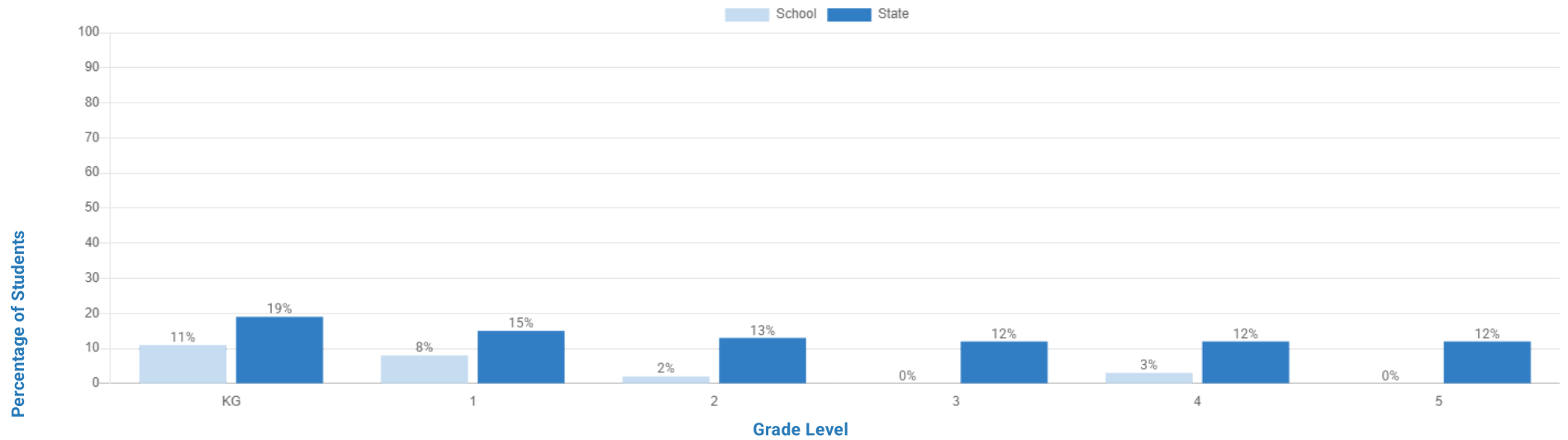

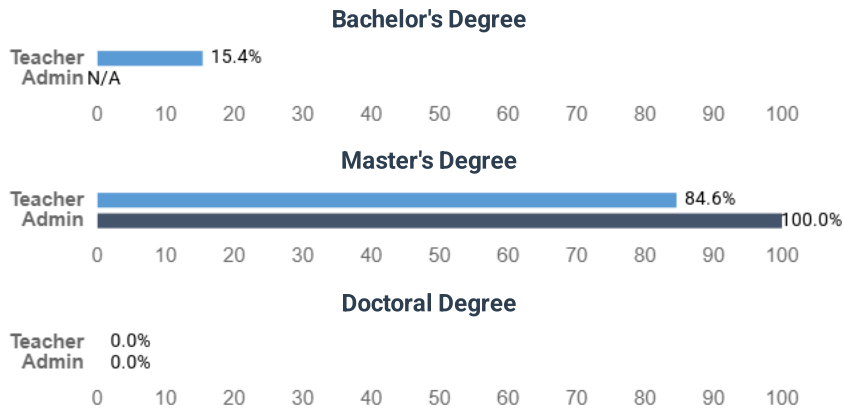

Courses, Curriculum, Instruction:

The River Vale School District prioritizes delivering a high-quality educational experience. Recent revisions to curricular documents in subjects like health, physical education, social studies, and science have been undertaken. Ongoing efforts include updating math and English Language Arts (ELA) curricula to align with current educational standards. Collaboration with consultants and the curriculum supervisor ensures continuous analysis and updates to maintain a robust and up-to-date curriculum. To support tiered 2 education, we've expanded course offerings and introduced new middle school classes. Additionally, Data-Driven Instructional periods at all schools enable tailored instruction based on individual student needs, using various data points. These initiatives underscore our commitment to effective, data-informed instruction, fostering student success and growth.



Clubs and Activities:

Students benefit from participation in a vast array of extracurricular programs including an art show, continental math club, intramurals, music concerts, student ambassador program, sign language club, W.H.O. Club, newspaper club, fitness and mindfulness clubs, garden club, STEM and Enrichment opportunities.



Before and After School Programs:

The PTA sponsors an aftercare enrichment program, and our River Vale Educational Fund sponsors a Robotics program for students, as well as before-school yoga clubs. Our school also offers band and chorus programs for students in grades 4 and 5. The District also has an excellent before- and after-school program sponsored by the River Vale Educational Fund - the A.C.E. Program.

Staff and Professional Learning:

The staff engages in professional learning throughout the year. The District has three professional development days. The school has three faculty meetings per month, which focus on teaching and learning. Woodside hosts professional learning communities focused on curriculum, data, and assessment, fostering collaboration and skill enhancement. Staff can choose from a variety of workshops led by experts, and educational consultants support their classroom efforts.



Student Supports and Services:

The school provides a variety of support to students who require additional help academically, including the Intervention & Referral services (I&RS), supplemental instruction, and supports and services for students with disabilities, as well as English Language Learners. The school also believes in providing differentiated instruction to all students so their learning is personalized to the maximum degree possible.



Student Health and Wellness:

The school uses the Educate 2B mindfulness program. There are several staff members trained in mindfulness, breathing, and yoga to support students. Yoga classes are run before school and incorporated into the daily classroom. In addition, there is a school guidance counselor to assist students and help with conflict resolution and creating a nurturing and safe environment. The school also has implemented the RULER Approach for students, staff and families to assist with recognizing and regulating emotions. For students requiring specialized support, our Child Study Team offers small group and individual counseling. We've also established a partnership with West Bergen Mental Health Care, providing clinical-level therapy on-site and a warmline for staff and parents.
