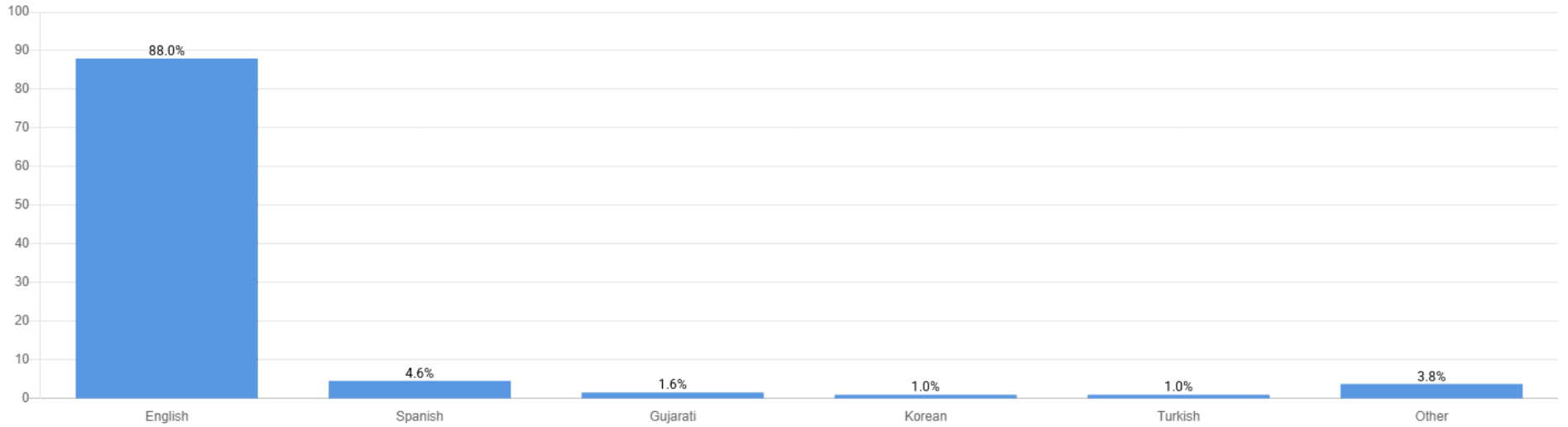

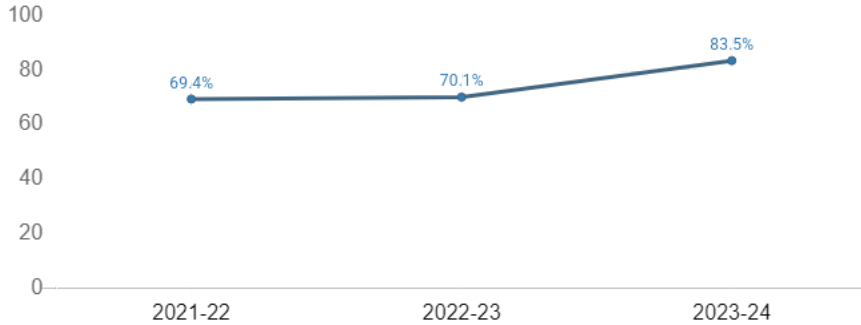

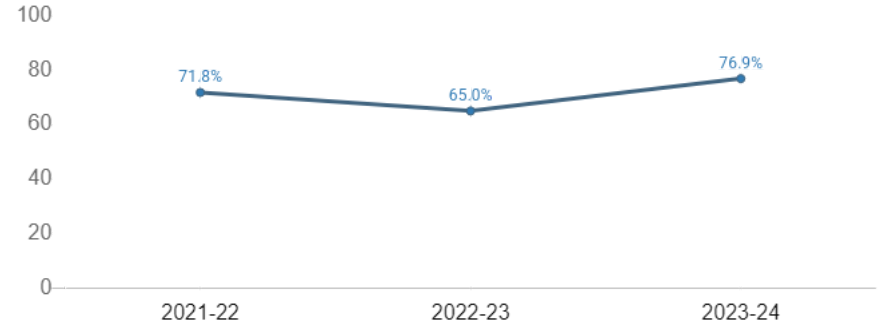
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 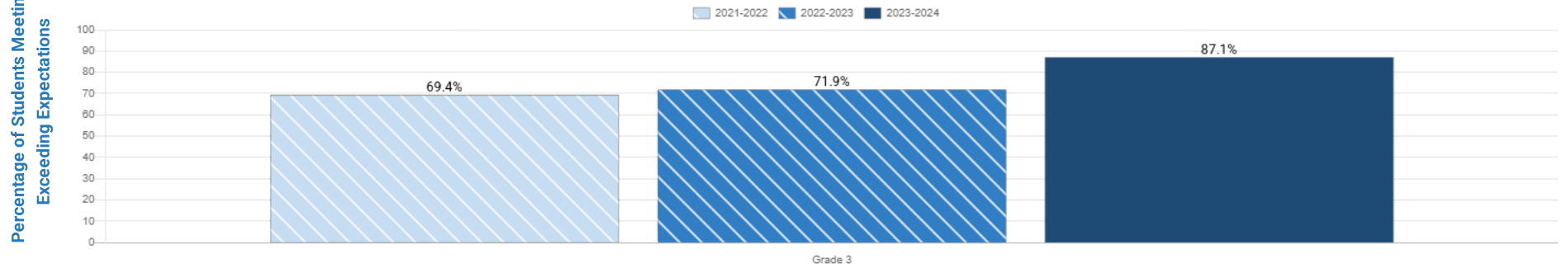

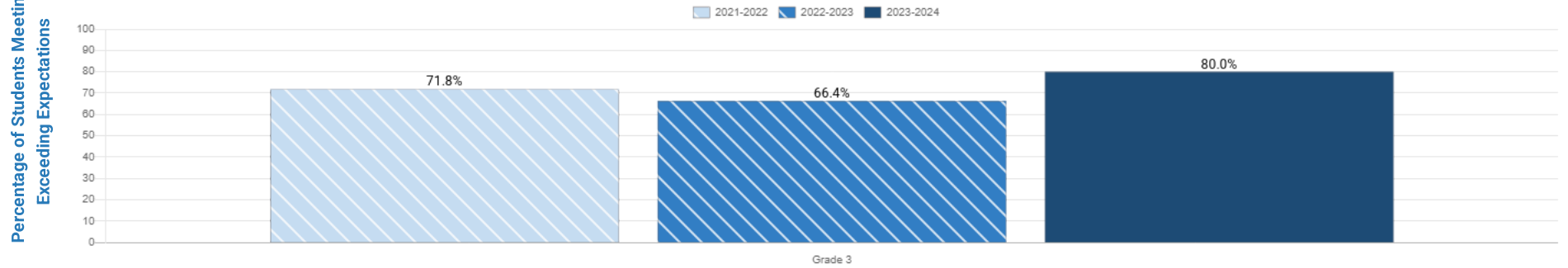

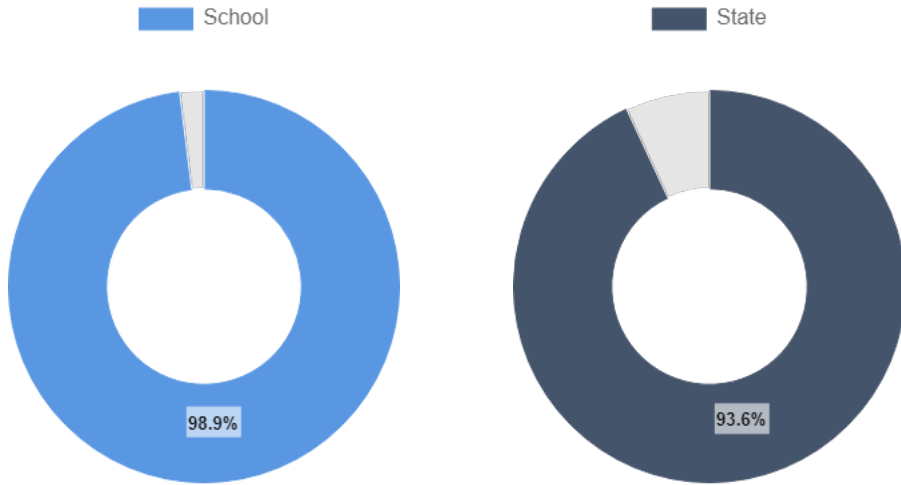

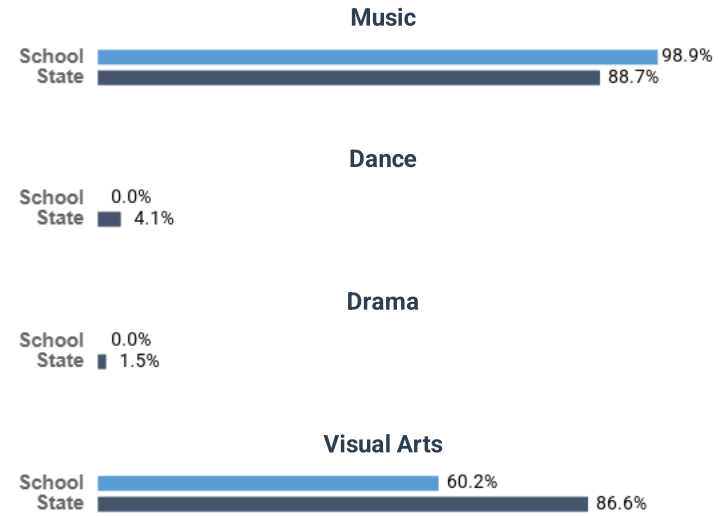

Students enrolled in one or more classes by discipline:



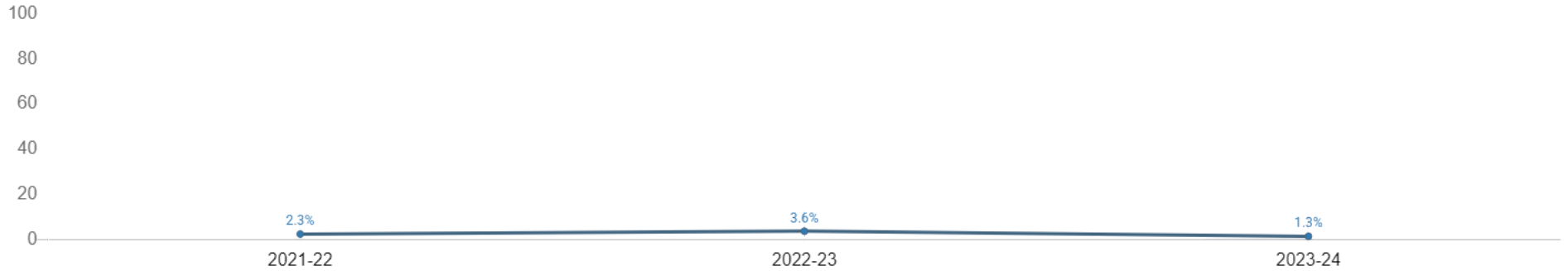

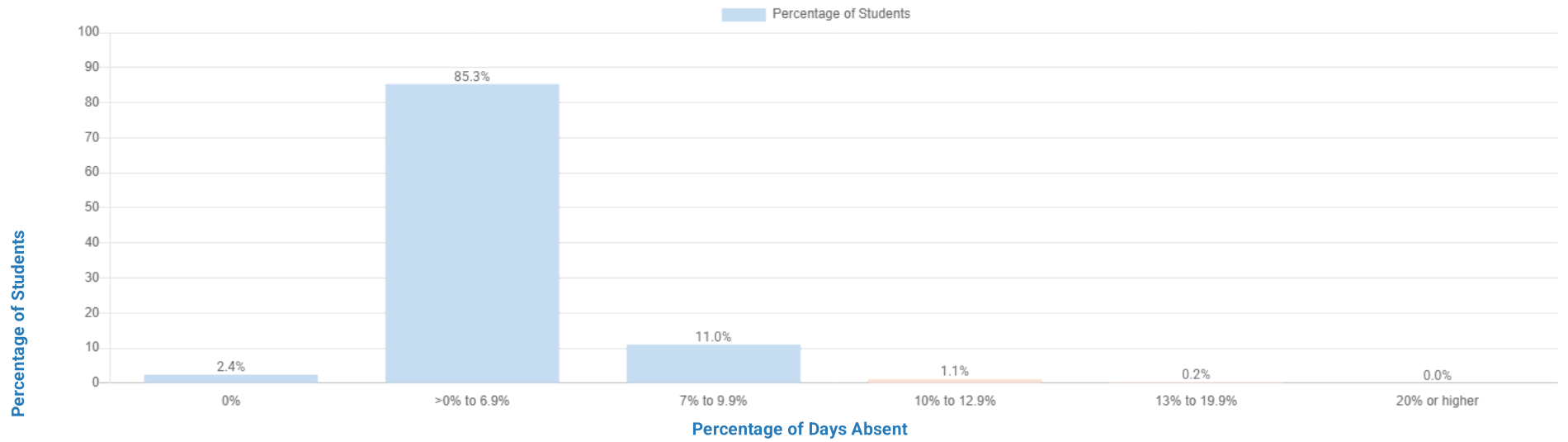

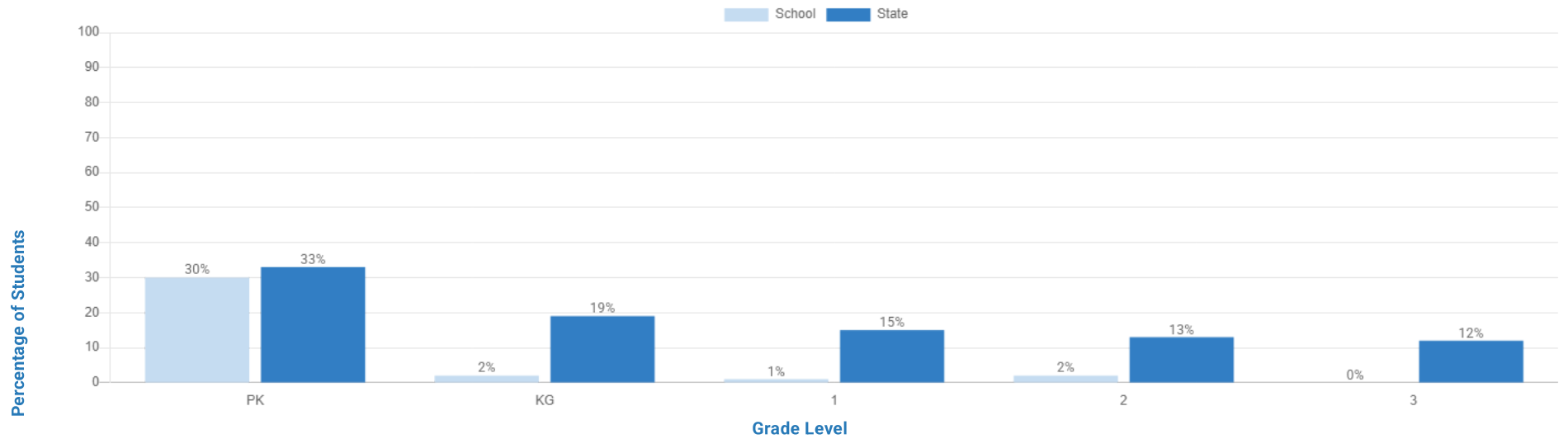

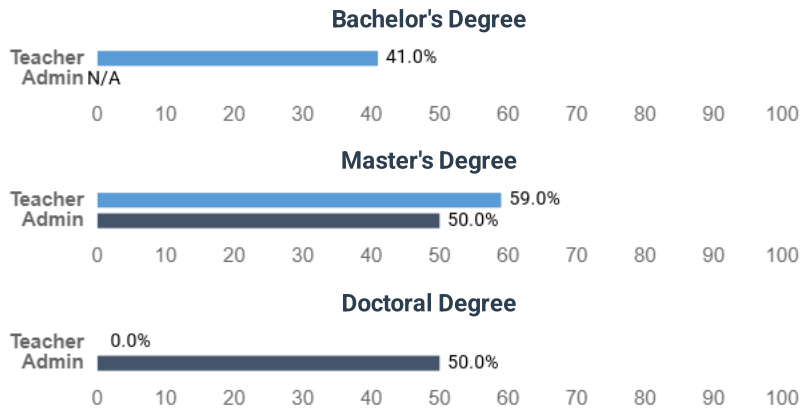

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Our comprehensive instructional programs from PreK-third grade focus on contemporary research, balanced instruction supported by adequate resources, interventions for children with special needs, and in-service training for teachers. These programs reflect the best pedagogical approaches and meet the academic, social, physical and emotional needs of our students.



Awards, Recognition, Accomplishments:

Lincoln School is using Title IV funds to add mindfulness, breathing and yoga practices to curriculum. The school also received numerous grants from the Bergen County Utilities Authority for its environmental work in reducing the number of plastic bottles used in school and preserving an outdoor space for study of soil, trees, plants and animals. Lincoln School was recognized by EZRide for promoting Safe Routes to School.

Courses, Curriculum, Instruction:

The curriculum aims to compact and integrate objectives. The balanced literacy program infuses Project Read, a multi-sensory phonics program, Advancing Literacy to teach comprehension and vocabulary skills, and Writer's Workshop methodologies. EnVision is the main program for math instruction. Our Lincoln Woods complements our Mystery Science curriculum. The teachers teach social studies using primary and secondary sources.



Clubs and Activities:

Lincoln School offers a lunch time book club and environmental club for students in second and third grade.



Before and After School Programs:

Bulldog Care oversees the before and after school programs held in the school. Morning care is available from 7-8:30 a.m. and aftercare runs from 3-6:30 p.m. Parents can register and pay for the program on-line. Students have access to the gymnasium and playground and eat a snack, complete homework, and play in structured games and activities under the direction of the site workers.

Staff and Professional Learning:

Teachers meet monthly with Professional Learning Committees to support school goals. All monthly faculty meetings are focused on professional development and school management. We have partnered with the South Bergen Jointure Commission and consultants from Columbia University to support teacher development. Our teachers received on site training on integrating body stretches for refocusing and calming. Teachers are encouraged to develop individualized Professional Improvement Plans that foster individualized growth which support the school's goals. Teachers have time to collaborate when planning. Our teachers have also trained numerous student teachers from surrounding universities.



Student Supports and Services:

Lincoln School uses a Response to Intervention (RTI) program. All students receive school-wide targeted instruction in reading. Students are assessed on their reading skills and then grouped with a teacher to develop this skill. This decreases the staff-to-student ratio in reading and allows reading specialists to deliver intense intervention. In addition, an RTI teacher is in the math classroom twice a week to offer support to those students who need assistance within the classroom. We have in-class support classes taught by a special education and elementary teacher. In addition, we use Title 1 federal funding to provide after school tutoring in math, writing, reading and phonics.



Student Health and Wellness:

Our physical education team offers a variety of lessons to develop gross motor activities and sportsmanship. Our physical education teacher supervises recess to transfer health and physical education skills to more independent settings. Our annual Field Day is a memorable event where Rutherford High School students help facilitate stations. In addition, our teachers infuse mindfulness throughout the day. Students are taught the benefits of breathing to calm or energize. Instructors visit the classrooms throughout the year to conduct yoga lessons as part of the social and emotional learning program. In addition, one character trait based on Dr. Angela Duckworth's work is reinforced each month. We participate annually in the national Great Kindness Challenge.

Parent and Community Involvement:

Lincoln School has a very active group. Parents plan Halloween, Valentine, and end-of-year socials for the children. Parents volunteer for events like book fairs, chick hatchings, field day, planting and holiday shopping. The PTA also plans a winter donation project. Students have collected items for an animal rescue organization and the Rutherford Food Pantry. Finally, the PTA fundraises to provide school assemblies and class projects. Parents are included on the School Climate and Schoolwide Title 1 Committees.



Facilities:

Our building houses preschool to grade 3 students. We currently have approximately 4 homerooms for each 1-3 grade level. The original building was built in 1913 and was expanded to its current formation in 2005. In 2021 two additional classrooms were added to accommodate needs. The gymnasium can accommodate a large crowd for sporting events. We have an art/music room, science classroom, media center, preschool classroom, multiple disabled and a multi-grade classrooms. We also have several small group instruction rooms.



School Safety:

Evacuation, lock down, fire and shelter in place drills are conducted on a regular basis. The Rutherford Police Department works with the school to make sure we have up-to-date safety information and are frequent visitors. Teachers are trained annually on emergency crisis response and school safety.

Technology and STEM:

The elementary science specialist incorporates science, technology, engineering and math into lessons. Students also work with an enrichment teacher to review coding. The school has a class set of VR goggles and numerous Chromebooks, document cameras, and interactive boards.



Early Childhood Education:

Lincoln School has half-day integrated preschool 3 and preschool 4 classes for students who receive special services and those general education students who register on a first come, first served basis. Preschoolers are taught by a NJDOE certified preschool teacher and use the Creative Curriculum program. Students learn through whole and small group instruction. Hands on kinesthetic learning is a priority. Students have dramatic, sand/water, art, building, math and reading centers. The speech therapist provides a push in model that allows students in need to foster conversation and practice articulation in a natural setting. Students receive art and music instruction and enjoy visits from the Children's Librarian from the Rutherford Public Library. It's a magical place!
