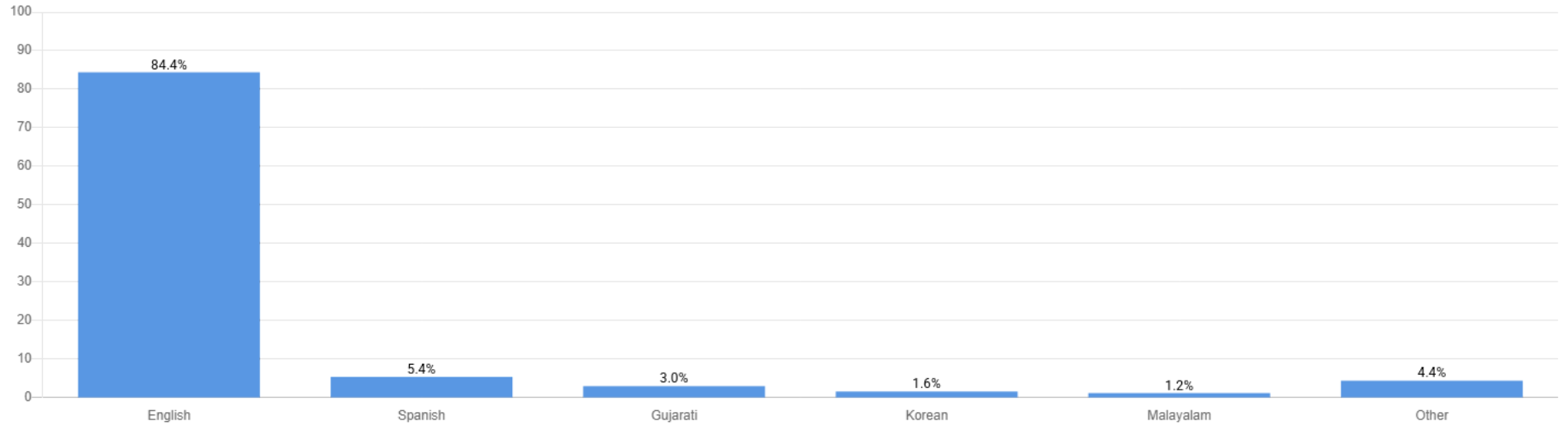

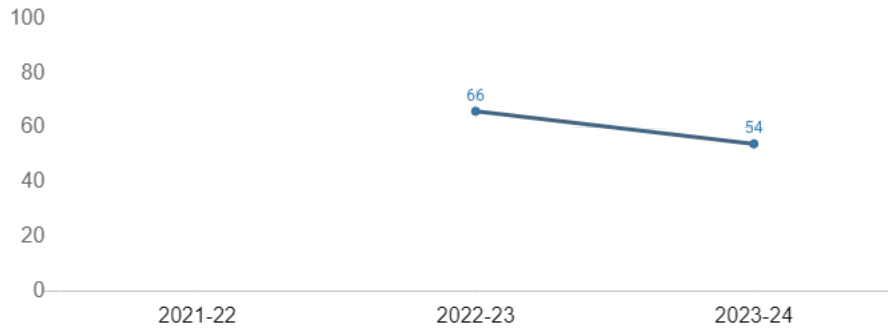

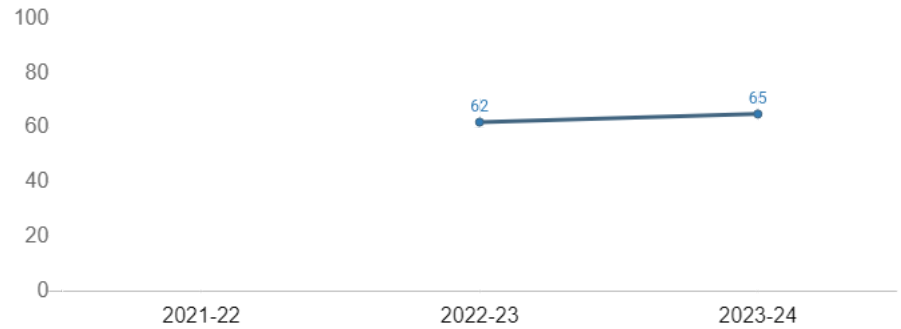

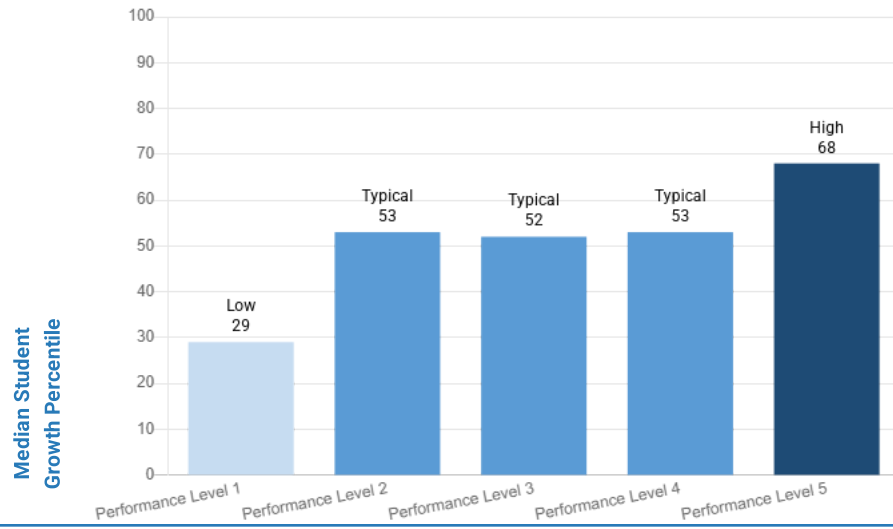

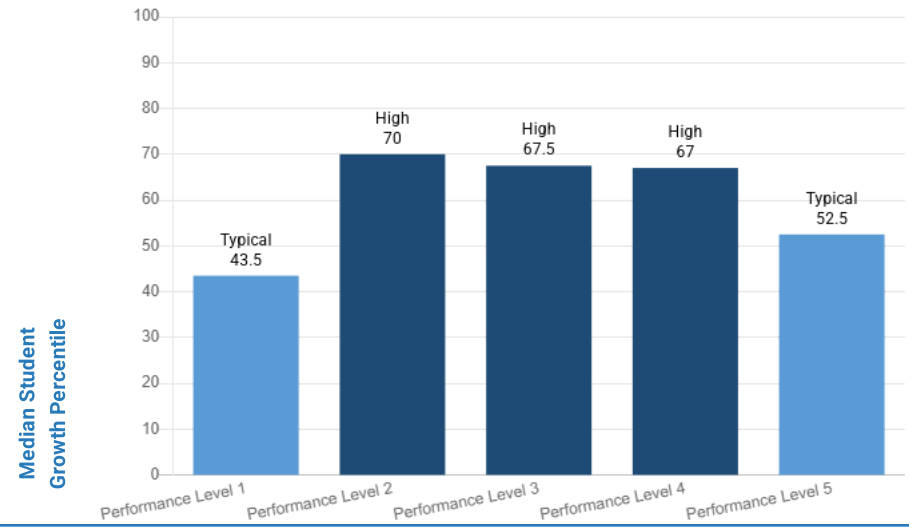

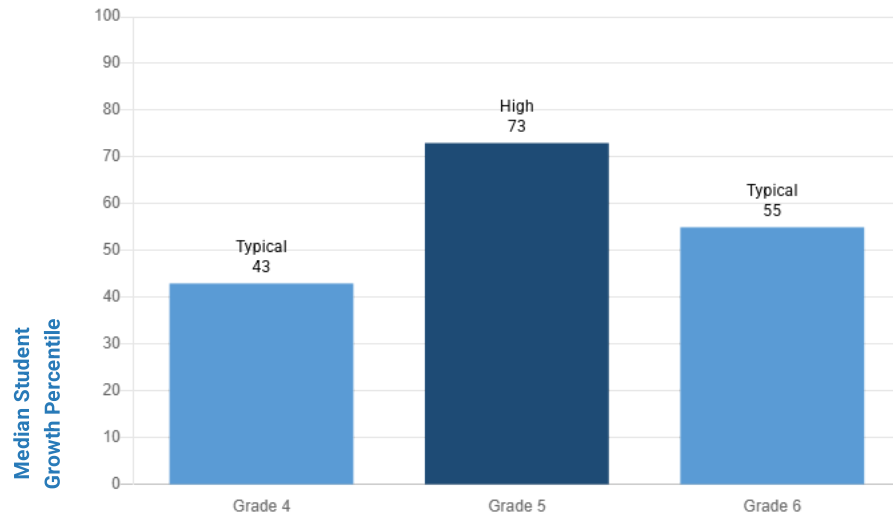

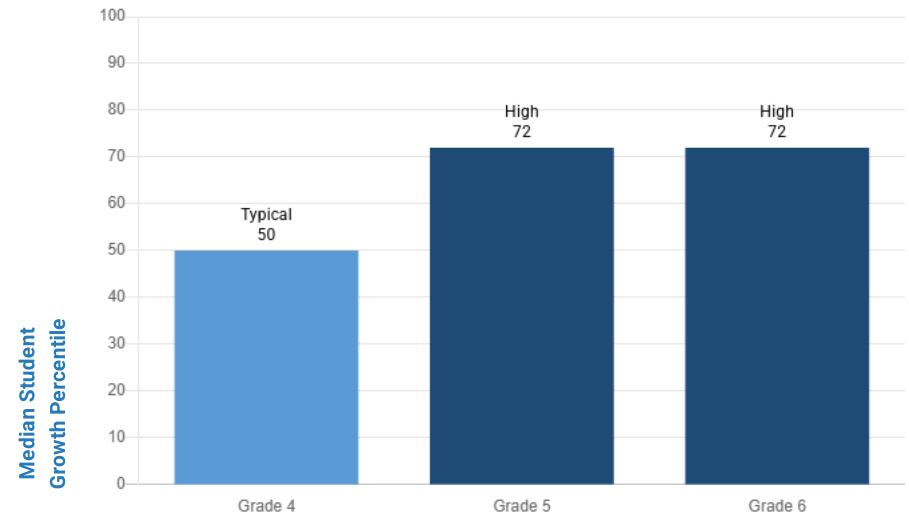

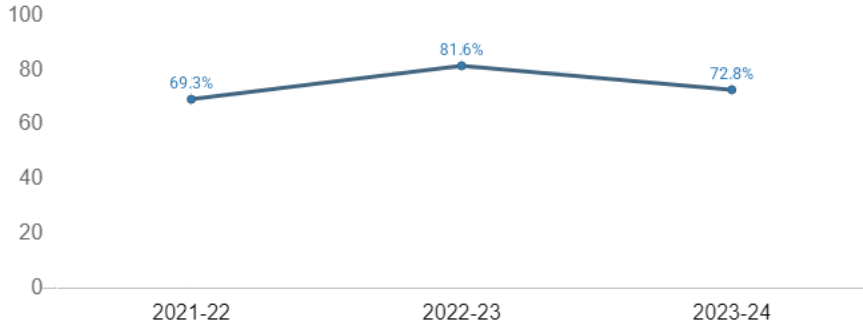

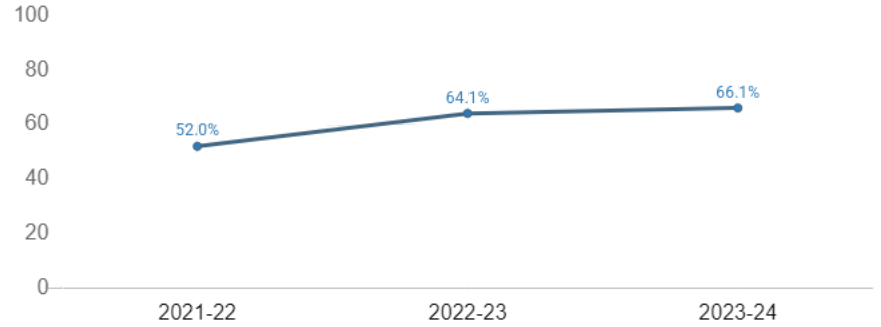
English Language Arts and Mathematics Performance Trends

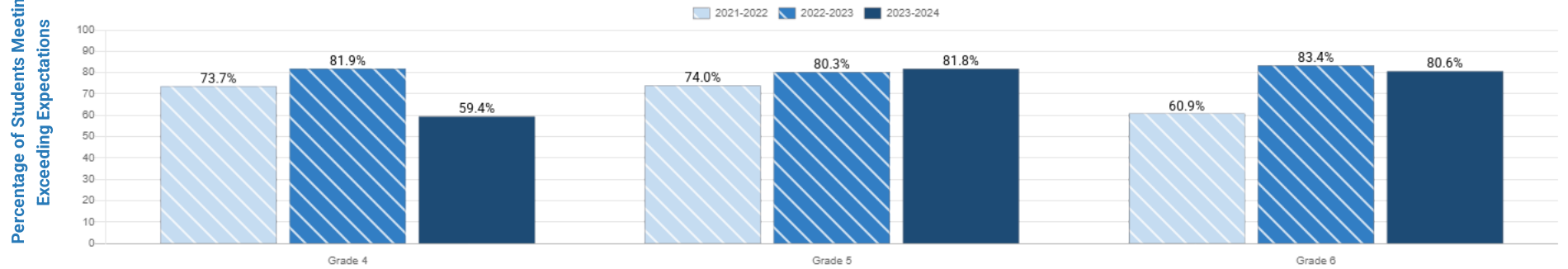

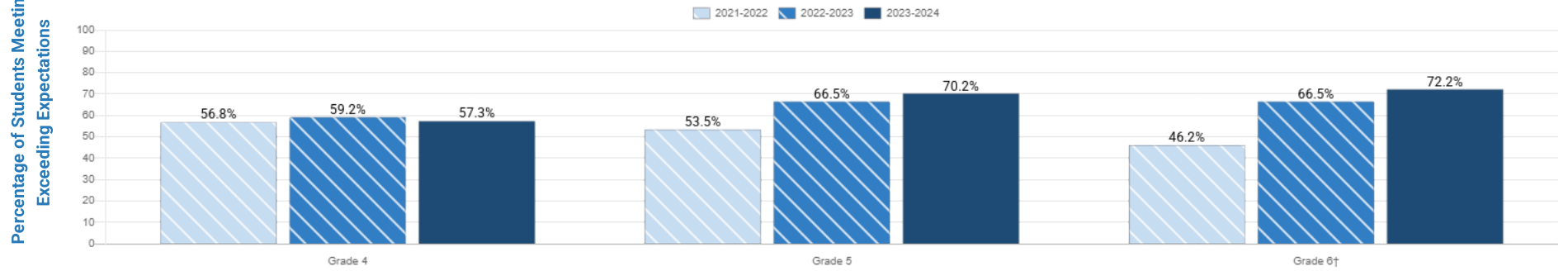

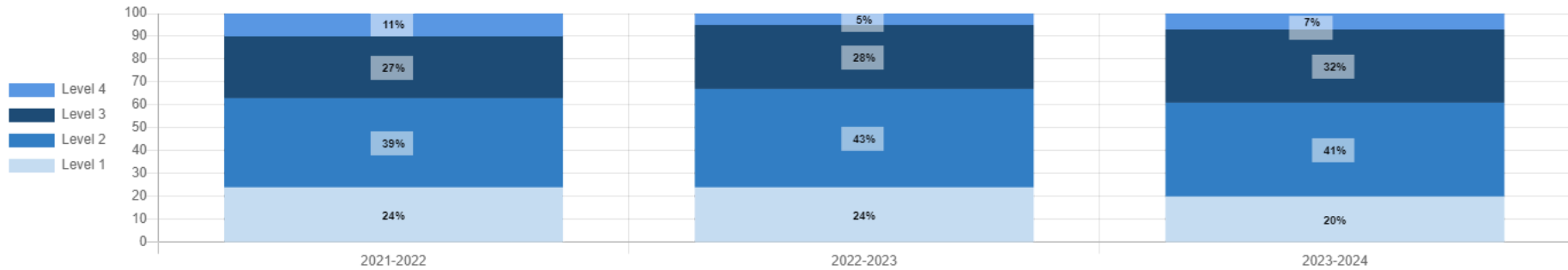

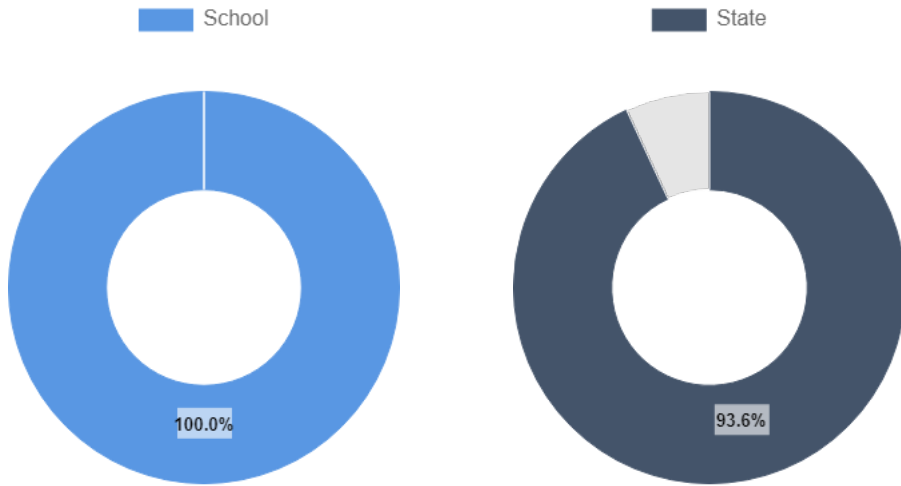

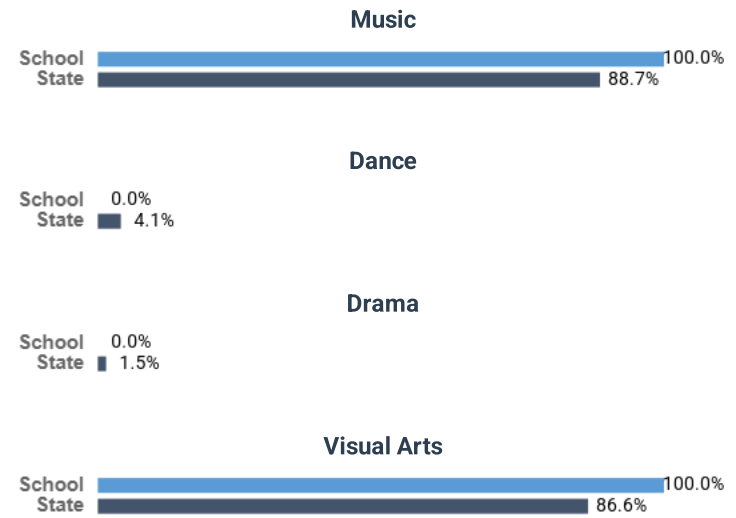

Students enrolled in one or more classes by discipline:



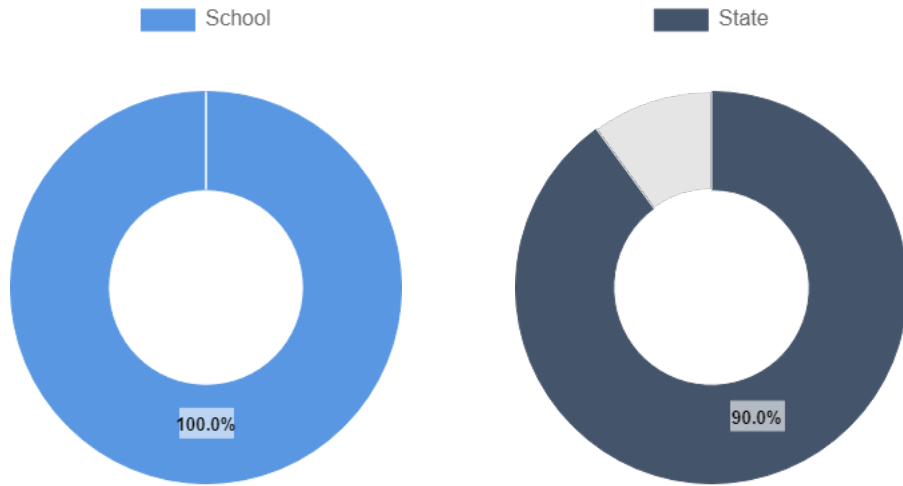

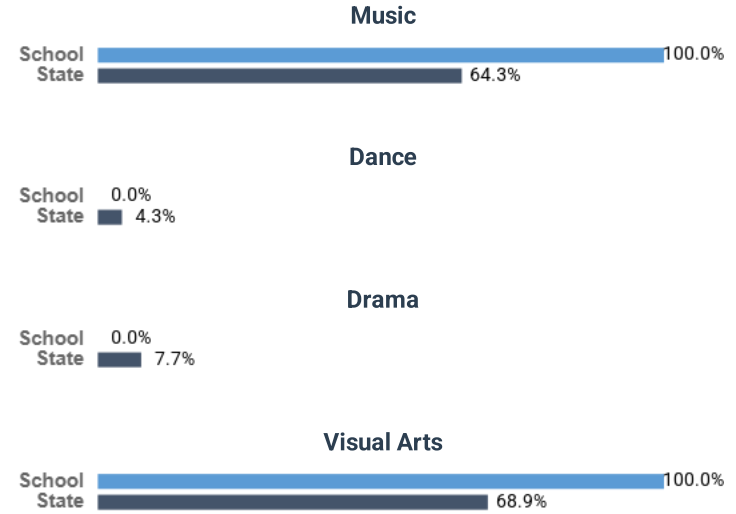

Students enrolled in one or more classes by discipline:



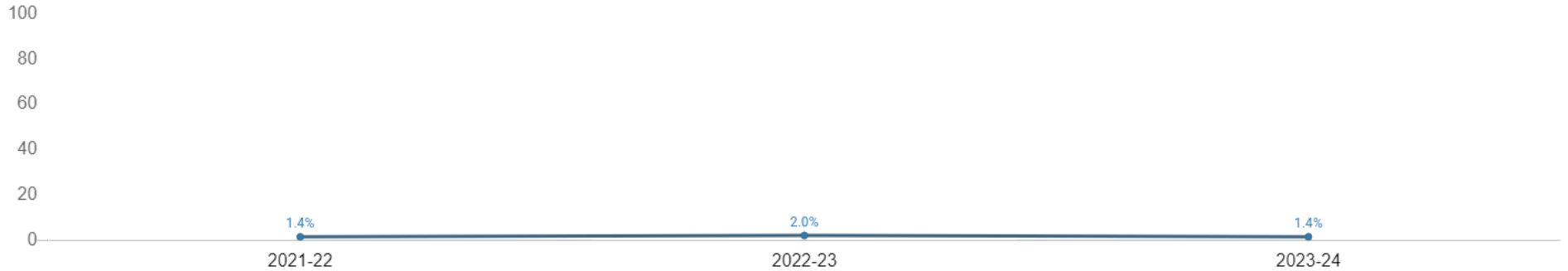
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. 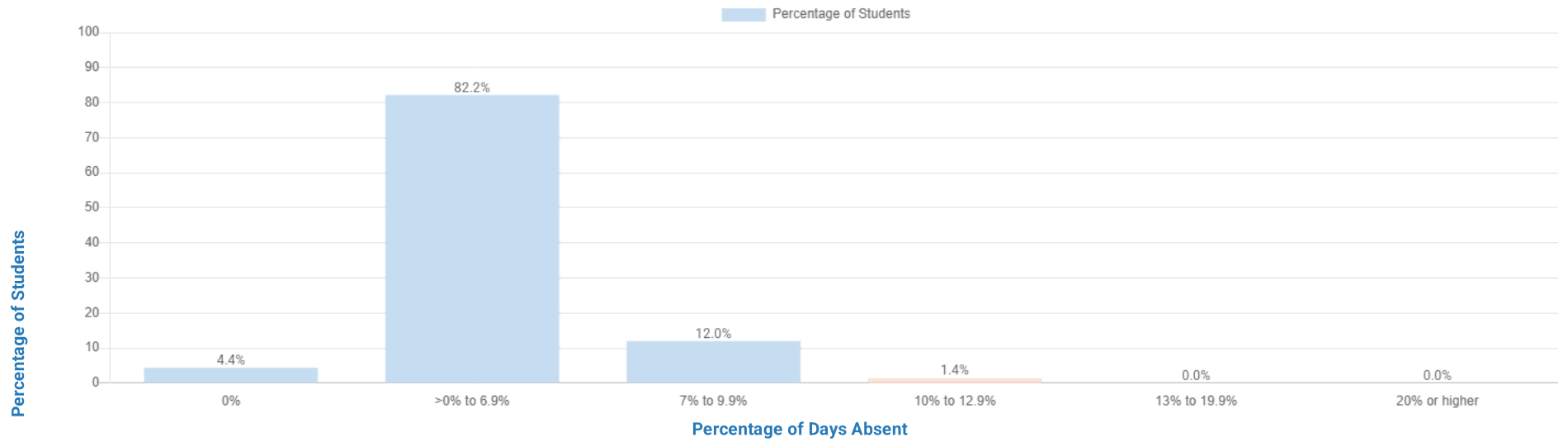

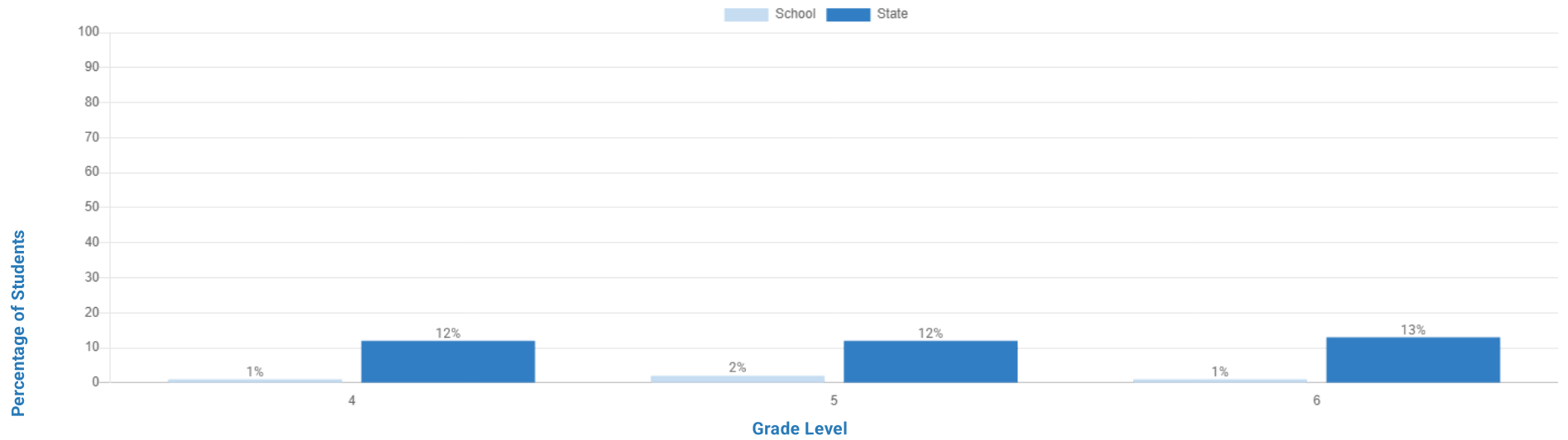

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

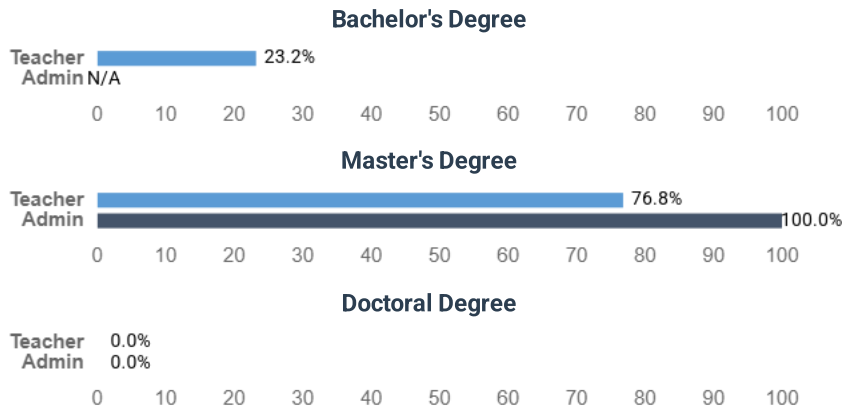

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Staff and Professional Learning:

Teachers meet monthly with PLCs that cover a wide range of topics including, but not limited to, curriculum, SEL, and best practice techniques. All monthly faculty meetings are professional development based. Pierrepoint has partnered with the South Bergen Jointure Commission and worked with staff trainers from Columbia University.



Student Supports and Services:

Pierrepoint School implements the Response to Intervention program. RTI is a method of identifying at-risk learners at an early stage, matching them to appropriate research-based interventions, and flexibly providing them with additional support as needed. All of our students are offered the opportunity to attend after school assistance on Tuesdays, Wednesdays, and Thursdays, from 2:54 p.m. - 3:12 p.m. PBSIS was implemented schoolwide in September 2022.

Facilities:

Our building houses 4th-6th grade students. We currently have 10 homerooms for each grade level. The gymnasium can accommodate a large crowd for school and community events. We have an art/music room, STEM lab, media center, multiple disabled and a multi-grade classrooms. We also have several small group instruction rooms. Our new gymnasium opened in the Fall of 2021. An addition of 12 new classrooms was completed for the 2022-2023 school year.



School Safety:
