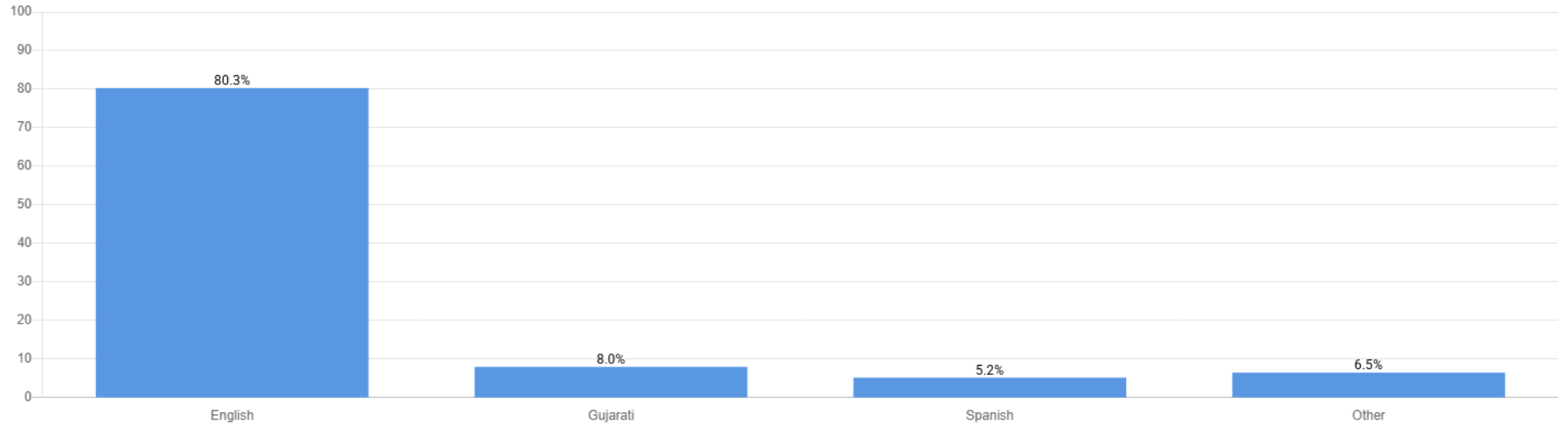

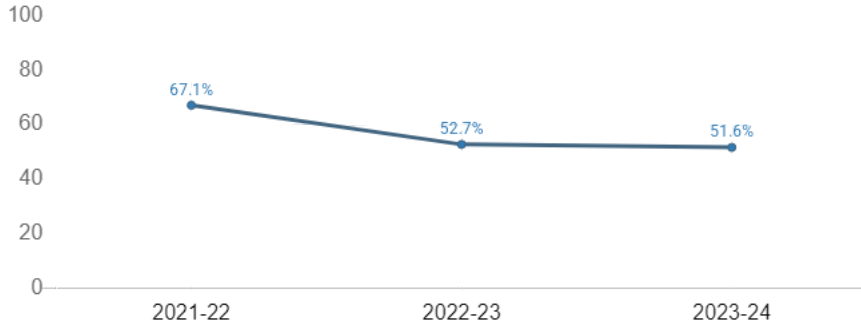

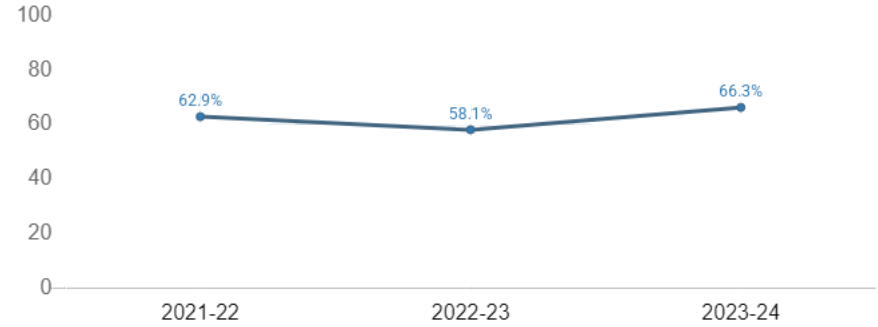
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 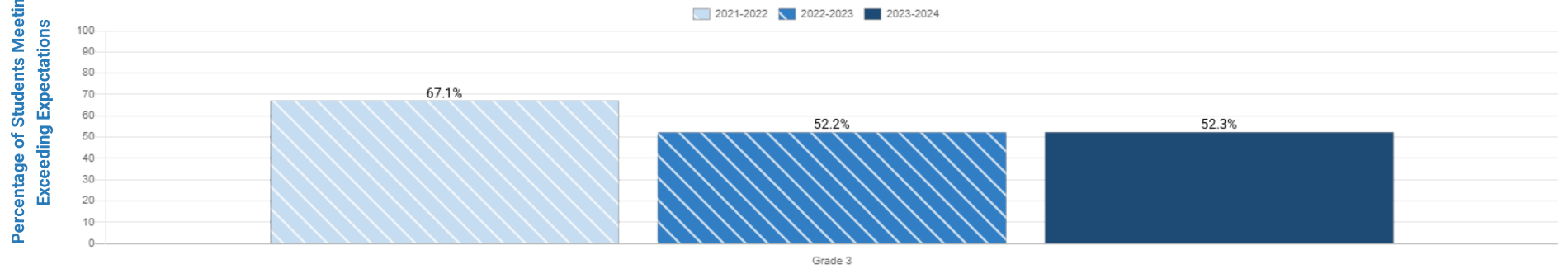

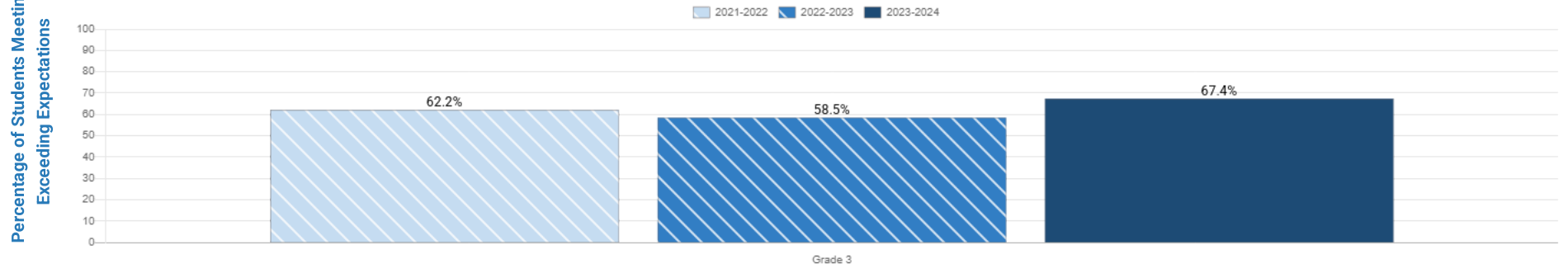

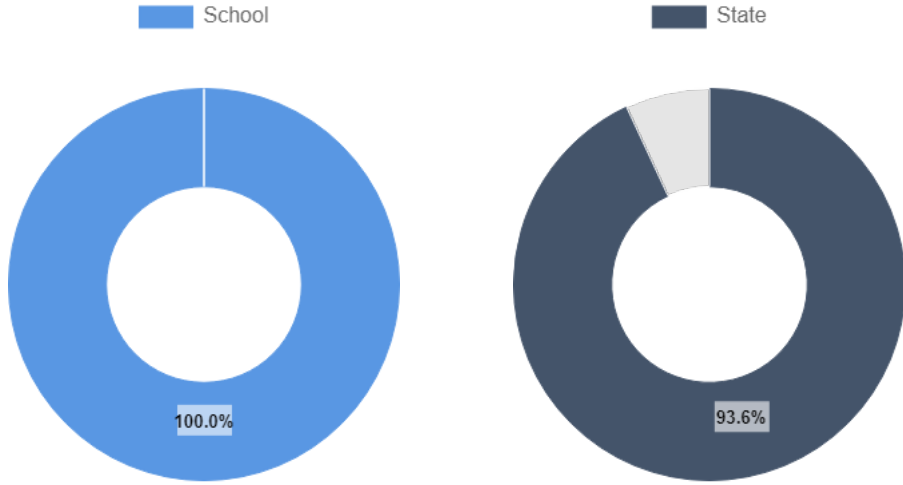

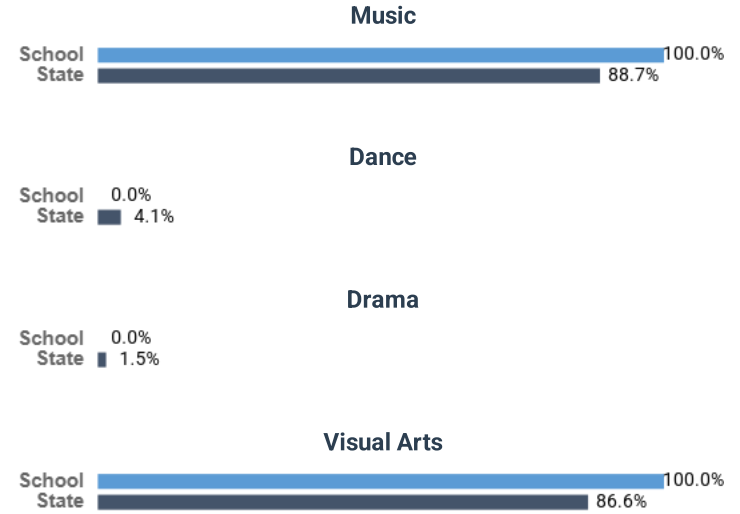

Students enrolled in one or more classes by discipline:



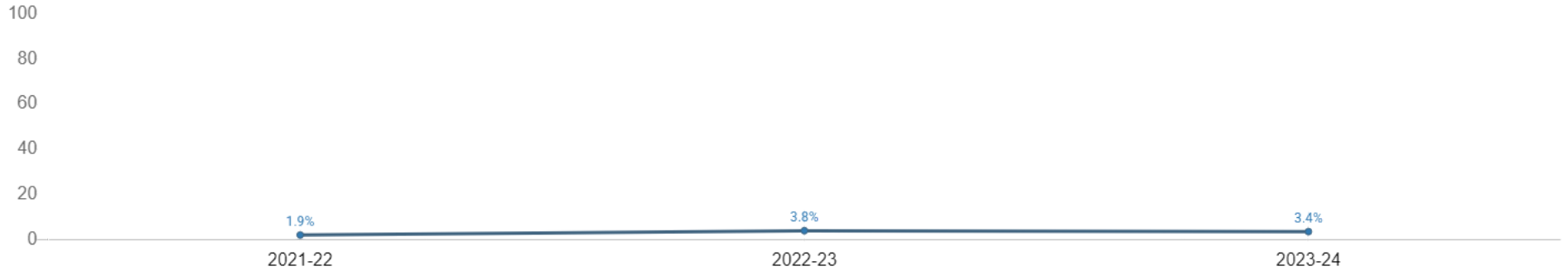
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

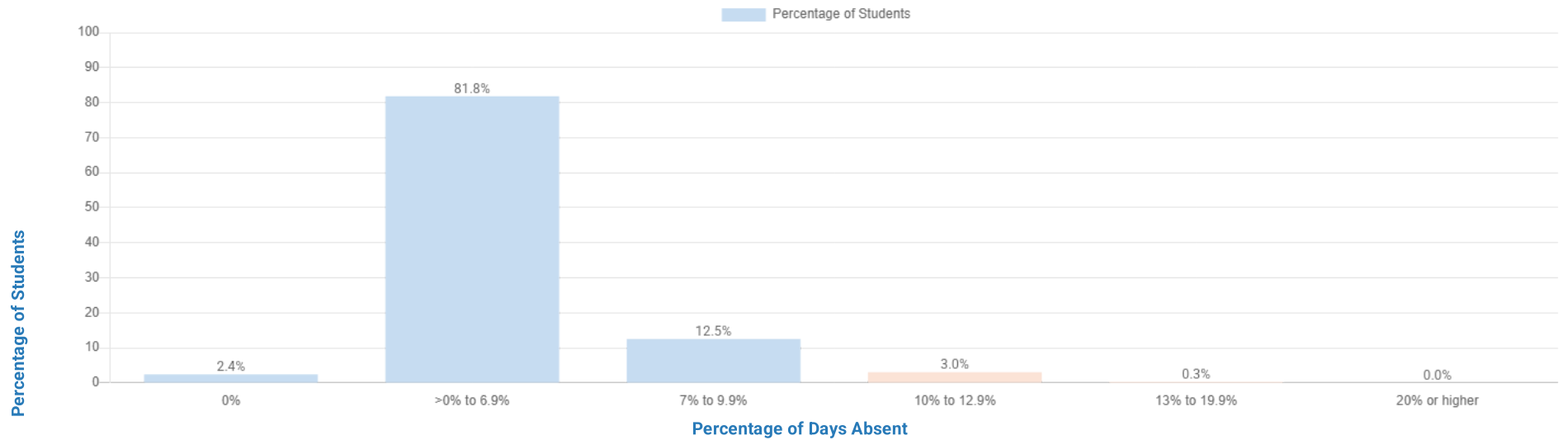

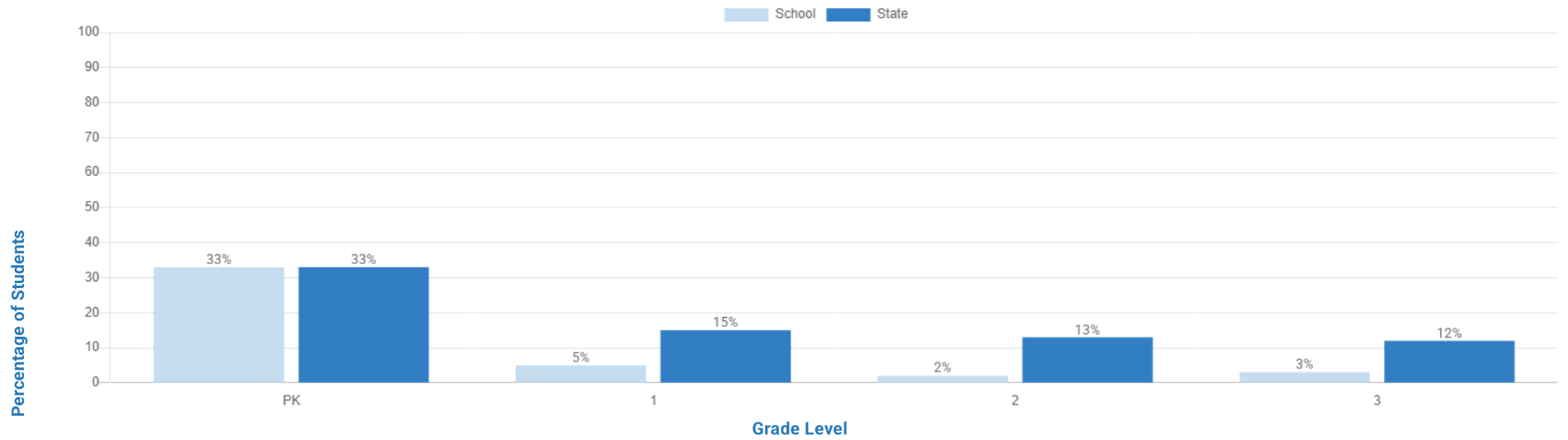

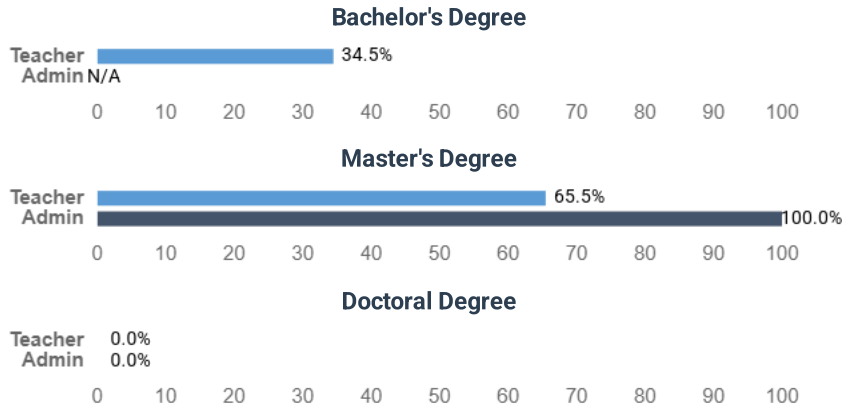

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Mission, Vision, Theme:

Students at Washington School learn and grow academically, socially, and emotionally to the best of their capabilities in a positive and productive learning environment. Our comprehensive instructional programs, in grades 1-3 and Pre-K, focus on contemporary research, balanced instruction, interventions for children with special needs, and continual in-service training for teachers. These programs meet the academic, social, physical and emotional needs of our students.

Courses, Curriculum, Instruction:

The curriculum aims to compact and integrate objectives. The balanced literacy program infuses Project Read, a multi-sensory phonics program, Advancing Literacy to teach comprehension and vocabulary skills, and Writer's Workshop methodologies. EnVision is the main program for math instruction. Our environmental science garden complements our Mystery Science curriculum. The teachers teach social studies using primary and secondary sources.



Before and After School Programs:

Bulldog Care oversees the before and after school programs held in the school. Morning care is available from 7-8:30 a.m. and aftercare runs from 3-6:30 p.m. Parents can register and pay for the program on-line. Students have access to the gymnasium and playground and eat a snack, complete homework, and play in structured games and activities under the direction of the site workers.



Staff and Professional Learning:

New teachers attend an orientation and are paired with experienced mentors. Teachers attend workshops through the NJDOE, Bergen County and local universities. Teachers participate in Professional Learning Communities, currently focused on our school goals. Teachers collaborate on given topics weekly, conduct trainings and read research. Teachers receive feedback on their lessons in order to continue to learn and grow. Faculty meetings focus on various PD topics. Teachers meet monthly with Professional Learning Committees to support school goals. All monthly faculty meetings are focused on professional development and school management. Teachers develop individualized Professional Improvement Plans that reflect on past performance observations foster and also support the school's goals. Teachers have time to collaborate when planning. ELA and Math coaching supporting our new programs is conducted a few times/year.

Student Supports and Services:

We implement a tiered Response to Intervention model in math and language arts literacy for students in need of additional support. This RTI model allows parents and teachers to focus on specific goals, document progress and then refine the goals as needed. Special education staff, our reading specialist, or support teachers work with the classroom teacher to assist students showing a weakness in a specific learning area. We also offer speech, OT, PT, counseling and behavioral services. We have a Student Assistance counselor who to support out students in social groups and 1-1 support as needed.



Parent and Community Involvement:

A very active PTA conducts numerous events, raising funds that benefit the school and enhance our academic and cultural programs. Through our semi-annual Scholastic Book Fairs, the PTA helps to increase the number of volumes in our library. Our PTA sponsors visiting authors and helps build community spirit at our social events. Parents visit classrooms as guest readers. We collaborate with the Future Teacher's Club and the Public Speaking Club from Rutherford High School on activities related to Read Across America Day.



Facilities:

Our building houses preschool to grade 3 students. We currently have 5 homerooms in Grade 1 and 4 homerooms each in Grade 2 and Grade 3. The original building was built in 1913 and was expanded to its current formation in 2005. The large gymnasium can accommodate a large crowd for sporting events. We have an art/music room, science classroom, media center and two preschool classrooms. We also have several small group instruction rooms.

School Safety:

Evacuation, lock down and shelter in place drills are conducted on a regular basis throughout the school year. These drills may be announced or unannounced. These drills may be conducted with the participation of state, local or federal authorities. Officers from Rutherford Police Department visit our school on a daily basis. We work with the RPD to review school safety measures.



Technology and STEM:

The elementary science specialist incorporates science, technology, engineering and math into lessons. Students also work with an enrichment teacher to review coding. The school has a complete inventory of Chromebooks to be 1:1 for all students in grades 1-3 at any time. We have Interactive Display Systems in all instructional spaces and have a large supply of document cameras.



Attendance:

Washington School again received Federal Funding under Title I. With this funding, the school was able to provide tutoring in language arts literacy and math at all grade-levels, 1-3. The District also provided a Summer Enrichment Academy for primary grade students whose families were seeking additional academic support.
