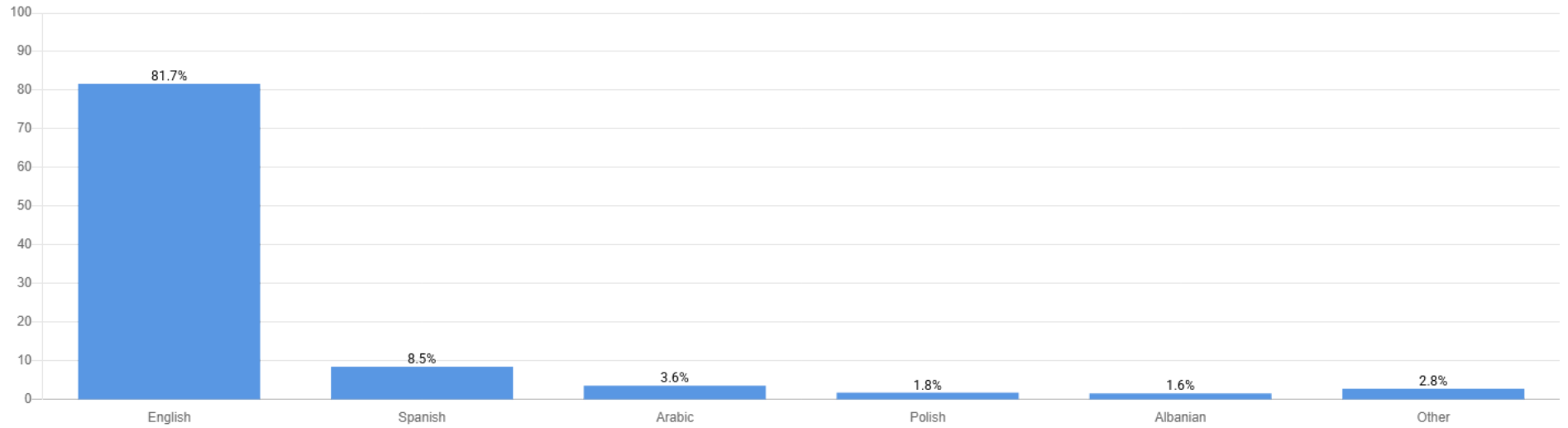

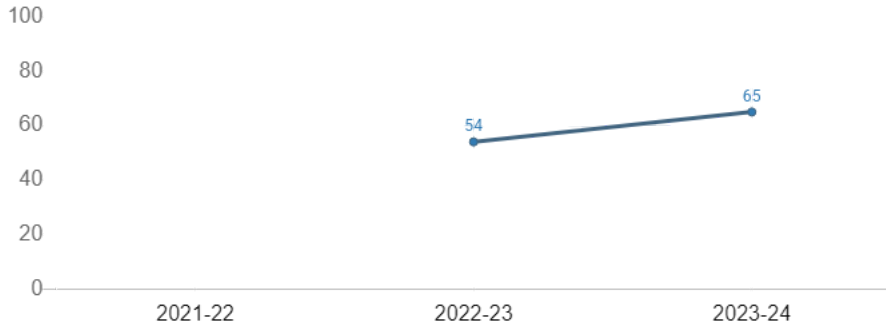

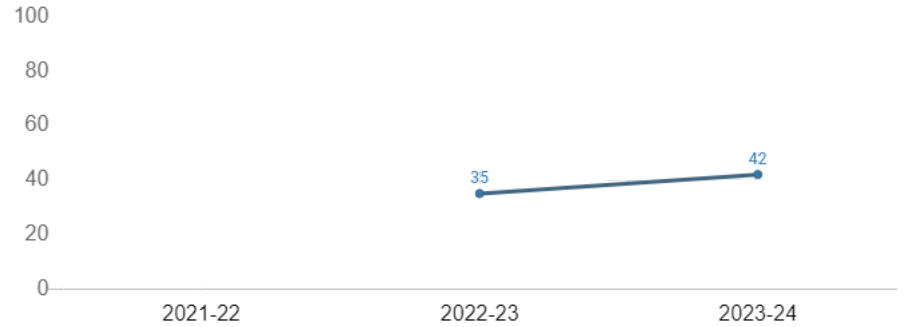

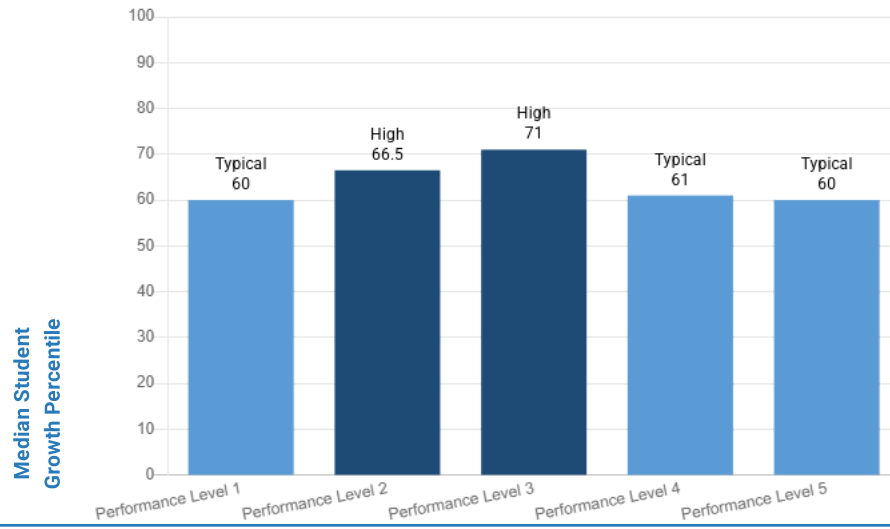

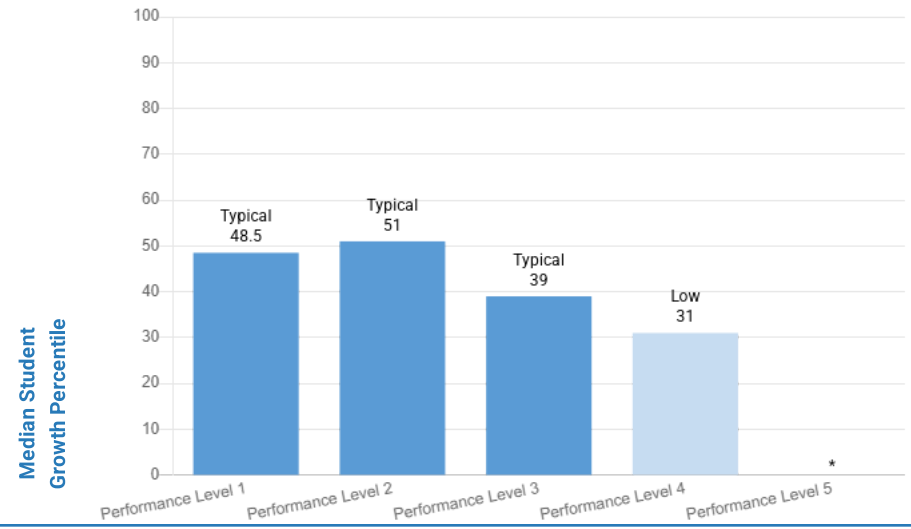

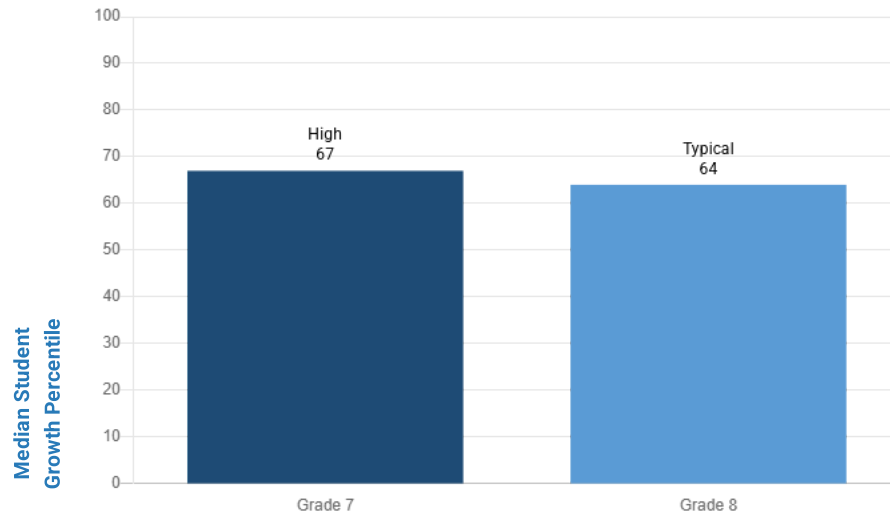

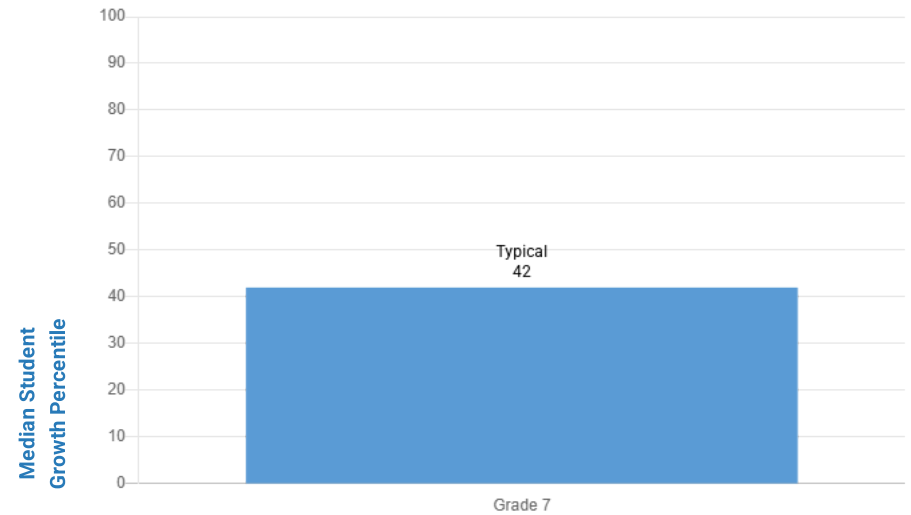

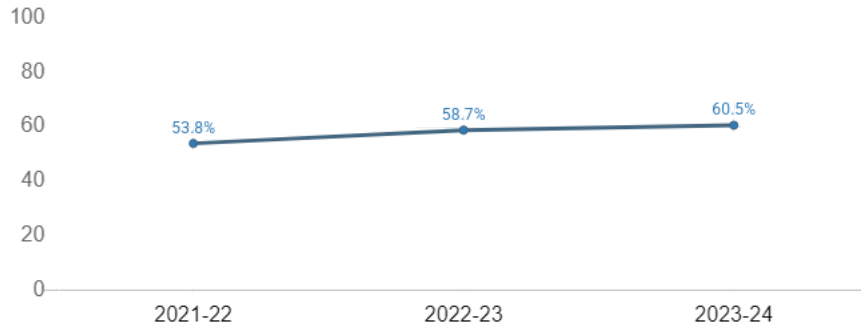

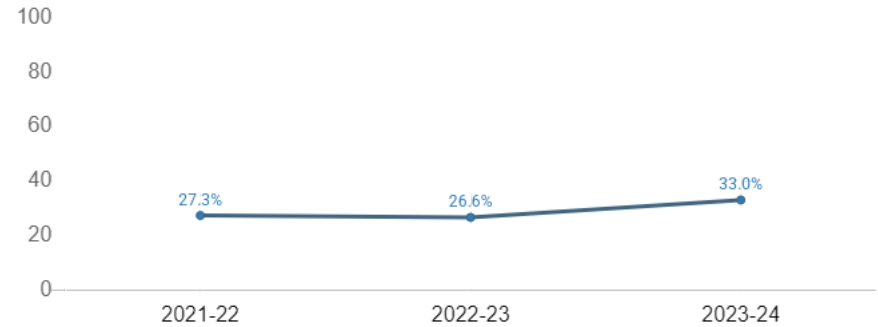
English Language Arts and Mathematics Performance Trends

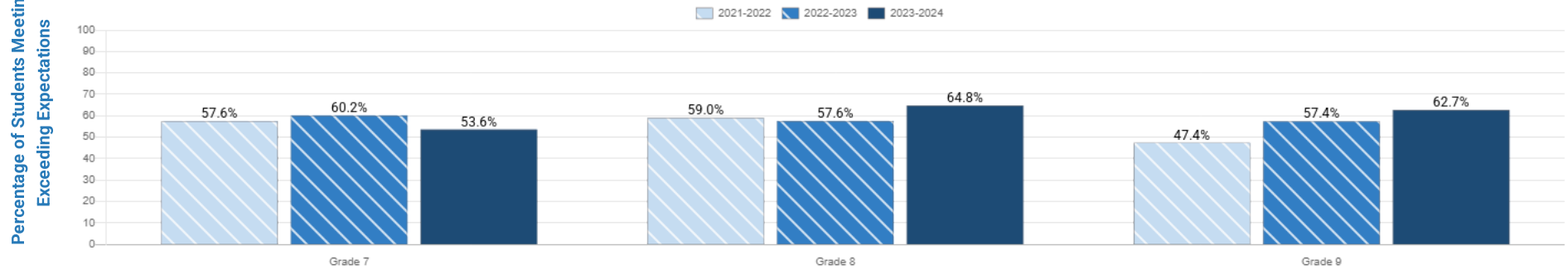

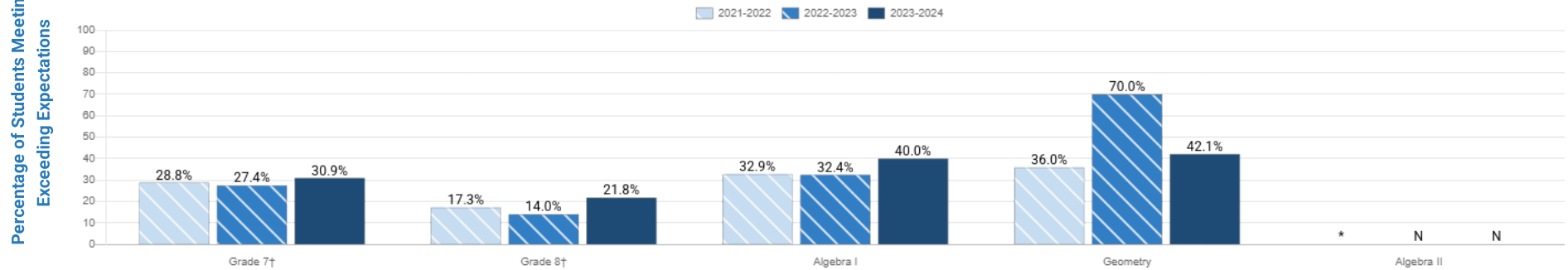

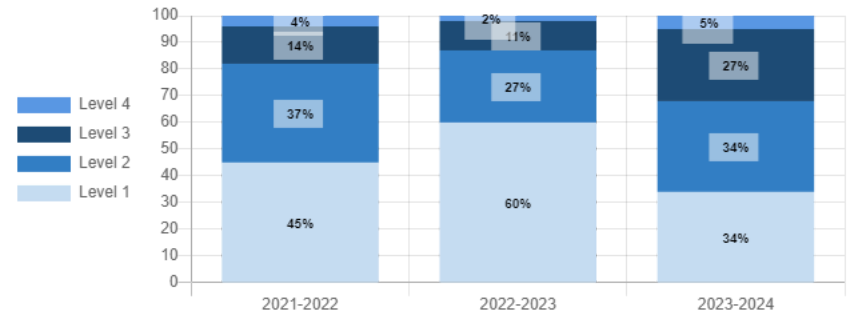

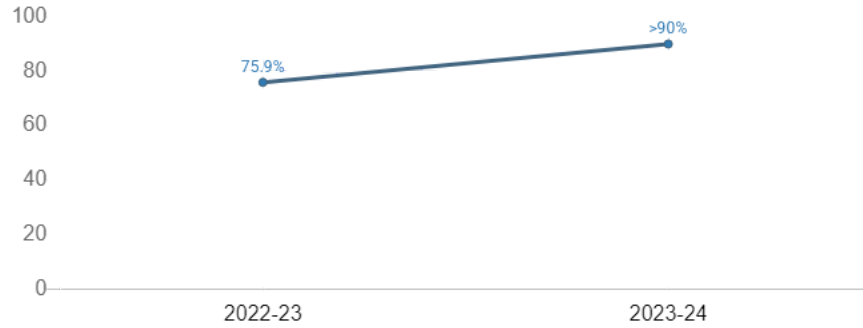

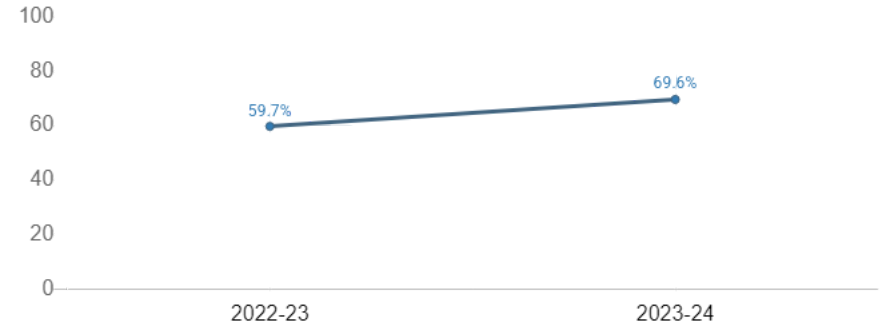

Students taking one or more AP or IB exam

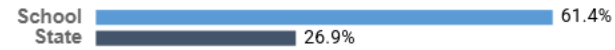

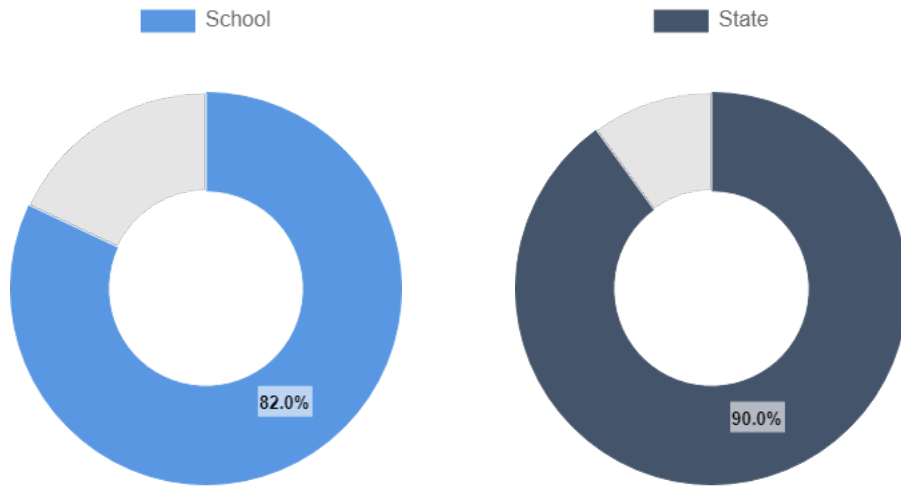

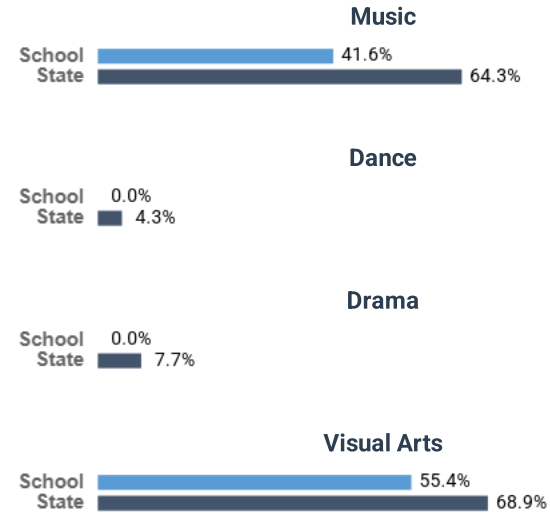

Students enrolled in one or more classes by discipline:



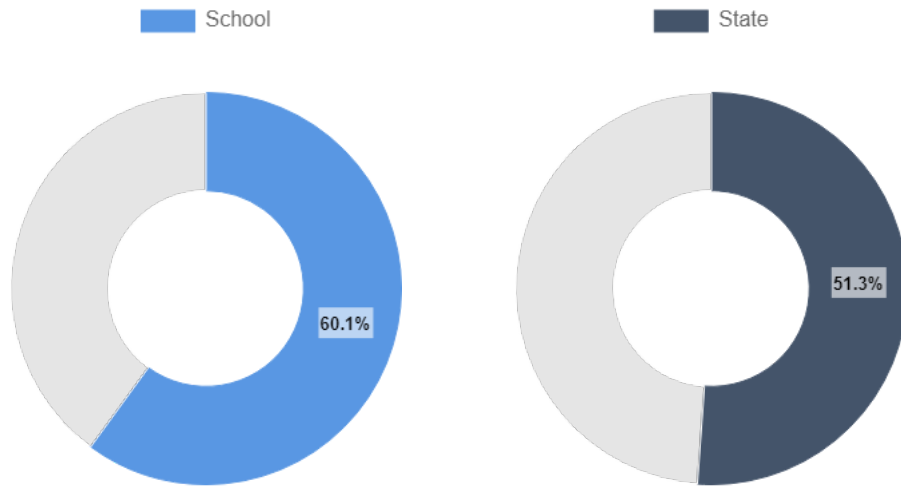

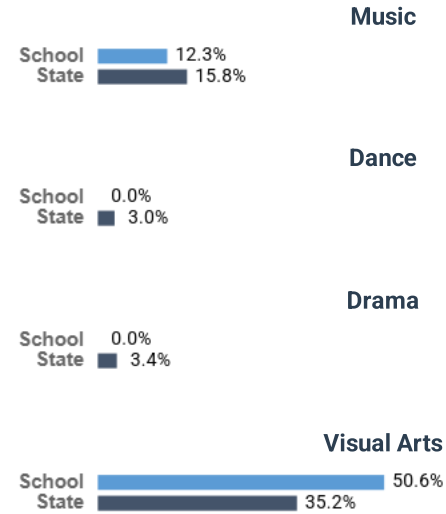

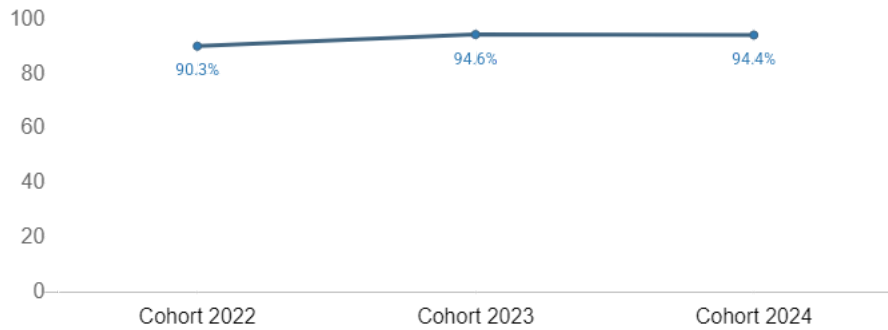

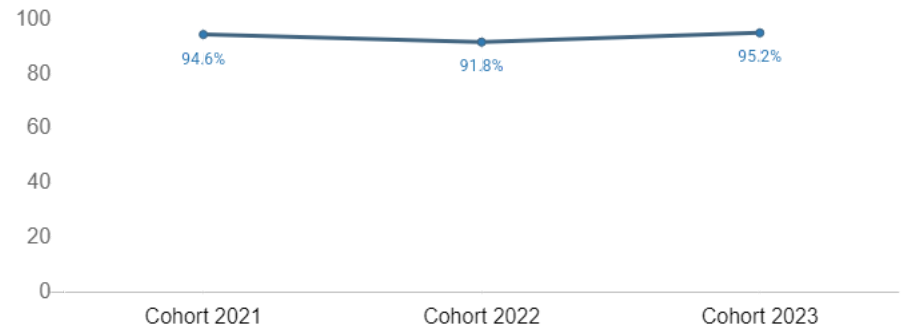

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

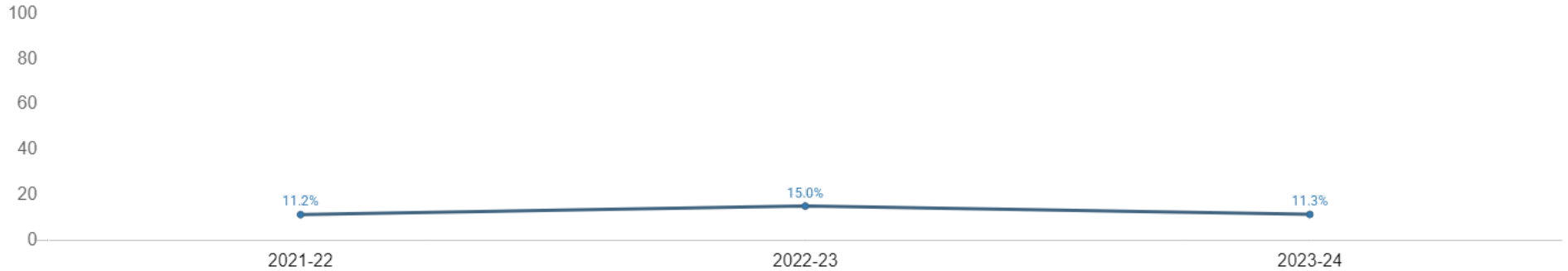

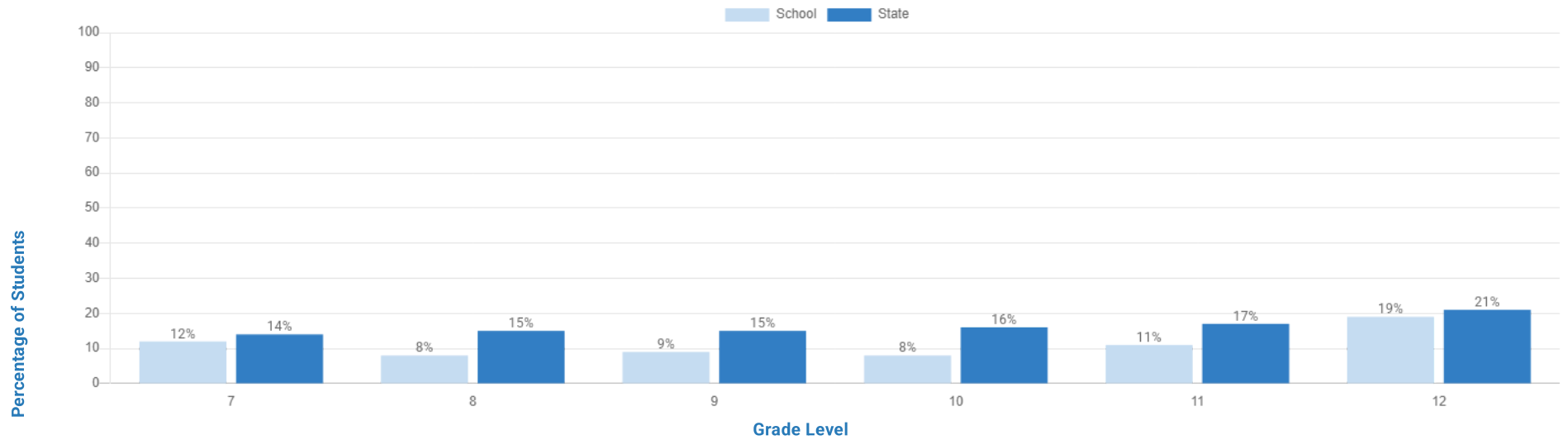

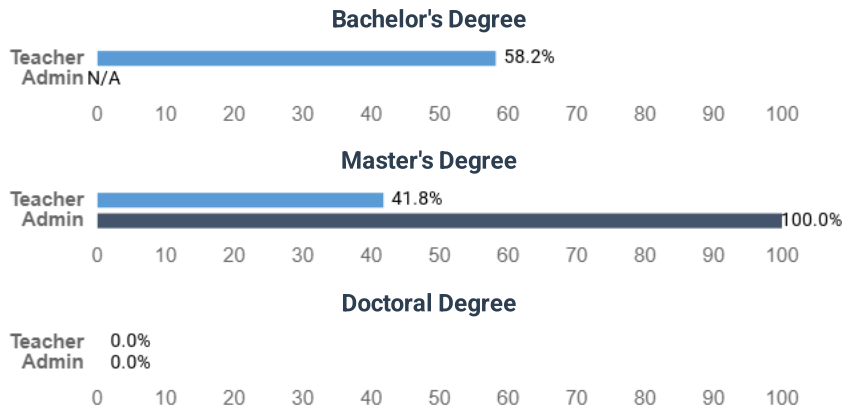

Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

 - Title I schools with a summative score in the bottom 5% of Title I schools.

Schools will be identified for TSI status based on data from the 2023-2024 school year, since that is required annually. If at least one student group did not meet all targets and also did not meet all targets in the 2022-23 school year, then the school will be identified as requiring TSI.

Courses, Curriculum, Instruction:

Saddle Brook MS/HS continues to focus on improving our students' college and career readiness. Our goal is to continue to provide students with opportunities and learning environments that promote discovery, collaboration, and problem-solving. Additionally, the high school offers 7 dual enrollment courses and the middle offers honors sections of 8th grade algebra and science. During the 22-23 school year, the high school introduced an aviation program where students are provided the opportunity to earn credits and credentials toward their pilot's license. Our Tomorrows Teacher program is hosted in partnership with Rider University where our students earn dual credit and complete internship hours in classrooms across the district. We have seen increased participation in our work-based learning experiences through our Option II program as well as an increase in the number of our seniors engaged in early college courses with Bergen Community College.

Saddle Brook High School is a member of the NJIC Meadowlands Division. Participation numbers have held steady in each of the last 3 years. 90 percent of our sports teams have qualified for and participated in the NJSIAA tournament. Numerous athletes were named to the All-league and all-conference teams. All our Fall sports teams participate in Breast Cancer Awareness Month.



Clubs and Activities:

Saddle Brook MS/HS offers a host of activities to enhance the educational experience of students with interests in academics, the arts, community service, and recreation. Many of these activities connect students from grades 7 - 12. Before and After School Programs:

The MS/HS provides morning supervision for students who arrive before school. There is also supervised before/after school tutoring facilitated by the National Honor Society and Science National Honor Society in the Media Center.



Staff and Professional Learning:

The overarching goal for the MS/HS is to engage our students in meaningful academic ways. A focus is on developing assessments aligned to the English and Math standards and the overall rigor level of the NJSLA and NJGPA. Another focus will be engaging our students in higher-order thinking as well as continuing to develop digital portfolios. Professional development is available for subject-based PLCs as well as pedagogy, classroom management, and other topics for PLCs chosen by staff members.



Postsecondary Information:

The Saddle Brook Guidance Department offers a multitude of programs to support students in applying to college, and technical schools, and receiving financial aid. These programs include junior and senior Class Meetings with guidance staff and individual meetings with counselors for upperclassmen. A High School 101 parent presentation, a Senior Parent Meeting, and a Financial Aid Night are avenues of parent outreach. The Guidance Department also hosts visits from college representatives and a Saddle Brook Alumni Return Day. Instant decision days hosted at SBHS have been well received by students.

Student Supports and Services:

For students who are eligible for special education and related services, various levels of specialized instruction and support are provided including in-class consultation, in-class resources, and pull-out replacement instruction. Additionally, for students who demonstrate significant learning or social-emotional difficulties, special classes are offered for students with multiple and/or behavioral disabilities.



Student Health and Wellness:

We offer an intramural program for our middle school students. Health is required once a year for a full marking period. These topics include Wellness, Alcohol, Tobacco, and other Drugs, Family Life, and Community Health Skills. Each student has physical education three marking periods per year. Middle School students are given time for recess during their lunch period. Breakfast is served daily before school in the cafeteria. We now promote Wellness Weekends during extended breaks, allowing students and staff to recharge without homework or grading, and we have incorporated Wellness/SEL days into our regular schedule.



Parent and Community Involvement:

Saddle Brook parents are very supportive of the schools. Groups include the MS/HS PTO, Special Education Parent Advisory Committee, and athletic/music booster clubs. We have developed partnerships with municipal government and community organizations to provide enrichment opportunities, including student elections, volunteer, and internships. The school works closely with the Saddle Brook Educational Foundation, a non-profit group that has supported the district through numerous grants each year.

Facilities:

Saddle Brook High School opened in 1958. The Middle School was merged during the early 1990s. An addition was built in 2005, which included a second gym, Media Center, and six additional classrooms. There are three computer labs, a photo studio, and two art rooms. The community supported a referendum in 2014, which was used to fund renovations to the auditorium, roof, and bathrooms, and upgrade building security. In 2023, the community approved a referendum to upgrade the facilities in the Middle and High School and update our athletic field to turf and include lights. Partial roof replacements, window and door replacements, restroom renovations, and front entrance security office have been completed with this community support.



School Safety:

Our Referendum, which was approved in March of 2023, allowed us to build a secure visitor vestibule area and office for personnel at our front doors. Ceiling and lighting upgrades in all hallways were completed, along with roofing repairs. Our building has a dedicated SLEO assigned each day, and we have a strong working relationship with the local police department. Saddle Brook MS/HS has a School Climate and Safety Team that meets throughout the school year. We collaborate with local agencies to complete all required school security drills monthly. We comply with all state requirements for safety such as having a Threat Assessment Team that collaborates on interventions to support our students.

Technology and STEM:

Each student and teacher has a dedicated Chromebook assigned to them. Our building has begun the transition from interactive Smartboard projectors to Interactive Displays in each classroom. Technological skills established in our middle grades program lead to future coursework at the high school level in Digital Editing & Design, TV Production, Computer Science, CAD Modeling & Manufacturing, Engineering, and Robotics. In addition, high school students can participate in Aviation and Aerospace coursework that leads to related certification.



Early Childhood Education:

Our students are serving in the Tomorrow's Teacher program which for some includes service at the district's early childhood center. We are proud of this endeavor hosted in partnership with Rider University. The SBHS Service Learning Club volunteers to lead seasonal programming with our pre-school students.



Attendance:

To improve and maintain regular school attendance, SBPS has implemented several evidence-based practices, including data-driven analysis of absenteeism to identify trends and target interventions effectively. Our Attendance support teams monitors attendance and provide timely interventions, while consistent communication with parents about the importance of attendance is facilitated through multiple channels. Fostering positive home-school relationships is emphasized through events and parent engagement programs, alongside verifying student residency to maintain accurate records. Early support systems are established by training staff to recognize truancy signs, connecting families with social services, and creating individualized action plans through the I&RS team. Collaborating with local agencies like NJ4S and leveraging resources from the Department of Truancy further enhances support. Educational workshops for families, student engagement activities, and recognition program
