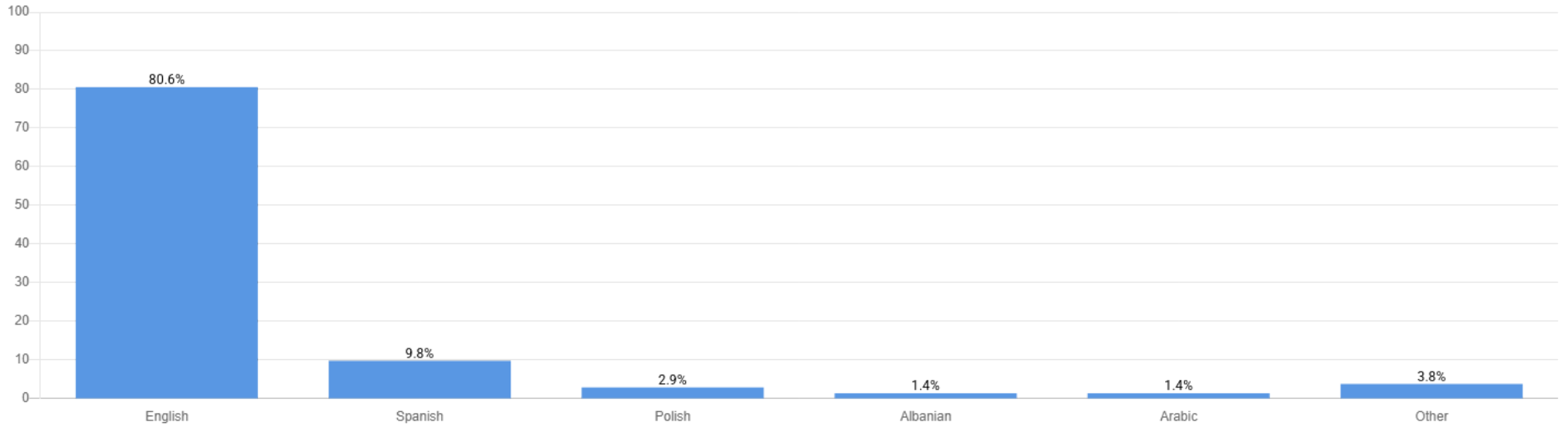

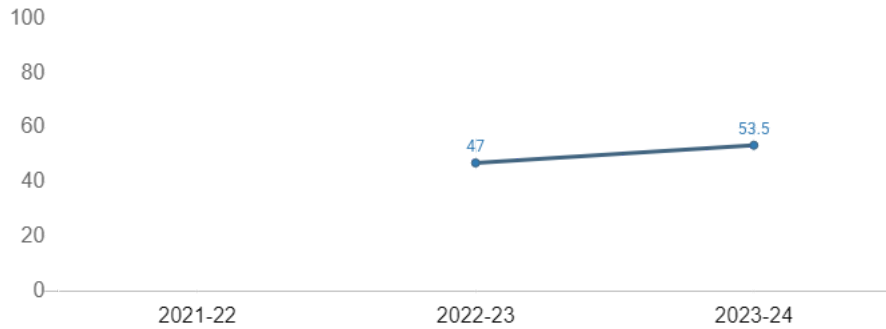

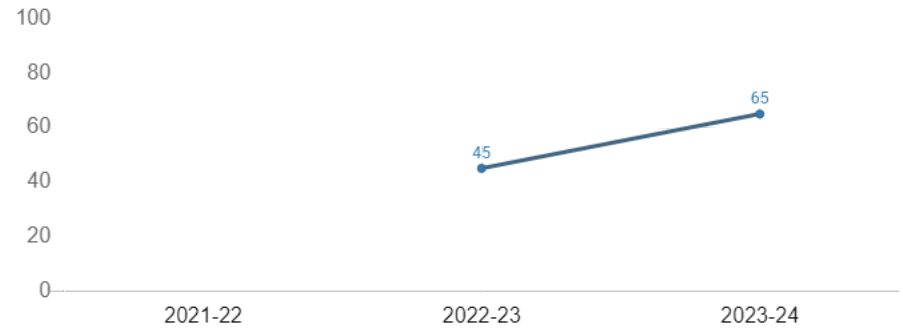

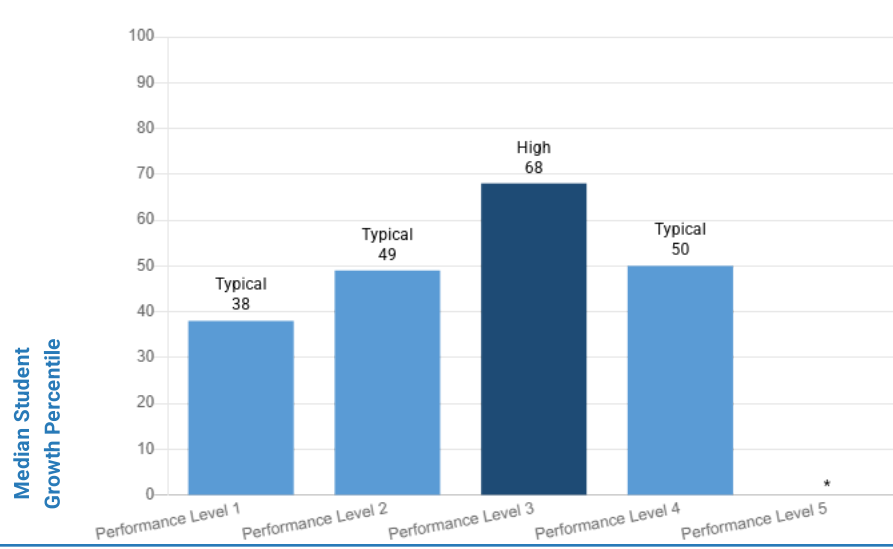

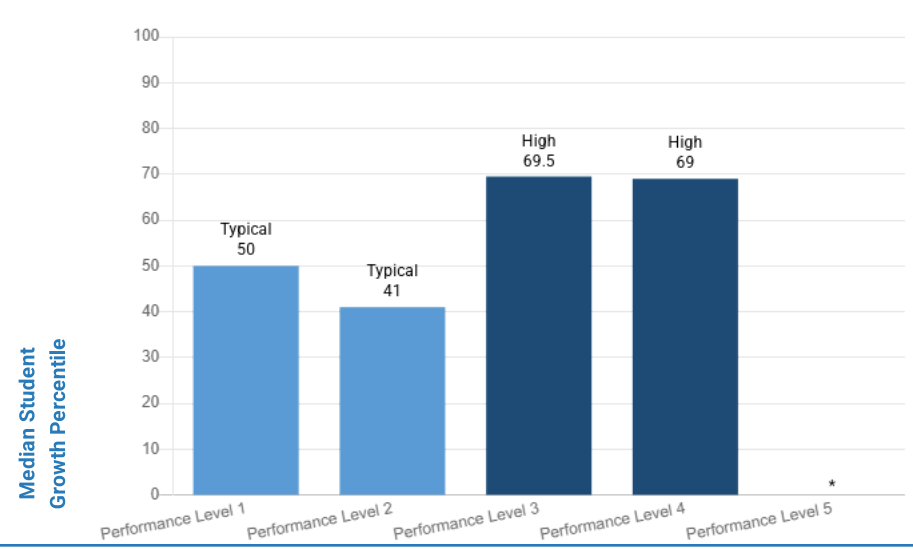

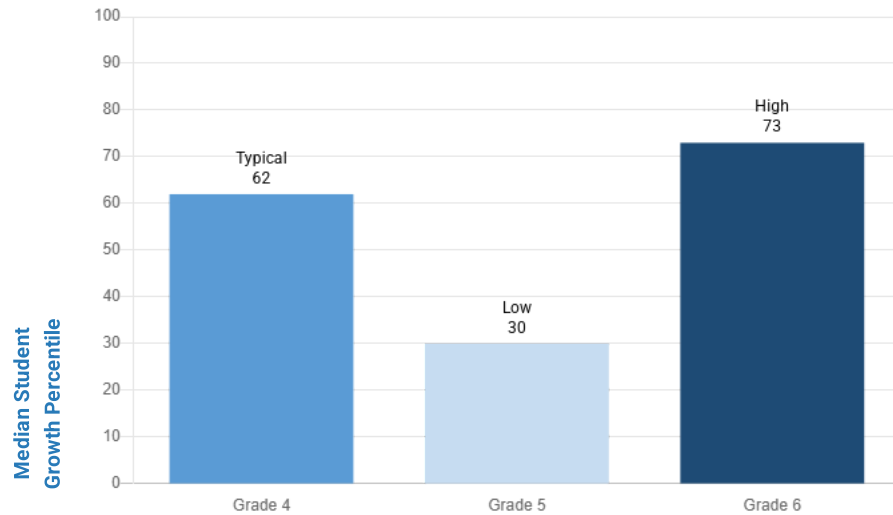

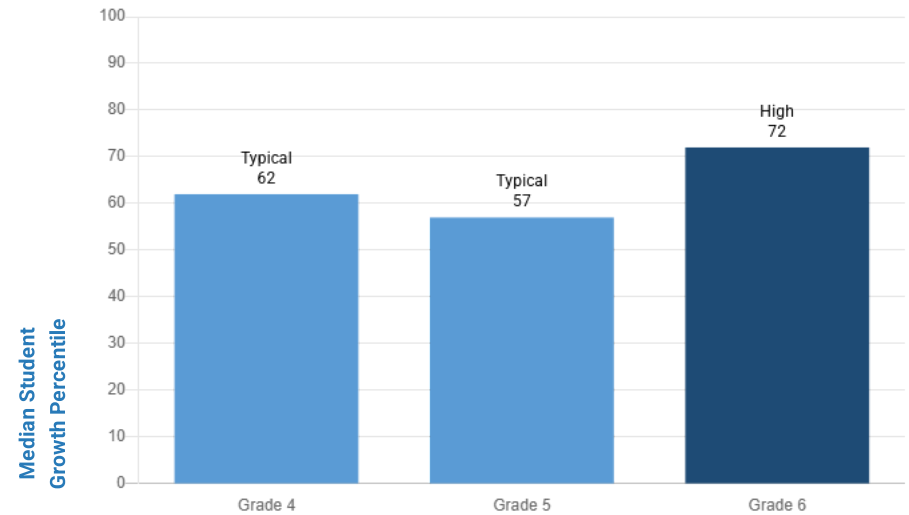

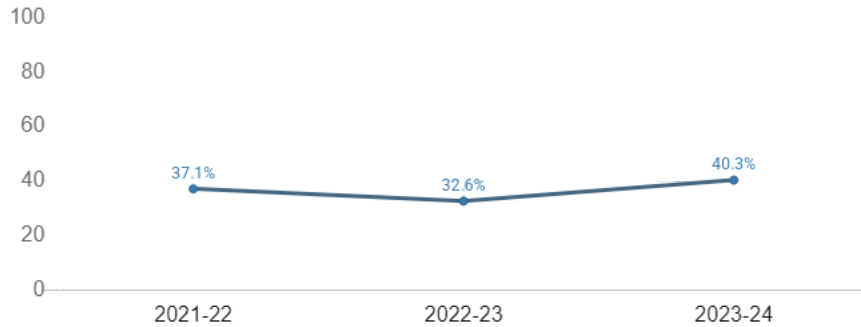

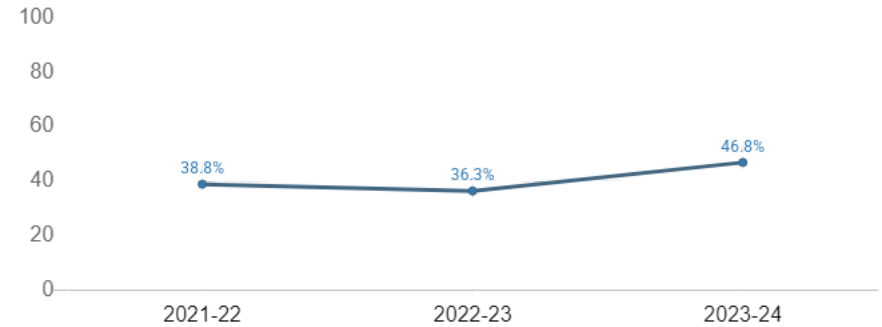
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 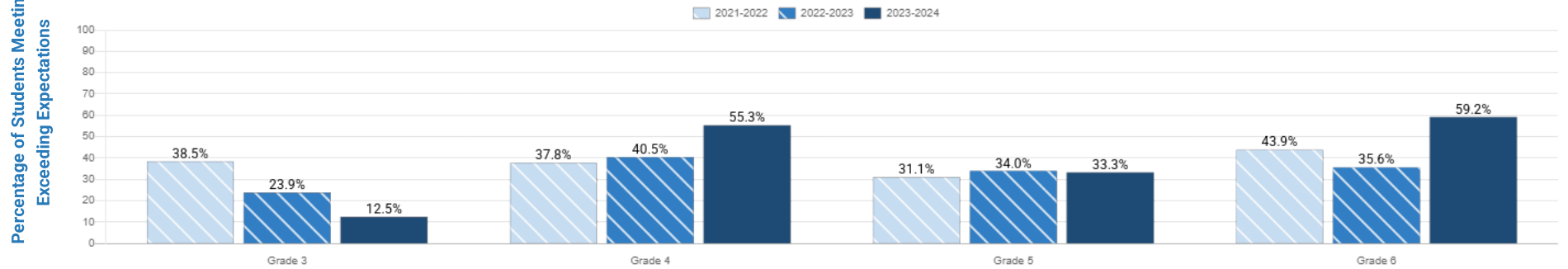

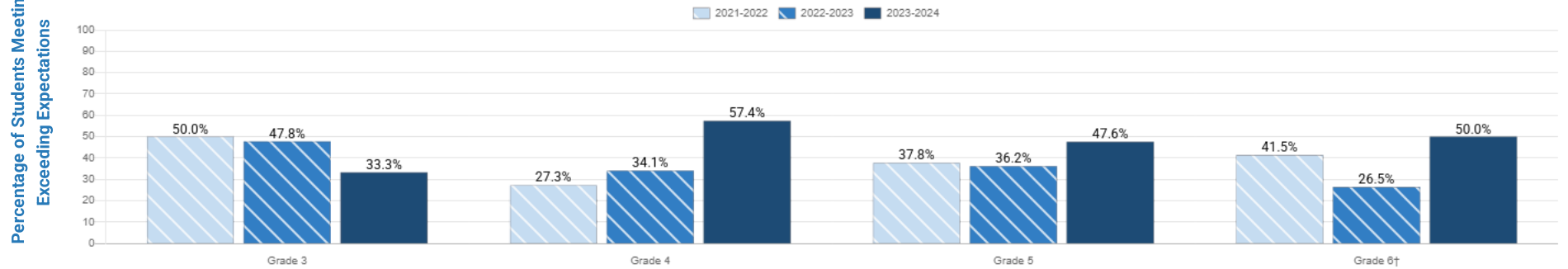

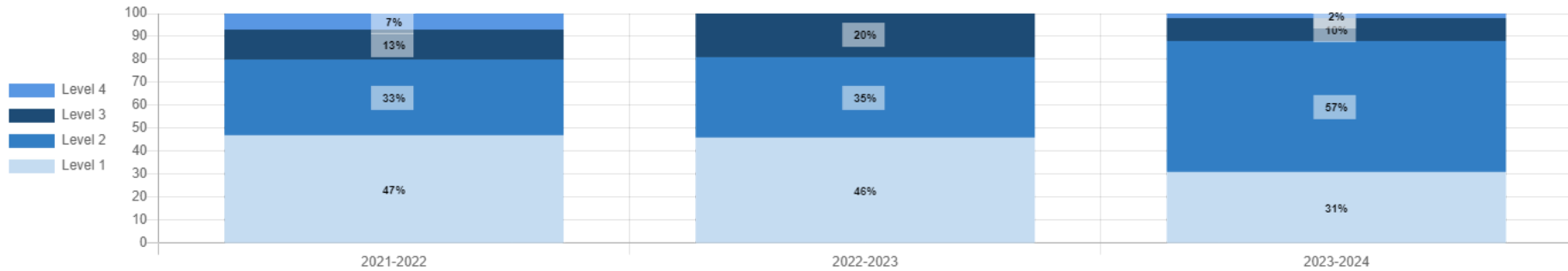

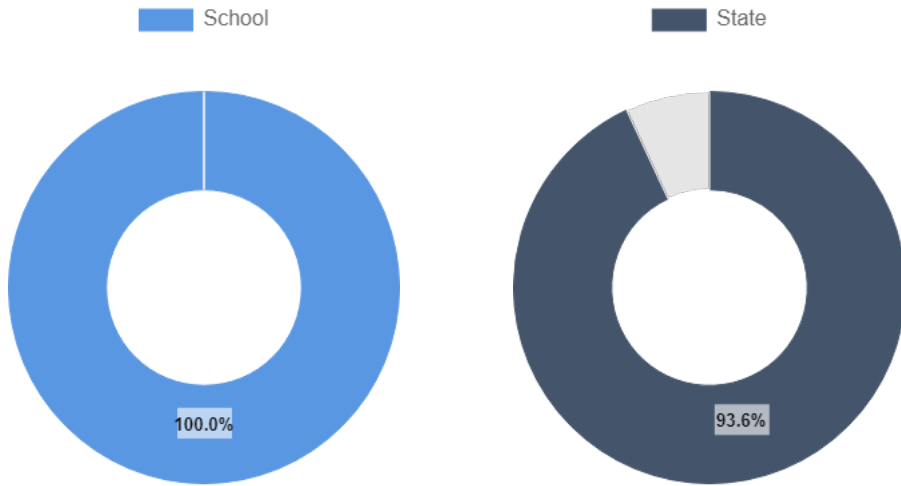

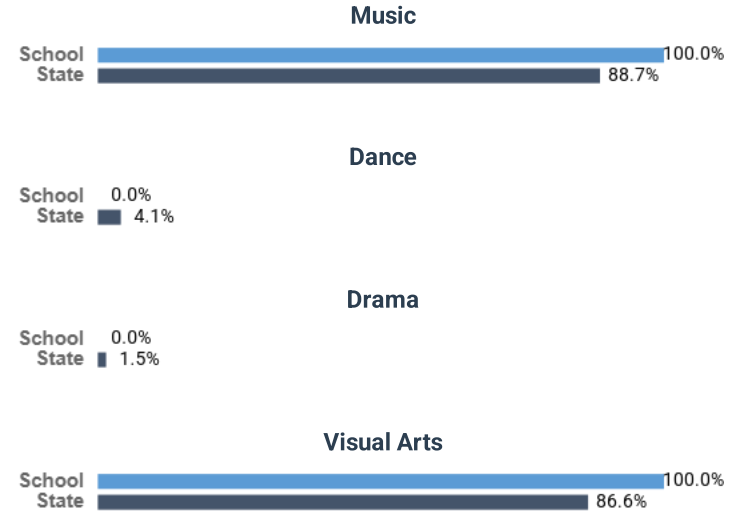

Students enrolled in one or more classes by discipline:



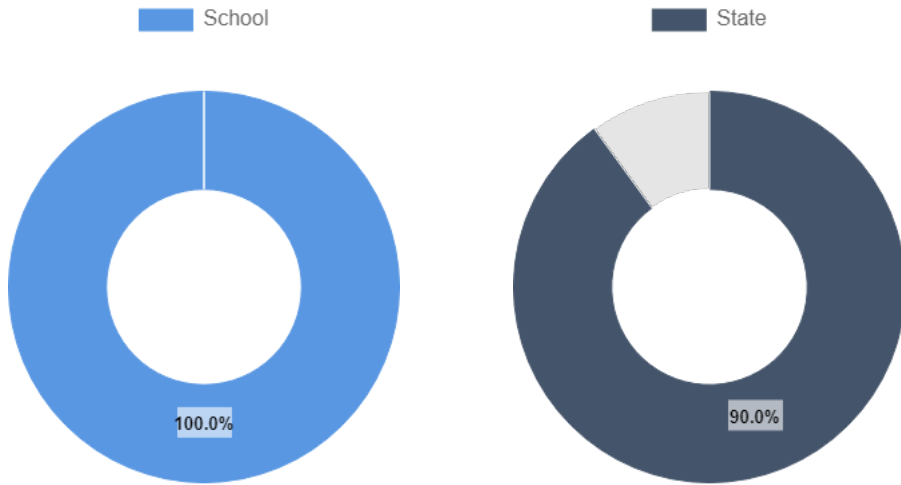

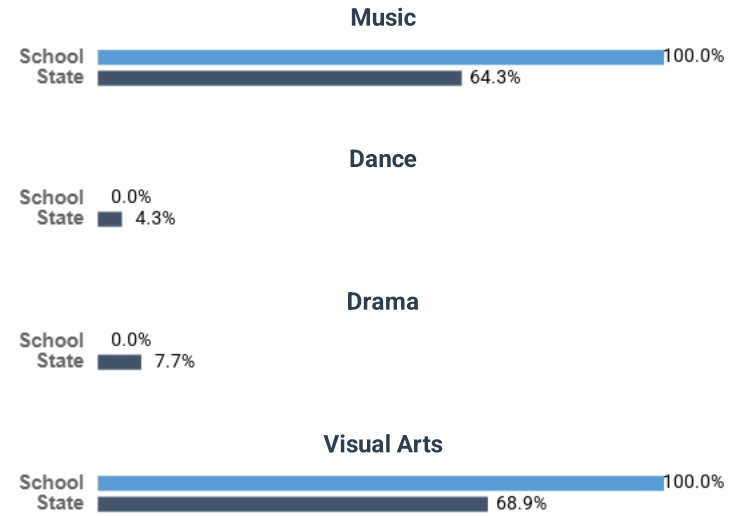

Students enrolled in one or more classes by discipline:



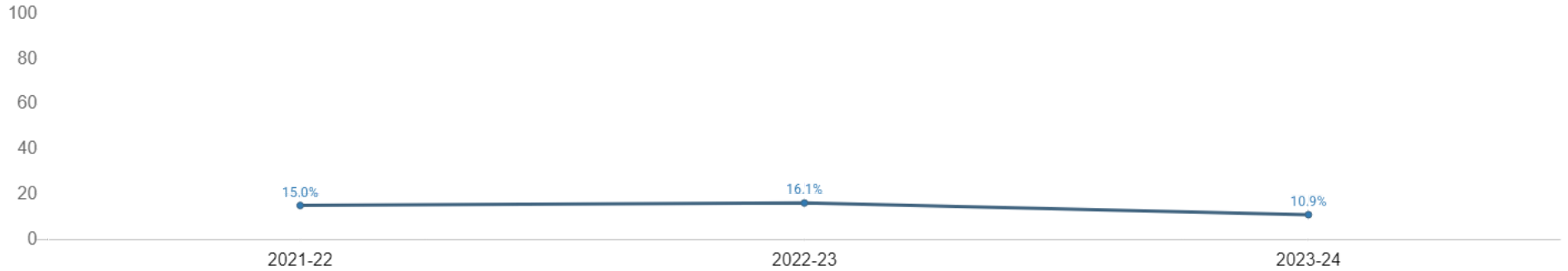

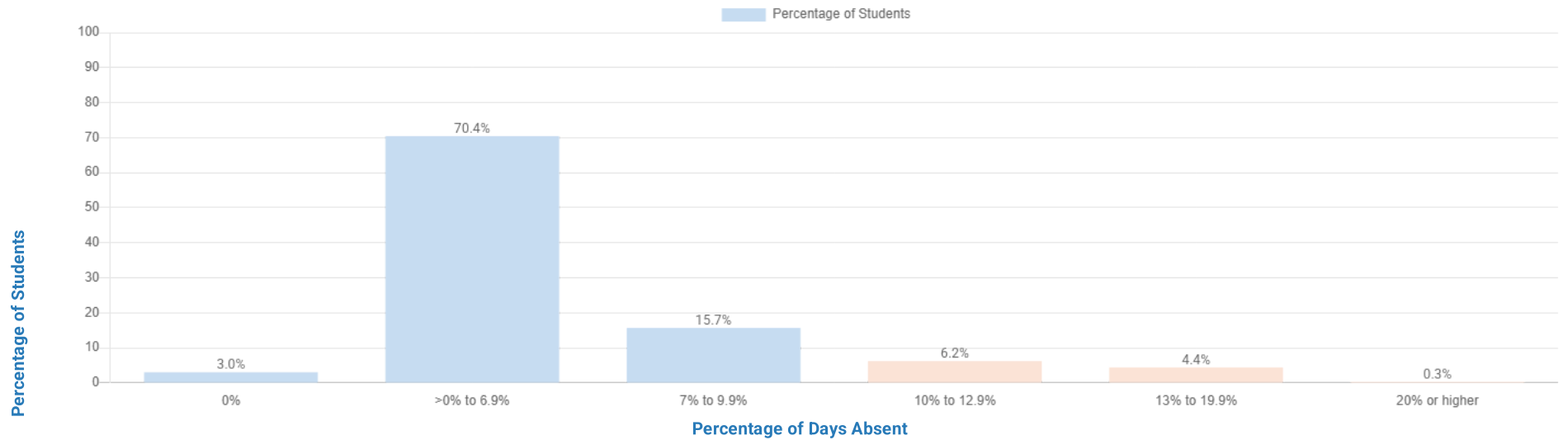

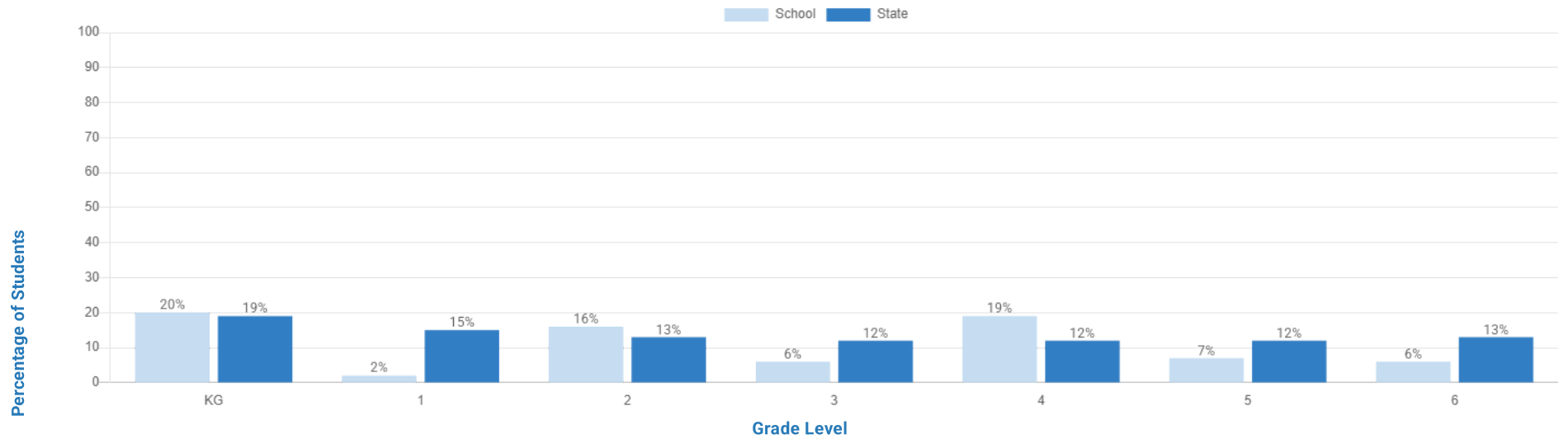

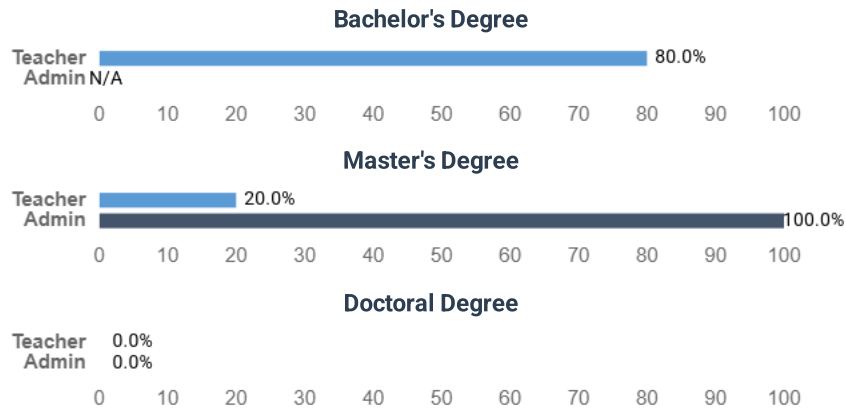

Courses, Curriculum, Instruction:

The Saddle Brook School District started a new curriculum in grades K-2 using Amplify CKLA which is aligned with the Science of Reading. Students in grades 3-6 follow a Balanced Literacy approach. Smith teachers and students continued to work with Google Apps for Education and we expanded our 1:1 Chromebook initiative to include students in Grades 3-6.

Staff and Professional Learning:

Our staff training focused around the Science of Reading in grades K-2 as we began a new literacy program, Amplify CKLA. Our ELA staff in grades 3-6 were supported in balanced literacy with a literacy consultant. Staff are encouraged to seek out and attend appropriate PD throughout the year. Several staff members attend courses to support Math through Conquer Math.



Postsecondary Information:

Our teachers supported our high school students' post-secondary interests by hosting Tomorrow's Teachers interns into our classrooms for lesson observations and work-based learning experiences. During the 2023-2024 school year, the district served as a lab site for Ramapo College and Smith School had 4 clinical interns.



Student Supports and Services:

Special Education and ELL services are offered to students who are deemed eligible. We have one reading specialist and a basic skills instructor in math. In addition, our Data team worked collaboratively with parents and teachers to foster student success and tiered interventions. Helen I. Smith parents of special education students had the opportunity to participate in the district SEPAG activities which included meetings and workshops for parents.

Helen I Smith students participated in Week of Respect, Red Ribbon Week, and National Unity Day focusing on anti-bullying and community building. District Wellness Day participation was used to support our learners periodically throughout the year.

The Smith PTO is an important component of our school-wide community. These dedicated parents sponsor many social events with the purpose of fundraising for additional student programs. Facilities:

Annual improvement projects included classroom upgrades, Media Center upgrades, painting in some rooms, and new tiles. The referendum passed in December 2023 allowed Smith School to gain upgrades to our hallway lighting, and ceiling tiles. Smith staff are working with a grant to develop a Wellness Room for our students.



School Safety:

Our Referendum, approved in March of 2023, allowed us to build a secure visitor vestibule area and other related security upgrades. Ceiling and lighting upgrades in all hallways were completed, along with roofing repairs. Our building has a dedicated SLEO assigned daily, and we enjoy a strong working relationship with the local police department. Smith ES has a School Climate and Safety Team that meets throughout the school year. We collaborate with local agencies to complete all required school security drills monthly. We comply with all state requirements for safety such as having a Threat Assessment Team that collaborates on interventions to support our students.



Technology and STEM:

Digital platform integration continued to be a significant focus for teaching and learning. The district 1:1 Chromebook initiative provided the means to catapult this. The district has begun transitioning from interactive projectors to interactive displays in our classrooms.

Attendance:

To improve and maintain school attendance, SBPS uses data-driven analysis to identify absenteeism trends and tailor interventions. Smith ES has attendance support teams that monitor attendance and offer timely interventions, with frequent communication to parents about its importance. Positive home-school relationships are fostered through events and engagement programs while verifying student residency ensures record accuracy. Staff receive training to identify truancy signs, connect families with social services, and create individualized action plans with the I&RS team. Collaboration with agencies like NJ4S, along with workshops, student activities, and attendance recognition programs, incentivize attendance. Staff receive ongoing professional development, and regular evaluation through surveys and data analysis refines these approaches, forming a comprehensive attendance framework.
