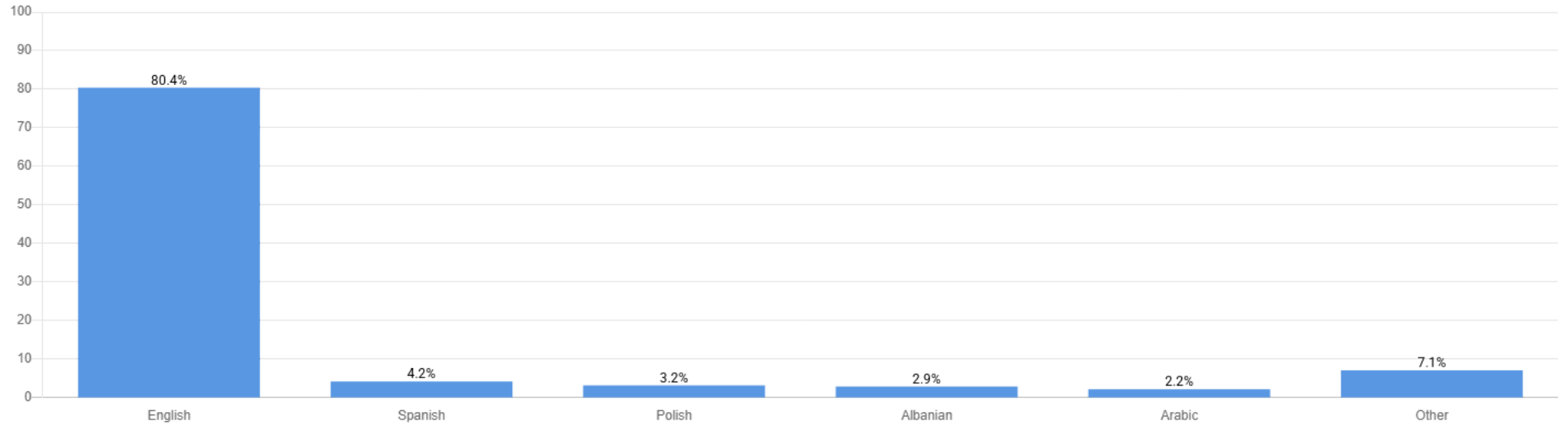

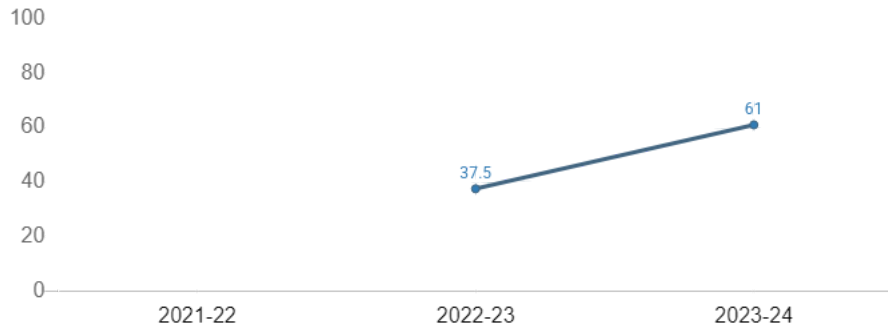

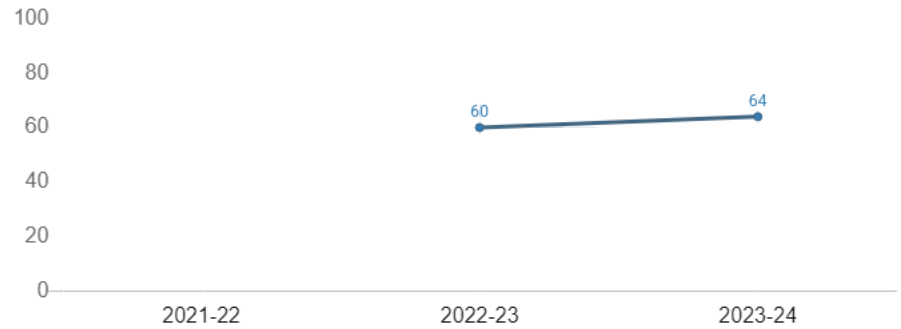

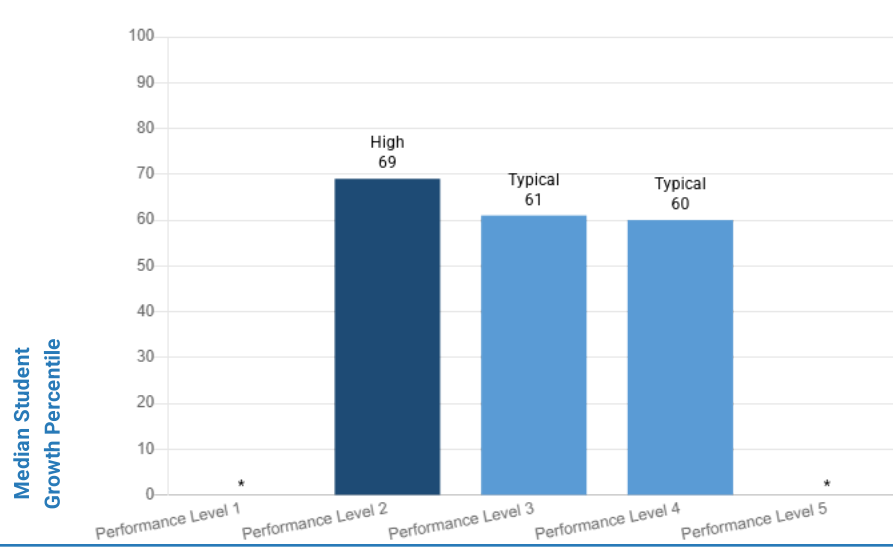

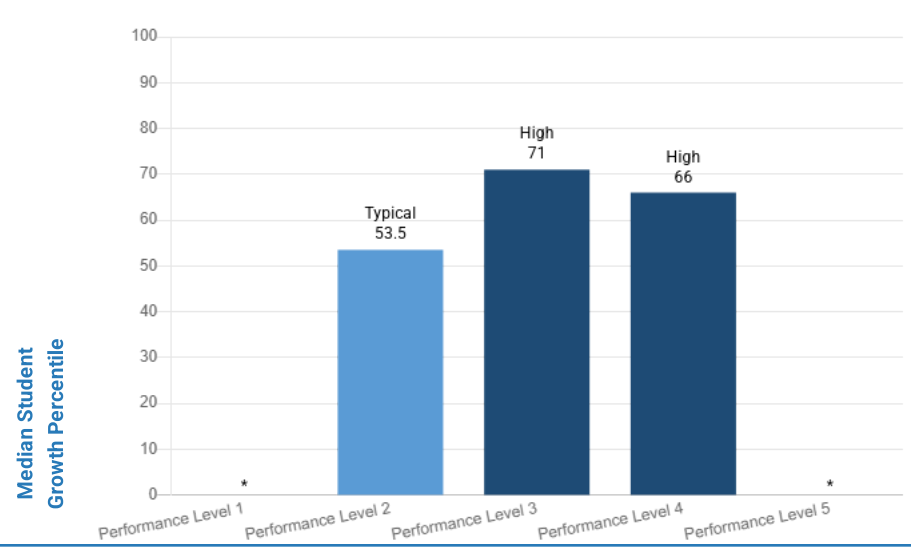

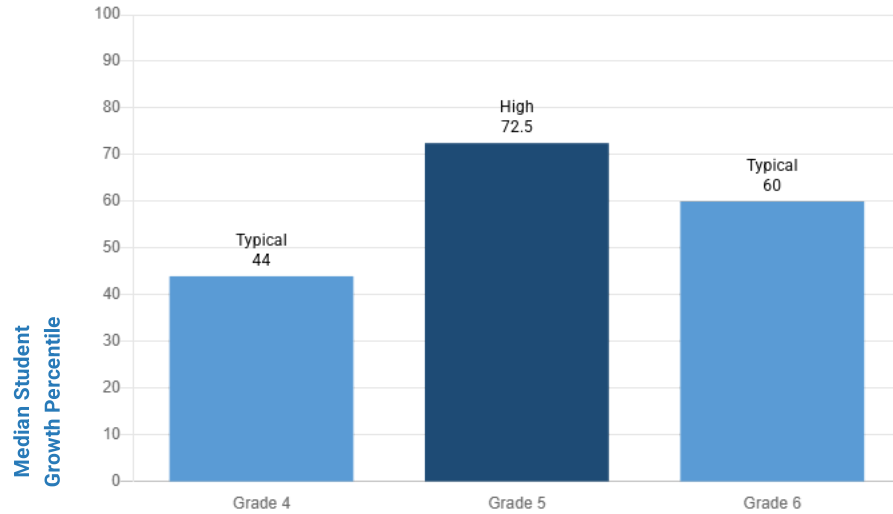

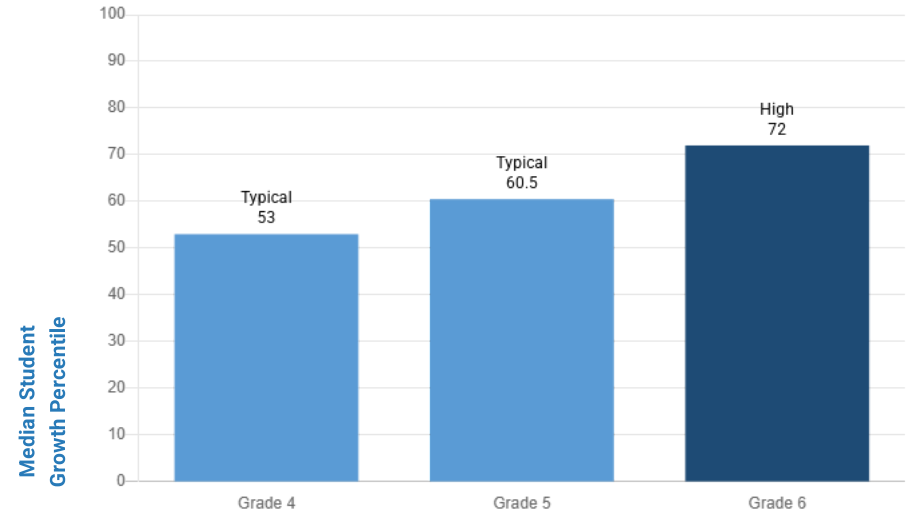

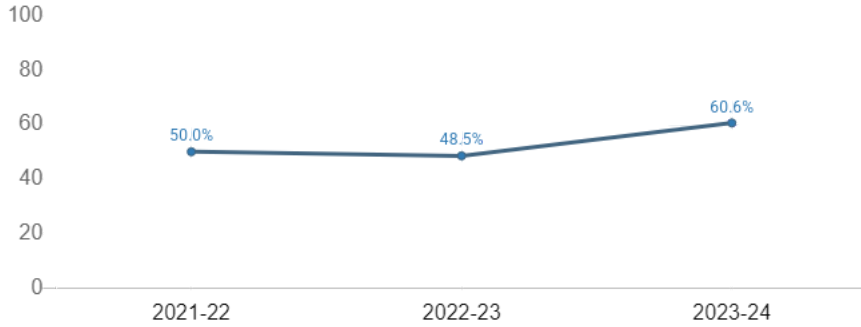

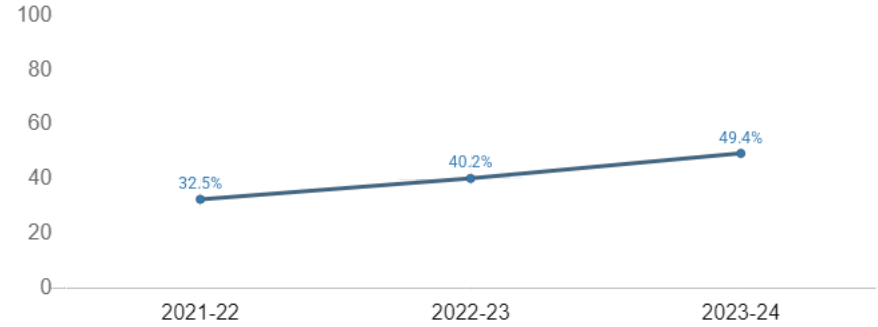
### English Language Arts and Mathematics Performance Trends

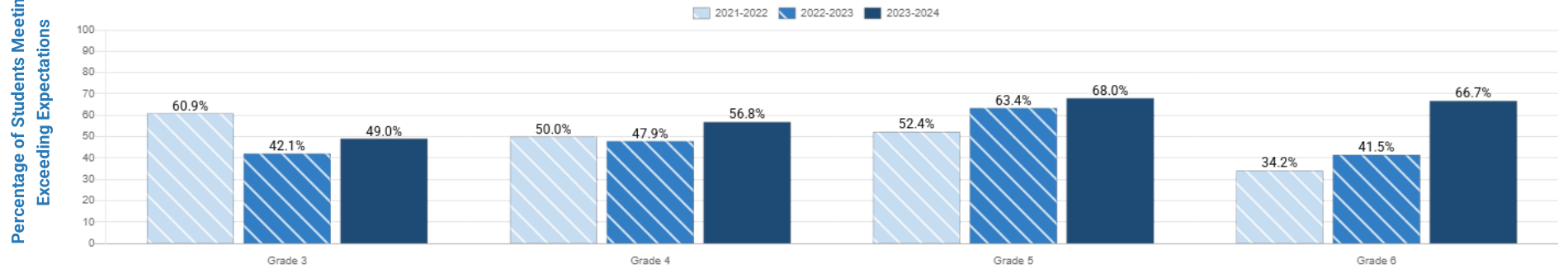

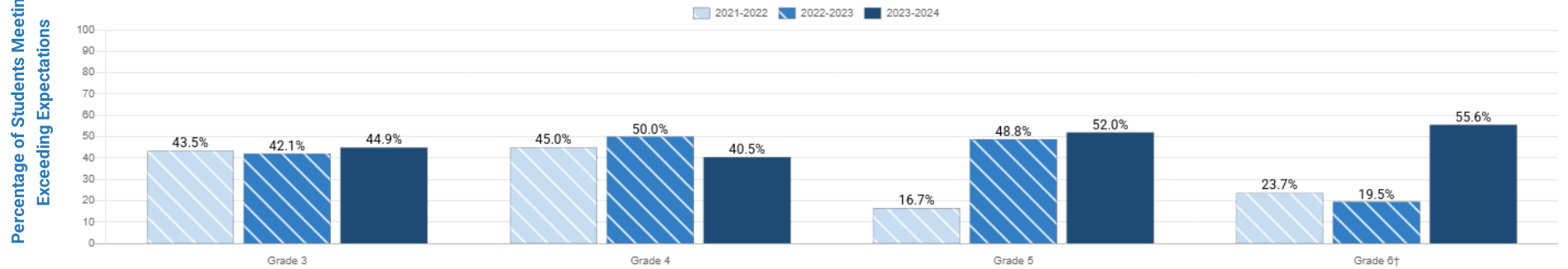

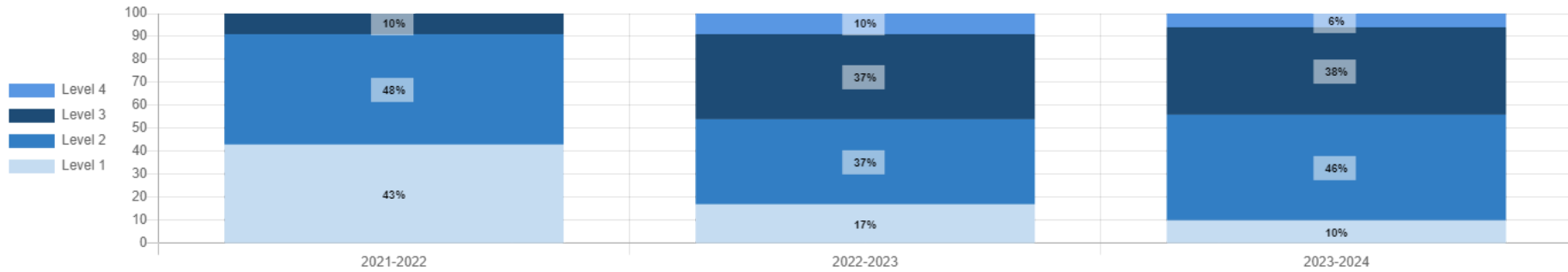

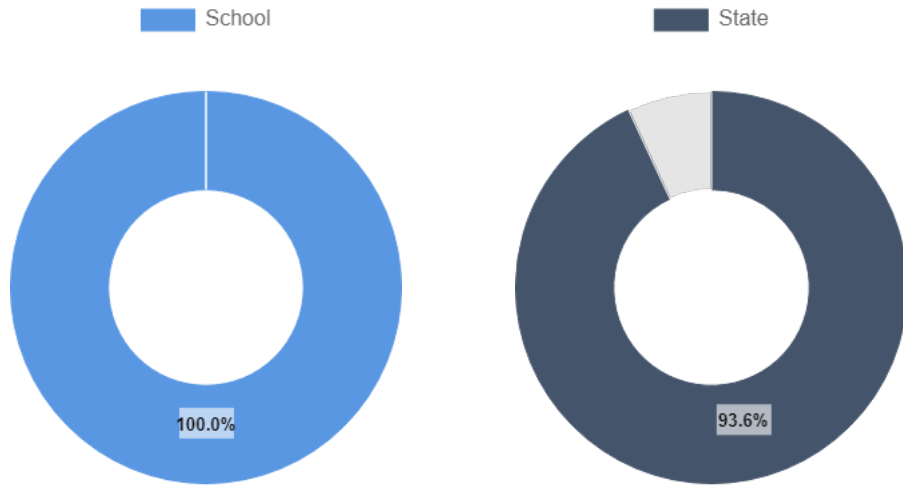

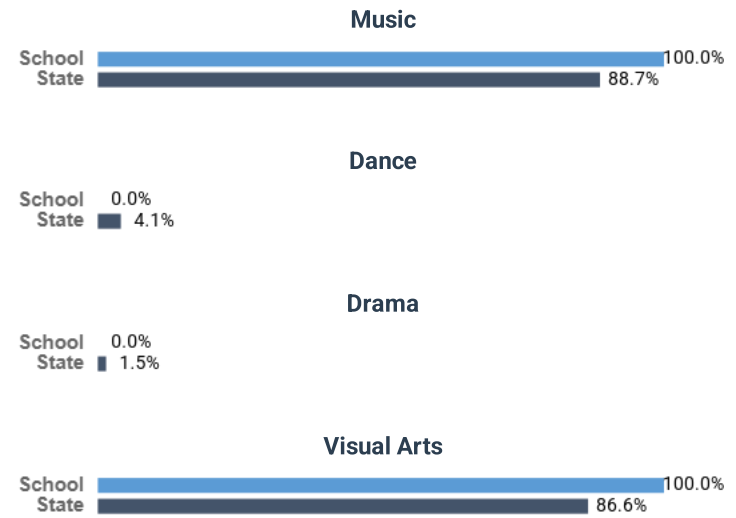

**Students enrolled in one or more classes by discipline:**



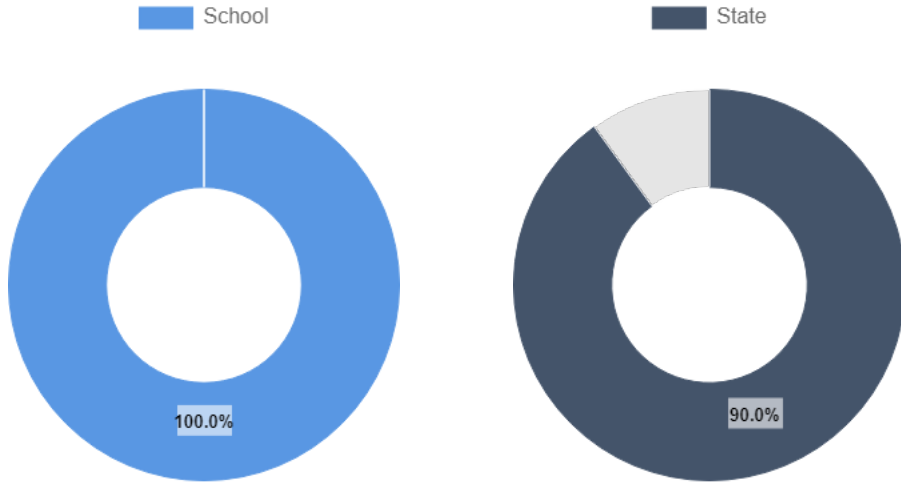

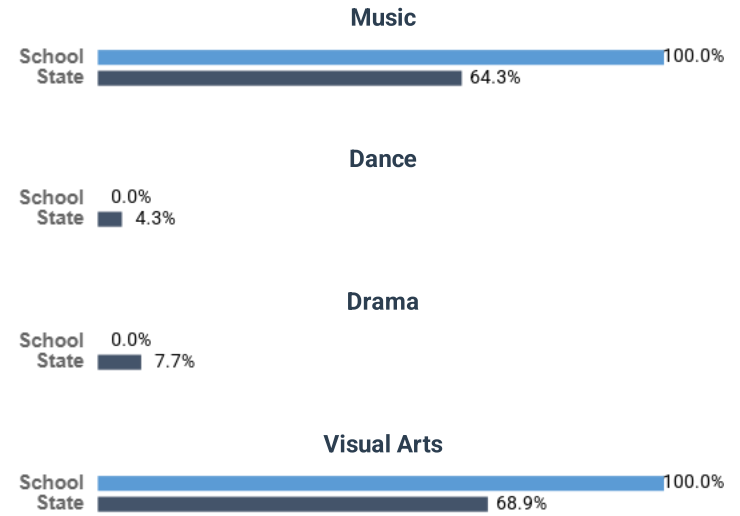

**Students enrolled in one or more classes by discipline:**



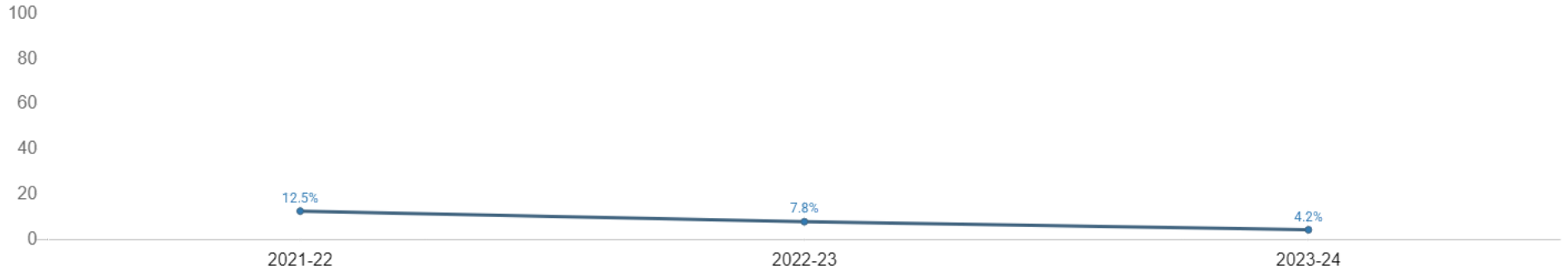

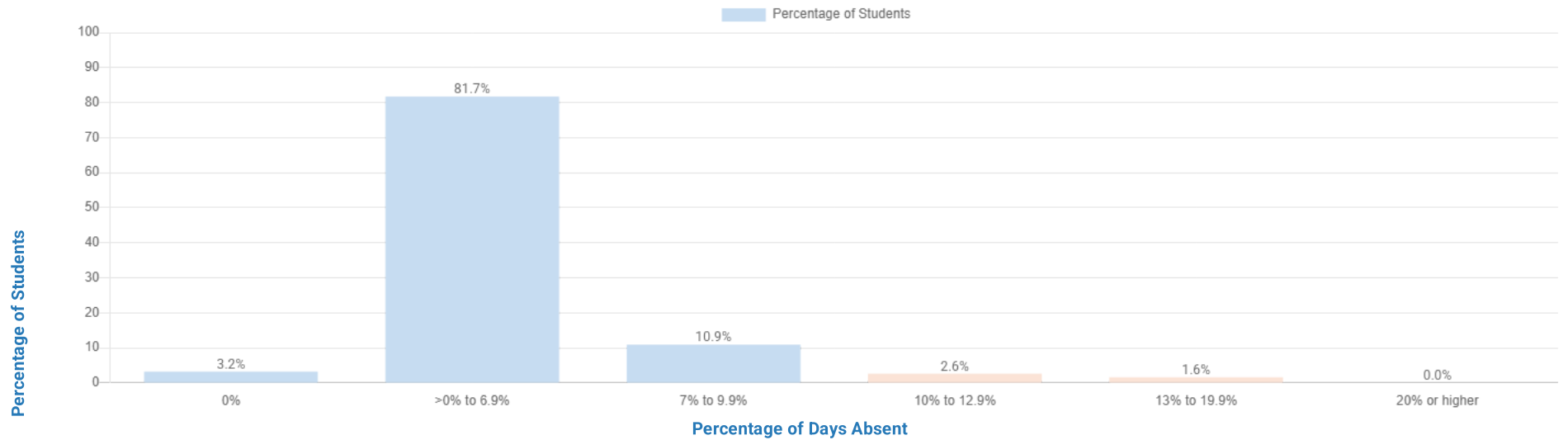

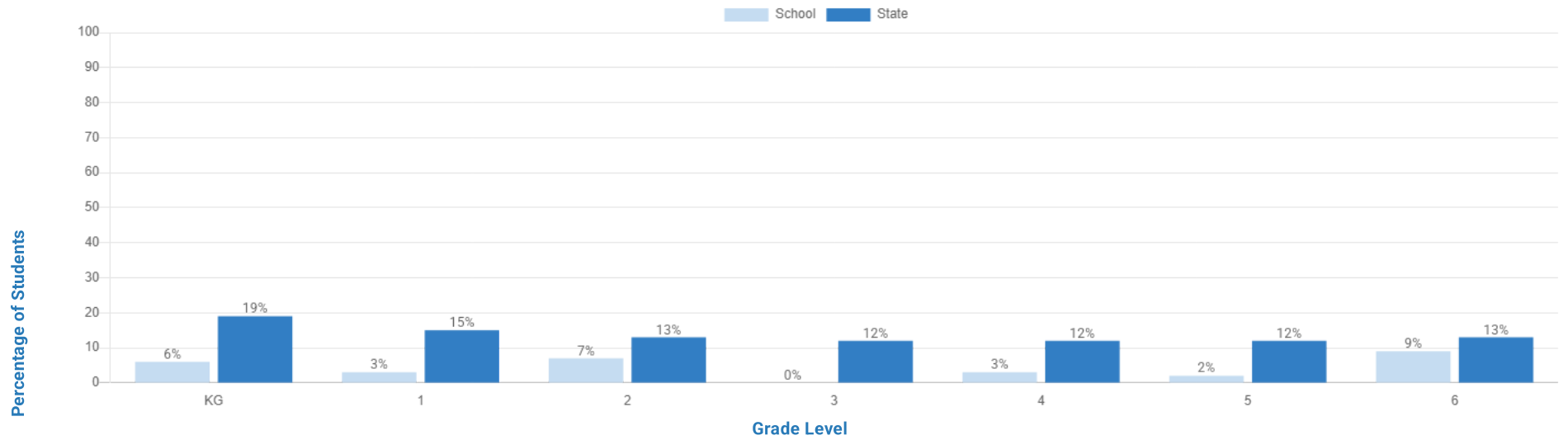

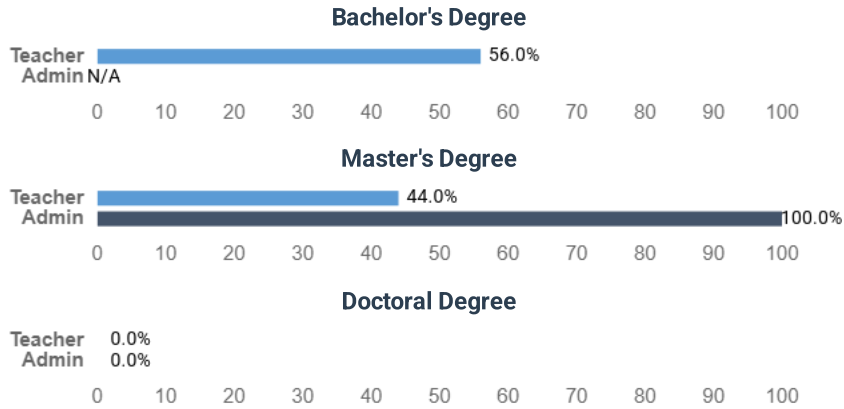

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. ### Mission, Vision, Theme:

Long Memorial School's mission is "to educate all who are involved within the school community in a caring and nurturing manner. The staff, students, parents, and community will work diligently to create a safe, and educational environment. Defined by ethical values and principles we will be open to change. We will be supportive and keep open the lines of communication. Through dialogue, collaboration, and openness we will promote an educational system of exceptional value". This year, we created a school theme to represent our school. Students are empowered to represent Long School by Leading by example, using Optimistic Thinking, Navigating Situations, and showing Grit and Determination.



### Awards, Recognition, Accomplishments:

LMS updated its student recognition program where students were acknowledged for displaying great character by becoming a BRIGHT winner (Building Relationships, Inspiring Greatness, High Expectations Together). Students selected were celebrated by being announced and recognized on our school bulletin board. Sixth Grade students who met the criteria received awards at promotion for demonstrating character and academic excellence and achievement. The awards were the Presidential Award for Academic Excellence, the Presidential Award for Academic Achievement, and the BRIGHT Character Award. Sixth Grade students also received a leadership award for epitomizing the theme of LONG-Leading by example, using Optimistic Thinking, Navigating Situations, showing Grit and Determination. A Teacher was selected as Bergen County's Educational Professional of the Year, receiving nominations from the community, and being selected by a committee.

### Courses, Curriculum, Instruction:

The Saddle Brook School District utilized a literacy curriculum in Grades K-2 grounded in the Science of Reading, to develop strong readers, writers, and thinkers. Students in Grades 3-6 used a Balanced Literacy approach for ELA. Long Memorial School teachers and students continued to work with Google Apps for Education and students in Grades 3-6 were able to utilize Chromebooks as we expanded our 1:1 Chromebook initiative to include all students in the upper grades. Our weekly "BRIGHT" period provides opportunities for students and staff to foster positive relationships, infusing the competencies of Social Emotional Learning. Students who met the criteria participated in the Gifted & Talented program, using critical thinking and engineering skills to nurture and develop these students' talents to their full potential.



### Clubs and Activities:

Students had an opportunity to join the Environmental Club, Student Council, and the new LONG Leaders Club (6th Grade). The Environmental Club planted flowers and vegetables in gardens at the school. The LONG Leaders promote peer leadership, assisting in younger classrooms, at recess, and in the cafeteria, and being a tour guide at parent events. The Student Council meets monthly and sponsors various collections throughout the school year to assist community organizations. Our Music program continues to grow with a Chorus, Band, ORFF program, and 3rd grade recorders. Our students enjoyed participating in Jump Rope for Heart, Reading Challenges, P.S. I Love You Day, the Week of Respect, and Red Ribbon Week, amongst other events. Some students also participated in an after-school event, Theater Week, incorporating performing and theater arts, culminating in a performance.



### Before and After School Programs:

Students in Grades K-6 have the choice to attend before-care and after-care programs each school day through Alphabest. We also have a before-school Breakfast Program. Our faculty members expanded our after-school extra help offerings during the 23-34 school year by offering tutoring across all content areas weekly.

### Staff and Professional Learning:

Professional development took place throughout the school year to enhance teaching practices, knowledge, and skills. Professional development in Reading and Writing Workshop has been a component of the district Balanced Literacy initiative for our third through sixth-grade teachers. Teachers in Grades Kindergarten through Second Grade received extensive training in the Science of Reading and the Amplify curriculum. A selection of teachers participated in Math Professional Development through Conquer Math to improve instructional practices to improve student learning.



### Postsecondary Information:

Our teachers support our high school students' post-secondary interests by hosting Tomorrow's Teachers interns into our classrooms for lesson observations and work-based learning experiences as teachers' assistants. In addition, the Saddle Brook School District partners with Ramapo College of NJ to host their Clinical Interns in our classrooms.



### Student Supports and Services:

LMS is committed to using data to drive our Response to Intervention (RTI) instruction. Data is essential for identifying students' academic needs. We have a Reading Specialist and a Math Basic Skills Instructor. Further support can be found through the services of the NJTSS Committee. Parents of special education students have the opportunity to participate in the district SEPAC activities which include meetings and workshops for parents. Our English Language Learners are serviced by our ESL teacher, and instruction focuses on providing language learners with the skills necessary to communicate effectively in English. It encompasses a wide range of skills, including listening, speaking, reading, and writing. The program continues to demonstrate growth and their work was celebrated in a Multicultural Night.

### Student Health and Wellness:

The SEL competencies are an emphasis of the LMS character education program. LMS students participate in Week of Respect and National Unity Day each year, emphasizing anti-bullying and community building. District SEL Days were held to support our students periodically throughout the year. A Breakfast program is offered, that our school nurse is an active member of and is present daily. Students have physical education classes two times per week, as well as daily recess where they participate in various activities including basketball, soccer, volleyball, and playground play.



### Parent and Community Involvement:

The LMS PTO is an important component of our school-wide community. These dedicated parents sponsor many social and educational events with the purpose of fundraising for additional student programs. With their support, we held an assembly that infused social-emotional learning with performing and visual arts. The PTO meets monthly to discuss and plan ways to support education in our school. The district held multiple Parent Partnership nights that our school supported. There is a Parent Portal for parents to gain access to academic records for their child to further be a partner in their education. The schools partner with the Saddle Brook Educational Foundation, which sponsors a Walk-a-thon that raises money to benefit our schools. There are opportunities for community readers to visit classrooms as well, reading to students, and being a part of their elementary school experience.



### Climate Surveys:

### Facilities:

Annual building improvement projects included phases of classroom painting and the installation of new flooring, as well as a new playground fence. A front vestibule was added for additional safety and security. Air conditioning systems were serviced to provide all classroom spaces with air conditioning. Long Memorial School has a Media Center, Music Room, Art room, Gymnasium, Cafeteria, and Occupational Therapy and Physical Therapy room, in addition to dedicated rooms for services such as Special Education, Speech Therapy, School Counseling, and Basic Skills Instruction.



### School Safety:

Our Referendum, approved in March of 2023, allowed us to build a secure visitor vestibule area and other related security upgrades. Ceiling and lighting upgrades in all hallways were completed, along with roofing repairs. Our building has a dedicated SLEO assigned daily, and we enjoy a strong working relationship with the local police department. Long Memorial ES has a School Climate and Safety Team that meets throughout the school year. We collaborate with local agencies to complete all required school security drills monthly. We comply with all state requirements for safety such as having a Threat Assessment Team that collaborates on interventions to support our students.



### Technology and STEM:

Digital platform integration continued to be a significant focus for teaching and learning. The district 1:1 Chromebook initiative provided devices to each student in grades 3-6. Students in Grades Kindergarten-2nd Grade have Chromebook carts in their classroom to utilize. Updates started to replace Smart Boards with newer interactive boards and wireless stations to make learning more dynamic. The Media Specialist infuses coding and engineering into programs.

Long Memorial works in partnership with Washington School to provide transitional strategies and skills for primary learners. Washington School is the building in Saddle Brook that services our preschool students.



### Attendance:

To improve and maintain regular school attendance, SBPS has implemented several evidence-based practices, including data-driven analysis of absenteeism to identify trends and target interventions effectively. Attendance support teams at LMS monitor attendance and provide timely interventions, while consistent communication with parents about the importance of attendance is facilitated through multiple channels. Fostering positive home-school relationships is emphasized through events and parent engagement programs, alongside verifying student residency to maintain accurate records. Early support systems are established by training staff to recognize truancy signs, connecting families with social services, and creating individualized action plans through the I&RS team. Collaborating with local agencies like NJ4S and leveraging resources from the Department of Truancy further enhances support. Educational workshops for families, student engagement activities, and recognition program
