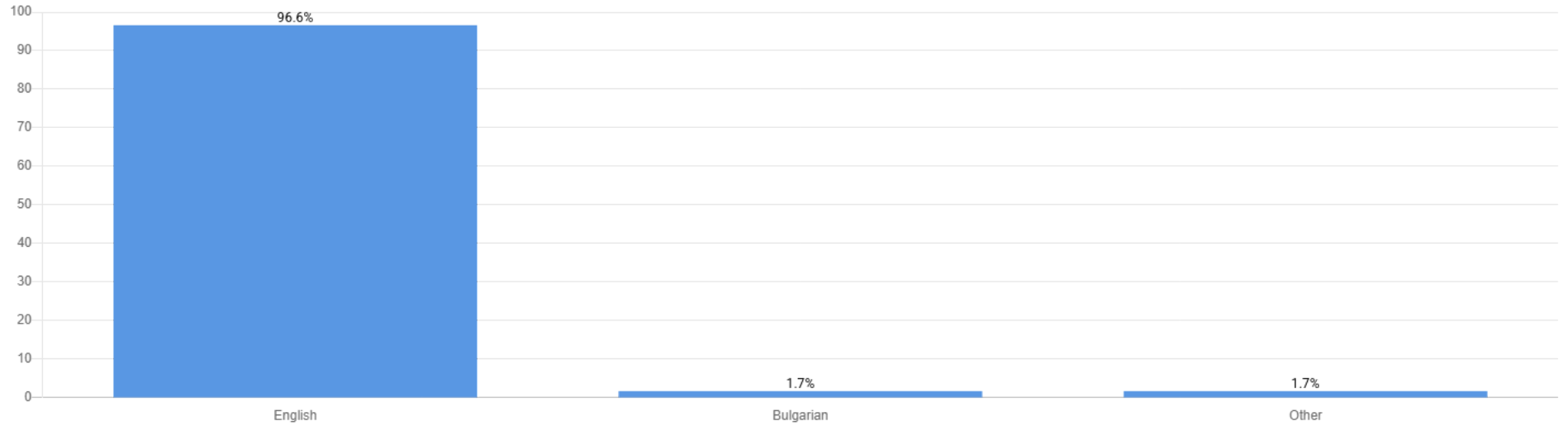

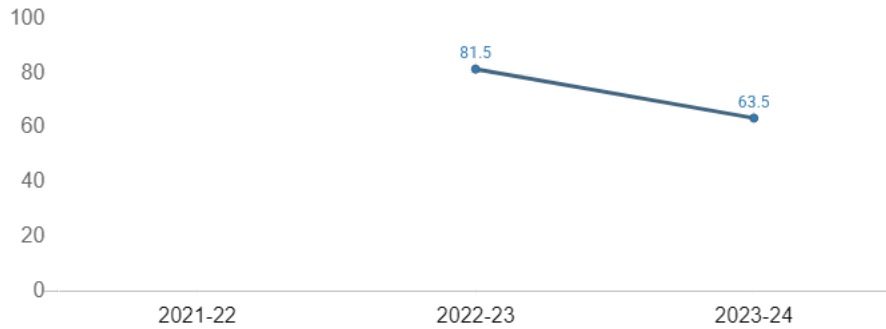

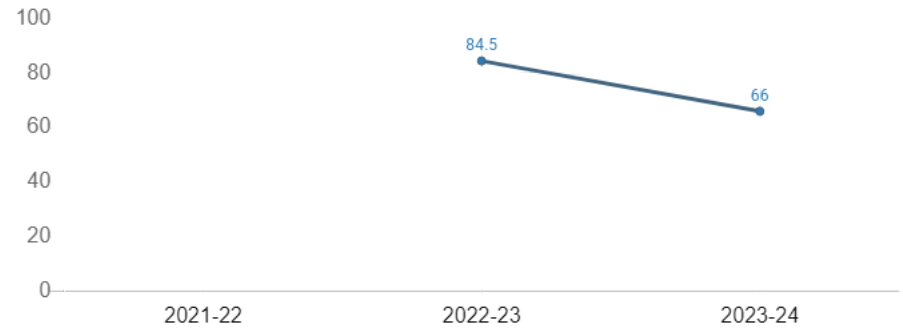

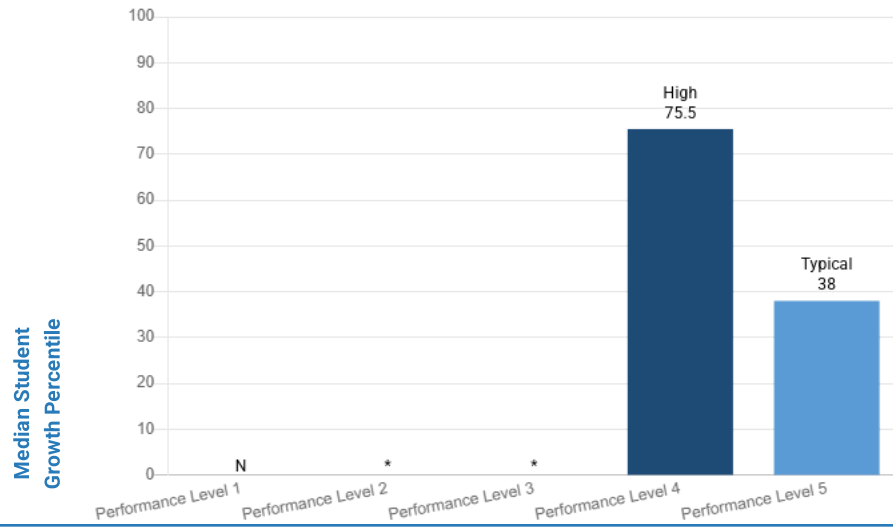

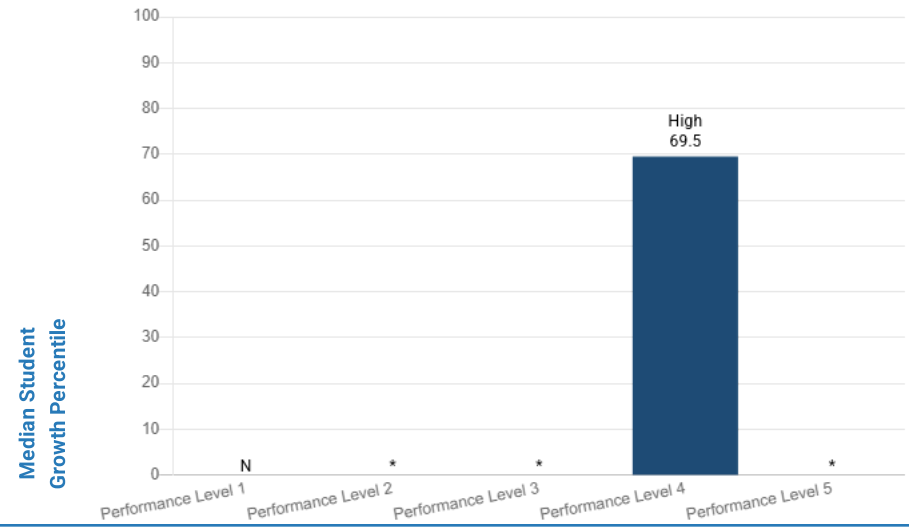

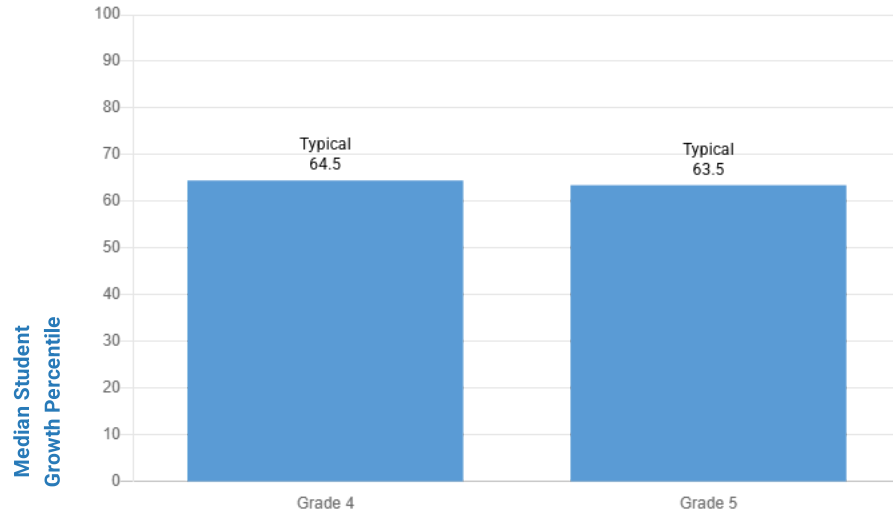

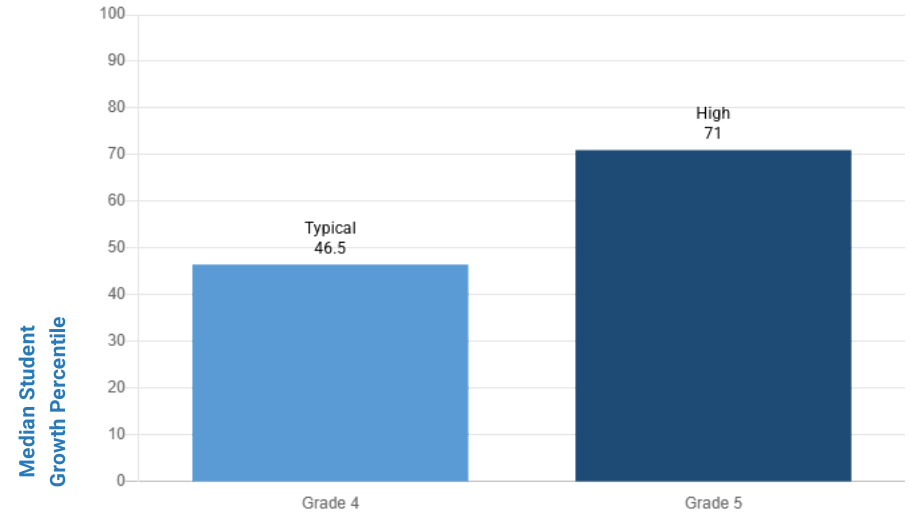

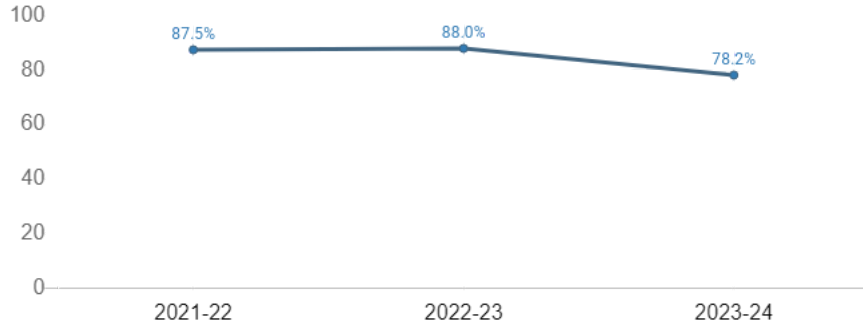

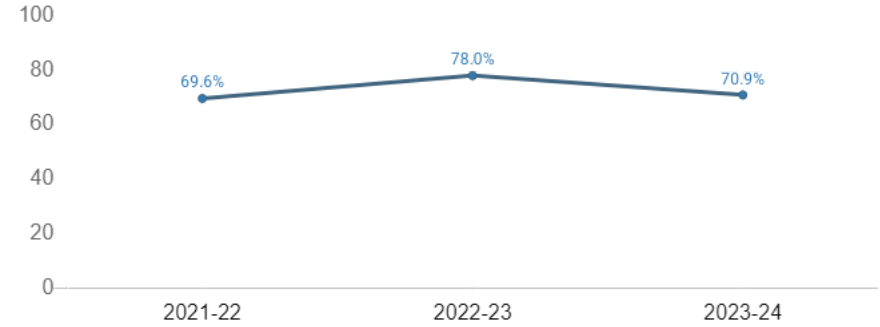
English Language Arts and Mathematics Performance Trends

English Language Arts Assessment - Participation and Performance

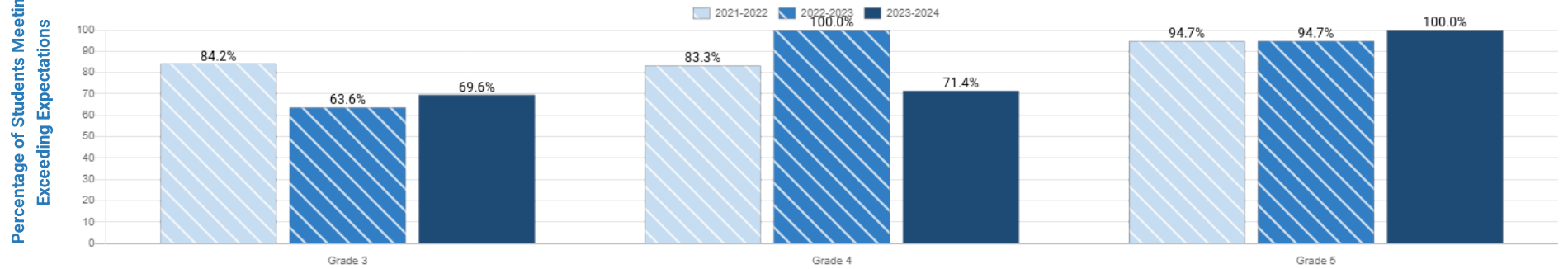

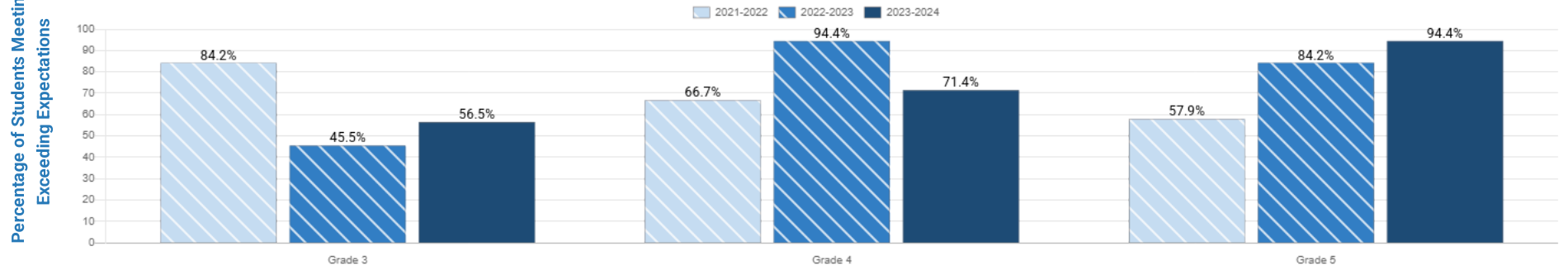

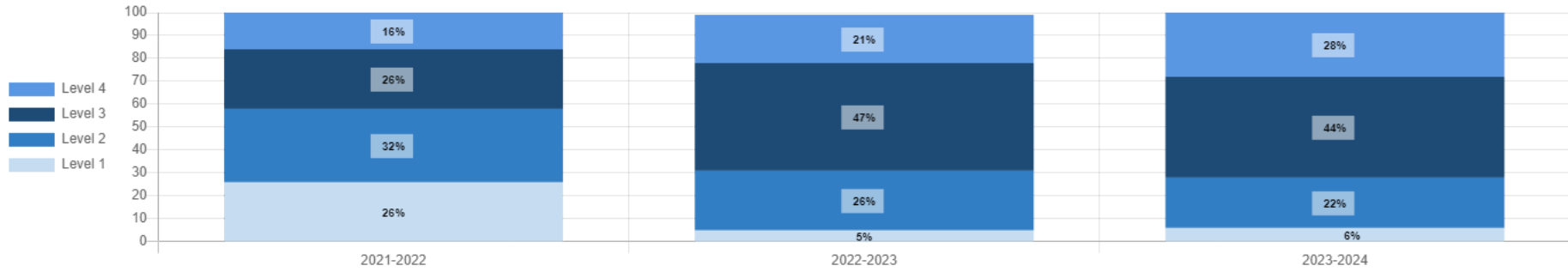

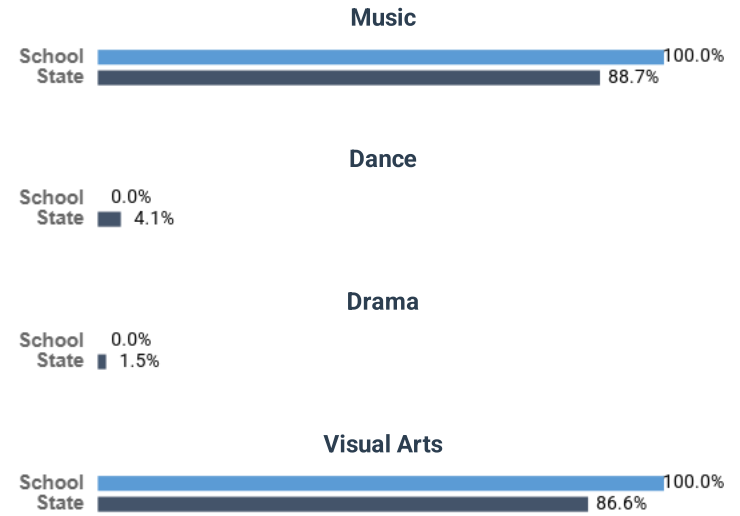

Students enrolled in one or more classes by discipline:



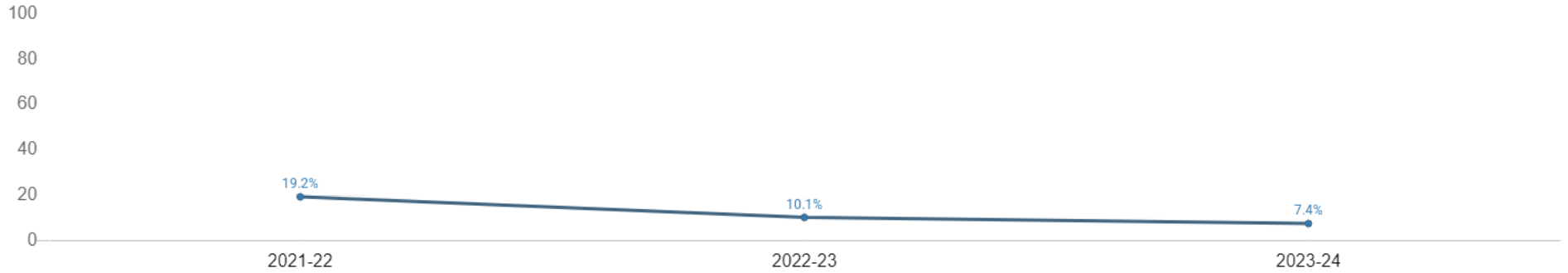

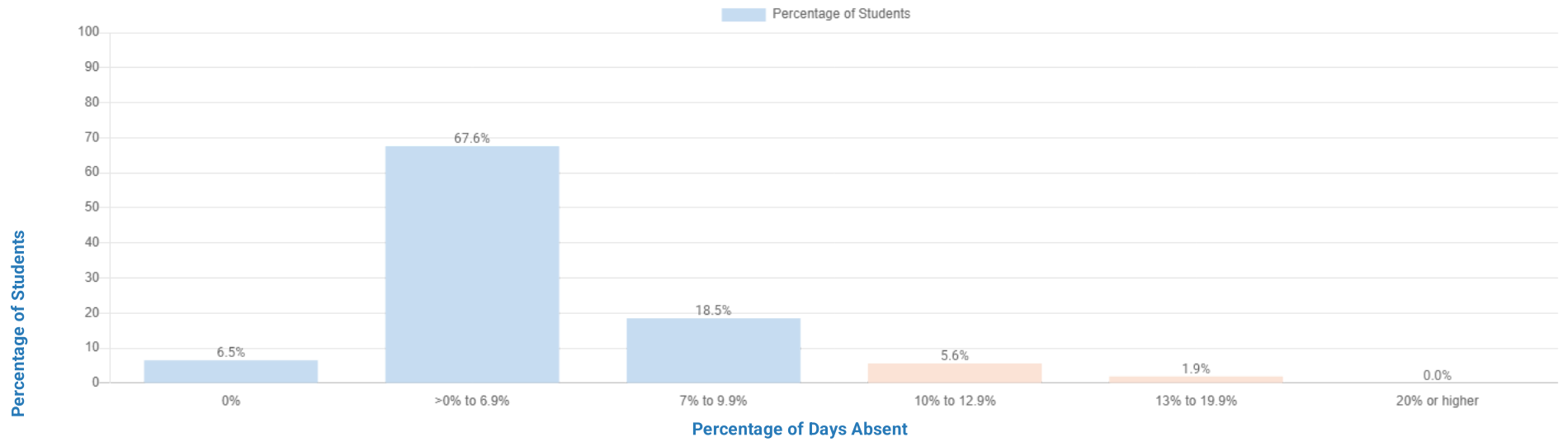

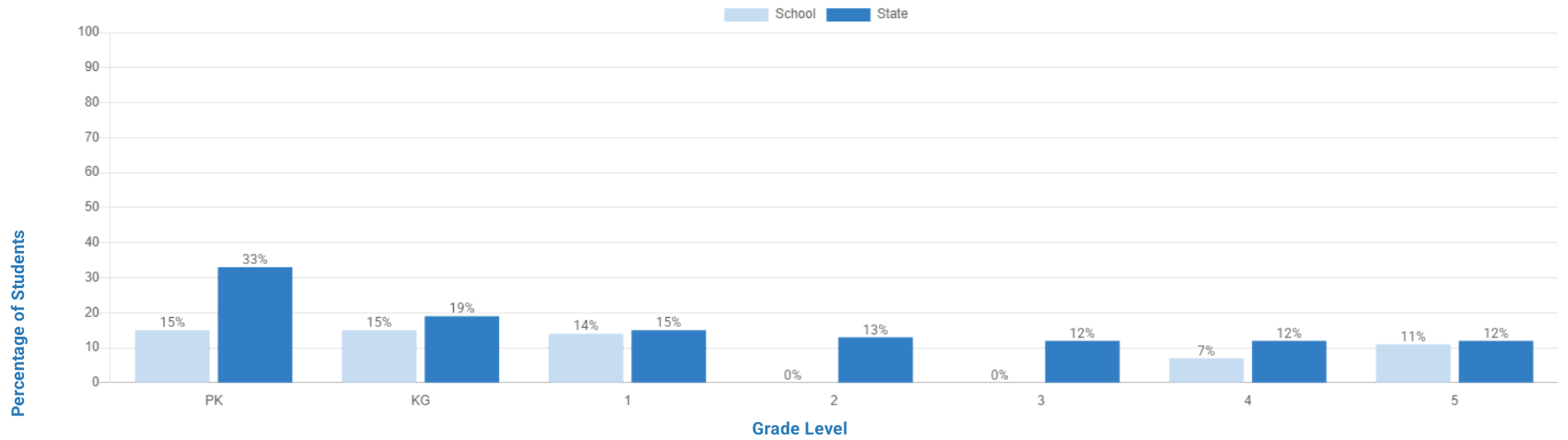

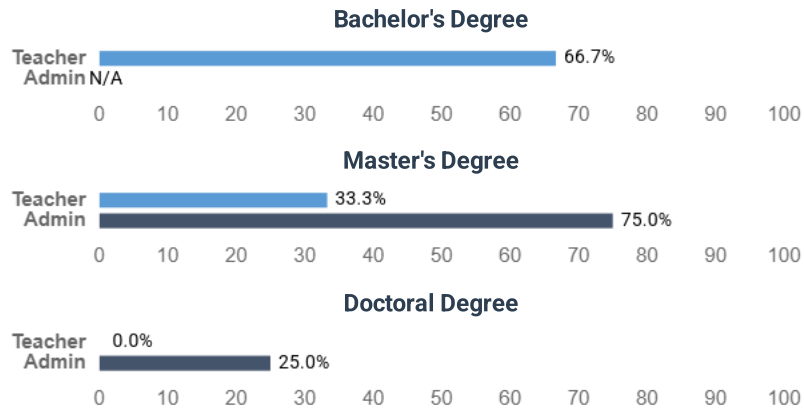

Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

Courses, Curriculum, Instruction:

In addition to the required courses, English Language Arts, Mathematics, Social Studies, and Science, students at every grade level receive instruction in Art, iSTEAM, Library/Media, Music, Physical Education/Health, and World Languages. In the 2023-24 school year, we continued to expand our iSTEAM program to various students who showed interest or potential in STEM, and renamed it "Imagineers." Additionally, individual students may receive Response to Intervention or Gifted & Talented instruction as per their educational profile. The staff utilizes an interdisciplinary approach to the instructional program that includes both vertical and horizontal articulation. Wandell School continues to departmentalize ELA, Math, and Science for Grades 4 and 5 to maintain the rigor required for middle school studies.



Clubs and Activities:

Students are offered a variety of activities outside the regular school day designed to enhance the educational experience. Students have the opportunity to participate in club activities funded by the Wandell School Education Foundation. Annually, the clubs offered varies according to student interest. Other activities include the multiple assemblies, Jump-A-Thon, Halloween Canteen/Trunk-or-Treat, book fairs, Field Day, choral concerts, and a school play. Additionally, we integrate a Social Emotional program for our students and staff. Each grade level has at least one period a week for SEL, Safety/Wellness, and Character Education.



Staff and Professional Learning:

Staff professional development is based on educational trends and a needs analysis. Teachers have established Team Time and Common Planning Time scheduled throughout each day through the Vice Principal's office that encourages vertical and horizontal articulation. Additionally, our staff communicates with grade level peers and program counterparts with our send/receive districts of Ramsey and Northern Highlands Regional High School. Staff and Administration attend local professional development to enhance their instructional practices and keep current in the field. Professional development is always tied to the district goals which are updated annually. A full continuum for students with learning disabilities is available, as well as enrichment and gifted and talented programs. Additionally, Response to Intervention (RTI) is offered for at risk students, and all staff have required weekly extra help sessions.



Student Health and Wellness:

As required by NJSLS, students receive physical education and health instruction from our certificated PE teacher. Additionally, the School Nurse, in conjunction with our local businesses and organizations, provides training and tips for students regarding handwashing, playground safety, dental care, etc. The School Psychologist works with staff and student peer leaders to provide mental health support programs throughout the year. We continue to expand our Social Emotional program to all of our students and families in PreK-5 in order to be successful students and learners.
