











Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

One of the finest aspects of the School Counseling Department is the FORUM, (Forging Opportunities for Reasoning, Understanding, and Maturity). This is a NJ School-based Youth Services Program that offers a myriad of opportunities that include after-school tutoring and after-school homework help through a peer-to-peer mentorship program entitled STRIVE, job placement, peer mediation, support groups, and individual and group counseling.

Before and After School Programs:



Teachers receive ongoing training and workshops focused on enhancing teacher clarity, emphasizing clear learning intentions and success criteria for students. Teachers also receive professional development on the three-phases of learning, and the application of progressive cognitive rigor. Teachers collaborate as teams to plan lessons that integrate all three phases of learning-acquisition, consolidation, and deep knowledge. Teachers also work together to analyze the necessary rigor needed to meet stated learning intentions.



For the Class of 2024, 77.2% went on to Higher Education. 60.9% enrolled in 4-year colleges and 16.3% enrolled in 2-year colleges. 0.07% went on to employment/ Armed Services, enrolled in a career education program, took a gap year, or were undecided. The PSAT is given to 10th & 11th-grade students each year. Evening programs were conducted for students and parents to assist with college applications, financial aid, scholarship searches, etc. Teaneck has developed college partnerships with Fairleigh Dickinson University and Bergen Community College providing students with opportunities to earn college credit while still in high school.

Student Supports and Services:

THS offers after-school tutoring with all teachers, including our ELL program, which enables our students to gain academic help in each area. After-school tutoring programs such as Peer Tutoring with NHS students, and STRIVE academic mentoring are additional programs offered. In addition, students have access to the Teaneck Writing Center, which provides students with targeted writing/language arts assistance. Free before and after-school SAT and ACT tutoring classes are also offered. An I&RS team is in place to assist students who are experiencing learning, behavior, or health difficulties. Our District Student Assistance Counselor provides counseling, education, and support services to all students at THS.



A nutritious breakfast program for students is offered every morning. Nutrition is emphasized in the Health curriculum at each grade level. Students are enrolled in Physical Education classes for 3 marking periods each year. Physical Education classes meet every other day in our block schedule for 80 minutes. Dance is also offered as part of the Fine & Performing Arts curriculum at THS. Students engage in a monthly advisory program in which Social-Emotional Learning activities are conducted.



Parent and Community Involvement:

Teaneck HS fosters a strong home and school partnership led by our PTSO. PTSO meetings are held on the second Monday of every month at 7:00 PM and are always well attended. Parents have many opportunities to support our entire school community in both social/emotional and academic growth. Teaneck HS also has a partnership with Teen Interns Leading Together (T.I.L.T.) which is an opportunity for students in Teaneck, both public and non-public, to work together and offer tutoring services for students in all grade levels.
