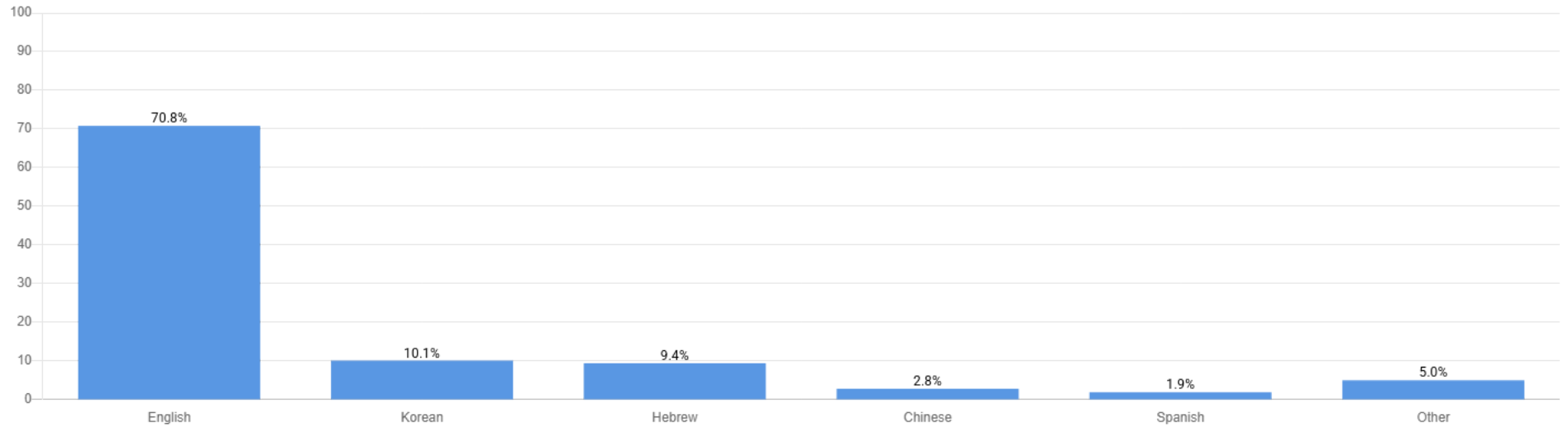

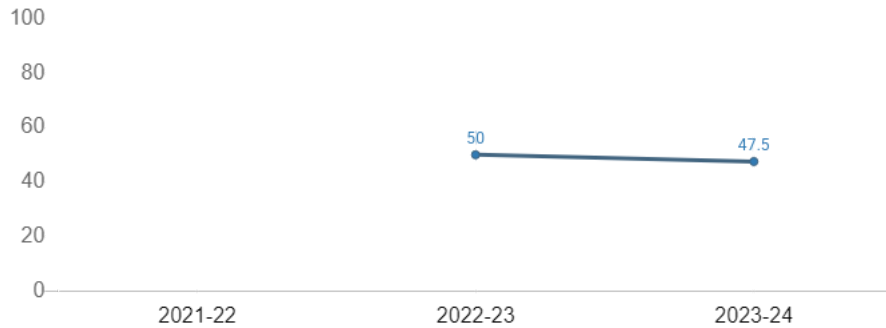

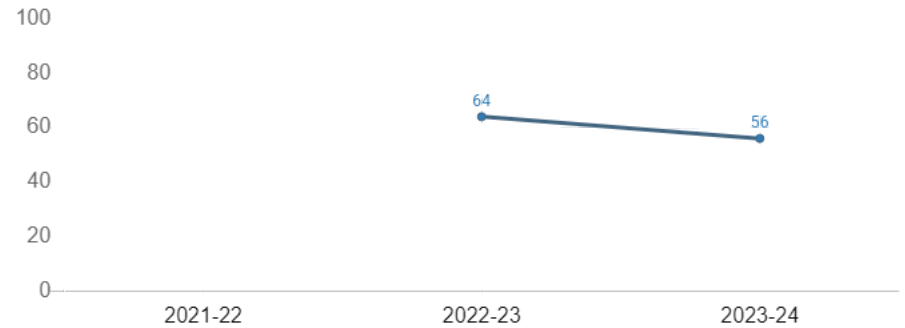

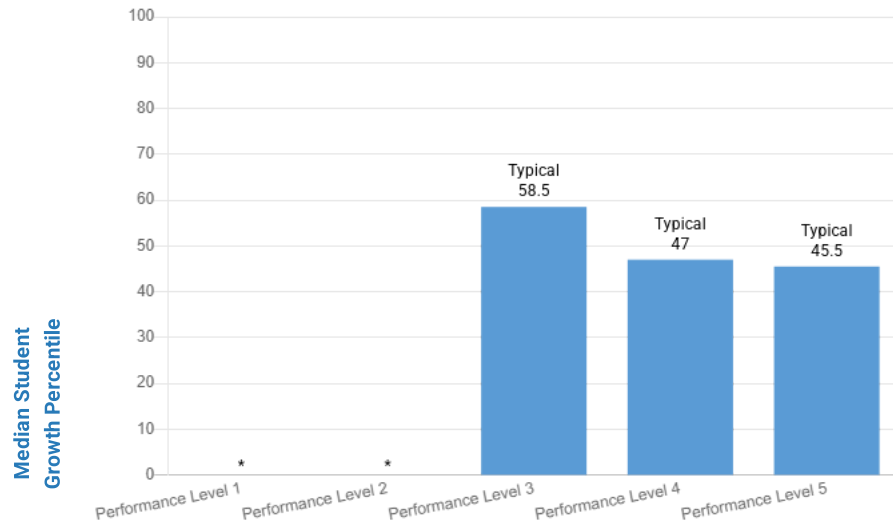

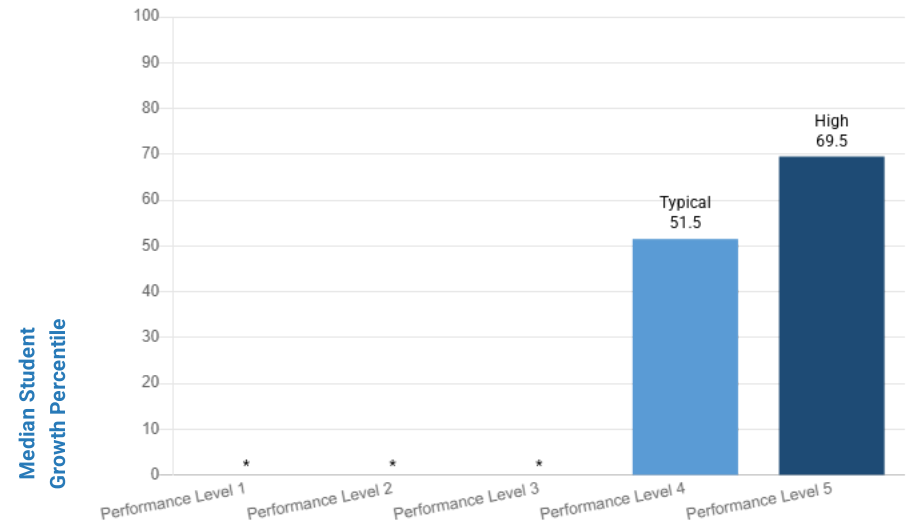

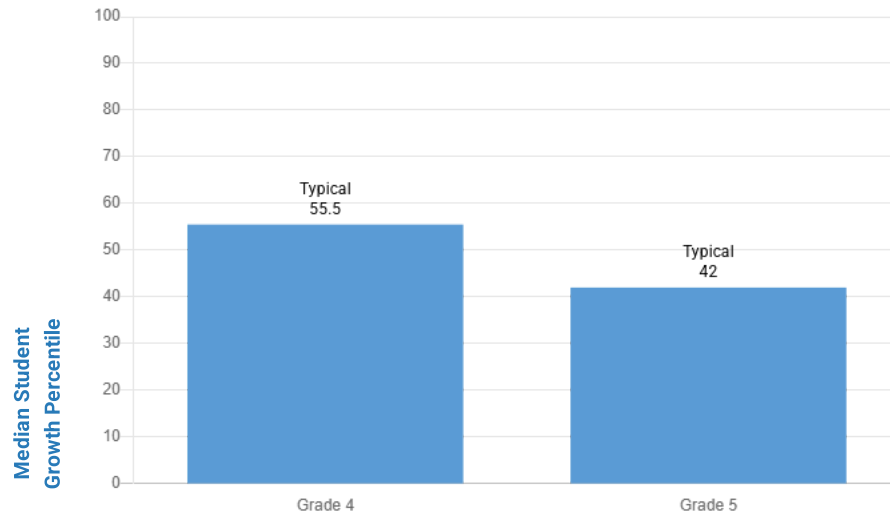

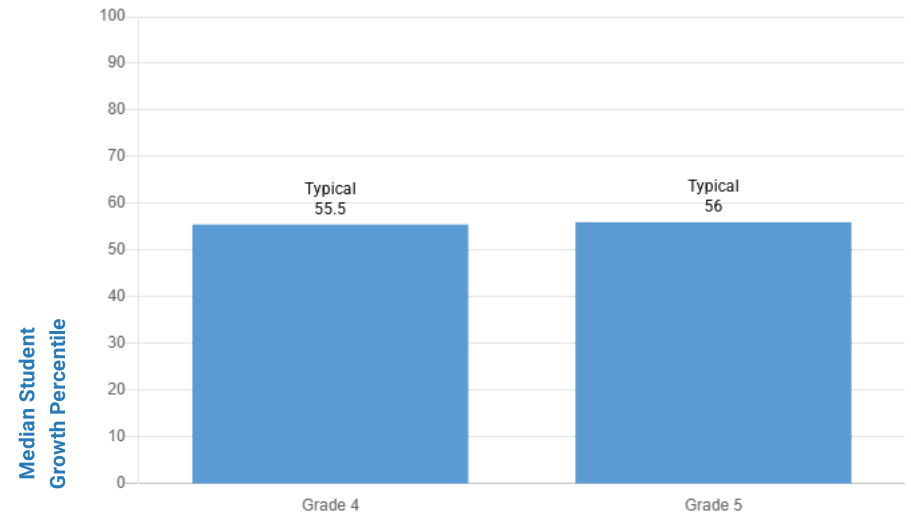

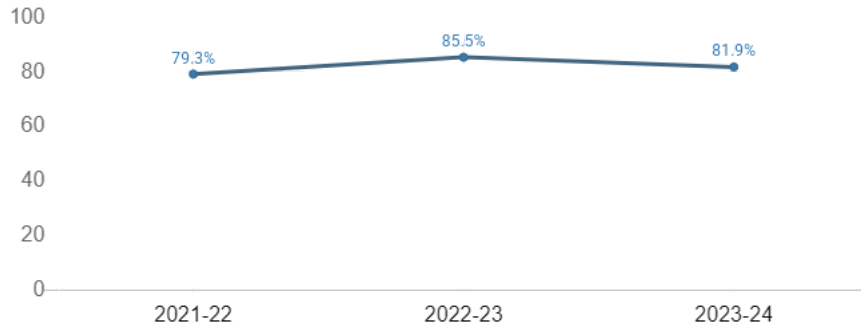

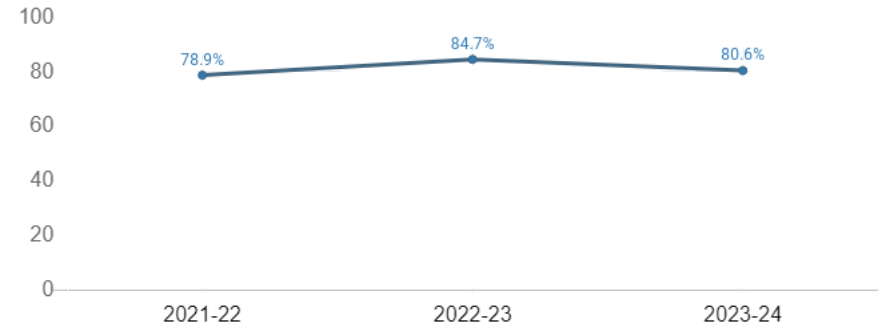
English Language Arts and Mathematics Performance Trends

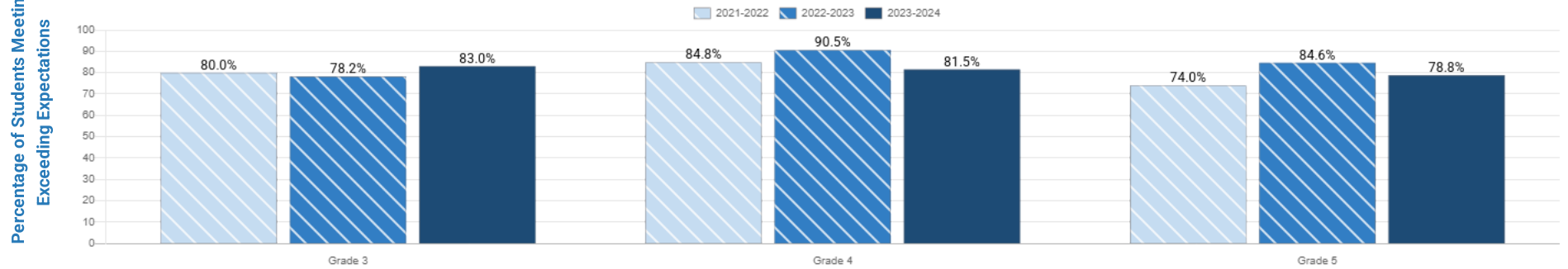

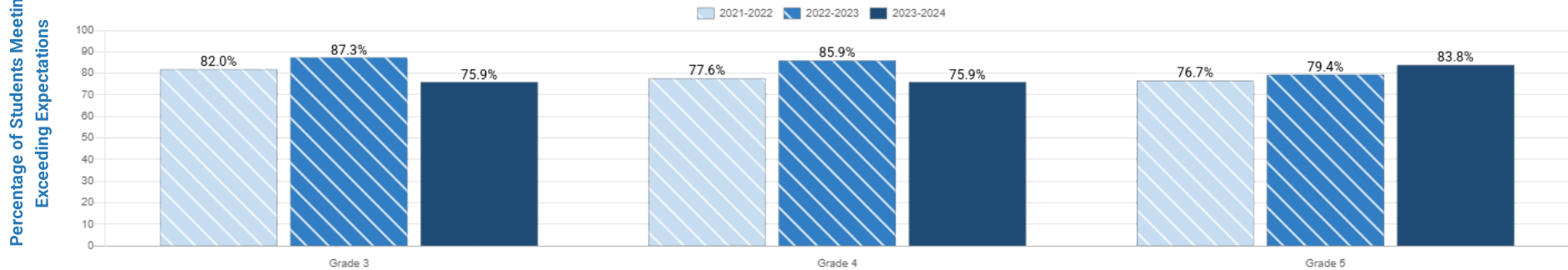

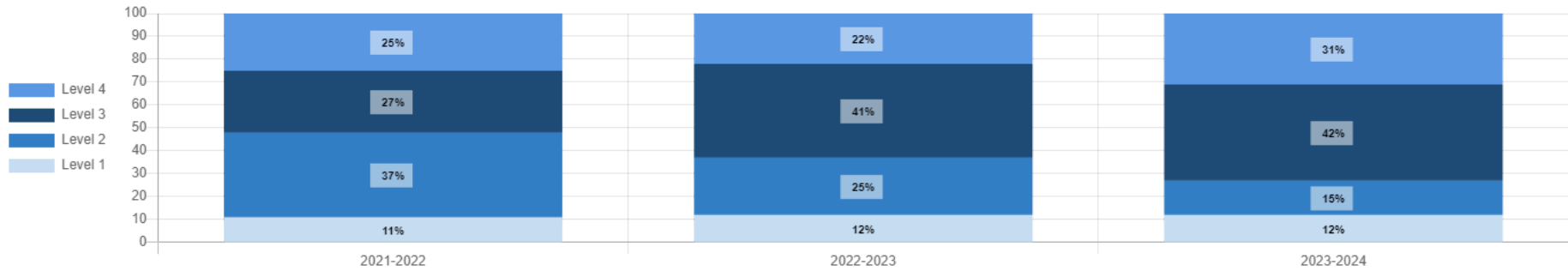

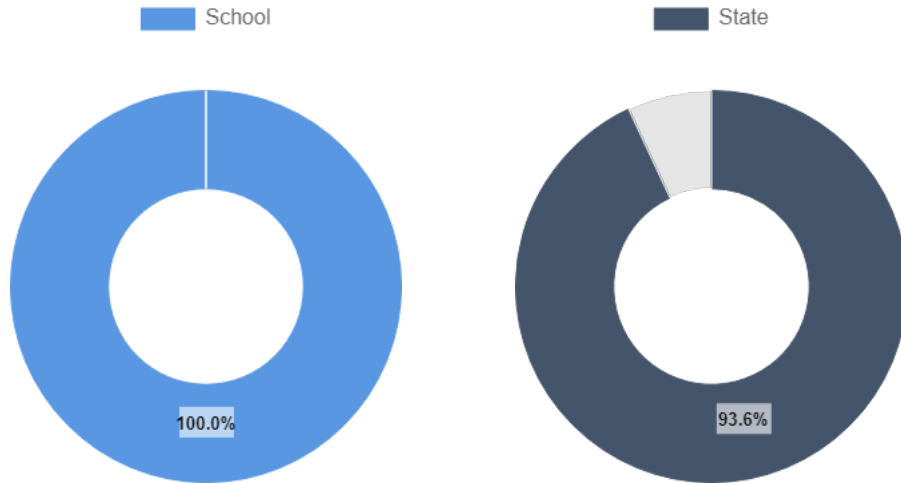

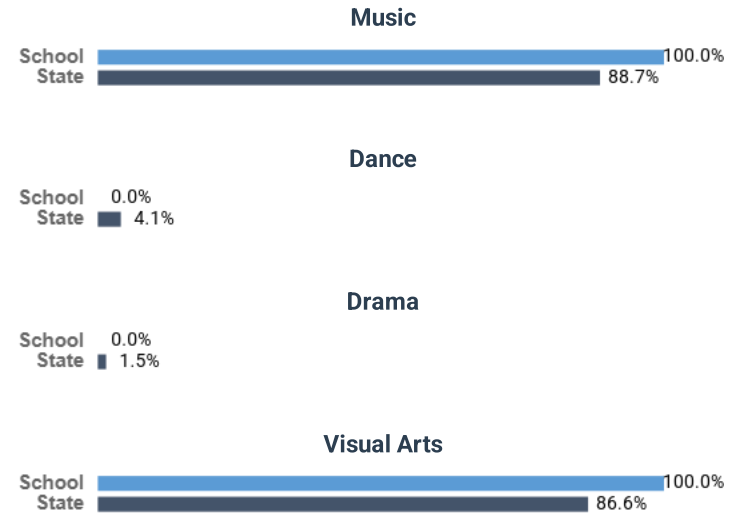

Students enrolled in one or more classes by discipline:



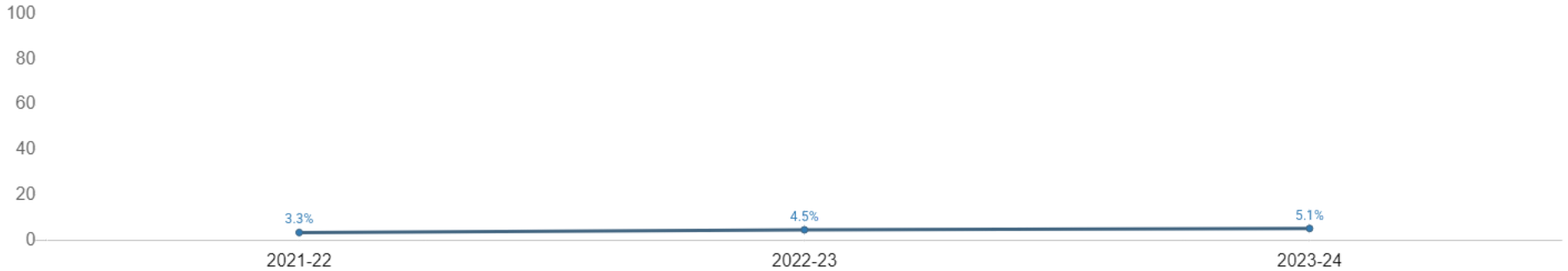

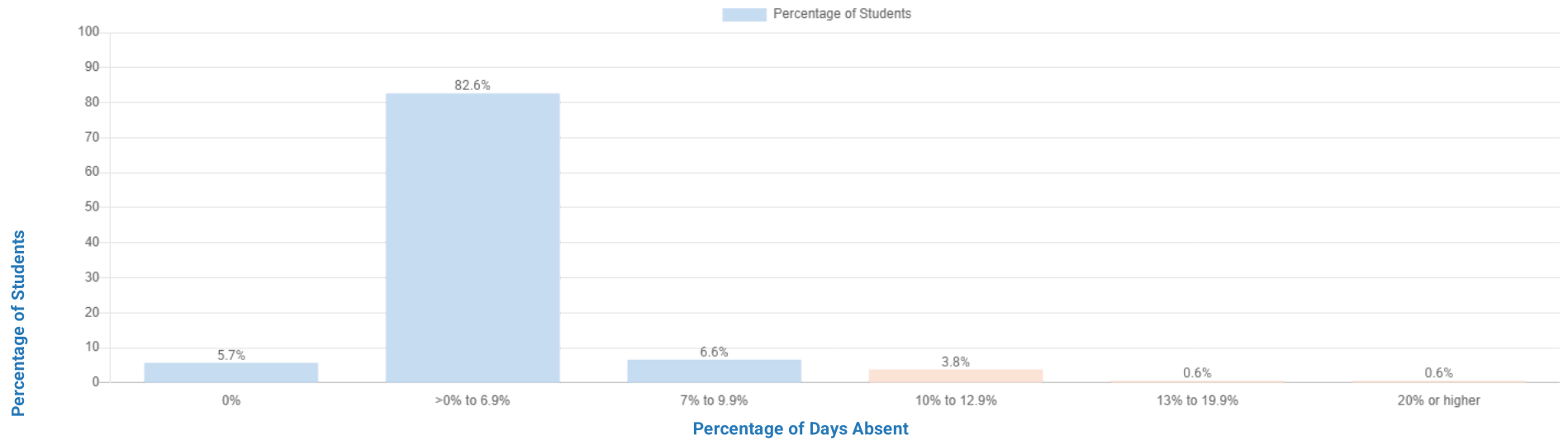

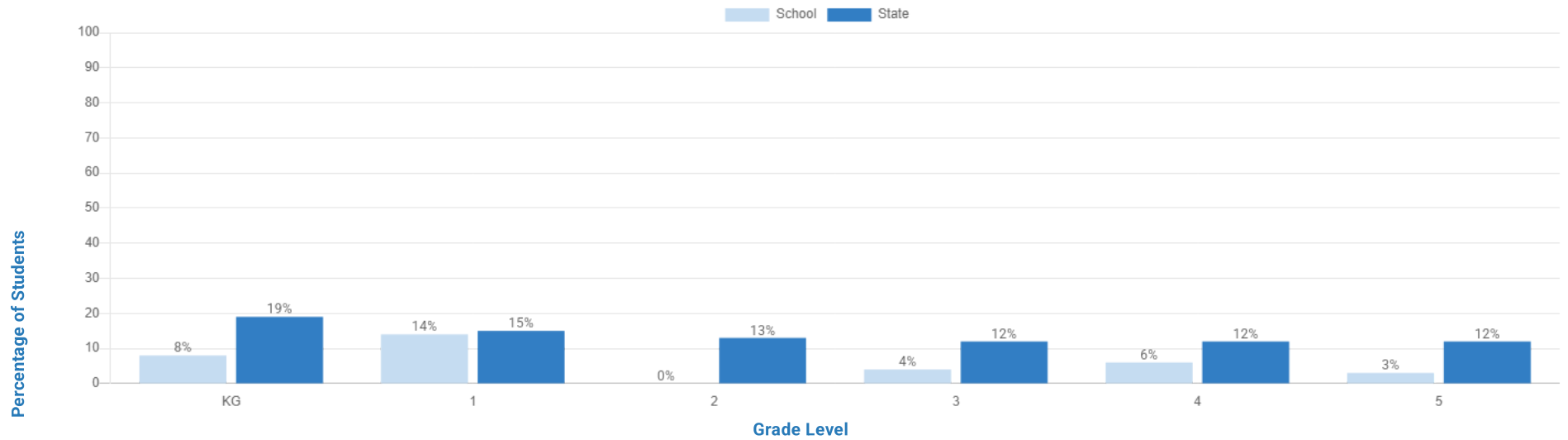

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

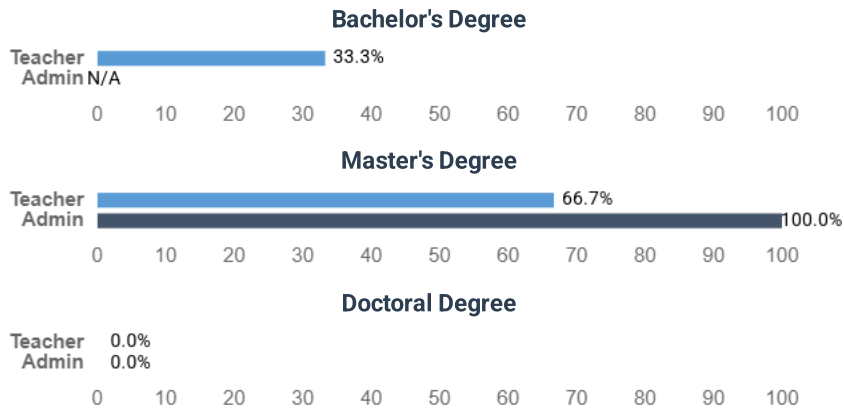

The Basic Skills program offers intensive instruction to remediate foundational skills in a small group setting. Special education students are offered a continuum of services, including but not limited to, paraprofessional and/or special education teacher-supported classes. Individual and small group therapies are offered as appropriate. Students with health and/or behavior challenges may be offered support and services. Gifted & Talented learners pursue authentic research projects inspired by inquiry that requires critical thinking.



Student Health and Wellness:

Wellness programs are provided in addition to an active Physical Education and Health Program. Students engage in Physical Education twice a week and have daily recess. Sudents participate in active learning and movement opportunities throughout the day. An emphasis is placed on mindfulness and social-emotional well-being. Students take part in Responsive Classroom activities and curriculum to build a sense of community and make positive connections with their peers. A Guidance Counselor provides whole class, small group and individual support. We educate the importance of inclusivity and character education through lessons, assemblies and an enriched curriculum.
