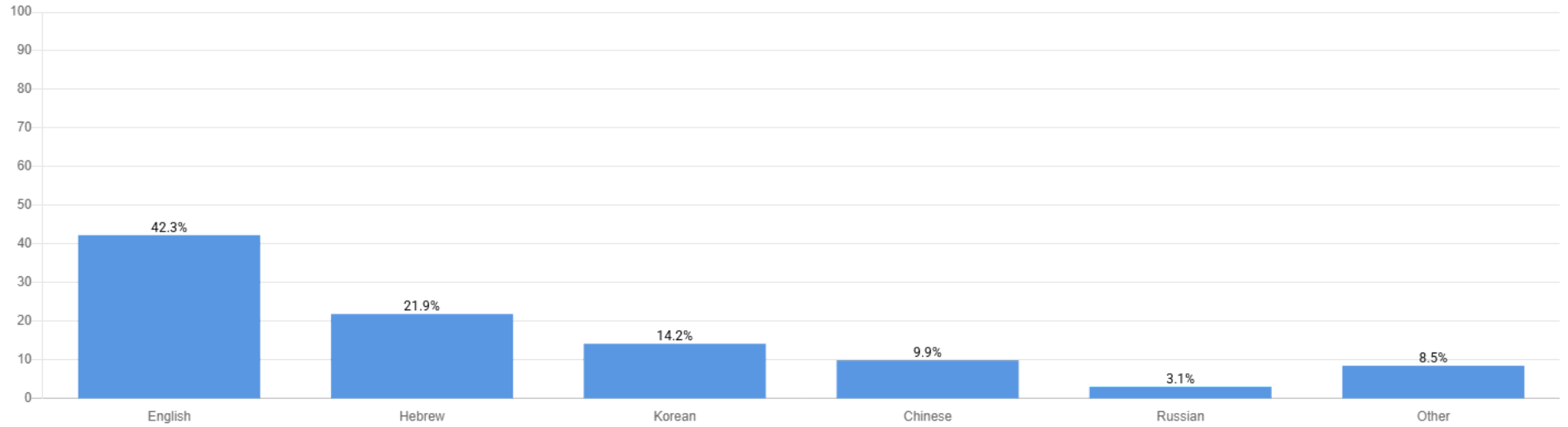

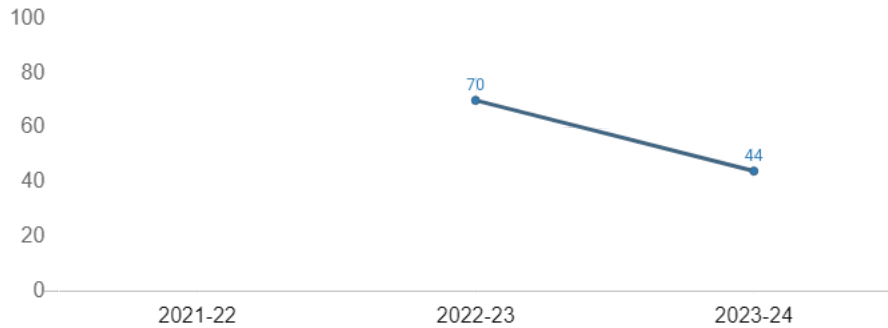

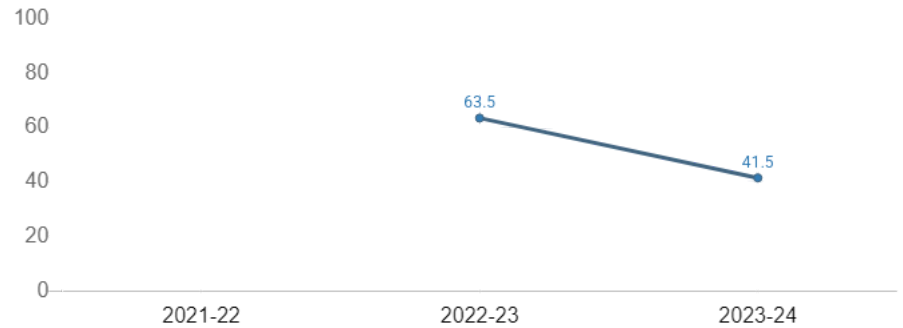

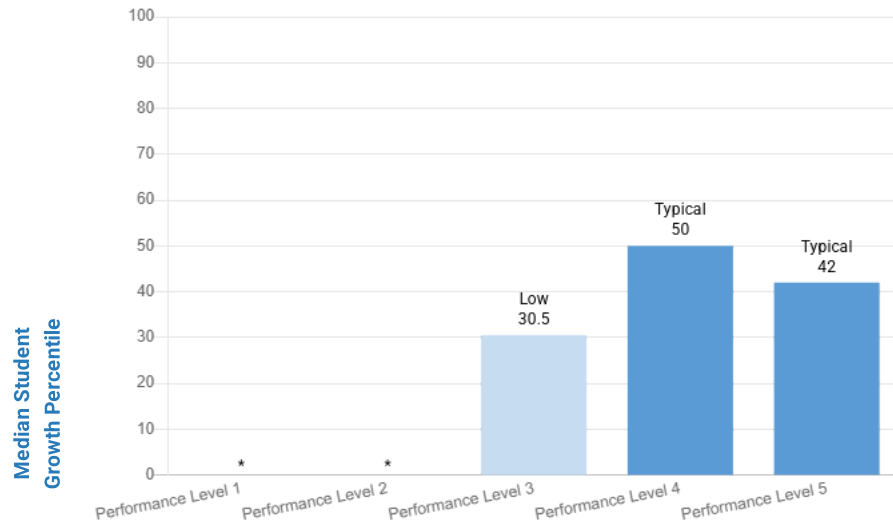

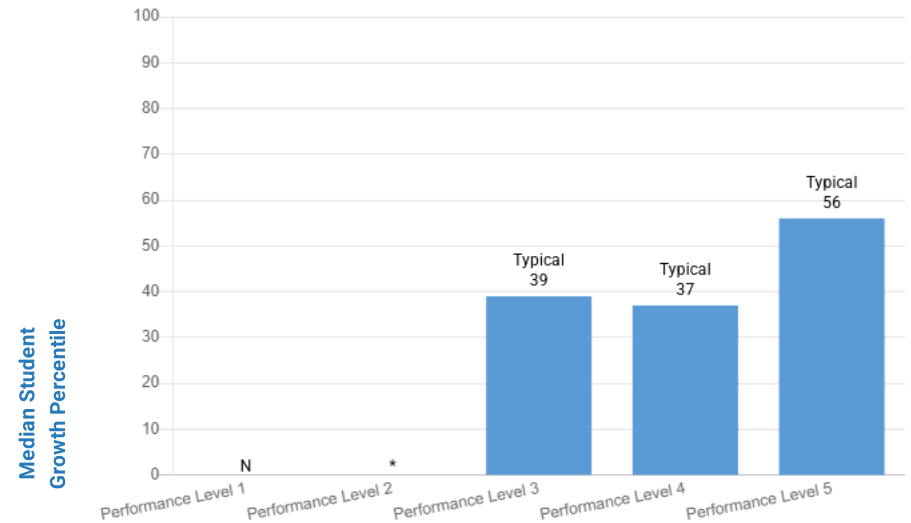

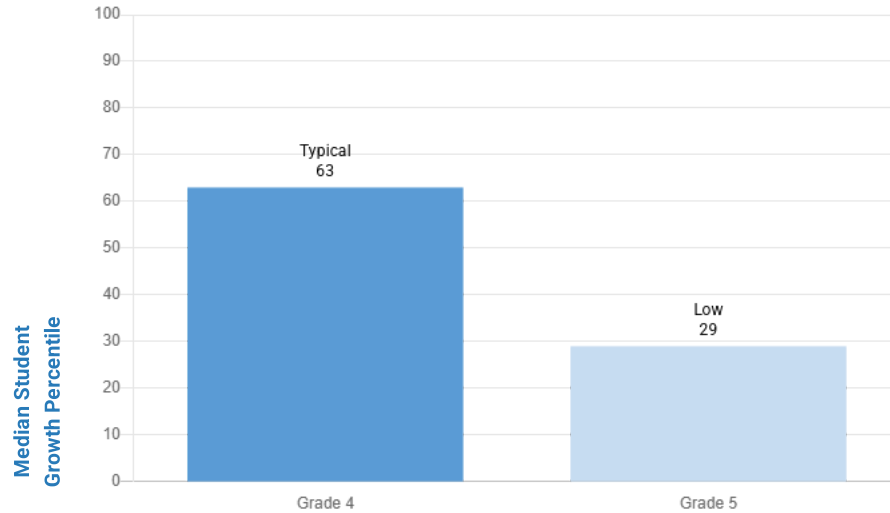

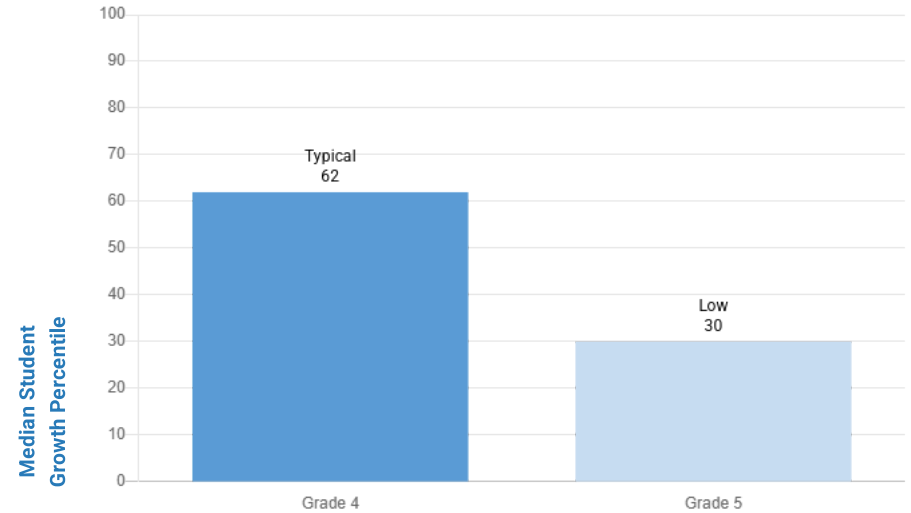

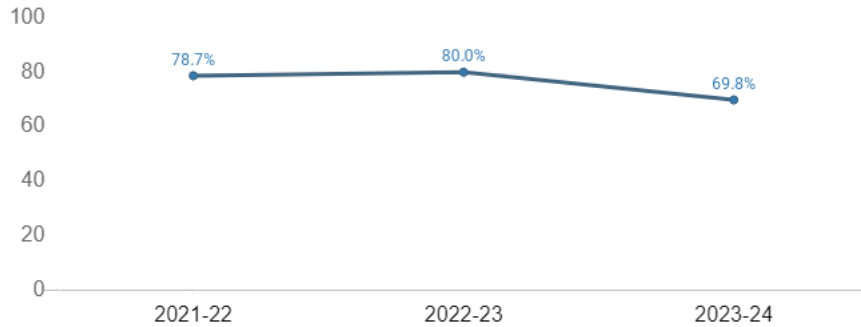

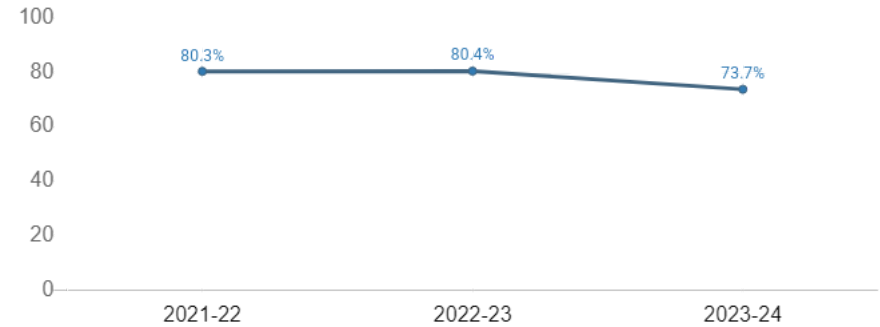
English Language Arts and Mathematics Performance Trends

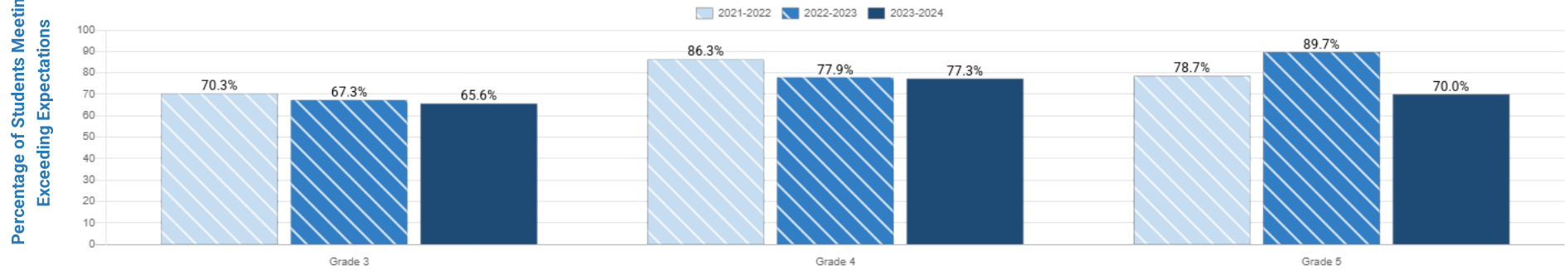

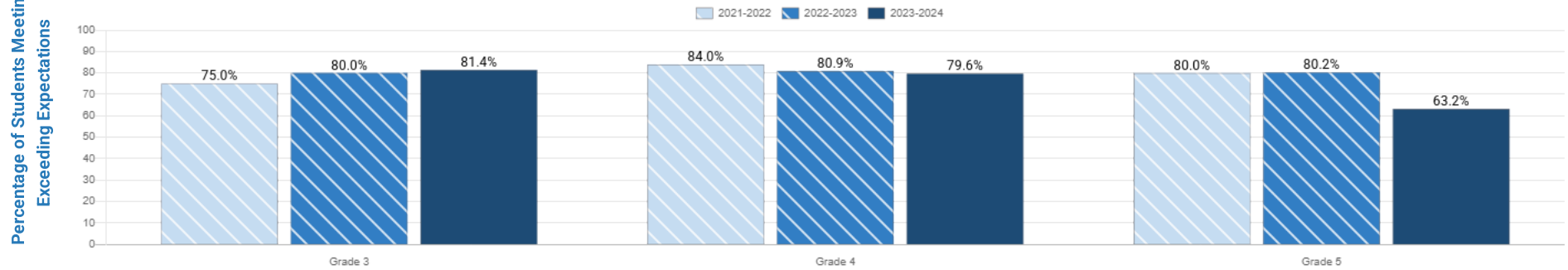

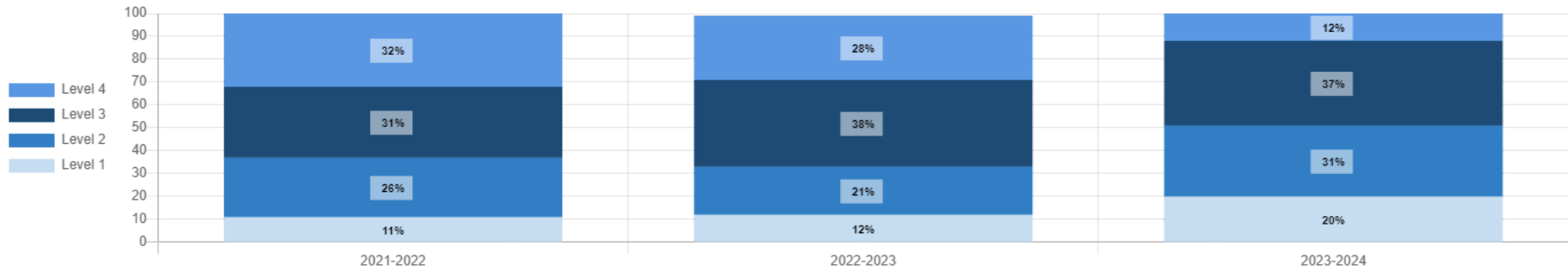

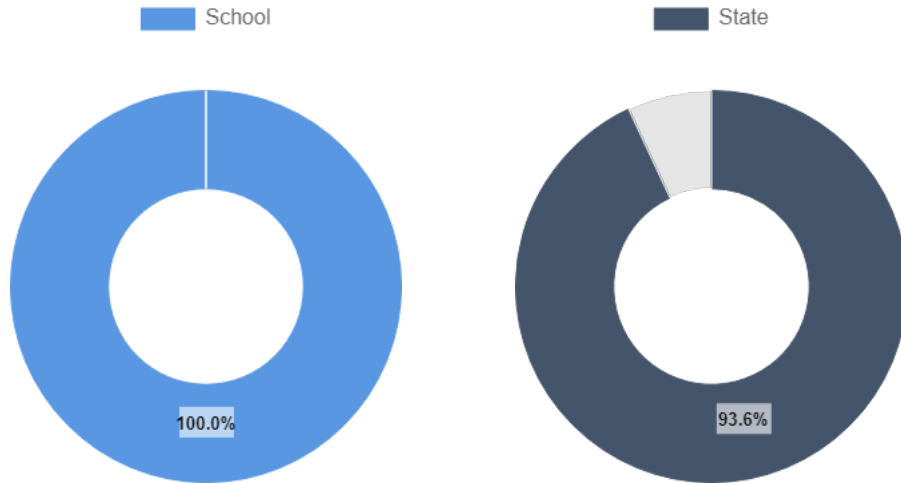

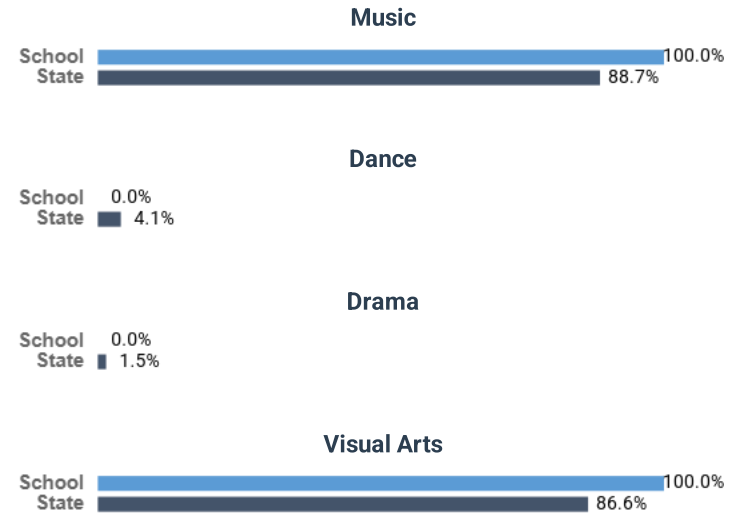

Students enrolled in one or more classes by discipline:



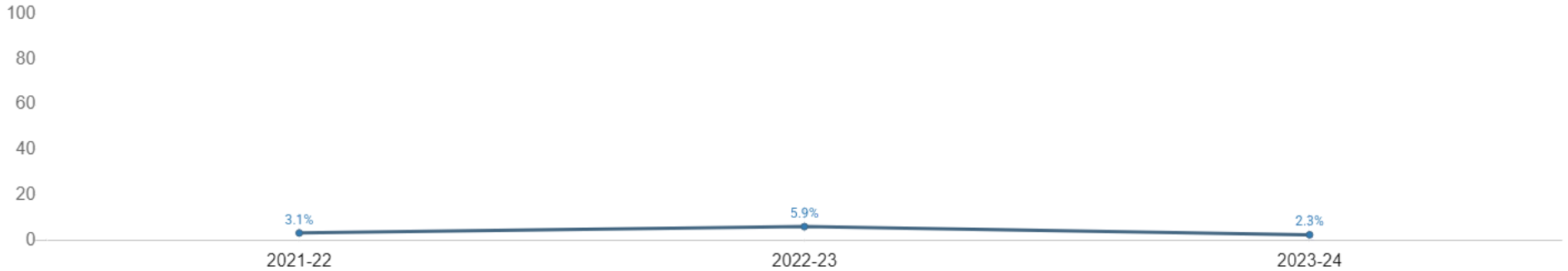

Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

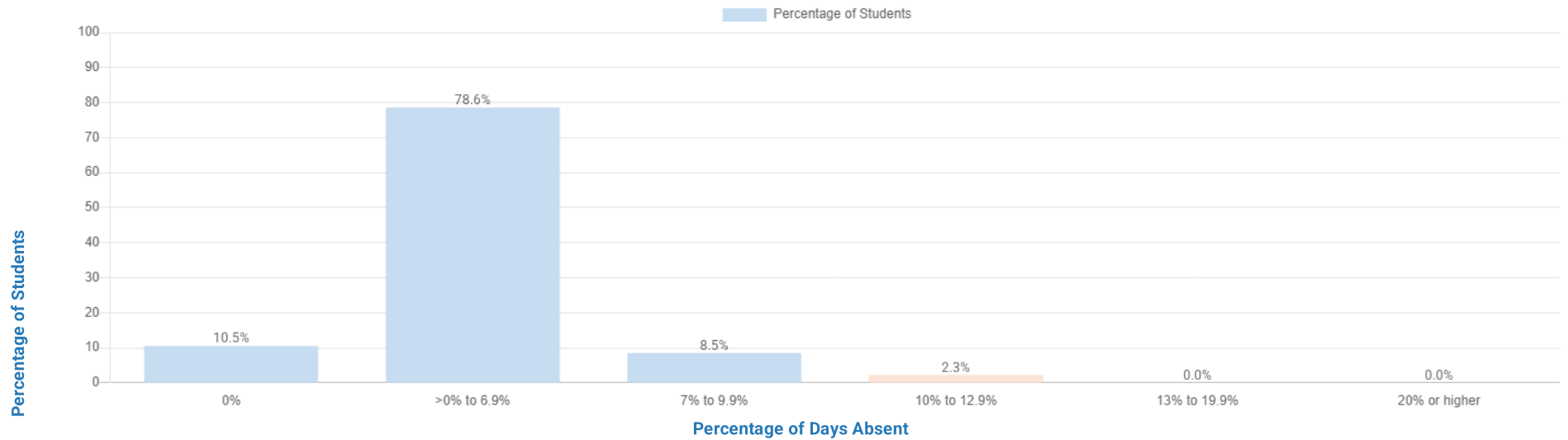

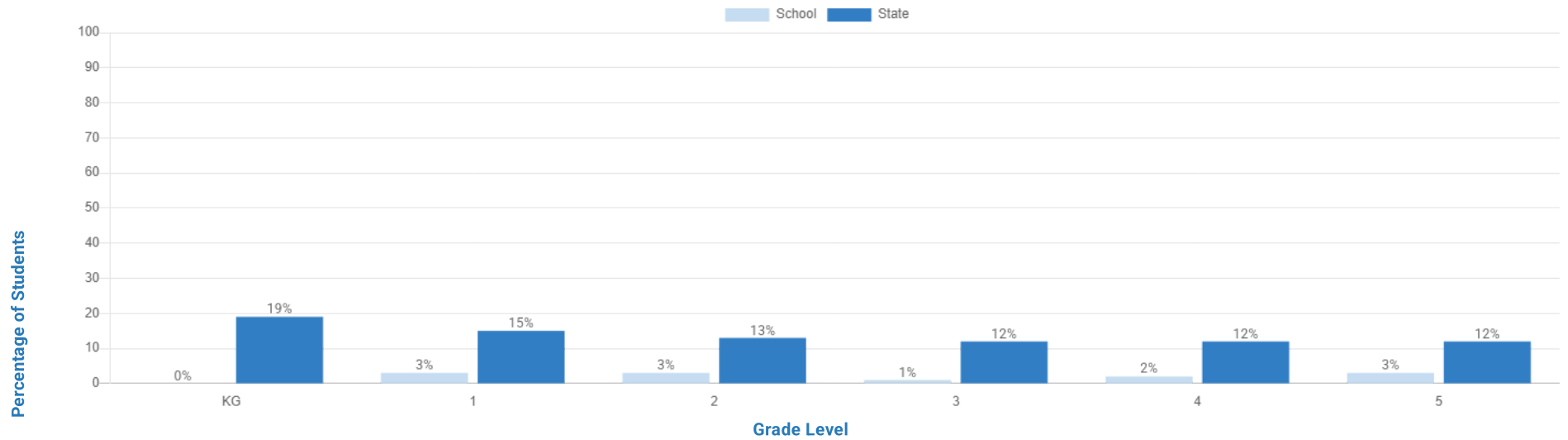

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 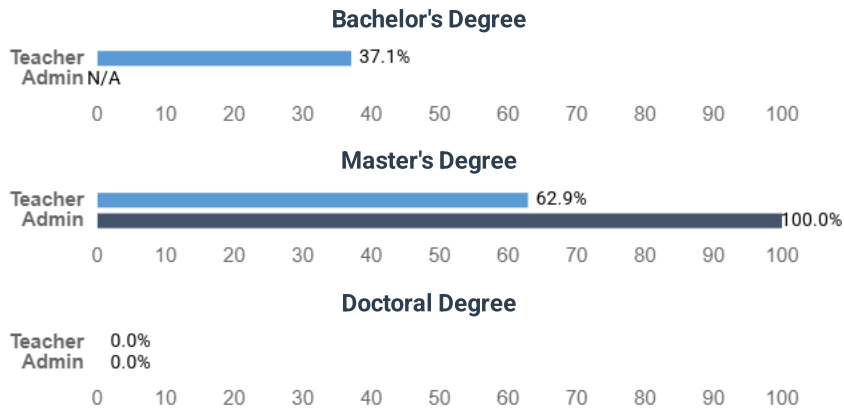

Accountability Summary by Student Group - 2023-24 School Year

Multi-Language Learners are provided with leveled small group instruction. Our Basic Skills Program offers intensive small group instruction to remediate foundational skills. Students in first grade participate in the Reading Recovery Program to receive intense support in early literacy. Our special education students are offered a continuum of services, ranging from in class support and collaborative teaching, to small group instruction, paraprofessional support and individual therapy. Gifted learners participate in small group enrichment programming. The school counselor provides various character education lessons and small group sessions to meet the social and emotional needs of the students. We also collaborate with West Bergen Mental Health Care Services to support our school community with additional resources.



Student Health and Wellness:

Students engage in Physical Education twice a week and daily recess. In addition, students participate in active learning and movement throughout the day. Emphasis is placed on social-emotional learning and mindfulness. Responsive Classroom activities and The Simple Seed journal program help students build a sense of community, positive connections and common themes and language. Our guidance counselor provides whole class, small group and individual support. We continue to promote character education through literacy initiatives, assemblies, classroom activities, and meaningful discussions.



Parent and Community Involvement:

Parents are encouraged to be involved in their child's learning. By joining one of the many available organizations, such as the Mackay Home School Association, parents quickly become a positive force within our school community. It is with this team approach that we are able to better serve the social, academic, and emotional needs of the children within our care. Parents are connected to the school via the Genesis Parent Portal and Blackboard System. Our monthly newsletters and notifications help keep our families well informed. Our school has a strong partnership with the Tenafly Nature Center, the Rotary Club, and all Municipal Departments.
