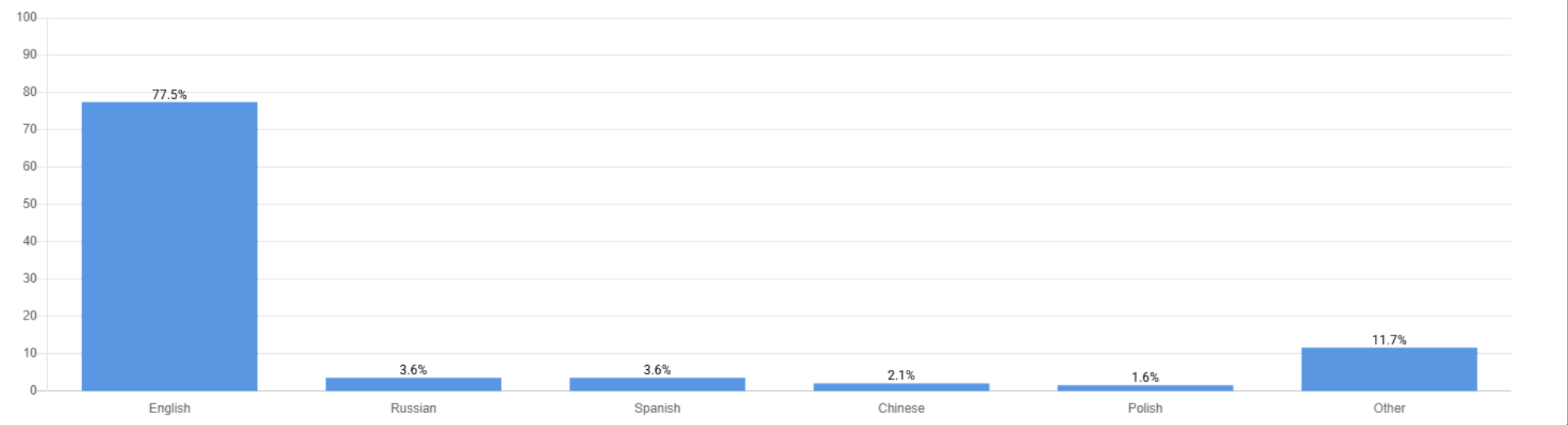

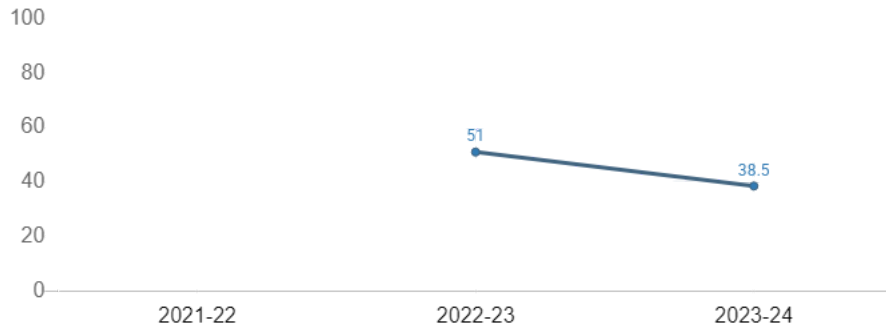

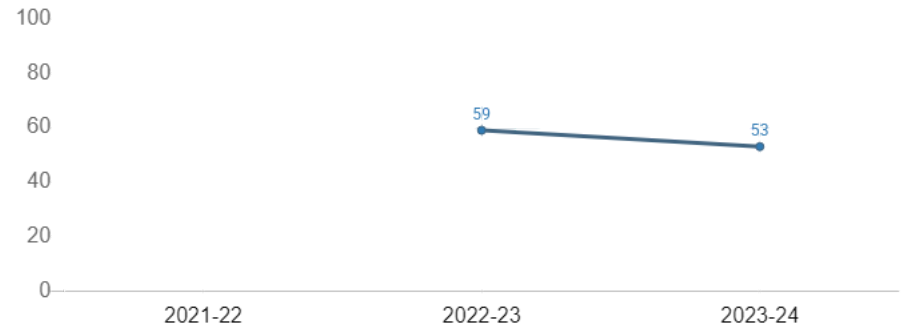

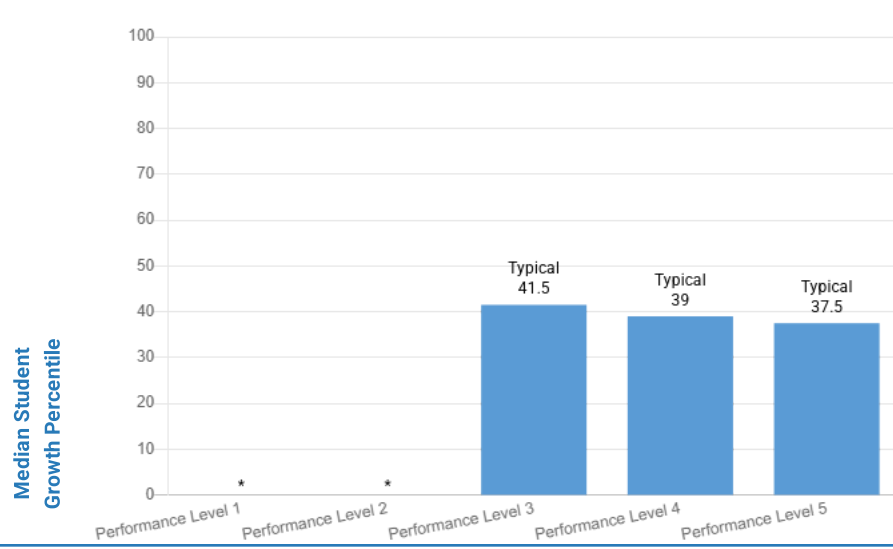

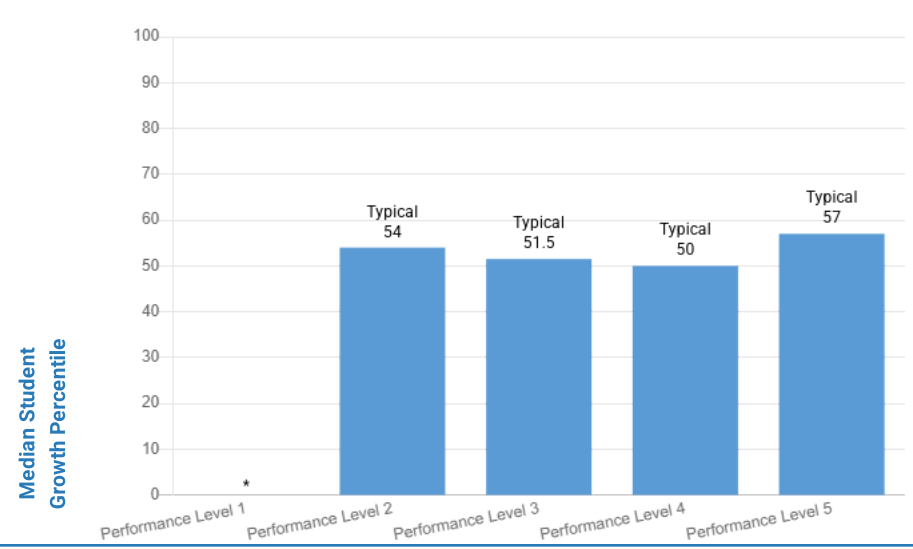

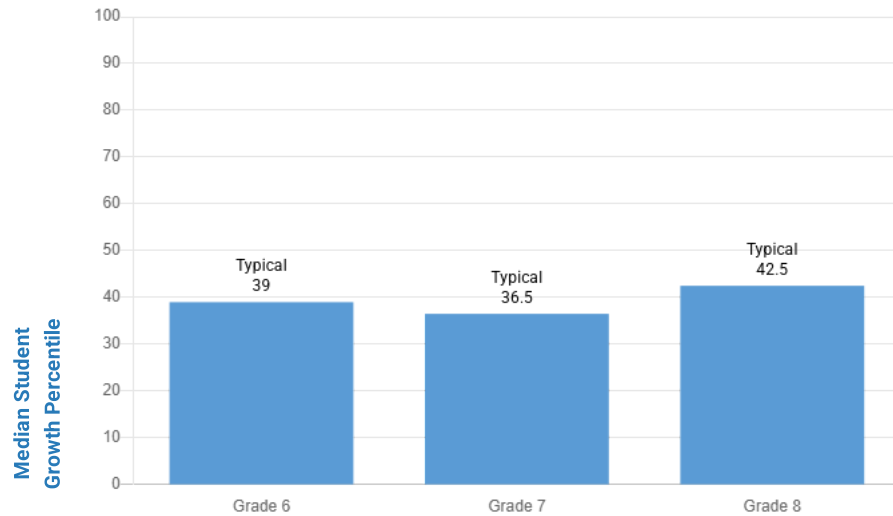

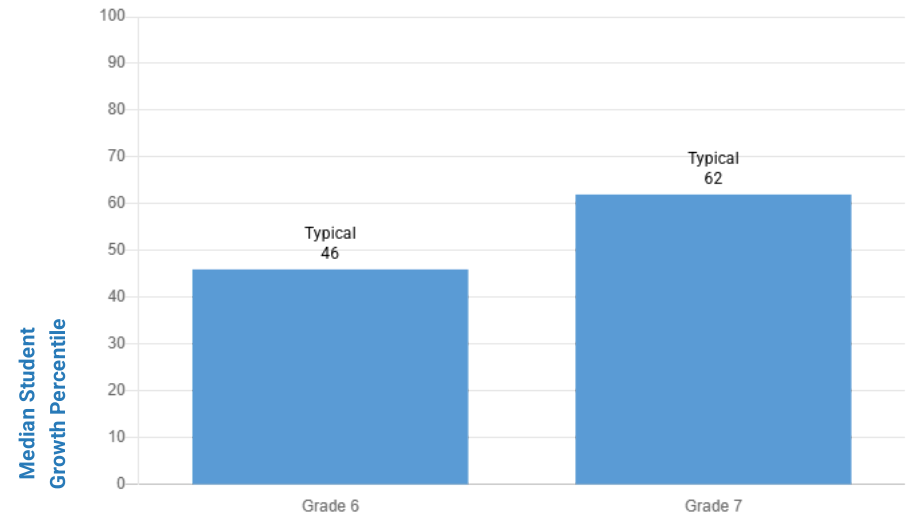

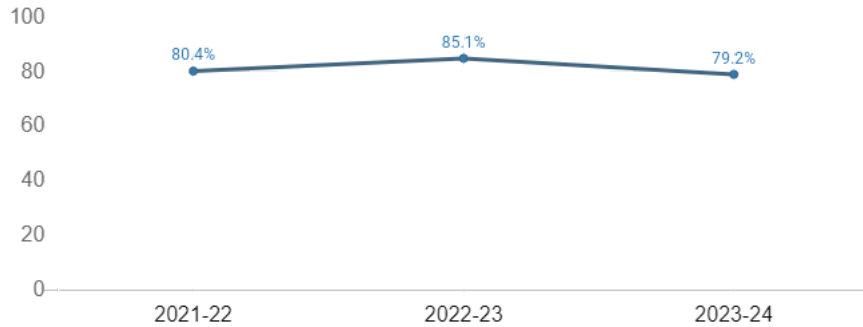

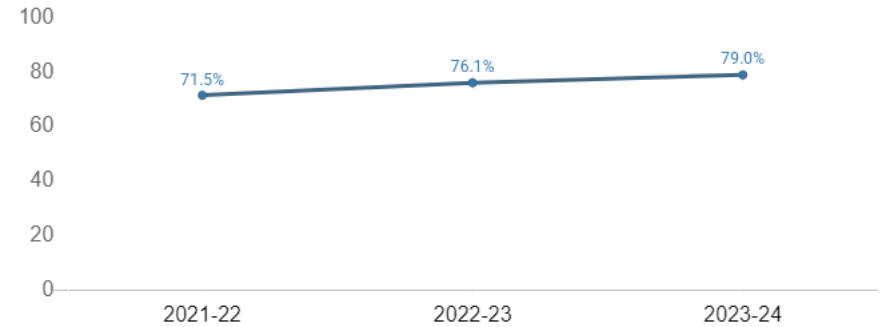
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 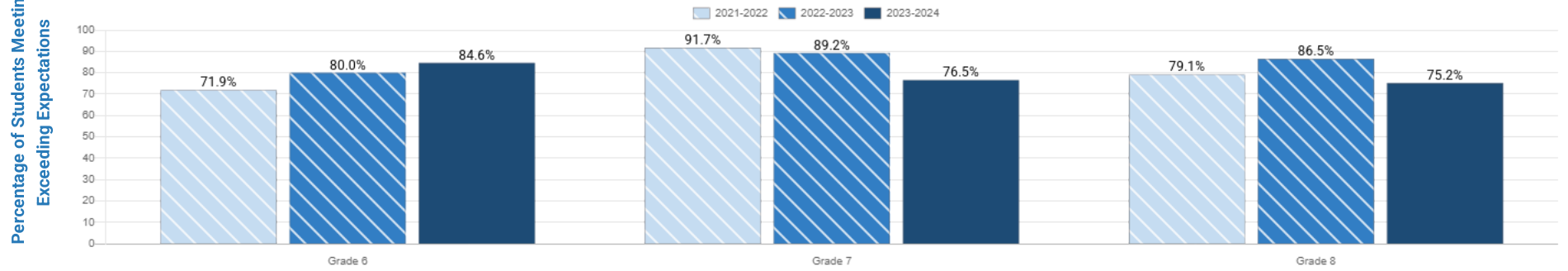

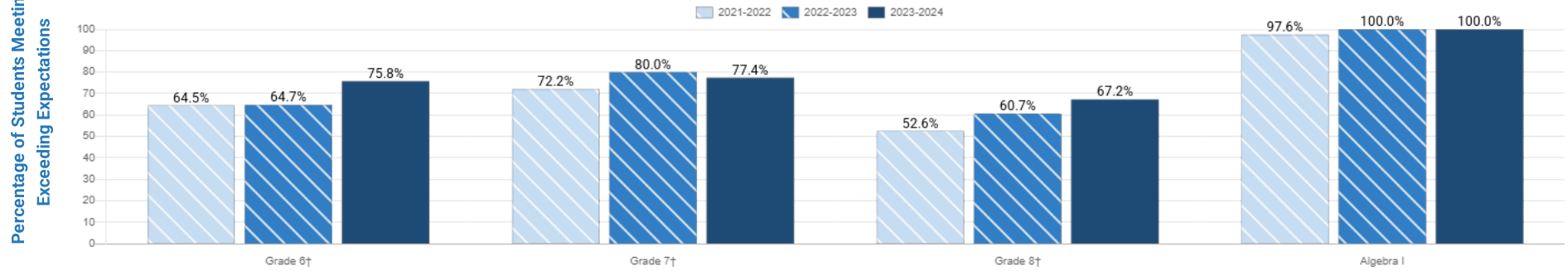

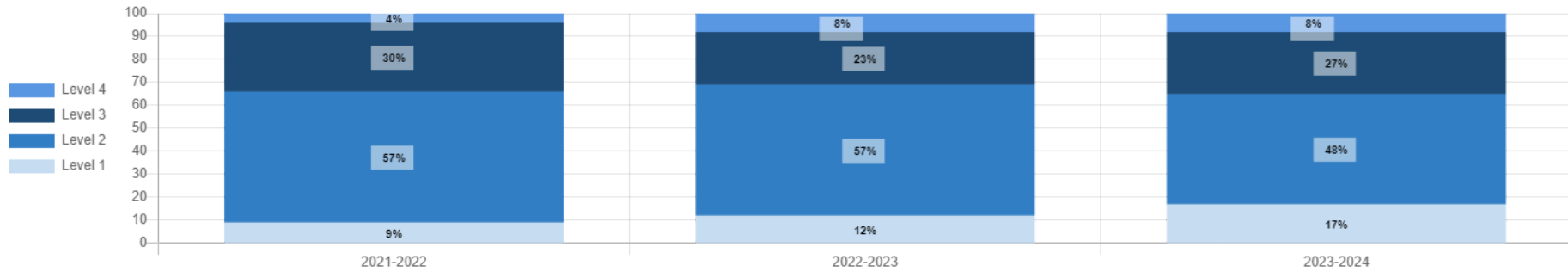

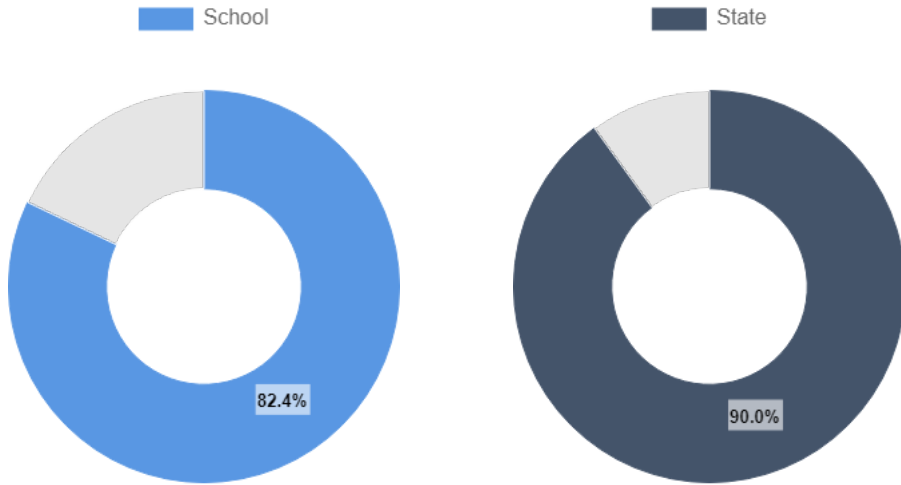

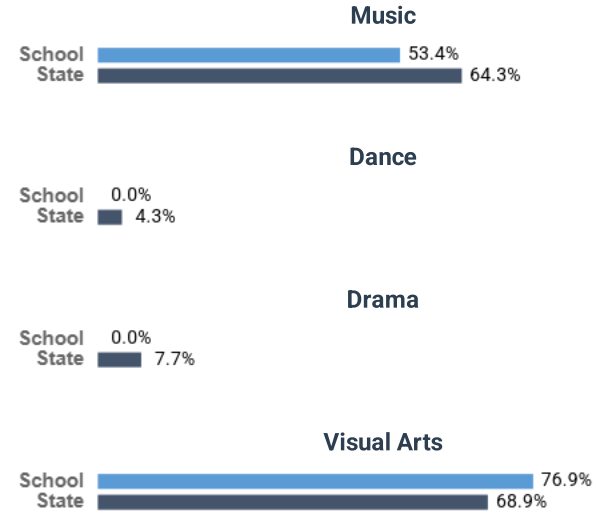

Students enrolled in one or more classes by discipline:



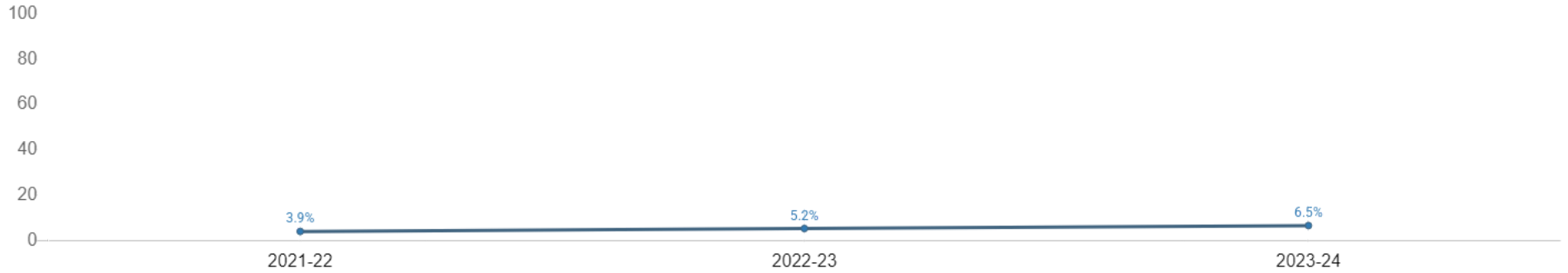

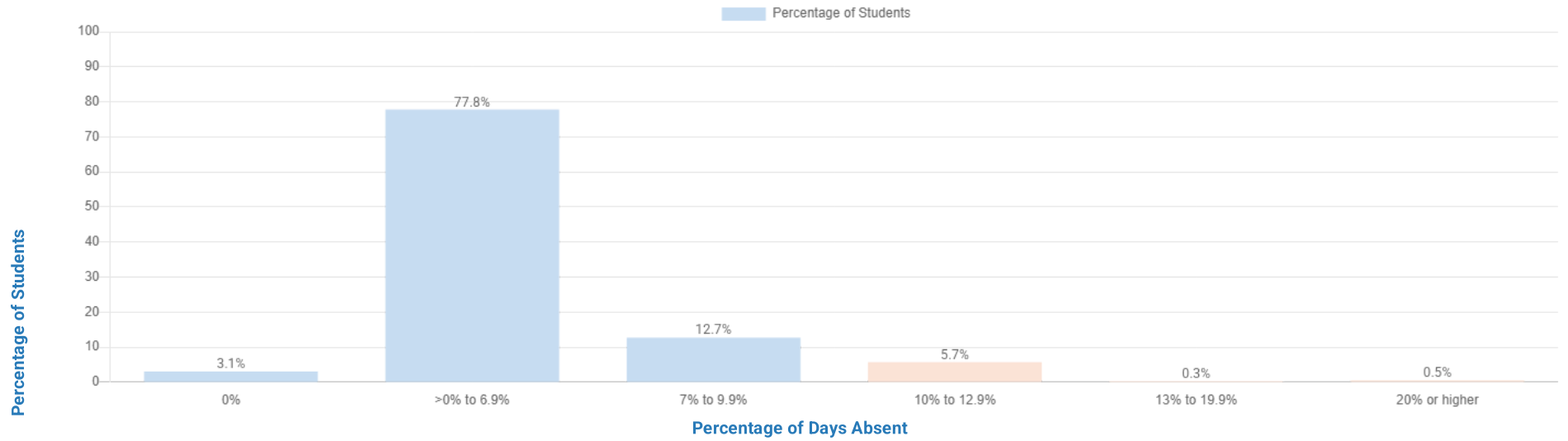

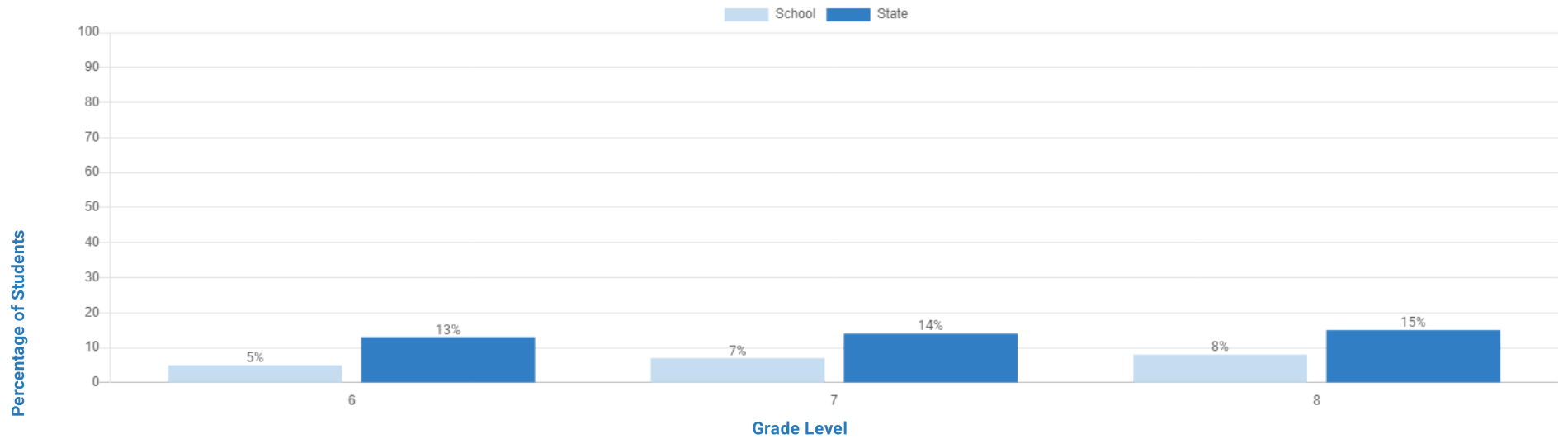

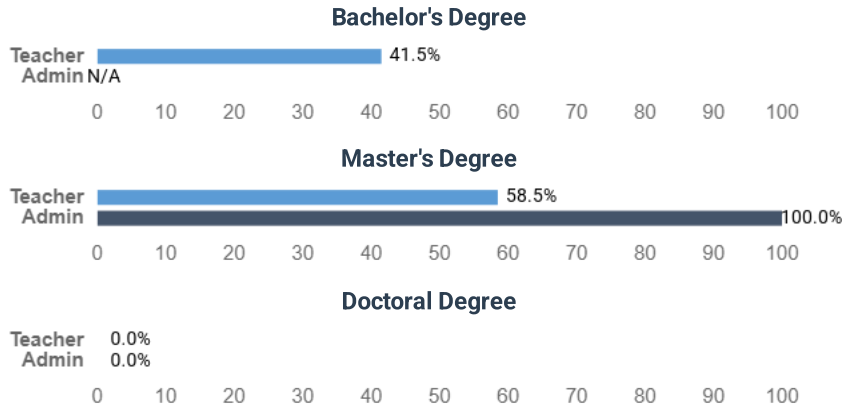

Accountability

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

It is worth noting that our Yearbook has been nationally recognized for middle school publication awards. In addition, a small group of students claimed first prize in a national innovation contest sponsored by Samsung electronics. The students won \$150k for our school. In addition, during the 2022-2023 school year, a Cavallini student claimed first place in the SIMA Foundation's Invest write contest. This is a statewide competition recognizing students for financial publications. Most recently, the school was ranked, by Niche, as a top middle school in Bergen County (#2), as well as in the the state of New Jersey (#6).

In the area of athletics, we offer both interscholastic and intramural sports. Our interscholastic offerings include soccer, volleyball, cross-country, basketball, softball, baseball, and track & field. Our intramural programs vary according to student interest with the most popular being basketball and pickleball.

In the area of extracurricular activities, Cavallini maintains a large selection of diverse opportunities. Our performing arts program offers students an opportunity to participate in Band, Jazz Band, Chorus, Making the Band, and a full length School Musical. Before and After School Programs:

The Upper Saddle River School District provides access to an after school program (ACE) available to all students (K-8). At Cavallini exclusively, we offer both interscholastic and intramural sports, as well as a full array of extracurricular clubs. Students can also see teachers after school for extra help. The building is open for drop-off thirty minutes prior to the start of the school day.



Staff and Professional Learning:

Cavallini features a dedicated staff that is diverse in experience. The district has a long tradition of prioritizing professional development in the area of curriculum and instruction. The school benefits from outside consultants, an in-district curriculum coordinator, as well as an active collaboration with its regional high school and fellow sending K-8 districts.



Student Supports and Services:

Cavallini offers a full service Child Study Team, featuring two Case Managers, a School Psychologist, a Director of Special Services, a Speech Pathologist, an Occupational Therapist and a Mental Health Social Worker. In addition, the school maintains two School Counselors, two full-time Basic Skills instructors and one Enrichment teacher. All teachers are available for after-school extra help on a daily basis and work with students individually, or in small groups, during an Academic Support period.

Student Health and Wellness:

Student Wellness has consistently been a formal district goal. At Cavallini, students enjoy a Wellness Day, a comprehensive health curriculum for grades 6-8, DARE classes taught by a police officer, guest speakers, and multiple lessons conducted by our school counselors. The school also promotes "Family Nights" and "No Homework Nights," aimed at maximizing family time and relieving stress. The district has also added a Mental Health Social Worker to further support and expand these efforts. In addition, students participate in a community building program called Community Circles led by the teaching staff. These routine meetings feature students assembling in small, consistent groups that ultimately function as a community within themselves.



Parent and Community Involvement:

In addition to our internal efforts, parental involvement is a definitive strength. Our parents and community continue to make significant contributions in the form of chaperoning, donation, and volunteering. Our three most prominent parent organizations include the Upper Saddle River Educational Foundation, Parent-Teacher Organization, and the Youth Guidance Council. These organizations have made countless donations, resulting in an enhanced scholastic experience for our students. The district also leads a Parent-School Wellness Committee which has planned several events and invited speakers to address the most prevalent challenges surrounding wellness.



Facilities:

Cavallini students and the Upper Saddle River community enjoy updated and exceptionally maintained facilities. The school's Gymnasium, Auditorium and newly renovated Media Center all feature large, modern spaces. The school also has four updated Science labs, one STEM Lab, a Computer Lab, Technology Education makerspace, cafeteria, band room and a television studio. All classrooms are air conditioned and equipped with a Promethean Board.
