







## Graduation/Postsecondary

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Facilities:

The school building was erected in 1922. The school houses a Library/Media Center, computer lab, two art rooms, and a gymnasium. Science labs are all newer. The school building has central air. We also have a full athletic facility similar to a field house. A brand new weight room. Positive murals have been painted on the wall.



School safety drills are conducted twice a month, per NJDOE/New Jersey guidelines. Our students are required to carry a school ID. Students must scan in and out of certain areas in the building throughout the day, and are monitored by an online program which details students' whereabouts throughout the day. The building uses 100 security cameras. We offer programming on character education, establishing a stigma-free environment and anti-bullying expectations. We also utilize school climate surveys. The School Safety Team meets once per month. A SRO walks through the building daily, and the local police department helps with dismissal and active shooter trainings.

Technology is infused across our curriculum, per state protocols. The school has a a developing Makers Space. We offer technology classes such as Web 2.0 and Computer Principles. Our students maintain a school YouTube channel called Blue Devil Nation. We offer a STEM Club, as well as a Robotics Club.



Student attendance rates are monitored daily and monthly for trends of absences and absence reasons. Daily communication between home and school takes place to confirm the absence of students. Students observed to have high degrees of absenteeism or erratic trends in school attendance are referred for intervention as appropriate. Historical attendance data from the Seventh grade students in their Sixth grade year at the Wood-Ridge Intermediate School as well as from the Ninth grade students in their Eighth grade at our sending district of Moonachie, are analyzed to assist in being proactive in addressing the attendance rate of our incoming students in their new school environment.
