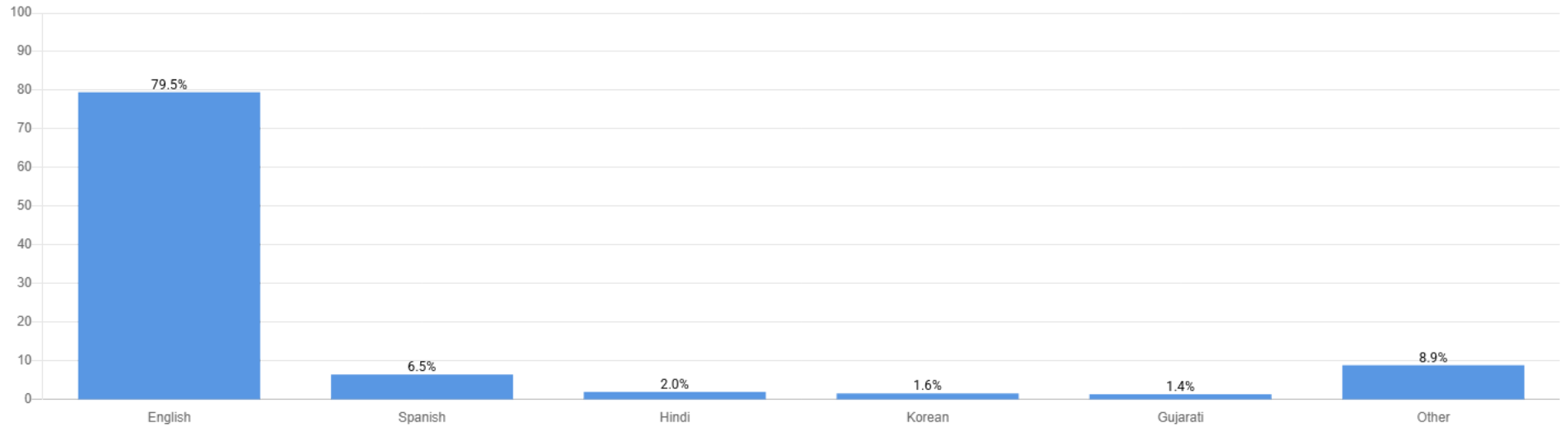

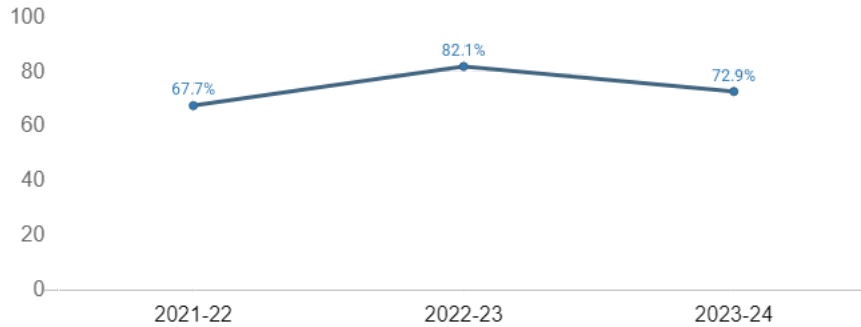

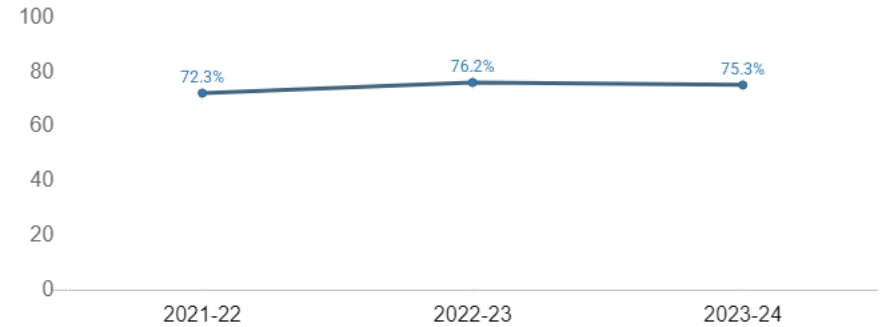
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 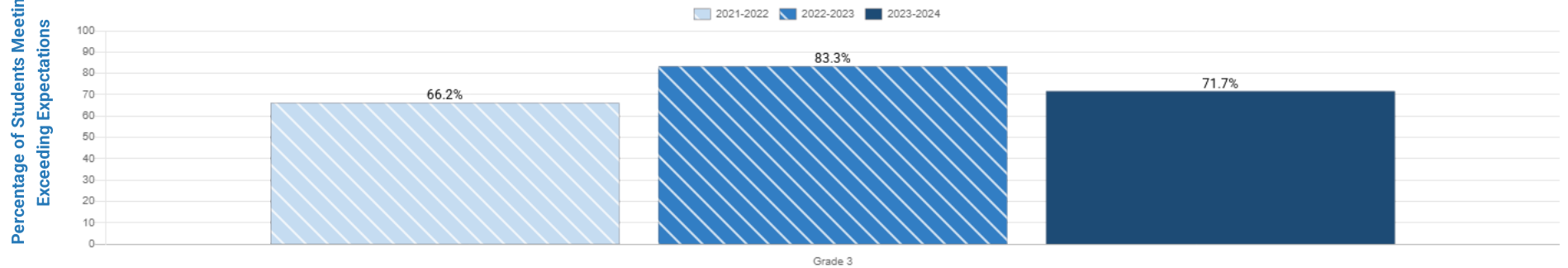

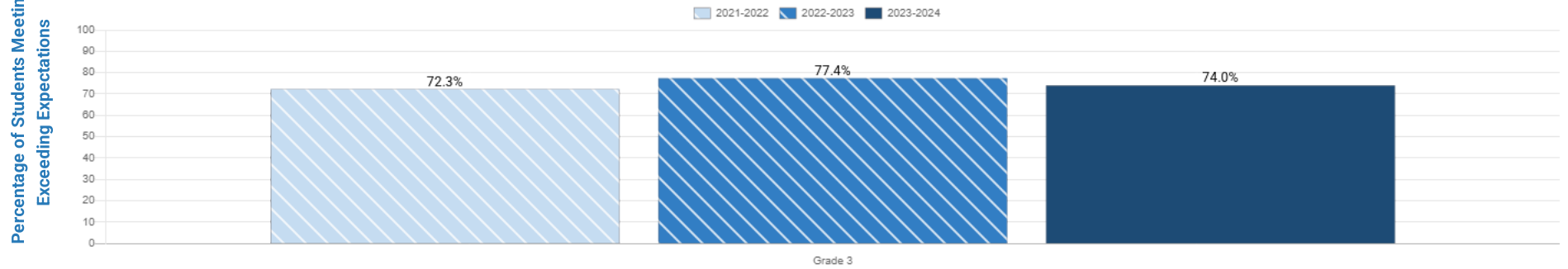

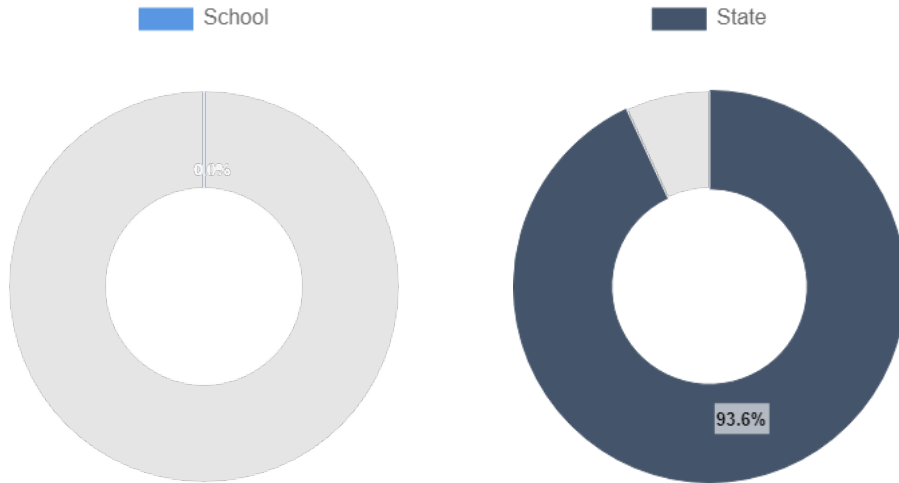

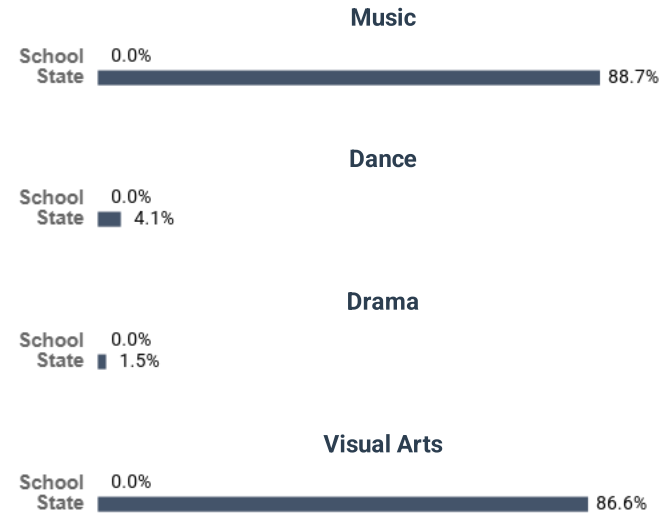

Students enrolled in one or more classes by discipline:



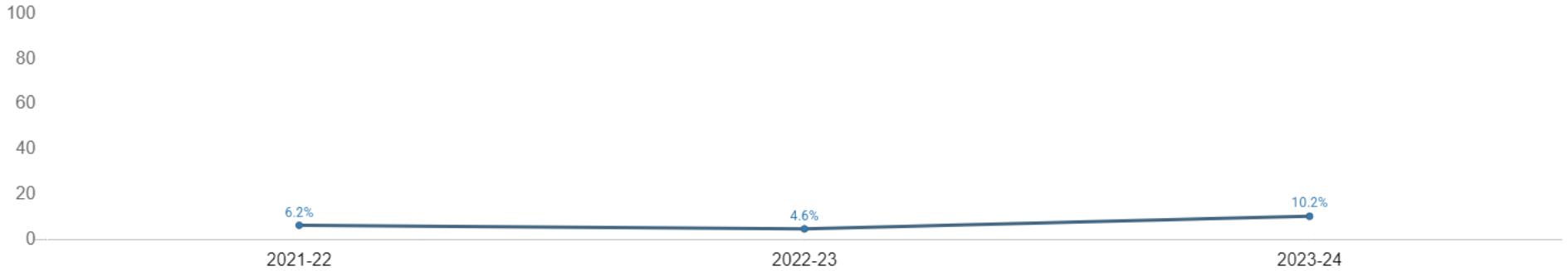

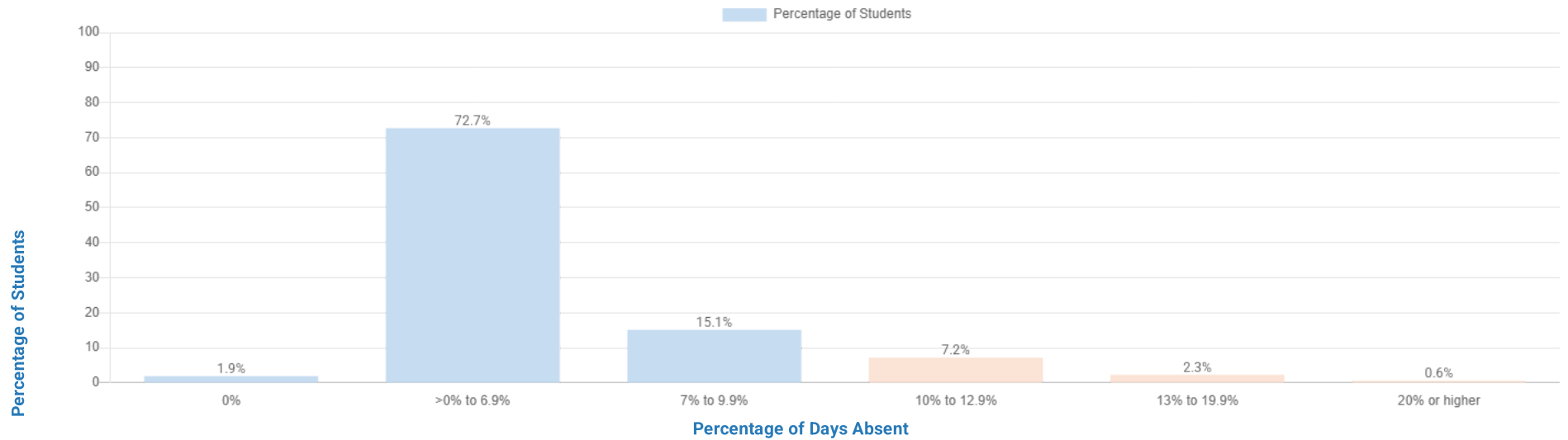

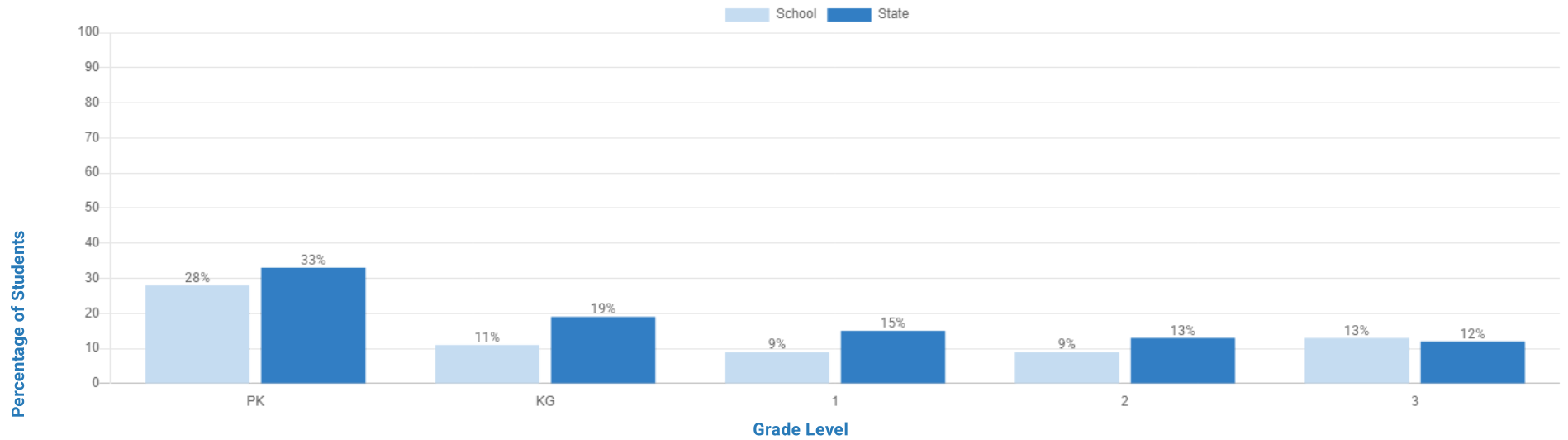

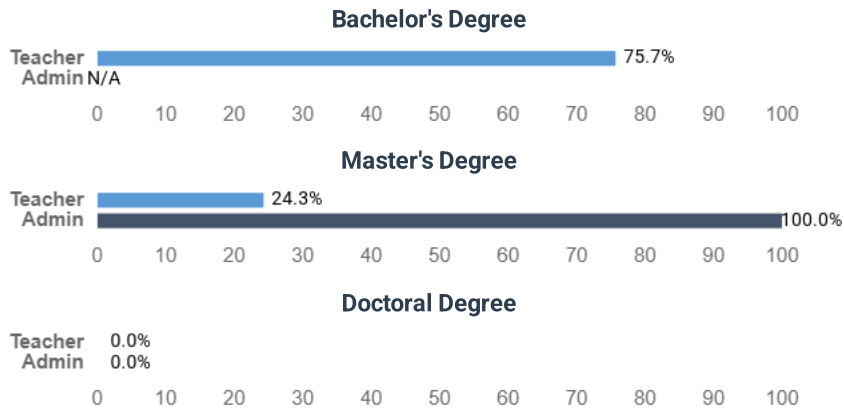

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Highlights:

- To further meet the needs of our diverse learners, a What I Need Now (W.I.N.N.) daily period was added to the instructional schedule for Grades K-3, after piloting it in Grade 3 last school year.

Courses, Curriculum, Instruction:

The District's curriculum aligns with New Jersey Student Learning Standards. For ELA, Grades K-3 use Savvas? myView Literacy, while preschool teachers implement Tools of the Mind and Central Reach, the latter also supporting Special Education classes with significant academic and behavioral needs. Staff across grades have been trained in multisensory reading instruction. In Math, Grades K-3 use Savvas? enVision 2.0. Core instruction for K-3 also includes Science, Social Studies, Visual & Performing Arts (Art, Music, Dance, Theater), Comprehensive Health & PE, and STEAM. We offer Special Education models such as Inclusion, Resource Room, and Self-Contained, as well as Gifted & Talented, ML, and Reading Support for eligible K-3 students. Special Education staff have completed Crisis Prevention Institute (CPI) training.



Sports and Athletics:

The Borough of Wood-Ridge offers many sports and athletics programs to students in this grade span via a robust slate of programs offered by the Borough Recreation Department.

Before and After School Programs:

The Doyle School provides tuition-based Before Care and After Care programs for students and families. Before Care runs from 7:00 to 8:00 A.M., and After Care operates from 3:00 to 6:00 P.M., both supervised by certified staff.



Staff and Professional Learning:

Doyle School staff participate in numerous professional development opportunities each year, with many exceeding the 20-hour annual requirement. Two full days and three half days are devoted to professional learning, along with monthly school-wide PLC meetings that allow for horizontal, vertical, and departmental collaboration. Additionally, as a member of the South Bergen Jointure Consortium, the Wood-Ridge School District offers faculty access to extensive professional development resources across all curriculum areas.



Student Supports and Services:

The Doyle School provides various Special Education programs, including Inclusion, Resource Room (ELA and Math), and Self-Contained classes with mainstreaming options. Qualifying students also have access to additional services such as counseling, behavioral analysis, speech therapy, occupational therapy, and physical therapy. Multilingual learners receive push-in and pull-out support tailored to their needs, while other at-risk students benefit from guidance counseling, behavioral analysis, Reading Support, and NJTSS through customized I&RS Action Plans. With a full-time elementary counselor, district BCBA, and on-site CarePlus therapist, Doyle School offers comprehensive social and emotional support. Extended School Day and Summer Acceleration programs provide ELA and Math remediation for K-3 students in need, while twice-monthly Office Hours allow for additional remediation or enrichment.

Student Health and Wellness:

All students at Doyle School participate in regularly scheduled Comprehensive Health and Physical Education classes per state requirements, along with 20 minutes of daily outdoor recess on a modern playground, weather permitting. Each day includes time for snack, and PSD students also have a daily nap period. Various outside vendors and organizations provide Health, Wellness, and Social Emotional Learning programs and assemblies on topics like Playground Safety, Bicycle Safety, and Halloween Safety. All students also enjoy annual events such as Field Day and Jump Rope for Heart through the American Heart Association. Additional support includes school counseling and on-site CarePlus therapy for social, emotional, and mental health resources, while a school-wide PBIS system promotes SEL and wellness.



Parent and Community Involvement:

The Doyle School is grateful for the support of the Wood-Ridge PTA and the Wood-Ridge Parent Advisory Network, which enhance our school and enrich our students' educational experiences. Background-checked and fingerprinted parents volunteer for various school events, including field trips and Field Day. Facilities:

CED Elementary School was built in 1952, with two additions, the latest in 2004. Over the past five years, the building and facilities have undergone significant renovations. The school is fully air-conditioned and features a modern HVAC system, new interior doors and exterior windows, and air purifiers in each classroom. We have a multi-use Library/Media Center and Art room. The All-Purpose Room is used for Physical Education classes, school-wide assemblies, and daily lunch service, boasting an advanced sound system. Additionally, the school includes a state-of-the-art playground and recreation facilities, including an outdoor instructional area. In the summer of 2024, and throughout the 2024-2025 school year, the building will undergo a construction project to enhance our facilities and add an extension to accommodate the growing student population. The school grounds are beautifully maintained, providing an inviting environment for our students and community.



School Safety:

CED is equipped with security cameras in every hallway and at all entry and exit points. These cameras can be monitored from any school in the district, the Board of Education office, and the Wood-Ridge Police Department. The school also has a School Resource Officer on site every day. All visitors are required to sign in and out as well as obtain a visitor's badge before entering the building. Fire and safety drills are conducted monthly, as mandated by the state, and a School Safety Team convenes throughout the year to explore additional measures for maintaining a safe and secure environment. Each year, Doyle School participates in the statewide Week of Respect, incorporating themed activities into the curriculum, alongside various school-wide initiatives promoting positive behavior and character development. Our guidance counselor serves as the Anti-Bullying Specialist and has completed the necessary training, while all staff members undergo annual HIB training.



Technology and STEM:

Many of CED's instructional programs incorporate technology for both students and teachers. Students in Grades 2 and 3 engage in a 1:1 program using Acer Chromebooks, frequently utilizing Google Classroom for instruction. Additional devices and charging carts are provided on a rotating basis for Kindergarten, Grade 1, and Media classes. All K-3 students also participate in a full-year STEAM course. To support ELA and Math instruction, we use the Savvas Realize platform and have adopted IXL for both subjects. Furthermore, many teachers use Class Dojo to communicate directly and promptly with families, sharing highlights and updates from their classrooms.

Early Childhood Education:

Catherine E. Doyle Elementary School offers two self-contained classrooms funded locally for students identified as Preschool Disabled. These classrooms serve both 3- and 4-year-olds who have been found eligible for support as Preschool Disabled.



Attendance:

Students observed to have high degrees of absenteeism or erratic trends in school attendance are referred for intervention as appropriate.
