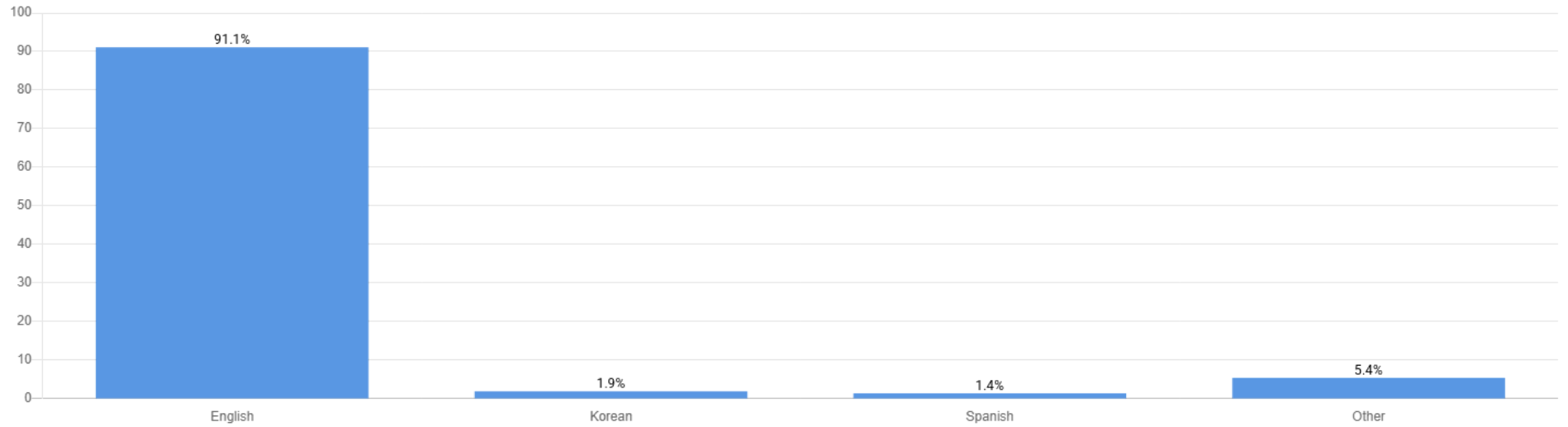

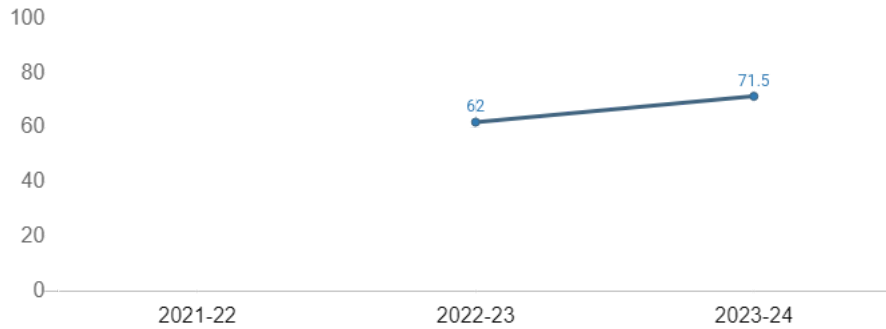

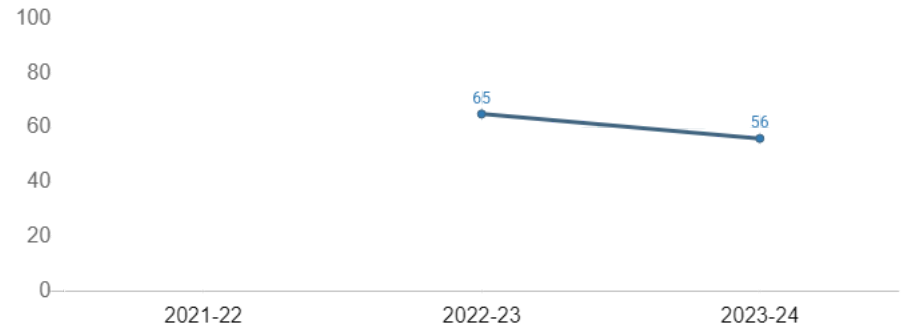

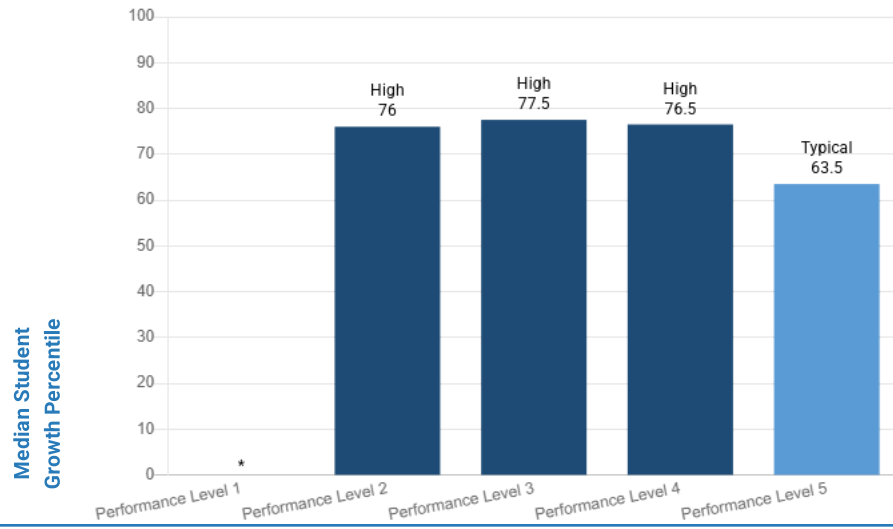

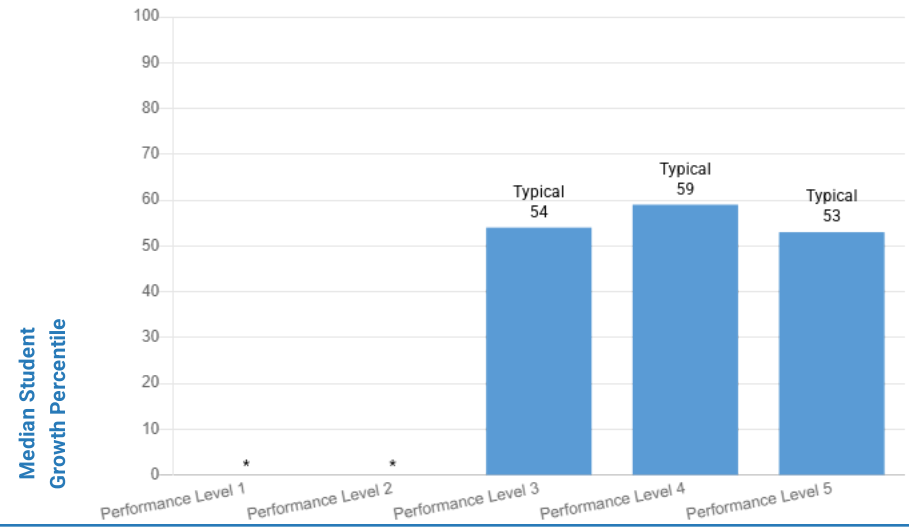

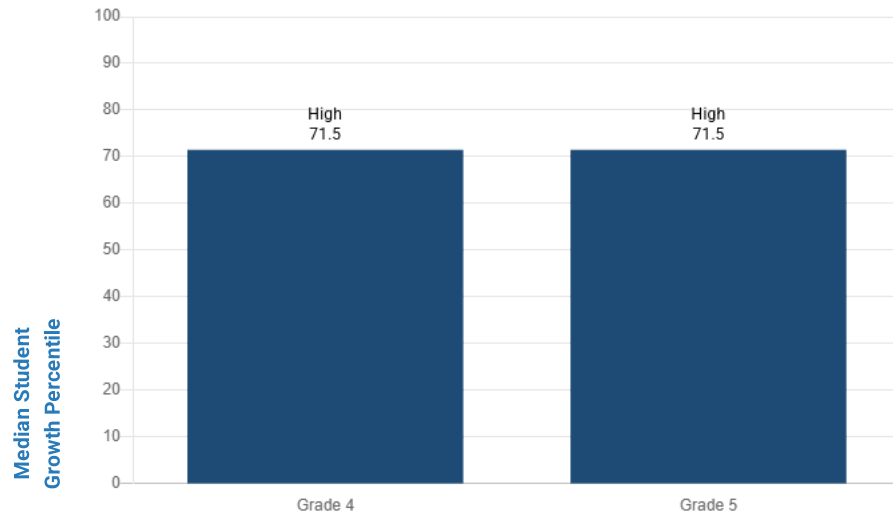

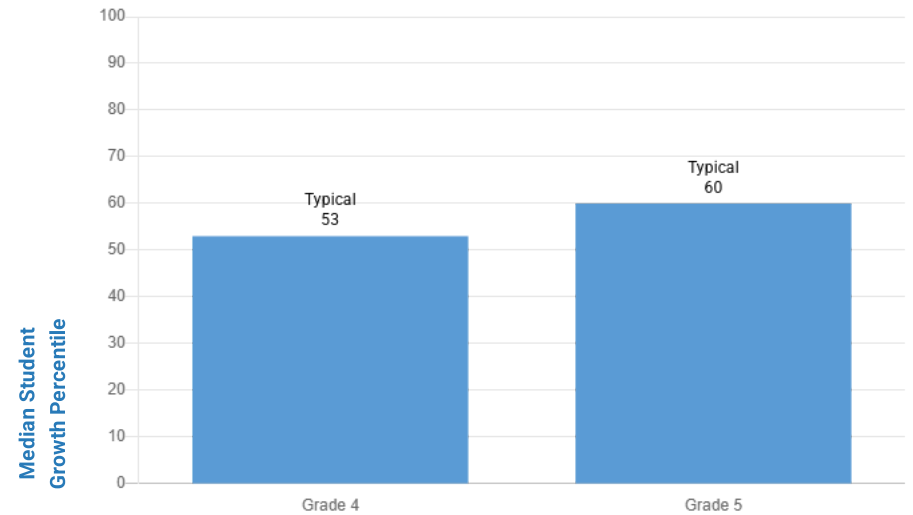

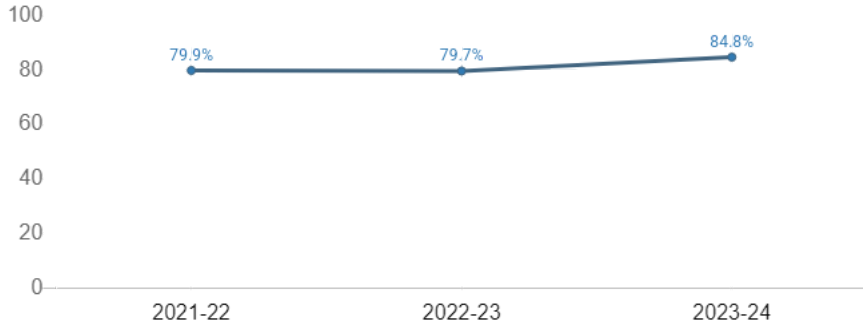

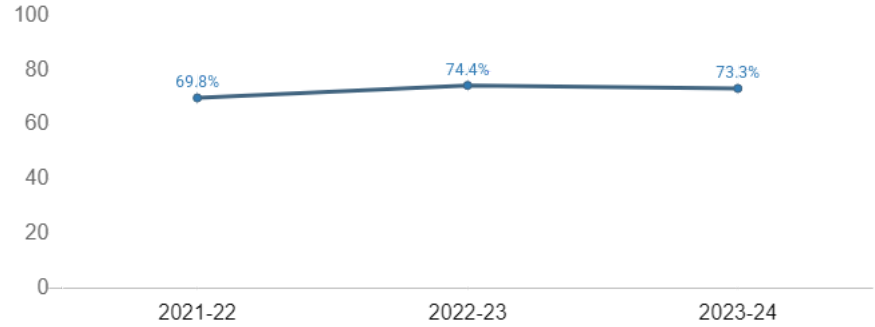
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

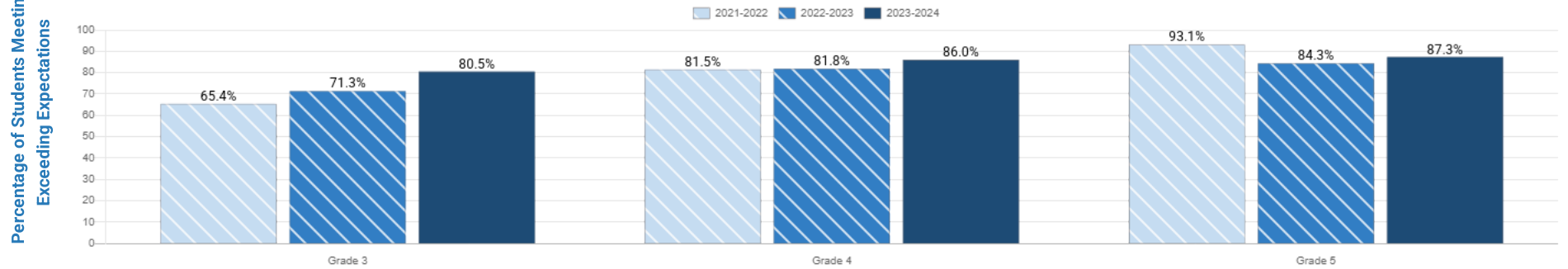

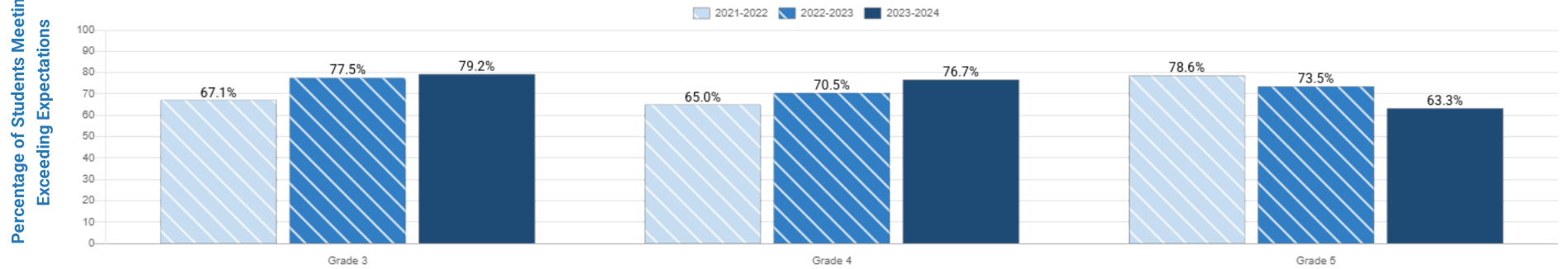

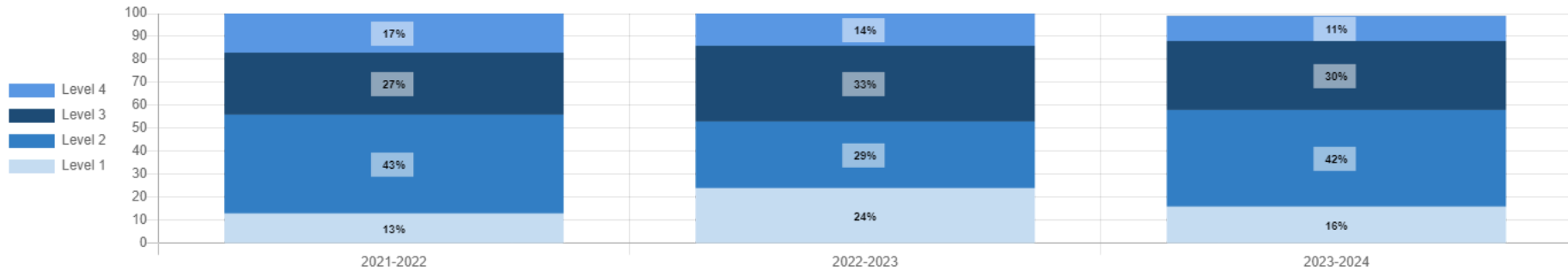

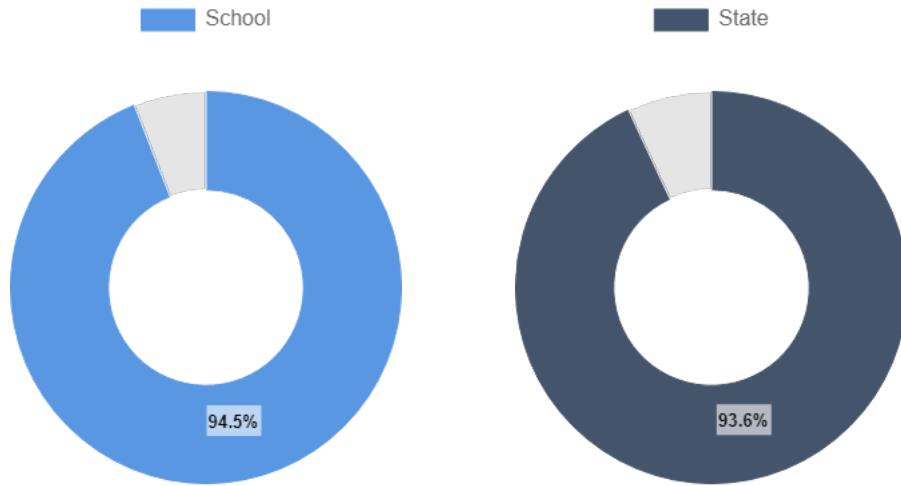

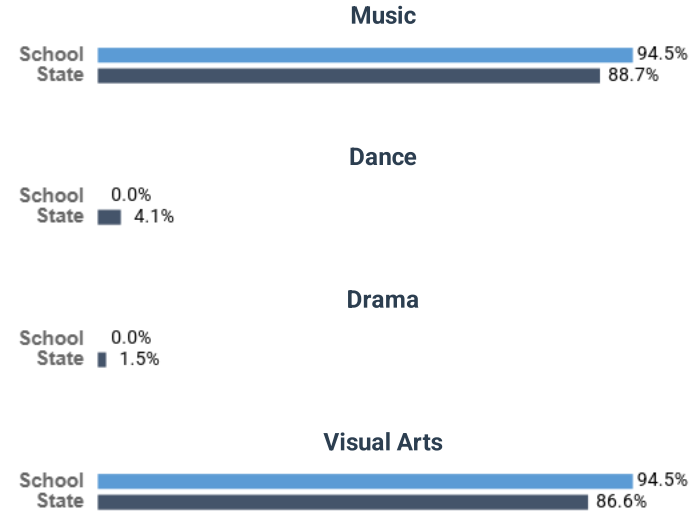

**Students enrolled in one or more classes by discipline:**



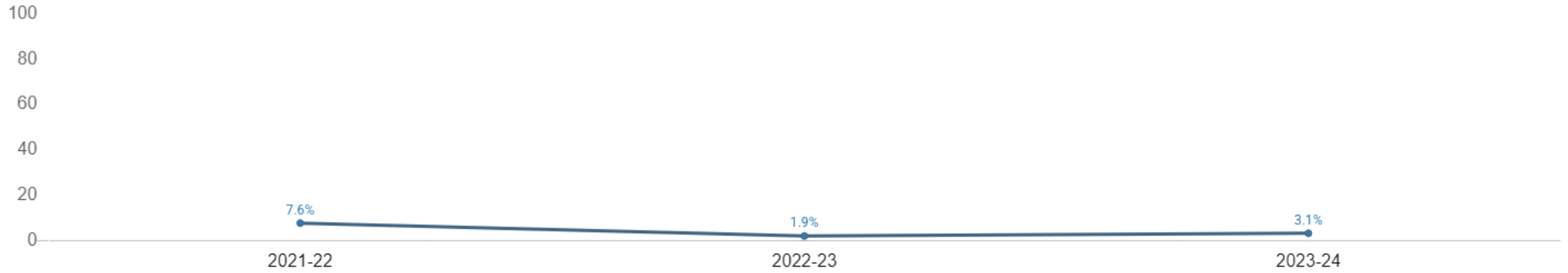
## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

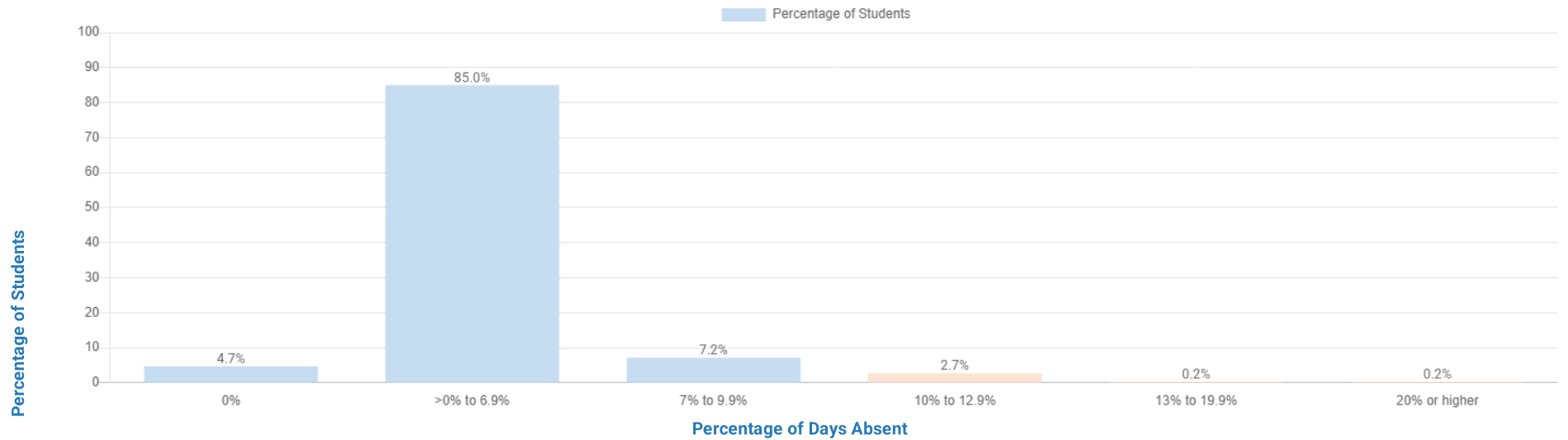

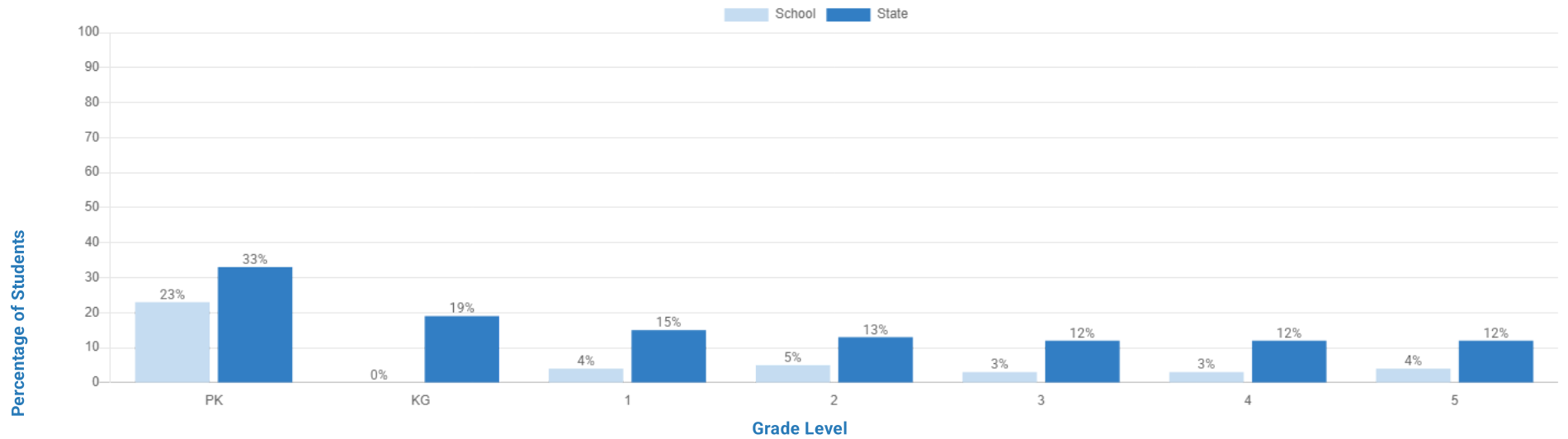

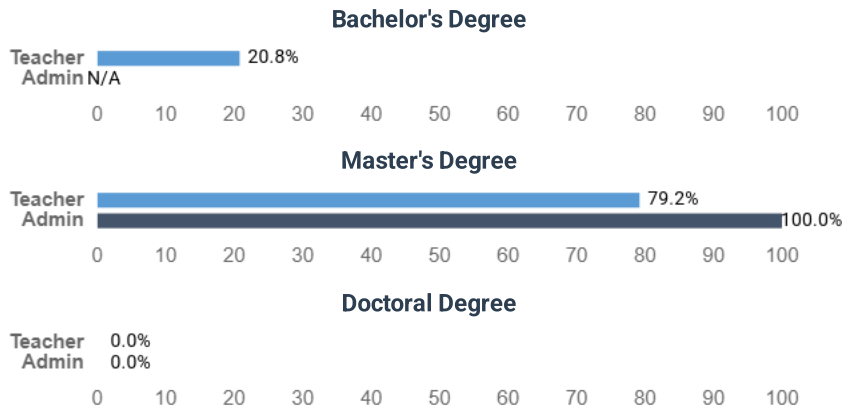

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. ### Technology and STEM:

In addition to cross-curricular connections integrated between the students' math, science, and technology classes, all students in grades K-5 have STEM classes embedded into their schedules. STEM classes are held in the Imagination Lab. This lab, funded by the WCLEF, is equipped with engineering tools and technology. At the 5th-grade level, the class is cotaught by the technology and art teachers, offering a STEAM experience in which students engage in projects such as stop motion videos.



### Early Childhood Education:

The Woodcliff Lake School District supports an integrated pre-school program serving 3- and 4-year-old students. The program provides a safe, nurturing environment, which enables both children with disabilities and general education students to engage in developmentally appropriate activities. The district offers two half-day sessions per day, or one full-day session, which are taught by teachers who are dually certified in both special education and general education and supported by teacher assistants.



### Attendance:

The district has developed and implemented a cohesive plan to maintain strong attendance. Using evidence-based practices, the district tracks and monitors student attendance, which is reviewed at monthly attendance committee meetings. When negative attendance trends among individual students are found, collaborative action plans are put into place to remediate these attendance issues.
