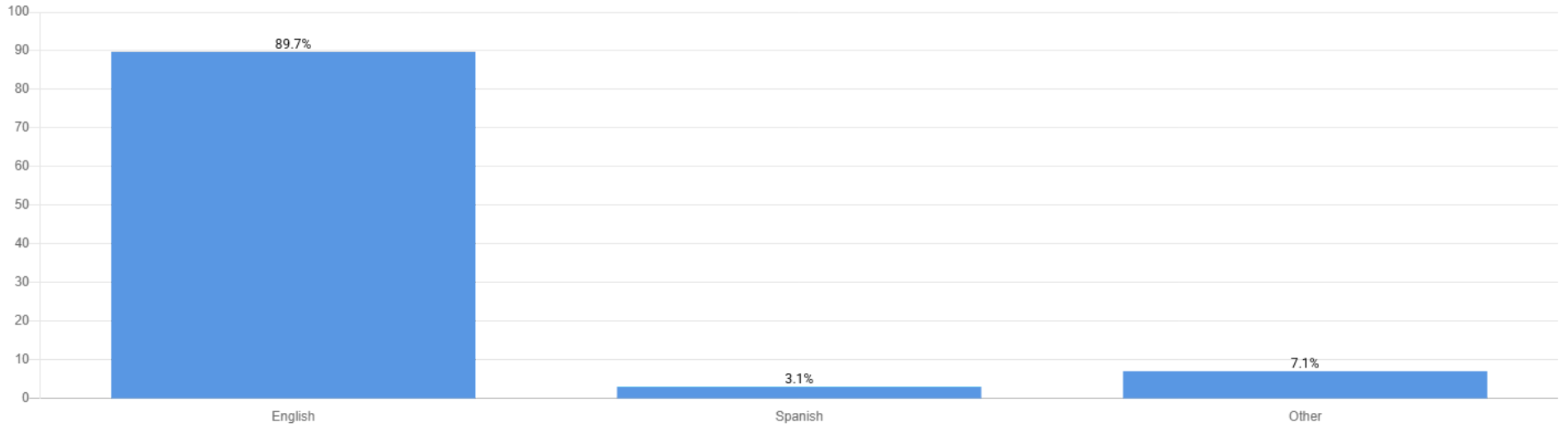

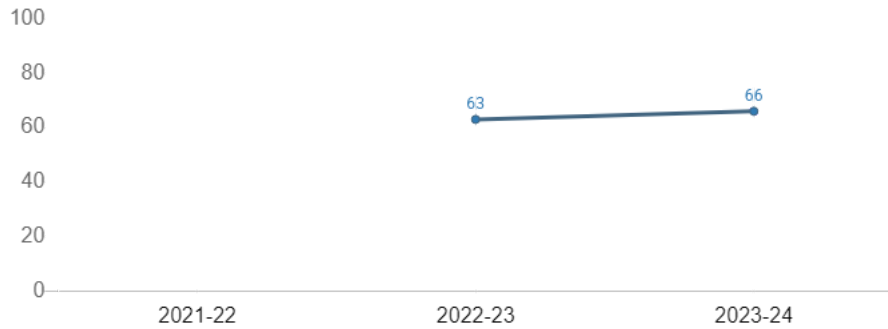

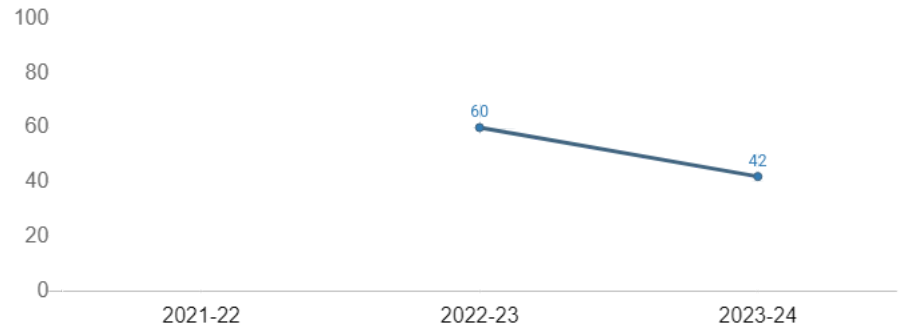

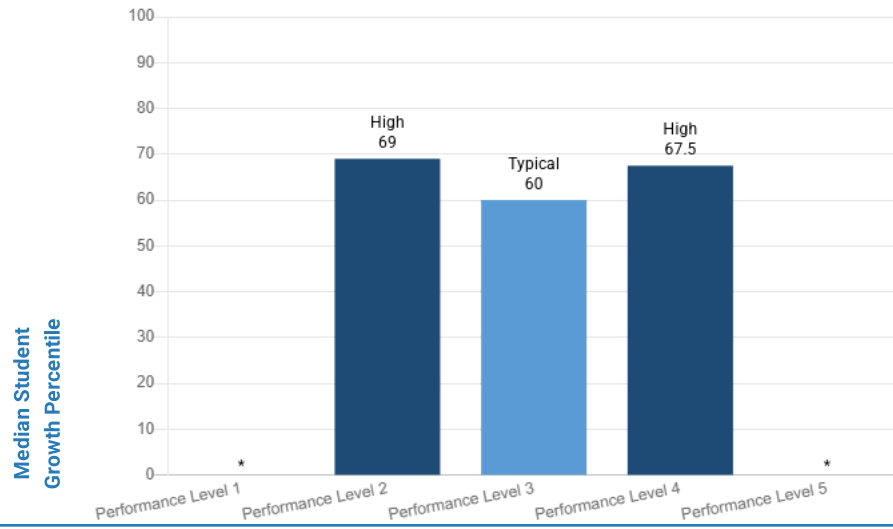

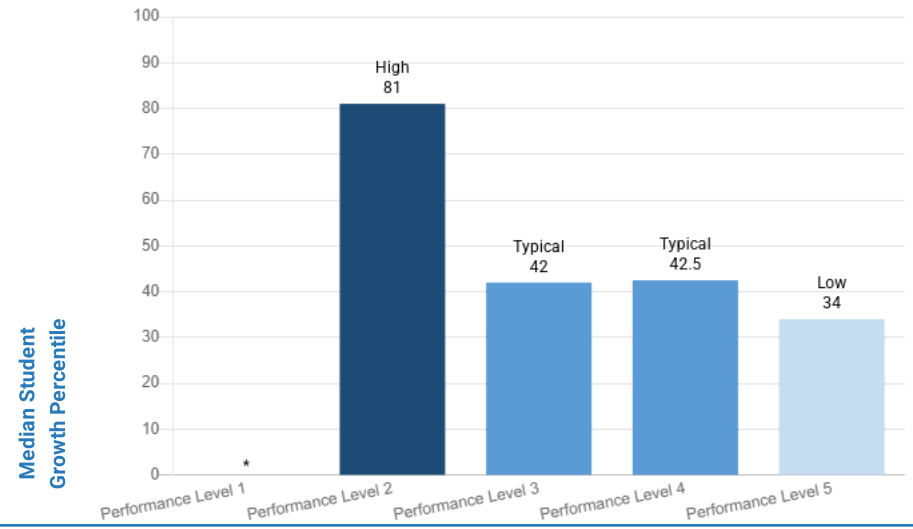

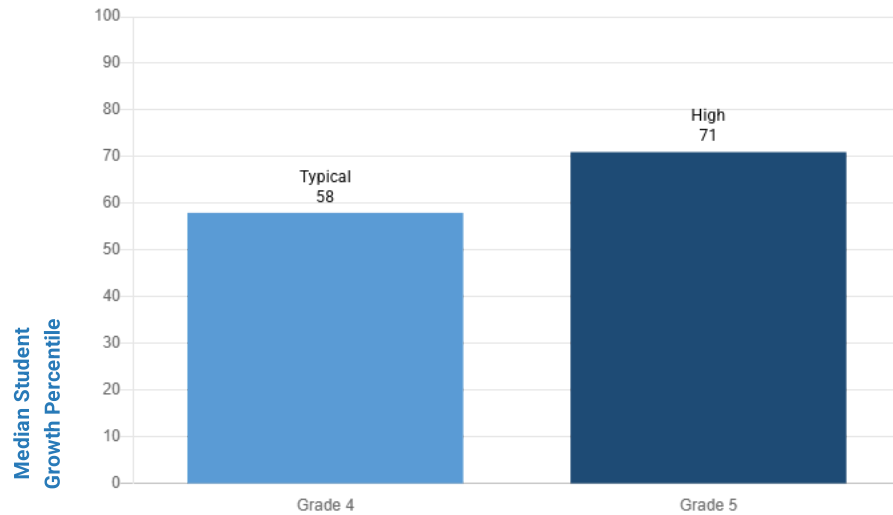

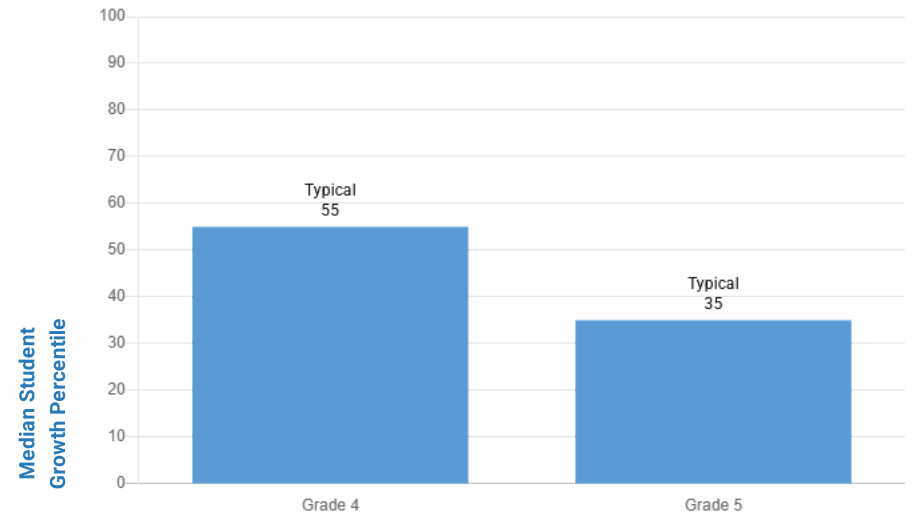

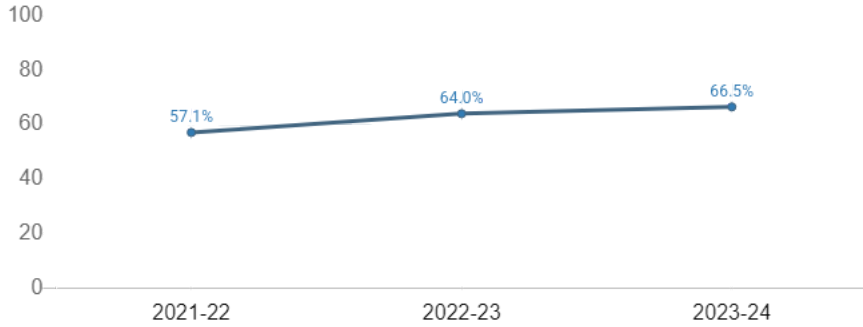

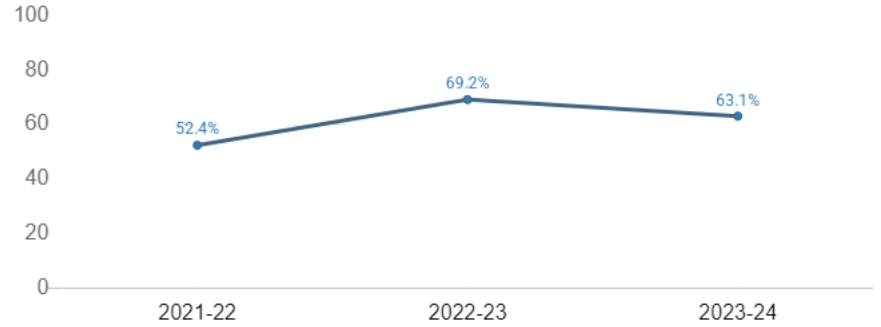
### English Language Arts and Mathematics Performance Trends

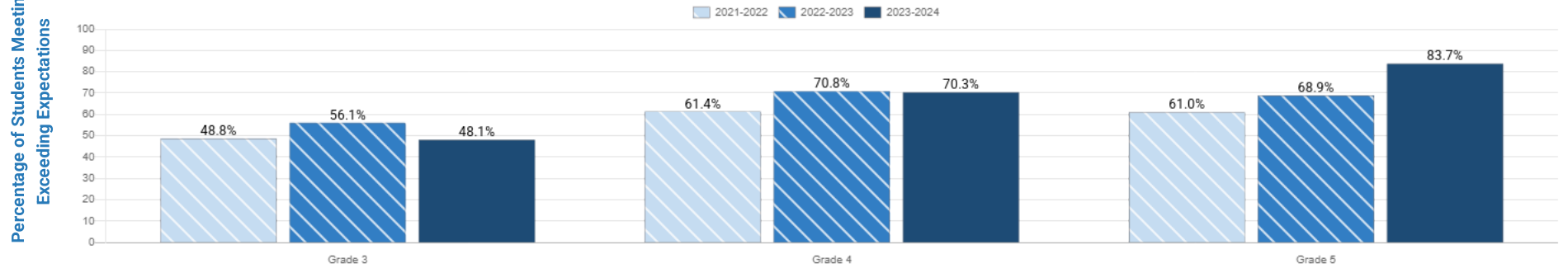

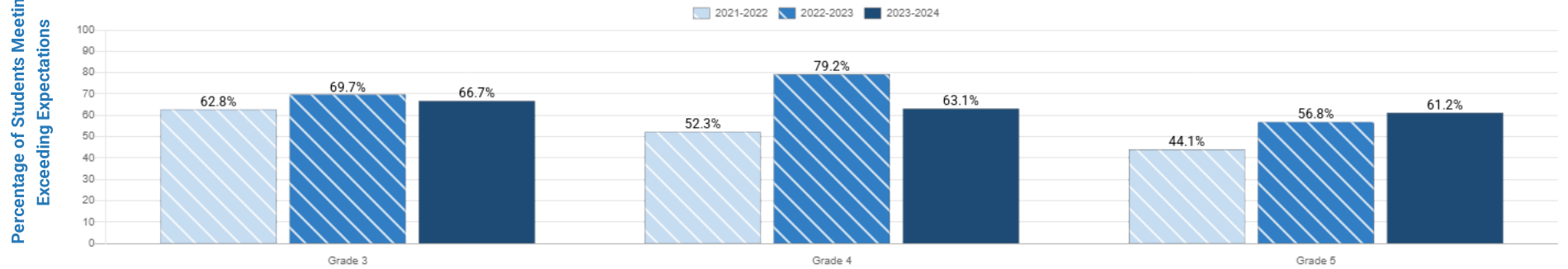

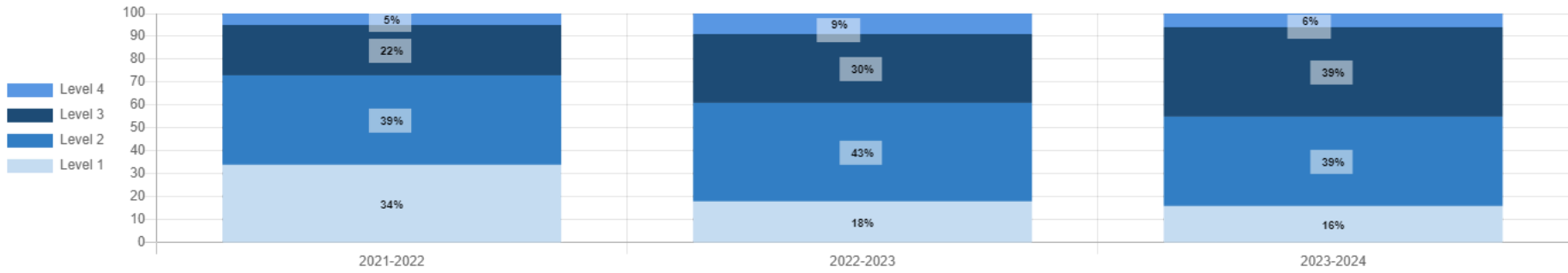

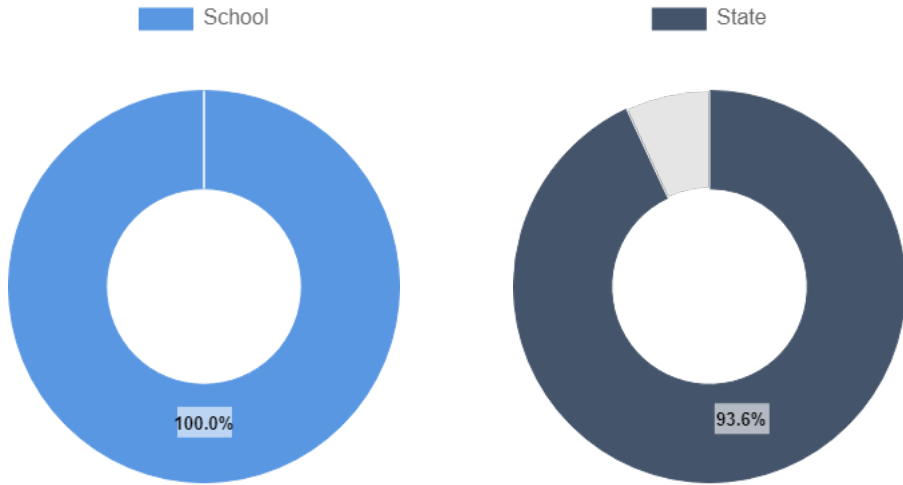

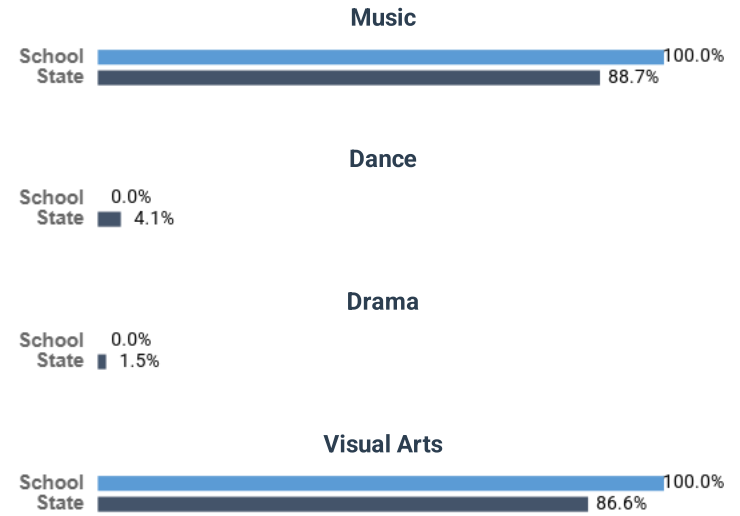

**Students enrolled in one or more classes by discipline:**



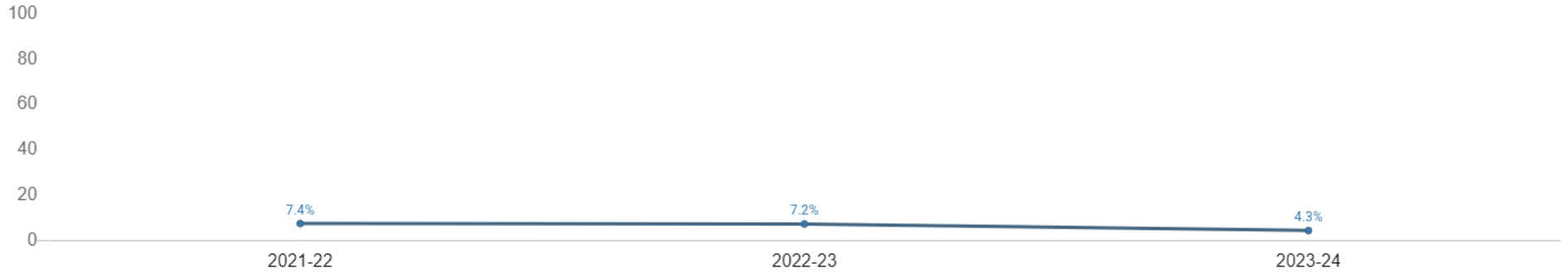

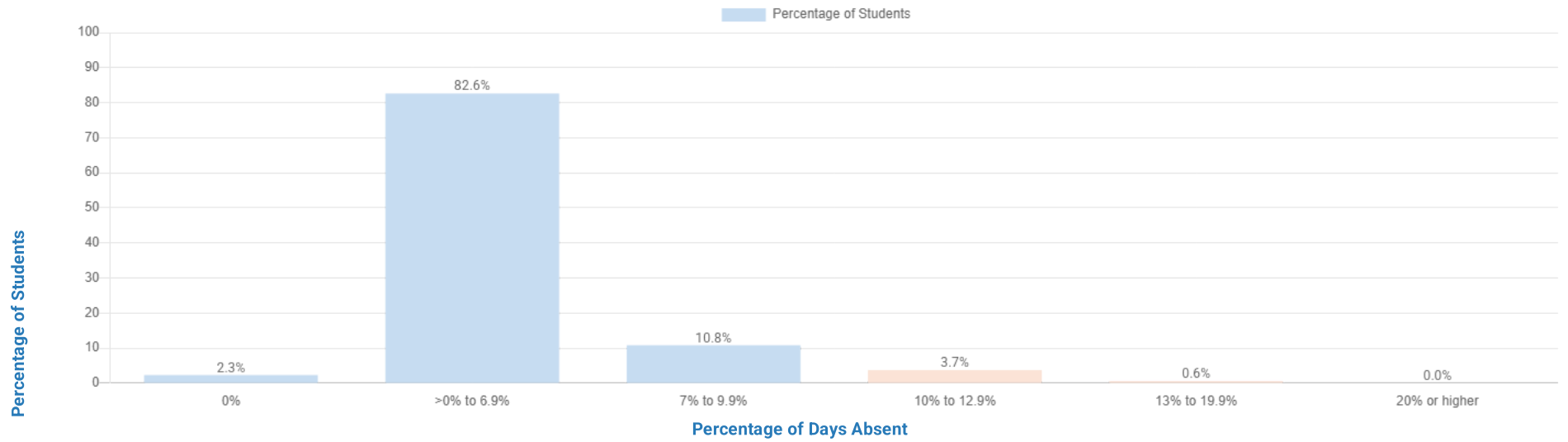

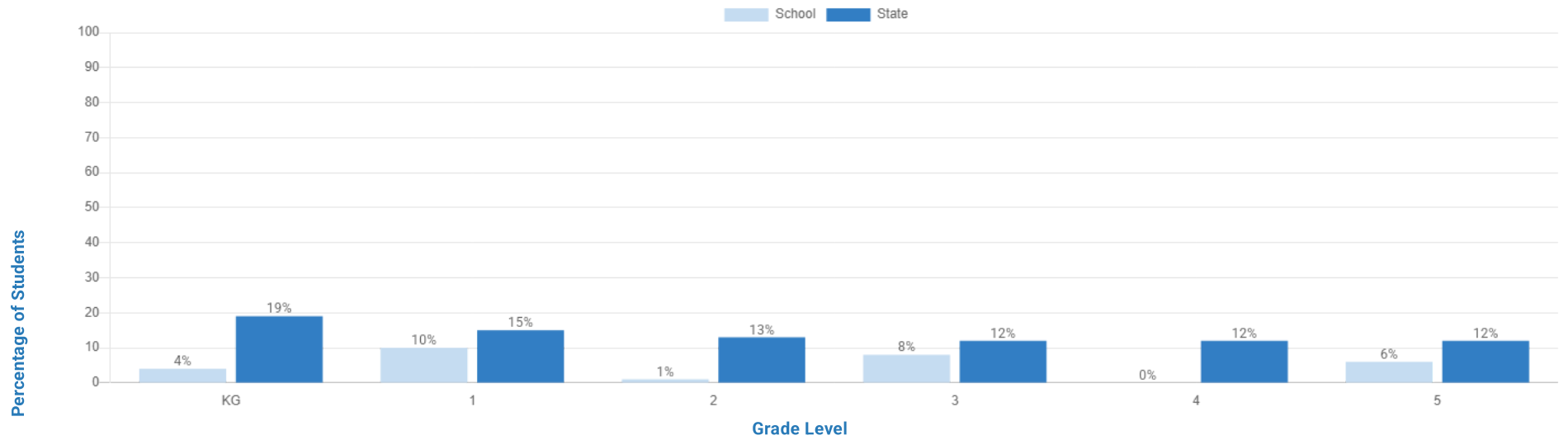

## Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

**Key terms for staff data:**

**Teachers:** All classroom teachers

**Administrators:** Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

**Experience:** Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

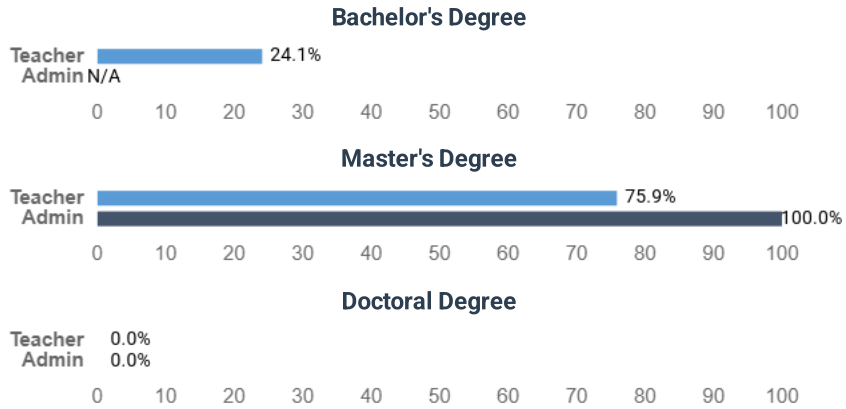

Lincoln School uses a research-based approach to English Language Arts, employing Reading and Writing Workshop along with explicit instruction in phonics and word study. Our math program, Math in Focus, utilizes a Singapore-based approach with a focus on problem-solving and communication. We follow Next Generations Science Standards in an inquiry-based science curriculum, and have a wide range of special area offerings.

Lincoln School has a number of after-school intramural activities, including soccer, speed ball, and scooter football. The scooter football season culminates in a "Scooter Bowl," a popular event in which the entire school unites to view the championship game of the intramural season.

### Before and After School Programs:

Several before and after school programs exist at Lincoln School, including Studio Art, Chorus, Instrumental Band, Student Council, and Intramurals. In addition, Daisies, Brownies, Girl Scouts, and Boy Scouts hold meetings after school and during the evenings at Lincoln School. The YMCA has morning and after-care services held in our school, as well as after school program classes for Lincoln School students that are held on-site once a week. Literary Lions, a student-developed journal, is offered once a month at Lincoln. Local recreational sports utilize our facilities on a regular basis.



### Staff and Professional Learning:

Teachers collaborate in Professional Learning Communities and meet during common planning time to discuss curriculum, instruction, and assessment. In-service offerings are provided after school to teachers in addition to regularly infused coaching and consulting. Lincoln School utilizes a dedicated Instructional Coach who works with our staff on a daily basis to improve instruction and assist teachers in their professional growth.



### Student Supports and Services:

Lincoln School offers the following student supports and services: ELL, School Counselor, Nurse, Reading Specialist, Math Interventionist, Occupational Therapy, Special Services, Speech and Language Services, and I&RS.

Lessons are provided in hand washing, medicine safety, stranger danger, body hygiene, nutrition, and cyberbullying. Guidance lessons are given throughout the year in classrooms. Lunches are provided through outside vendors. Students at Lincoln School receive physical education classes, regular brain breaks, and 20 minutes of recess each day.

### School Safety:

Lincoln School has a dedicated school safety team, comprised of the principal, a school social worker, teaching staff members, and a parent liaison. The team meets several times yearly to discuss and analyze school safety issues, including the physical and emotional safety and security of students. A school crisis team meets regularly to plan responses to potential crises, and performs tabletop exercises to brainstorm how to respond to potential issues of school safety and security. Lincoln School uses the Raptor visitor management system and a single entry system to enhance security and manage access to the building.



### Technology and STEM:

Lincoln School has a strong focus on STEM and an integrated educational technology curriculum. Promethean Boards are located in each classroom at Lincoln School. Students in grades 1-5 have access to Chromebooks on a 1:1 basis. Primary students utilize iPads and interactive software in the classroom. Students in K-5 receive regularly scheduled pull-out technology instruction. STEM lessons are integrated into our Science curriculum, which follows the Next Generation Science Standards. Students perform hands-on inquiry-based science explorations, and make interdisciplinary connections in the classroom as well as through the use of our Makerspace.
