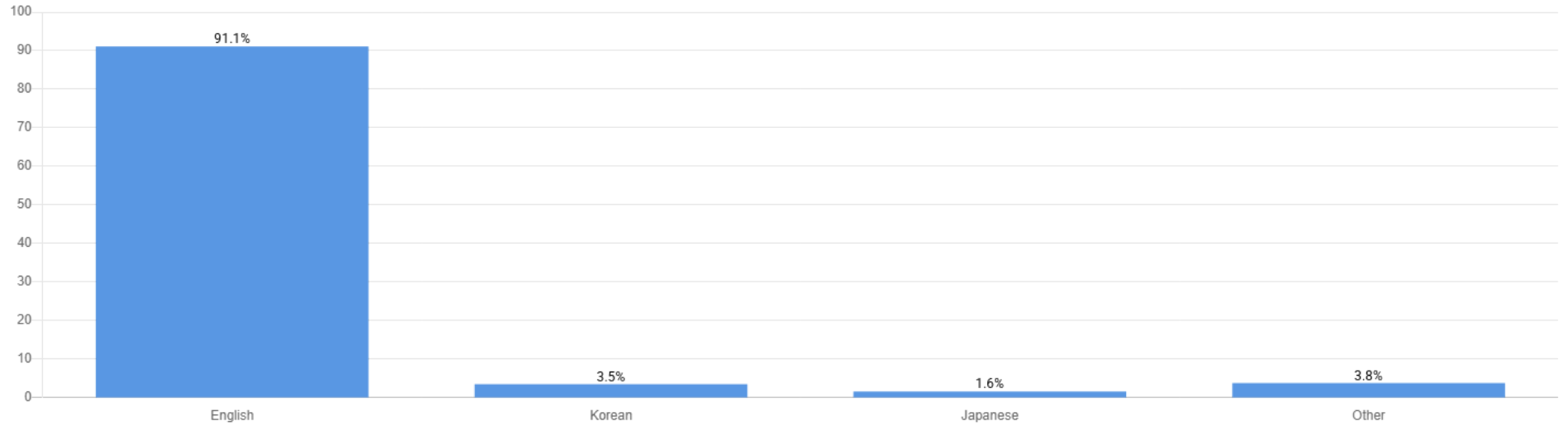

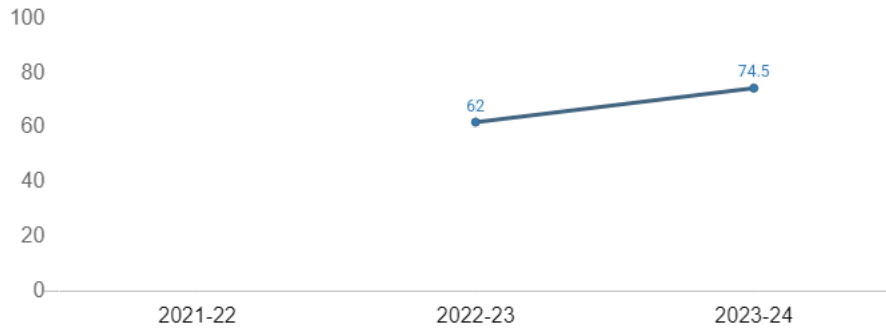

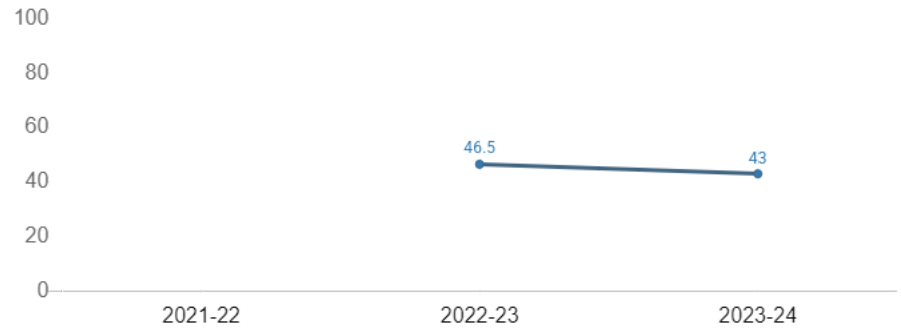

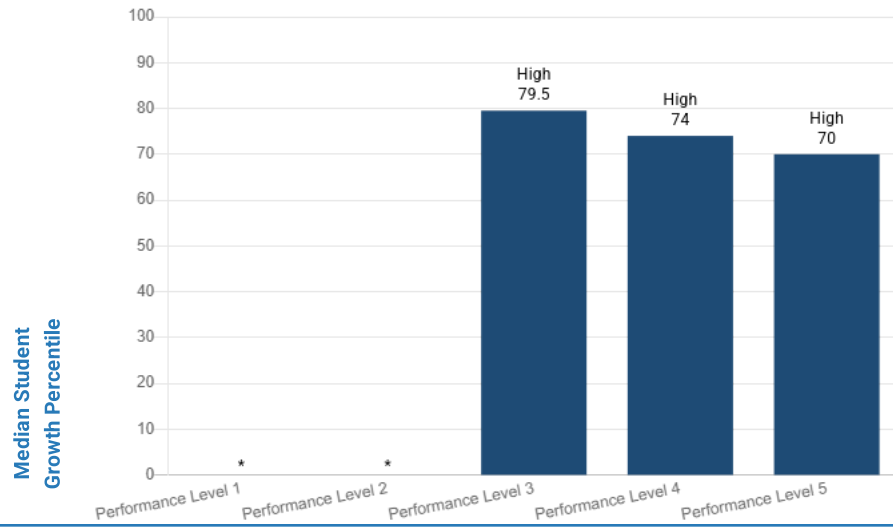

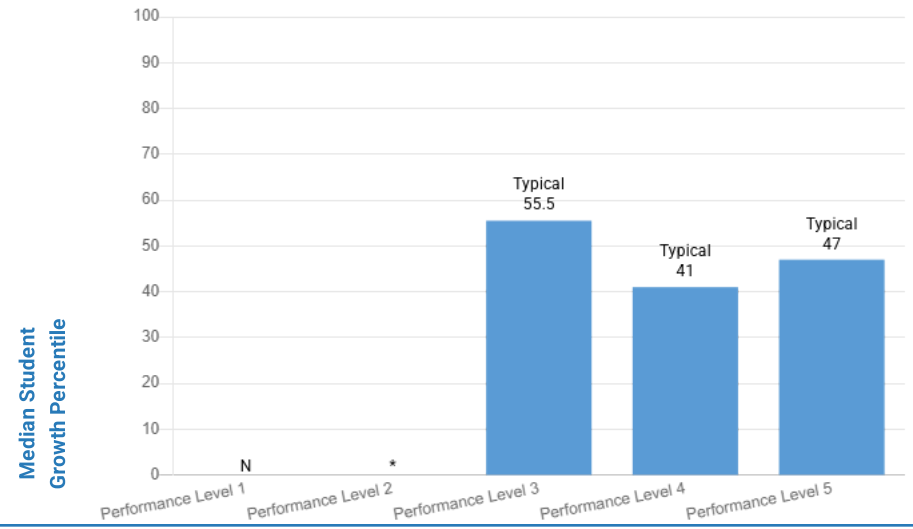

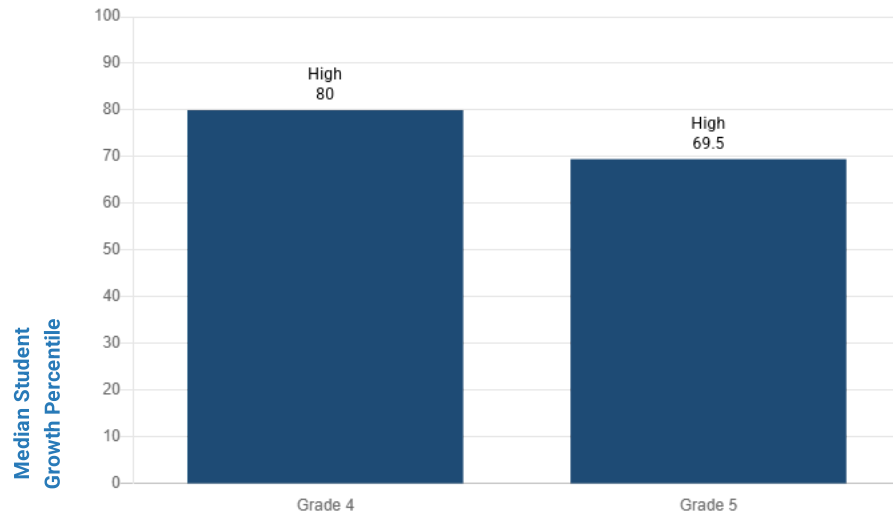

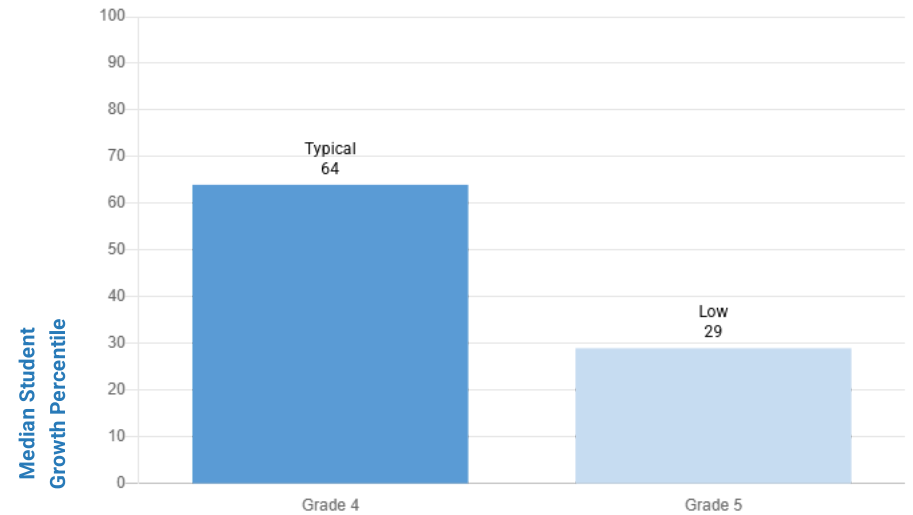

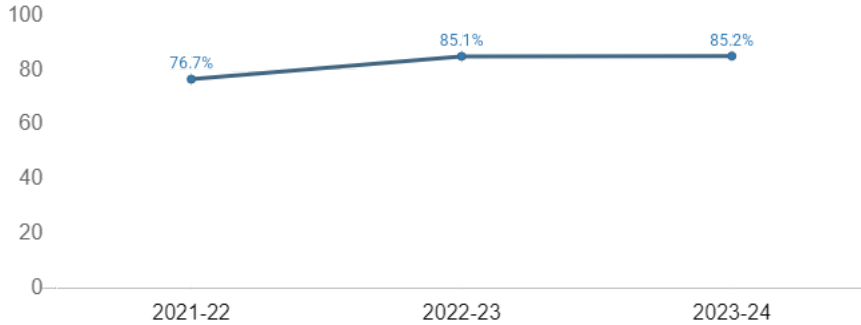

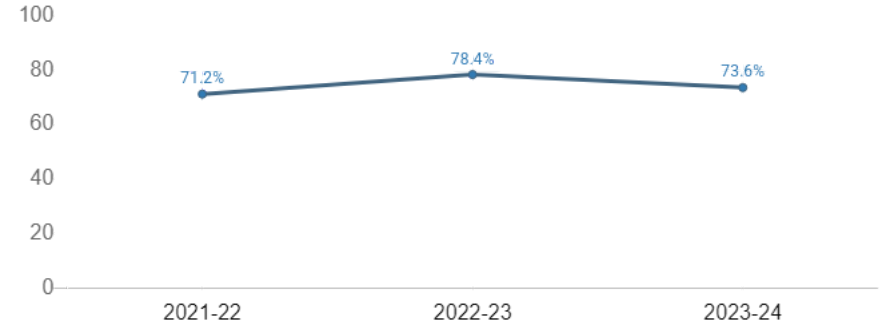
English Language Arts and Mathematics Performance Trends

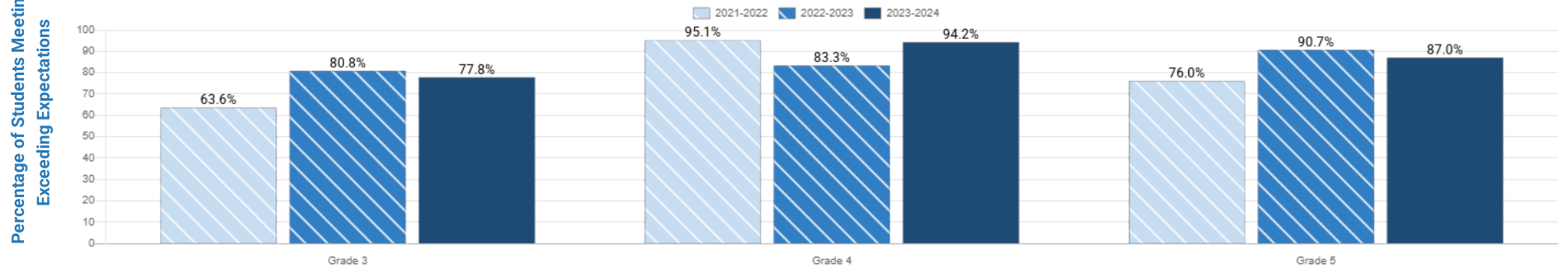

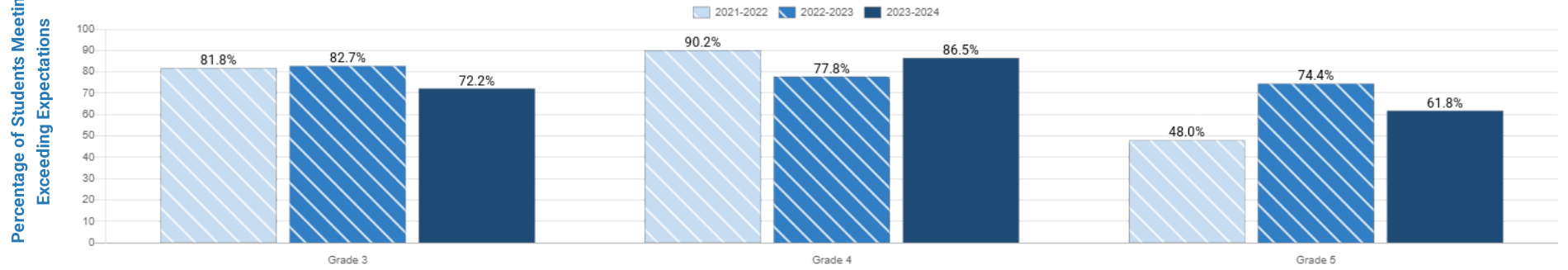

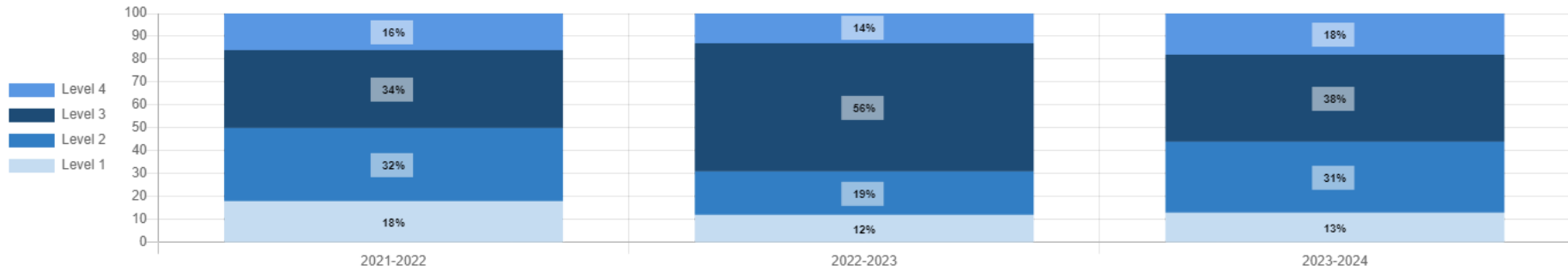

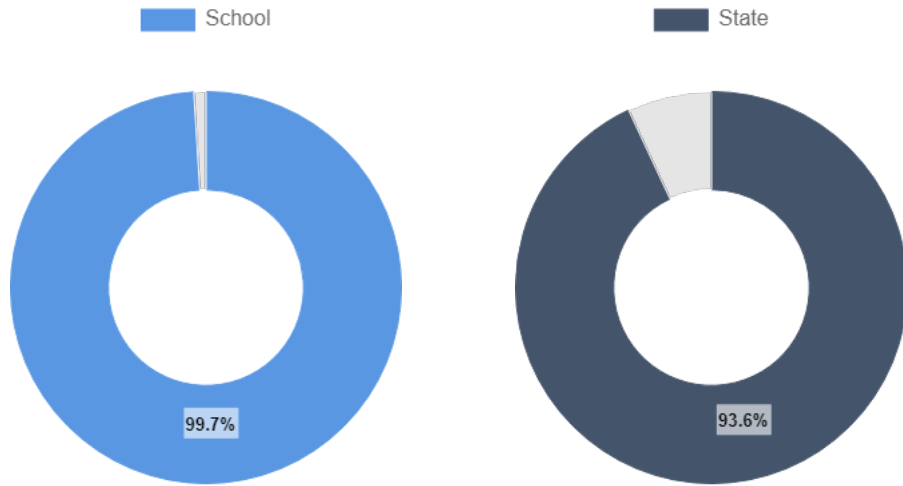

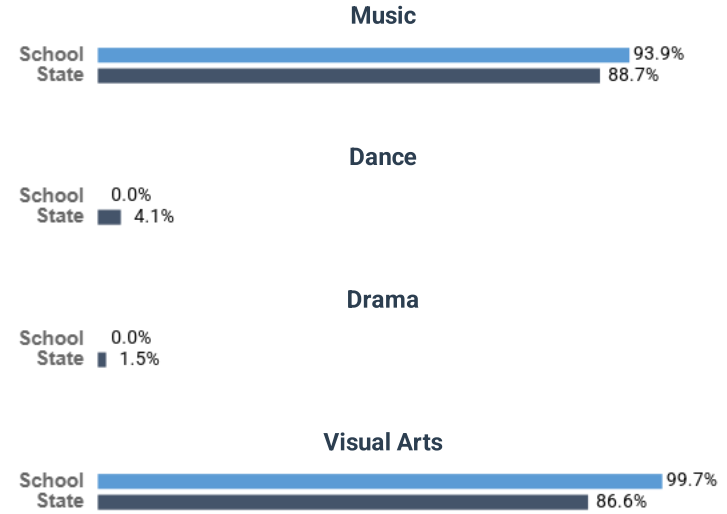

Students enrolled in one or more classes by discipline:



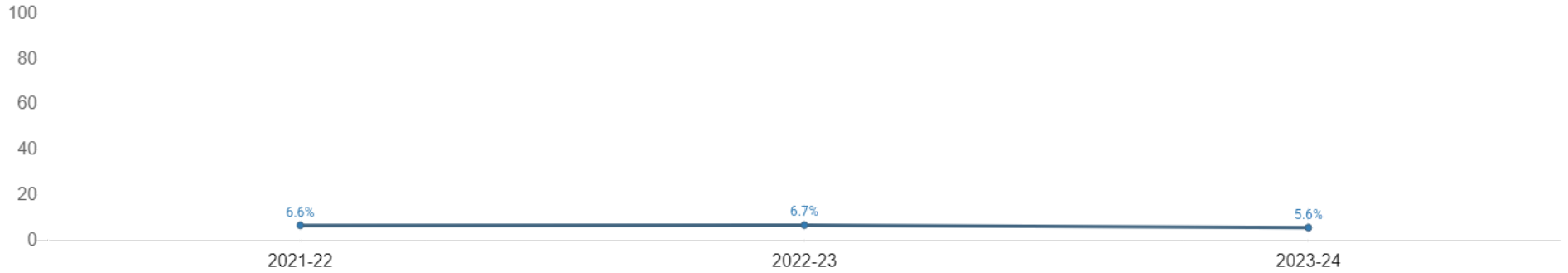

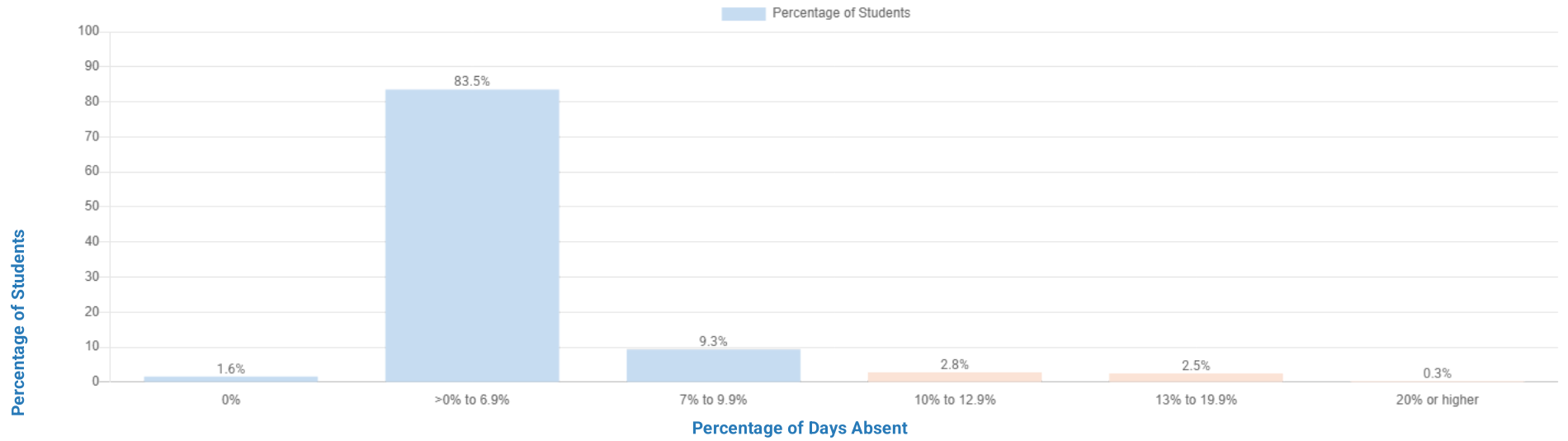

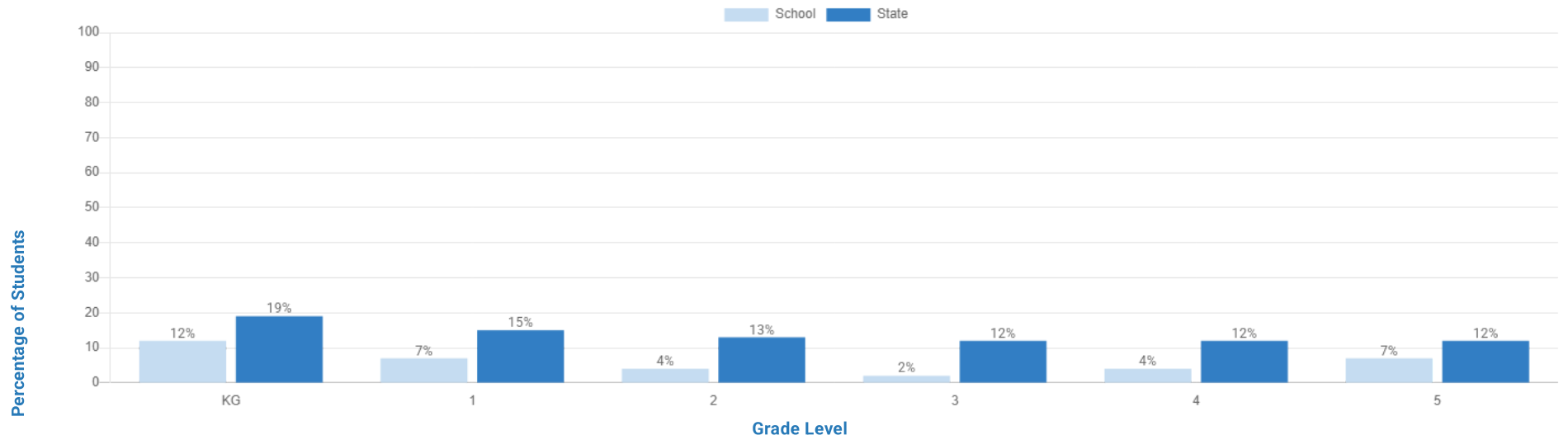

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 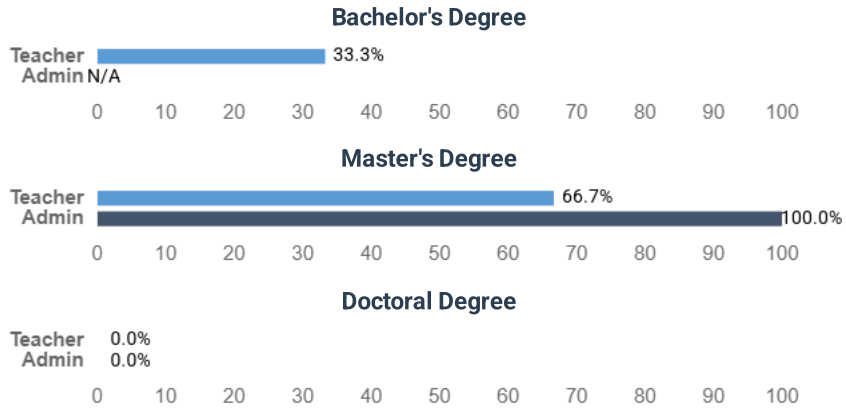

The YMCA also has after-school program classes for students that are held at Coolidge School once a week. The Coolidge PTO regularly runs community service, enrichment, and environmental programs after school at school. Recreational sports utilize our facilities regularly.

Staff and Professional Learning:

Teachers, recognizing community demands for a high priority on excellence, provide an atmosphere for excellence in teaching and learning. They regularly participate in strong in-service programs to improve instructional skills in the areas of technology integration, language arts, inquiry-based math instruction, bullying prevention, social-emotional learning, and much more. Our Instructional Coach regularly works with teachers to provide modeling, mentoring and professional development. Yearly staff book clubs provide an opportunity for collaboration and individualized professional development. Additionally, many teachers take part in Self Directed Growth Plans as part of their evaluation process where they engage in action research with their students.



Student Supports and Services:

Coolidge School seeks to meet the needs of all learners regardless of ability. Working in collaboration with our Instructional Coach, teachers plan differentiated lessons to meet a diverse population and implement Tier 1-3 interventions. Assessments are administered regularly to gain a deeper understanding of the strengths and weaknesses of our students. Working through a multi-tiered system of support, Reading specialists and Math interventionists work with students on targeted instruction to remediate learning difficulties. Regular data team and grade level meetings help the guidance and administrative team carefully track student progress as we review scores from multiple assessments, including i-Ready assessments in language arts and mathematics. Diagnostic assessments are administered three times per year and students work consistently on their "My Path" learning plan each week to promote their personal growth.



Student Health and Wellness:

Student health and wellness are supported at Coolidge School in many ways. Our school counselor meets regularly with students individually and in small groups on a variety of topics to support their social and emotional health. Self-regulation strategies are emphasized as students work on self-control and implement techniques such as the Zones of Regulation. Movement is consistently incorporated into instruction and students are provided with flexible seating opportunities to be successful as learners. Daily recess is supervised closely by aides, teachers, the school counselor, and the principal. In addition to providing much-needed fresh air and physical movement, recess is viewed as a period of the day where students learn and practice important social/emotional skills as well as sportsmanship, teamwork, fair play, and cooperation.

Parent and Community Involvement:

Outstanding parental involvement in our PTO allows us to present many programs and events in our school. We use the money raised by the PTO for enrichment assemblies, field trips, science days, technology, media equipment, and campus beautification. Coolidge School is proud of the partnership we have developed with our parent community. Working collaboratively with our Parent Teacher Organization, numerous enrichment, social, and cultural activities are planned for our students. Our Parent Teacher Organization greatly supports our teaching staff through the implementation of our teacher scholarship program, encouraging innovative ideas by our teachers. Students are allowed to participate in exciting assembly programs, author visits, art docent programs, and special events such as Field Day, Theme Day, and science fairs.



Facilities:

Coolidge School opened in 1932 and has seen numerous additions over the years. Classroom spaces are designed with students in mind to enhance the learning environment. Most classroom instructional spaces are equipped with a Promethean Board to make learning engaging for the students. All instructional spaces in the school are air-conditioned. A multi-purpose room provides adequate space for daily lunch as well as large group activities. Our gymnasium provides a dedicated space for physical education classes and the performing arts. Coolidge School encompasses several outdoor learning spaces including our two courtyards and an outdoor classroom setting. A recently renovated nurse's office and art room provide upgrades to our physical spaces for students and staff.



School Safety:

Student safety is a priority at Coolidge School. Staff meets regularly to discuss our Crisis Plan and best practices to ensure a safe school environment. Security, medical, and table-top drills are regularly conducted in conjunction with local law enforcement officials and our security advisor. All visitors are required to sign in via the main office utilizing our Lobby Guard Visitor Management System where they need to provide proper identification. Under the direction of our school nurse, a Medical Emergency Team is formed and takes part in drills throughout the year to be prepared to properly respond to a medical emergency. Furthermore, as a staff, we make it a priority to foster a safe and inviting school community where all students are accepted and welcomed, for this helps reduce and eliminate bullying and unkind behaviors between students. Additionally, a Special Law Enforcement Officer (SLEO) is assigned to Coolidge School and is on campus at all times.
