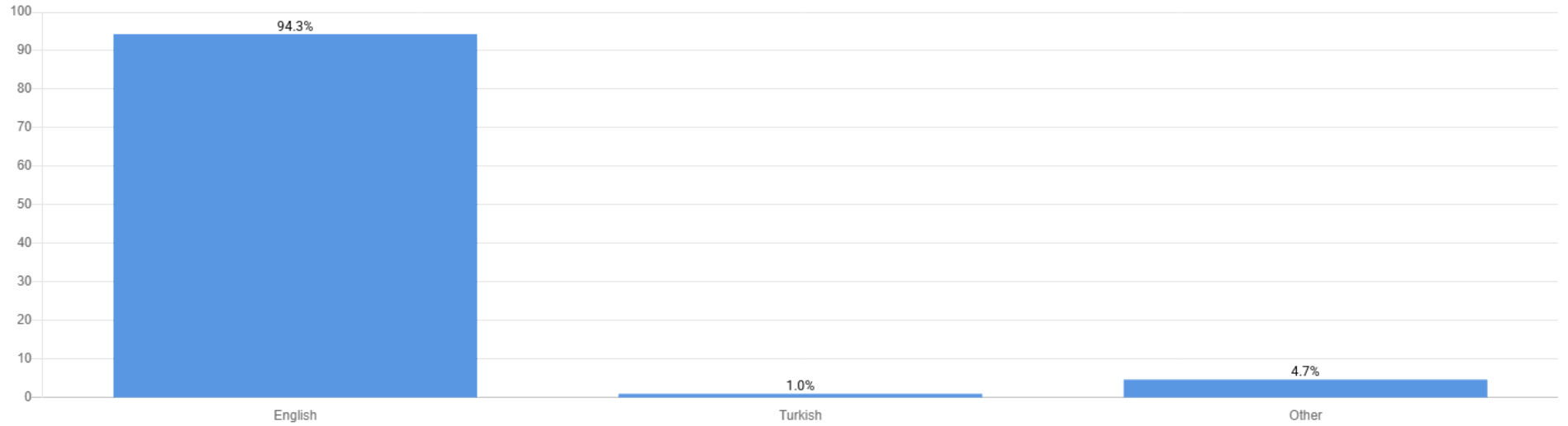

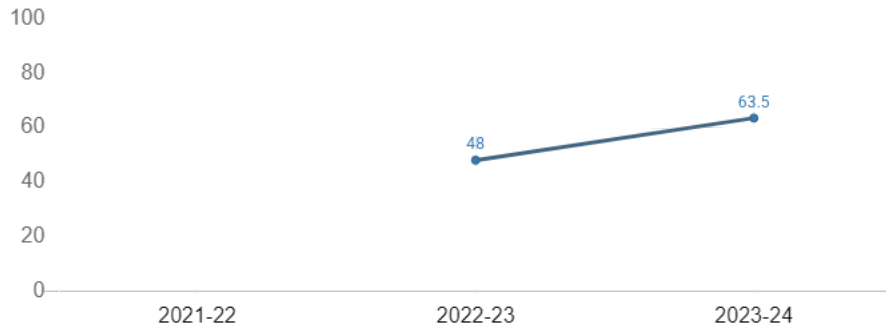

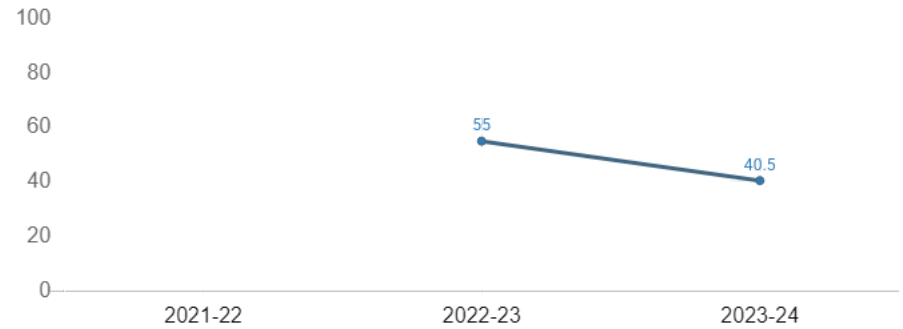

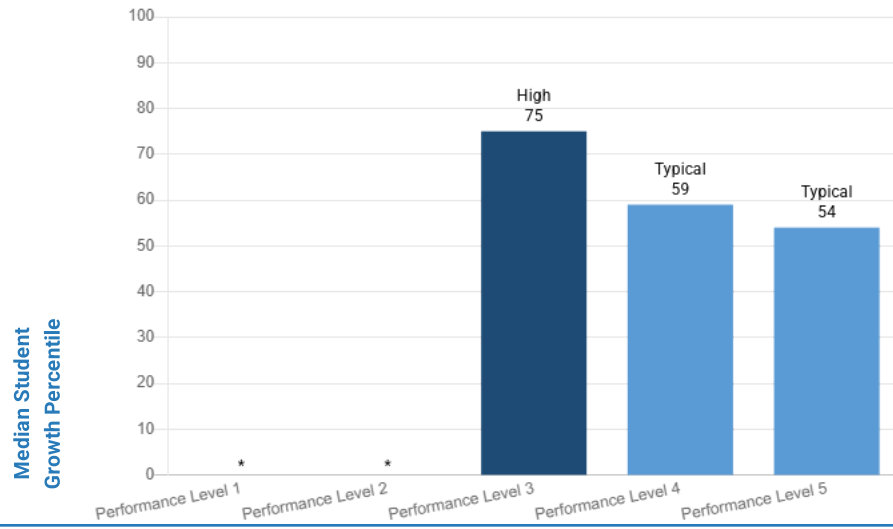

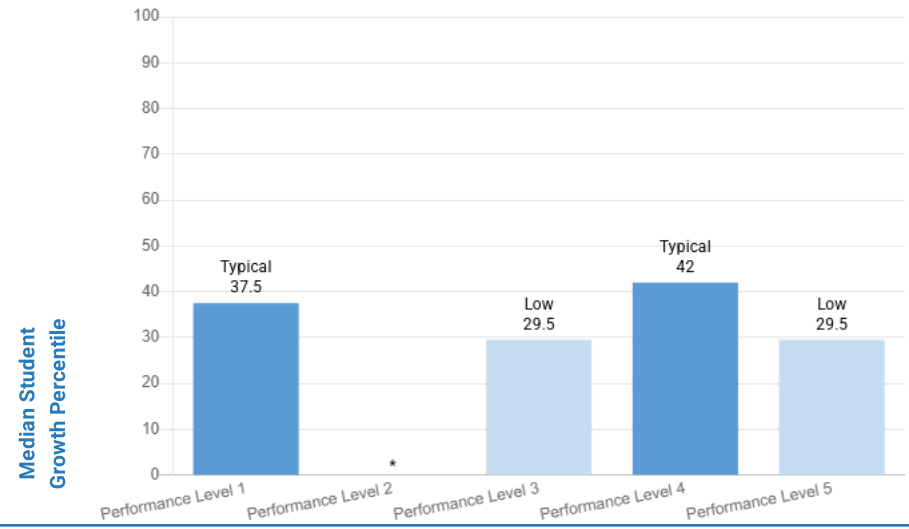

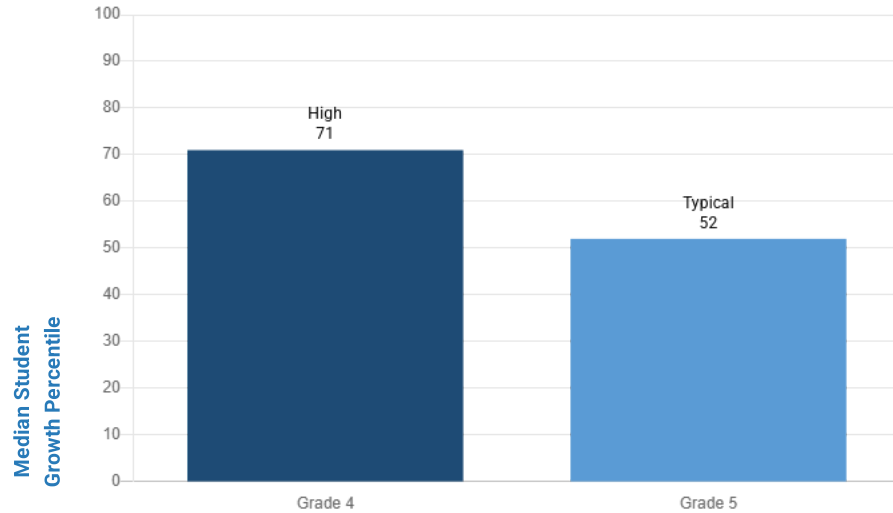

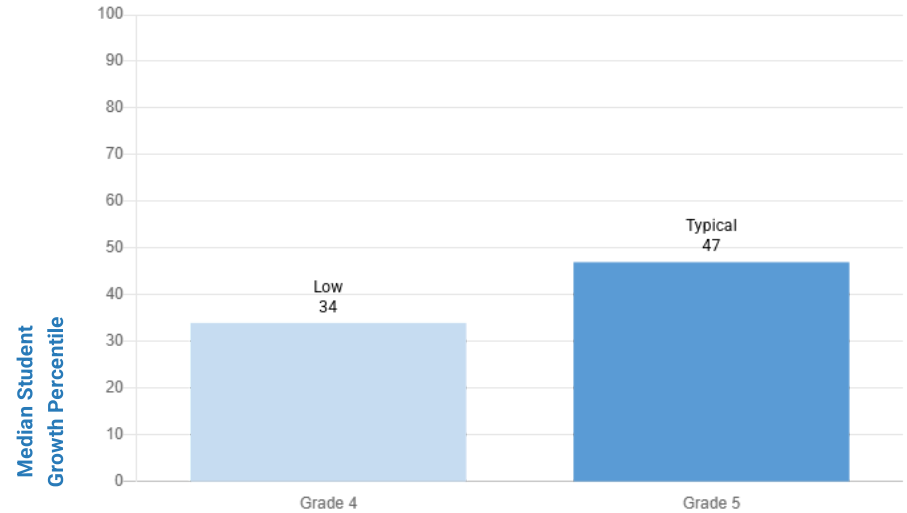

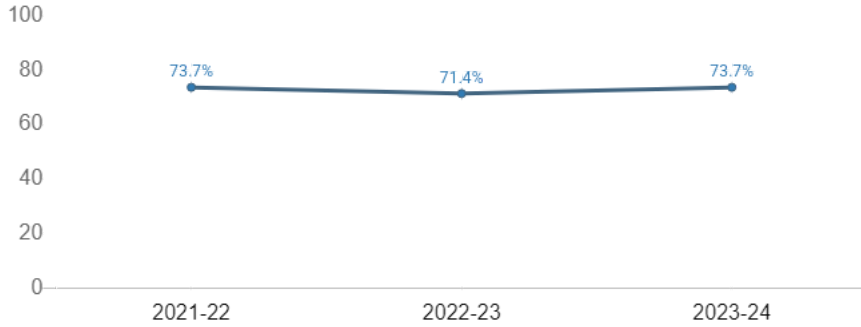

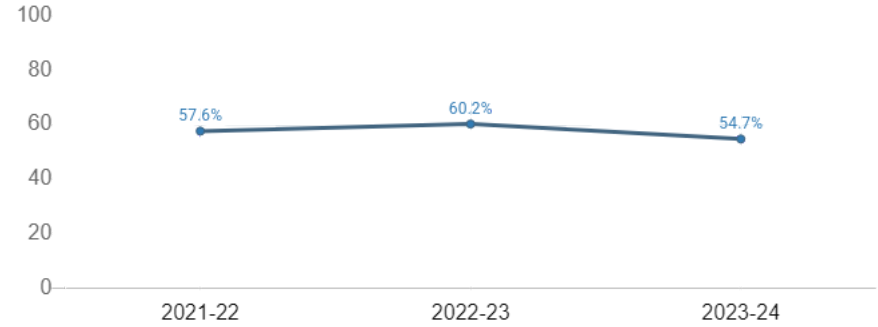
### English Language Arts and Mathematics Performance Trends

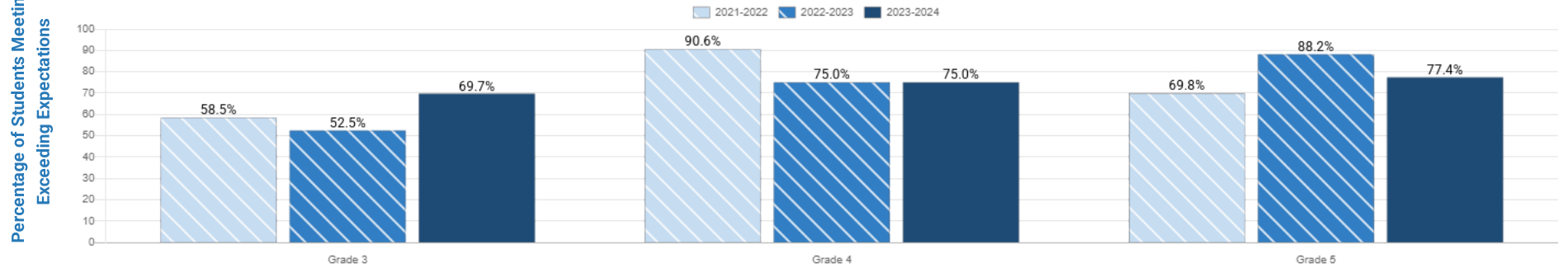

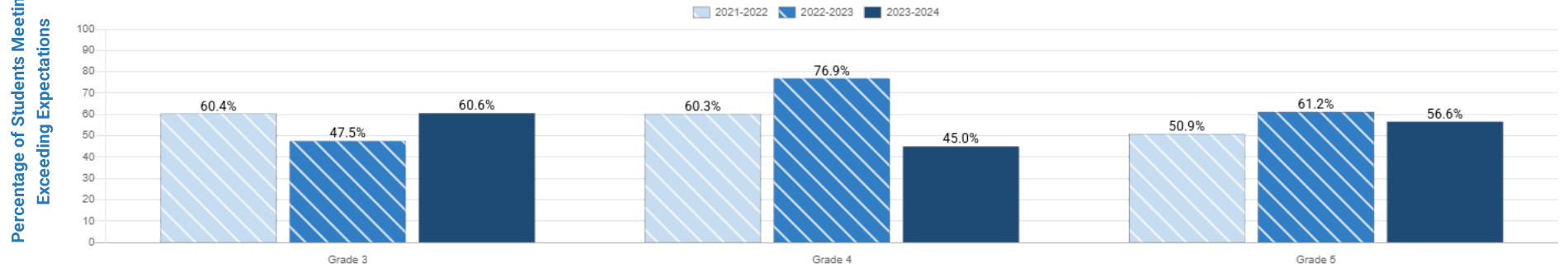

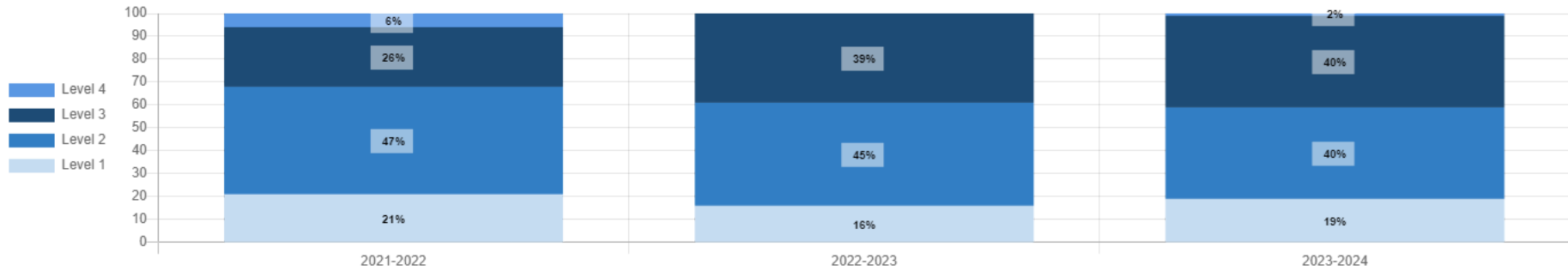

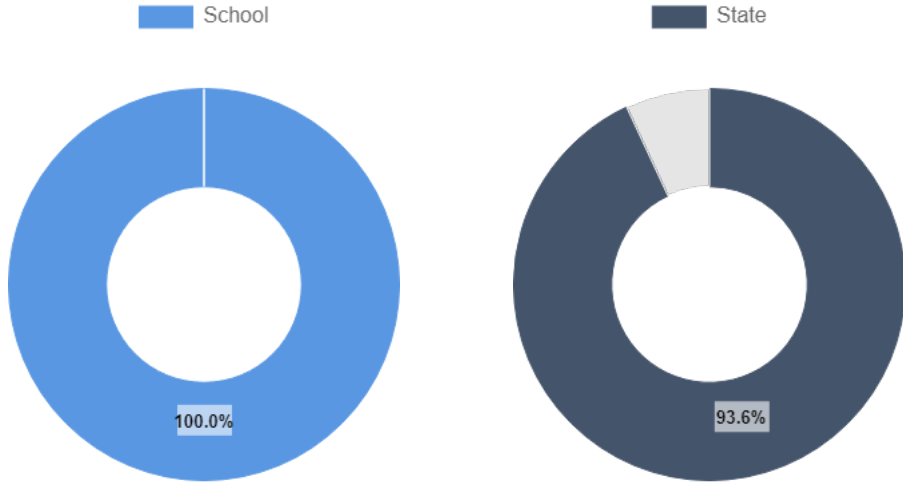

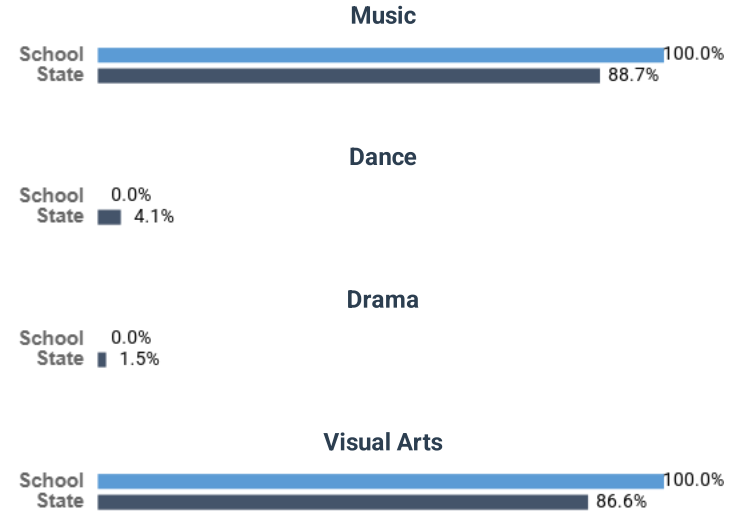

**Students enrolled in one or more classes by discipline:**



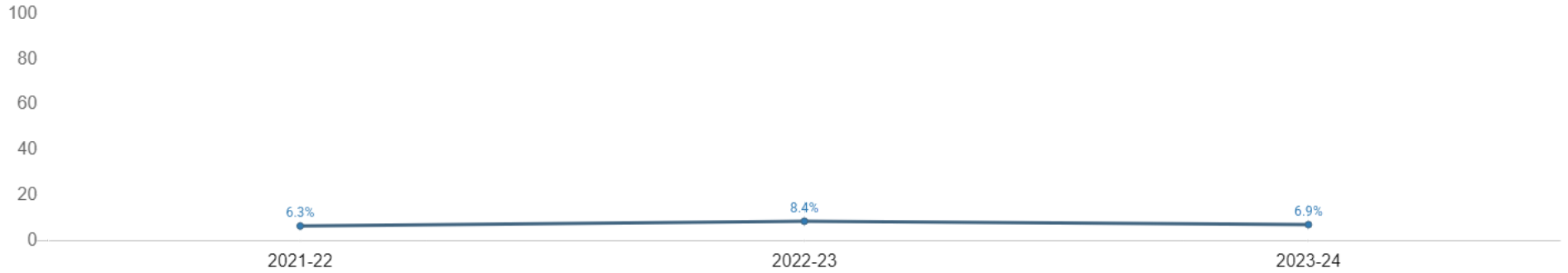

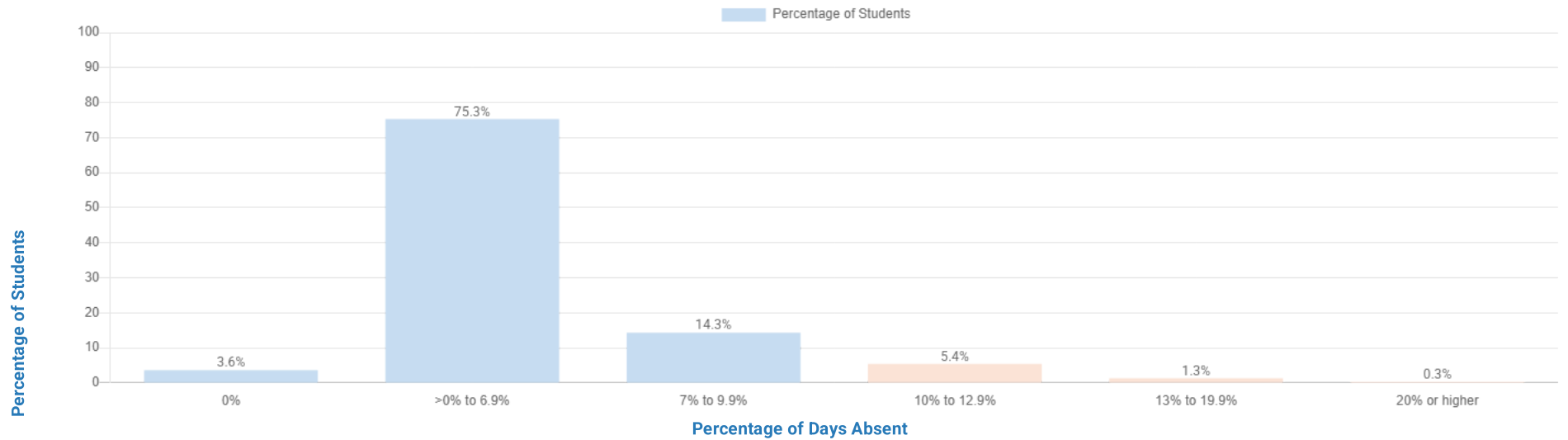

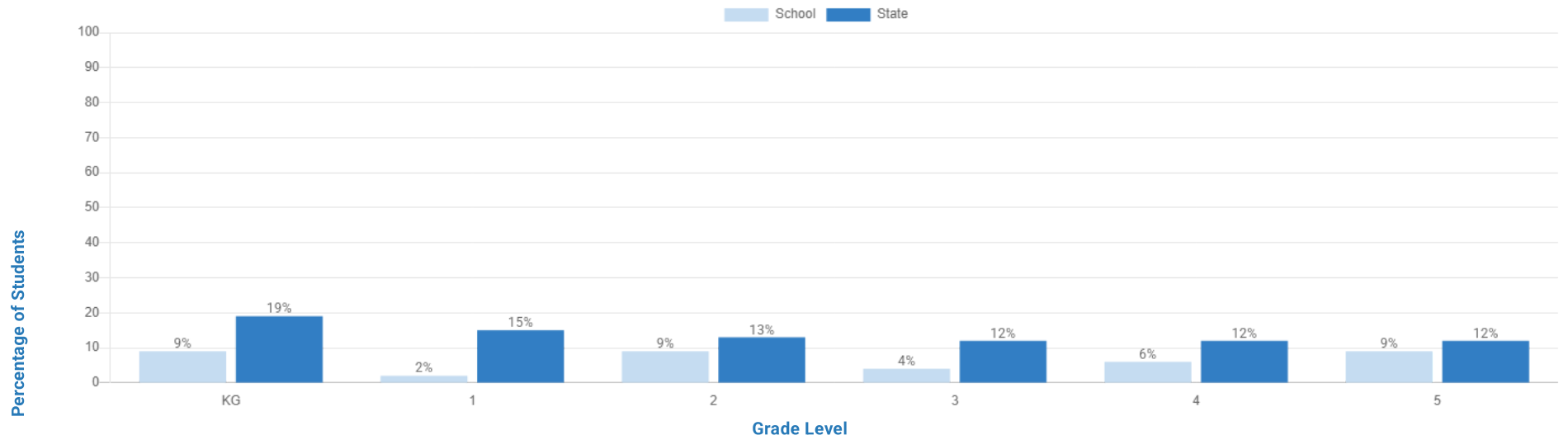

## Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

**Key terms for staff data:**

**Teachers:** All classroom teachers

**Administrators:** Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

**Experience:** Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

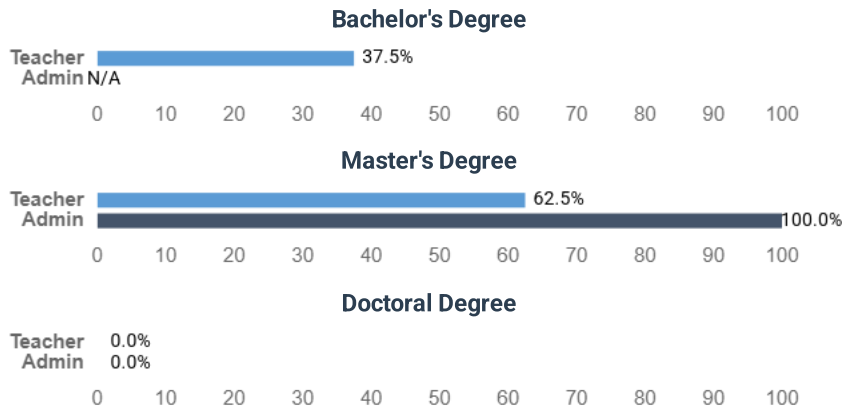

We want our children to be responsible citizens as well as high-achieving students. Developing positive self-esteem and a sense of security about the school environment allows for greater inquiry, risk-taking, and creative expression. We believe in meeting the needs of the whole child, be they physical, mental, social, or emotional.

George Washington School relies upon a partnership of parents and educators committed to a common cause: the education of its children. A very active Parent/Teacher Organization provides funding to the school for special cultural and enrichment programs and a variety of other instructional needs. ### School Safety:

George Washington School has a dedicated school safety team comprised of the Principal, School Counselor, SLEO Class III Officer, teaching staff members, and a parent liaison. The team meets several times yearly to discuss and analyze school safety issues, including students' physical and emotional safety and security. A school crisis team meets regularly to plan responses to potential crises and performs tabletop exercises to brainstorm how to respond to potential issues of school safety and security. George Washington School uses a visitor management system and a single entry system to enhance security and manage access to the building.
