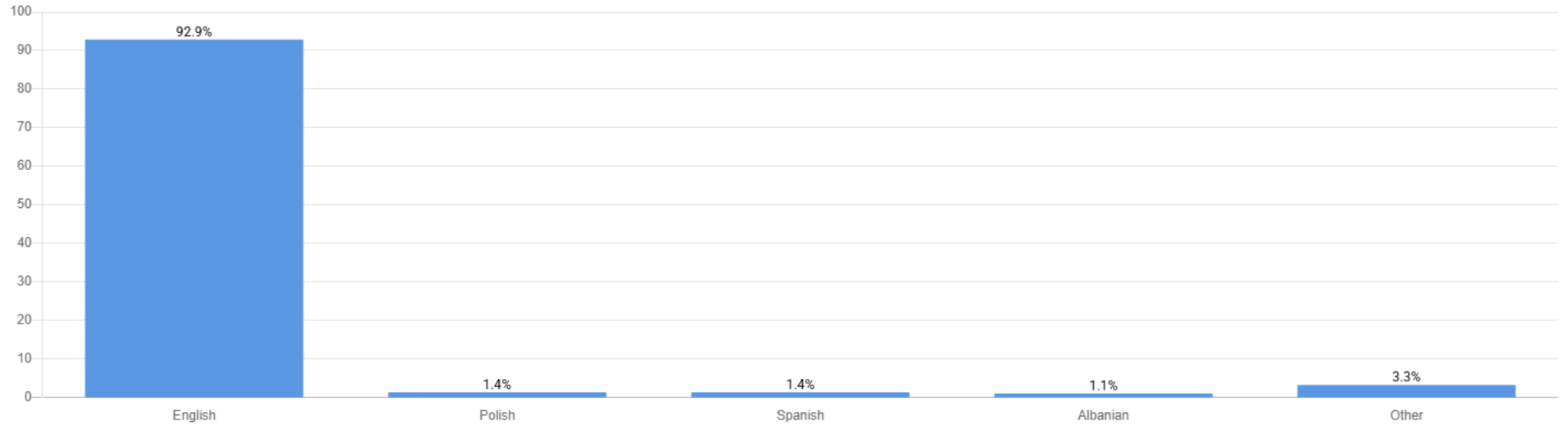

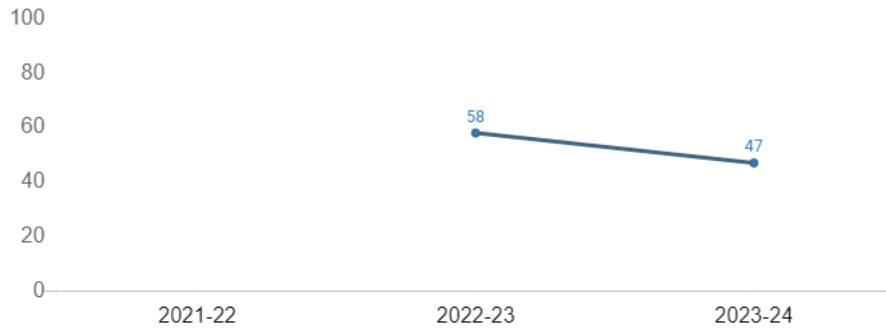

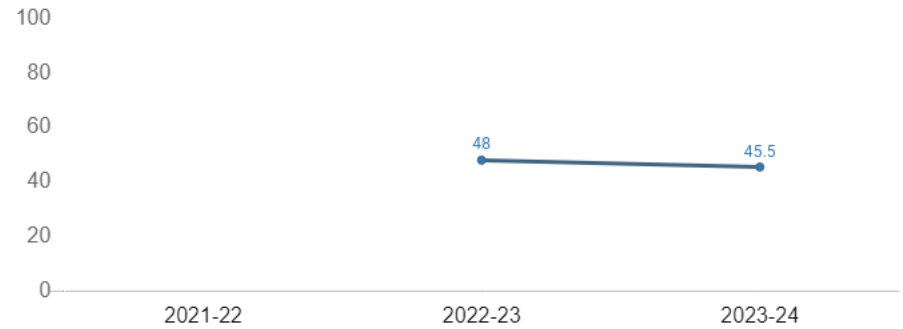

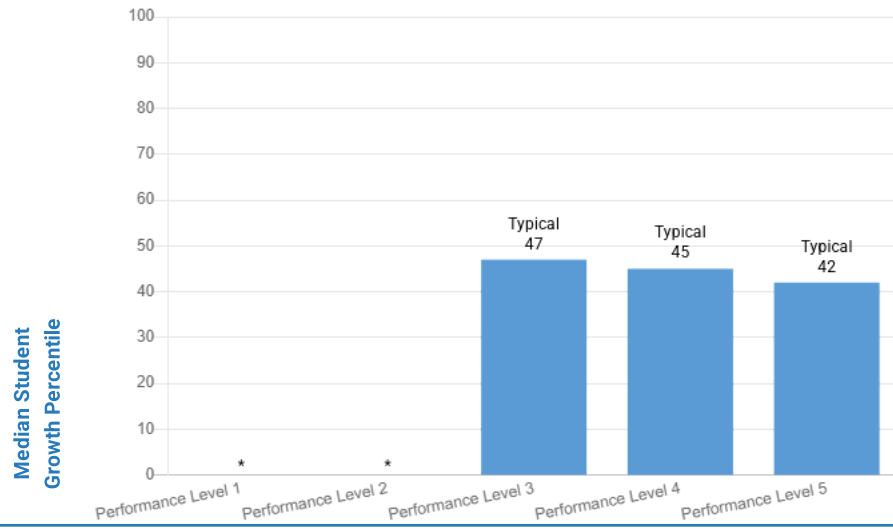

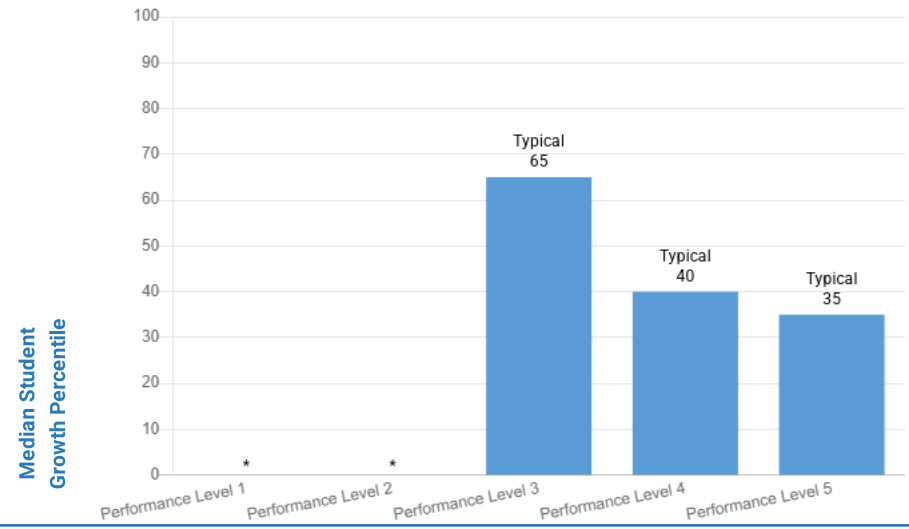

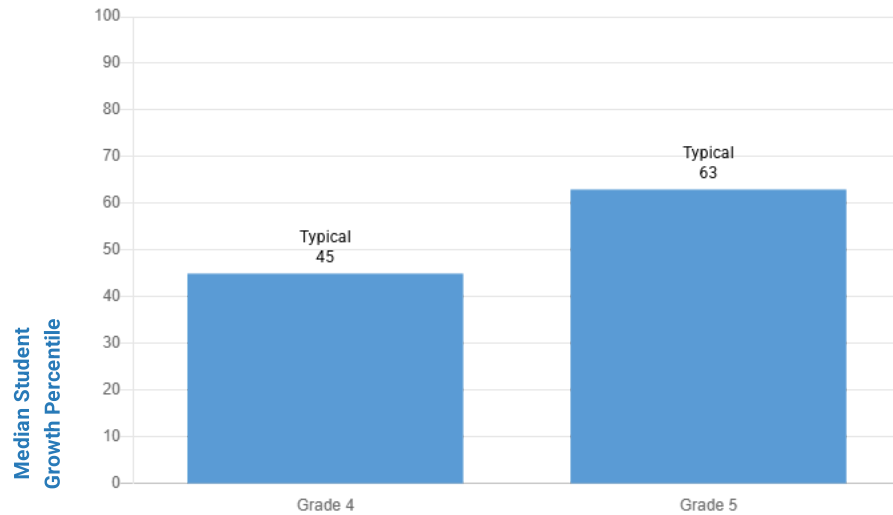

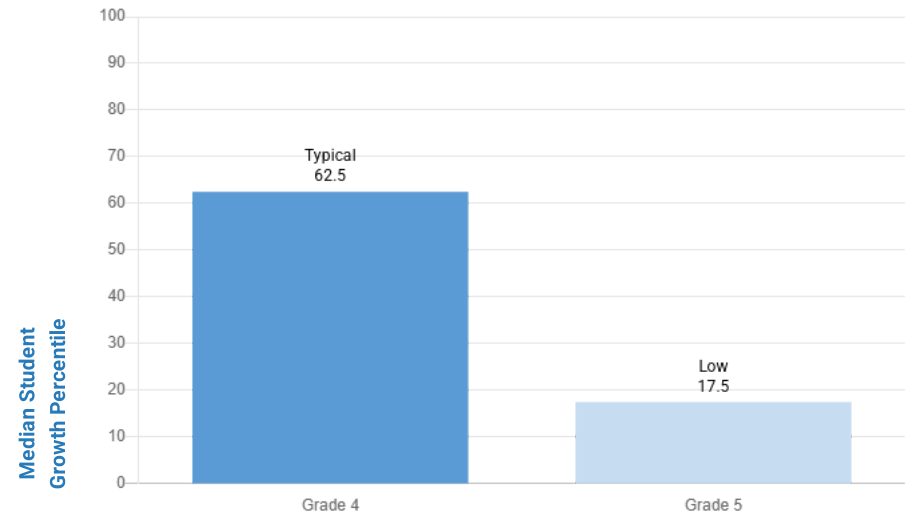

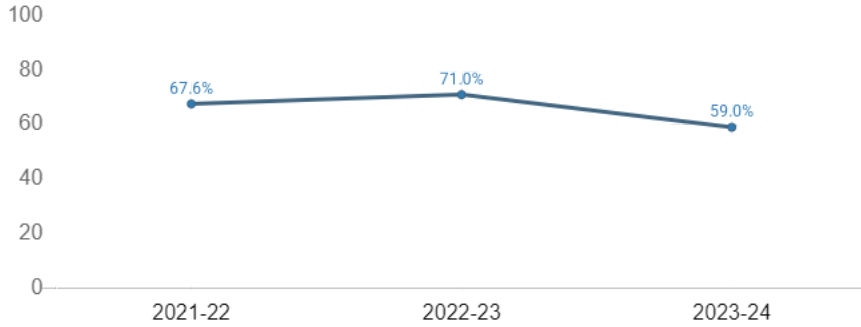

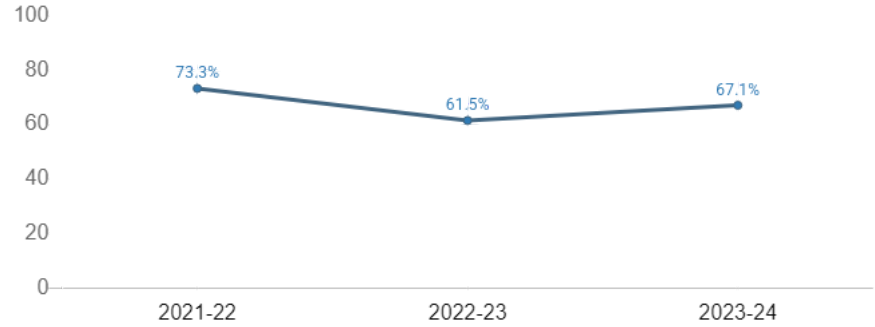
English Language Arts and Mathematics Performance Trends

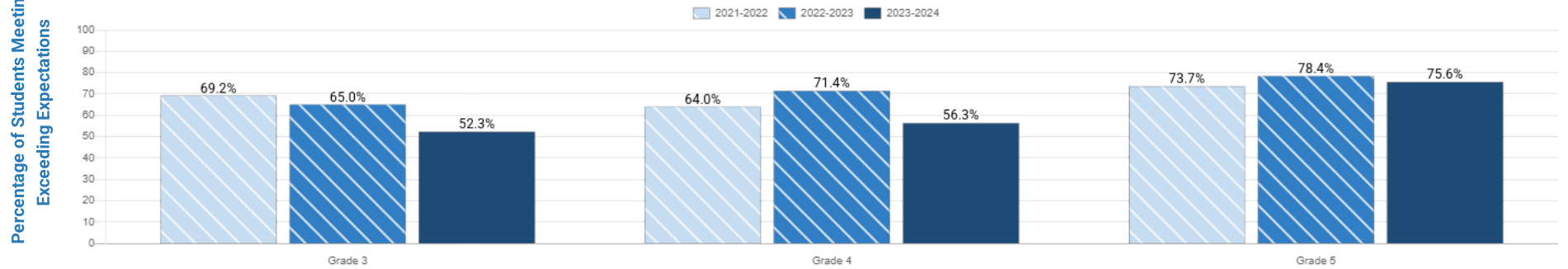

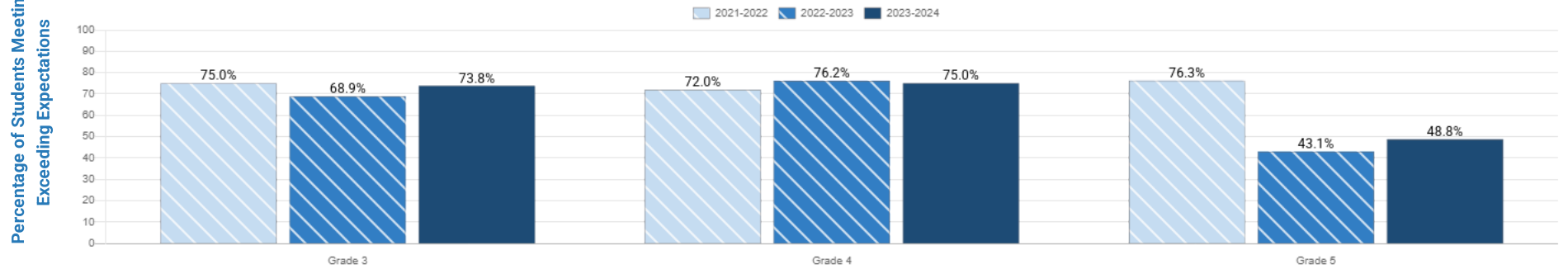

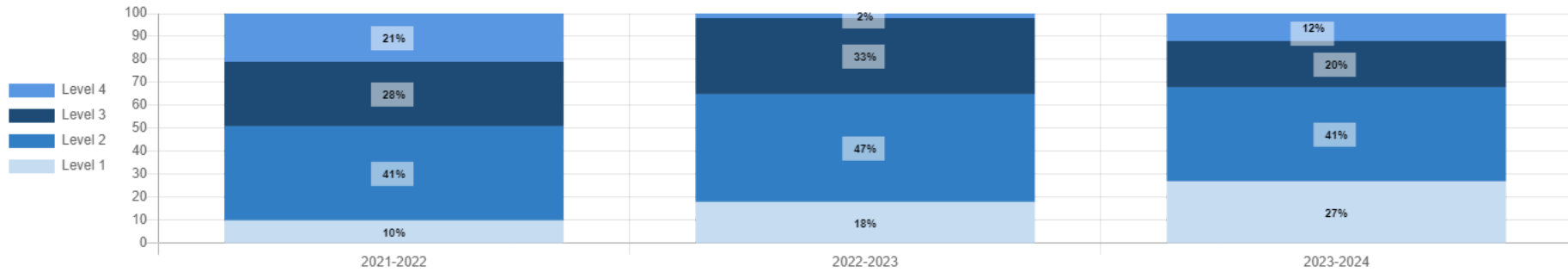

Students enrolled in one or more classes by discipline:



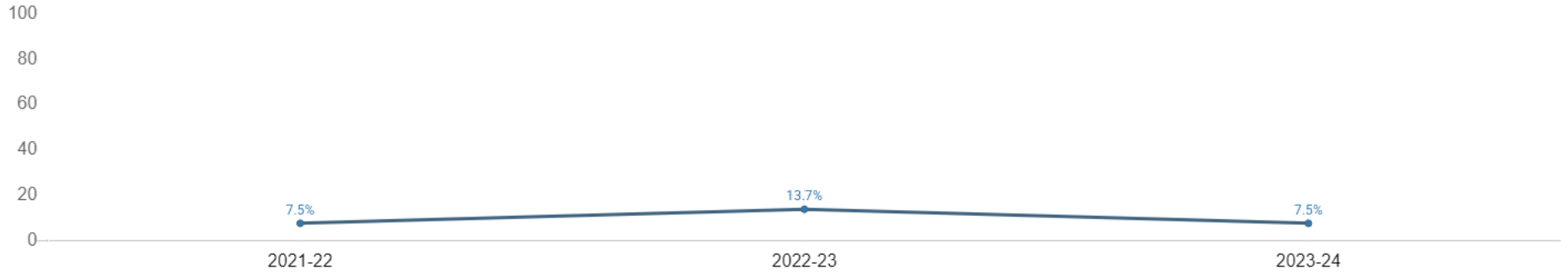

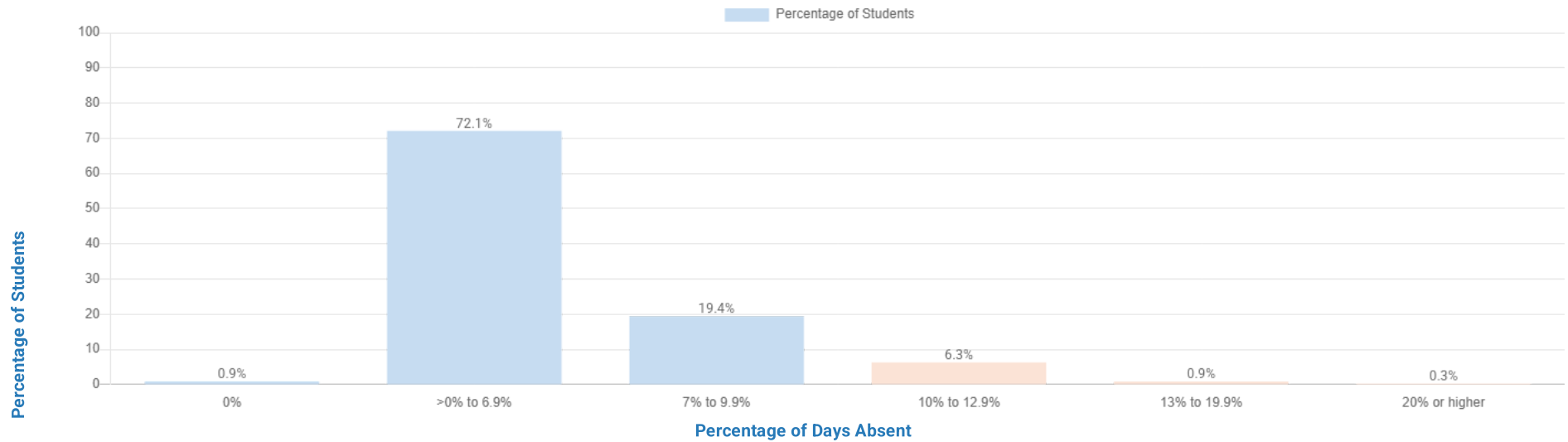

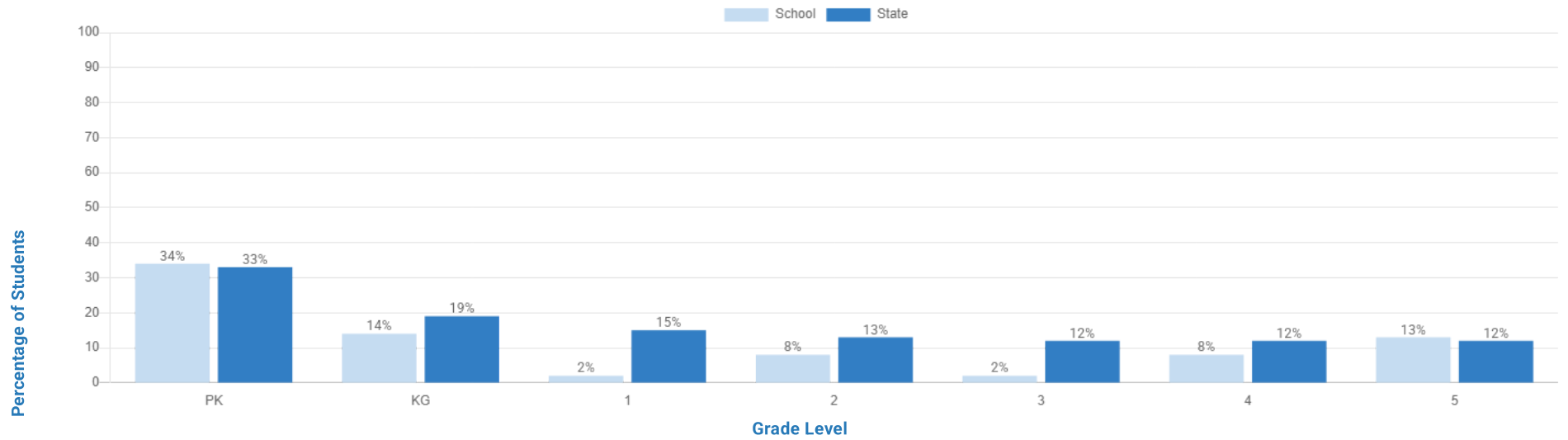

For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

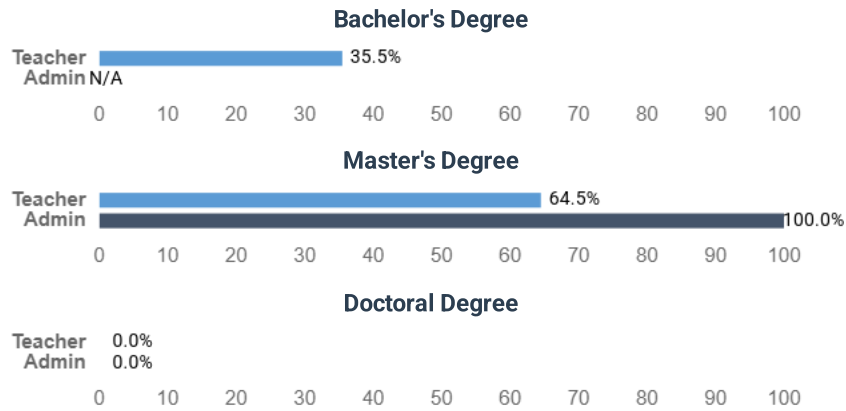

Student Health and Wellness:

A registered nurse on site meets the health needs of our school population. We also employ a full-time school counselor to support the social-emotional and wellness needs of our students. Sicomac School's physical education teacher, guidance counselor, and nurse provide lessons in social skills and health. During normal operation of the school, healthy lunch options are available for purchase from outside vendors contracted by the PTO for students in grades 1-5. Sicomac School hosts a Kindergarten Health and Wellness Fair most years, and students have opportunities for planting and harvesting vegetables in our Outdoor Classroom. Outdoor learning is embraced at Sicomac School and teachers are encouraged to bring learning outdoors whenever possible.



Parent and Community Involvement:

Our active and vital PTO meets monthly (virtual and in-person meetings) and is both supportive of and committed to enriching our school. The PTO runs various fundraising activities and manages both special and ongoing events such as our Newcomers Social, Harvest Festival, Theme Day, Military Bridge, PTO Dinner, Walk or Bike to School Days, and enrichment assemblies. A Special Education Parent Advisory Group is open to the school community. The Wyckoff Education Foundation (WEF), supports district-level learning initiatives to enrich all Wyckoff schools.



Facilities:

Our school is housed in the newest elementary school building in the Wyckoff School District and we celebrated our 50th Anniversary in 2017. Sicomac features air conditioned classrooms, a full size and newly-refurbished library, gymnasium, newer multi-purpose room with a PTO-purchased 4K TV and sound system, an ample stage in the gymnasium, recently refurbished front office, professionally designed Outdoor Classroom courtyard, spacious soccer and baseball fields, a newer K-5 playground, newer Pre-K playground, and recently upgraded security systems.

School Safety:

Sicomac School follows all State and district protocols for best practices in student safety. Contemporary security systems including visitor entry screening are in place. Sicomac, like all Wyckoff Schools, enjoys the support of a full time Special Law Enforcement Officer on-site during each school day to enhance safety in our school.



Technology and STEM:

Makerspace activities are incorporated into our technology lessons by our in-house technology teacher for students to explore STEM-related learning activities, which may include robotics, and open-ended Maker projects during the school day for students in grades K-5. Students in grades K-5 receive direct technology instruction in the computer lab from our technology teacher on Mac desktops. Students in grades 2-5 have access to 1:1 Chromebooks in their classrooms. Dedicated iPad carts exist for use in our primary grades. With generous PTO and district support, classrooms are fitted with interactive Promethean panels to facilitate engaging instruction and interactive learning.



Early Childhood Education:

Early childhood learning environments receive great attention at Sicomac School. Our teachers' lessons are responsive to the developmental needs of their students; teachers plan activities and creative experiences, for example, that include the regular use of play and open-ended learning activities. Block play, in fact, is an essential component of our work in grades PreK - K. Kindergarten classroom environments include Reggio Emilia-inspired provocations and documentation to both engage and nurture student creativity, curiosity, and exploration; Reggio-inspired practices inform our work in grades 1 and 2. The district's Preschool programs for students aged 3-5 are housed at Sicomac School. Program options include typically developing children (tuition basis) and children with developmental delays.
