
















### English Language Arts and Mathematics Performance Trends













**Students enrolled in one or more classes by discipline:**













## Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. ## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.









## Accountability

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
  - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
  - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Multiple afterschool academic programs are offered. Students can stay afterschool for academic help/growth in ELA, Math, Science, and overall academic focus. We initiated a before and after school program for credit recovery to remediate some of our learning loss and education gaps that presented themselves due to COVID restrictions.



### Staff and Professional Learning:

Professional learning opportunities are provided for the entire school district through in-services, Professional Learning Communities (PLC) in Math, Best Practices, Science, Literacy, Technology, Equity, and Data as well as in faculty meetings. Teachers collaborate on topics regarding data, attendance, instructional strategies, classroom management, resources, and differentiation. Administrators meet for Superintendent's Council, Administrative Council, and through school improvement committees.



### Postsecondary Information:

The Naviance program is used as a tool for compiling and submitting college applications, transcripts and resumes. Two Financial Aid workshops are presented each year. We also administer the PSAT, SAT and ASVAB Tests to our students. Burlington City High School students attend post-secondary institutions. Our graduates attend colleges in New Jersey, as well as across the country. We also have students who go into the workforce as well as those who serve our country in a branch of the military. Many students receive scholarships, financial aid, as well as sign with universities to play sports.

Student support services: ESL program; Life Skills Program; Behavior Intervention Program; Mentoring Program; Attendance Improvement Program and Mandatory ProAction for Athletes, NHS Tutoring Programs, as well as after school academic support clubs and activities are available. Credit recovery classes are offered as well.



### Student Health and Wellness:

BCHS programs and activities are offered to promote the health and wellness of students. Food Services Management, physical education department activities, mental health activities and counseling with a partnership with NJ4S, and incorporated programs, sports team activities, and the JROTC program which promotes basic training and battalion group activities are available for all students. Breakfast and lunch programs meet nutritional guidelines and also include a before school breakfast program.

BCHS continues to develop a number of key community partnerships to inform and engage the public. The City Pride Partnership district initiative involves the business community, local government officials and staff to foster programs and mentorship for students and schools. Highlights of our high school are the State of the Art Media Center and our beautiful Blue Devil Focused Support Academies which service our students.



### School Safety:

BCHS places safety and security at the forefront of our mission. This is demonstrated by the hiring of a student resource officer, a team of security guards, and two vice principals that assist in developing the building culture for a safe environment. BCHS conducts tabletop drills, locker sweeps, lockdown and evacuation drills. Procedures are in place to facilitate lockdowns and visitor management. The district utilizes advanced camera technology for early weapons detection as well as automatic electronic door locks throughout the building for immediate responses. Communication systems have been upgraded and connect with local police for rapid response. Secure vestibules have been added for visitors with protective glass. Gates with card reader capability provide secure access for deliveries.
