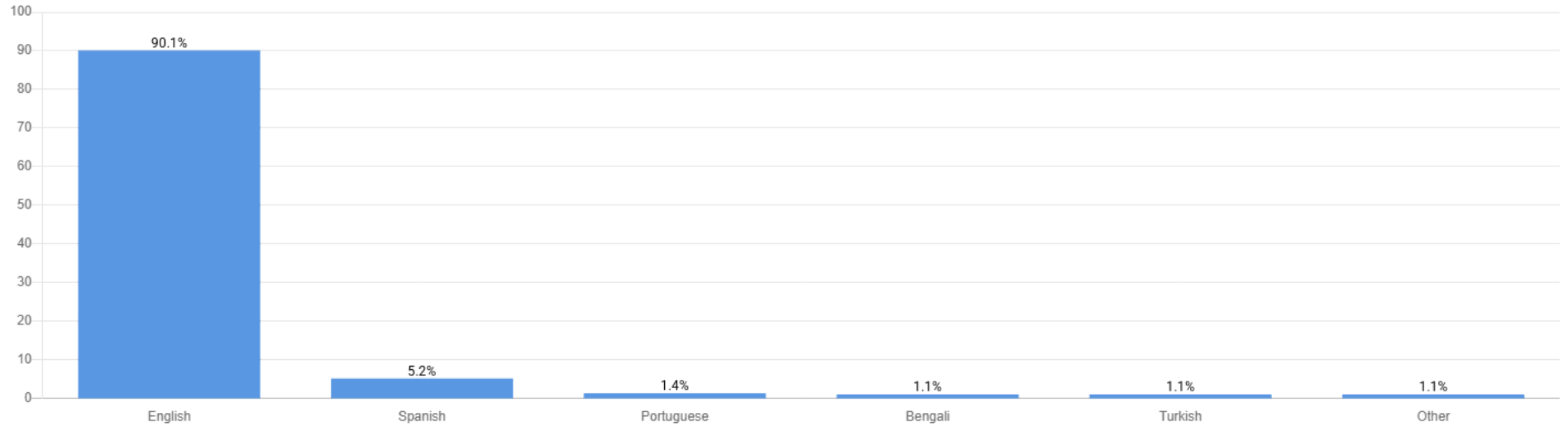

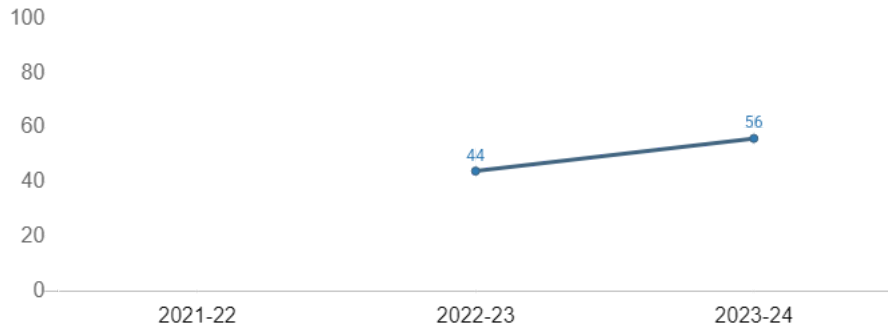

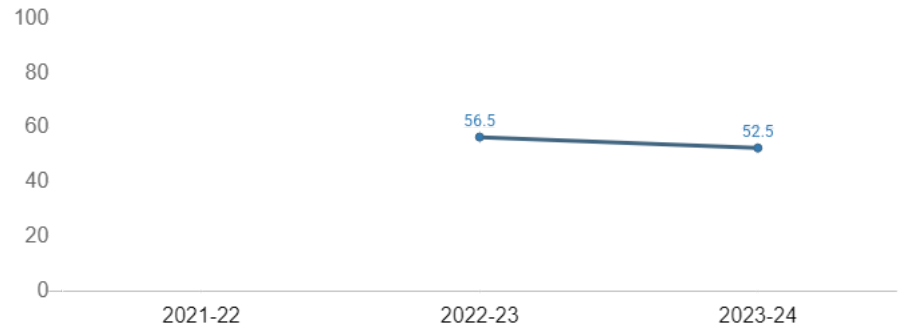

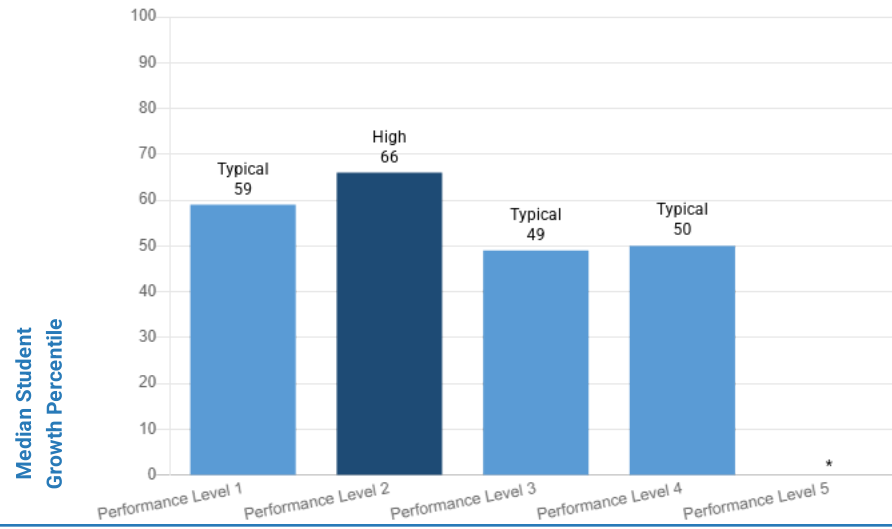

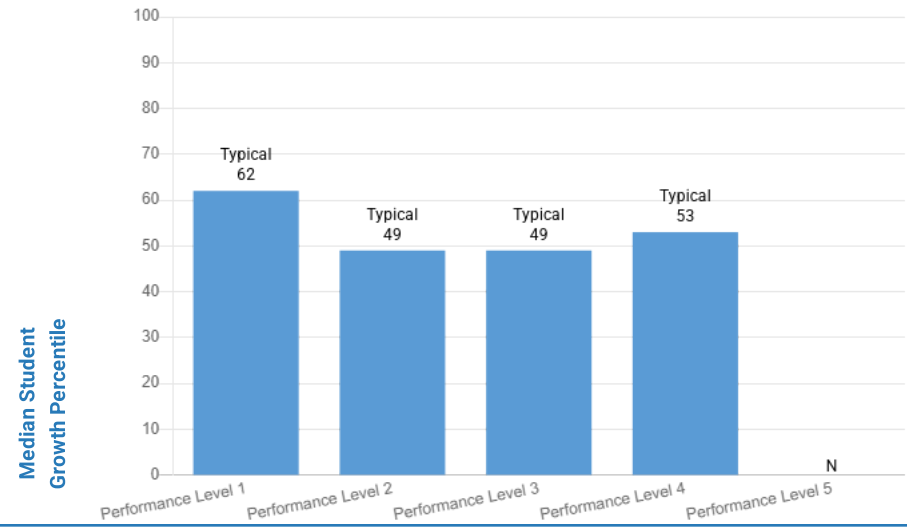

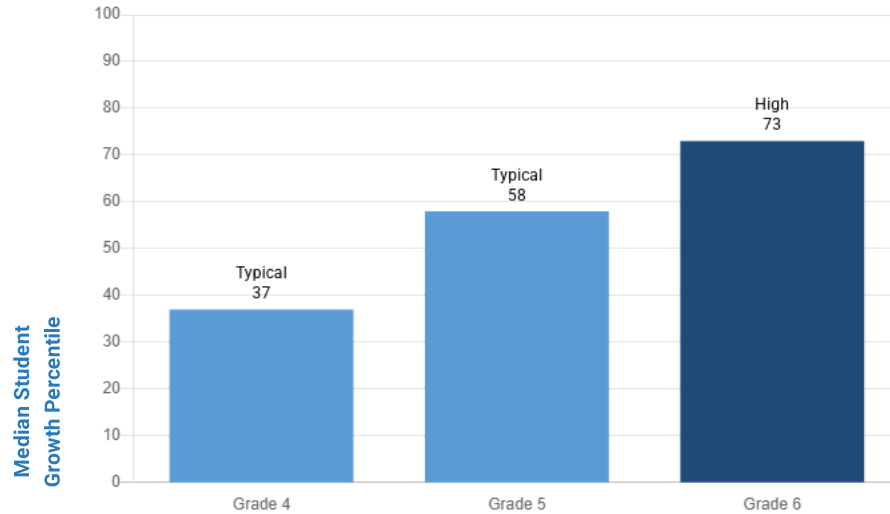

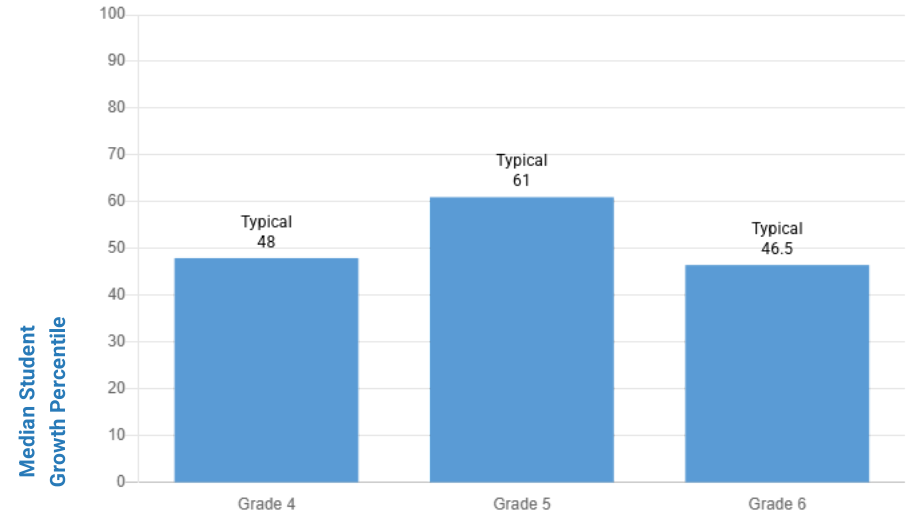

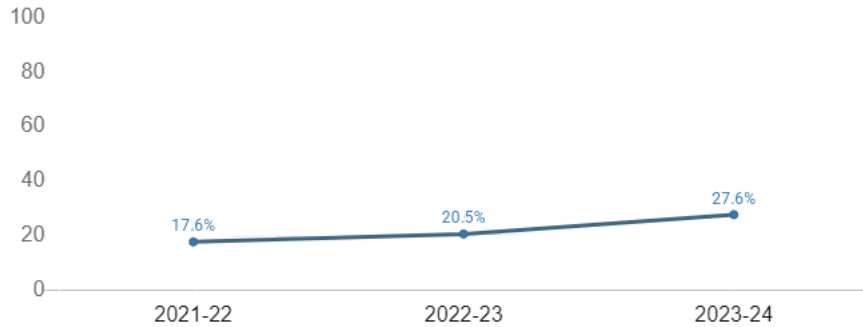

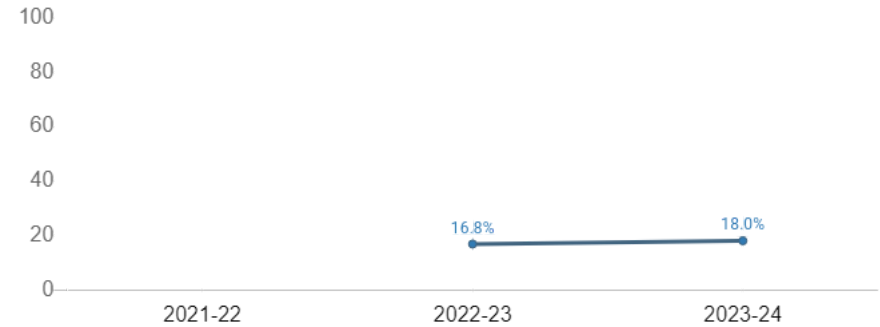
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 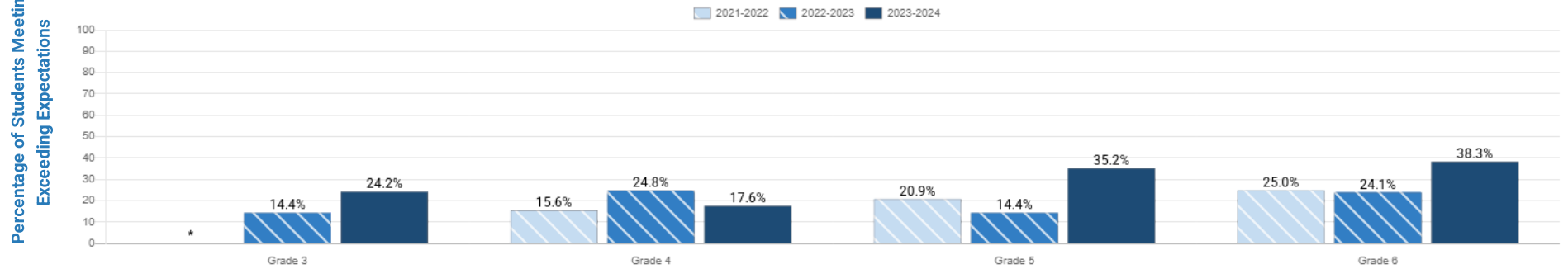

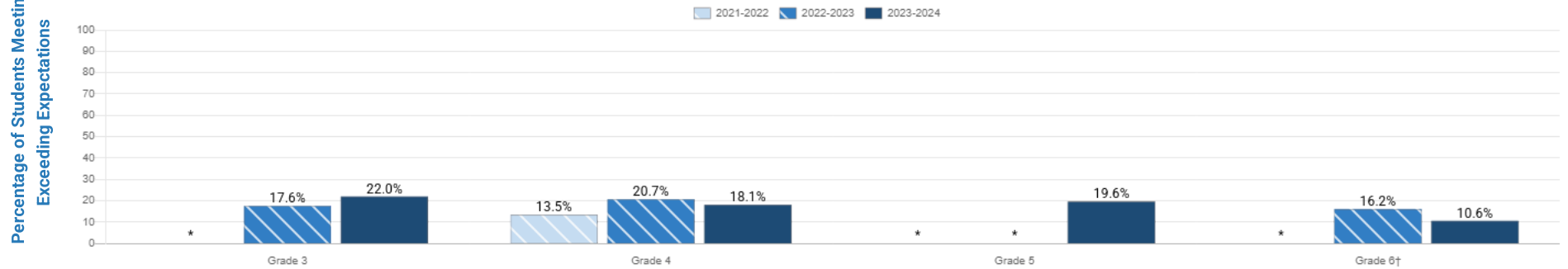

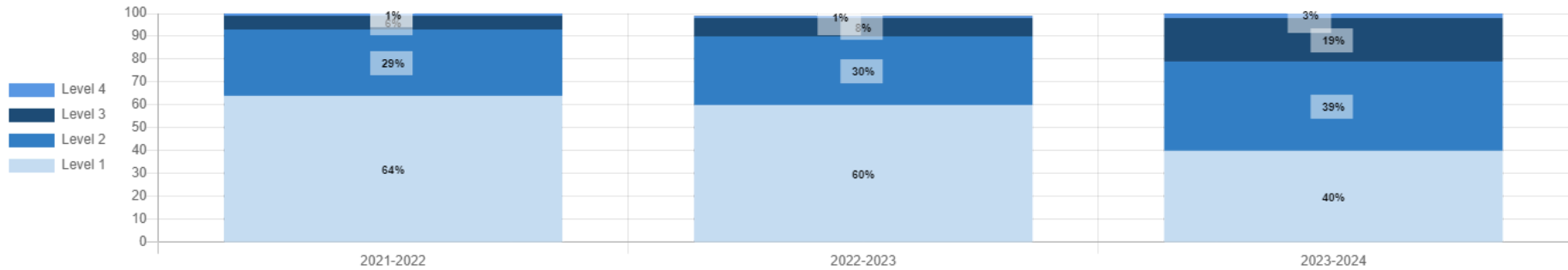

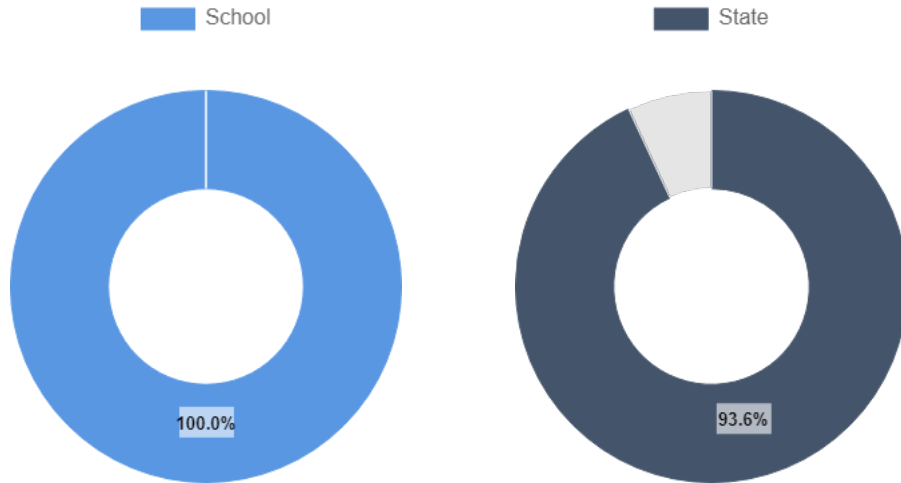

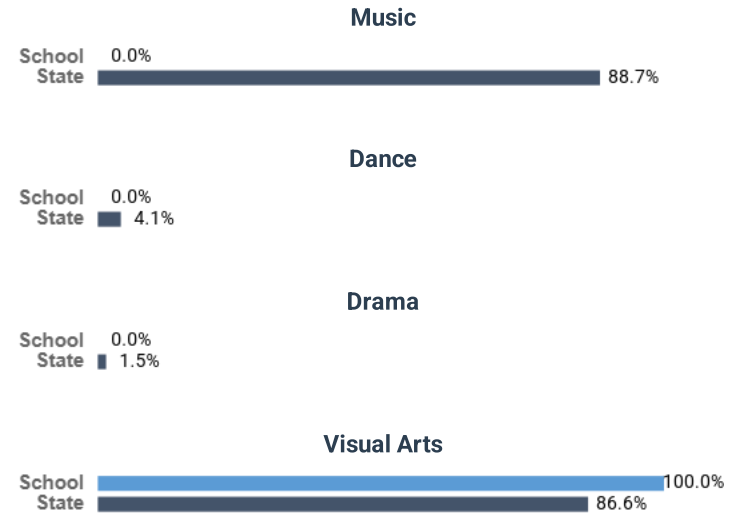

Students enrolled in one or more classes by discipline:



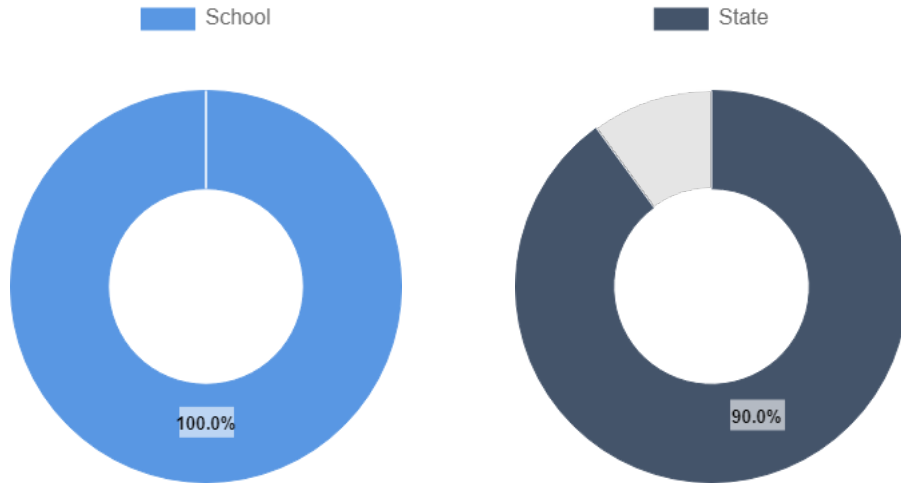

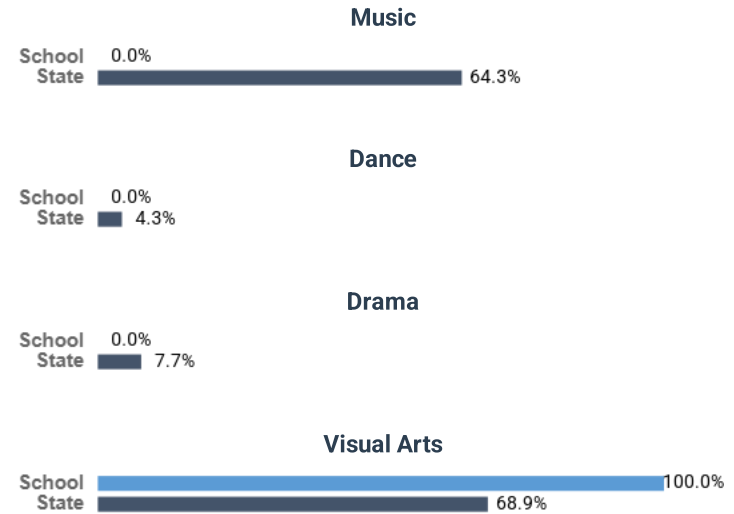

Students enrolled in one or more classes by discipline:



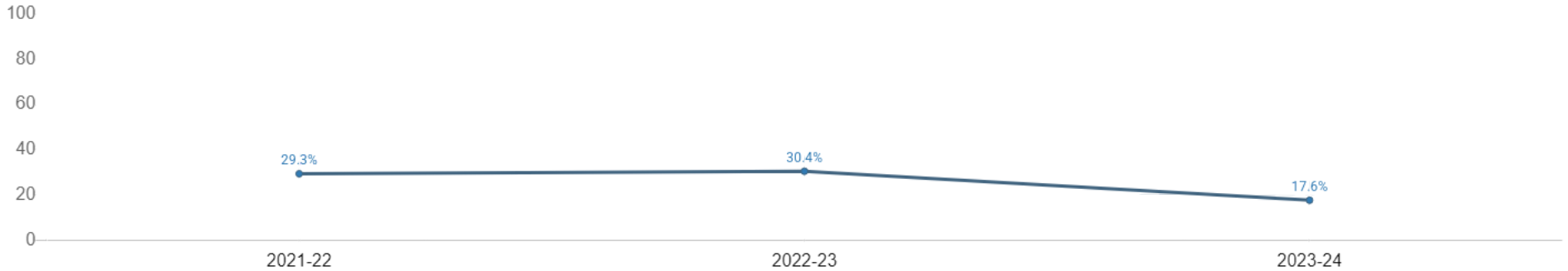

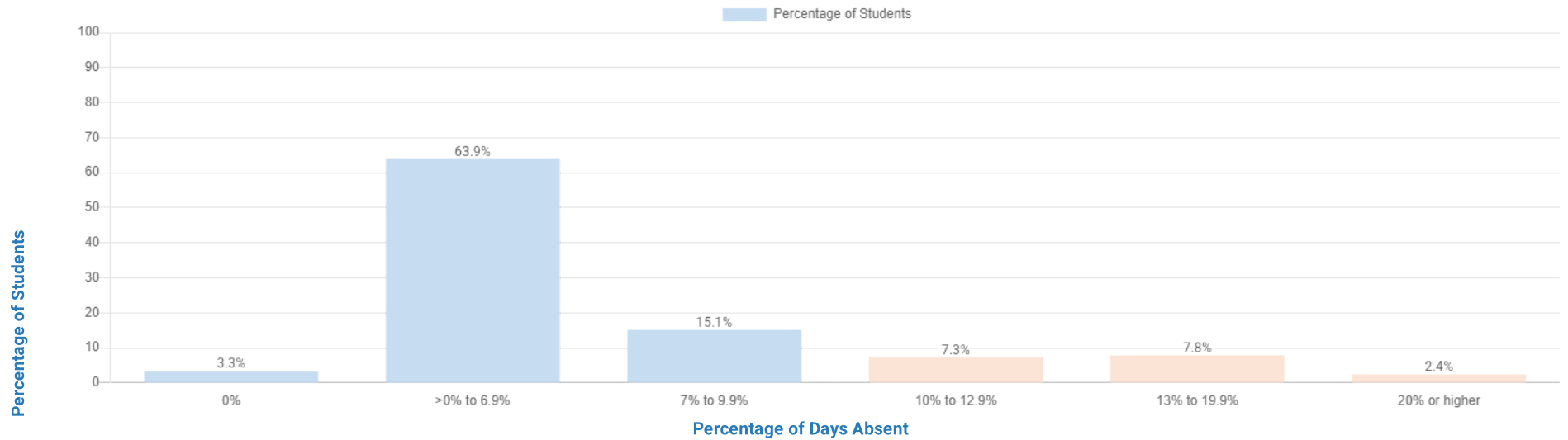

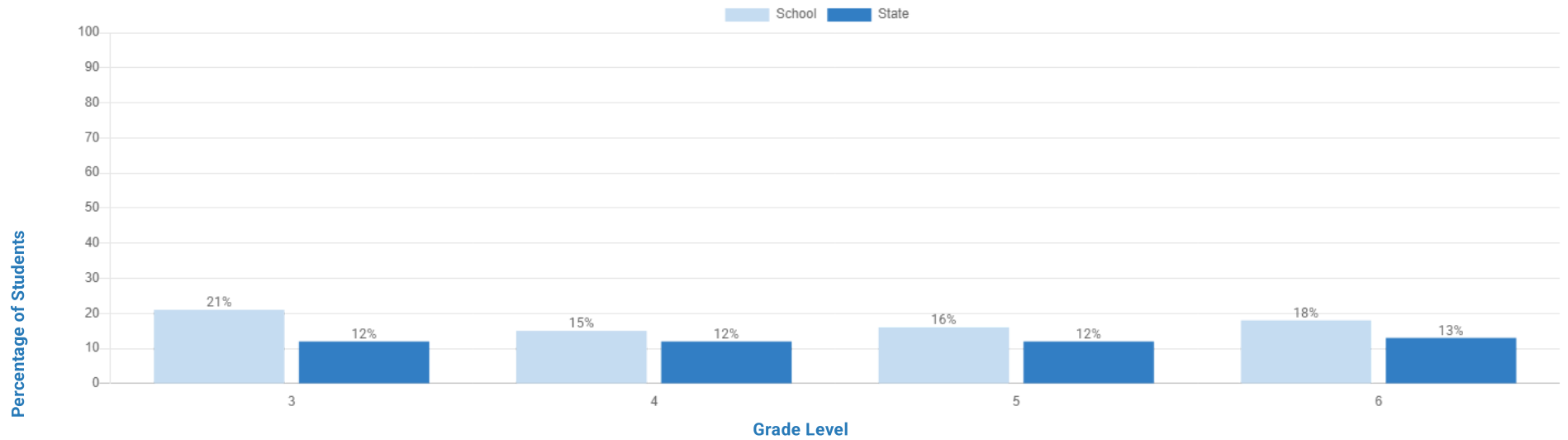

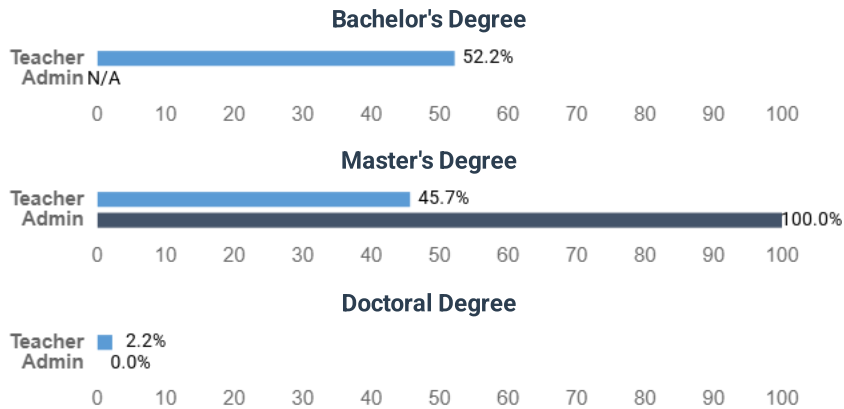

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

The NJDOE identified schools for ATSI status based on data from the 2022-2023 school year, so schools will not be identified for ATSI status based on data from the 2023-2024 school year. The table below will show the summative score for each student group, but it will not show a cut-off score or indicate that a student group has been identified for ATSI status since it is not an identification year.

Schools will be identified for TSI status based on data from the 2023-2024 school year, since that is required annually. The remaining columns in the table show whether each student group met annual targets or standards for all indicators for the 2023-24 school year. If at least one student group did not meet all targets and also did not meet all targets in the 2022-23 school year, then the school will be identified as requiring TSI.

Courses, Curriculum, Instruction:

We offer the HMH Into Reading for grades 3-5 Language Arts, and Into Literature for grade 6. Our anchor mathematics program is the EnVision 2.0 series through Pearson and the Pearson Realize Savvas platform. Success Maker is utilized to help create differentiated learning paths for all students. All the programs, as well as a myriad of supplemental materials, contribute to a rigorous curriculum that build students' reading, writing, higher-order thinking skills, and critical problem solving. We also offer W.I.N. (What I Need), including Read 180 as differentiated reading support and enrichment programs for our various levels of learners. Many of our staff are trained in Wilson Reading and/or Orton-Gillingham methods to help support struggling readers. Our Supervisors of Instruction, Reading Interventionists, ML and G&T teachers work side-by-side with our staff to support student success!



Clubs and Activities:

WWIS provides a program conducive to good physical and mental health with activities such as the Positive Behavior Supports In Schools (PBSIS) program, Intramural sports, Instrumental music, Choir, Peer-Mentoring groups, The Wellness Center, and PTO sponsored events, like the Scholastic Book Fair, and Coffee with the Counselors. Students are also involved in various community service projects through Student Council. There was even a community partnership with our Summer Reading program that included a trip to Barnes & Nobel, free books for the students, and a special luncheon to celebrate their Summer Reading success!



Before and After School Programs:

We offer a variety of before and after school programs such as "The Breakfast Club", "Level-up", "Steps to Success" targeted instruction, "Battle of the Books", "The B.R.I.D.G.E." program, Student Council, Band, Choir, and Intramural sports. The staff at WWIS understands the importance of modeling lifelong learning, as many pursue graduate and doctoral level degrees. In addition, we take part in job embedded professional development, such as grade level PLCs (professional learning communities), school level book study, turn-key trainings at faculty meetings, and district sponsored professional development workshops, and peer visits where teachers sit-in to watch and learn from their colleagues.



Student Supports and Services:

We provide targeted assistance for Multi-language Learners and at-risk students, both during and after school. We also offer an Intervention and Referral Service Team for academic, behavior, and/or social-emotional support. We are a PBSIS (Positive Behavior Supports In School) school, with results that exceed state expectations. We work with our high school to provide peer mentoring programs, like "Leading Ladies" and "The Red Zone". These programs are for Tier 2 & 3 PBSIS interventions. For students with disabilities, our Child Study Team works with our staff and families to support their individual needs.



Student Health and Wellness:

WWIS offers a breakfast program for students so that they may start the day off right! The School Nurse facilitates programs to help support and educate students with food allergies, as well as their friends. We also offer comprehensive Health and Physical Education curricula to support our students' health and wellness. Students have the opportunity to engage in physical activity through physical education, social-emotional support groups, and recess every day.

We even host our high school's home football games, as well as many home soccer games, and middle school basketball games. We also host many of the sporting events for our City Recreation Program.
