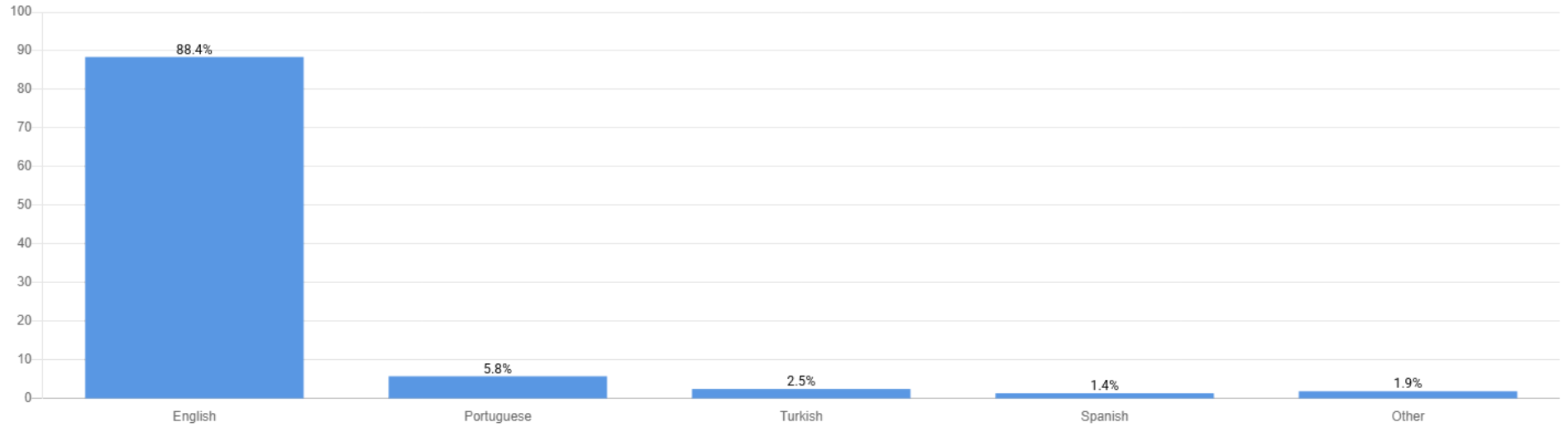

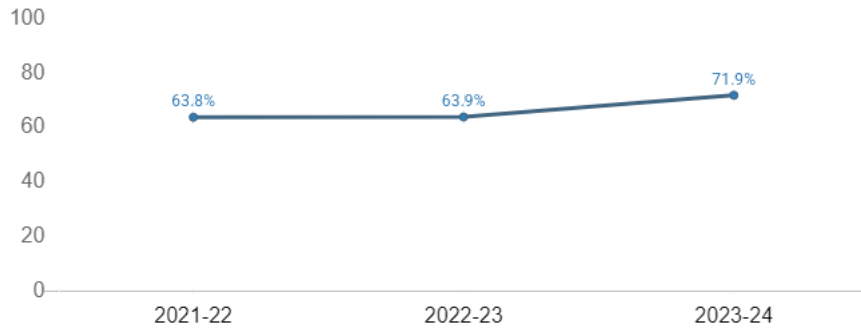

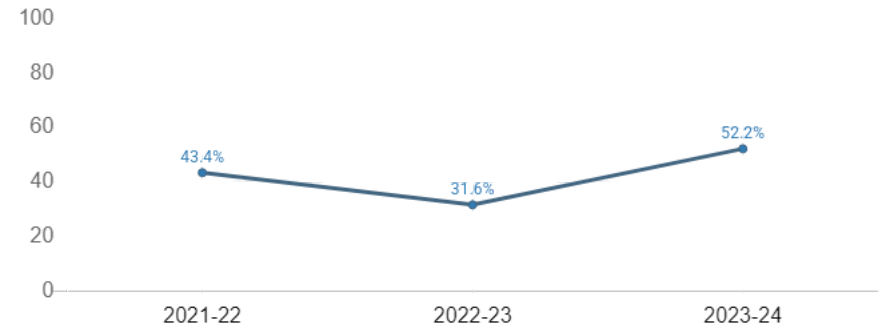
### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 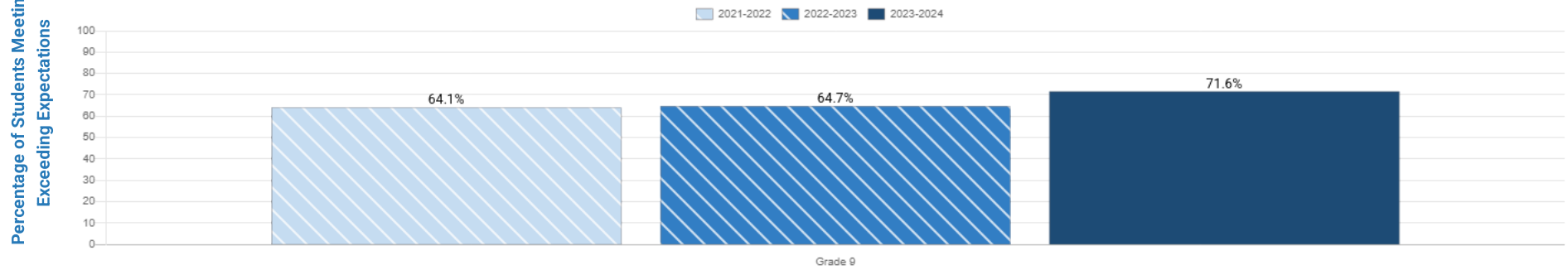

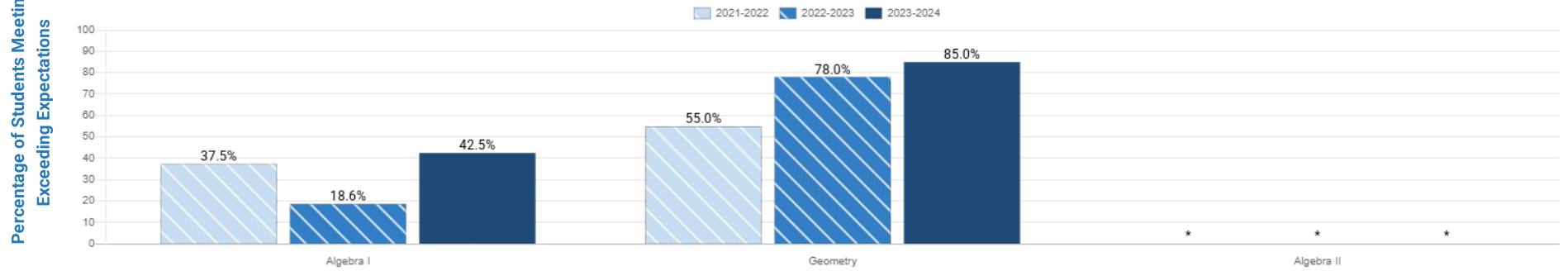

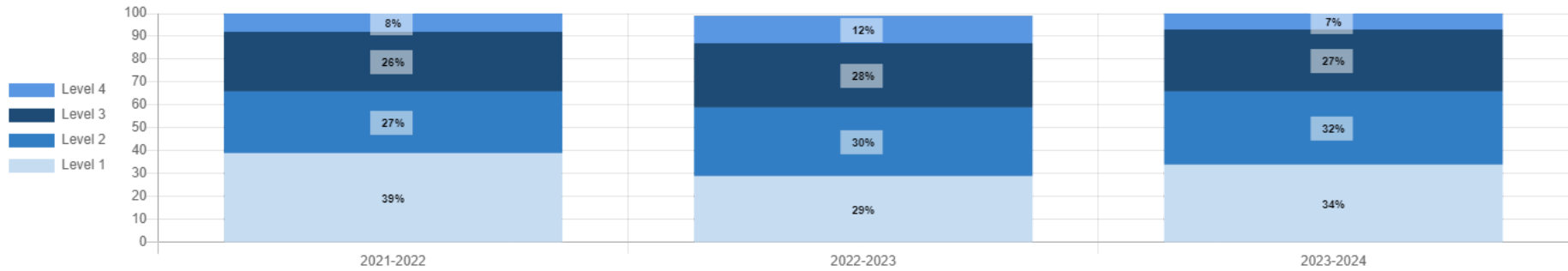

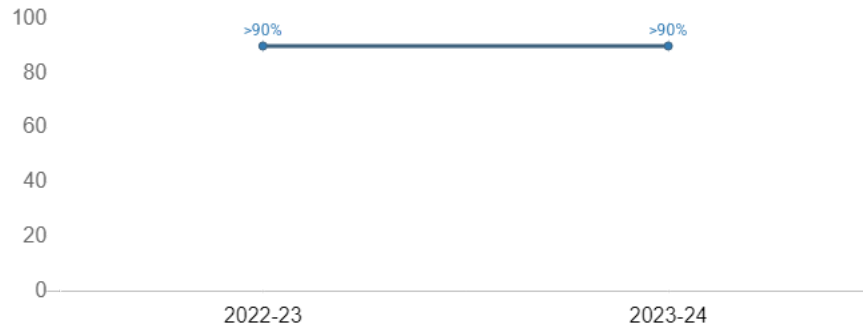

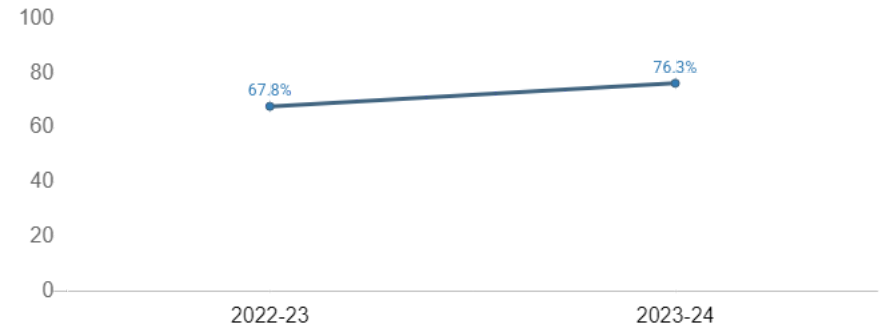

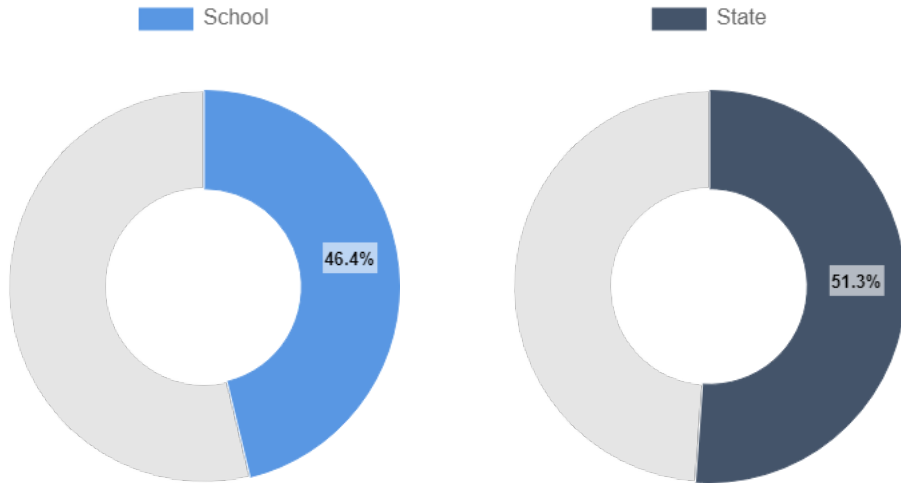

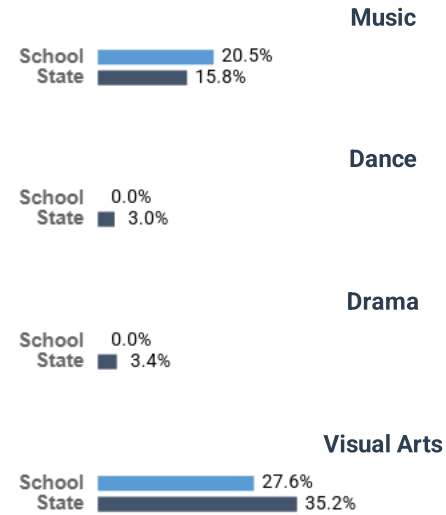

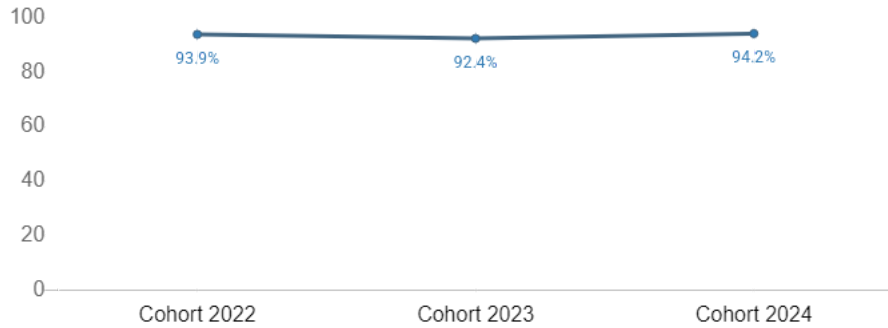

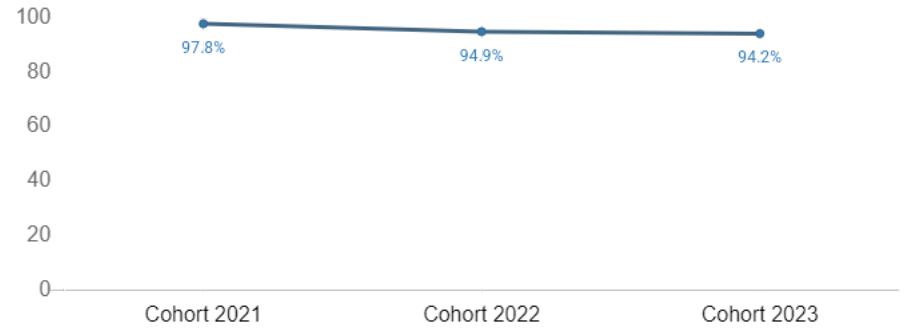

## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

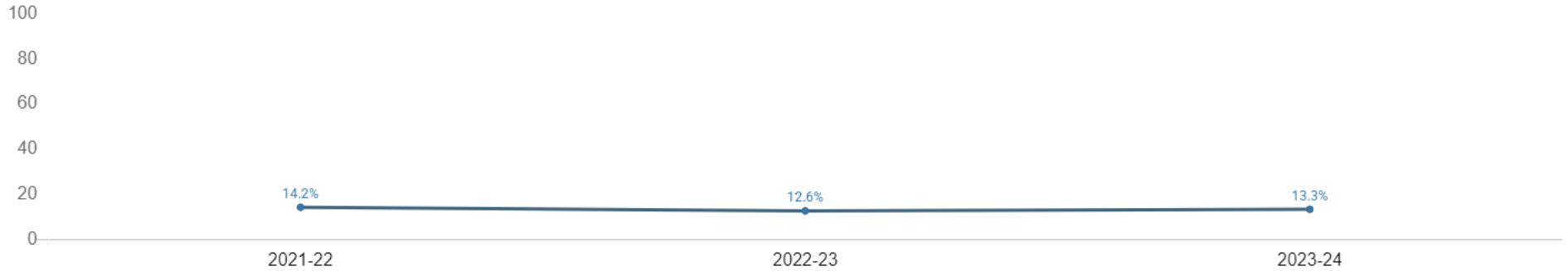

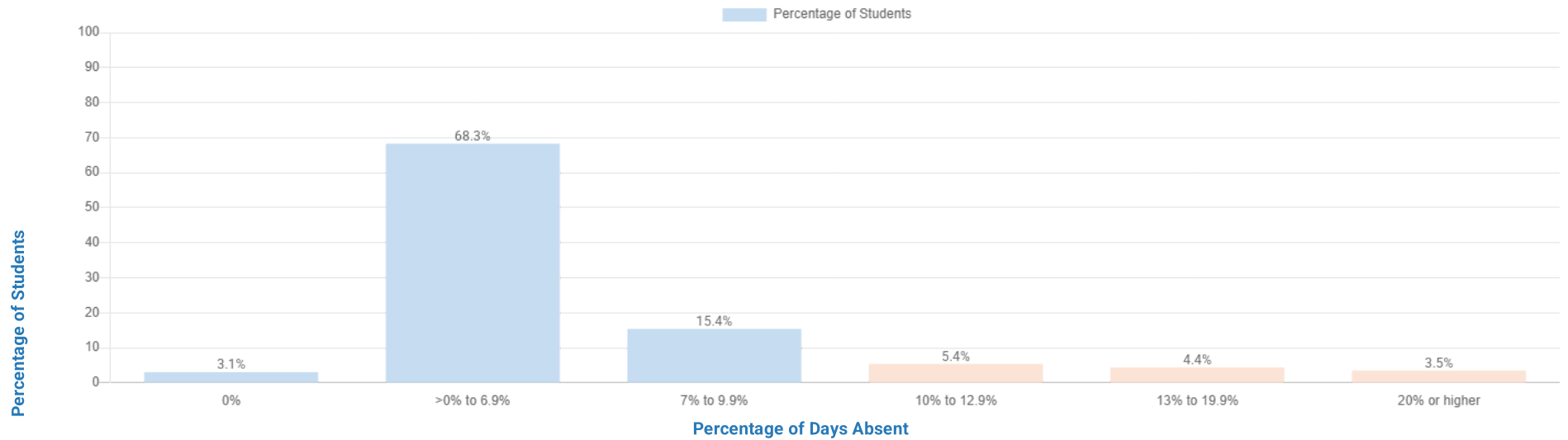

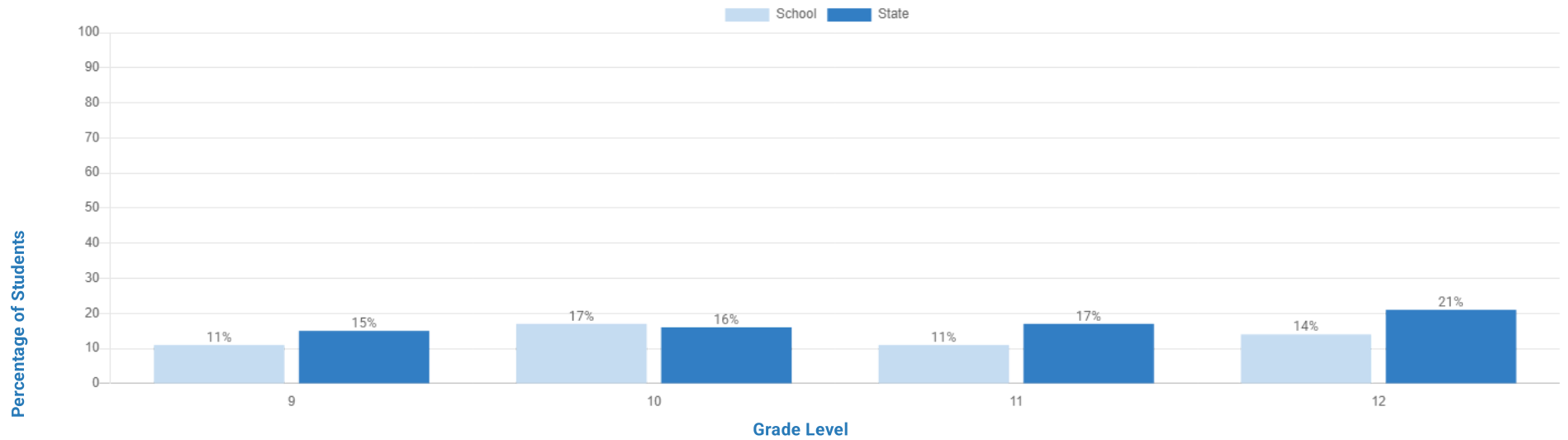

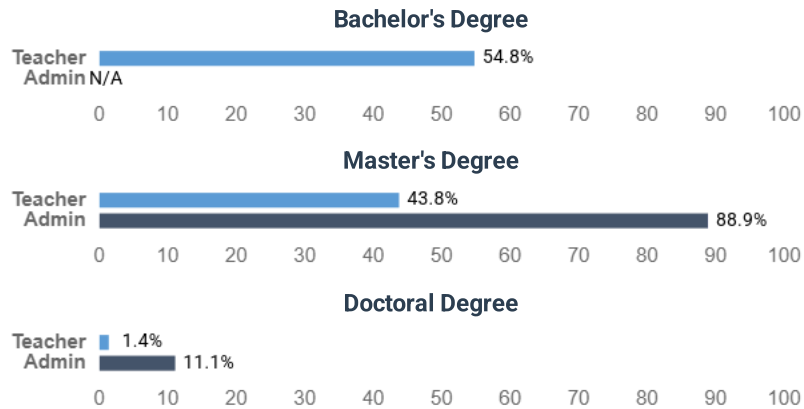

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ### Highlights:

- In 2024, CHS offered 19 AP courses. Students in those courses took 209 AP Exams. Of those exams, 48% resulted in a score of 4 or higher.
- CHS has a state-of-the-art TV studio where students produce a weekly morning show. In addition, students in our Engineering program investigate the design process in our STEM lab.
- CHS has a wellness center staffed full-time by 2 counselors. Students are able to utilize the wellness center whenever they need assistance from a counselor or a quiet moment in their day.

In October of 2023, CHS Math teacher Riley Gartland was recognized as a Milken Educator. She was one of only three teachers in the state of New Jersey to receive this award. Each month we recognize a student of the month in each grade level and two athletes of the month. Our school community has the opportunity to recognize a teacher every month with our Golden Apple award. Annually, we recognize a certified teacher is with the Governor's Educator of the Year award, and the BOE Achievement Award is given to staff a member who has gone above and beyond to better our schools.

Students can complete four-year English, Mathematics, Social Studies, Science, and World Languages programs. The high school program of studies offers 19 Advanced Placement courses, 16 Honors courses, and an extensive college preparatory program. Furthermore, the College Accelerated Program (CAP), offered in conjunction with Rowan College at Burlington County, allows students to earn college credits with the successful completion of approved courses.



### Sports and Athletics:

During the 2023-24 athletic season, the Pirates won division titles in three boys sports (basketball, football, and spring track), three girls sports (lacrosse, soccer, and track), and one co-educational team (Golf). The golf team also won the sectional title. Cinnaminson has a long tradition of athletic excellence and last year was no exception.

CHS has a comprehensive set of activities available to students to complement our academic and athletic options. The National Honor Society provides after-school tutoring for CHS students. We also offer Student Enrichment programs in English, Math, and ML instruction.

CHS offers in-district professional development (PD) opportunities during six in-service days. Staff members are encouraged to pursue outside PD from private providers and various county/state consortiums.



### Postsecondary Information:

From the graduating class of 2024, 61.38% went to a four-year school, 23.78% went to a two-year school, 5.44% post-grad, 0.99% pursued an apprenticeship, 1.98% joined the military, and 5.44% joined the workforce. Naviance, Financial Aid Night, College Application Night and Assembly, College Rep visits, and info sessions for local colleges all support students in applying for college or financial aid. CHS supports college entrance exam students by providing the PSAT to all 10th and 11th-grade students during school and at no cost to the student, fee waivers, and free practice sessions through various testing programs.

### Student Supports and Services:

NHS hosts a tutoring program for groups and private tutoring. We utilize the NJTSS program to ensure all students have the support they need to be successful in class. Students experiencing additional difficulties can be referred to the I&RS team, which meets regularly to assist students. Students are then assigned a mentor teacher to help guide them. In addition, CHS has a robust Special Education program to provide support for students with disabilities. Our Life Skills program partners with the Special Olympics and participates in the unified club and sports.



### Student Health and Wellness:

Our Wellness Center offers students the opportunity to receive on-demand assistance from one of two counselors on staff. Our Interact club participates in many school-based volunteer opportunities to help the needy. All our students participate in health or physical education classes for 167 minutes a week during the school day. We also have a renovated weight room for students during PE classes, practices, and Saturday mornings. We have adopted the Choose Love curriculum and engage in school-wide SEL lessons specifically focused on the mental health needs of our student body.



### Parent and Community Involvement:

There are two primary parent groups at CHS. The CHS Home and School Association (HSA) and the Project Graduation Committee. The CHS HSA meets once a month and invites all parents to attend. Subgroups within the organization meet additional times as needed to complete many tasks. The Project Graduation Association focuses on hosting one of our largest events, Project Graduation. It provides a safe, drug, and alcohol-free event for the graduates on the graduation night. Many of our sports teams also have parent-led booster clubs.

### Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students. Cinnaminson High School administers two school climate surveys. The first is administered in September. The results are utilized to drive our character education programming and HIB training for the year. The second survey is administered in June. The results are analyzed over the summer and factored into the planning for the Week of Respect and School Violence Awareness Week.



### Facilities:

CHS was originally built in 1964. In 2016, it completed a 40 million-dollar construction project to renovate the entire building and add a second floor, air conditioning, science labs, and a new gym. Since then, we have remodeled the culinary arts room, refinished the lockers, improved exterior finishes on the building, and converted a science classroom to house the district's technology engineering and design program.



### School Safety:

CHS employs a full-time Class 3 Resource Officer. We recently added several security features, including a secure vestibule and the VisitorAware system, which visitors must use upon entry into the building. A Columbine lock protects all classroom doors. In addition, security cameras monitor most of the school's common areas. We conduct monthly fire and crisis drills throughout the school year. CHS utilizes SmartPass, a digital pass system that streamlines the process for students needing to leave the classroom for various reasons. This technology allows teachers and administrators to easily track student movements, ensuring accountability and safety. The introduction of SmartPass aims to promote a more organized and efficient environment, helping students maximize their learning time while maintaining order throughout the school day.

### Technology and STEM:

CHS has a full complement of technology courses, starting with an introductory computer usage course and culminating in AP Programming. Students can participate in a Television production course that includes student-created broadcasts. We have a dedicated STEM lab to house our three levels of Engineering courses. Our Technology department offers a Robotics course. Several extra-curricular STEM and technology activities are available through the Robotics Club, Technology Students Association, Math League, and Physics Olympics.



### Attendance:

CHS partners with students and families to avoid chronic absenteeism. Our teachers, counselors, and administrators work with students and families to ensure they have the support they need to attend school. We utilize attendance data to identify students who may need additional assistance and connect them with counseling services. We proactively strive to ensure that all students have a connection within the building to encourage attendance and recognize those students who have exemplary attendance. We also provide courtesy bussing to all students.
