




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 



Students in sixth grade who were enrolled in Algebra I course were required to take both the Algebra I and Grade 6 mathematics assessment. The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

The results of their Geometry assessment are not included in these results but will be reported when the student is in grade 9.
















Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.









Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Highlights:

- Cherokee offers 28 Advanced Placements courses.
- DECA had 156 qualifiers: 40 advanced to States, 13 went to Nationals, 1 ranked in the top 10 internationally. FBLA had 93 qualifiers, 58 advanced to States and 3 progressed to international contests.
- Cherokee had 8 Commended National Merit Scholars, 67 AP Scholars 34 AP Scholars with Honors, and 37 AP Scholars with Distinction. We administered 736 AP exams with 82% scoring 3 or higher.



Mission, Vision, Theme:

Cherokee High School is part of the Lenape Regional HS District serving the community of Evesham in Burlington County offering 240 different courses, including 28 AP classes and over 60 College Dual Enrollment options. With our graduation rate of 97%, Cherokee strives to meet the social, emotional, and cognitive needs of all students preparing them to become productive members of our ever changing and diverse society. Cherokee's North/South layout provides students with the distinct advantage of a large high school with two smaller learning communities. This arrangement allows Cherokee to join in the LRHSD mission to maintain high expectations while providing students with unlimited educational experiences, exceeding the NJCCS, all in a coordinated relationship with our families and community.



Awards, Recognition, Accomplishments:

Cherokee had 8 Commended Students at the National Merit Scholar Program. We are a Project Lead the Way Distinguished School and received the Anti-Defamation League's No Place for Hate accreditation. We had students honored at the Teen Arts Selection Showcase and at the Burl Co. Arts for Teens, 22 students were awarded the Seal of Biliteracy, and 5 students were recognized on the Natl Latin exam. We had a Bausch and Lomb Science award recipient, an American Chemical Society awardee, 2 Science and Service recipients, and 2 Society of Women Engineers of NJ Certificates of Merit designees. 119 students received the Presidential Academic Excellence Award while 33 students received SAT recognition. Cherokee's music programs are recognized at the state and national level for outstanding achievement. These programs (Orchestra, Marching/Wind/Jazz Bands, and Choral) have performed in competitions and community events along with sponsoring students at the region and All State level ensembles.

Courses, Curriculum, Instruction:

Through more than 236 course offerings, 26 AP courses and 68 College Acceleration Program courses, 43 at Rowan College at Burlington County (RCBC) and 25 at Rowan University (RU), complemented by summer enrichment programs, the Lenape District offers academic tracks to meet every student's needs. In the 2023-24 school year, 942 students district-wide applied for RU and RCBC dual credit; on average, each student earned 7.9 college credits.



Sports and Athletics:

Cherokee had 1,394 athletes with 271 Varsity players achieving a 3.65 GPA or higher including 3 Olympic Conference Scholar athletes. On the athletic fields and courts, Cherokee has won six Conference Championships and three SJ Sectional Championships.

Before and After School Programs:

Cherokee provides breakfast programs before school as well as before and after school access to the weight room thereby promoting students' health and well-being. In addition to the many after-school clubs and sports activities, we offer weekly Social Rec meetings, Cherokee Buddies club, Unified Basketball, and evening SAT prep workshops.



Staff and Professional Learning:

All of the LRHSD teachers are trained by our in-house Research for Better Teaching (RBT) trainers. RBT offers professional development, which takes place during a teacher's first three years at Cherokee, with refreshers offered throughout the year. Cherokee teachers are also trained in Understanding by Design (UbD) Curriculum Writing, Asthma, Lyme Disease, Glucagon & Diabetes, EpiPen, Blood Borne Pathogens, Diabetes, Epilepsy/Seizure and Suicide awareness. Cherokee provides its teachers with an uninterrupted common planning time, which allows for collaboration and collegiality.



Postsecondary Information:

During the 2023-24 school year, 942 students earned 7283 college credits through the dual credit program. LRHSD is proud to offer the PSAT to all students in grades 9, 10, and 11, as the district believes that opportunity better prepares them for the SAT. LRHSD's success as a high-achieving district is exemplified by its 96.2% graduation rate, its SAT scores consistently above state and national averages, and its 75.5% of graduates attending over 236 colleges and universities.

Cherokee's Intervention and Referral Services are designed to assist students experiencing learning, behavior, or health difficulties. Cherokee offers a complete range of programs for students who have been determined to be "Eligible for Special Education and Related Services," including resource center programs, inclusion, and self-contained programs. In addition to the many services provided through assigned counselors, Cherokee offers our students the comfort of a Wellness Room where students can quickly destress under the guidance of professionals.



Student Health and Wellness:

Cherokee provides a nutritious breakfast and lunch throughout the school day. All students, regardless of grade, take part in Physical Education and Health classes. Cherokee adopted the concept of a Wellness Room, where students are welcomed at any time to emotionally prepare for the day; there is a constant focus on the social and emotional well-being of our student population.



Parent and Community Involvement:

Parents are able to access student grades and pertinent information through our Genesis Grading Portal, the LRHSD app, Cherokee's X and Instagram accounts and our Blackboard Email communication portal. Additionally, Cherokee hosts 25 parent booster clubs that support and promote Cherokee athletics and activities as well as our parent sponsored Foundation for Education. Students and staff are involved in many community service projects both independently and through cooperation with Evesham Township. 551 seniors participated in Cherokee's Senior Day of Community service, an organized program providing volunteer opportunities throughout Evesham and Burlington County. Each year we recognize a Student and Parent Service Volunteer of the Year.

Climate Surveys:

The survey focuses on the school's Core Values of Accountability, Integrity, and Respect (AIR). The results are shared administratively and are part of the protocol for our Middle States Excellence by Design Accreditation. Cherokee has seen an increase in student ownership and empathy towards others as the students' progress from 9th to 12th grade.



Facilities:

Cherokee High School was inaugurated on a 71-acre site in Evesham Township in September 1975. In the early 1990's addition and renovation projects were completed to meet the educational needs of the growing Evesham Township community. In December 1997, voters approved a referendum for the construction of Cherokee's South building, to house students in grades 9-10 and also the addition of the Lenape District Performing Arts Center. Cherokee is up to date with the latest in modern technology and all students are provided a personal Chromebook to support our technological school curriculum.



School Safety:

The Safety and Security of all LRHSD students and staff is a top priority which is evidenced by the following security initiatives already in place at all LRHSD schools. SRO's with marked vehicles are assigned to each school reinforcing a highly visible police presence. All schools have Security staff assigned to assist with maintaining a safe school environment. Exterior doors are secured and locked during the school day. Main office vestibules limit direct entry into the school. All schools are equipped with 24/7 interior and exterior surveillance systems. Lockdown buttons and a phone system are installed at all schools to initiate and expedite lockdown procedures. Portable radios are assigned to key personnel. Interior door locks were installed to expedite the lockdown process and exterior doors have intruder film. In conjunction with the NJDOE guidance, each school implemented Threat Assessment teams to investigate reports and provide appropriate interventions and supports.

Technology and STEM:

Through a referendum the LRHSD was able to create three new programs: Metalwork, welding and fabrication, Automotive with an ASE certification and Construction, Building and Carpentry. These career pathways will allow students to gain hands on experience in a possible career of their choosing. The LRHSD has also partnered with Project Lead the Way a nationally recognized STEM program to offer a pre-engineering pathway where students works collaboratively in a cohort to take an engineering elective each year of their high school experience. This will expose them to different facets of a STEM related career. The LRHSD has two district Robotics teams which compete locally and nationally. Members of the LRHSD Robotics teams report that the project based problem solving design of each challenge deepens their understanding of the concepts behind the designs necessary to compete.



Attendance:

Consistent school attendance is one of the key components of student achievement. Prolonged or repeated absences excused or unexcused, from school or from class, deprive students of the educational and classroom experiences deemed essential to learning. The LRHSD fosters high student attendance by forging strong partnerships with students and families. The LRHSD routinely monitors student attendance and implements supports and interventions when appropriate to enhance student attendance.

Cherokee, along with the entire LRHSD, utilizes a 57-minute class period, with a rotating schedule. The rotating schedule has a morning and afternoon wheel with a 50-minute Community Lunch and Learn period in the middle. This schedule more closely mirrors the college experience, as classes rotate and drop off within a 4-day cycle.
