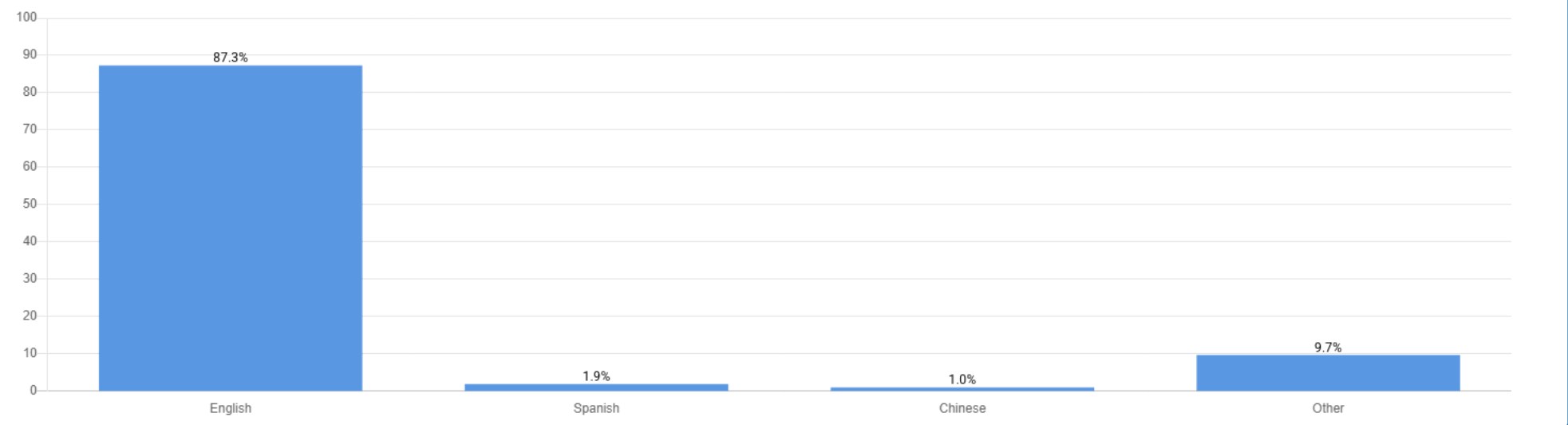

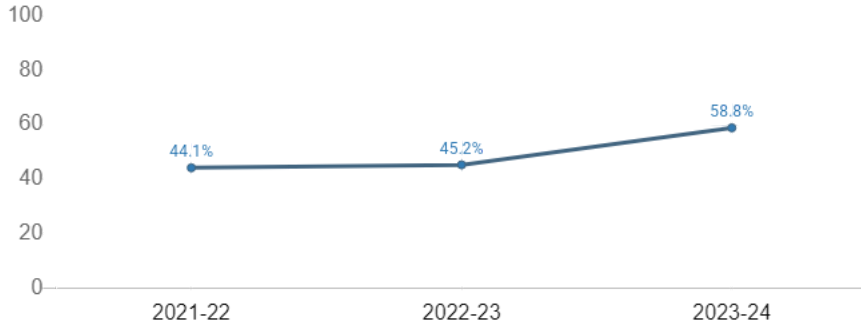

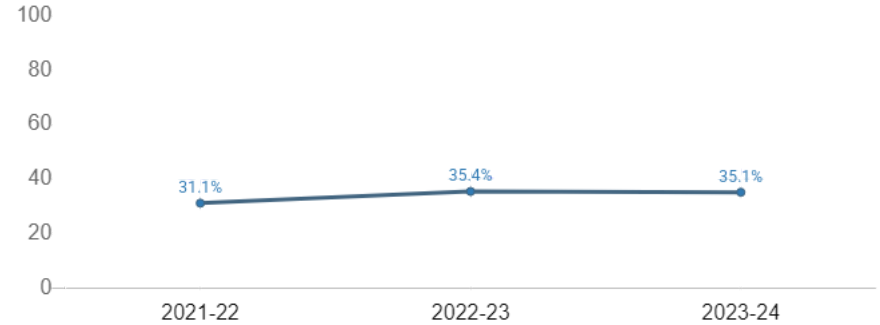
### English Language Arts and Mathematics Performance Trends

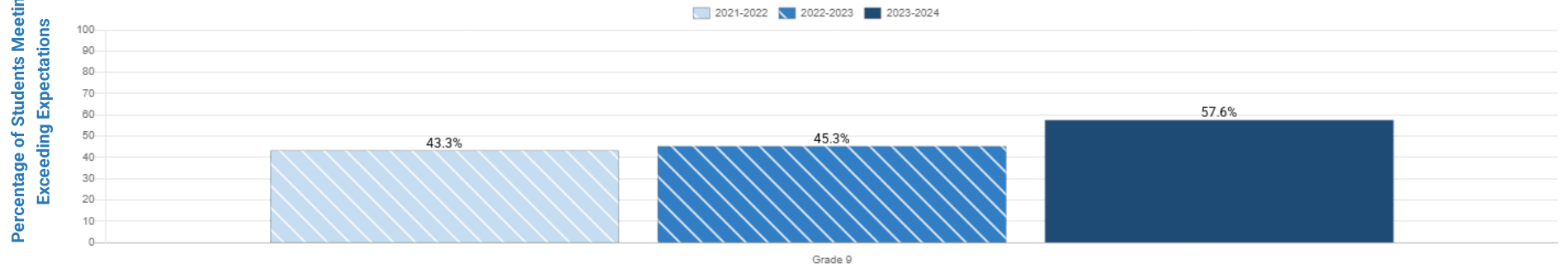

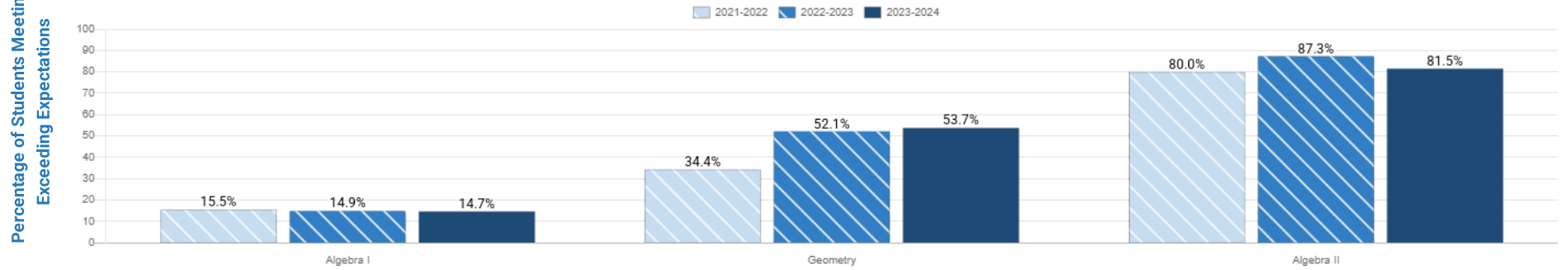

### Mathematics Assessment - Performance By Test: Algebra I

This table shows performance on the NJSLA Algebra I end-of-course assessment. The performance results in this table include all students who took the NJSLA, it does not exclude students who were enrolled less than half a year.

This includes any students who were enrolled in an Algebra I course and took the Algebra I assessment in grades 7 through 12. Students in sixth grade who were enrolled in Algebra I course were required to take both the Algebra I and Grade 6 mathematics assessment. 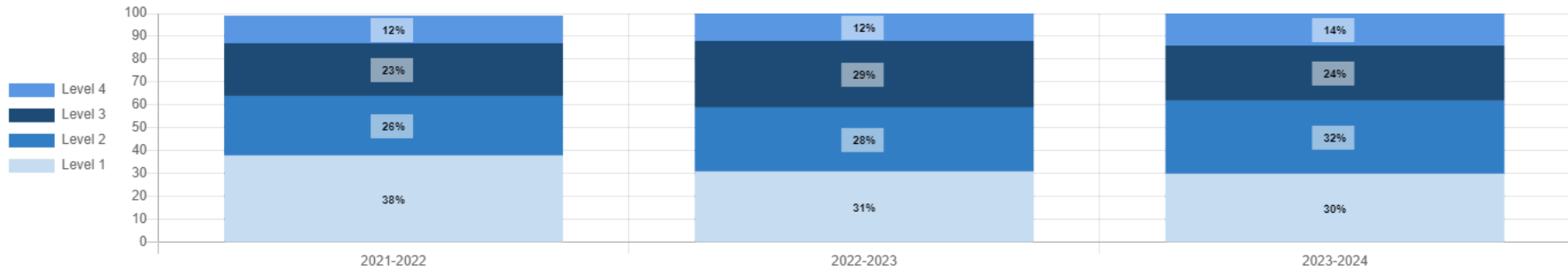

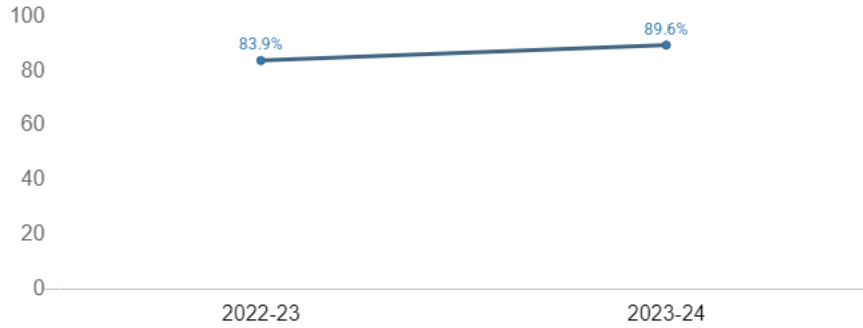

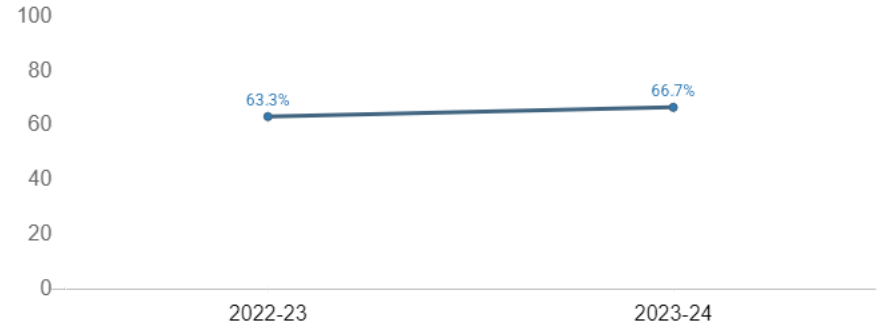

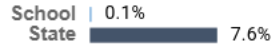

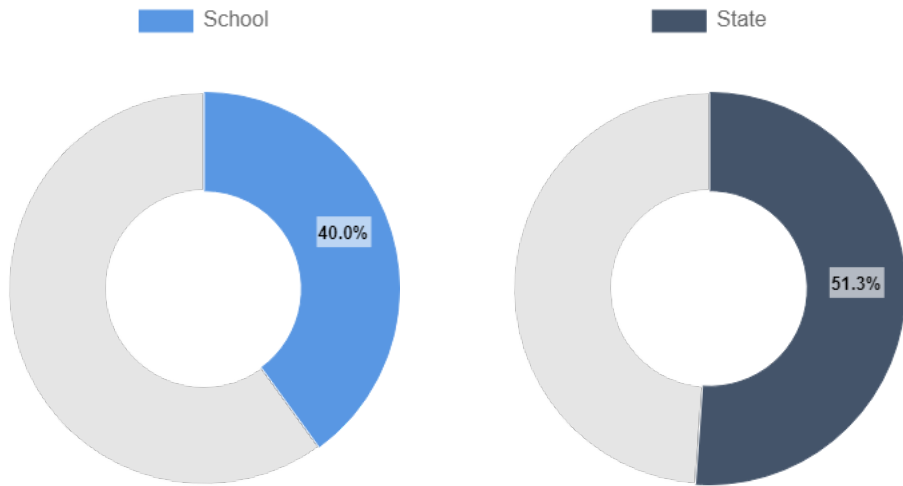

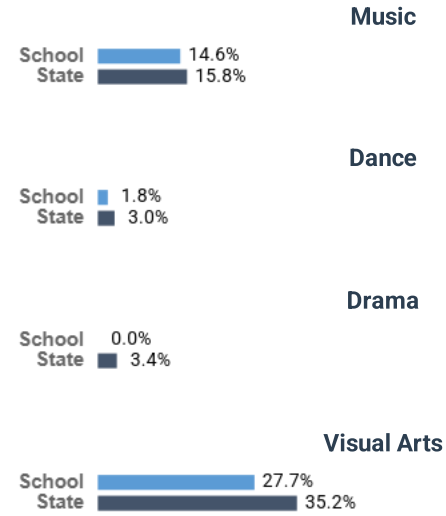

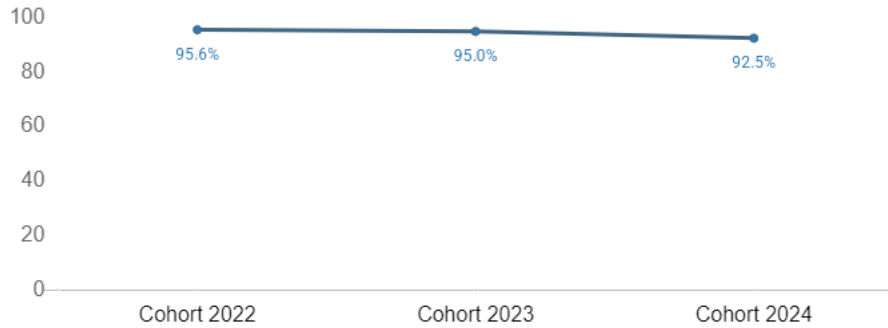

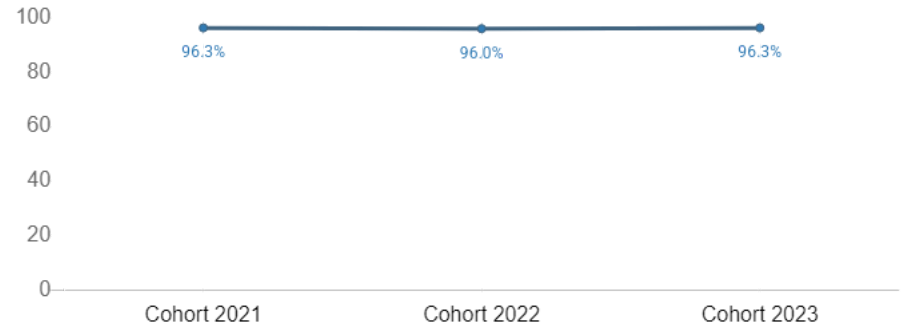

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

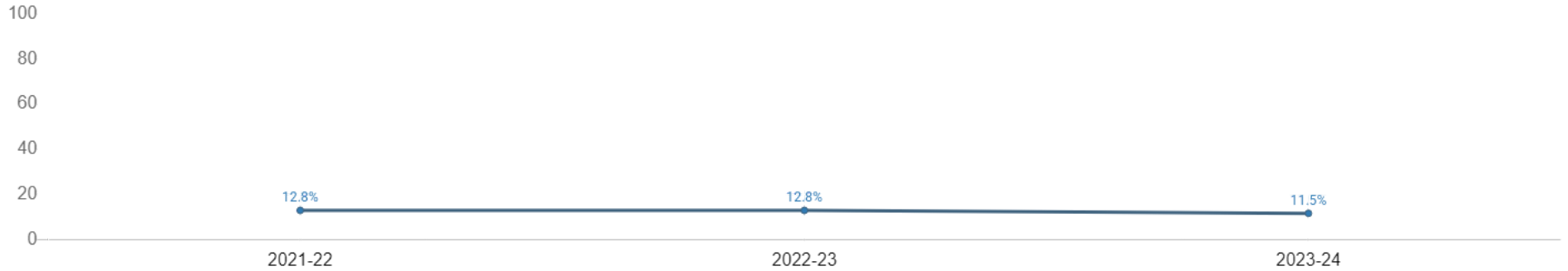

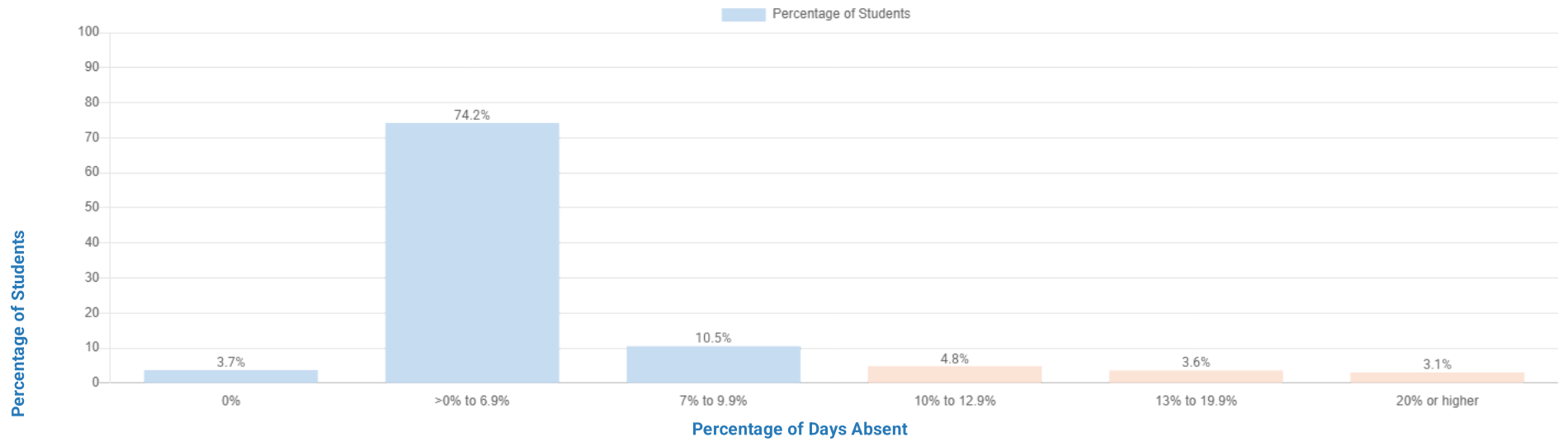

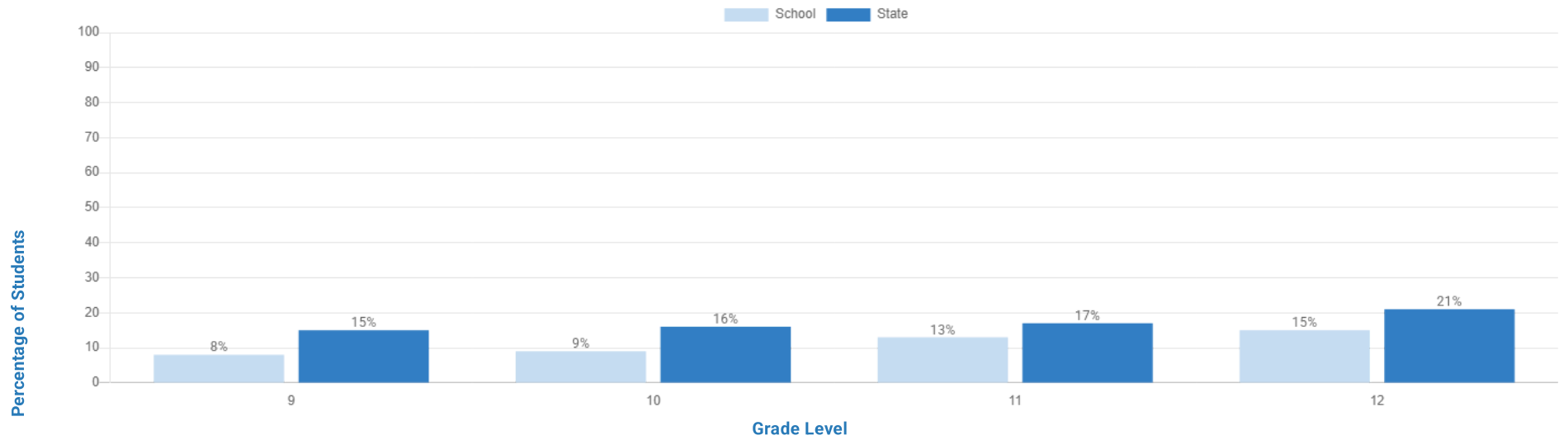

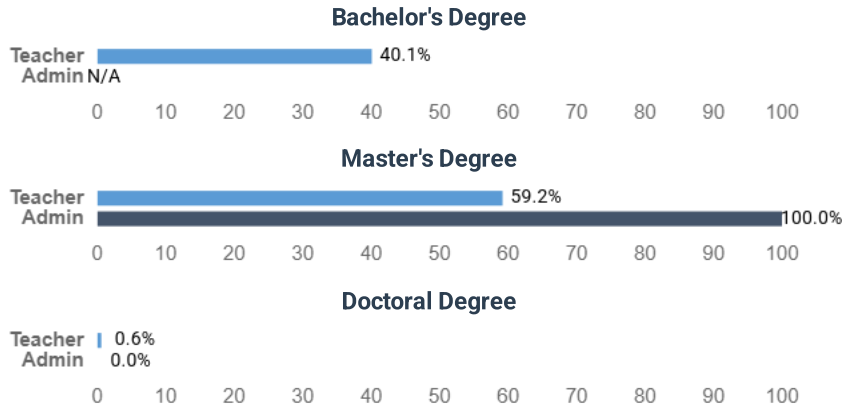

Lenape High School is proud of the achievements of student-athletes. During the 2023-24 school year, its teams won several tournaments and divisional championships. Lenape girls' and boys' tennis teams won the Group 4 South Jersey Sectional titles. The girls and boys basketball teams both advanced to the Group IV State Championship Game, with the girls team winning the title. In addition, individual athletes were recognized for their talents by various newspapers and organizations, having been selected for all-area teams and player of the year honors. Lenape's athletic programs are a part of the Positive Coaching Alliance, working to not only advance their athletic abilities, but also their empathy and citizenship through sports.



### Clubs and Activities:

With a wide range of academic, community service, cultural, and special interest organizations in which students can get involved, students can choose from a variety of options. In the past year Lenape clubs have volunteered at food pantries in Camden and Mount Holly, Give Kids The World in Kissimmee, FL, and at several other locations throughout the region. Lenape's clubs and activities have sponsored a number of celebrations of diversity, including the March for Martin and World Voices Day. The Lenape Band also won the New Jersey Group I Open Championship.

### Before and After School Programs:

Lenape offers a variety of academic resources to address clarity or additional assistance for all students. Whether it is after school or during Community Lunch and Learn, teachers and National Honor Society students are available to assist students. After school, Lenape provides individual teacher instruction at the Tutoring Tribe and NHS tutoring in the media center. Lenape also assigns NHS students to meet with students in need during their study hall or Community Lunch and Learn.



### Staff and Professional Learning:

All LRHSD teachers are trained by the in-house Research for Better Teaching (RBT) trainers. RBT professional development takes place during a teacher's first three years, with refreshers offered at various intervals. Lenape's teachers are also trained in Understanding by Design (UbD). Lenape also provides its teachers with an uninterrupted common planning time, which allows for greater collaboration and collegiality. Lenape teachers participate in extensive peer observation and Collegiality Cafe programs which enable staff to share best practices. Lenape teachers have conducted 1000+ peer observations in the past four years, and 100+ Collegiality Cafes of teachers sharing best practices to their peers.



### Postsecondary Information:

During the 2023-24 school year, 942 students earned 7283 college credits through the dual credit program. LRHSD is proud to offer the PSAT to all students in grades 9, 10, and 11, as the district believes that opportunity better prepares them for the SAT. LRHSD's success as a high-achieving district is exemplified by its 96.2% graduation rate, its SAT scores consistently above state and national averages, and its 75.5% of graduates attending over 236 colleges and universities.

Lenape's Intervention and Referral Services are designed to assist students experiencing learning, behavior or health difficulties. Lenape offers a complete range of programs for students who have been determined to be eligible for special education and related services, including resource center programs, inclusion and self-contained programs.



### Student Health and Wellness:

Lenape has established a Wellness Center for students to take a break from the pace of high school. The Lenape Wellness Center is staffed by two counselors. Lenape provides a nutritious breakfast and lunch throughout the school day. The Lenape weight room and fitness center are also available after school and during our Community Lunch and Learn. Lenape hosted a Wellness Day for all students and staff to learn more about leading a healthy lifestyle. Lenape school nurses conduct a health screening for any student that does not have a current physical on record.



### Parent and Community Involvement:

Lenape has had an established PTO group for several years. The Lenape PTO sponsors the Lenape Project Graduation, in order to provide a safe, drug and alcohol free environment for all seniors on graduation night. Parents can access students' grades and information through our Genesis Gradebook or through the LRHSD app. Lenape also utilizes X (formerly known as Twitter), Facebook, Instagram, Blackboard Messenger, and Naviance to connect with families.

### Facilities:

Lenape High School opened in 1958 on a 53-acre plot of land in Medford, NJ. Since that time, the school has undergone multiple renovations to accommodate the educational needs of the sprawling community. As part of recent renovations, learners enjoy enhanced climate control throughout the building and new classroom and athletic facilities. Students attend classes throughout the campus and enjoy the advantages of a large high school and smaller learning communities. The school is up to date with modern technology needed to support the school curriculum.



### School Safety:

The Safety and Security of all LRHSD students and staff is a top priority which is evidenced by the following security initiatives already in place at all LRHSD schools. SRO's with marked vehicles are assigned to each school reinforcing a highly visible police presence. All schools have Security staff assigned to assist with maintaining a safe school environment. Exterior doors are secured and locked during the school day. Main office vestibules limit direct entry into the school. All schools are equipped with 24/7 interior and exterior surveillance systems. Lockdown buttons and a phone system are installed at all schools to initiate and expedite lockdown procedures. Portable radios are assigned to key personnel. Interior door locks were installed to expedite the lockdown process and exterior doors have intruder film. In conjunction with the NJDOE guidance, each school implemented Threat Assessment teams to investigate reports and provide appropriate interventions and supports.

### Technology and STEM:

Through a referendum the LRHSD was able to create three new programs: Metalwork, welding and fabrication, Automotive with an ASE certification and Construction, Building and Carpentry. These career pathways will allow students to gain hands on experience in a possible career of their choosing. The LRHSD has also partnered with Project Lead the Way a nationally recognized STEM program to offer a pre-engineering pathway where students work collaboratively in a cohort to take an engineering elective each year of their high school experience. This will expose them to different facets of a STEM related career. The LRHSD has two district Robotics teams which compete locally and nationally. Members of the LRHSD Robotics teams report that the project based problem solving design of each challenge deepens their understanding of the concepts behind the designs necessary to compete.



### Attendance:

Consistent school attendance is one of the key components of student achievement. Prolonged or repeated absences excused or unexcused, from school or from class, deprive students of the educational and classroom experiences deemed essential to learning. The LRHSD fosters high student attendance by forging strong partnerships with students and families. The LRHSD routinely monitors student attendance and implements supports and interventions when appropriate to enhance student attendance.

Lenape High School takes pride in its outstanding academic success and relationship with the surrounding communities. Lenape students are known for not only their impressive test scores, but also for their kindness and respect. The high school's administration holds their students to a higher level than most because they know exactly what each individual student is capable of, and that is success. With the help of an outstanding district, Lenape students can confidently walk through the doors knowing that they are receiving an exceptional education and building a strong foundation for their future. Lenape, along with the entire LRHSD, operates using a 57 minute class period, rotating schedule. The rotating schedule has an AM wheel and a PM wheel with a 50 minute Community Lunch and Learn time in the middle. This schedule more closely mirrors what our students will experience in college, as classes rotate and drop off within a 4-day cycle. Our students utilize the Community Lunch and Learn to seek assistance from their teachers, study with their peers, complete their independent work, meet with clubs, complete a variety of tasks that would otherwise interrupt instruction, or socialize with friends. It also provides our students the opportunity to further develop their time management skills. We are preparing our students to succeed in life after Lenape High School.
