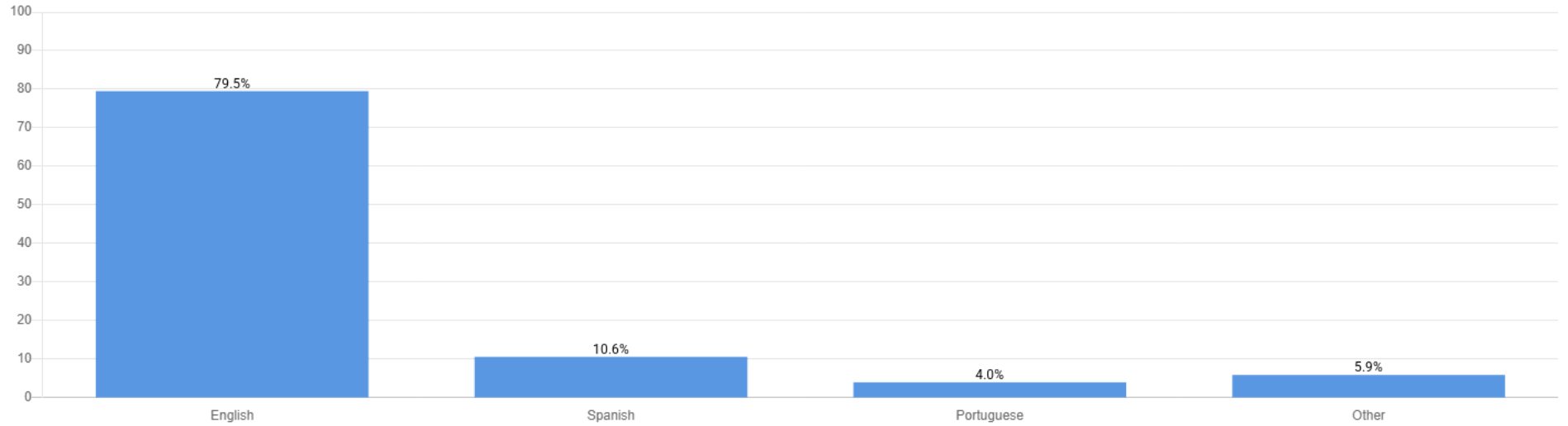

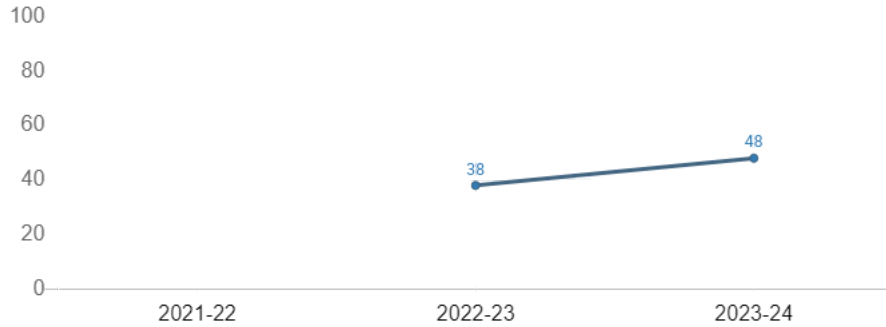

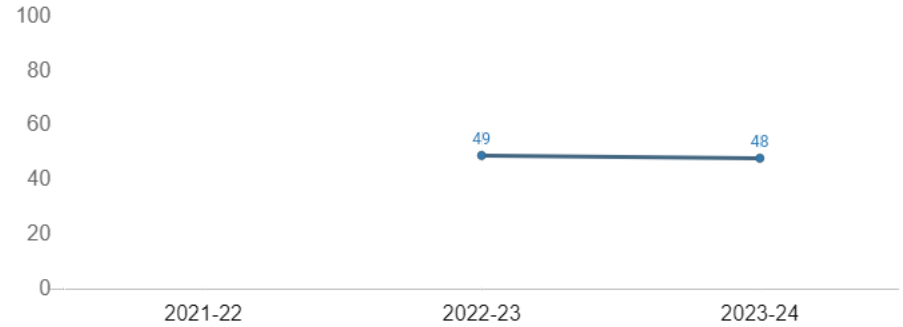

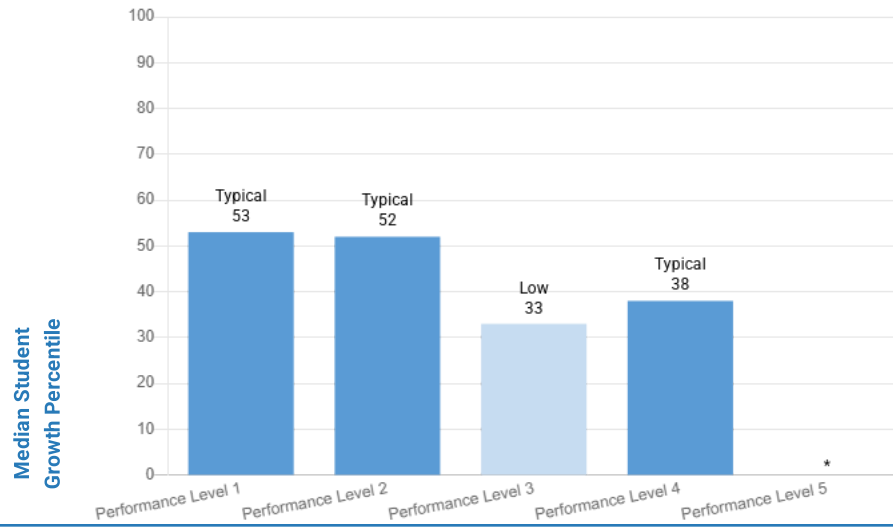

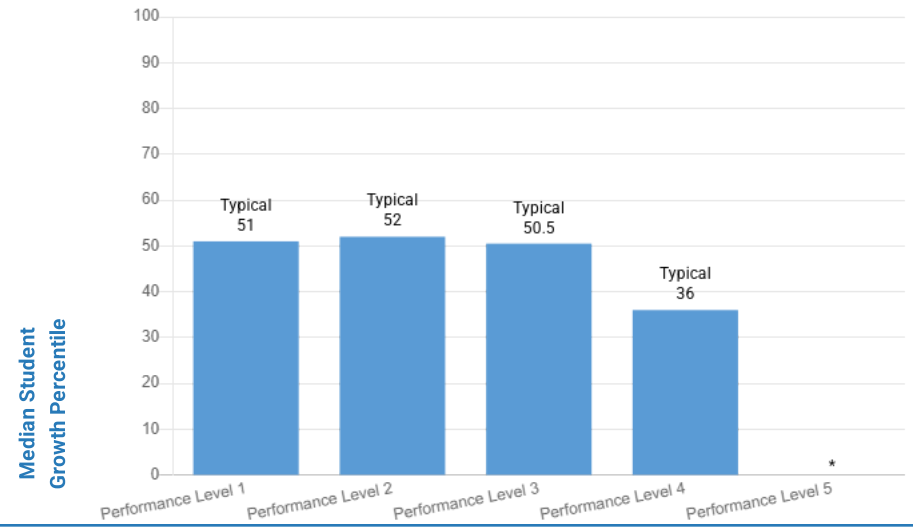

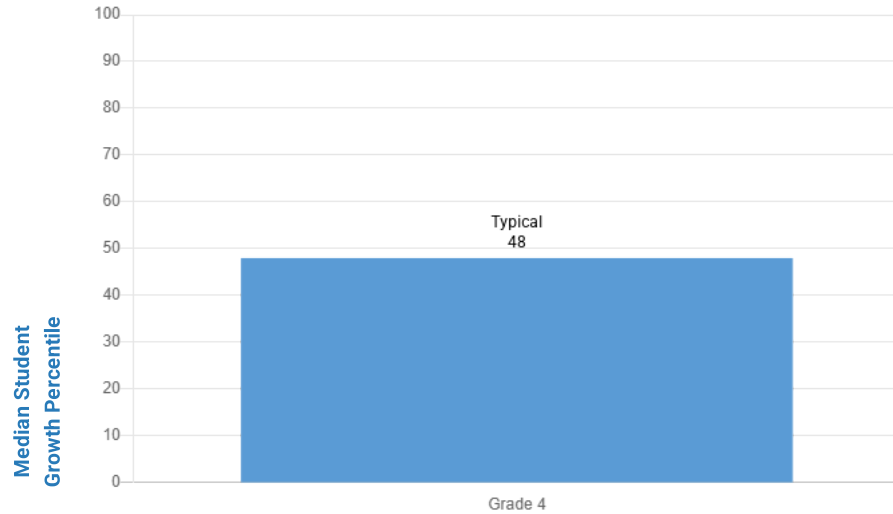

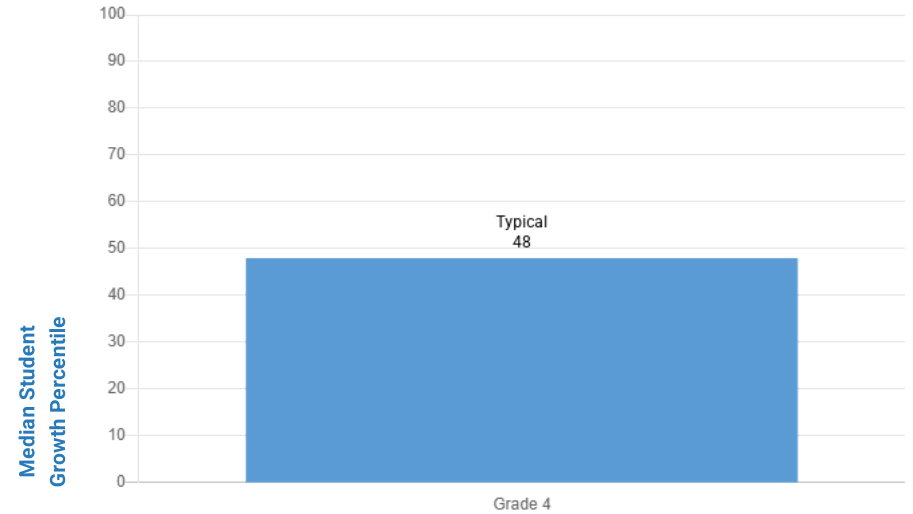

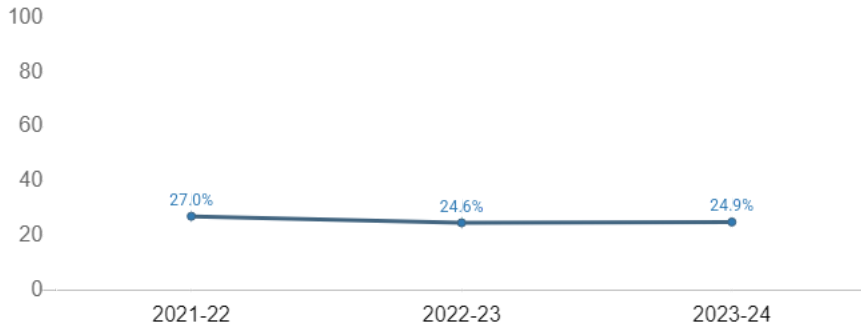

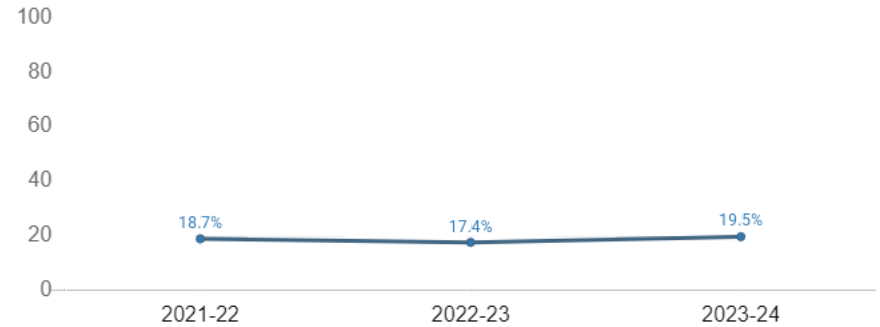
English Language Arts and Mathematics Performance Trends

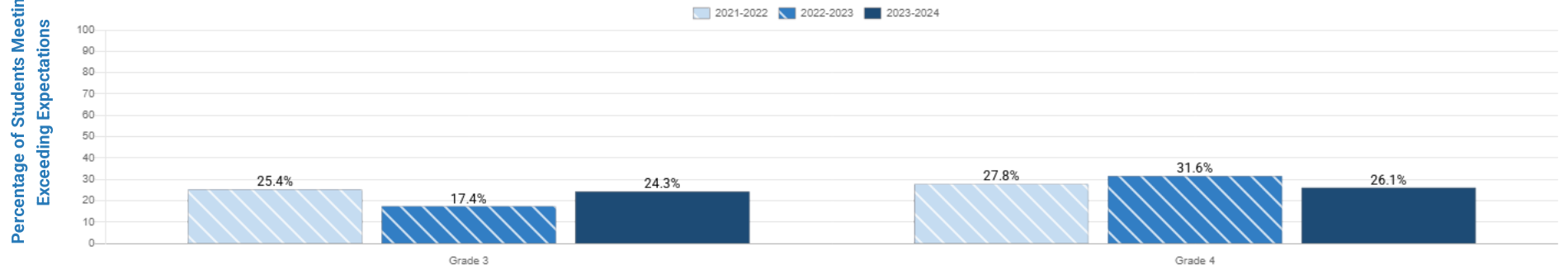

Mathematics Assessment - Participation and Performance

High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 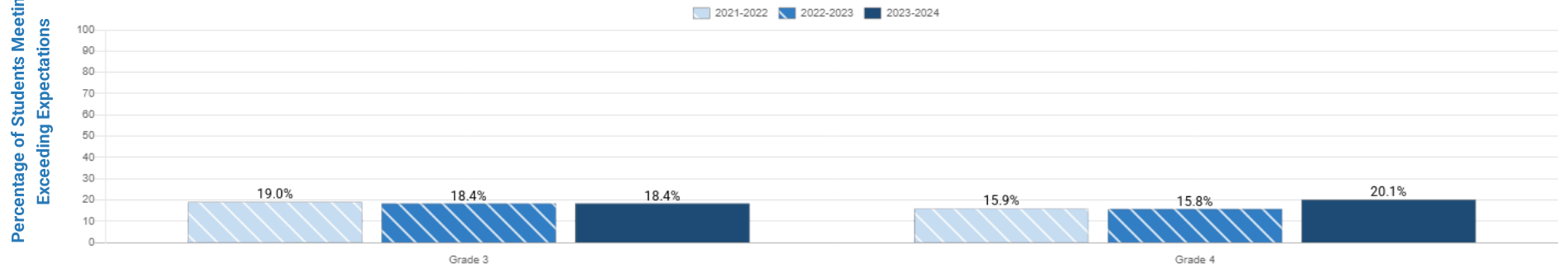

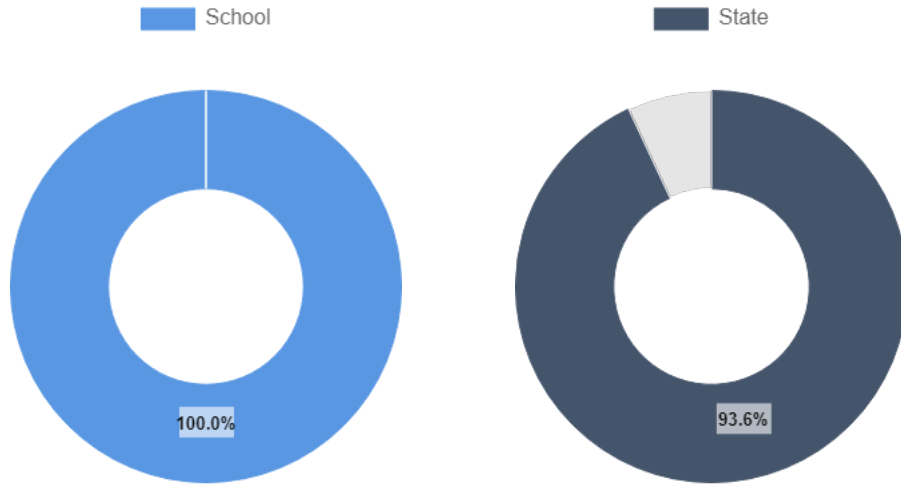

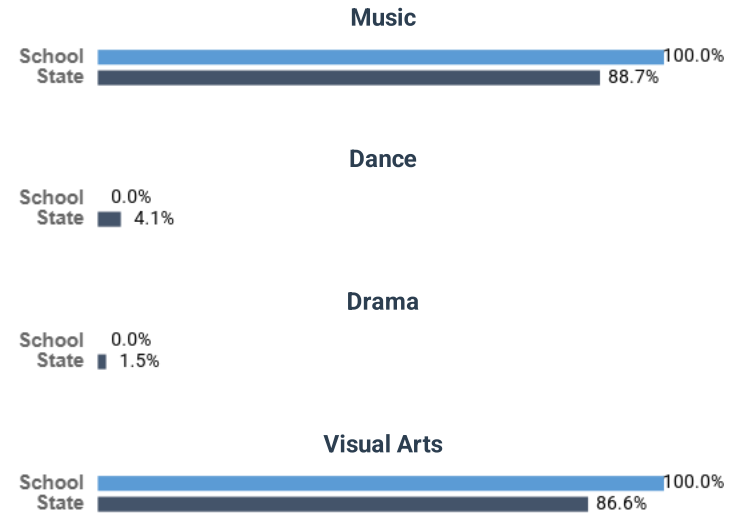

Students enrolled in one or more classes by discipline:



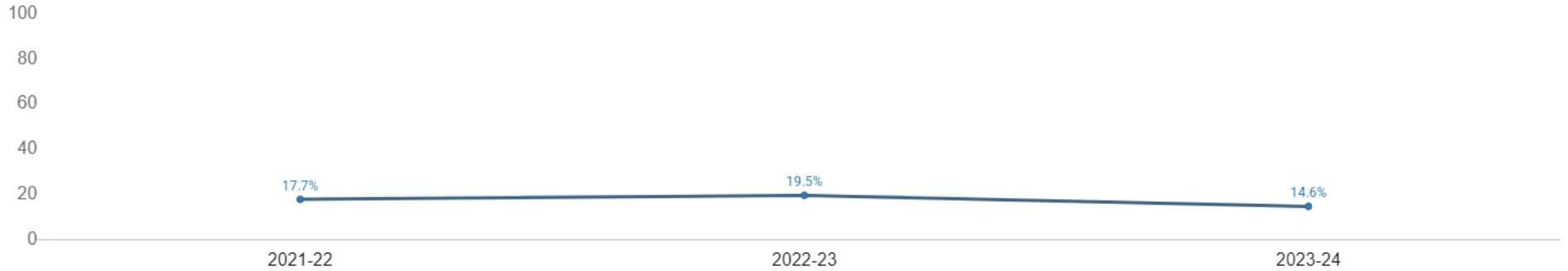

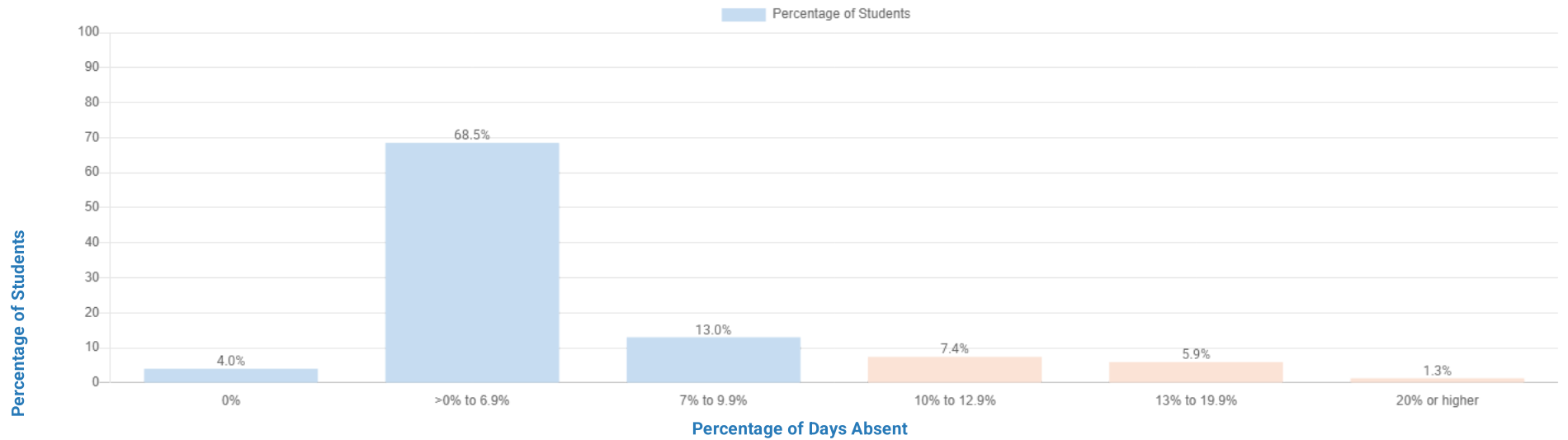

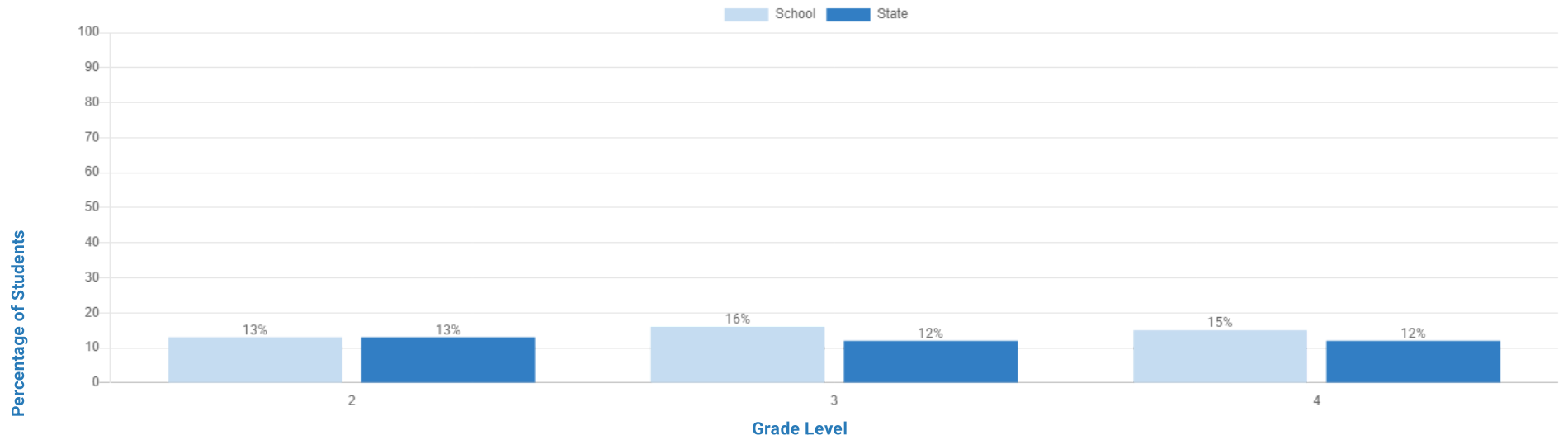

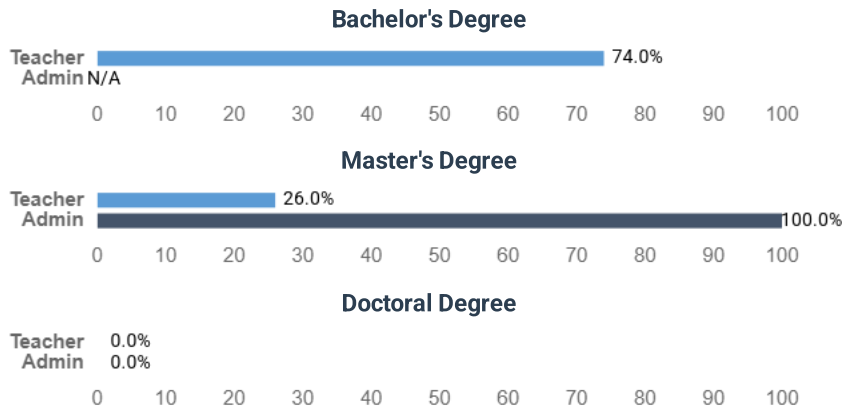

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. The Maude Wilkins Elementary school was built in 1926 with upgrades in 1959 and 2008 and 2020. Renovations of stairwells, security systems, technology, and roofing projects have been completed in the 2014-2016 school year. During the 2019-20 school year a new second grade wing of 9 classrooms, school wide air conditioning, upgraded bathrooms, new roofing and upgraded facilities were completed in the 2019-20 school year. referendum The school has 8 fourth grade classrooms, 8 third grade classroom, 8 second grade classrooms, an Art room, a Music room, Library/Multimedia center which is also utilized for computer instruction, Gymnasium, Cafeteria, Computer Lab and 17 classrooms used for student support in special education, basic skills, and Speech Therapy.

Maude Wilkins has a school safety team that meets to discuss and implement procedures for all students to be safe at Maude Wilkins. Students receive instruction and presentation on safety in schools. Security and emergency drills are performed monthly. The Maude Wilkins Elementary school also houses a class III officer in the school.

Maude Wilkins students have access to 350 Chromebooks with wireless access. Each classroom is equipped with an interactive panel that is utilized for daily instruction. Technology is infused into instruction daily.
