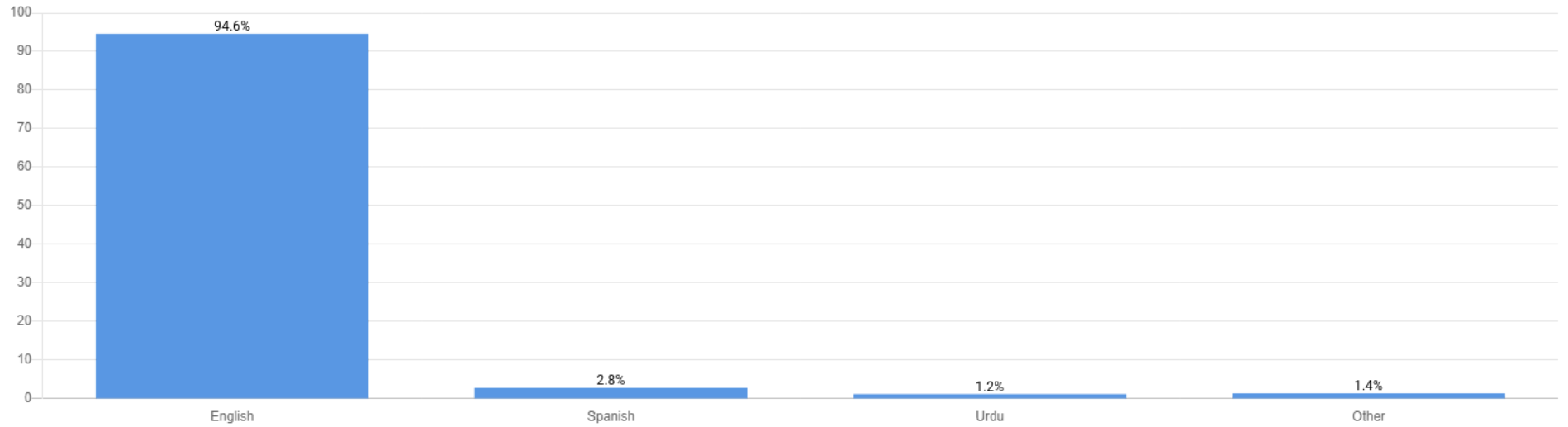

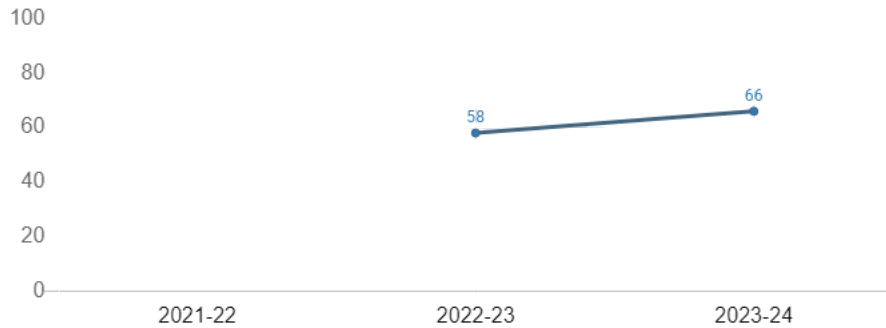

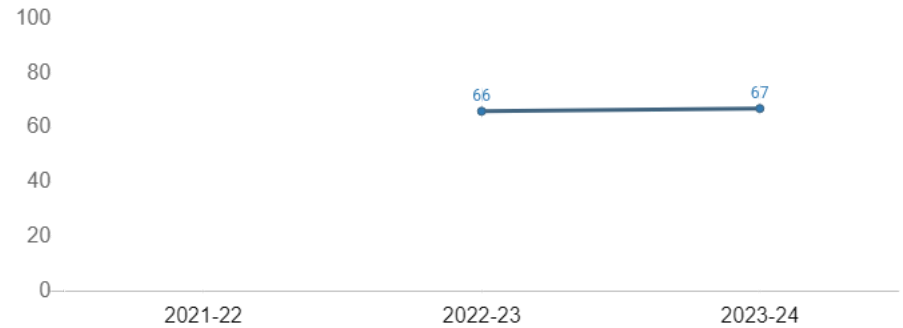

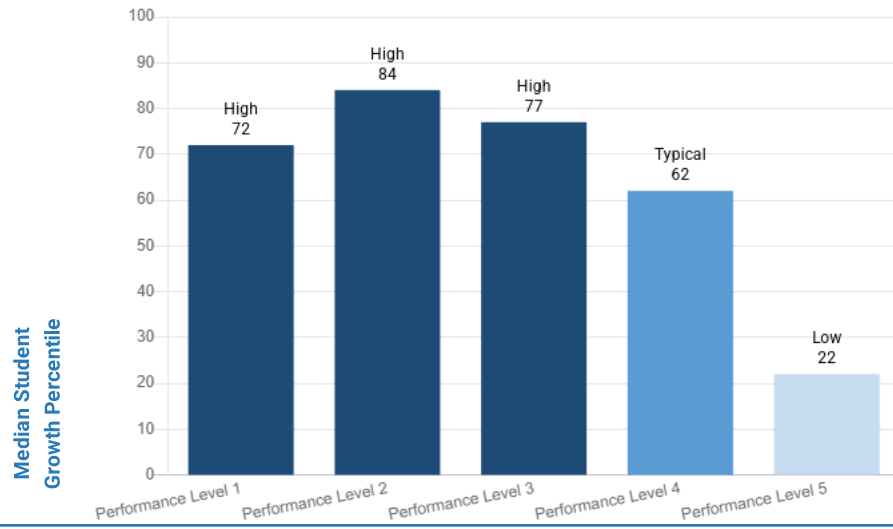

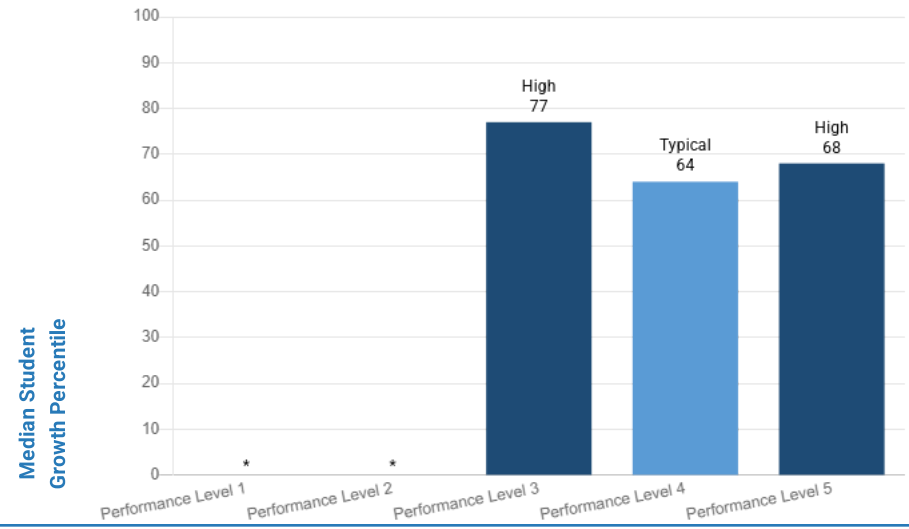

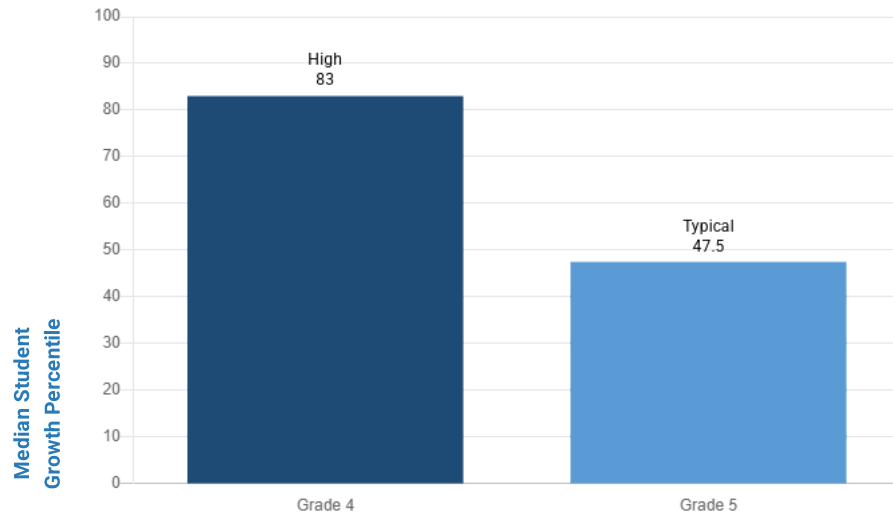

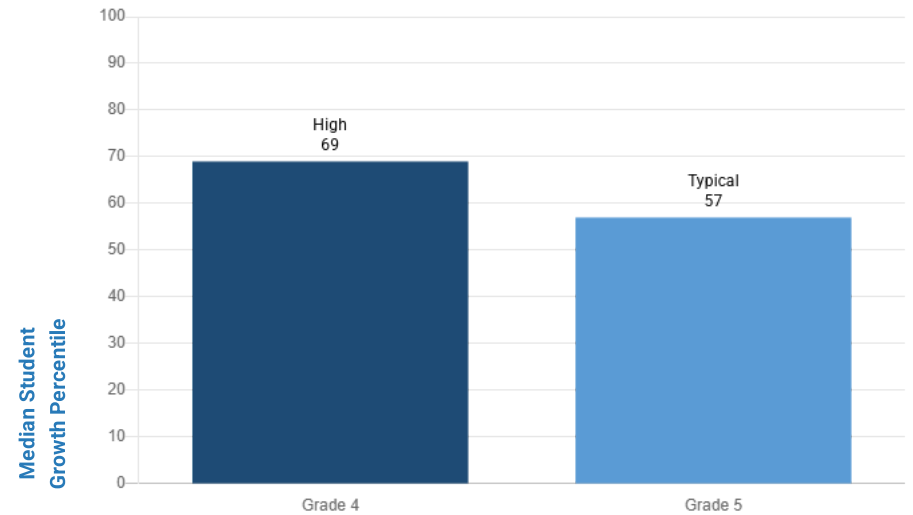

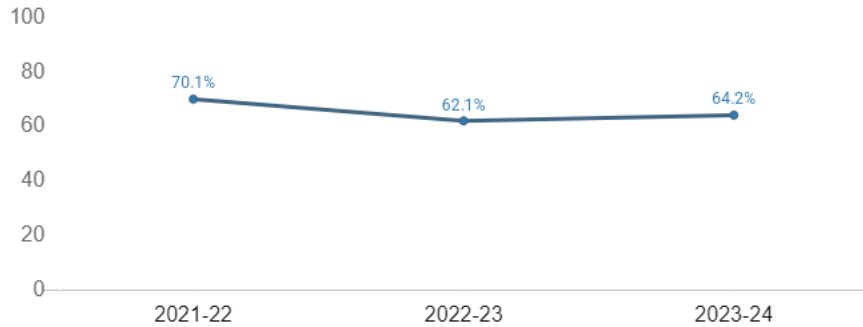

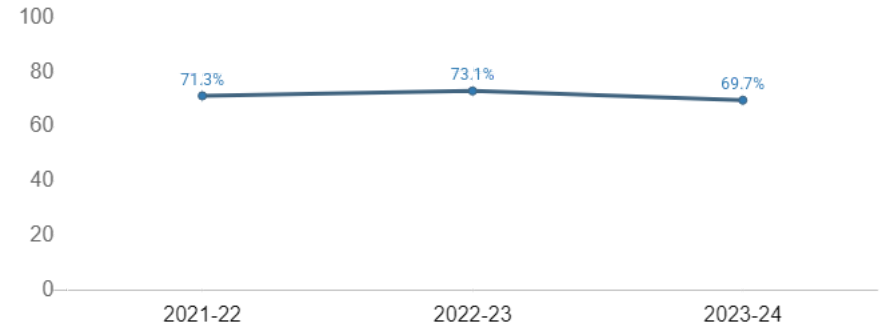
English Language Arts and Mathematics Performance Trends

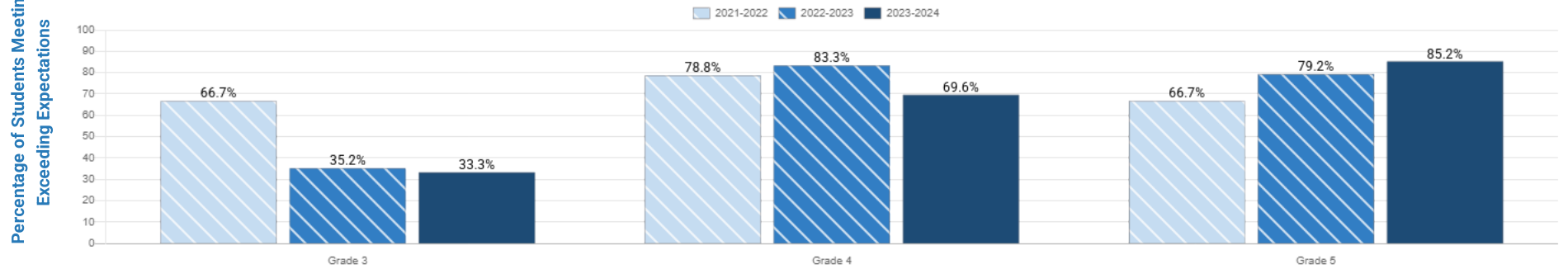

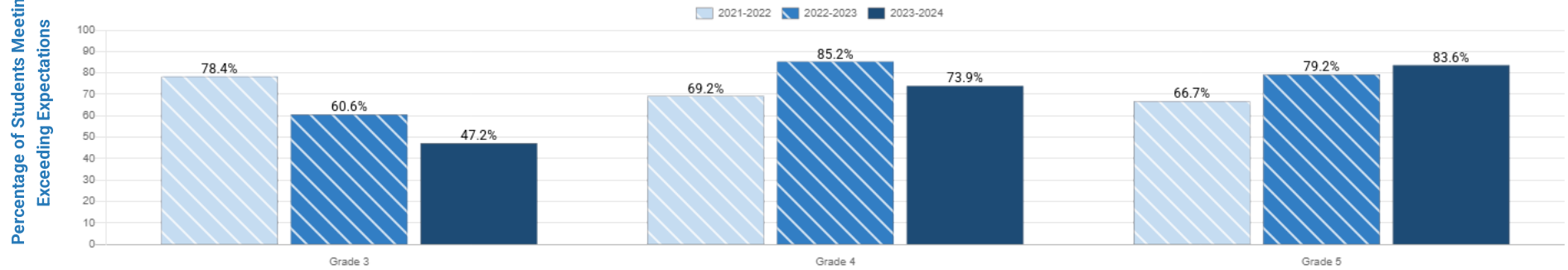

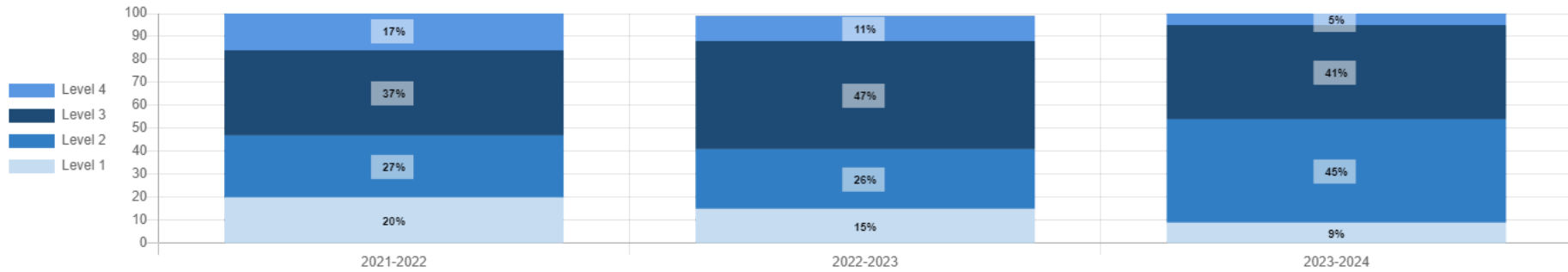

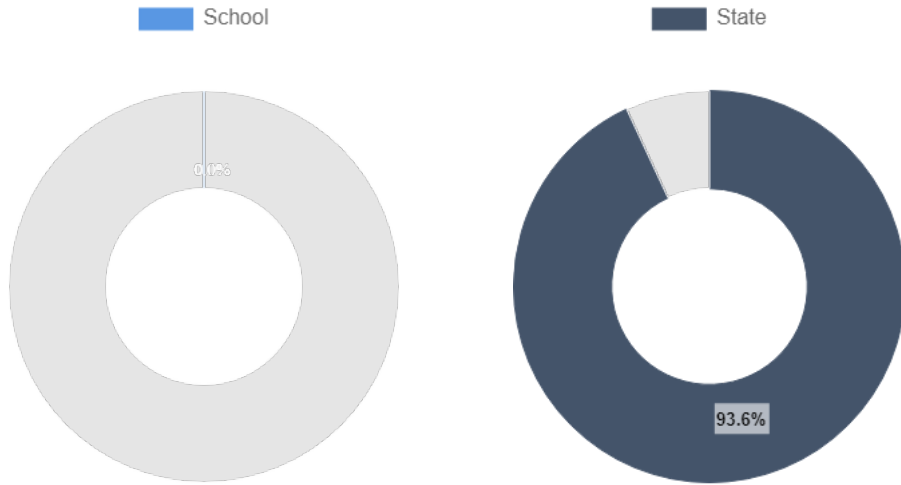

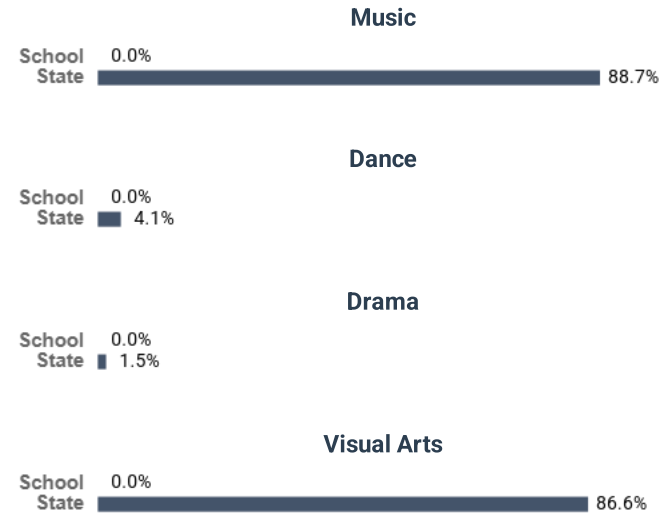

Students enrolled in one or more classes by discipline:



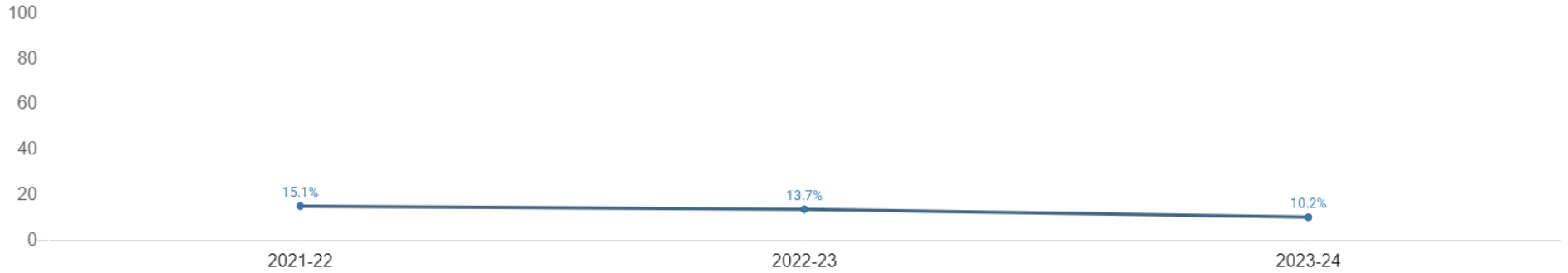

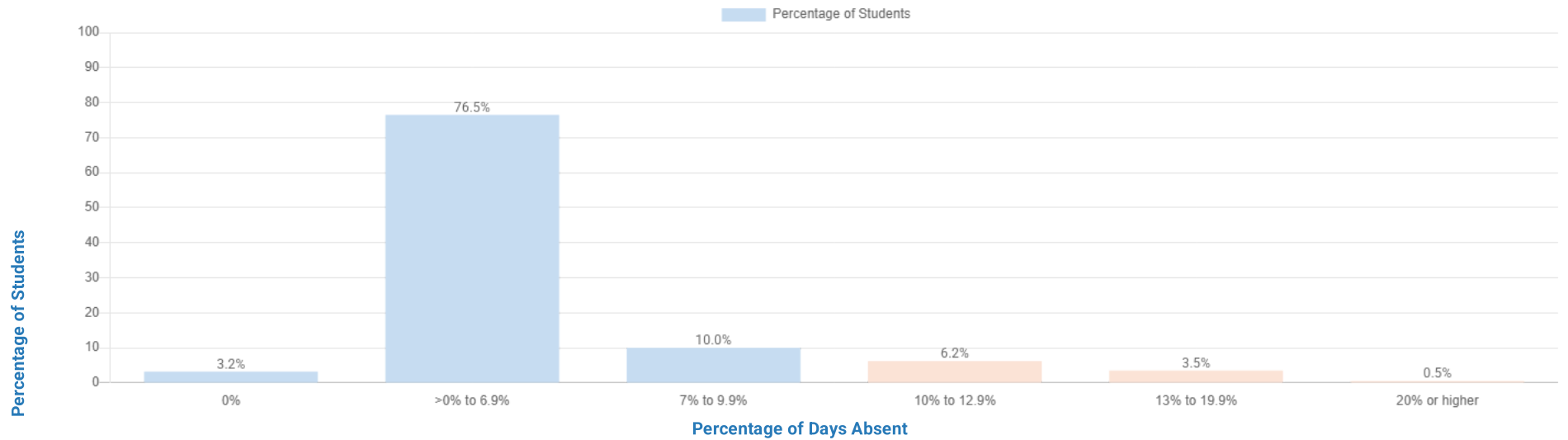

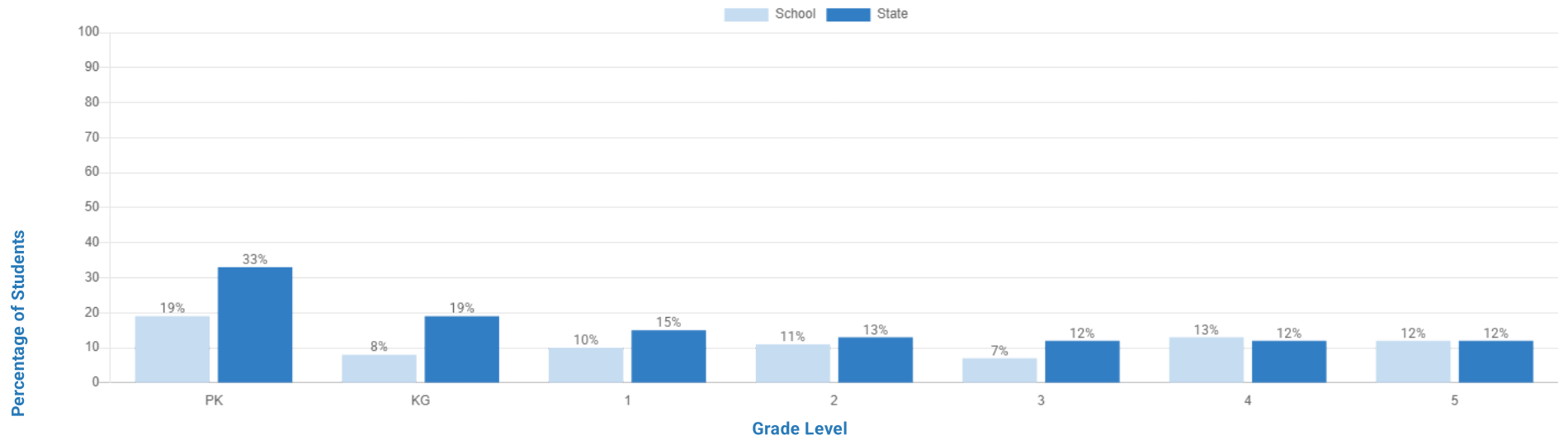

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

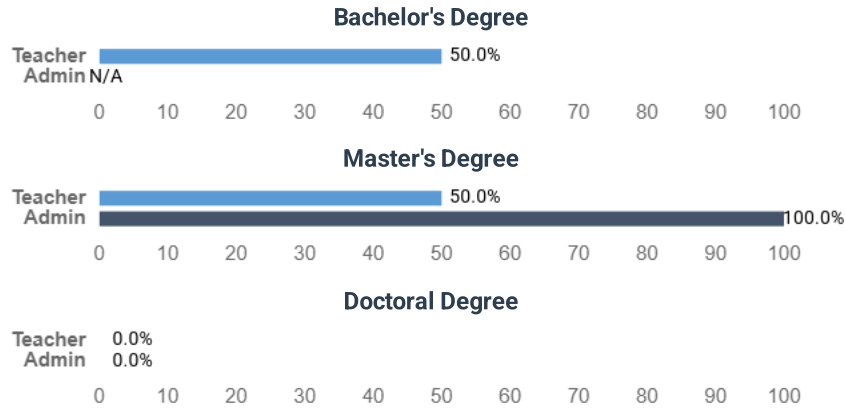

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Students in Medford begin exploring an array of technology very early in their school career. As early as Kindergarten, students use technology to investigate, hypothesize, collect and analyze data and extrapolate understandings to unknown scenarios. Students utilize individual devices throughout their learning environments through our 1:1 program which virtually tears down walls of our physical learning environments to bring a world of learning to each student. In Grades 1-6, every student engages in Engineering units that extends & supports lessons they learn in their Science Classrooms. A variety of engineering concepts are delivered through hands-on units that focus on the engineering design process and design thinking. In the "Fab" Labs, students utilize various robotic devices to understand algorithms, computer science and the foundational elements of coding. Coding and engineering exploratory classes are offered to middle school students in Grades 7-8.
