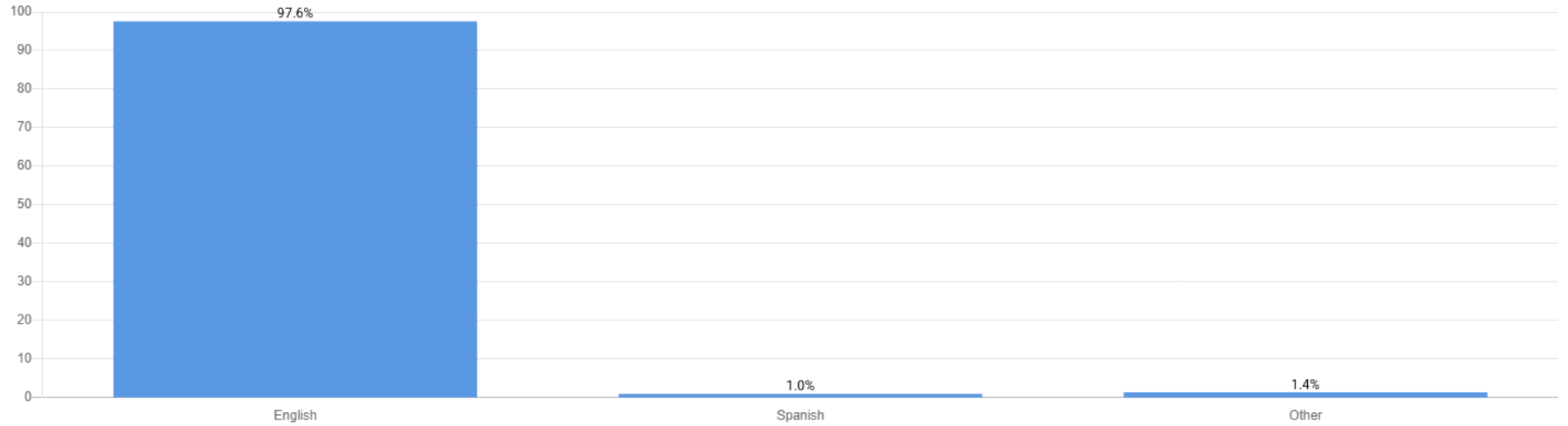

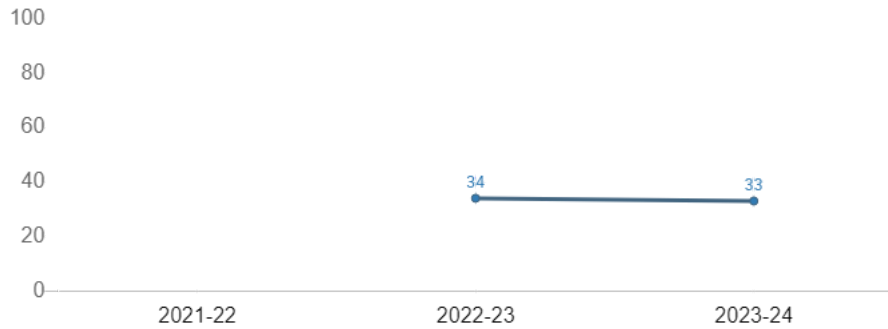

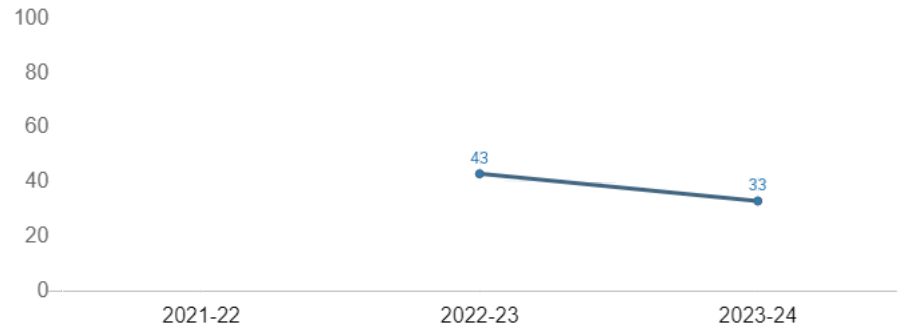

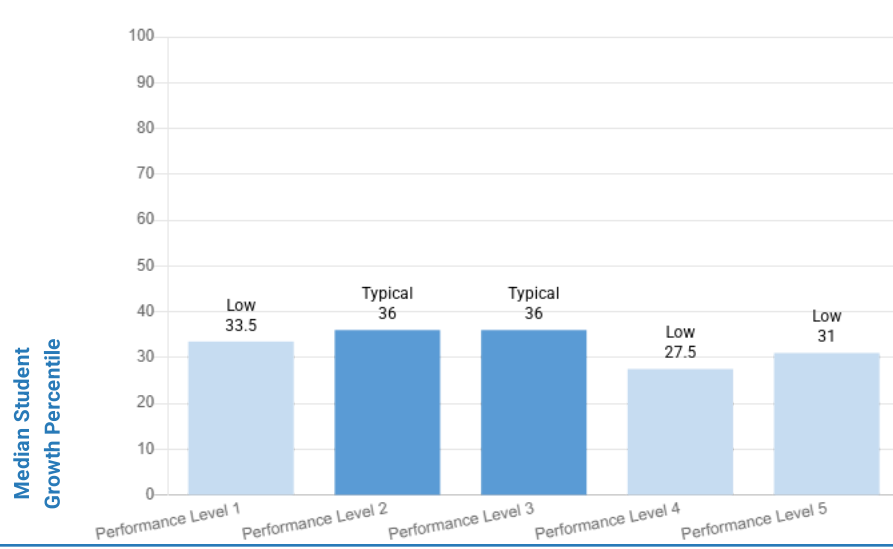

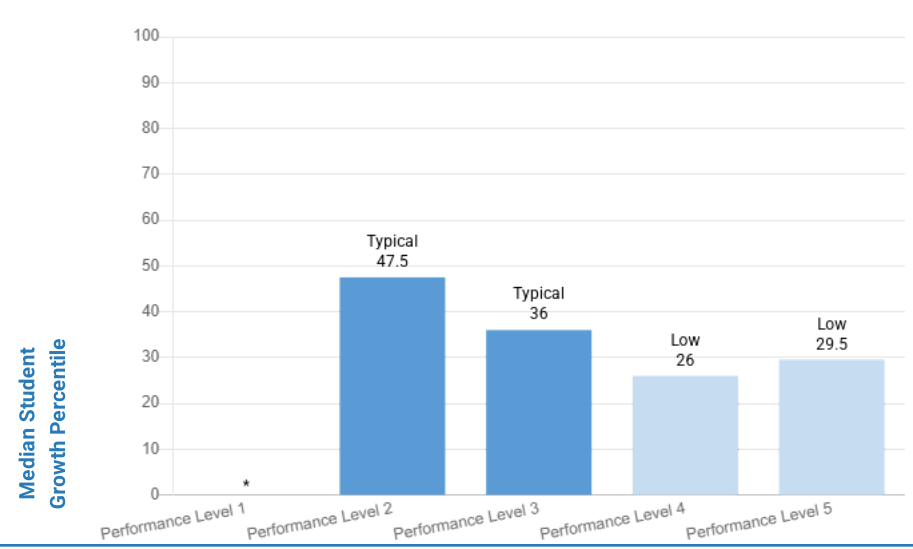

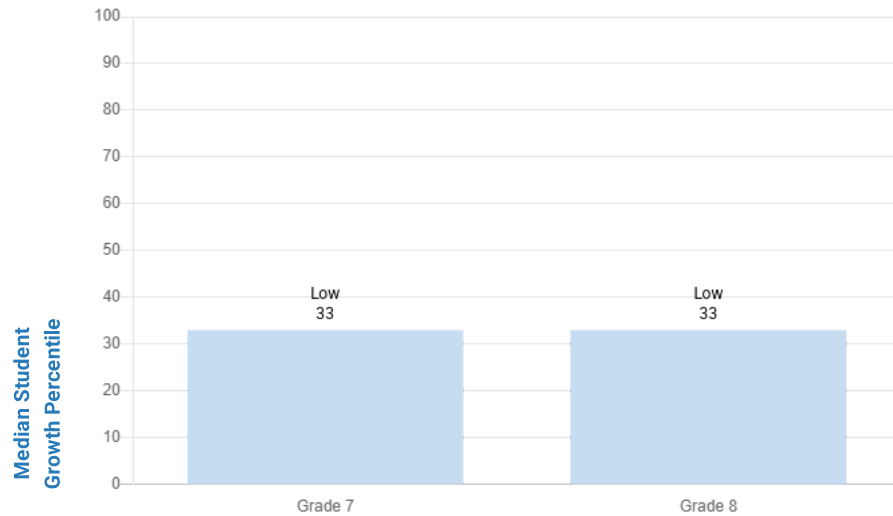

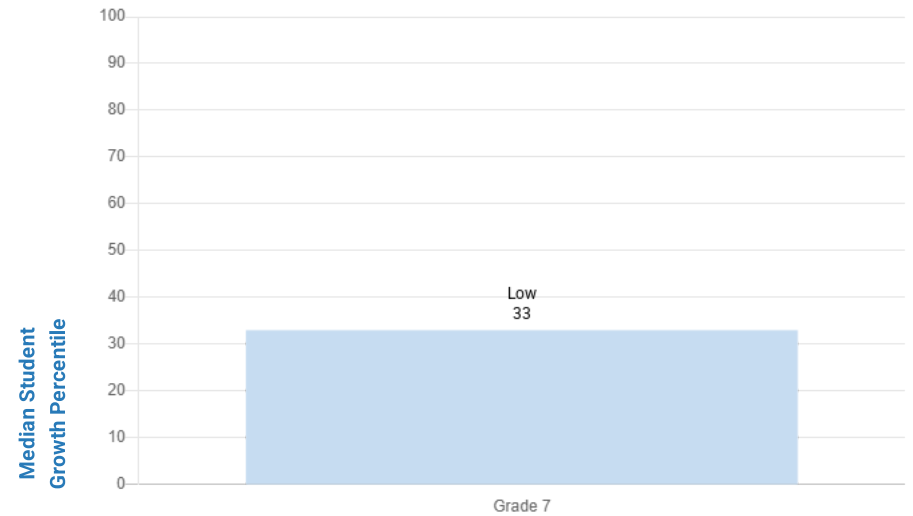

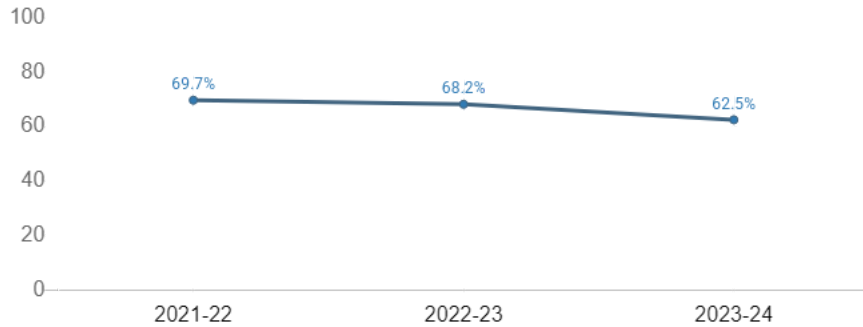

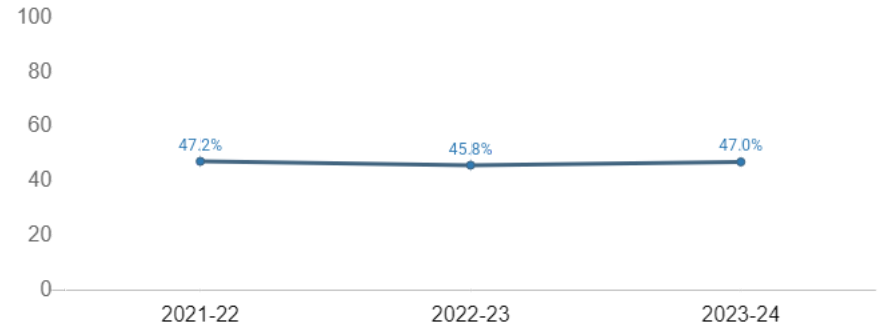
English Language Arts and Mathematics Performance Trends

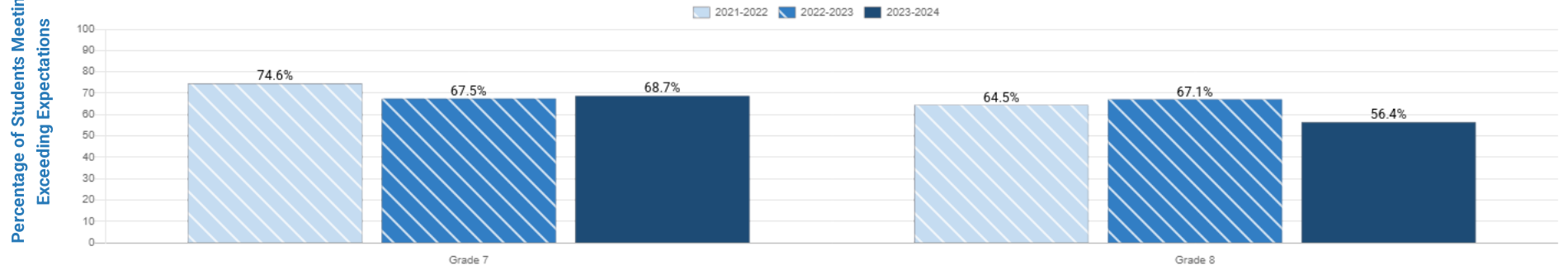

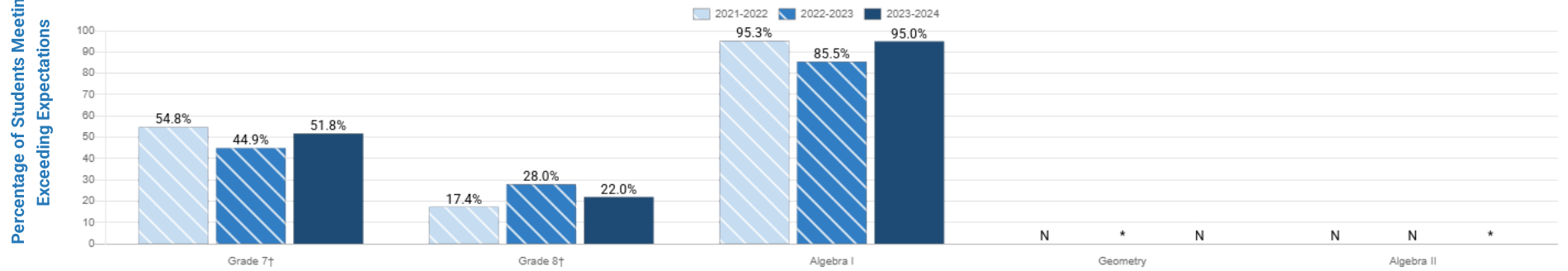

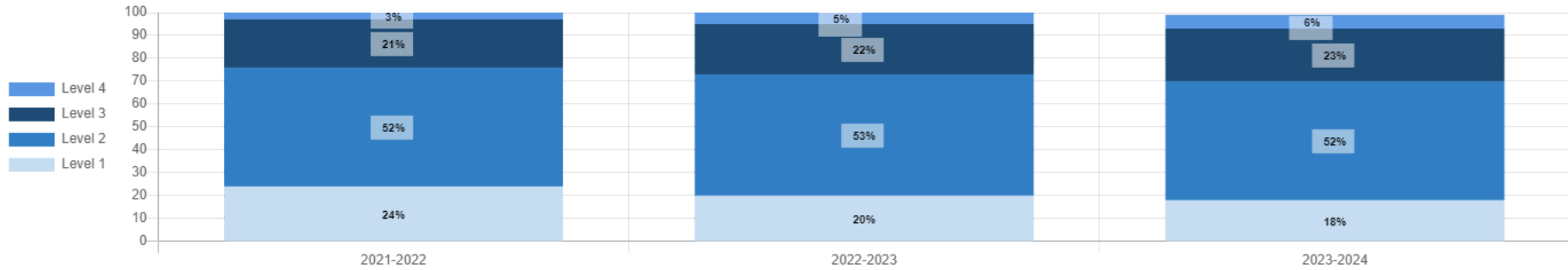

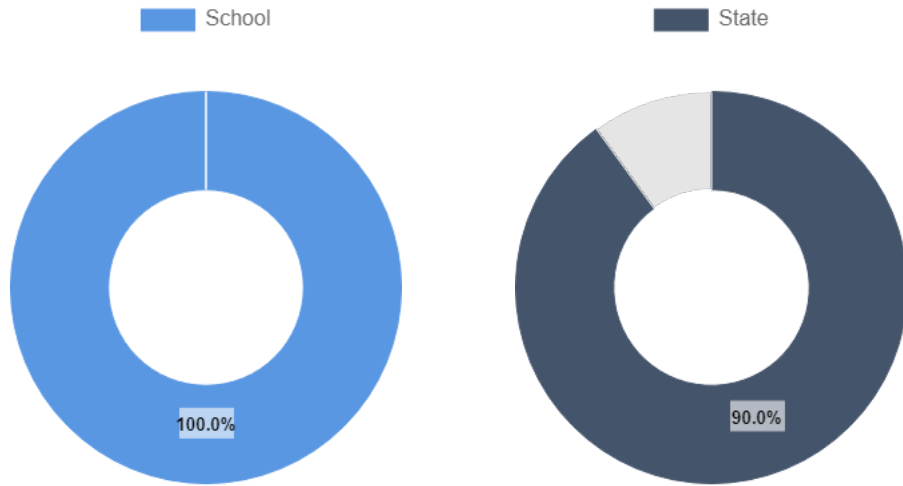

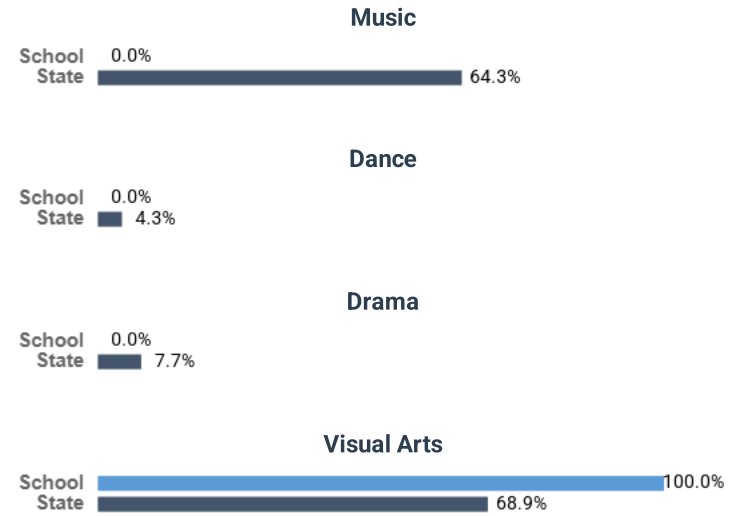

Students enrolled in one or more classes by discipline:



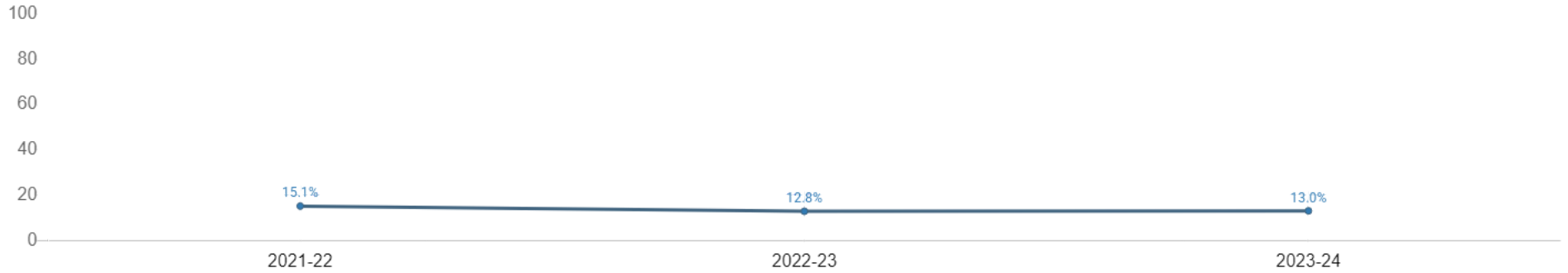

Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

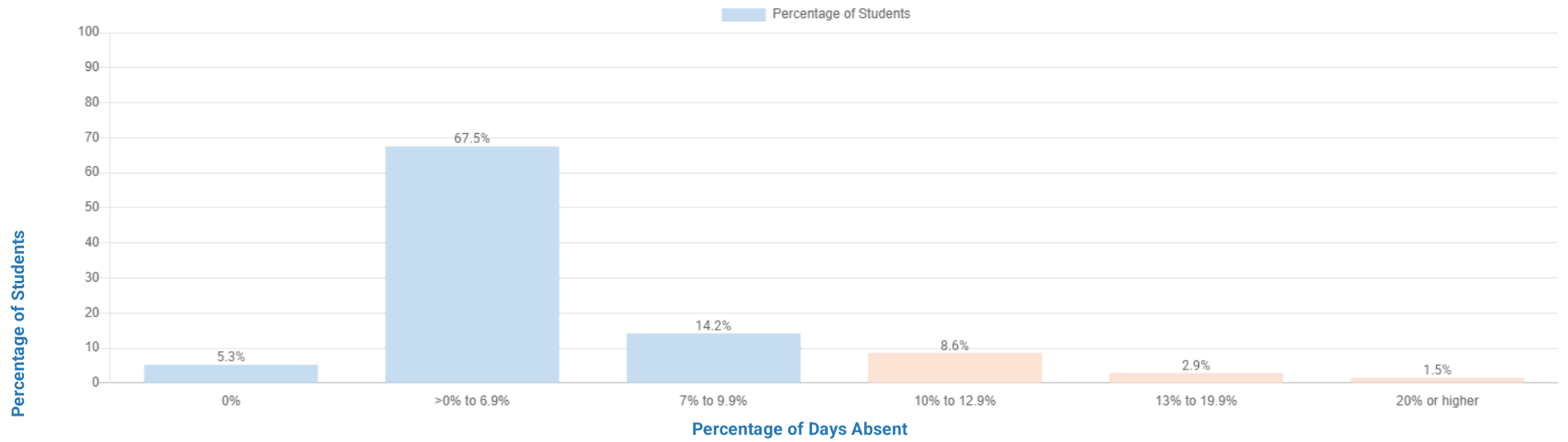

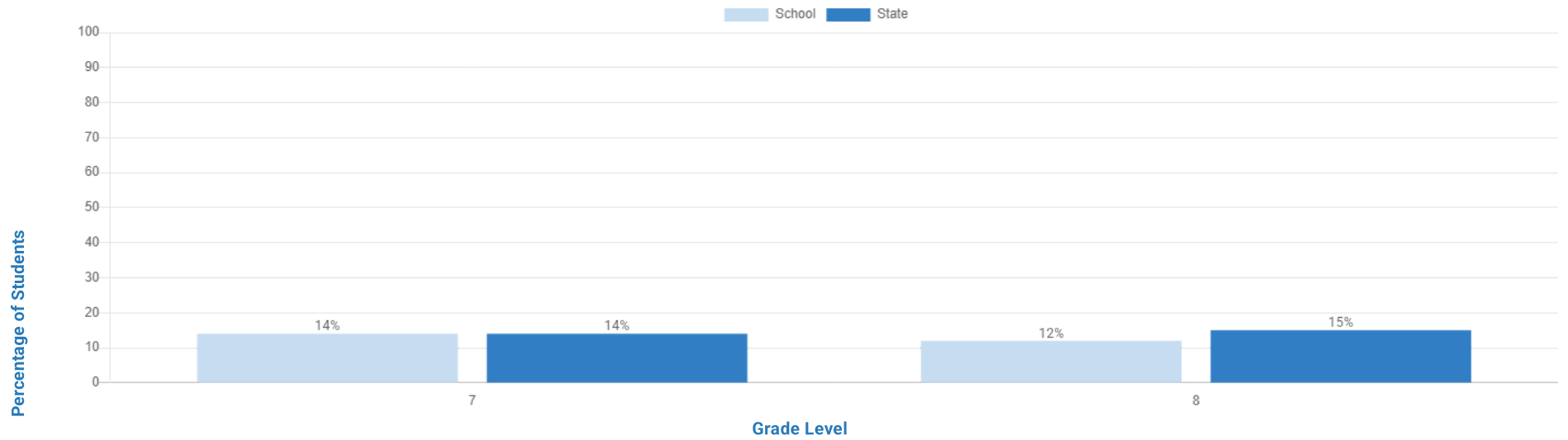

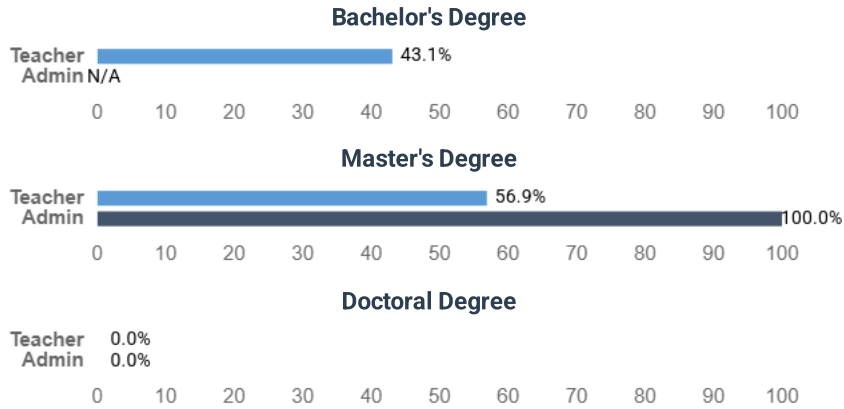

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Technology and STEM:

Students in Medford begin exploring an array of technology very early in their school career. As early as Kindergarten, students use technology to investigate, hypothesize, collect and analyze data and extrapolate understandings to unknown scenarios. Students utilize individual devices throughout their learning environments through our 1:1 program which virtually tears down walls of our physical learning environments to bring a world of learning to each student. In Grades 1-6, every student engages in Engineering units that extends & supports lessons they learn in their Science Classrooms. A variety of engineering concepts are delivered through hands-on units that focus on the engineering design process and design thinking. In the "Fab" Labs, students utilize various robotic devices to understand algorithms, computer science and the foundational elements of coding. Coding and engineering exploratory classes are offered to middle school students in Grades 7-8.
