









Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

All teachers at Palmyra High School have met the criteria for Highly Qualified Teacher. All faculty members are encouraged to develop and expand their knowledge through Professional Development in the form of course work, in-service training, and workshops. Palmyra High School teachers and staff continue to develop their knowledge and practice in areas of trauma-informed schools, Social Emotional Learning and support.



The Naviance program is used as a tool for compiling and sending off college applications, transcripts, and resumes. Two Financial Aid workshops are held each year. We also administer the PSAT and ASVAB Test to our students. Palmyra High School course offerings for 2022-2023 will include a College and Careers course that allows students to navigate the college selection, matching and application process. The course will also concentrate on assisting students' transitions to jobs in the trades, military, or workforce.



Student Supports and Services:

Palmyra offers ELL services and as a Child Study Team overseeing all Special Education Services. Among those services are Inclusion classes, Resource classes, and Basic Skills Instruction. In addition, we also have an RTI Team and tutoring services. Palmyra High School also supports an alternative learning program (Palmyra Learning Academy). 

PHS has a variety of Advanced Placement, Honors and College Prep courses and curricula have been revamped and updated. Virtual High School capacity provides additional course offerings at PHS. We participate in a College Accelerated Program so students can earn college credits while still in high school. Students can take accredited courses with Stockton University, Rowan College of Burlington County, and William Paterson University. Technology plays a vital role; we utilize brand new computer labs, iPads, Smart Board/Mimeo-Board technology, and Texas Instrument Nspire graphing calculators. "Class Initiatives" include a variety of community service events throughout the year. A major endeavor in the area of character development and positive recognition is our Renaissance program in which students and staff are recognized for their efforts/accomplishments. Finally, PHS continues to strive toward diversity, equity, and inclusion for all students by offering new courses in the English and Social Studies departments starting next year. Current course offerings include Diversity in History and Unrepresented Voices in Literature.
