
















English Language Arts and Mathematics Performance Trends









Students enrolled in one or more classes by discipline:











Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Pemberton Township Schools serves over 4,500 students from Pemberton Township, Pemberton Borough and Joint Base McGuire-Dix-Lakehurst. Marcus Newcomb Middle School serves approximately 325 6th grade students. Newcomb's theme is "Unlock Your Potential with Newcomb's Keys to Success." Our theme addresses the importance of Newcomb's core values in all aspects of student learning and student life. We have implemented both character education and social emotional components in our vision to connect students and staff to everyday learning while also building positive relationships and promoting empathy through monthly school-wide service learning initiatives.

This is balanced by a variety of electives and enrichment courses including coding, Spanish, art, music, band, and chorus. In addition, we offer intervention for students who are not meeting proficiency in math and language arts as well as enrichment for students who exceed proficiency in math, language arts, and science. We also offer academic support in the context of after school tutoring.



Sports and Athletics:

Our boys' soccer, girls' soccer, cross-country and field hockey teams played very competitive games within the South Jersey Middle School League. Winter sports include boys' and girls' basketball, cheerleading, and wrestling. Spring sports include baseball, softball, and track and field.
