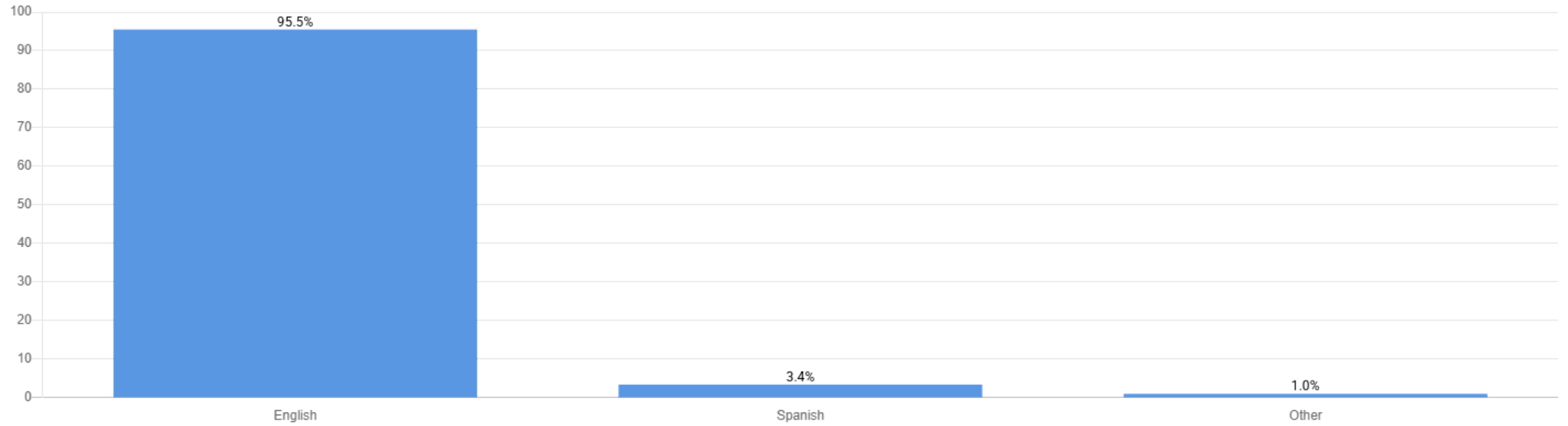

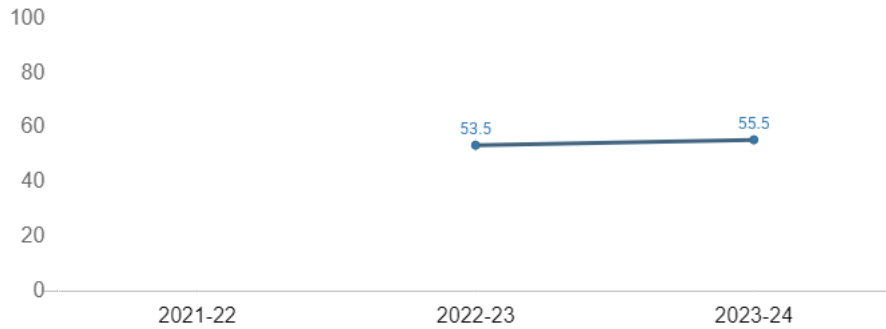

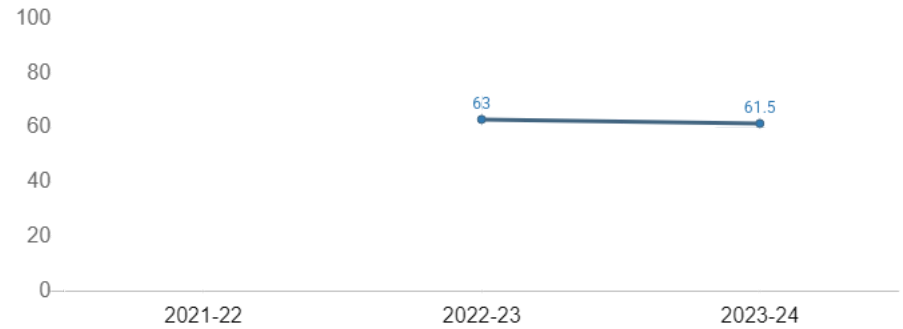

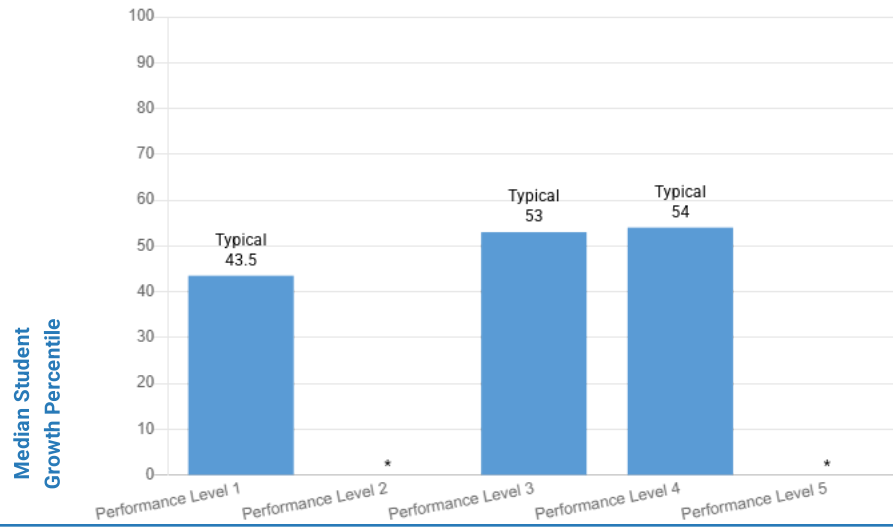

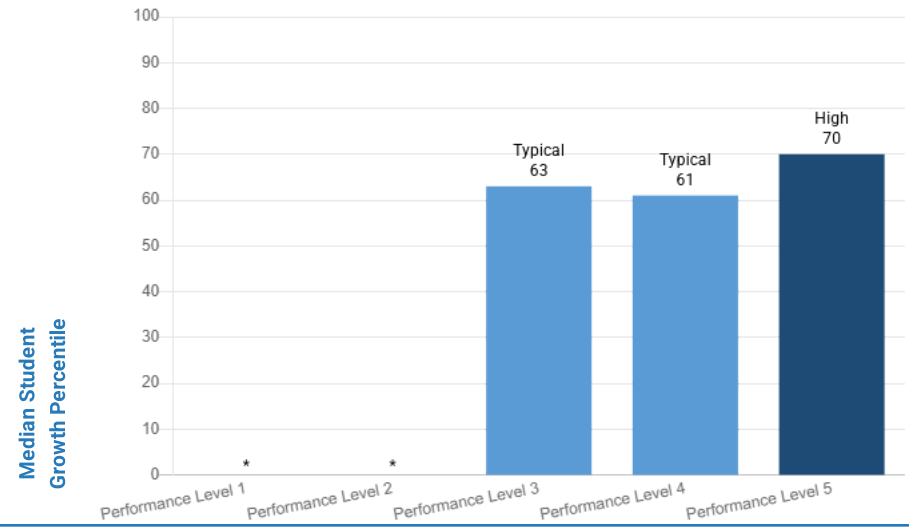

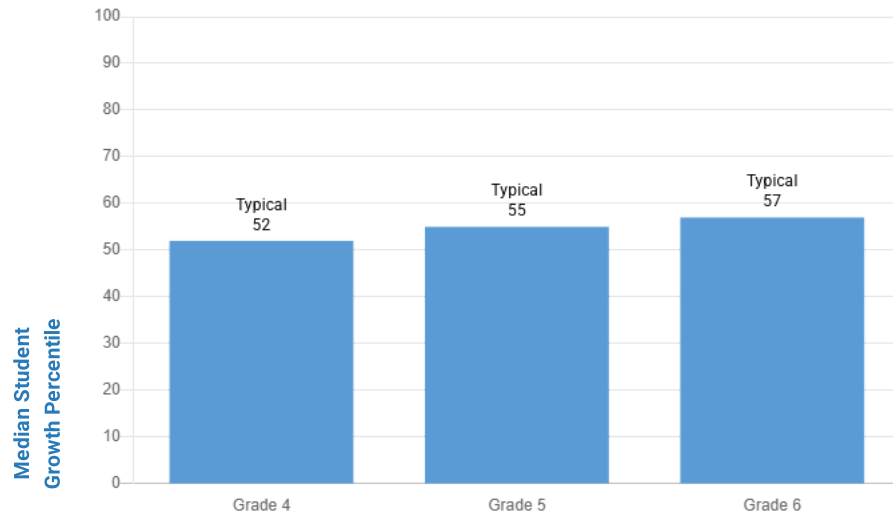

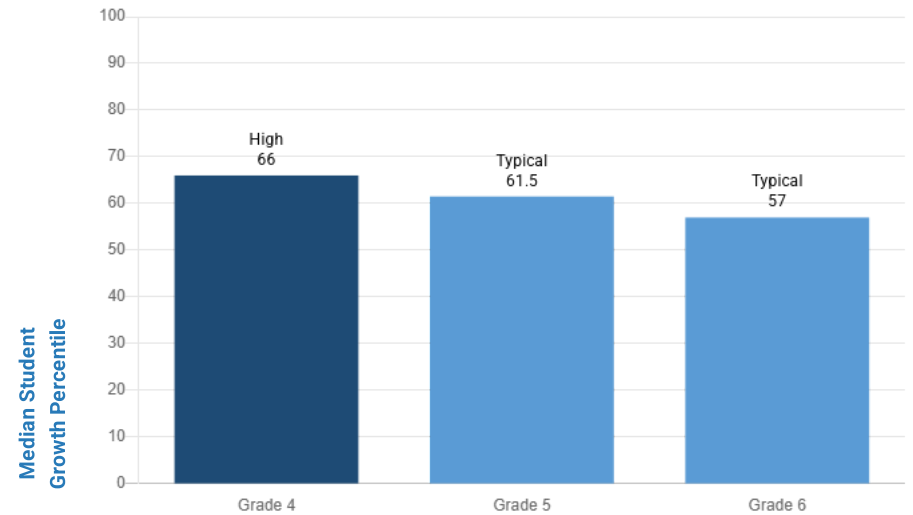

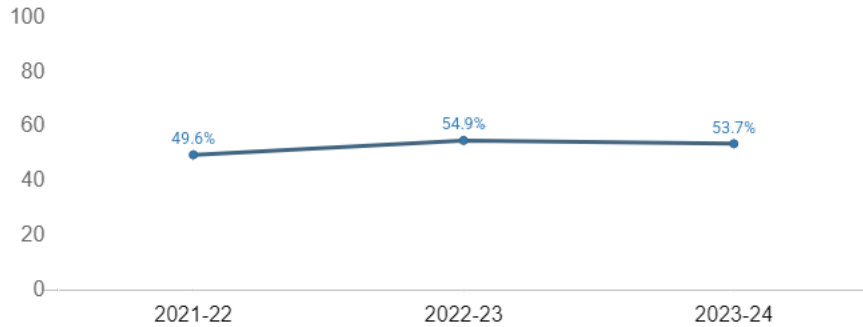

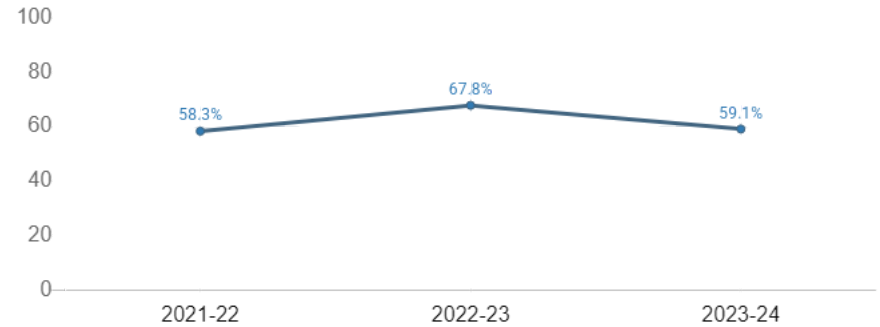
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

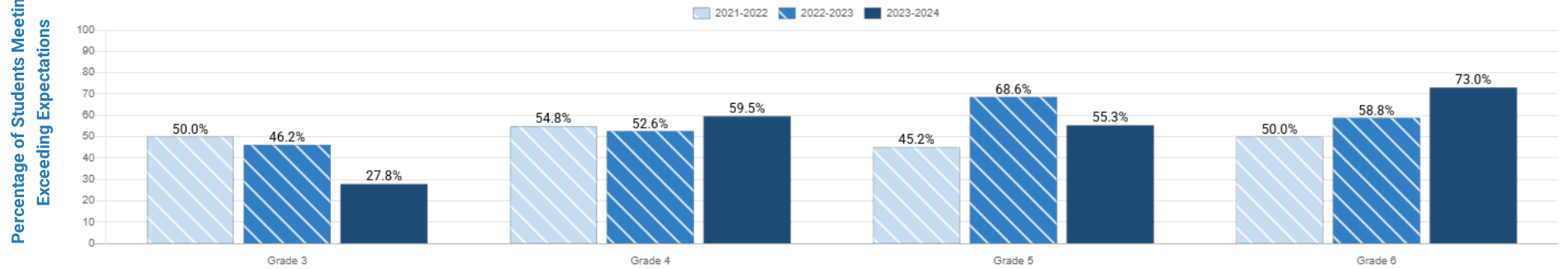

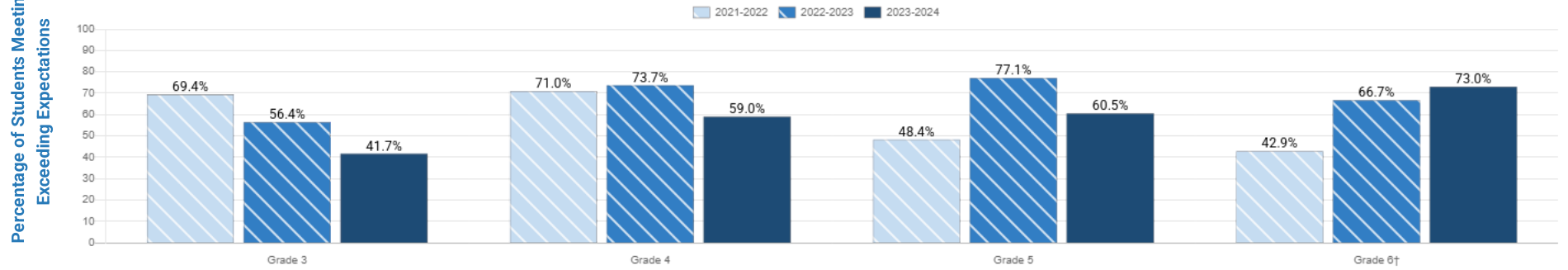

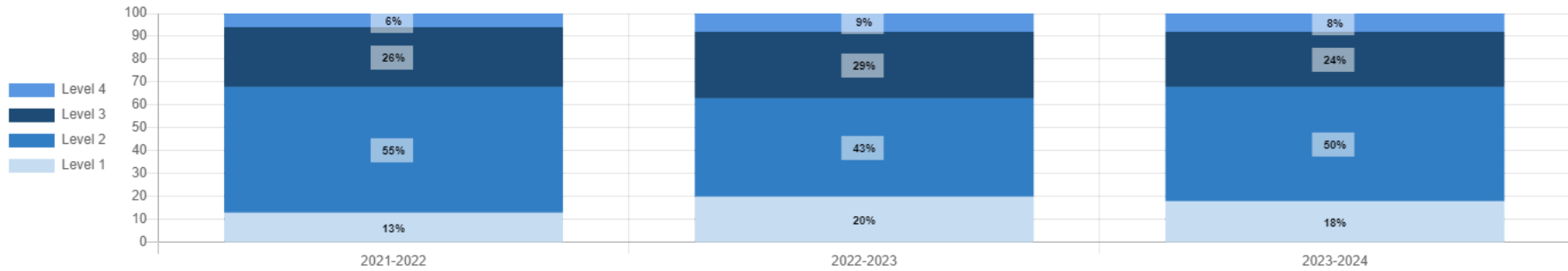

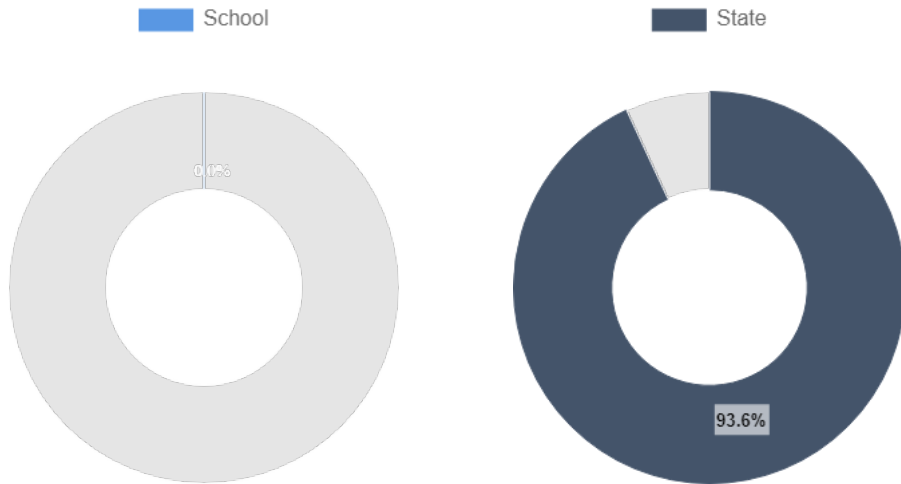

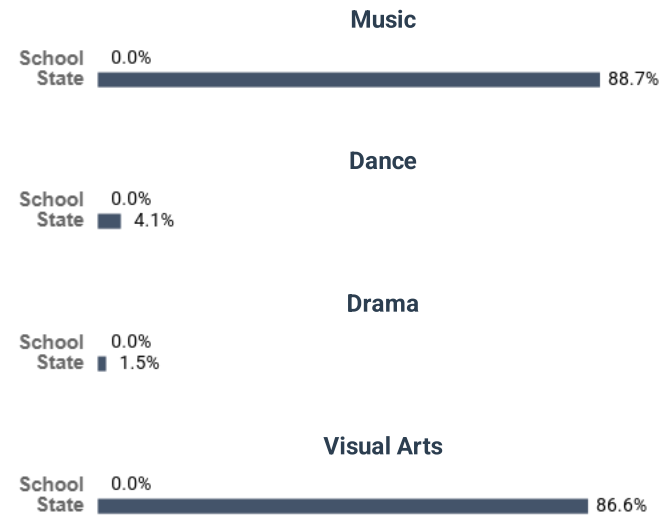

**Students enrolled in one or more classes by discipline:**



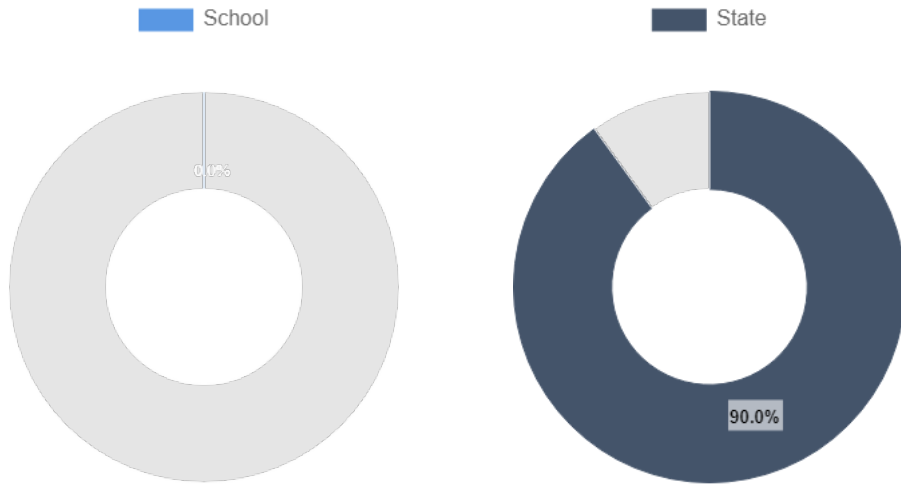

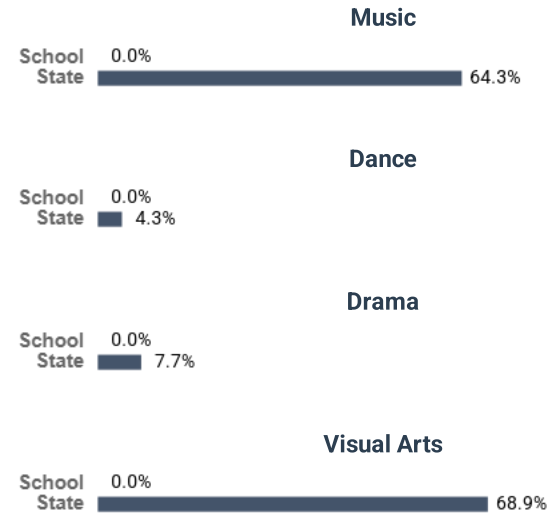

**Students enrolled in one or more classes by discipline:**



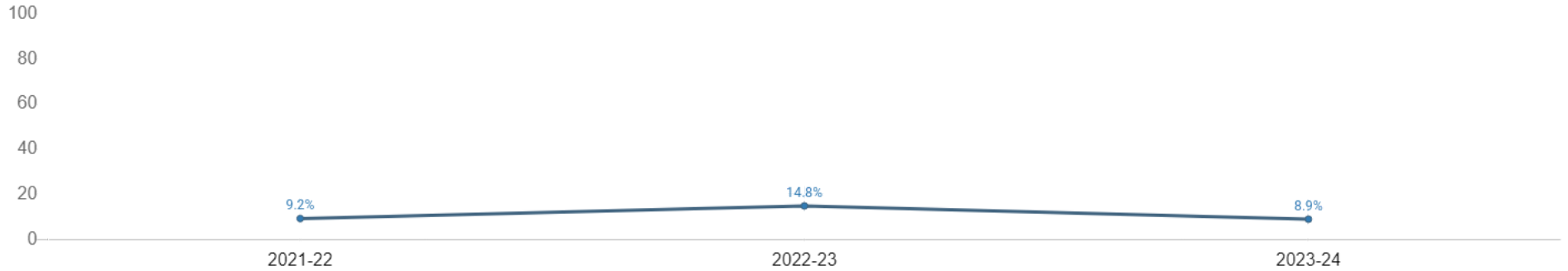
## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

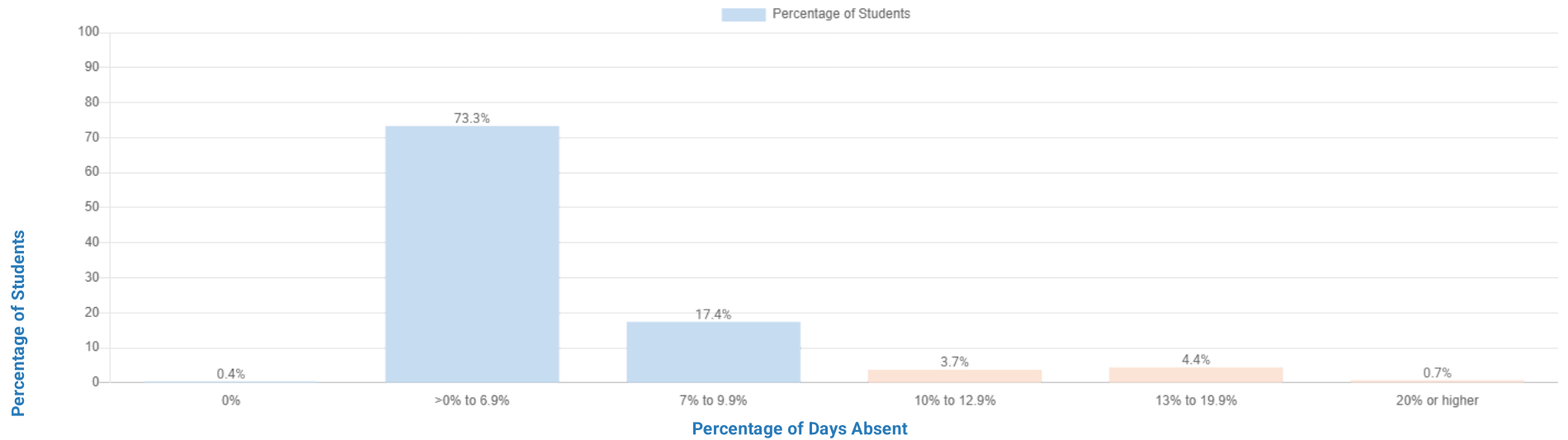

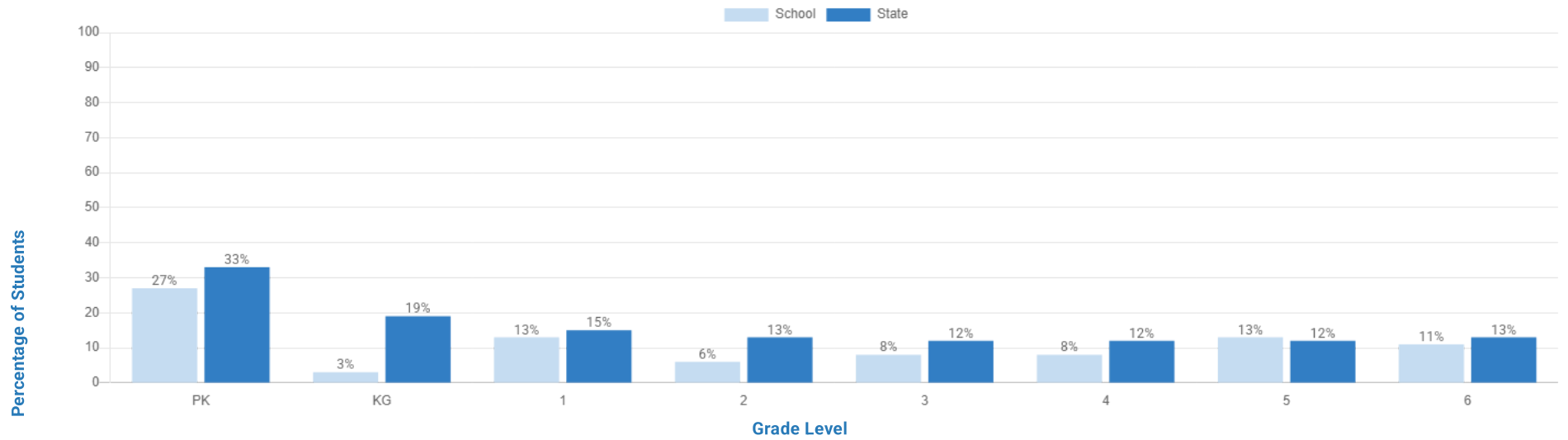

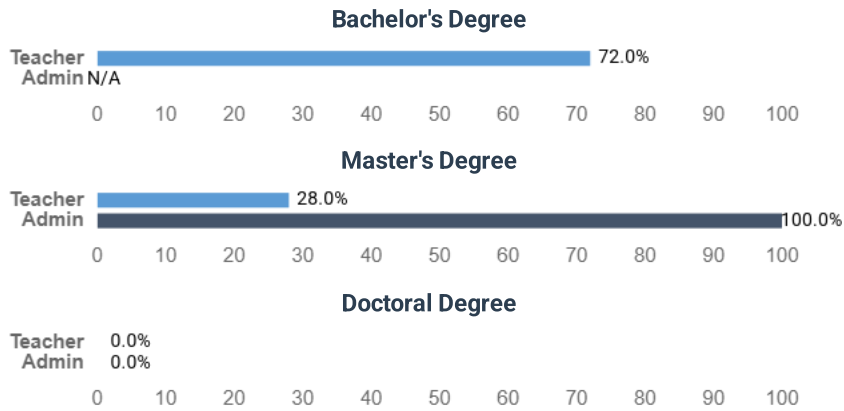

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. - As a single school district, Springfield embodies a sense of "school community." The BOE prioritizes student achievement and is committed to promoting a safe and positive learning environment.
- The BOE, administration, and staff strive to provide a comprehensive educational program which will prepare students both academically and socially to become successful and responsible citizens.
- The faculty & staff of Springfield are creative, innovative & attentive to the needs of the students. Their concern for the well-being of each child is central to the successes of the school district.



The Springfield Township School District is committed to collaborating with the local, county, and state Boards of Education, staff, students, parents, and community in the goal of creating a caring and positive environment that encourages each student to develop his or her potential in academic, physical, social, emotional, cultural, and moral aspects.



A five-year curriculum matrix is used by the district to review and modify the curricula. Content area curricula is designed to address the New Jersey Student Learning Standards, be challenging to the students, and reflect the best available thinking in the field of education. Recent curriculum and instruction initiatives have resulted in the implementation of a workshop model for reading, writing, and mathematics instruction, advances in instruction aligned with the NJ Student Learning Standards for Science, and enrichment opportunities aligned with visual and performing arts.

### Before and After School Programs:

Thanks to the support of our Home & School Association, we are able to offer after-school clubs for all students during three time periods each year. These clubs cover a broad array of offerings including indoor and outdoor athletic games, archery, arts & crafts, technology, visual & performing arts, and STEM activities.



### Staff and Professional Learning:

The Board of Education supports a robust professional development program for staff. This includes five full-day inservices each year, a master schedule that provides bi-weekly Professional Learning Community meetings, and graduate coursework tuition reimbursement available through a negotiated agreement clause.



### Student Supports and Services:

The district provides a multi-tiered system of supports for students in the areas of academics, behavior management, and social-emotional wellness. An Intervention & Referral Services team exists to provide academic support to students exhibiting difficulties in a specific content area or experiencing behavioral concerns. A Basic Skills Improvement Program is in place to provide remediation in the areas of reading, writing, and mathematics through both in-class support and small group instruction. A universal social-emotional learning program provides daily instruction for all students, with Tier 2 and Tier 3 services provided to students in need of additional supports. A contracted behavioral consultant works closely with students and staff to monitor and respond to student behavior concerns through a system focused on positive behavior supports.

Through both teacher completed screeners and student self-screeners, students identified in need of Tier 2 and Tier 3 supports are provided additional services on an individual and small group basis.

Our school benefits tremendously from the support of an active Home & School Association. Through fundraising and outreach efforts, the Home & School Association provides financial support in a variety of ways including funding offsets for class trips, student assemblies, and school dances. In addition, the Home & School Association sponsors several family events throughout the year including a Breakfast with Santa event, parent-child dances, and a spring carnival.

### Facilities:

Springfield Elementary School consists of the original building constructed in 1939 with additions built in 1957, 1964, and 1993. A gymnasium, constructed entirely through community fundraising, was added in 1973. Most recently, a construction referendum allowed for upgrades including HVAC, a replacement of the original slate roof on the 1939 portion of the building, security upgrades, and select window replacement.



### School Safety:

The school is the center of community activity and the quality of education is vitally important to the entire community. Located across the street from the Springfield Township Police Department's headquarters, our school district's safety and a secure environment are enhanced by the routine presence of our local police. Their presence, along with powerful school-based programs focused on character education and the maintenance of a respectful environment, ensure that Springfield Elementary is a safe, welcoming, and nurturing school where all students can thrive.



### Technology and STEM:

Preparing our students for succeeding in an increasingly technology oriented society is a priority of the school district. This is evidenced by interactive Smart Boards in every classroom to supplement instruction and a 1:1 technology initiative that provides iPads to all students in Kindergarten and grade 1 and Chromebooks to all students in grades 2 - 6. Our district also provides weekly technology instruction for all students as well as opportunities for all students to participate in our Creator Lab program which focuses on elements of STEAM instruction. Recently the school has implemented a Studio Productions course for students in grades 5 & 6, allowing these students to learn multiple aspects of video recording including pre-production (writing, set design, etc.), filming, editing, and uploading for viewing.

### Early Childhood Education:

Springfield Elementary School provides an integrated preschool program for 3-year-old and 4-year-old students. This program focuses on the Tools of the Mind Curriculum, a research-based early childhood model designed to help children develop the cognitive, social-emotional, self-regulatory, and foundational academic skills they need to succeed in school and beyond. Students in both the 3 and 4-year-old programs benefit from exposure to related arts programming as well, with weekly visits to our music, art, technology, and PE programs.



### Attendance:

The district has provided continued support to students and families through the use of Elementary and Secondary School Emergency Relief (ESSER) funding. Through ESSER funds the district implemented a new diagnostic evaluation and remediation program (iReady) and has provided significant opportunities to address learning loss through remediation programs such as Renaissance Learning and increased personnel in our Basic Skills Improvement Program (BSIP). We've also addressed the social-emotional needs of our students through a universal program - HeyKiddo - which has provided daily lessons aligned with the CASEL framework for social and emotional competence.
