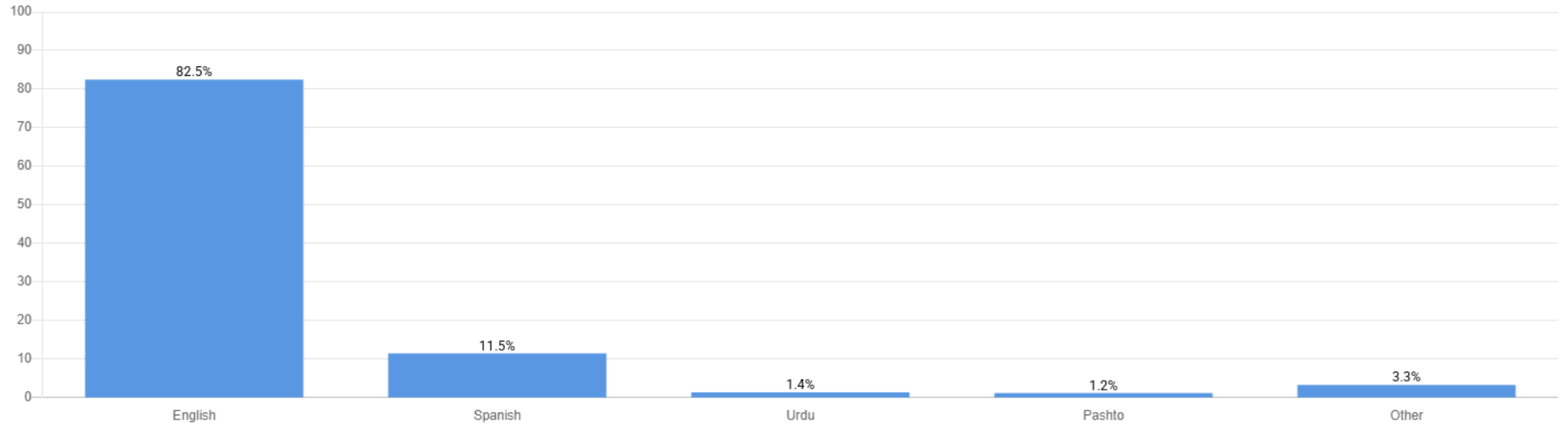

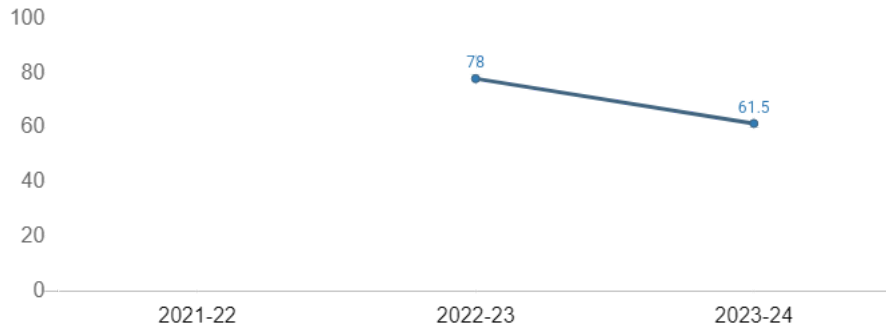

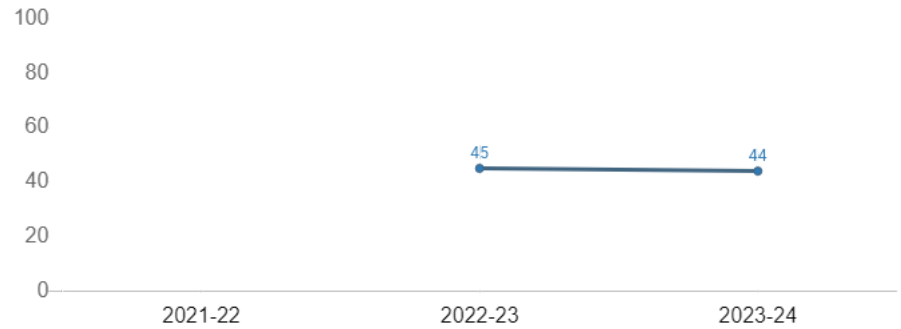

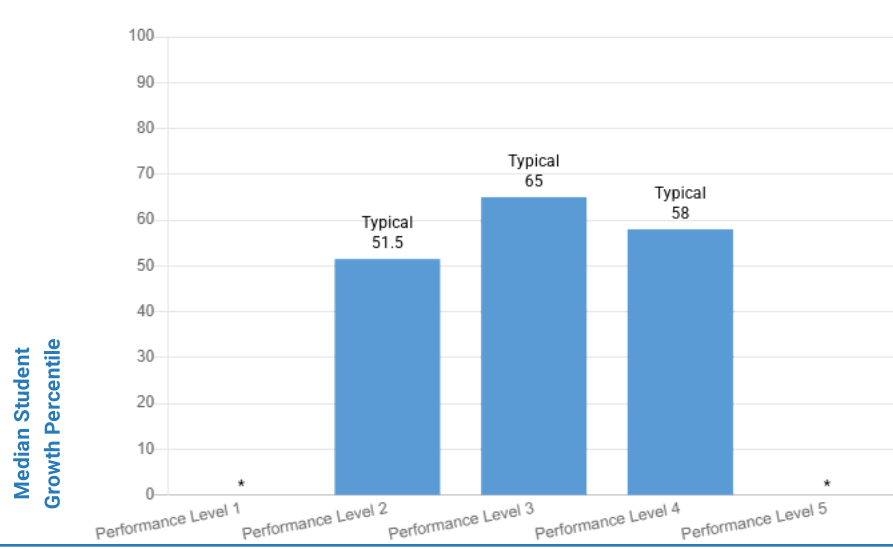

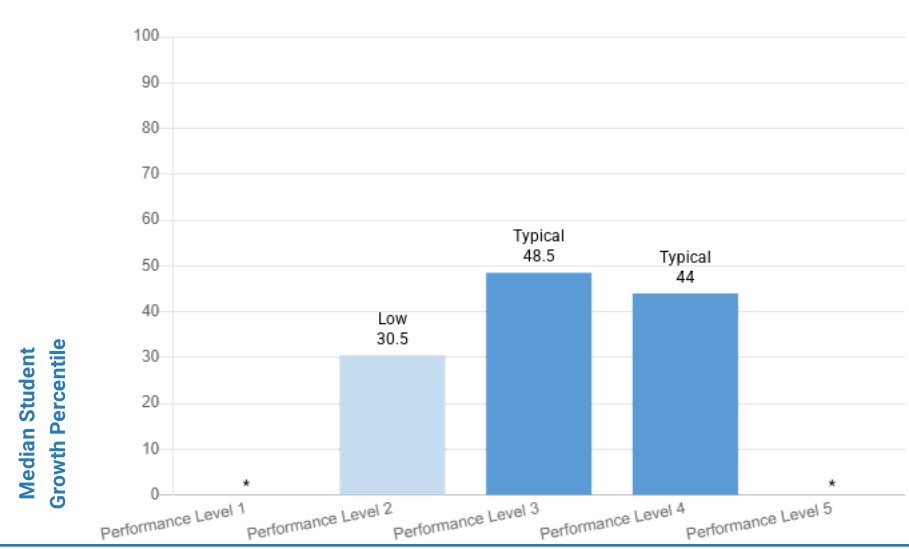

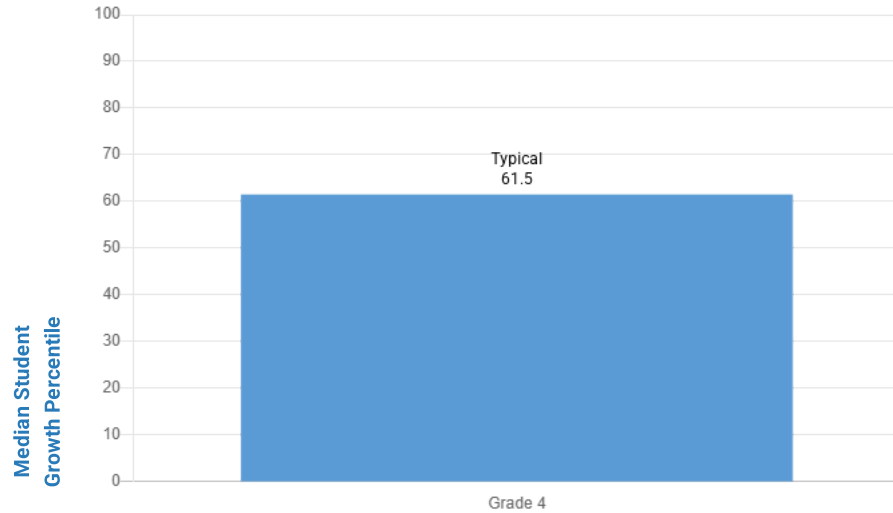

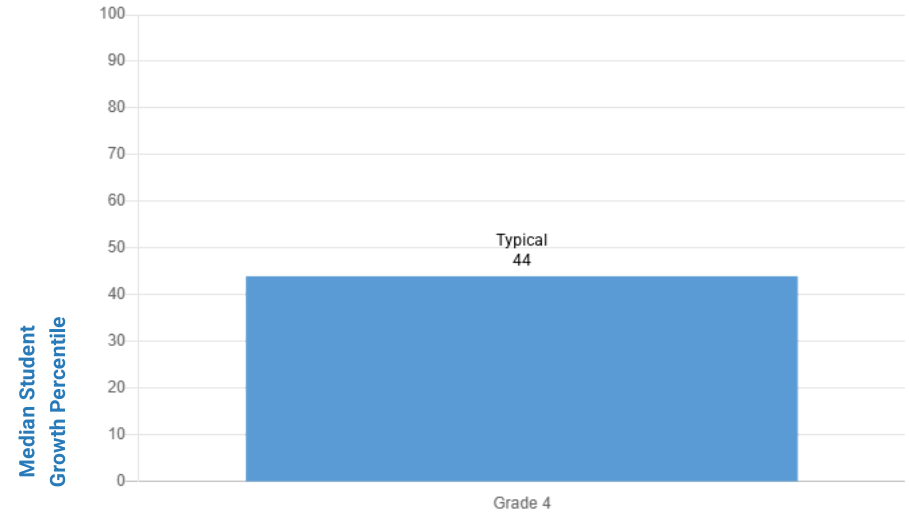

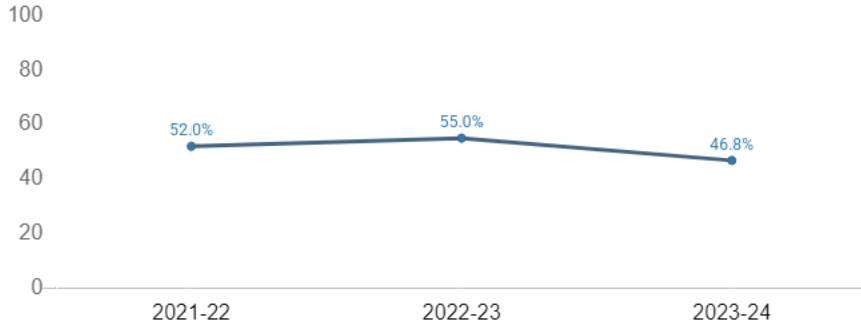

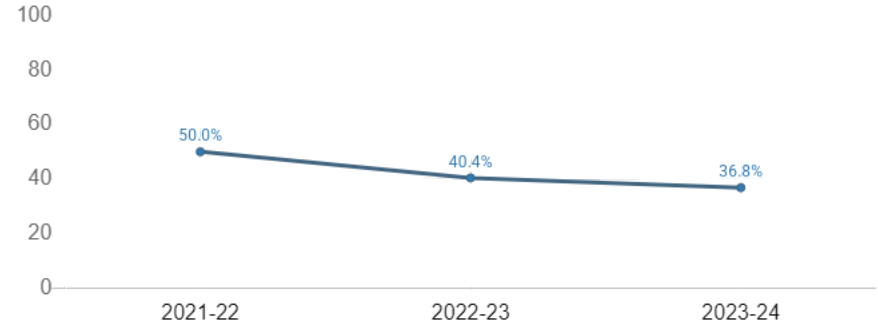
English Language Arts and Mathematics Performance Trends

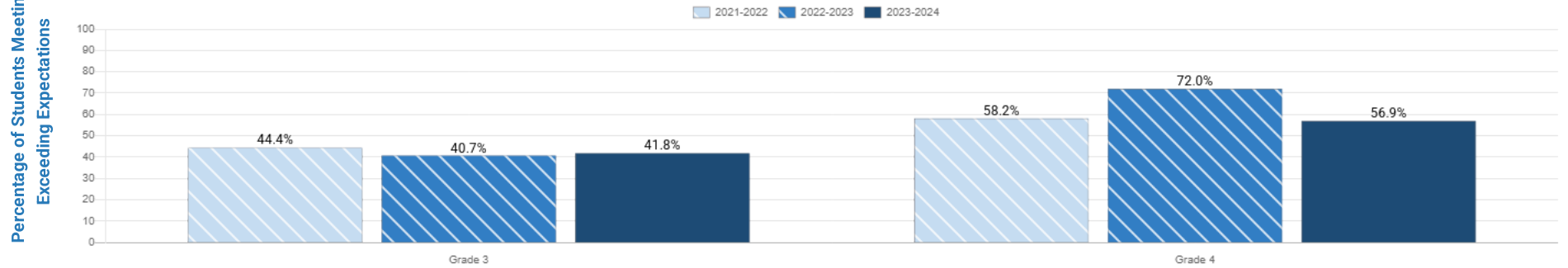

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 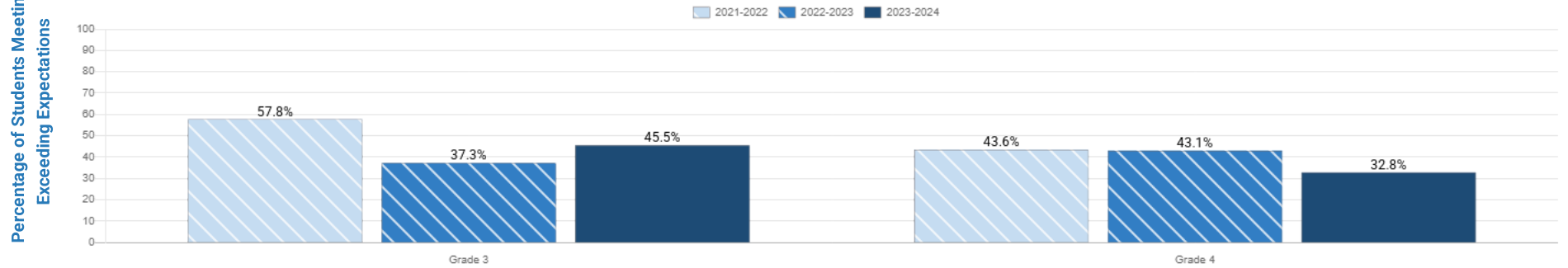

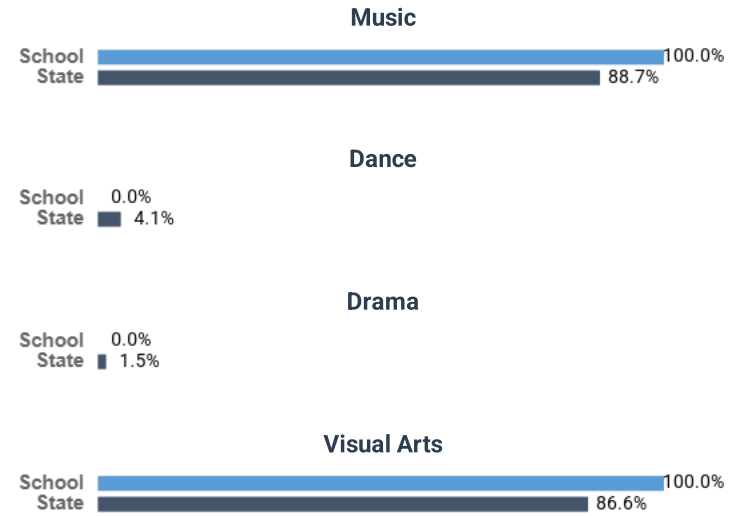

Students enrolled in one or more classes by discipline:



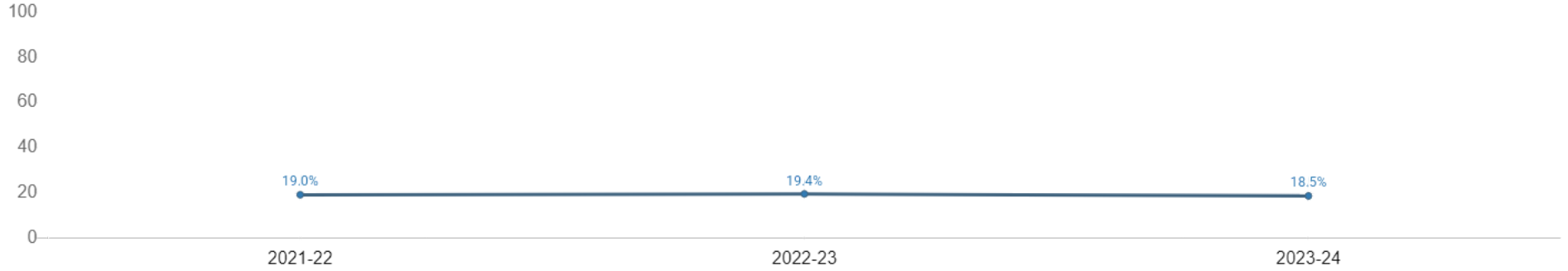

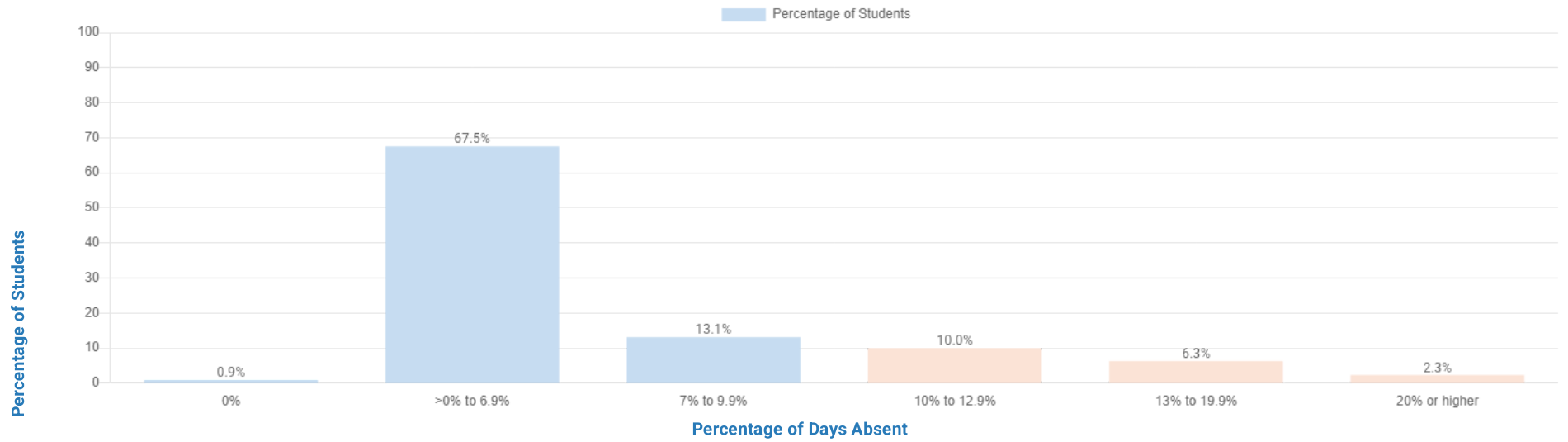

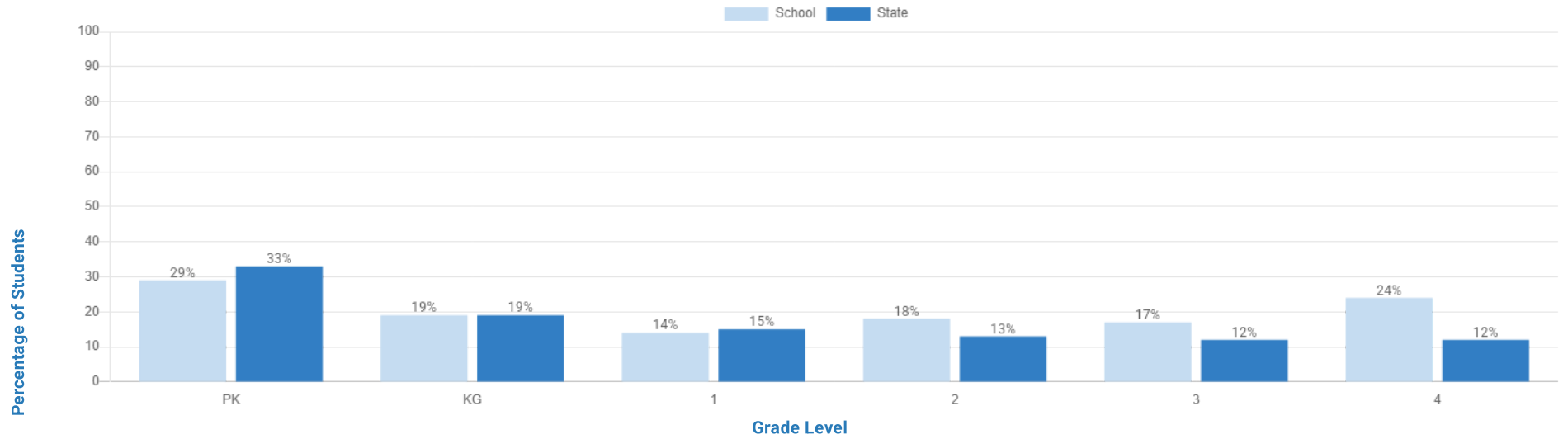

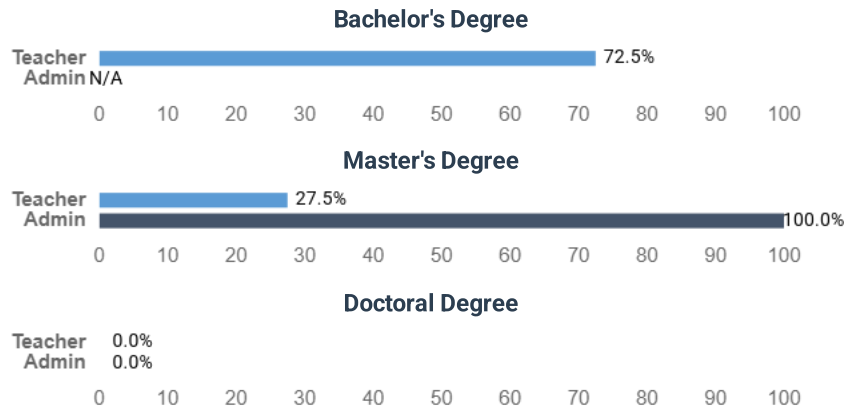

Courses, Curriculum, Instruction:

We provide a wide range of opportunities for Pre-K - 4th Grade students, focusing on building a strong academic & social foundation. Our programs are thoughtfully aligned with the New Jersey Student Learning Standards, ensuring that students receive the latest research-based, data-driven instruction. Our ELA curriculum emphasizes structured foundational Literacy with whole & small group instruction, & a 30-minute writing block. K-4 students receive daily phonics instruction via the 95% Phonics Core Program. We offer a daily 30-minute rotating Science & Social Studies block. Math instruction at Bellmawr Park aligns with state standards & student needs. Young learners use a workshop model, while Grades 1-4 use Eureka Math2 to build number sense & mathematical reasoning. Our related arts program features art, music, technology, STEAM, health & PE, & Spanish, enriching students' experiences. We closely monitor student growth through systematic data review.



Sports and Athletics:

To support and promote activity. Our intramural sports program is offered in 8 week cycles twice a year to our 3rd and 4th grade students.

The Bellmawr C.A.R.E. Program provides enriching, child-centered activities for students needing extra supervision beyond regular school hours. Designed for pre K through 4th grade, the program ensures a safe, caring, & structured environment. It aligns with Bellmawr's commitment to excellence, offering opportunities for play, arts and crafts, fine & gross motor activities, & social interactions with peers. Both before & after school, children engage in diverse activities that support their development. The C.A.R.E. Program fosters a supportive atmosphere of mutual respect, benefiting both children & their families.



Staff and Professional Learning:

We prioritize high-quality, targeted professional development to meet the specific needs of our students & staff, ensuring that our educators are equipped to engage in strategic, data-driven instruction rooted in the latest research. This enables us to continuously improve teaching practices & student outcomes, fostering an environment of ongoing learning & growth. Our professional development offerings are comprehensive & focused on enhancing instructional practices & student outcomes. Key areas of training include the Science of Reading, classroom behavior management, Genre-Based Libraries, Read Alouds, Vocabulary development, Eureka Math, & strategies for addressing Harassment, Intimidation, and Bullying (HIB). We also emphasize High-Impact Strategies & Visible Learning techniques, alongside diversity & inclusion through the Welcoming Schools program. For our Pre K educators, specialized training covers Math in the Classroom, the Pyramid Model, & integrating libraries & literature.



Student Supports and Services:

The school is assigned a school psychologist as our school case worker. We provide occupational & speech services, contract physical therapy with Virtua Health, & offer transportation through Camden County Educational Services. Counseling is available via our CST or school counselor, & we partner with Care Solace for external mental health resources. We provide special education services, including self-contained programs in preschool & In-Class Resource (ICR) for all grades with co-teaching. Social & emotional support is provided by our BCBA & Registered Behavior Technicians (RBTs), with additional training from Brett DiNovi & Associates. Our behavioral support team ensures students' needs are met in the least restrictive environment. As a School-wide Title I school, Bellmawr Park provides year-round basic skills instruction in ELA and Math, supported by Title I funds. Student Health and Wellness:

Student health services including annual screenings by the nurse, PE and health classes, daily recess, & nutritional breakfast & lunch programs aligned with national guidelines are all part of the school's wellness plan. PBIS committee has developed a robust Tier I program emphasizing the pillars of perseverance, responsibility, inclusivity, determination, & engagement. This incentive-based program rewards positive behavior using specific action-based language to encourage self-ownership, fostering a healthy & productive learning environment. The research supporting PBSIS shows that this approach leads to a safer, more effective learning environment. An Inclusive Learning Library has been established to address our students' social & emotional needs, with support from Welcoming Schools professional learning. Books were carefully chosen based on our diverse student population's needs, with input from faculty and staff. Generous contributions from the community made this possible.



Parent and Community Involvement:

Our PTO enhances our school's educational experience by organizing engaging assemblies & events aligned with our school philosophy. We connect all stakeholders to support our vision & future goals, ensuring students benefit from a well-rounded education. Key initiatives include a weekly newsletter for family updates, preschool playdates to ease the transition to school, & a preschool/kindergarten orientation to familiarize families with the school environment. We also use Class Dojo & Genesis Parent Portal for effective communication. Activities such as Fire Safety assemblies, Field Day, & events like the Multicultural Fair, Title 1 Math & ELA Night, & Read Across America further enrich students' learning and development.



Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Teachers. Our District has teamed up with Renaissance Fundamentals to implement a research-based screener designed to uncover non-academic barriers that may impact student learning & success. This survey provides a standardized assessment of 9 key areas: feelings about school, perceived learning capability, self-regard as a learner, preparedness for learning, attitudes towards teachers, general work ethic, confidence in learning, attitudes towards attendance, & response to curriculum demands. Results are carefully reviewed by administration & staff to guide decisions on professional development, student needs, & Tier 1 support strategies. Students participate in this screener both the fall & spring. The insights gained from these surveys will provide our district with invaluable information on student experiences, fostering school-wide improvement & informed MTSS (Multi-Tiered System of Supports) interventions. All responses are confidential and will only be shared with parents & staff.

Facilities:

Bellmawr Park Elementary, serving PreK students in the Annette Castiglione Early Childhood Center and K-4 students from the west side of Bellmawr, is a vibrant two-story school that has seen extensive updates recently. We've renovated classrooms with new wall unit shelving and storage, and upgraded ceiling grids, lighting, and flooring. Modern air filtration systems and interactive TVs have been added to enhance the learning environment. All hallways and stairwells have been freshly painted, incorporating positive sayings on stair threads to support our PBSIS and SEL goals. The completed rooftop solar panel project boosts energy efficiency and integrates with our science curriculum. Outdoors, we now feature five developmentally appropriate play structures, an exploration area for natural play, and upgraded grounds with fences for added safety in parking lots.



School Safety:

The Bellmawr Park School takes a serious and pointed approach to safety via our emergency management protocols and procedures. All administrative staff is involved in professional development throughout the year and turnkey to stakeholders throughout the district. Safety training is part of our new teacher orientation and subsequent meeting held during the school year to update any changes or clarify practices aligned to the safety of our schools. Facility upgrades to enhance the security of our school, including a BluePoint system, has been installed to improve further our ability to communicate a need for assistance as efficiency and efficacy. Additionally, a supportive and working relationship is maintained with the local police department, which provides regular well-check visits to our school.



Technology and STEM:

Technology & STEM are integral parts of our special area rotation where students engage with state-standard-aligned curriculum designed to build foundational skills in these critical disciplines. As part of our 1 to 1 Chromebook initiative, all Kdg - 4th graders have access to technology that enhances their learning experience. We believe that a strong foundation in creative thinking & design is essential for preparing our students to be successful citizens & future leaders in the 21st century. Our carefully crafted curriculum encourages students to actively engage in critical thinking, communication, collaboration, & creativity. This approach helps them develop the ability to ask & answer questions that drive their learning. To support these goals, we use Google educational tools, which empower both staff & students in instruction, collaboration, computer literacy, & expressive thinking. This approach ensures that our students are equipped with skills needed for future success.

Early Childhood Education:

We offer a full-day preschool, three and four-year-old program. Our classrooms are mixed age level, which research supports as the preferred when working with young learners. Our program supports our community through our CPIS, and professional development is provided for our teachers through our Instructional Coach. These two positions will allow us to better serve our teachers through ongoing coaching in curriculum and developmentally appropriate practices and focus on our parent and community outreach. ECERs and TPOT are tools to measure our program's successful implementation and quality.



Attendance:

Bellmawr Park offers a range of extracurricular activities, including a bowling club, a school safety program with the Bellmawr Police, and a multi-sport intramural program. We also co-sponsor Girls on the Run for 3rd and 4th graders and provide an extended school day.
