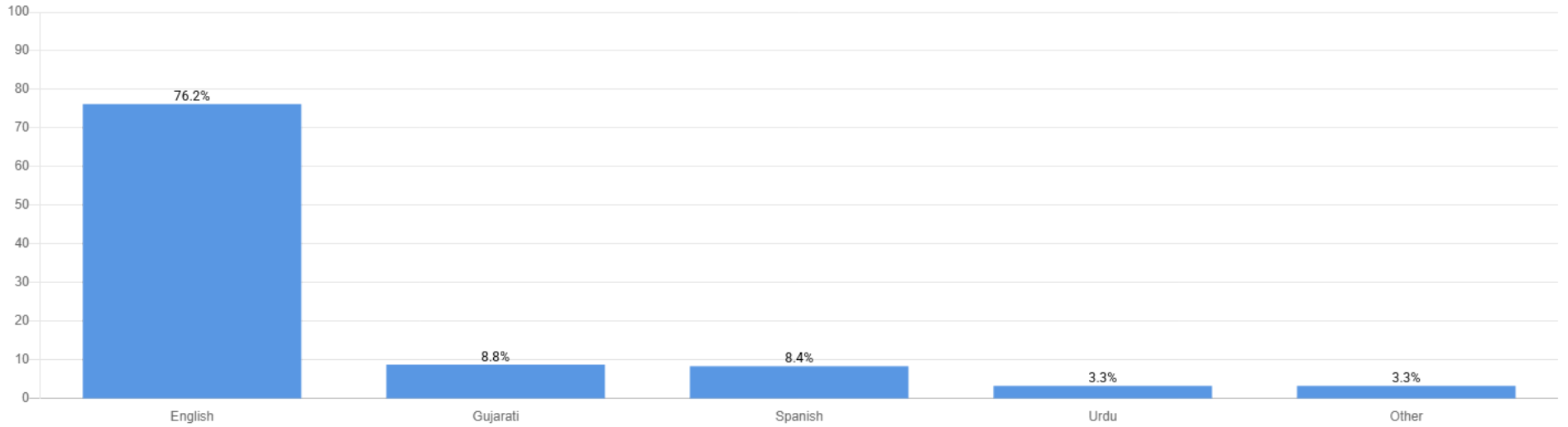

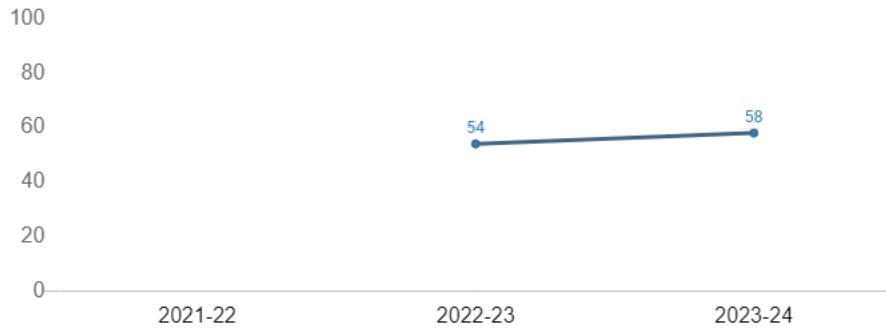

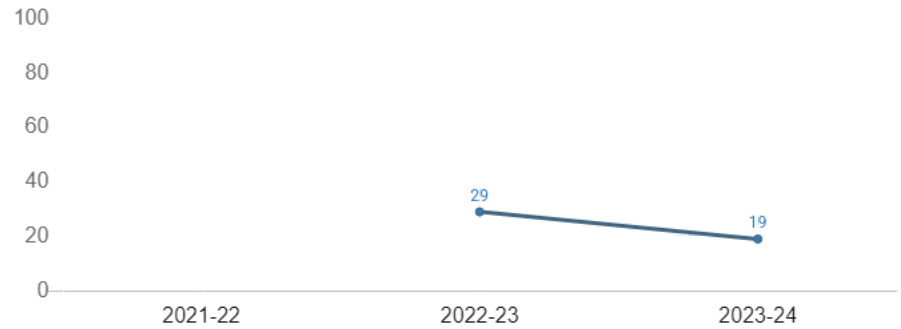

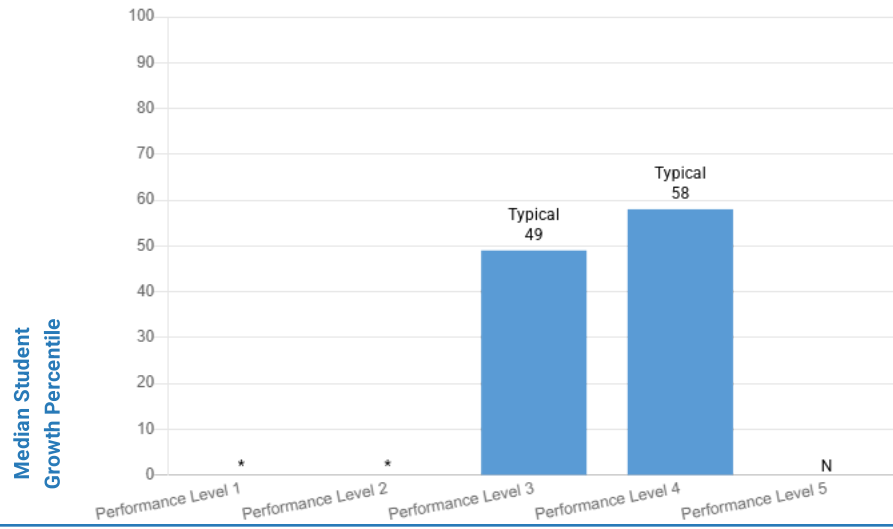

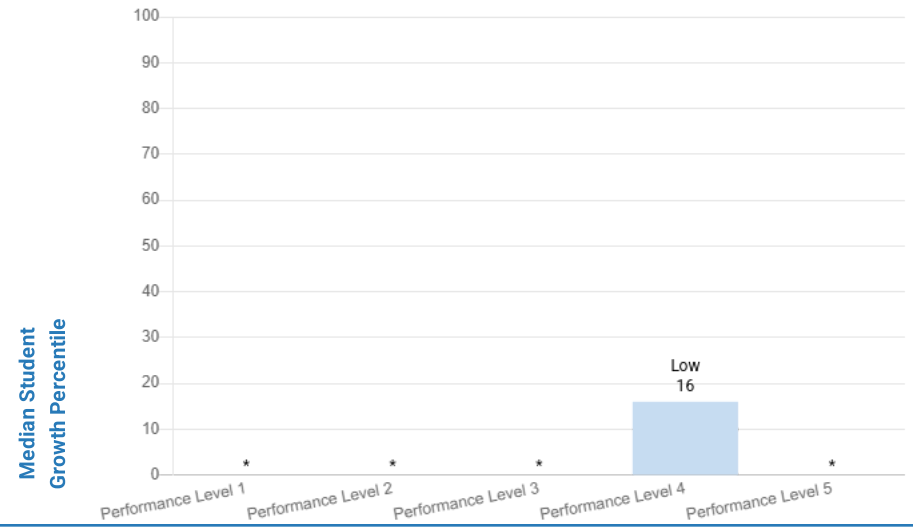

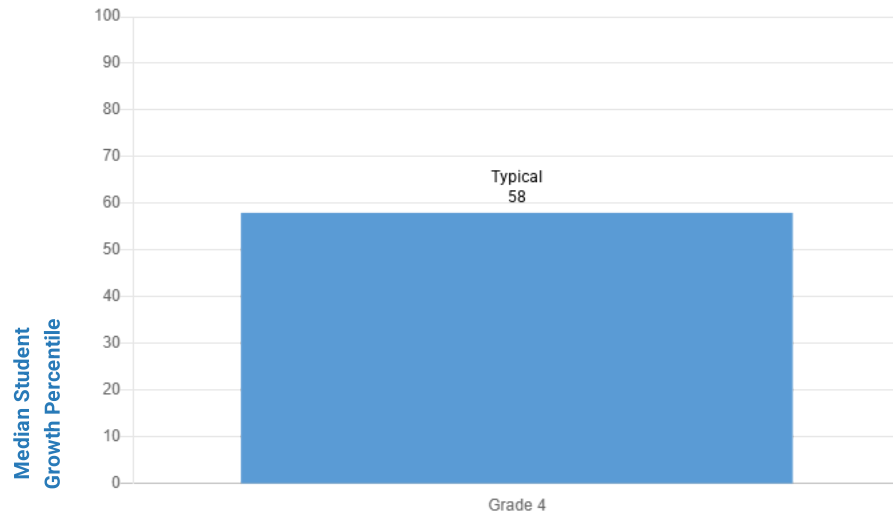

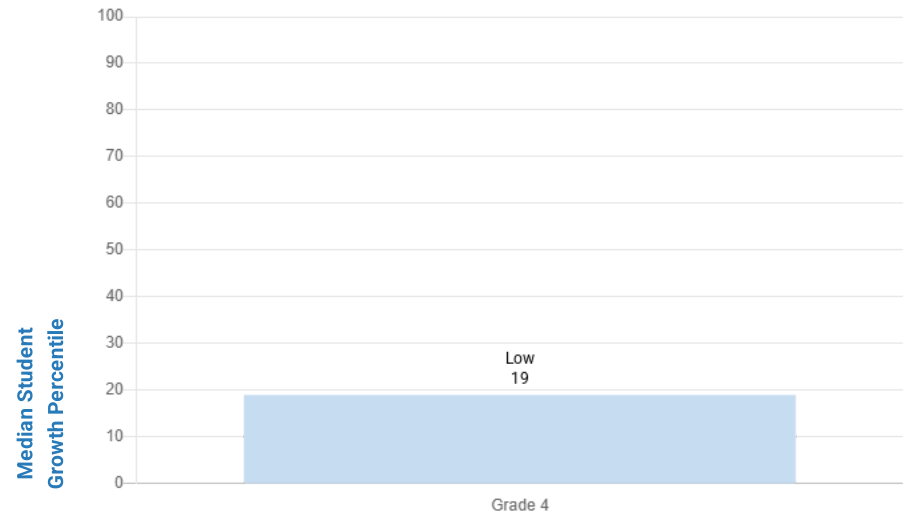

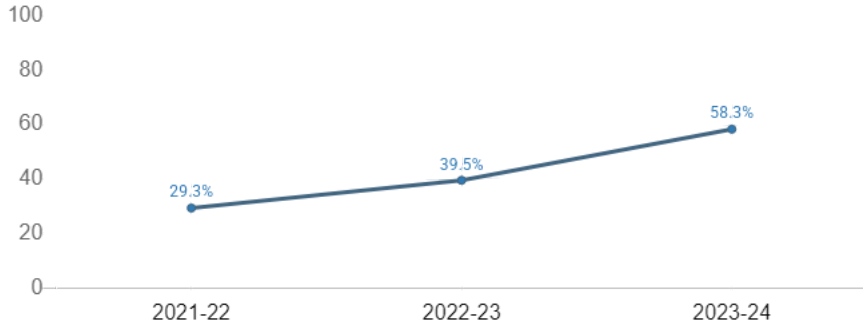

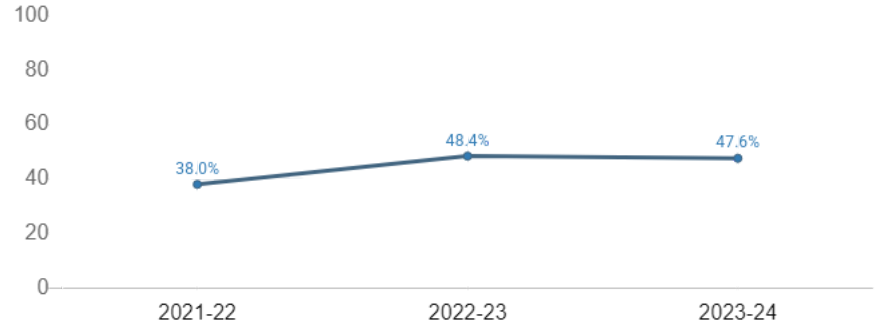
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 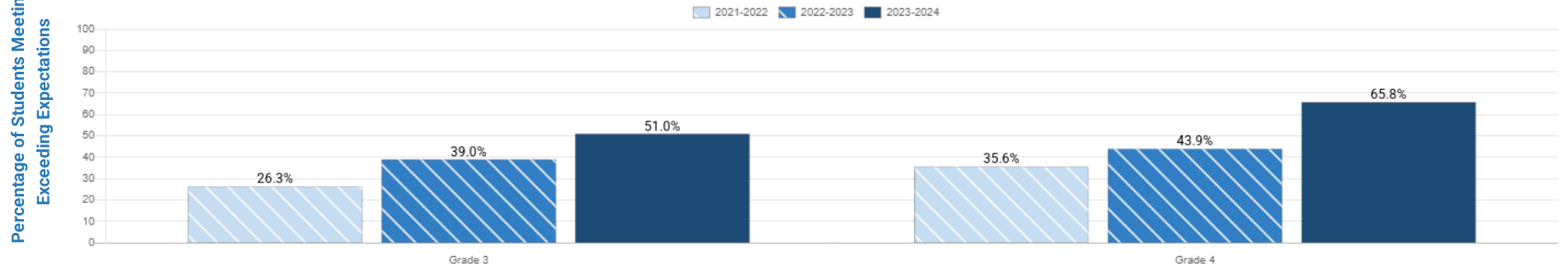

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

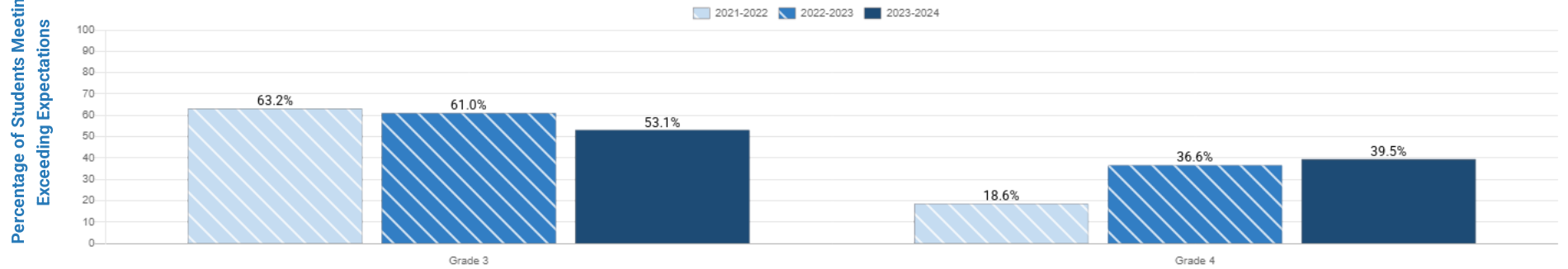

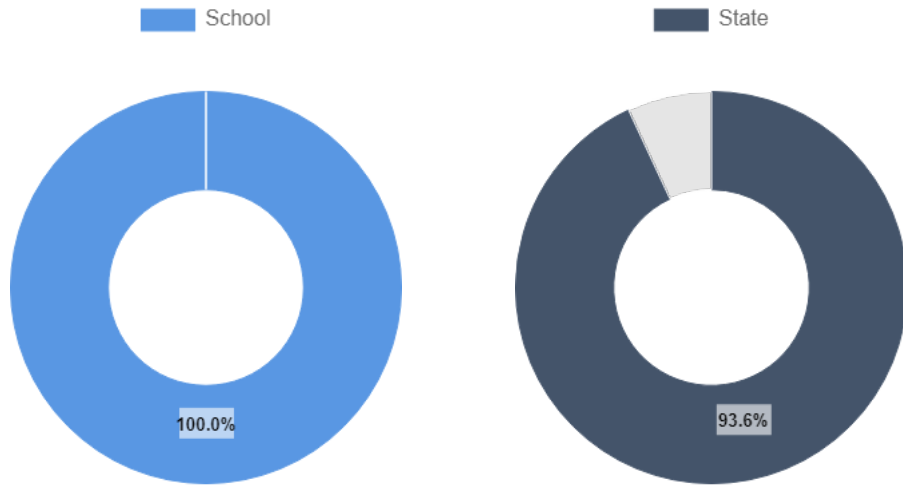

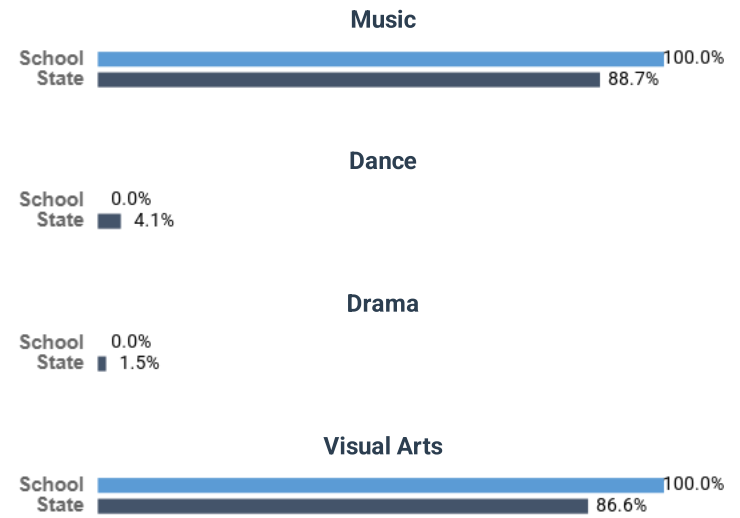

Students enrolled in one or more classes by discipline:



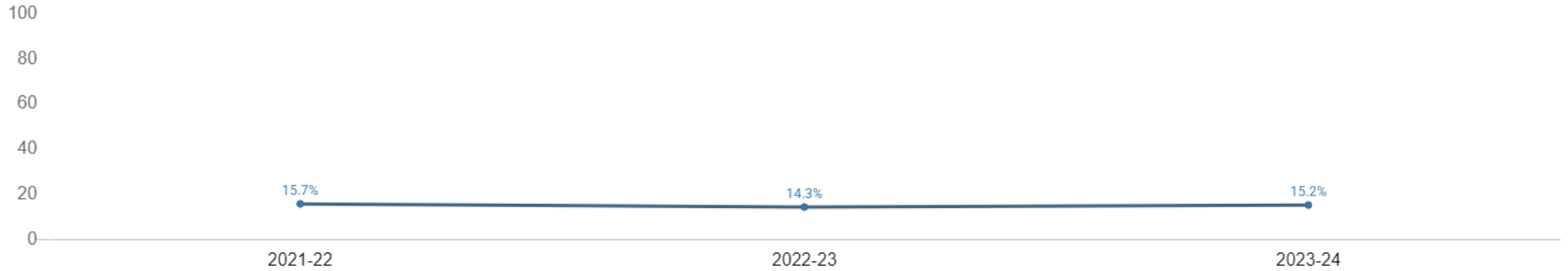

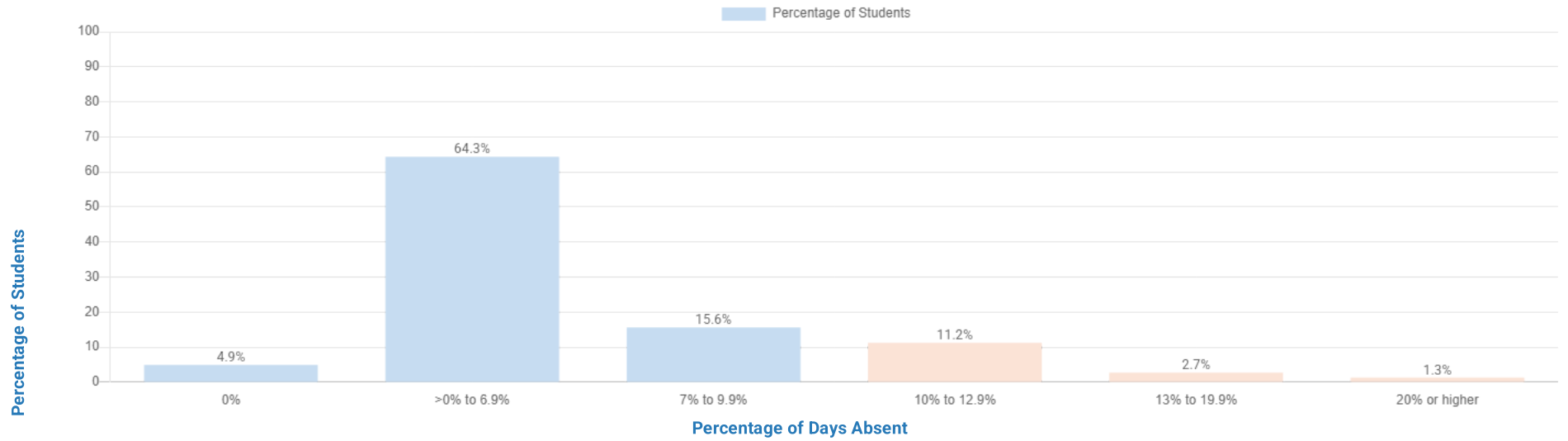

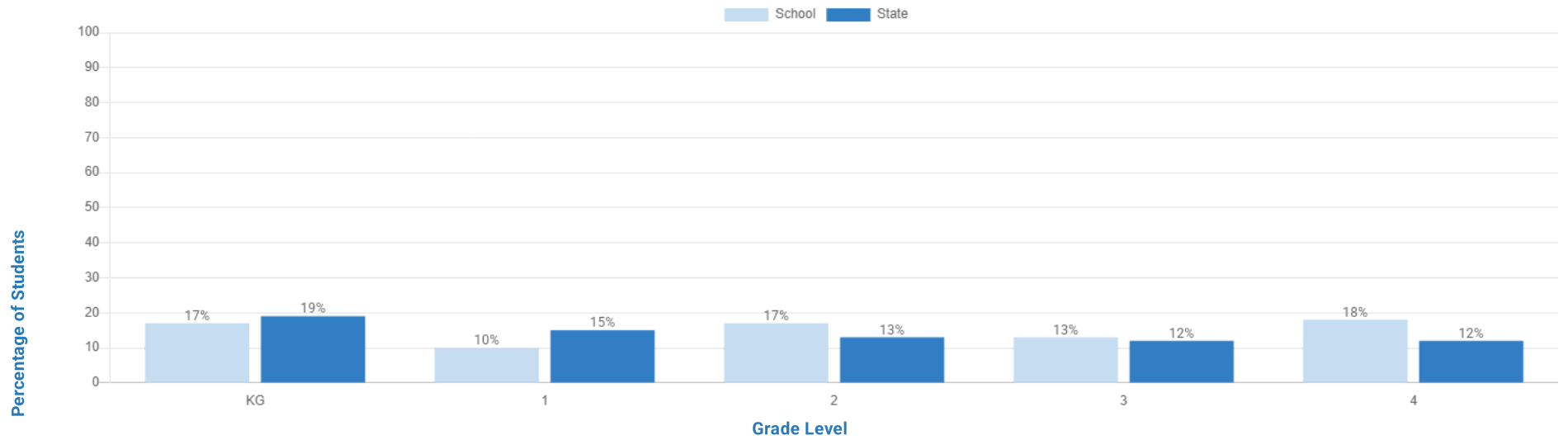

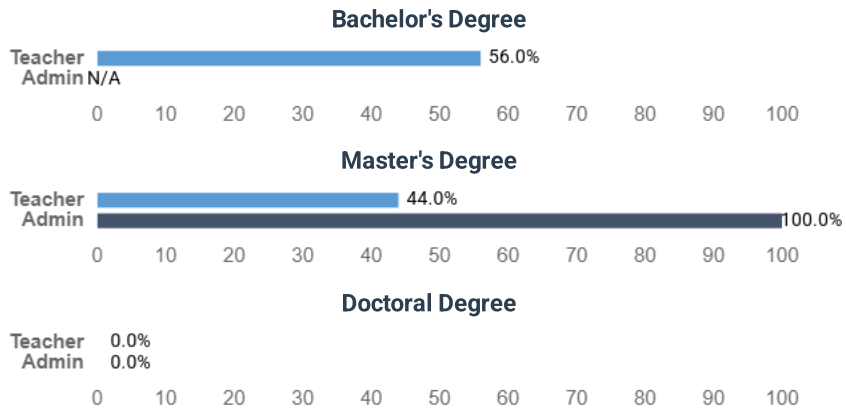

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

We offer diverse & expansive opportunities for our Kdg-4th Grade students. All programming has been designed to meet the requirements of the New Jersey Student Learning Standards & to ensure students are exposed to the latest research-based, data-driven best practices in education. Our Language Arts/Literacy program integrates the Wit & Wisdom program & Science of Reading standards, focusing on reading, writing, speaking, listening, & vocabulary in complex texts & media. Daily phonics instruction & a rotating Science & Social Studies block are included to integrate content standards into reading instruction. Math learning emphasizes standards & student needs. Kindergarteners use a math workshop model, while 1st-4th graders focus on number sense & mental math skills through Eureka Math. Concepts are revisited over consecutive years, with progress monitored through module assessments. Our related arts programming in Grades K-4 includes art, music, technology/STEAM, health, PE & Spanish.



Sports and Athletics:

Before and After School Programs:

C.A.R.E. After-School Program: The Bellmawr C.A.R.E. Program provides child-centered activities that reinforce excellence for children who need additional supervision outside the hours of the typical school day. The program offers a safe, caring, and structured setting for students in preschool through eighth grade. It is consistent with the Bellmawr learning environment in that all students are entitled to excellence every day. Children that participate in the before and/or after school program will be exposed to a variety of opportunities to engage in play activities, arts/crafts, fine and gross motor tasks, as well as ongoing social interactions with peers. The C.A.R.E. Program continues to offer caring support for the children and families in an atmosphere of mutual respect.



Staff and Professional Learning:

We have adopted Charlotte Danielson's Framework for Teaching (FFT) which was designed to enhance professional practice. It has been shown to accelerate teacher growth and improve student outcomes, by ensuring that educators and administrators are able to engage in a common dialog of what effective instruction looks like. We utilize Assessment Capable Visible Learners John Hattie's research on teacher practice which encompasses 1,800 meta-analyses of over 100,000 studies, encompassing 300,000 students worldwide, and is growing daily. Bellmawr Public Schools believes that the most valuable professional development is embedded, ongoing and that it comes from within our rank of master teachers which is demonstrated through our Collaborative Teacher Crew/New Teacher Academy. This allows ongoing support and collaboration during PLC time. Bellmawr School District also hosts outside presenters, a districtwide book study, staff presentations, and districtwide sessions using Google meets



Student Supports and Services:

Bellmawr School District has a full child study team consisting of 2 school psychologists, a learning disabilities teacher consultant, & a school social worker all supervised by the director of special services. Counseling services are also provided. We provide social & emotional support through our own BCBA & Registered Behavior Technicians (RBTs). Our school district also contracts with Brett DiNovi and Associates for additional training for our staff with behavioral supports & clinical associates who work closely with our behavioral support team to ensure the needs of our students are being met in the least restrictive environment. Our school district also offers community-based instruction trips to enhance life & social skills for those students in our self-contained programs & we partner with Crisis Canines for additional social emotional support for students & staff throughout the year.

Along with the PTO, staff & students celebrate Field Day by displaying sportsmanship & competition in physical activities. Climate Surveys:

We have partnered with Renaissance Fundamentals (formerly PASS) to develop a researched-based screener that identifies hidden non-academic barriers to student learning & success. The survey provides a standardized measure for 9 factors: 1) feelings about school, 2) perceived learning capability, 3) self-regard as a learner, 4) preparedness for learning, 5) attitudes towards teachers, 6) general work ethic, 7) confidence in learning, 8) attitudes towards attendance, and 9) response to curriculum demands. Students will take the screener during school in the fall & spring. Feedback received from the survey will provide our district with invaluable insights into student experiences, enabling general school improvement & informed MTSS intervention support. Established in 1889, Ethel M. Burke has a proud history of servicing students in grades K-4 from the eastern portion of Bellmawr. During the 2023-2024 school year, Ethel M. Burke has installed a new dynamic school sign on the front of the building, remodeled Kindergarten bathrooms, signage, doors, railings, grounds, and other building areas. Classrooms have been modernized with new technologies such as interactive whiteboards, upgraded HVAC units, new recess equipment and a rubber playground, a newly installed gymnasium floor, and the installation of a solar energy system on the roof.
