




### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 



Students in sixth grade who were enrolled in Algebra I course were required to take both the Algebra I and Grade 6 mathematics assessment. The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.















## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.









## Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). ### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

We offer Option 2 in Television Production & Broadcasting and have a S.T.E.A.M. Academy. Finally, Highland provides an Air Force Junior ROTC program that serves all students in the Black Horse Pike Regional School District.

### Before and After School Programs:

We offer academic tutoring programs (both during and after school): Lit Cafe and Math Power Hour running parallel with one another four days a week after school, Literacy Nights, and daily Math Tutoring services. During the 2023 school year, Highland also offered science empower hour after school two days a week. Test preparation for state assessments, Advanced Placement exams, and SAT are provided throughout the year.



### Staff and Professional Learning:

Administration works collaboratively with faculty through an Academic Enhancement Committee to provide our teachers and staff with opportunities to grow in use of instructional strategies, wellness, and restorative practices. Professional development is offered through staff work days as well as optional workshops offered on a monthly basis with a focus on equity and equality within the teacher evaluation platform. Highland has created a Teacher Leadership team that reviews teacher walkthrough data and student growth. This group of teachers, supervisors and administration have provided additional professional development through monthly faculty meetings and Power PD workshops.



### Postsecondary Information:

Over 80% of our graduating seniors attend either a two or four year college. Students attend various colleges such as Princeton, LaSalle, Penn State, Thomas Jefferson, and University of the Arts. Approximately 10% have gone into the military to service our country and the other 10% of students have gone directly to employment.

### Student Supports and Services:

We offer a full spectrum of support services to promote academic and social emotional growth. Highland has focused on mental health through the services of full time SAC and MHAC counselors; and the addition of a full time transition MHAC counselor supported by the state. Additionally, Highland has a certified staff member (Student Success Coach) working with "at-risk" students supporting efforts towards graduation and a student mentor working with students developing good work habits at earlier stages of their high school careers. Highland has a full CST on site supporting all students with IEPs and an I&RS team developing plans for students having academic struggles.



### Student Health and Wellness:

We focus on educating the whole child including their social-emotional health. We offer mindfulness activities across the curriculum and have incorporated restorative practices to help students in decision making that can positively impact their future.



### Parent and Community Involvement:

We have a Home and School Council in which parents meet monthly to discuss important topics. They also contribute to our whole school community through donations and scholarships. We have an Equity Committee including parents working collaboratively with teachers and administrators to make school improvements. Highland collaborates with several community groups through Interact and AFJOTC relationships with Rotary and Kiwanis groups. Real time academic updates are provided through Genesis and parent support groups throughout the year.

### Facilities:

Our building is 57 years old and we work to make sure it has up-to-date facilities to meet the ever changing needs of our students. We have state of the art infrastructure to support technology so our students can all use one to one Chromebooks. We've made updates to our ventilation and HVAC systems. This past year, the district has completely restored the main gym, created a larger dance studio, and upgrades within the Auditorium. We have also been named a Green Ribbon School for our commitment to making our environment cleaner.



### School Safety:

Safety and security are primary areas of concentration. Highland has a certified school safety and security specialist (Vice Principal) who oversees all safety and security measures. We have strict safety procedures in place that all visitors must follow before entering the building. We require appointments for adults to enter our building which has significantly reduced the number of outside people within our school. We work in close contact with our local police department and have a School Resource Officer on premises at all times.



### Technology and STEM:

We offer a variety of courses in engineering, architecture, and technology. A highlight is our Robotics (now Design & Technology III) program. Highland students also participate in the STEM capstone competition which is held every year at Camden County College. Students have multiple opportunities to learn in an integrated STEAM environment and students consistently place in local competitions.

Each grade level has their own Vice Principal who stays with them until graduation. We have six counselors, a Career Counselor, Student Assistant and Mental Health Counselor. Our counselors are here to assist your children with academic, career development and personal/social matters. Ms. Altman and Ms. Devlin, our mental health assistance counselors, works with students who may struggle with depression, phobias and other mental health issues that could interfere with their academic progress. If your child has or may require an individualized educational program, Highland is fortunate to have their own Child Study team.
