




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 



















New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.









Accountability Summary by Student Group - 2023-24 School Year

The mission of Timber Creek High School seeks to educate the whole child, strengthen opportunities to build character and utilize our resources to ready students to meet life demands. This premise informs our daily work. We enforce high expectations for ALL students and address student challenges with a mindset of equity, empathy and care. The staff and faculty at Timber Creek High School work in concert to provide rich learning experiences, opportunities for student engagement, and life application of knowledge. We acknowledge the importance of sustaining relationships with families and partner with the community to promote student success. Through our efforts and our CHARGE, we expect to maximize student potential, inspire a spirit of innovation and ignite their commitment to active citizenship and lifelong learning.



Awards, Recognition, Accomplishments:

With 1117 students, Timber Creek High School develops high performing scholars, musicians, and athletes. We honor student achievement at Board of Education meetings - including Eagle Scout and District Tech Challenge winners. It is common for students to receive full scholarships to reputable schools; and we give out 71 local scholarships to over 75 Seniors each Spring. Out of DECA competitors worldwide, several students placed in the top 8%. Our Winter Track team (girls) won the NJSIAA South Jersey Group 3 Championship and State Group 3 Championship. Our Girl's Basketball team won a Tri-County Conference Title. Both of our basketball teams won the Tri-County Conference Tournament. We also had a softball player get her 100th hit. Our Girls Track team had a 4x400 team set a new school record, as well as be the only public school to qualify for the Championship of America at the Penn Relays.

Courses, Curriculum, Instruction:

Timber Creek High School engages students in learning that enhances technical skill, challenges perspective and promotes an interdisciplinary experience. All academic courses are considered College Prep or College Prep Accelerated levels. We host 16 AP & 14 Honors level college prep courses to promote academic rigor; and we partner with Camden County College to offer 27 Dual Credit courses for students with college ambition. 5 Career Prep Programs are offered to Seniors, including College Now, Career Investment, Finishing Trades Institute, Internship and Work Study- all programs to enhance postsecondary selections. S.T.E.A.M. Academy and Teen Pep are offered to enhance skill, peak interest and build student character.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cheerleading (Coed), Cross Country (Boys & Girls), Field Hockey (Girls), Football (Boys), Golf (Coed), Lacrosse (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Swimming (Coed), Tennis (Boys & Girls), Track and Field - Spring (Boys & Girls), Track and Field - Winter (Coed), Volleyball (Boys & Girls), Wrestling (Coed)

Timber Creek High School offers 24 NJSIAA Interscholastic sports and two seasons of Cheerleading (Fall and Winter). We won the Tri-County Conference in Boys and Girls Basketball. We had 16 student-athletes sign collegiate letters, 369 students were awarded Varsity letters and 107 students received first or second team All-Conference athletes. Additionally, we celebrated a State Championship win with the Girls Track Program.



Clubs and Activities:

Timber Creek High School offers 48 co-curricular clubs and activities. The variety of clubs boosts collaborative experience and thoughtful opportunity. Our Leo, Interact, and Key Clubs donate to, work with and service many local non-profit organizations. Each year, volunteer clubs are chartered for students by students and reflect the interests of our diverse population. We added a Girls Flag Football team; the only team offered in the district. This club boosts opportunity and involvement in the spring season. As a practice, we employ selfless teachers that are willing to donate their personal time to help grow the interests of our student body; and our leaders are continually brainstorming and inspiring new ways to sustain student involvement. We trust the direct correlation between active participation, student investment and academic success. Their engagement fosters our legacy.

Before and After School Programs:

Response to Intervention is an initiative that customizes our work with struggling learners; the program assembles a team of professionals that target academic and behavioral supports to maximize student success. Parent conferences are facilitated by Counseling on Mondays afterschool each week to strengthen partnerships with families. To meaningfully engage all learners, we offer intramural sports to students in all grade levels, most notably for our multiple disabled students. To extend learning beyond the classroom, Timber Creek offers supplemental tutoring for English and Math afterschool throughout the week. Our Reading Specialist works with students daily to increase student success in literacy. Transportation is provided for students participating in afterschool programs to maximize accessibility.



Staff and Professional Learning:

Our professional learning focus includes Equity, Wellness, and Academic Enhancement. Our subsequent committee work disaggregates disciplinary trends and relationship building, examines mental health awareness and strengthening instruction through inquiry and technical application. We have a Teacher Leadership Committee that facilitates training sessions for staff. That work focuses on instruction, culturally responsive education and student success. Faculty and department meetings enhance development efforts and extend professional capacity by sharing resources and examining data to support the processes that are being implemented.



Postsecondary Information:

Our School Counseling Program readies students throughout their high school career to perform at their best and actualize and maximize options after graduation. 44% of our graduates attend a 4 year college, 32% attend a 2 year college, 11% attend a trade school, and 1% join the military. We had 46 NJSTARS recipients. The district pays for 2 PSAT test administrations in 10th and 11th grade as well as 1 free SAT test administration in the Spring for all students in grade 11. We also offer all Juniors a free SAT prep course through KAPLAN.

Student Supports and Services:

Timber Creek offers a host of resources to support our students academically, socially and emotionally. The academic services we offer include Response to Intervention, after school tutoring programs, a Reading Enrichment Network and a Peer to Peer Life Skills Program. Our counseling services include a Student Assistance Coordinator, a Mental Health Assistance Counselor, a Transitional Coach, a District Mentor, and a Drug and Alcohol Early Intervention Program. Our 'No Place for Hate' initiative fosters student-driven advisement and support. Students and staff alike utilize our School Counseling & CST to support development. We fostered a relationship with the local police to offer support student services and build better connections with law enforcement. Our Interact Club partners with the Gloucester Township Rotary Club to support families during the holiday season, organize a year round Food Pantry located at Timber Creek and aid in the beautification of our community.



Student Health and Wellness:

Timber Creek High School offers an array of opportunities to promote health and wellness for staff and students. We facilitate intramural programs, rigorous Physical Education classes, competitive health challenges, and opportunities to use the weight room even if students are not associated with a current sport. We provide healthy meals for breakfast and lunch and healthy vending choices at the conclusion of the day. We boast a Student Assistance and Mental Health Counselor, Student Mentor and Transition Coach on staff. Mindfulness and meditation are infused into many of our lessons in Physical Education, Freshman Seminar and academic classes. We sustain active participation on our Wellness Committee that organizes and facilitates monthly Wellness activities. They include recreational sports activities, the promotion of healthy eating and mental health awareness, and counseling sessions facilitated by our Employee Assistance Program and Care Solace.



Parent and Community Involvement:

Teamwork makes the dream work; and communication is key. Our HSC develops programming to support the school community, inspire instructional staff and engage students beyond the classroom. This group of invested caregivers implement student appreciation days and student-centered events. Our booster clubs also CHARGE UP parent engagement in meaningful ways. We regularly examine efforts to involve our local community. Students, staff and families are invited to our legacy programs- a 100 Days Party, seasonal festivals, orientation programs, and other amazing community events throughout the year! Most recently, we implemented an athletics summer clinic for middle school students who will be joining the TC community in future years. We market all opportunities regularly through our community newsletter- 'The Charge'. We also enjoy the support of local businesses that donate toward student-based initiatives and generously support staff projects during Educator Appreciation Week.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. The principal provides a 360 degree review for stakeholders to assess the school environment. Over the summer, the building administration reviews the data. The data is shared with faculty and staff in September, and the outcomes are employed to consider building level improvements for the Fall. Climate and school environment is assessed during checkpoints throughout the year by our administrative team; and we have a Teacher Leadership and Wellness Committee to brainstorm additional approaches to student and staff success. Our Student Voices Committee and Equity Council gauge community recommendations and use that content to advocate for lasting change.



Facilities:

Timber Creek High School is 300,000 square feet and sits on over 60 acres. Our Maintenance and Grounds crew continues to update our facilities to provide a safe and conducive learning environment. The building is 24-years-old and our most recent projects include the installation of a new track, Main Gym floor, baseball and softball scoreboards; and updates to enhance the Auditorium and our stadium and auditorium sound equipment. Other projects worth a mention include an enhanced chiller system and installing a new repeater to enhance our communication on our school radios to strengthen safety measures. The outside facilities have been enhanced including turf management and new outdoor restrooms are now tied into our sewer. Groups utilize the indoor and outdoor facilities to host events which is a flattering testament to the maintenance of our building. We adhere to our CHARGE to sustain a building that is spirited, safe and a beacon to our school community.



School Safety:

Timber Creek High School continually develops improvements to heighten security measures. In addition to a front desk and security vestibule, we have an SRO, Front Desk Monitor, and Security Guard on staff. They continuously monitor the interior and exterior of our building to ensure we provide a safe environment to our staff and students. We collaborate with GT police, and our local Fire Department to gain feedback about our building EMT procedures. Our facility is surveillanced by a camera system that has been updated and new cameras are installed when needed. Recently we installed a nightlock system that allows staff to easily lock their door from the inside of their office or classroom. We purchased a LENS system that allows our school to be placed in a lockdown and call 911 with the push of one button. Our School Safety and Behavioral Wellness Assessment Teams identify potential challenges and brainstorm solutions to provide greater protection for our learning community.

Technology and STEM:

The technology offerings at Timber Creek High School are continually increased to meet the demands of our 21st century. In addition to our engineering, computer and graphic arts classes, The S.T.E.A.M. Academy is a rigorous interdisciplinary program designed to provide a strong educational foundation for students planning to pursue careers in Science, Technology, Engineering, Arts or Math. There are also opportunities for engagement via work in our telecasted news program, 'The Morning Jolt', which is run by our student body as well as exposure to new equipment to remotely telecast. Members of our Technology Team compete in the Camden County College Engineer Week Design Competition. Additionally, students participate in an annual SJ Physics Olympics and consistently place well in this competition. As a district, we celebrate the fourth year of our Chromebook adoption and our AV/Technical Support Team is integral to supporting the success of our electronic resources in the building.



Early Childhood Education:

At Timber Creek High School, we value sustaining partnerships, fostering experiences and uplifting students. Opening our doors to middle school students to get ALL CHARGED UP about future opportunities is a pretty cool thing. To this end, each year we host summer camps for middle school students in July and August. These sessions introduce our prospective students to our offerings in co-curricular activities and athletics. The Black Horse Pike Regional School District hosts district literacy events at each of the high schools every year. Our faculty creates a host of exceptional experiences that expose children to career opportunities and the wonderful world of teaching on 'Take Your Child to Work Day'. Our 'Future Teachers of America' club lends classroom support to our neighboring schools. As a practice throughout the year, we host festivals and family FUN-ctions that engage our students in leadership and service.
