




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 

















Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.











Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. - We offer a variety of Career Exploration programs including partnerships with the Finishing Trades Institute, Camden County Technical School, work-study programs, and a S.T.E.A.M. Academy.
- We offer ten performing arts activities and clubs including Theatre, Dance, and Music. There are over 70 options in Academic Activities, Gaming, Community Service, and Athletics.

Our mission is to educate the whole child. We will lead students to make good academic and social decisions and create a culture where they are engaged, challenged, and involved in their learning. Students will feel physically and emotionally safe and supported by our faculty and staff. They will turnkey that support to their friends and peers and take pride in the school, themselves, and their environment. Students will learn how to live a healthy lifestyle, physically and emotionally.

Triton is a National Green Ribbon School and Lighthouse School District. We are a No Place for Hate School. Student awards and accomplishments include, but are not limited to, the Prudential Spirit of the Community Award, Widener Leadership Award, Camden County Best of Class, American Legion Boys State, and American Legion Auxiliary Girls State.

Courses, Curriculum, Instruction:

Teachers and students utilize Google Classroom to present instruction and complete assignments. We offer 30 Honors and Advanced Placement courses, Dual Credit, and College Now. We partnered with Camden County College, so students can graduate with up to a semester's worth of college credits. S.T.E.A.M. Academy is a rigorous two-year program for students in this content. Finishing Trades Institute - Students may attend an off-campus vocational program that focuses on drywall finishing, painting, and glazier. Students also have the option to participate in a full or half-day AFROTC program.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cheerleading (Girls), Cross Country (Boys & Girls), Field Hockey (Girls), Football (Boys), Golf (Boys & Girls), Lacrosse (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Swimming (Boys & Girls), Tennis (Boys & Girls), Track and Field - Spring (Boys & Girls), Track and Field - Winter (Boys & Girls), Volleyball (Boys & Girls), Wrestling (Boys & Girls)

Over half of our students participate in our athletic programs. Our fall season offers Football, Field Hockey, Soccer, Girls' Volleyball, Cross Country, Cheerleading, and Girls' Tennis. The winter season offers Track, Basketball, Wrestling, Cheerleading, and Swimming. The spring season offers Baseball, Softball, Lacrosse, Track, Boys' Volleyball, Boys' Tennis, and Golf. We have E-sports in the Fall and Spring.



Clubs and Activities:

Triton has over 40 different clubs for students to join including, but not limited to, History, World Language, Men and Women's leadership, Technology, Art, and D.E.C.A. We have Interact and Key Club that are service-oriented clubs connected with our community. Our performing arts clubs include the Fall Production, Spring Musical, One-Act Festival, Tri-Tones, Choir, Dance, PEP Band, and Indoor Percussion. Students can also choose to become part of Student Government.

Before and After School Programs:

Literary Cafe: English teachers are available four times a week, two hours a day, and once a week one and a half hours, to assist with Language Arts. We have math and extra help once a week after school. Students have access to computers, books, charging stations, and academic assistance. Parents or students can schedule appointments with counselors after school for assistance with post-secondary planning, navigating high school, or other issues. All teachers are available after school for academic help.



Staff and Professional Learning:

New Teacher Academy: All non-tenured teachers attend weekly workshops for the first two months of school and then workshops are held on a monthly basis for the remainder of the year. The workshops incorporate Restorative Practices, Wellness, and Academic Rigor. All faculty have access to training to support Equity training and instructional strategies are offered during the summer and throughout the school year. Mandatory Anti-Bullying and Transgender training. Our Response to Intervention Team (RTI) provides professional development to our faculty for strategies to implement in the classroom that will assist our struggling learners.



Postsecondary Information:

Eighty-five percent of our students attend a two or four-year college or vocational school. Four percent enlisted in a branch of the military. Parents and students are invited to evening workshops to aid in post-secondary decisions and to navigate the financial aid process. Fifteen percent of our students attend other types of post-secondary education or receive apprenticeships. Students receive SAT prep courses throughout the year and an optional weekend boot camp before the test administration. Students utilize the Naviance program to help with post-secondary decision-making.

Student Supports and Services:

We have six School Counselors, a full Child Study Team, Mental Health Counselor (MHAC), Student Assistance Counselor (SAC), a Transitional Counselor, three Life Skills programs, and a Student Success Coach. A Reading Specialist is on staff to provide instruction for students with deficits in reading skills. Our Response to Intervention Team (RTI) suggests interventions or strategies that can be employed with general education students towards positive outcomes in the areas of Academics, Behavior, Health, and Attendance through early intervention. The team will also make recommendations for individualized interventions that may include referrals to the Child Study Team for evaluation. Our ML program is designed to assist students in acquiring English language skills. We have four ML teachers and three classroom aides.



Student Health and Wellness:

Breakfast is served daily to all students. Yoga and mindfulness are incorporated into Freshman Seminars and Physical Education classes. The PE department offers physical activities each day during lunch and weekly after-school activities for students to stay physically active. We have a Mental Health Counselor, Substance Abuse Counselor, and Anti-Bullying Specialist. We have partnered with CARE Solace. This group assists families who are having difficulty acquiring counseling services outside of school. The group matches families with providers that meet their needs and accept their specific insurance. We offer a Transition Counselor on-site for students who are unable to obtain outside services but need more intensive and individualized counseling beyond the scope of our counselors.



Parent and Community Involvement:

Parent-Teacher-Partnership meets once a month to discuss school programs. PTP fundraises to support scholarships and school projects. Triton is a member of the Runnemede-Bellmawr-Glendora Rotary and Blackwood Kiwanis. Our students participate in community service that supports their national organizations. Parents have access to student grades, attendance, and discipline in real time through a web-based program. Evening services available for financial aid and post-secondary planning.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. A Google form was put on our web page for the students to access to ask students how they felt physically and emotionally while they were in school, if they felt bullying was prevalent at Triton, and how they felt about faculty and staff. The responses showed that 90% of our students believe that the faculty and staff protect them from being bullied and over half of the students do not have a concern about bullying. The results of the survey were shared with our School Safety Team.



Facilities:

Triton was built in 1957. It has since added a new Library Media Center (LMC), science wing, weight room, and auxiliary gymnasium. The LMC is home to the Literacy Lab, Math Lab, Tech Repair, Computer Lab, and charging stations for Chromebooks. Seventy-five percent of the building has air conditioning and all classrooms have smartboards and LCD televisions. We have five outdoor areas that teachers and students can use for instruction or eating areas. Most of our bathrooms have been renovated and we are currently replacing our water fountains with water bottle fillers.



School Safety:

We have a School Resource Officer on-site daily. He is a member of the Runnemede Police Department. Our main entrance is monitored by a retired police officer. The students enter the school through three entrances monitored by a school administrator. All students must show their student ID before entering the building. After 7:20 a.m., all students and visitors must enter through the main entrance. All visitors must have an appointment and show a photo ID to enter the building. Their ID is scanned through the National database for sex offenders. Upon entry to the building, all students, faculty, and visitors must display their photo identification or visitor badge at all times.

Other Information:

Triton serves three suburban communities situated in Camden County. The school is located approximately six miles east of Philadelphia and 50 miles west of Atlantic City. Two of our communities, Runnemede and Bellmawr, are well-established, settled areas while the third, Gloucester Township, is growing at a very fast pace. We operate on an alternative bell schedule, a change from the traditional eight-period schedule. Our schedule maximizes resources, relationships, and time for students to make the most of their high school experience. Transition time is reduced by moving towards a rotating four-day design that allows students to meet six times a day, dropping two class periods. As a result, valuable instructional time is gained. With this schedule, more students have the opportunity to engage in academic enrichment activities, participate in co-curricular programs, and eliminate the monotonous "groundhog" effect that can occur with a traditional schedule. Triton has its own Hometown Hero program, established in 2013. Triton celebrates those who make a difference by inspiring others and volunteering their time to improve our community. Triton Mustangs believe in leadership, social responsibility, focus, dedication, and integrity. Our Mustang team thrives on morals and leadership while forging memories and inspiring dreams. We teach students to lead the way, set high standards for themselves, take pride in their school, and share their glory - just like our hometown heroes. Triton welcomes these heroes into our Mustang family. The Hometown Hero Program furthers our commitment to engage and impact our community as well as provides an opportunity to celebrate their extraordinary efforts and good deeds.
