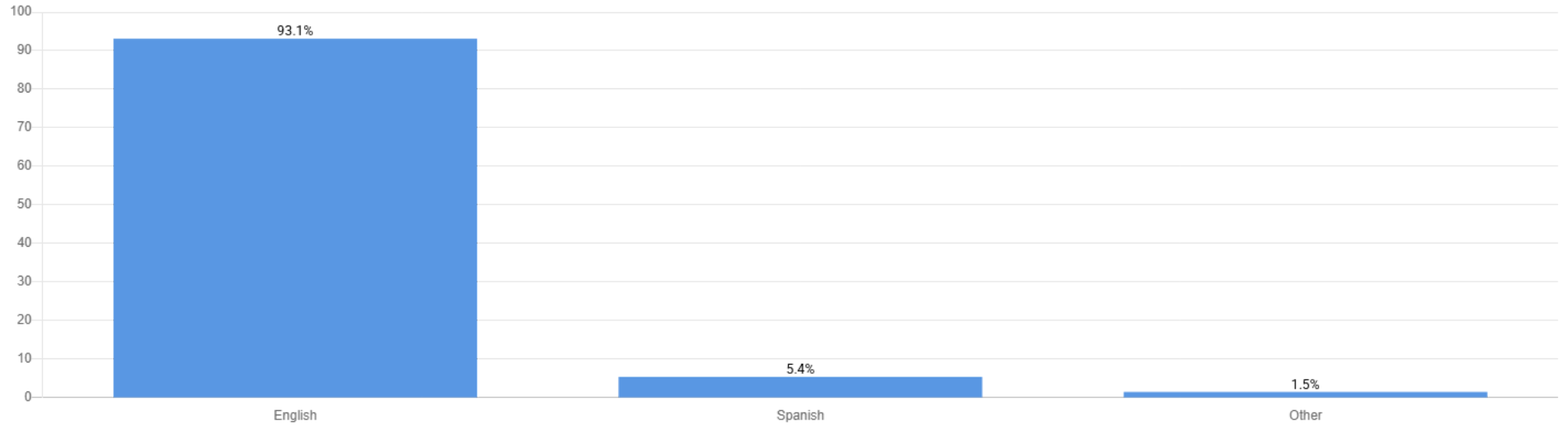

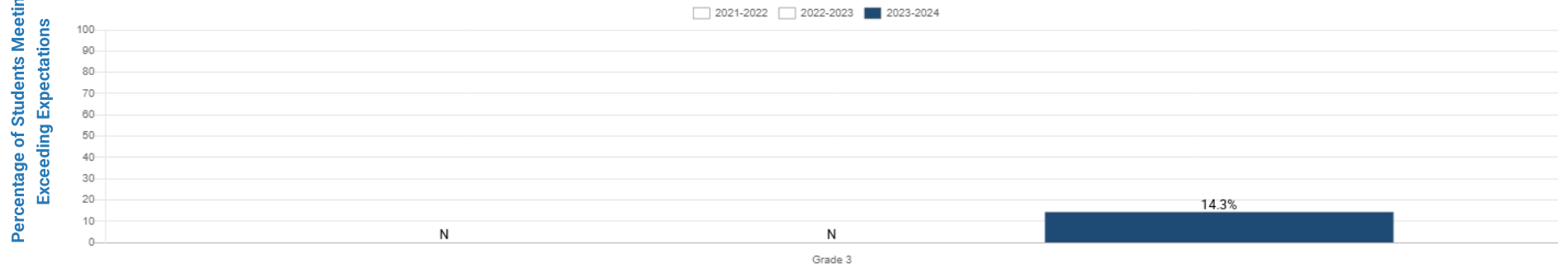

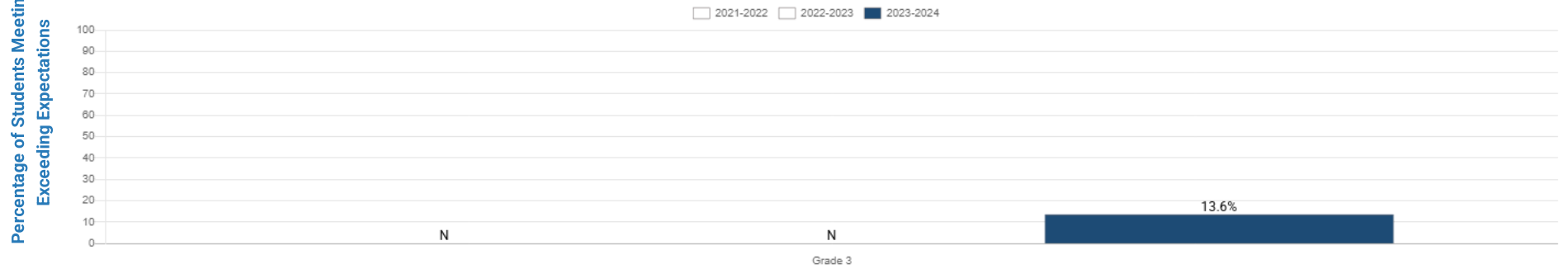

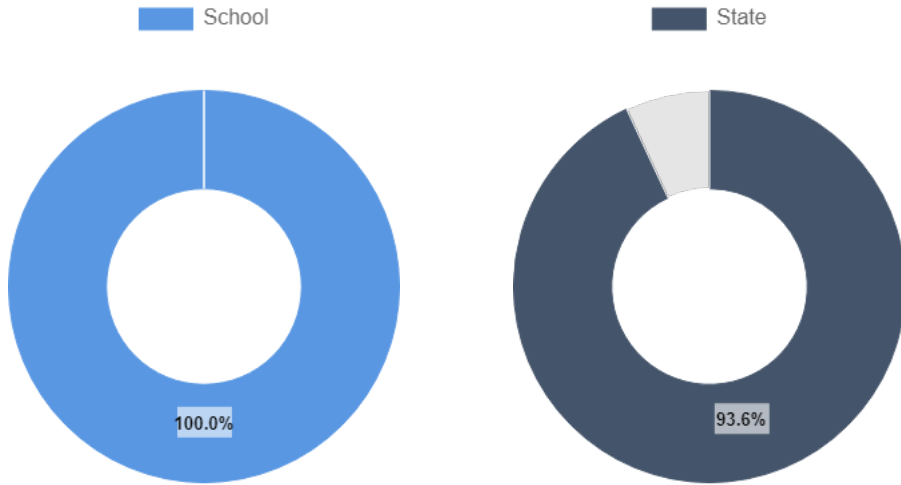

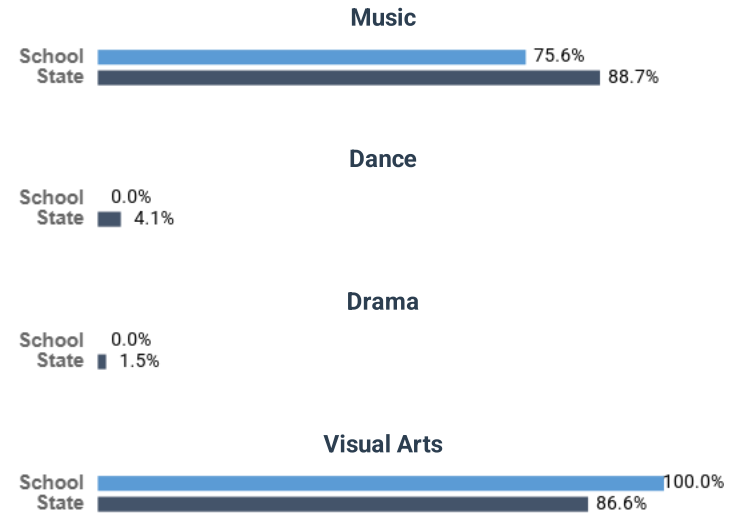

Students enrolled in one or more classes by discipline:



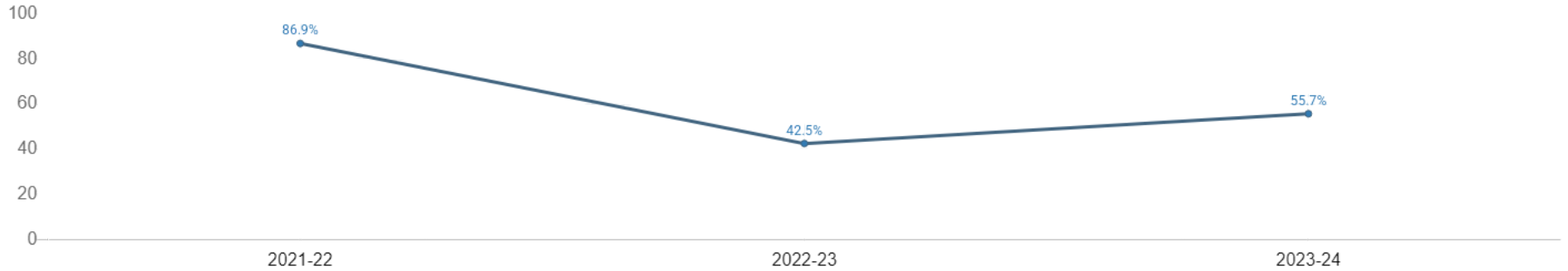
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. 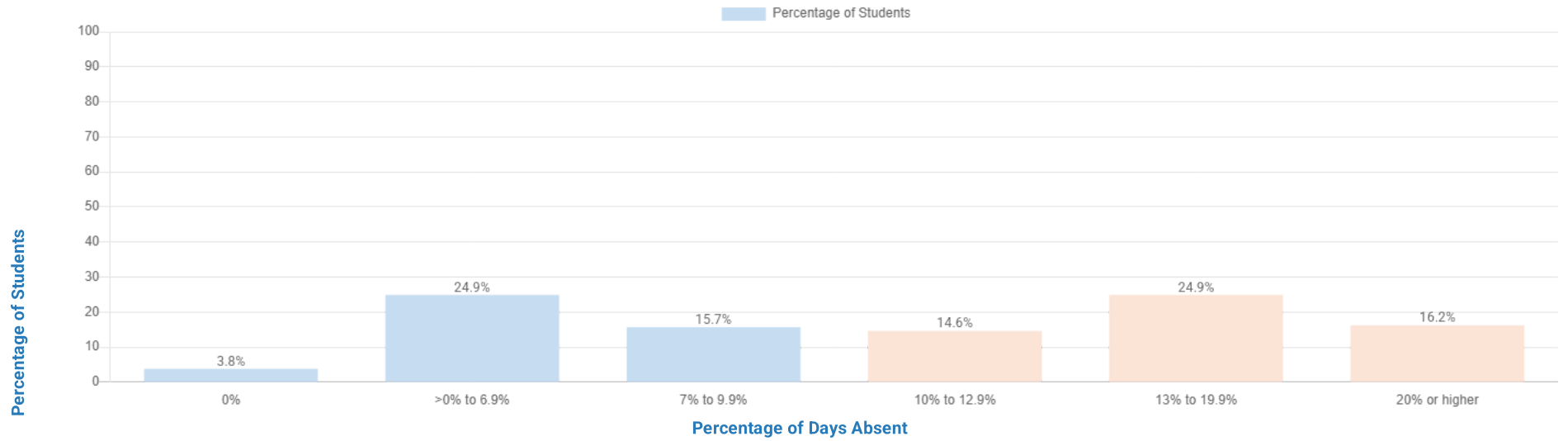

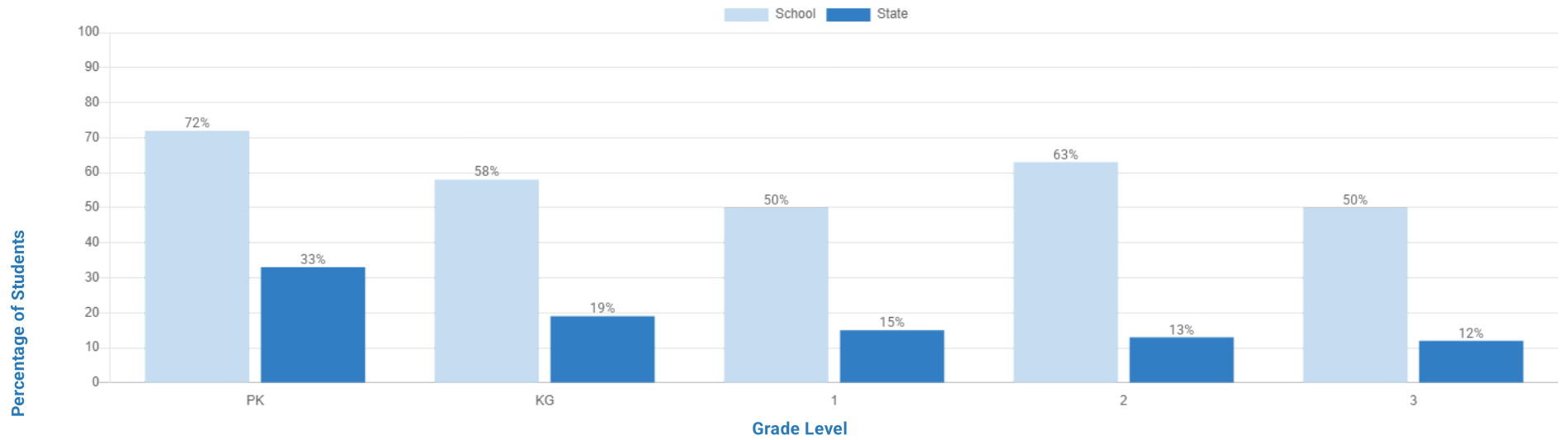

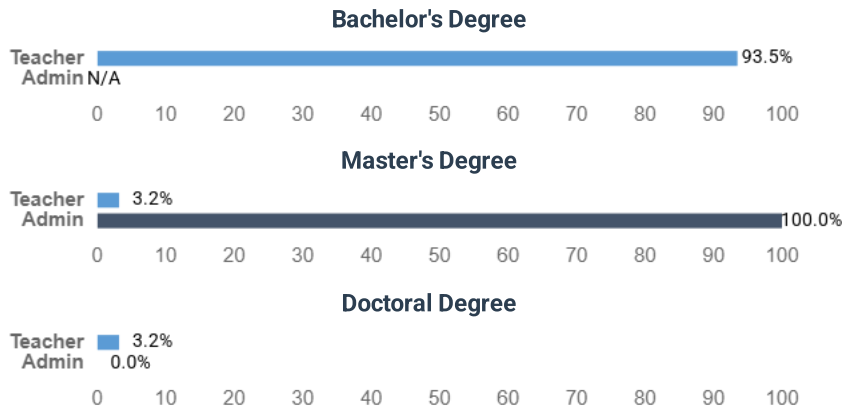

Our Kindergarten to 3rd grade students participate in organized sports offered during their physical education classes such as: volleyball, football, kickball, relay races, etc..

Our students also receive mediation and peer counseling (as needed) through our guidance counselor. Our students receive health education lessons weekly in grades kindergarten - 3rd. They cover topics such as community, dental health, eating healthy, exercise, etc.



Parent and Community Involvement:

We have a Parent Advisory Council that meets regularly and supports the planning of the school. They plan fundraisers and family engagement activities and serve on our Annual School planning as well as our Safety and Security planning for the school. Our Parent Advisory Council is supported by our school's Family and Operations Coordinator, who is responsible for advocating for families and connecting them with local services. We also serve on the Office of Early Childhood Advisory Council. We collaborate with district, community and fellow school staff to support our district's early childhood planning.

The Riletta Twyne Cream Early Childhood Center serves students in Pre-K to third grade. We have an enrollment of about 340 students with majority of our student population comprised of pre-k. Our school has 10 pre-k classrooms, 4 kindergarten classrooms, 3 1st & 2nd grade classrooms and 2 3rd grade classrooms. Each grade level has an ICR classroom which is a mix of students with IEPs.
