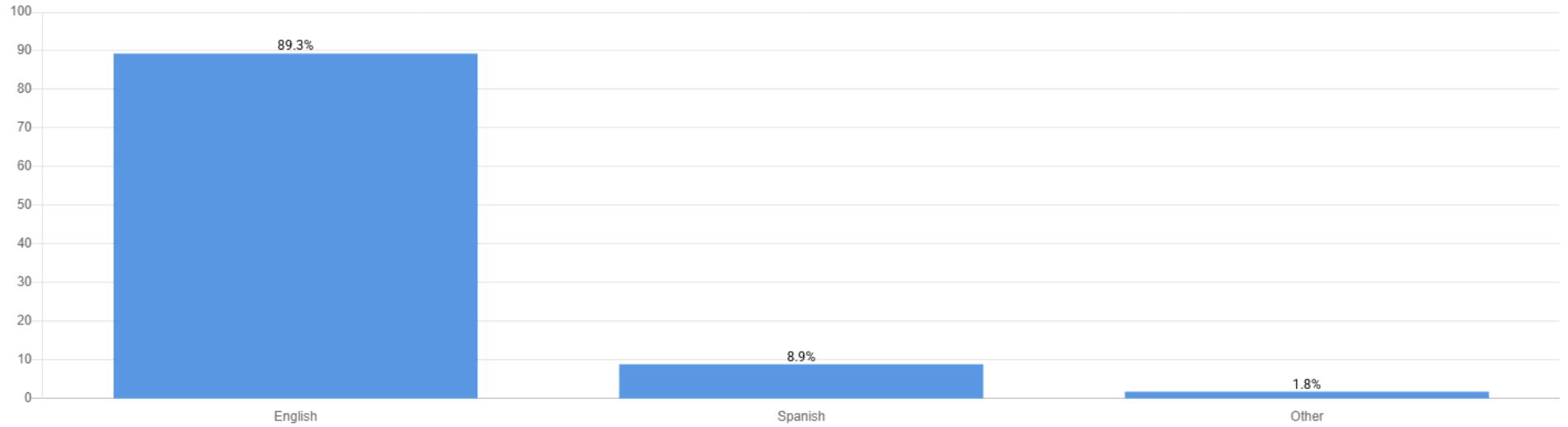

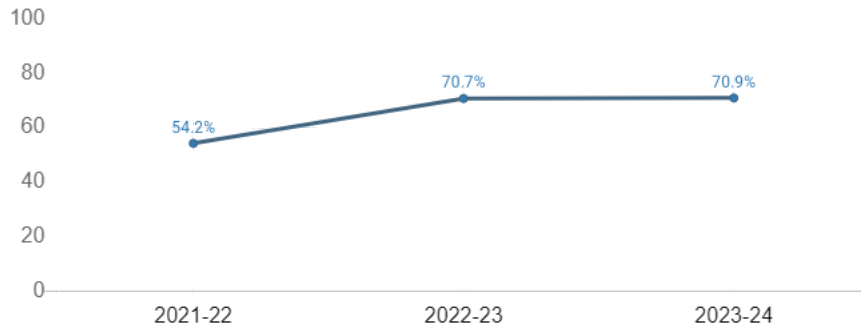

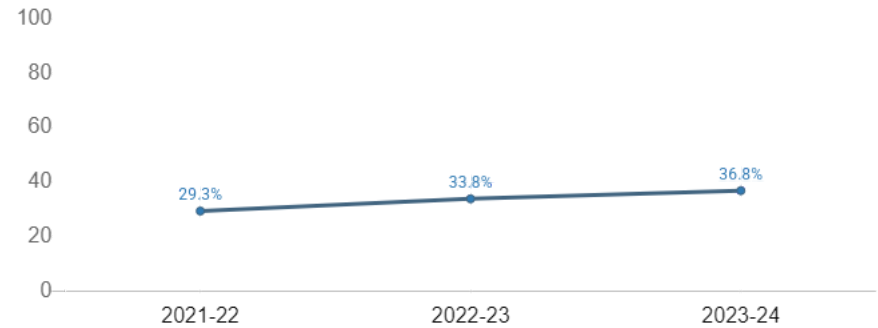
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. 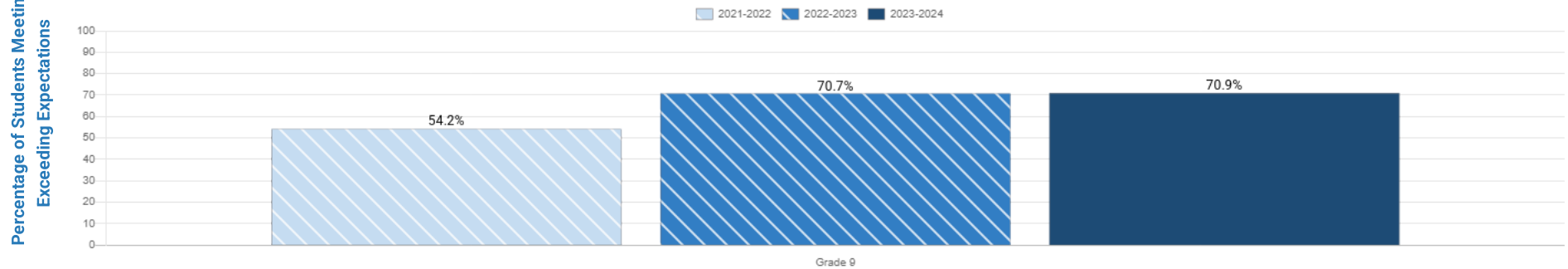

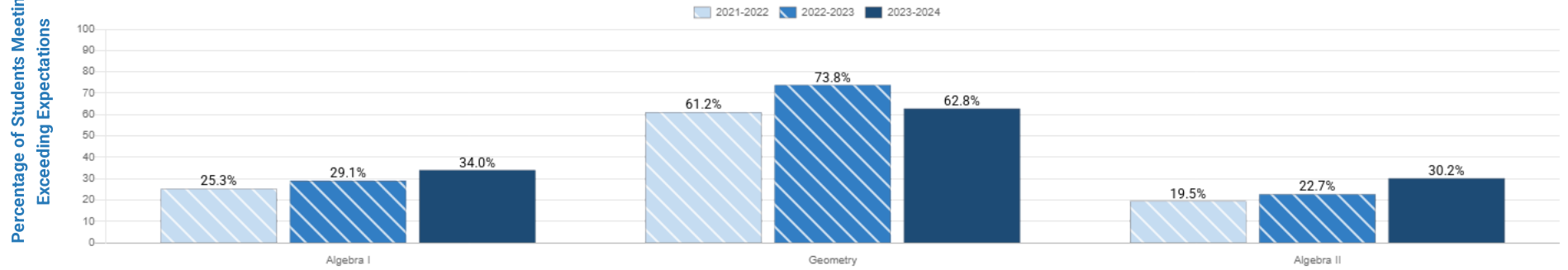

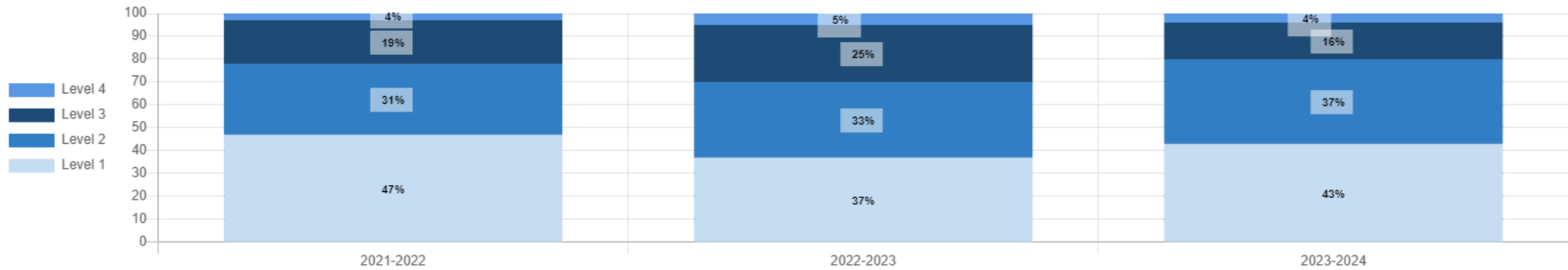

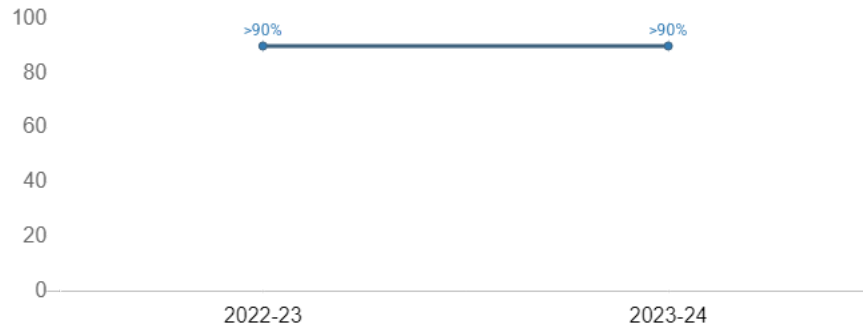

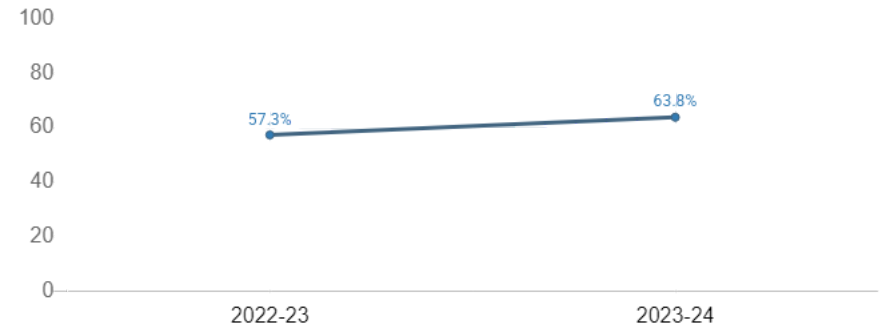

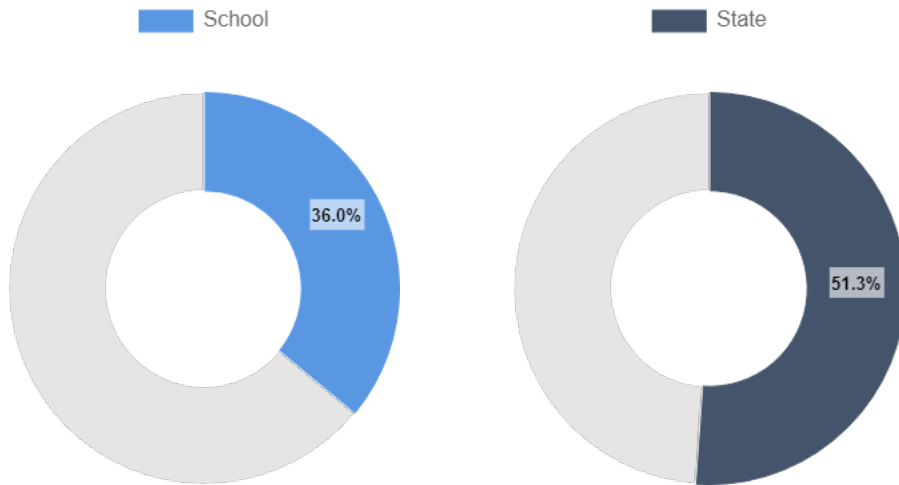

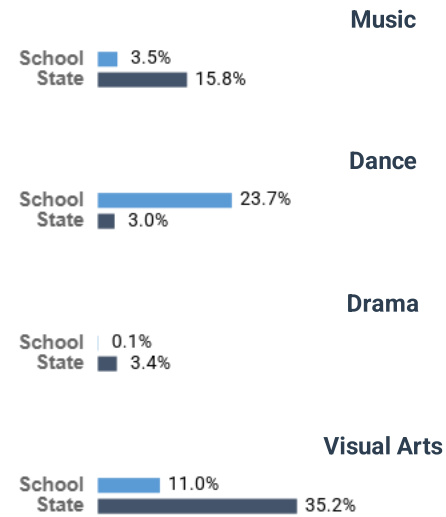

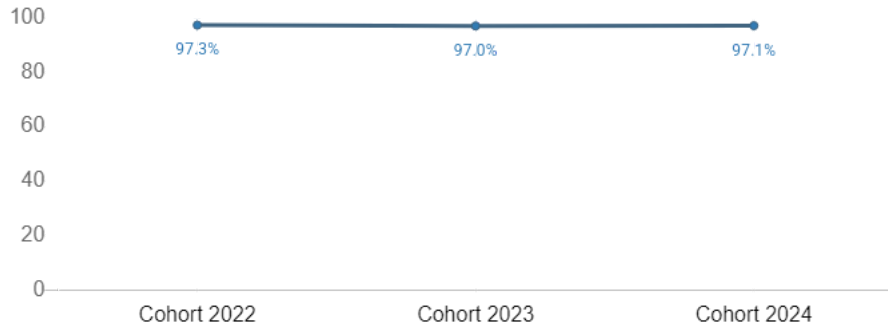

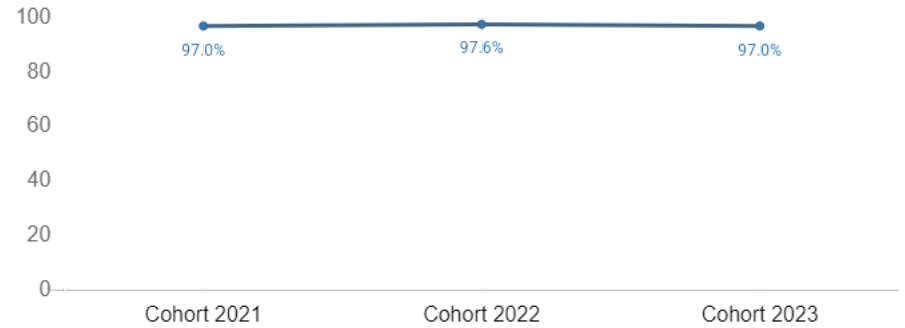

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

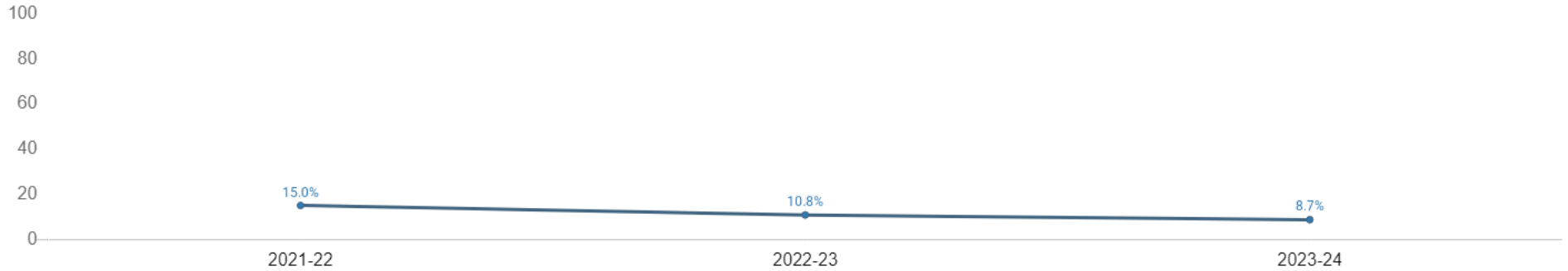

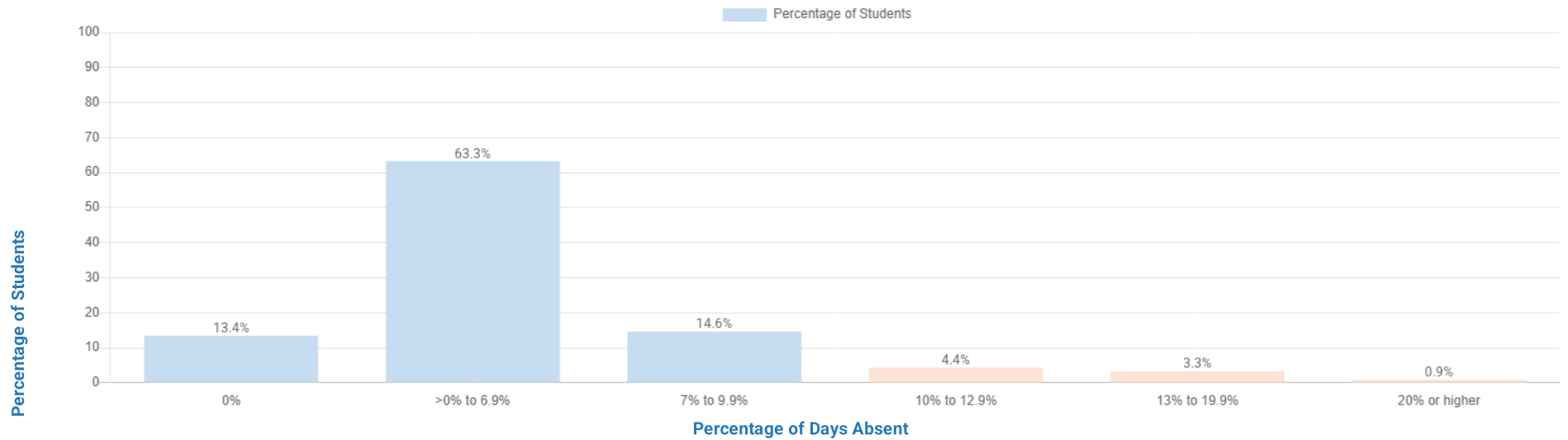

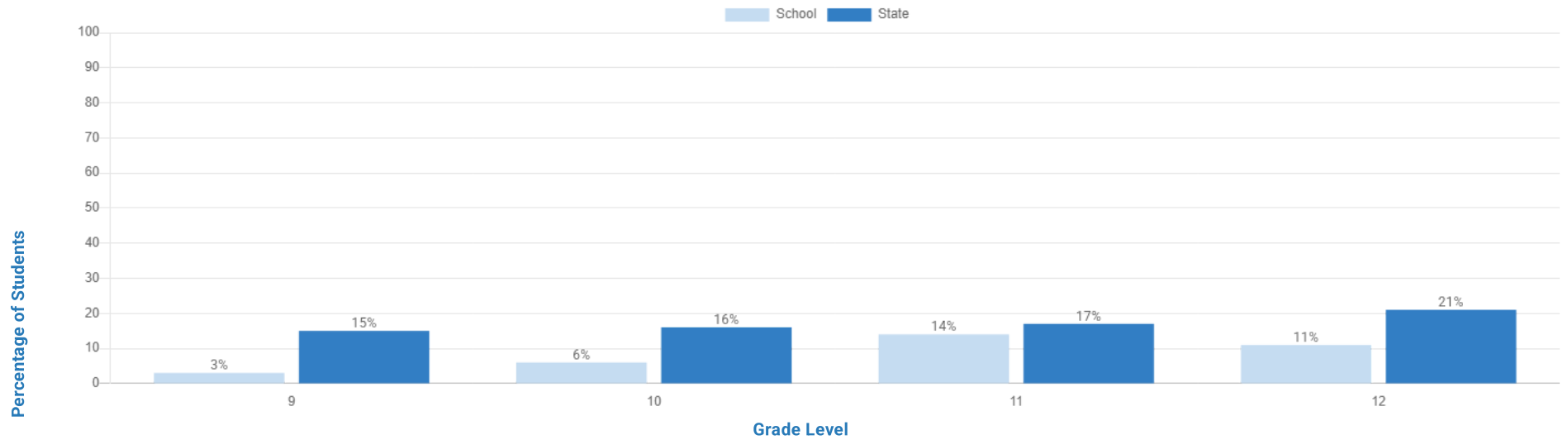

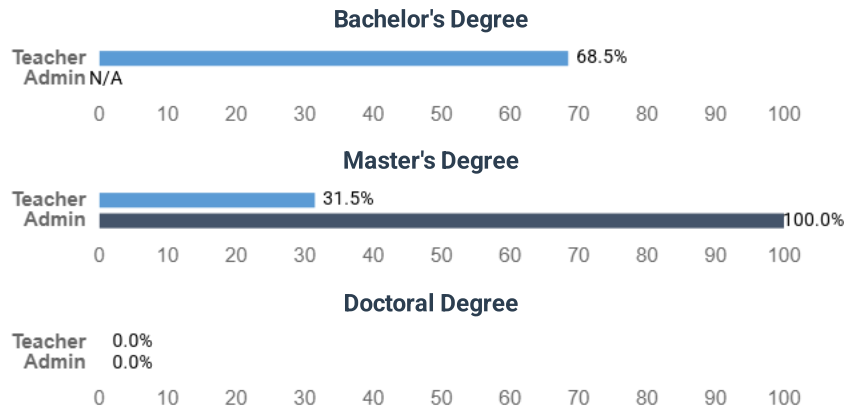

The mission of Camden County Technical Schools (CCTS) is to: Ensure all students are proficient in the New Jersey Student Learning Standards; Prepare all students for career and college success; Develop ethical character; Provide a safe, secure, and caring environment. The vision statement of CCTS: The Camden County Technical School District is dedicated to student success through college and career readiness in an ever-changing world environment; Students will develop into ethical citizens who demonstrate active inquiry and effective problem solving, while fostering creativity, communication, and collaboration skills. The student experience will include the core values of environmental awareness, emotional and social development, self-respect, and respect for others; This vision will be achieved through a collaborative effort of students, parents and guardians, the staff, the greater Camden County community, and the Board of Education.



Awards, Recognition, Accomplishments:

Our 2024 graduates were awarded a total of \$12,043,174 in scholarships. One hundred-fourteen students spent their senior year at Camden County College as dual enrolled students, earning a minimum of 24 college credits and high school credits at no cost to the students. Our Career and Technical Student Organizations continued to participate in most regional, state, and national conferences. Students who participated in Future Business Leaders of America, Family, Career and Community Leaders of America, FFA, For Inspiration and Recognition of Science and Technology (FIRST) Robotics, HOSA-Future Health Professionals, and SkillsUSA competed and won awards.

Courses, Curriculum, Instruction:

Our school offers an impressive curriculum that is aligned to the state standards. Our focus on career education allows many of our students to graduate with career-based certifications/credentials. Career programs are offered within the Schools of the Arts, Automotive Tech., Business, Communication Arts, Culinary Arts, Health & Education, Homeland Security, Professional Services, and Science, Technology, Engineering and Math (STEM). Qualifying seniors participate in our Senior Option Program with Camden County College and they earn college credits for college-level work completed while in high school. Students also have the opportunity to enter the Early College Associate Degree (ECAD) program and earn both a high school and associate's degree upon graduation. Students may also earn college credits by participating in select Advance Placement academic classes, after-school enrichment classes and units of study within certain CCTS career programs, academies and diverse academic offer



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Bowling (Boys & Girls), Cheerleading (Boys & Girls), Cross Country (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Swimming (Boys & Girls)

The Gloucester Township Campus of CCTS is a member of the NJSIAA, offers Varsity and Junior Varsity teams in multiple sports, including Basketball, Bowling, Cheerleading, Cross Country, Soccer, Swimming, Track and Field, and Volleyball. In 2023, the Girls' Track and Field team won the NJTAC Championship, and the Boys' Soccer team qualified for the NJTAC Championship game. Additionally, the cheerleading team achieved local, regional, and national competition titles. During the 2023-2024 school year, 49 student-athletes earned First or Second Team Olympic Conference All-Star honors, and several students signed collegiate sports commitments. Approximately 330 students participated in athletic programs throughout the year.



Clubs and Activities:

The school offers a variety of student activities, including Campus Courier (School Newspaper), Student Council, National Honor Society, National Technical Honor Society, Interact Club, Intercultural Club, Athletes Against Bullying, Gender and Sexuality Alliance, Yearbook Club, Jazz Band Club, Chorus Club, Performing Arts Club, and Weight Lifting Club. Additionally, the campus hosts Career and Technical Student Organizations (CTSOs) to help students dedicate extra time to their technical career fields and compete in local, regional, and national events. These CTSOs include Future Business Leaders of America (FBLA), Family, Career and Community Leaders of America (FCCLA), HOSA-Future Health Professionals, Future Farmers of America (FFA), SkillsUSA, and FIRST Robotics. From 2021 to 2024, many CCTS students excelled at state CTSO competitions, with several qualifying for national competitions each year.

Before and After School Programs:

Certified teachers provide academic support in English and Mathematics twice weekly through an after-school Extended Learning Program, and transportation is provided. Through the 21st Century Learning Centers Program, a federally funded grant, CCTS offers a variety of after-school programs which address the social-emotional, physical, career, and academic needs of its students.



Staff and Professional Learning:

Literacy initiatives include English/Social Studies interdisciplinary units & district-wide summer reading. Math teachers meet regularly by course to increase math readiness & student success, implementing math practice during the summer. Embedded professional development in project-based learning is provided for science and mathematics teachers. Teachers of all subjects collaborate weekly through professional learning communities, facilitated by teacher leaders, with a focus on student learning through common assessments, data analysis of student progress, lesson design & reflection, and instructional strategies.



Postsecondary Information:

At the Gloucester Township Campus of CCTS we are committed to helping students realize their goals. Many of our graduates pursue apprenticeships, join the military, or find immediate employment in the career path in which they have studied in order to earn a corresponding certificate. Our students have also been accepted to a wide range of great colleges and universities across the country. Some of the colleges our students were accepted to include: Camden County College, Rowan University, Rutgers University, Delaware State University, Walnut College, Drexel University, Penn State University, Temple University, Morehouse College, Thomas Jefferson University, and many more. We host an annual College Night to discuss the application process and financial aid. We also assist with scholarship information, offer the SAT and PSAT testing at our campus, and host an annual college fair. We now offer information about completing the FASFA form for 12 grade students.

We have an array of services available to meet our students' needs. Camden County Technical School also provides academic support after school in math and English with a certified teacher, as well as through a National Honor Society (NHS) Peer Tutoring program.



Student Health and Wellness:

The Health and Physical Education courses taken by our students focus on cardiovascular health training, making good decisions, mindfulness, healthy living and driver education. The school utilizes the fitness center, gym, pool, and sports fields. All students begin the day with a free nutritious breakfast provided by the school district. The school lunch program exceeds the nutritional guidelines. The nurses' office provides yearly screenings, referrals, and athletic participation physicals with the school physician. We also have a Wellness Committee which meets regularly and hosts campus-wide events.



Parent and Community Involvement:

Our Parent Advisory Committee meets three times a year with opportunities for parents to learn about available resources, meet district and school-level staff members, and participate in presentations by guest speakers. Many different voices have been heard during these meetings which have made them necessary, productive, and positive. Aside from the parent meetings, we also host meetings with business and industry leaders to ensure that our curriculum and equipment meet industry standards in all of our career programs.

The Gloucester Township Campus of CCTS surveys school stakeholders annually to gather information on how parents, staff and students perceive the learning environment, character education, and school culture. The results indicated that stakeholders felt that the Gloucester Township Campus is a caring and academically rigorous learning environment where students and staff demonstrate respect for one another.



Facilities:

The Gloucester Township Campus of CCTS consists of 12 buildings. The buildings include an Instructional Materials Center (library), computer labs, an art room, gymnasium, fitness center, pool, science labs, greenhouse, and various career program areas. The buildings have been under constant maintenance and renovation. We replaced roofs, installed air conditioning, replaced exterior doors and windows, painted hallway lockers, installed gym lockers, and renovated classrooms. We have also repaved the parking lots added five new classrooms to our facilities. We added a new career program, Manufacturing, Engineering, and Technology, also known as MET. It is now an extension to Building 6 and opened this September 2024, welcoming students to its program. The extension also houses new Chemistry labs and the science supervisor's office.



School Safety:

The safety and security of our students are our top priorities. Our campus is monitored by a state-of-the-art security camera system covering hallways, entrances, and exits, with feeds accessible to local police through a partnership. We employ a school resource officer and a team of security officers who patrol the campus regularly. An iron security fence surrounds the school, and all visitors are screened, identified, and photographed upon entry. Students and staff are required to wear ID badges at all times. We have an active Crisis Response Plan designed to protect life and property during emergencies by coordinating with law enforcement and fire and rescue personnel. Regular drills are conducted. The plan guides in managing potential crises effectively. A threat assessment team screens at-risk students, provides necessary support, and shares resources.

Pre-Engineering, Medical Arts, and Computer Science/Information Technology career programs are part of our STEM offerings. We have a STEM FIRST Robotics Team, we hold a STEM Summer Science Camp and STEM Robotics Camp each summer.



Early Childhood Education:

Students in the Early Childhood Career Program learn by hosting 17 pre-school aged children in its daycare that is open to staff members from 7-4pm.



Attendance:

GTC maintained strong student attendance in 2023-2024 through engaging programs like Homecoming Spirit Week, Respect Week, and Warrior Wear Fridays, which encourage school spirit and positive behavior. Career programs requiring certification hours also motivate students to attend regularly. An assistant principal monitors attendance, contacts families, and develops action plans to address concerns. Credit restoration is offered later in the year to support students with attendance challenges. The Star Student Achiever program further incentivizes attendance by recognizing students for character, academics, and consistency.

Other Information:

The Gloucester Township Campus of CCTS is a National School of Character as designated by Character.org. Character.org sponsors an application process for this prestigious and competitive National School of Character designation. This campus was named a National School of Character in 2020 and will hold the title until 2025. Students, staff, and parents all took part in the application process. Camden County College (CCC) provides high school juniors and seniors at Camden County Technical Schools with various opportunities to earn college credits for college-level work completed while in high school. Students may bank the credits earned for future enrollment at CCC or transfer them to other colleges and universities. Students may earn college credits through various programs by participating in select AP academic classes, after school enrichment classes, and through units of study within certain career programs. These dual-credit programs not only accelerate student achievement, but they also save students time and money. Seniors may also be eligible to participate in our Senior Option program whereby they attend Camden County College full time during their senior year at no cost to the students. Students who participate can earn a year's worth of college credits when they successfully pass their courses. Qualifying students participated in our Early College Associate Degree Program (ECAD) with Camden County College; they will earn an Associate's Degree while in high school. During the 2023-2024 school year, our student members of our Career and Technical Student Organizations (CTSOs) participated in and won regional, state, and national awards, even though many were held remotely. Students who participated in competitions for Future Business Leaders of America, Family, Career and Community Leaders of America, FFA, For Inspiration and Recognition of Science and Technology Robotics, HOSA-Future Health Professionals, and SkillsUSA competed and won.
