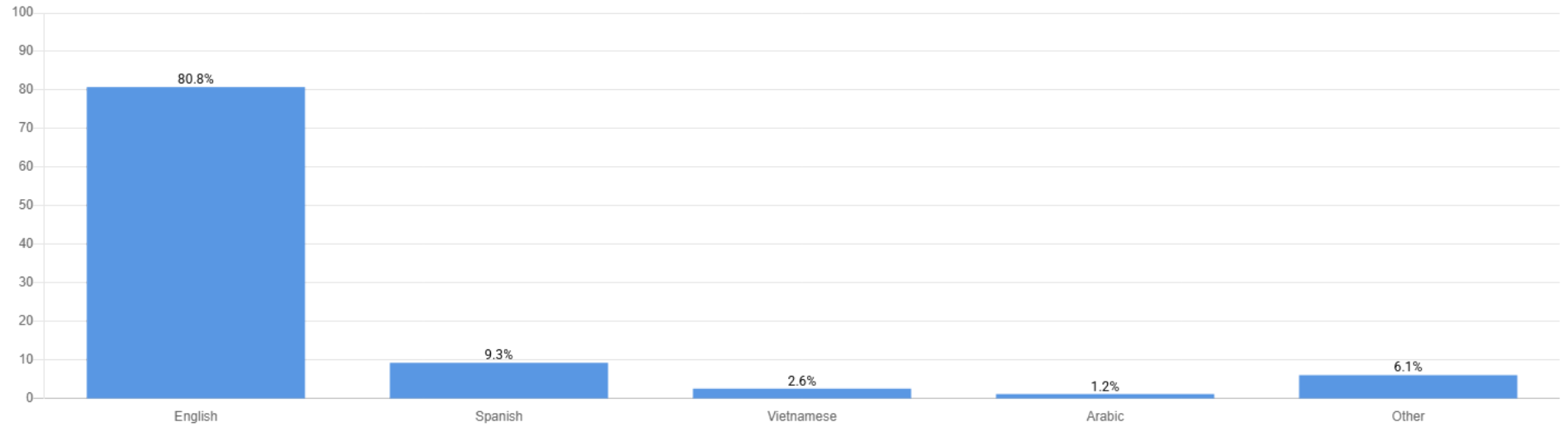

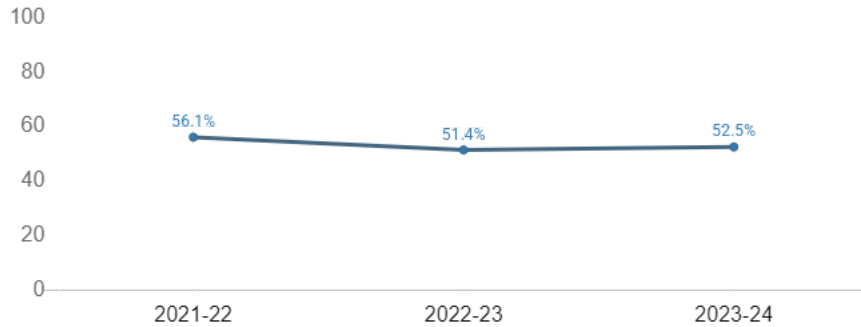

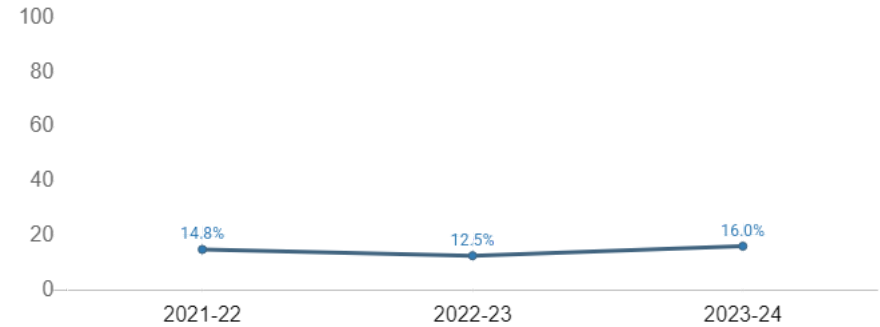
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. 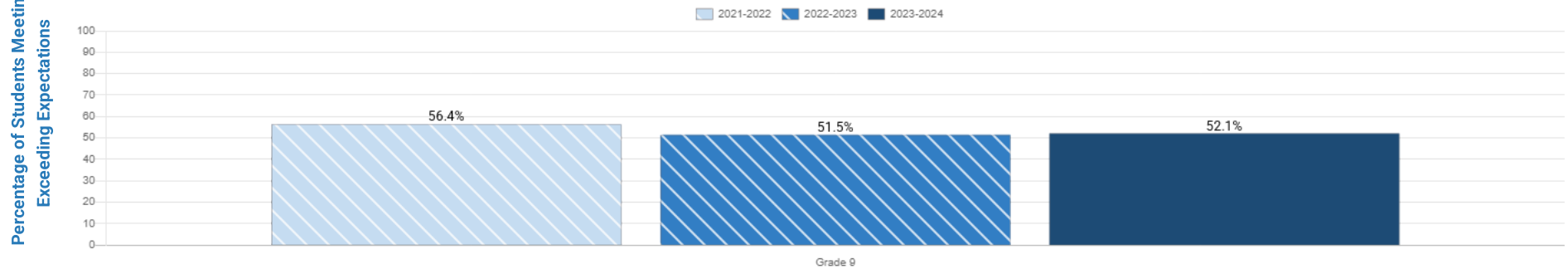

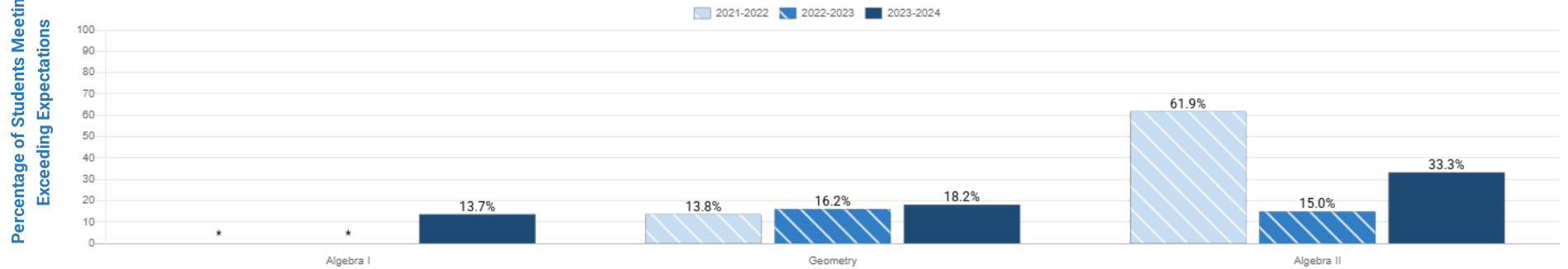

The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

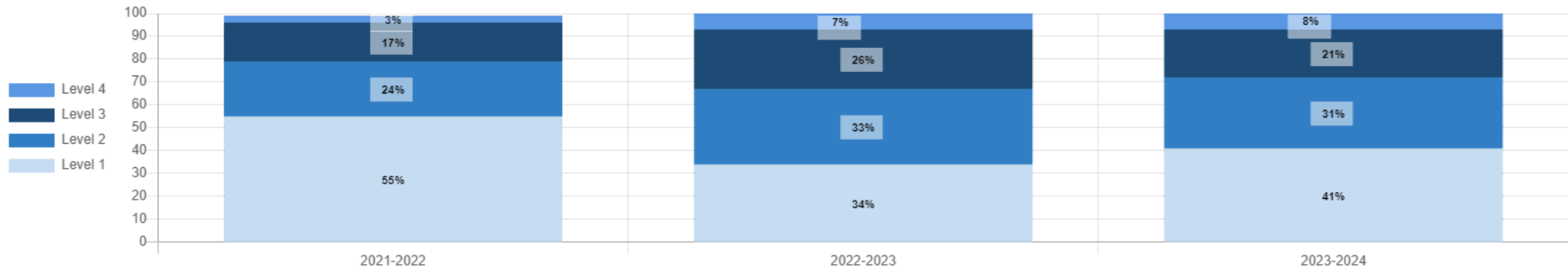

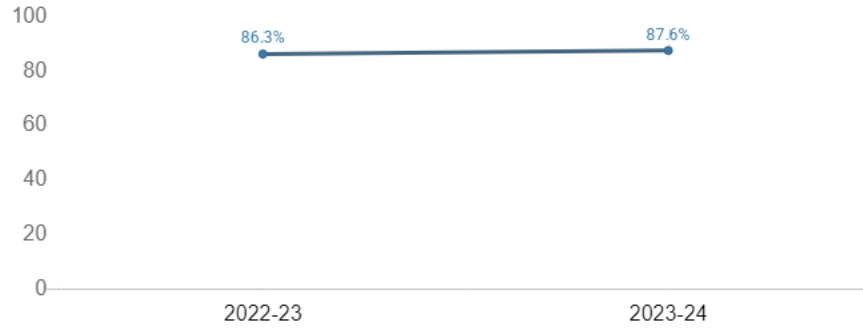

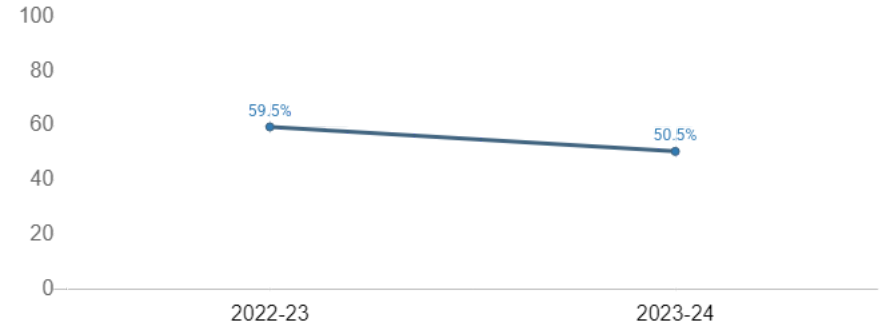

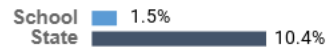

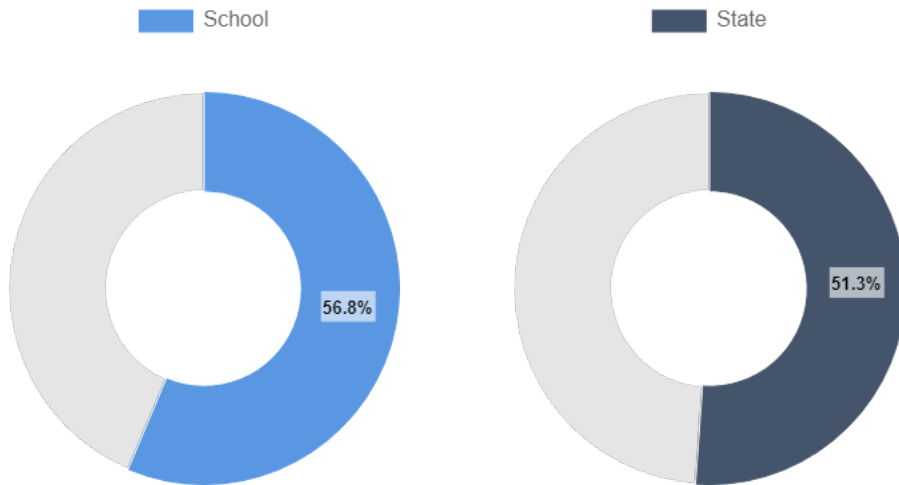

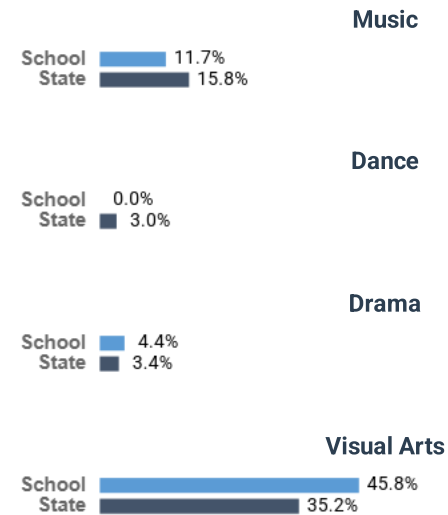

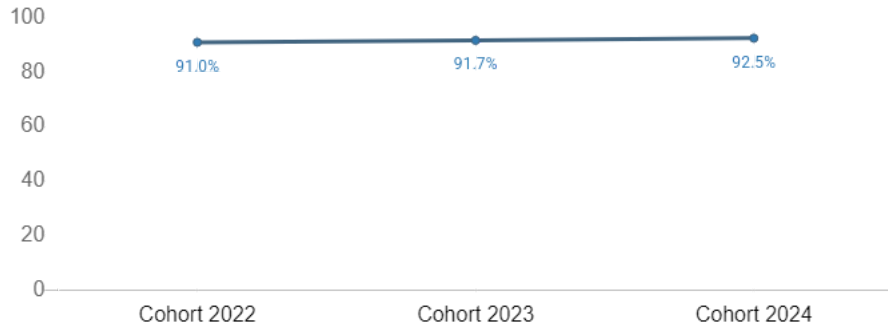

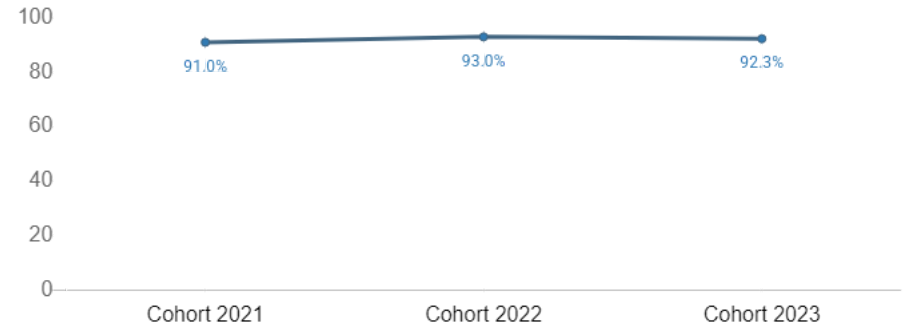

Graduation/ Postsecondary

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

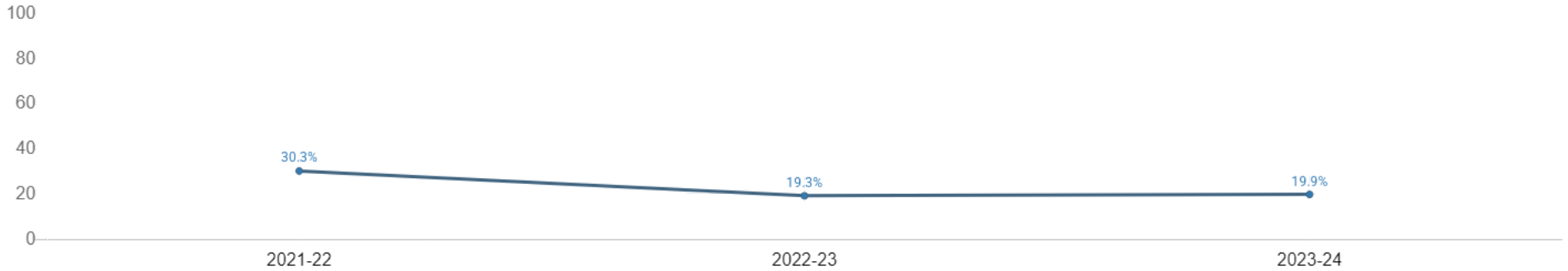

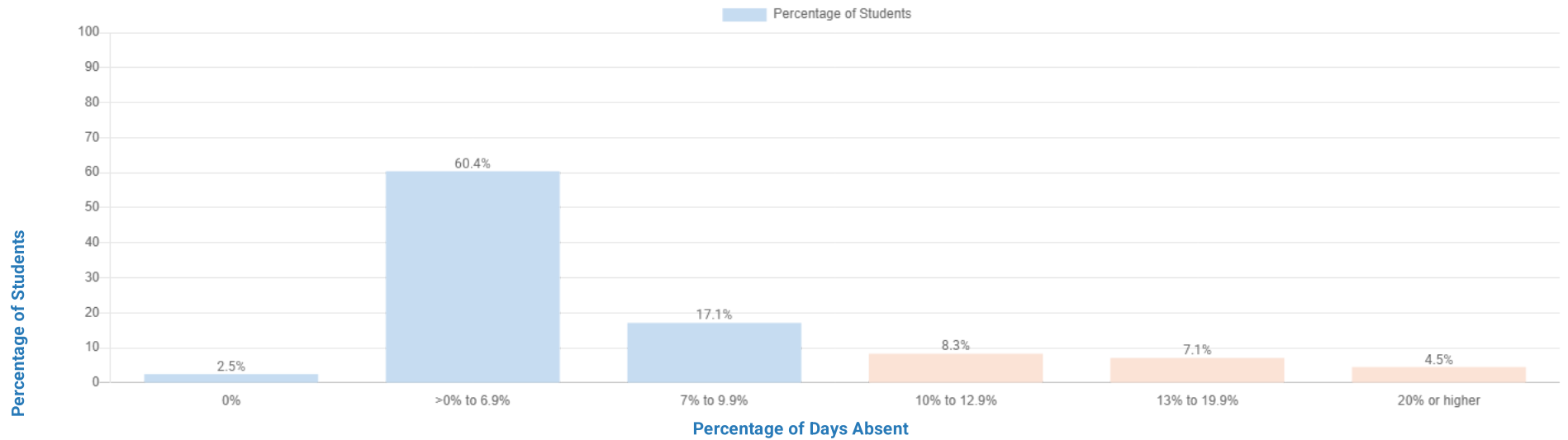

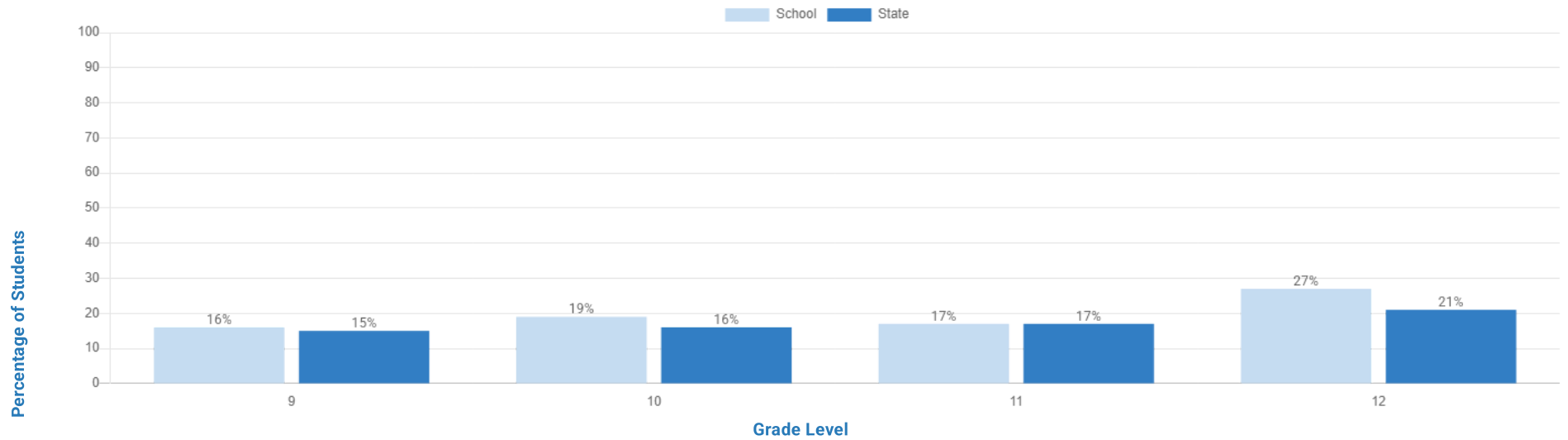

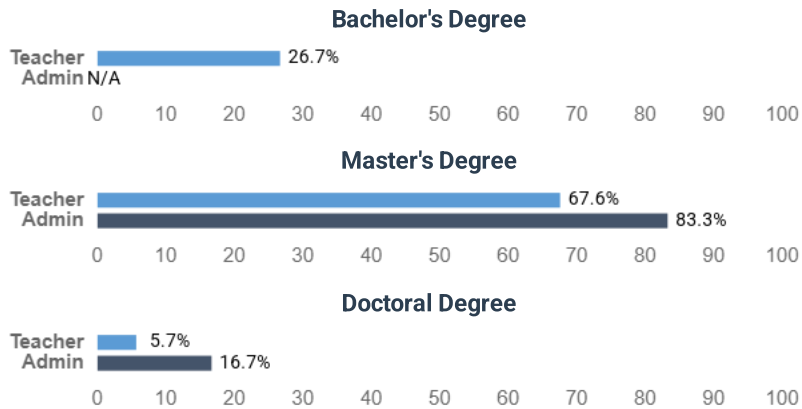

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. West Athletics also has 2 Unified Sports teams in conjunction with SONJ. Cherry Hill West competes in the National Division of the Olympic Conference. West pride is demonstrated via high participation numbers in all athletic programs and an active student body who support these programs. Upgraded facilities include a new artificial turf field, a state of the art sound system in the main gym, upgraded grass fields, new scoreboards, and new baseball and softball dugouts. Additionally, we offer Esports as a Varsity & Sub-Varsity sport which is connected to our athletic programming. Esports engages students through technology and gaming.



Clubs and Activities:

An active Principal's Student Advisory Council promotes student leadership and student voice. A variety of grade level and mixed grade level groups exist to lend their voices to school climate needs. More than 1,000 male and female students participate in athletics on 26 varsity teams. Award winning vocal and instrumental musical program featuring the West Marching Band and Color Guard. An active National Honor Society (NHS) Student leadership opportunities include: Principal's Student Advisory Council, Student Aspirations Committee, Student Government Organization (SGO), Class Governments, No Place for Hate Committee, Positive Coaching Alliance, Captains Club, and Student Diversity Council. A comprehensive HW Club exists with afterschool and evening virtual hours to support students in meeting their academic goals. Our Community Service group and Latinos at West perform numerous service projects both in the building and the Cherry Hill community at large.



Before and After School Programs:

National Honor Society and various World Language Honor Societies provide tutoring to students after school. Students in need of additional support may obtain teacher assistance via the Success Center. Homework Club (teacher provided support) is offered after school and at night. Postsecondary Information:

More than 90% of seniors are college bound each year. The Guidance Department hosts an annual college night and financial aid nights to discuss the application and process of applying for financial aid. A semesterized SAT course is offered during the school day, and SAT/ACT workshops are offered each summer; PSATs are administered during the school day each October. Annual participation in the Malcolm Bernard HBCU College Fair to increase diversity college access and attainment. A sampling of colleges/universities attended by recent West graduates is: Princeton, Columbia, Brown, Cornell, Drexel, Rutgers, Harvard, Johns Hopkins, Rider, NYU, North Carolina A&T, Stevens Institute of Technology, Rowan, and Berklee College of Music. Graduates also enlist in the military each year.



Student Health and Wellness:

Students receive a semester of Health education each year that covers healthy living, mindfulness, driver education, and making good choices. Students complete a semester of Physical Education each year, and learn lifetime fitness techniques and game play. Breakfast is offered in each high school to all students on free and reduced lunch. Policy 8505, Wellness Policy and Nutrient Standards for Meals and Other Foods provide details of programs, procedures and curriculum and School Level Wellness Committees.



Parent and Community Involvement:

There is an active PTA, Parental Principal's Advisory Council, and a district SEPTA (Special Education PTA). These groups meet with the school administration and hold meetings to inform parents about school events, as well as to provide feedback. Title I holds community meetings throughout the year to ensure that we are including all stakeholders in decision making. To increase achievement and awareness of career and technical education programs, West conducts bi-annual stakeholder groups. Parents have access to Genesis Parent Portal containing information about grades and assignments for their children. Teachers provide updates on a frequent basis. Community partnerships with the Cherry Hill African American and Hispanic Civic Associations are another important hallmark of Cherry Hill High School West. Our Latinos at West student group held a 20 year anniversary gala where former members attended to celebrate with current students.

Climate Surveys:

In addition to our formal data collection in 2023 through the NJ SCI platform, climate surveys in 2023-24 were completed in a more informal basis through PTA meetings, Title 1 meetings, Student Grade Level Groups, Principal's Advisory Council, Superintendent Focus Groups with students, etc.; in addition, West uses data from the prior year's surveys. We were able to use this data to support students and staff based on their recommendations. We were able to offer academic support in the evenings and SEL support through PD and parent and student group feedback.



Facilities:

Cherry Hill West was built in 1956 and underwent several additions including a major science wing addition. There is an active library with a computer lab and several other computer labs throughout the building. A secure entrance vestibule, along with card access and external and internal security cameras have been installed. During the summer of 2023, roofing work was completed at the building.
