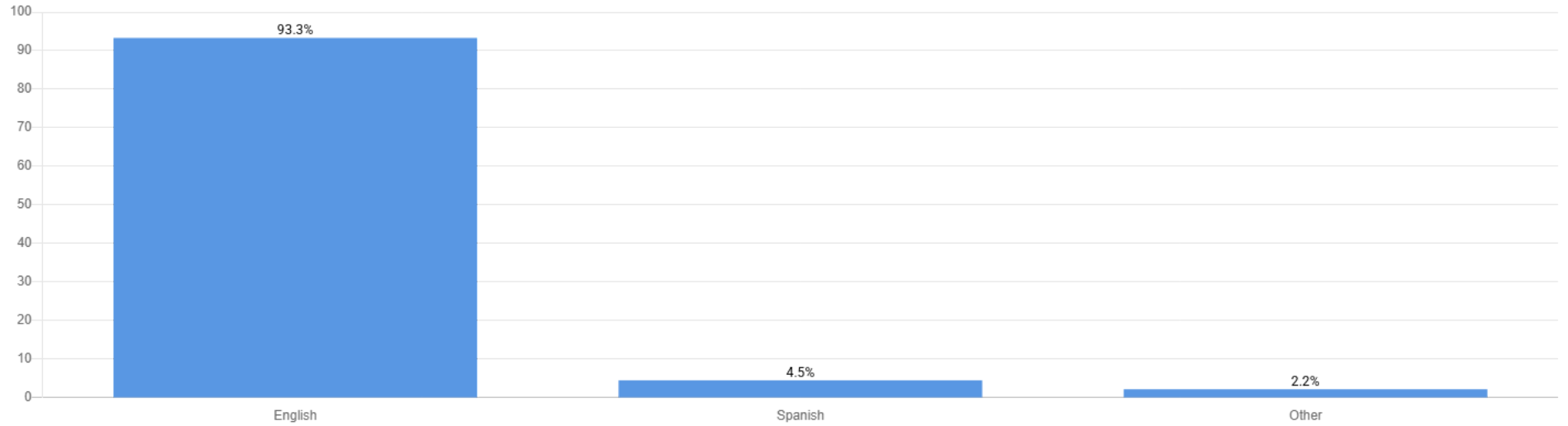

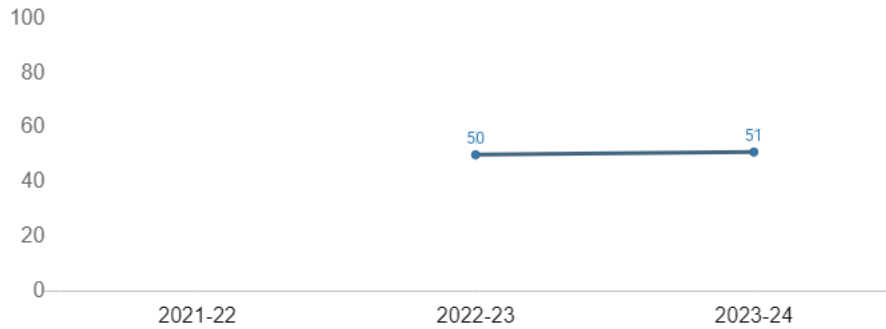

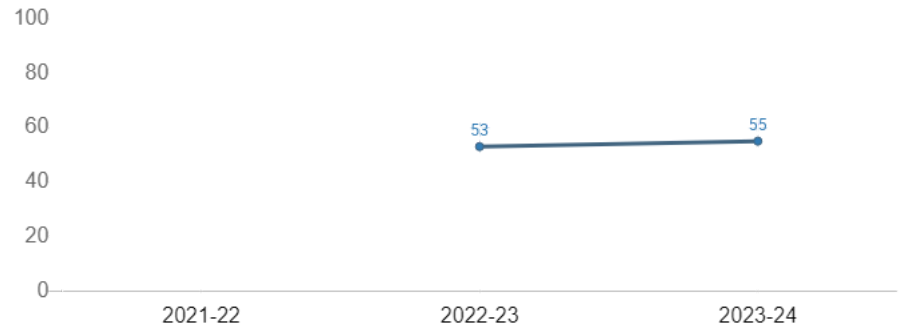

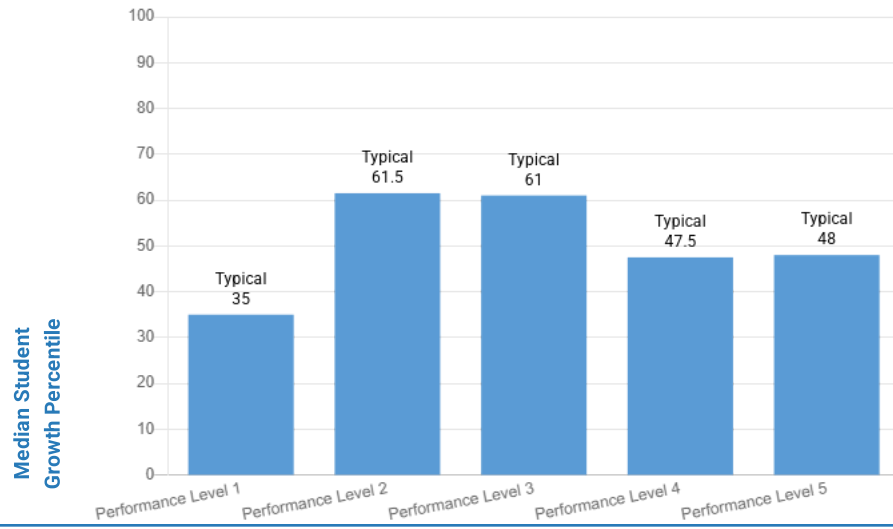

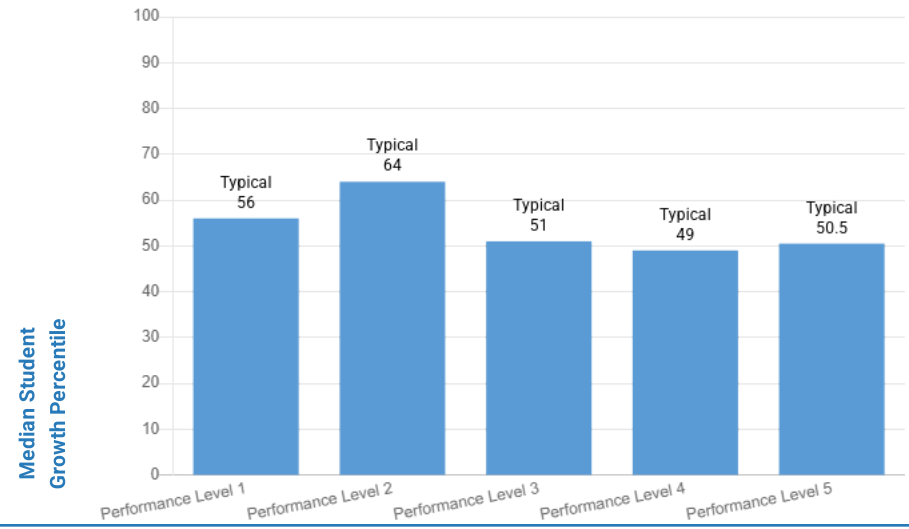

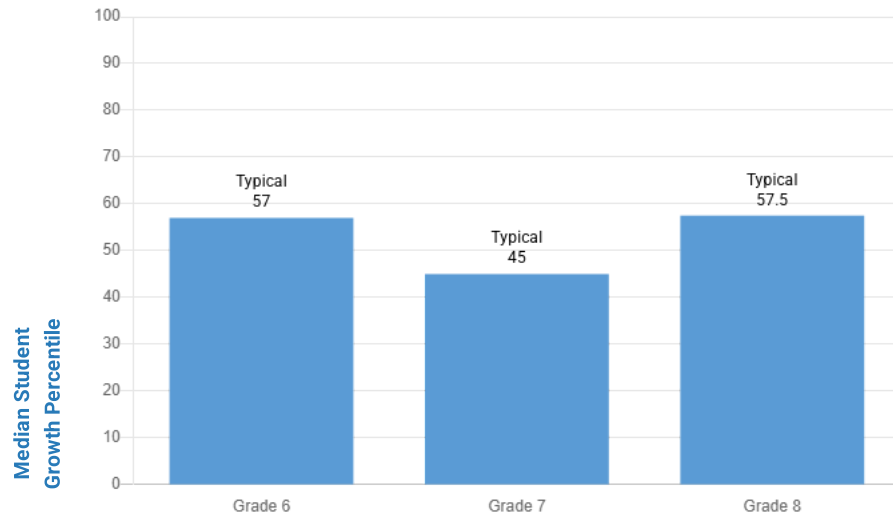

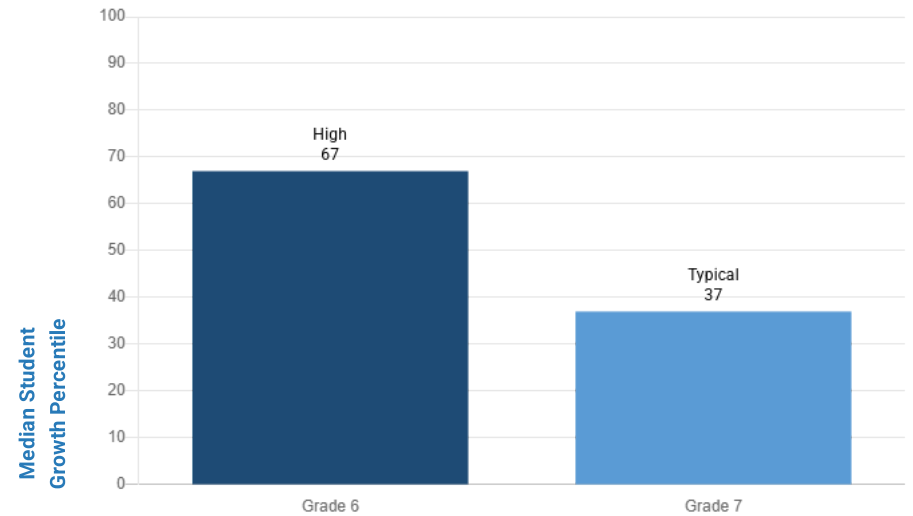

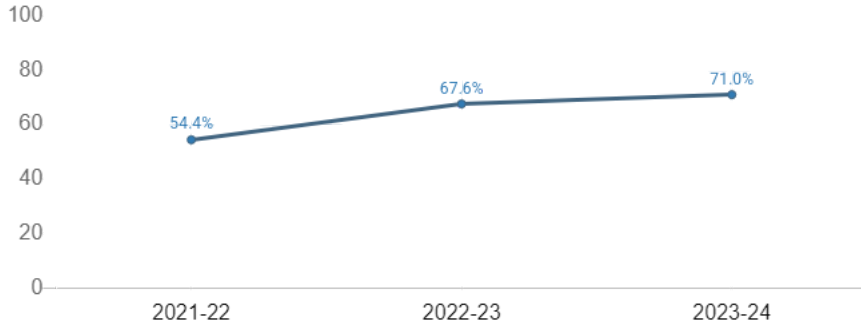

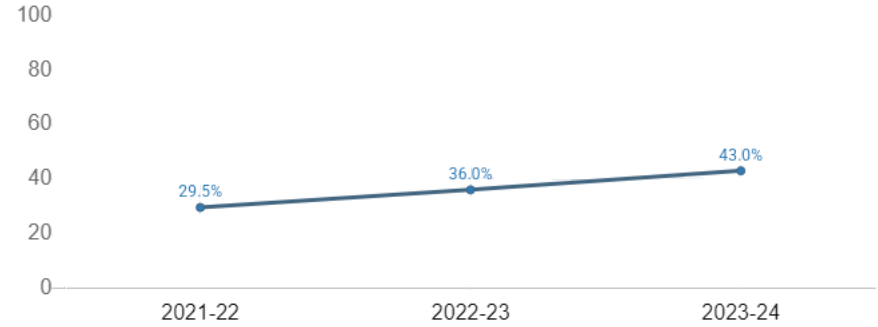
English Language Arts and Mathematics Performance Trends

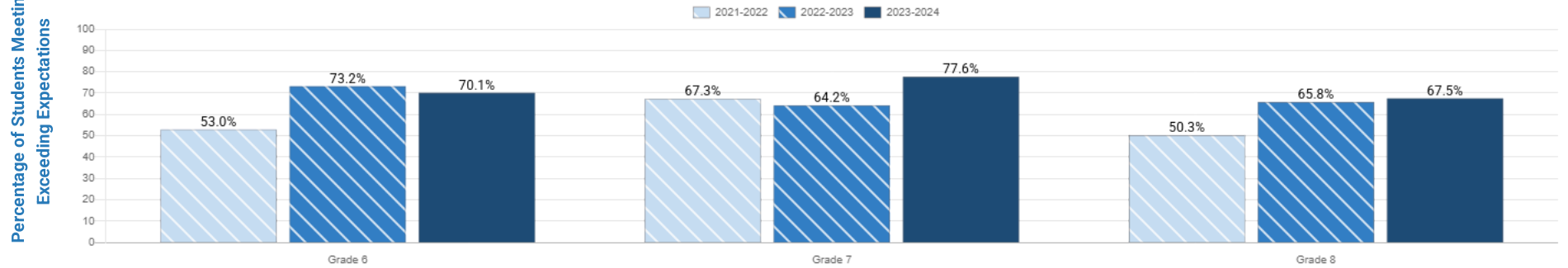

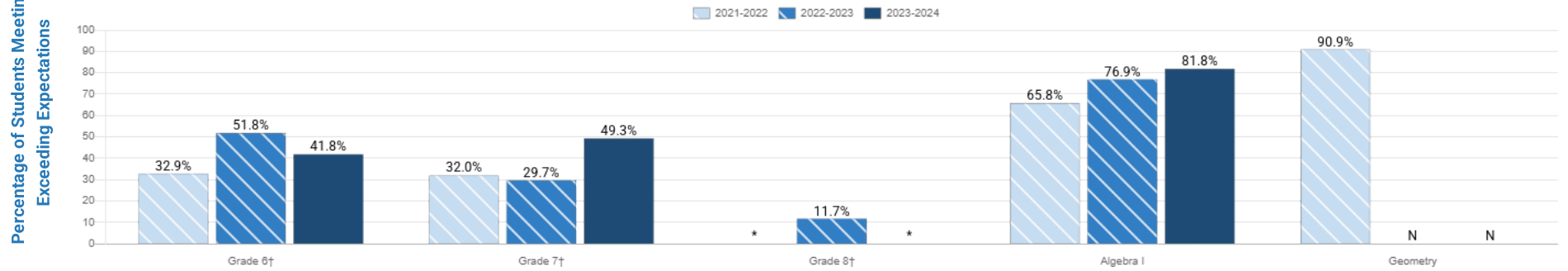

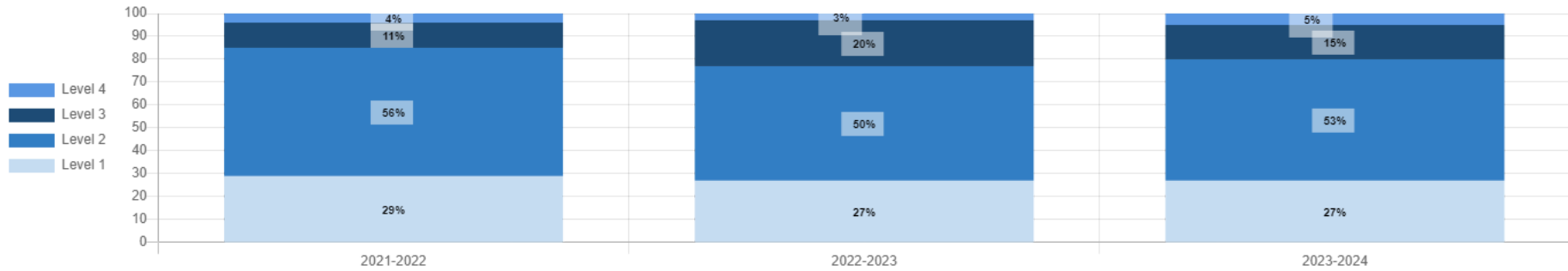

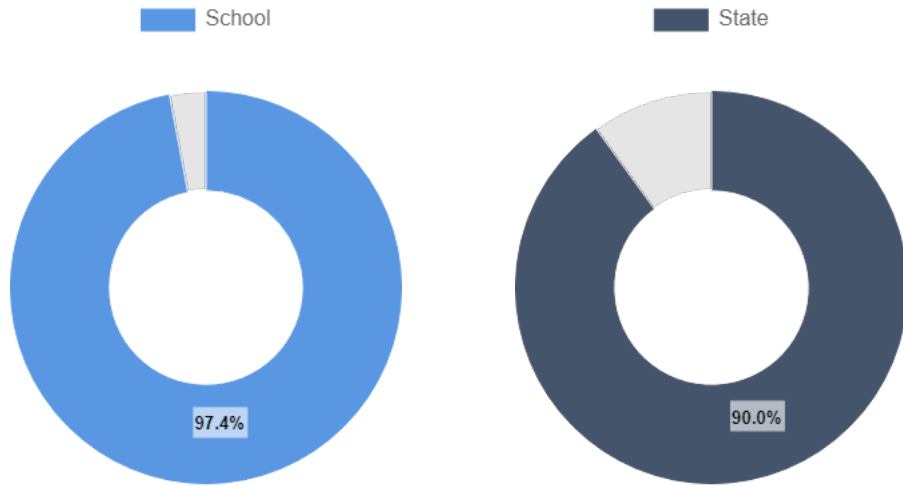

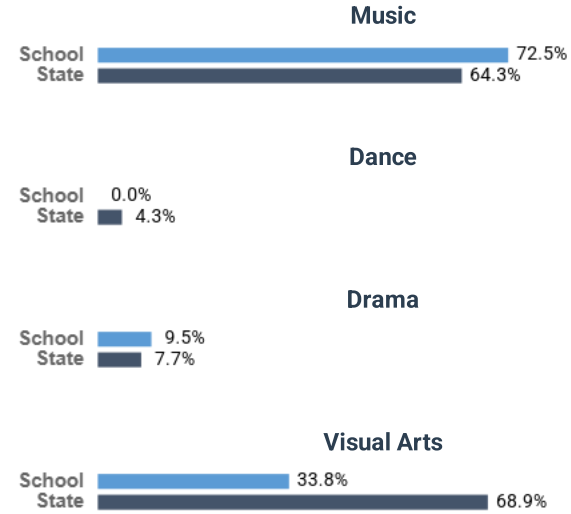

Students enrolled in one or more classes by discipline:



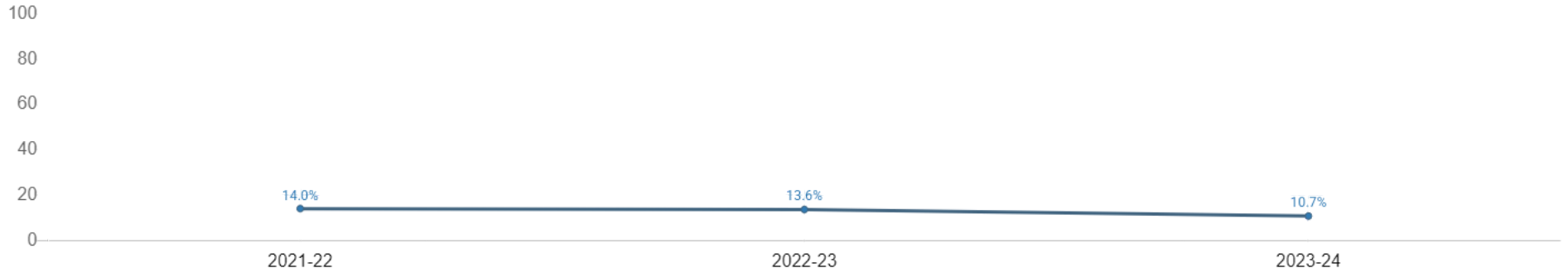

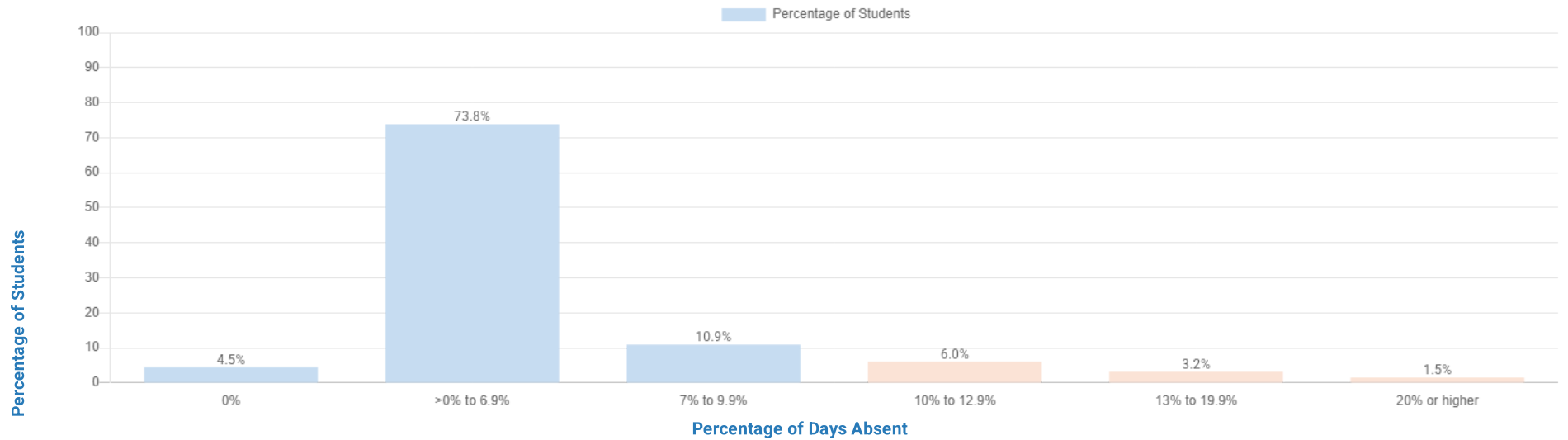

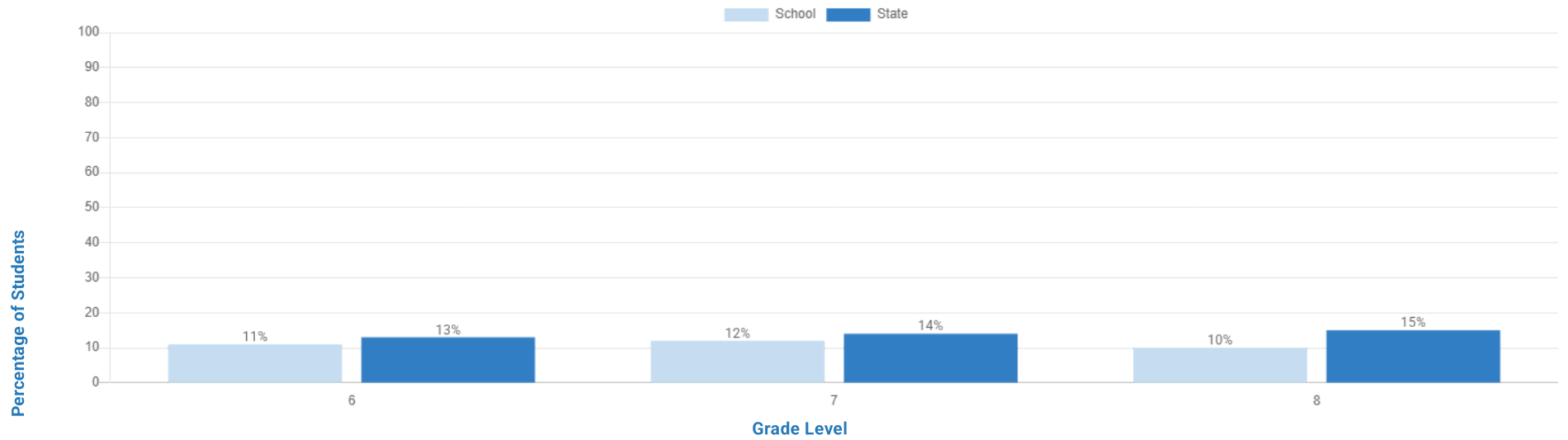

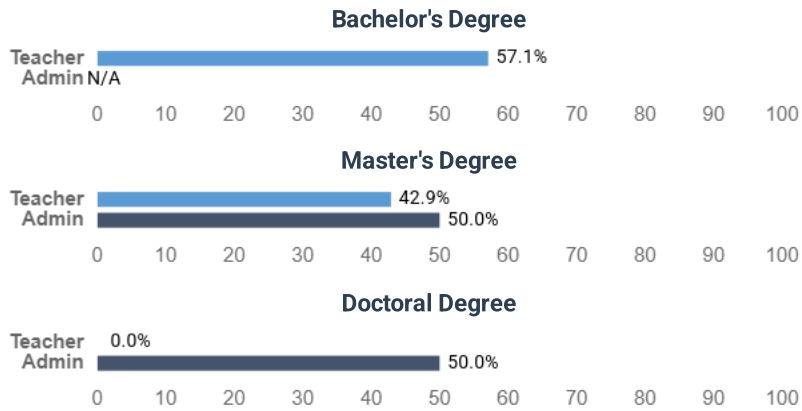

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

Literacy and problem-solving are integrated across the curriculum. Students are given the opportunity to apply their knowledge through their participation and performance on cross-curricular units, assessments, and multi-text analysis. The Writer's Workshop curriculum is incorporated into LA instruction in grades 6 through 8. Literacy and problem-solving skills are reinforced through the concerted efforts of the entire staff in a systematic and integrated manner. Online Common Lit Program provides our students with leveled texts based on formative data. Guiding questions, assessments, discussions, and annotations that are incorporated into the program reinforce and extend learning. Into Math Program provides teachers and students with the flexibility and variety of print or digital content and instructional delivery. Embedded assessments furnish teachers with a means to easily monitor, forecast and accelerate growth.

Staff and Professional Learning:

Staff members participate in sustained, differentiated prof development. Opportunities for prof development and growth are provided through a prof development program that is a direct outgrowth of student needs. The Prof Development Program consists of Collaborative Learning Communities and both internal and external seminars, workshops, and coursework. Recent prof development has focused on visible learning, trauma-informed care, effective online teaching strategies, restorative practices, cultural sensitivity, diversity and accelerated learning. Prof Learning Communities meet on a regular basis for ongoing department level prof development. CMS is in year 1 of the 3 year NJ Inclusion Project (NJIP) Grant, managed by the NJ Coalition for Inclusive Education (NJCIE). The NJIP Grant represents a comprehensive endeavor designed to facilitate systemic change and promote inclusive education. Prof Development and coaching in the area of inclusive ed. is provided through the NJIP grant.



Student Supports and Services:

Academic support is provided to the students through a content-related Accelerated Learning Activities, READ 180, STEM Lab and After School Homework Club. A comprehensive I&RS program is in place to further assist at-risk students. A school-based I&RS team meets regularly to review at-risk students and formulate and implement interventions to support both academic progress and social emotional learning. In addition to I&RS, a student recognition/incentive program utilizes the principles of positive behavior supports in school (PBSIS) to further support our students. Although CMS does not currently use a universal screening instrument for grades 6-8, the Collingswood Schools Wellness Center utilizes screening instruments with students referred for services. The purpose of these screenings is to ascertain appropriate supports for student mental health and social and emotional growth and development.



Parent and Community Involvement:

An extension of our school climate is evident in the atmosphere of mutual respect that exists between the home and the school. The PTA is extremely active and involved and significantly contributes to the life of both the school and the community. PTA-sponsored activities provide the students with a wide variety of rich and meaningful social and educational experiences.
