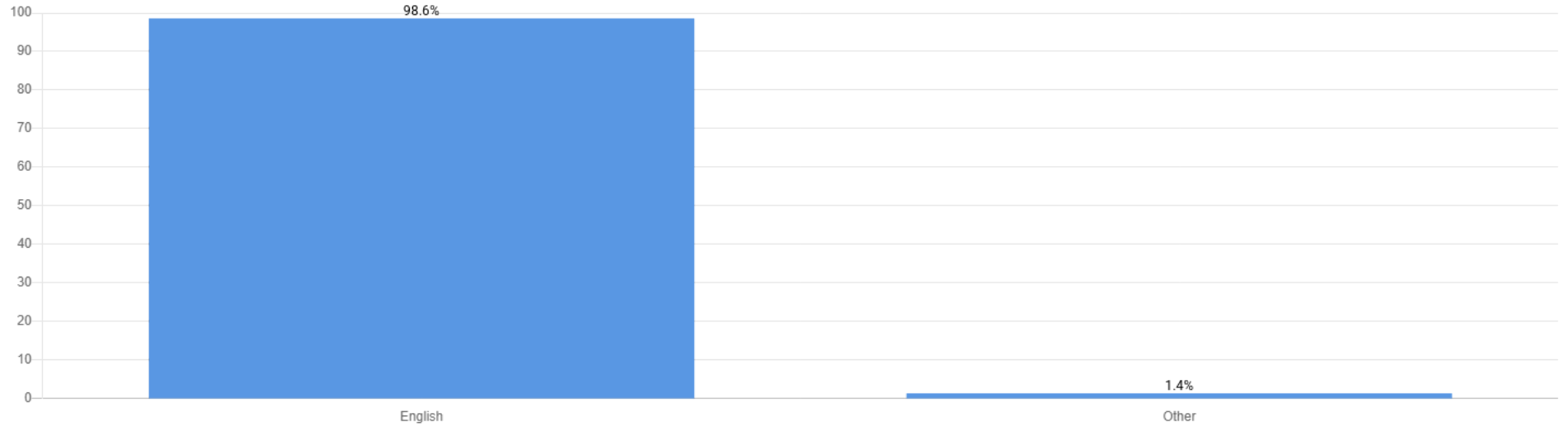

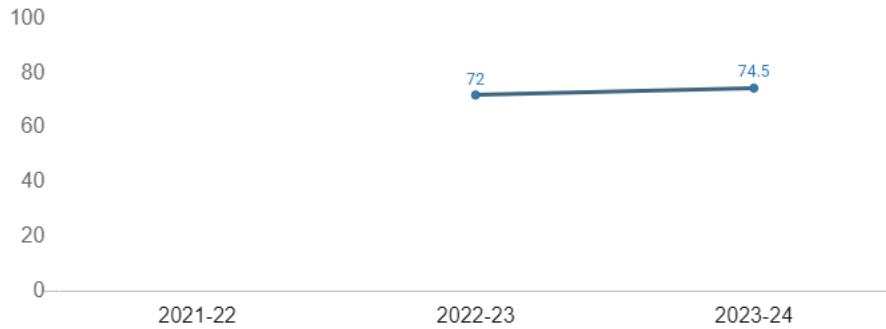

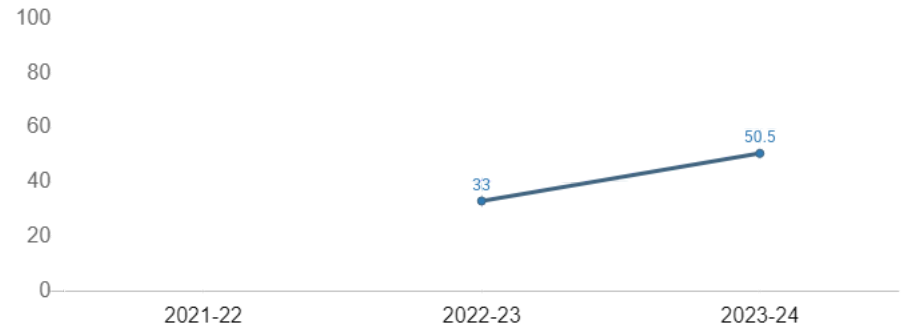

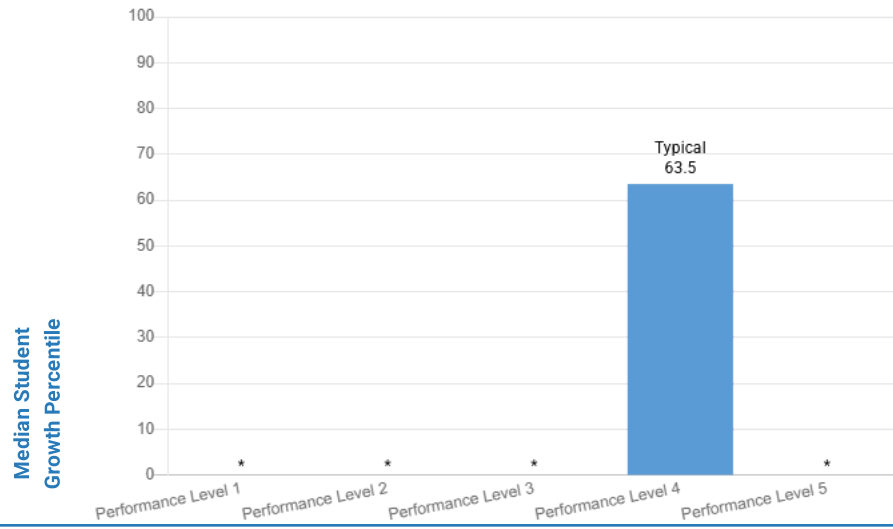

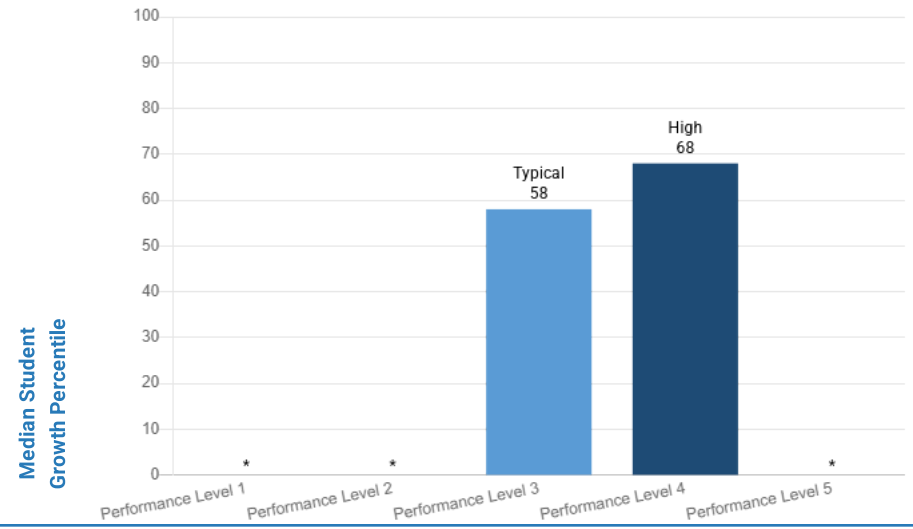

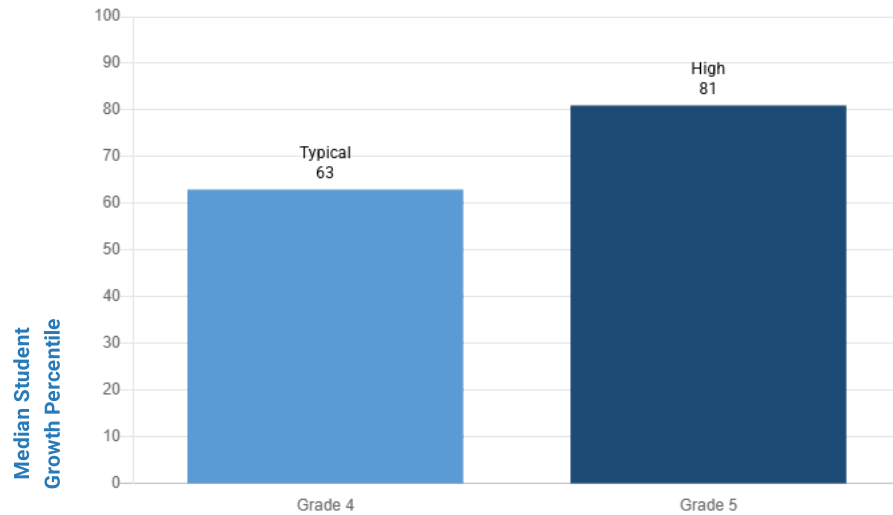

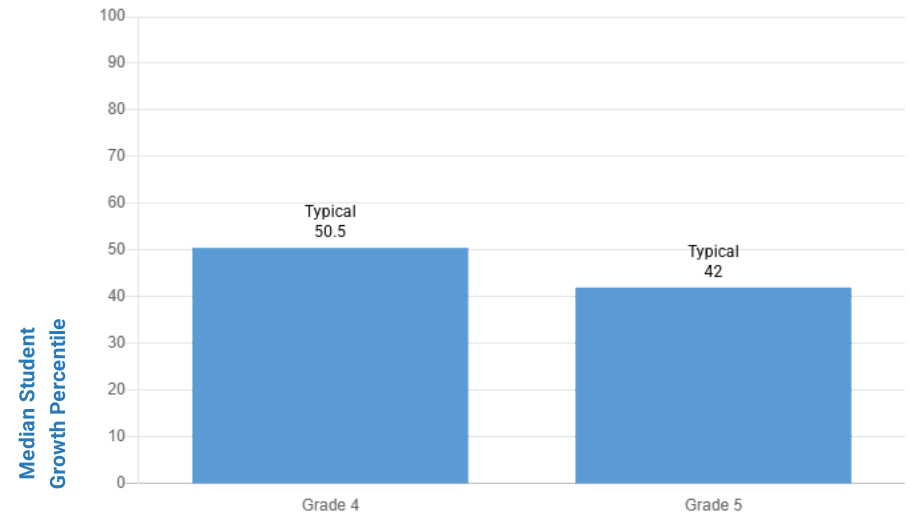

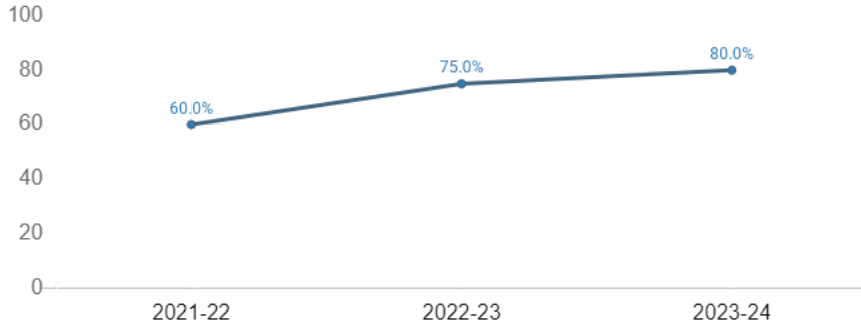

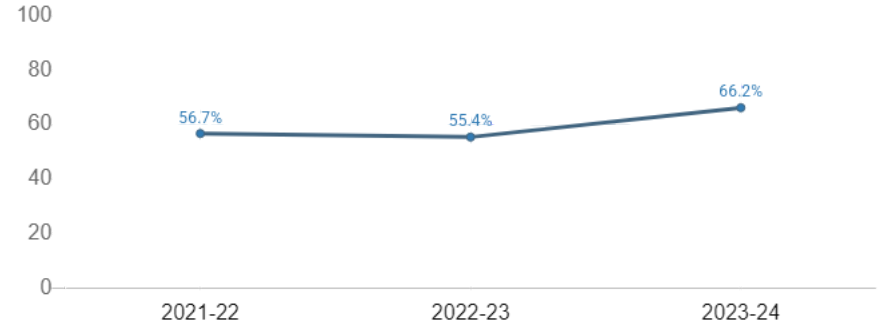
English Language Arts and Mathematics Performance Trends

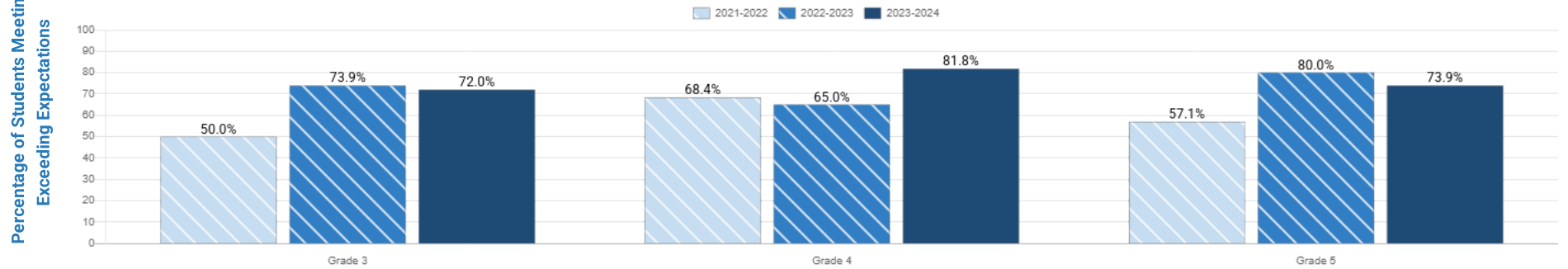

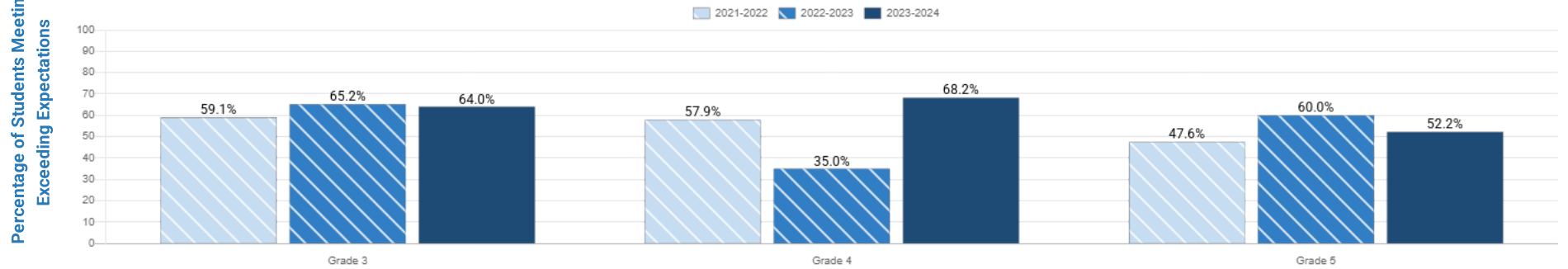

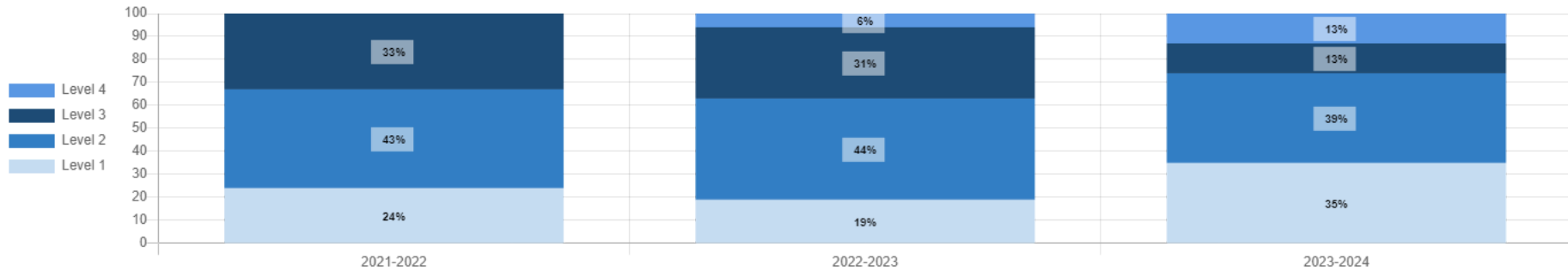

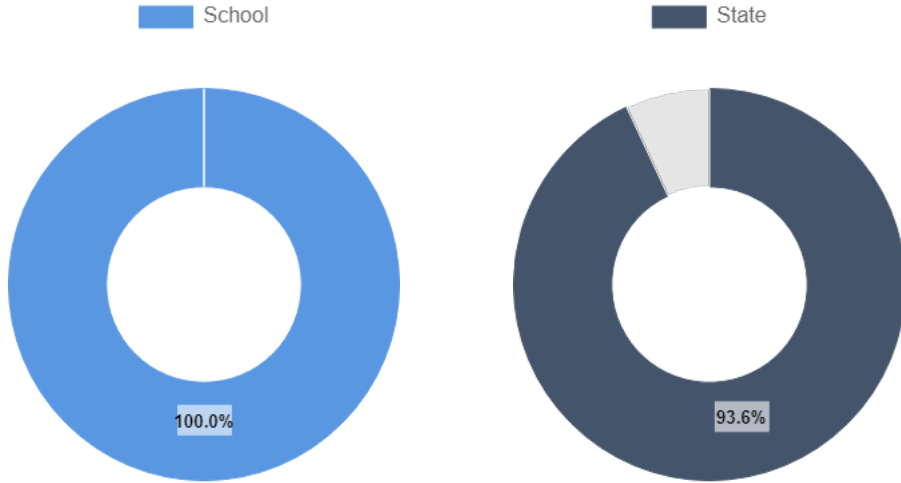

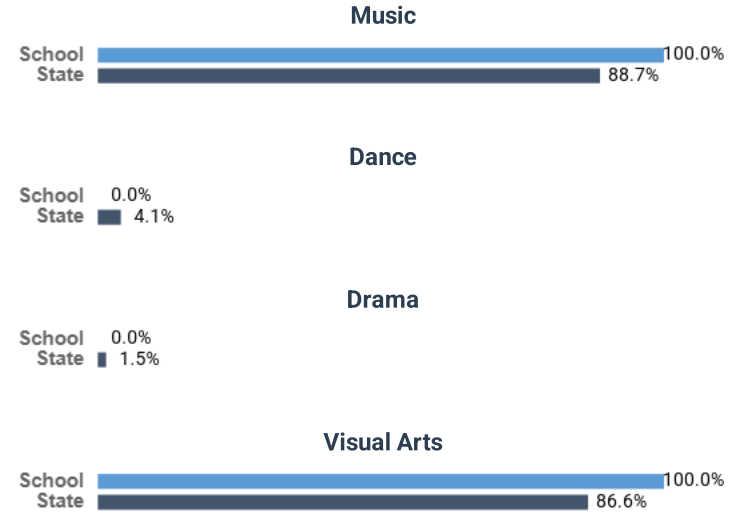

Students enrolled in one or more classes by discipline:



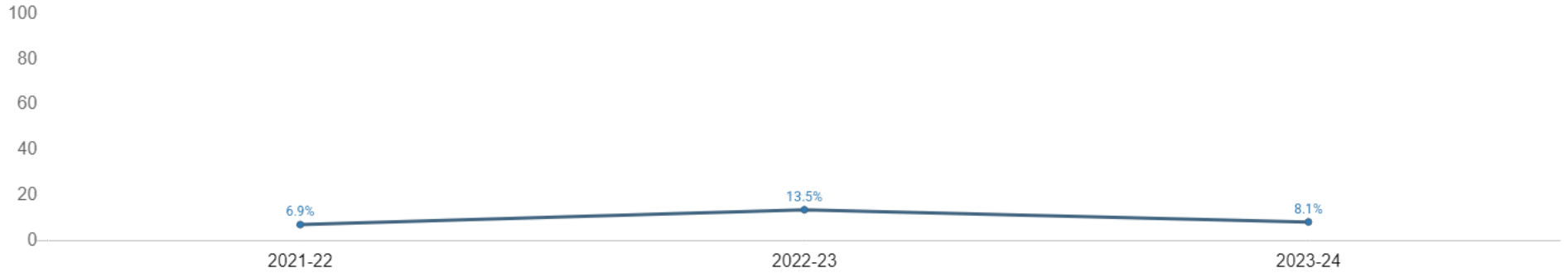

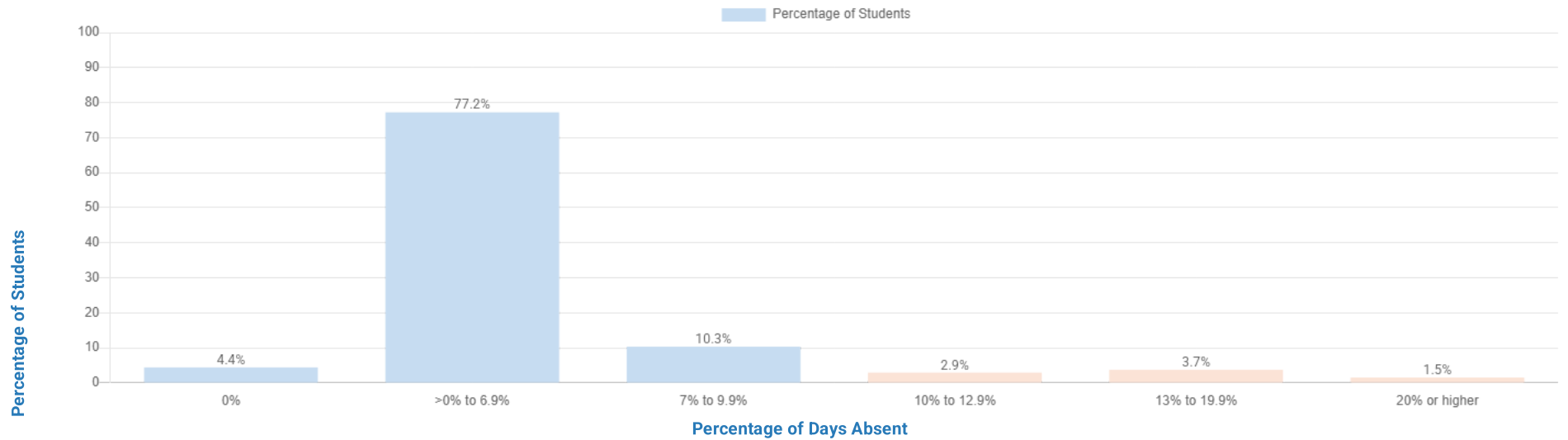

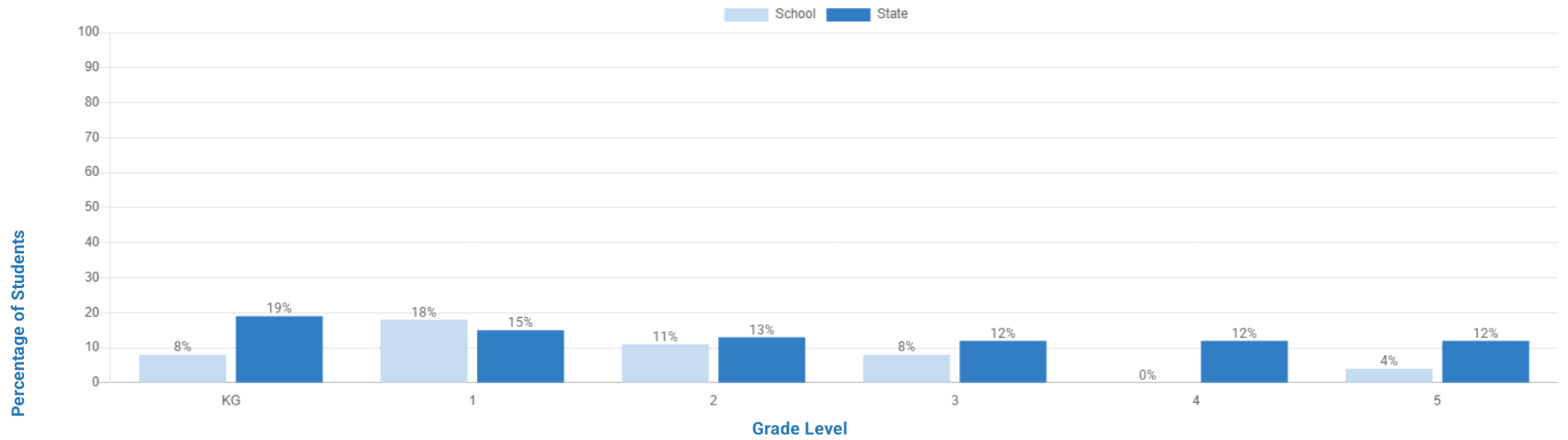

Staff

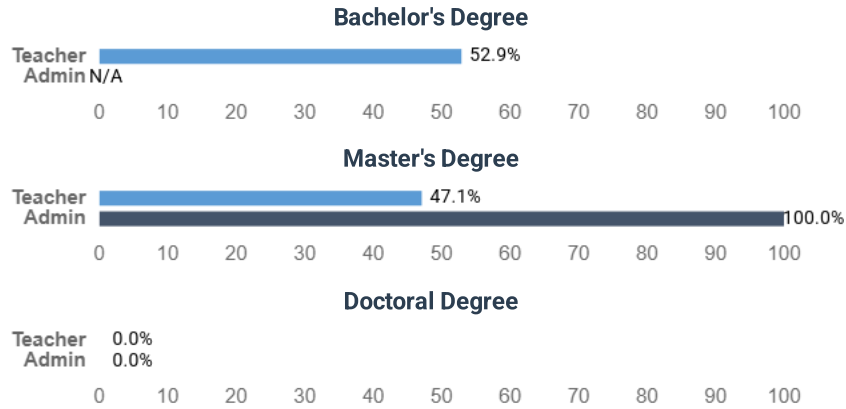

Offered targeted instructional support from a Remote Instructional Support Teachers to all students during the time they were instructed to quarantine due to COVID-close contact or because they received a positive COVID result; Extended the school day and year for those who had unfinished learning by providing interventions that included extended day and summer programs. These programs were all driven by data and grounded in the Visible Learning research of John Hattie; Hired five full-time Elementary Multi-Tiered System of Supports (MTSS) teachers and one full-time BCBA to help support our students, families and community; Provided district-wide targeted Visible Learning professional development based on the research of John Hattie.
