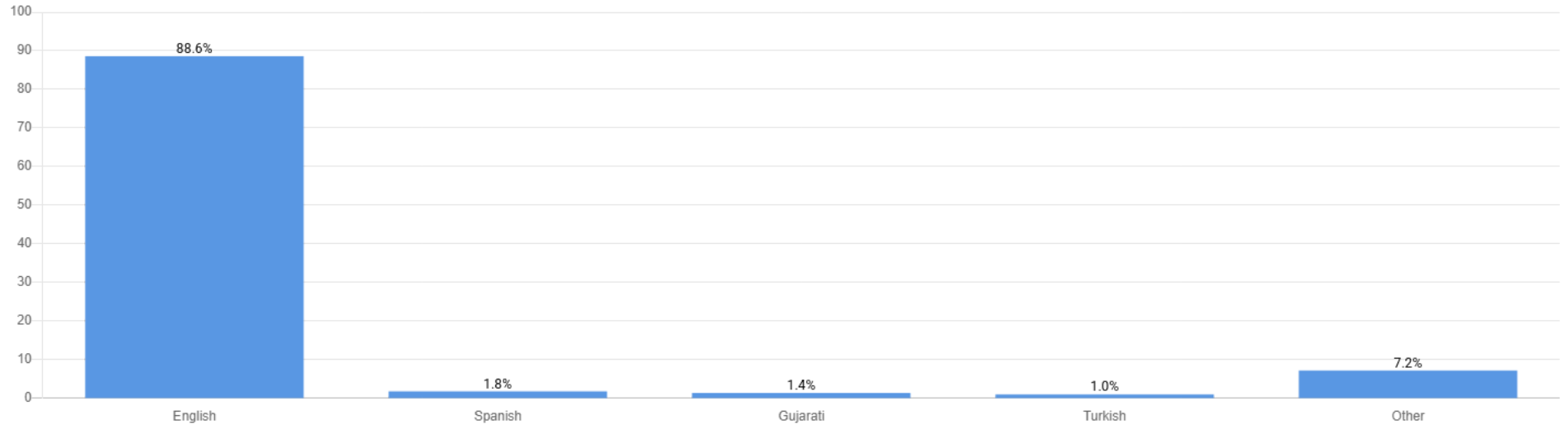

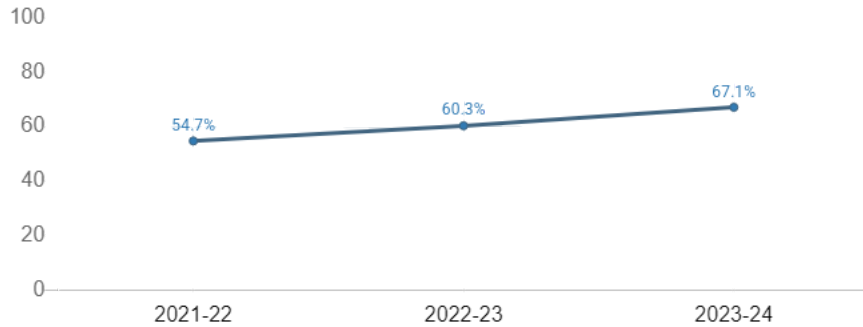

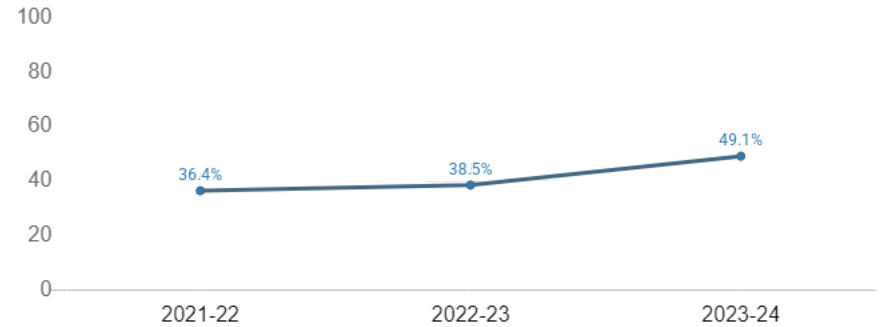
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 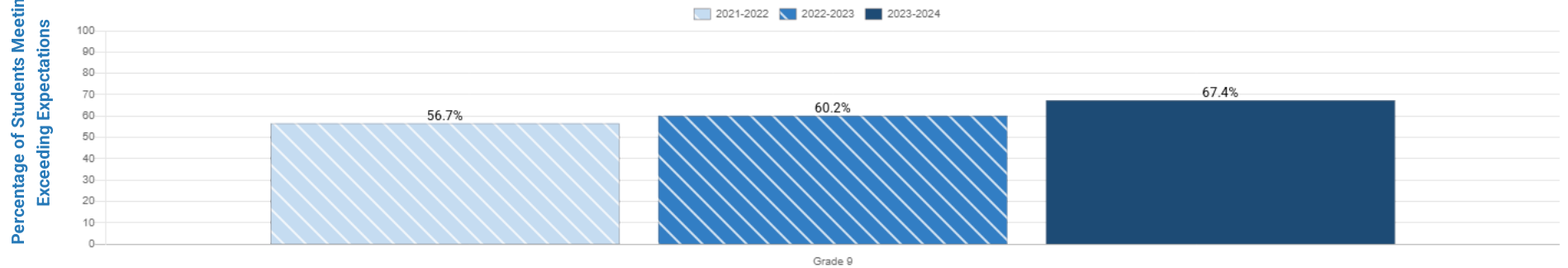

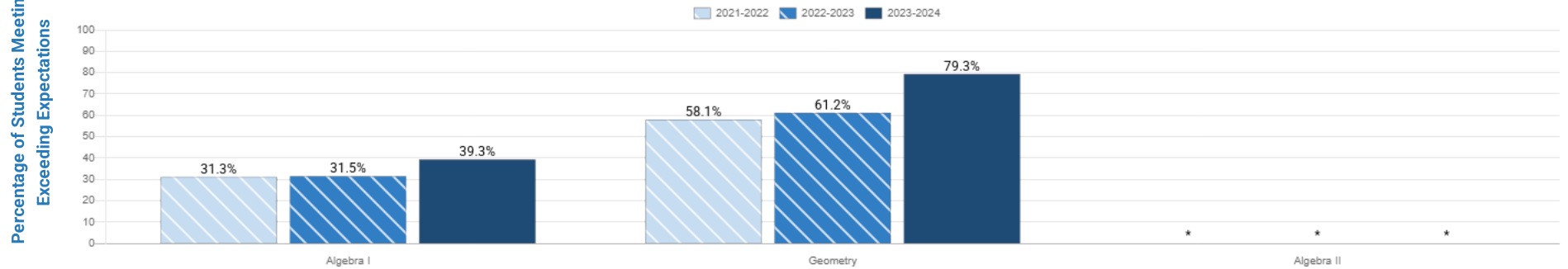

Students in sixth grade who were enrolled in Algebra I course were required to take both the Algebra I and Grade 6 mathematics assessment. The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

The results of their Geometry assessment are not included in these results but will be reported when the student is in grade 9.

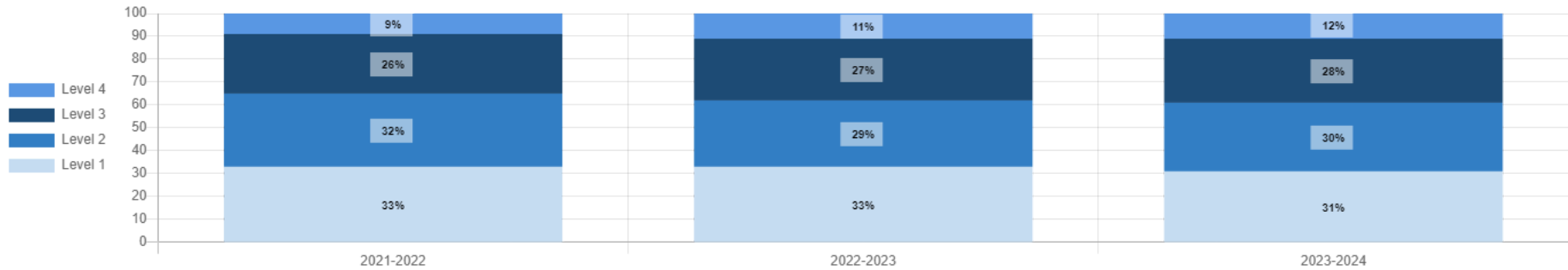

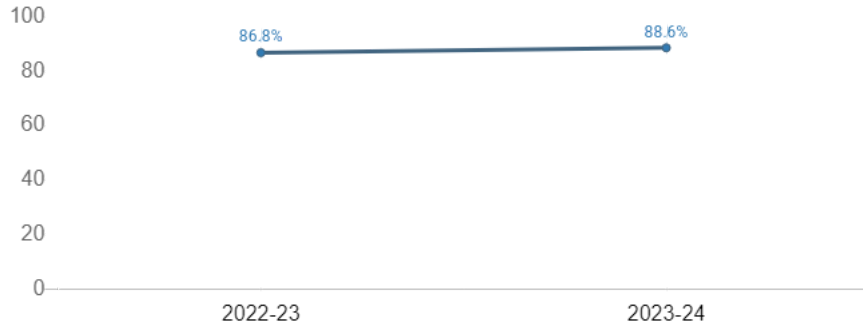

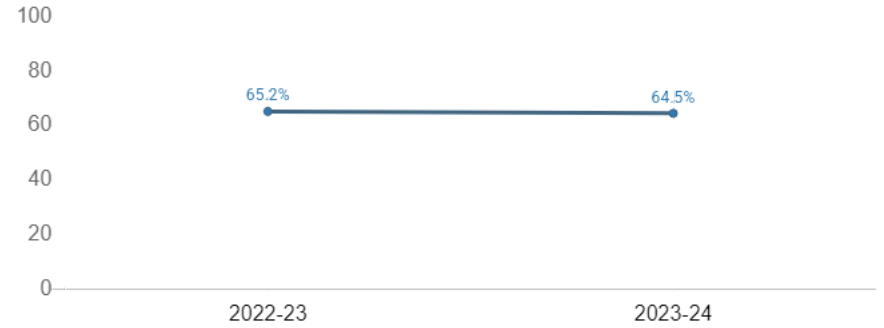

Students taking one or more AP or IB exam

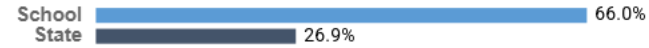

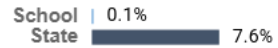

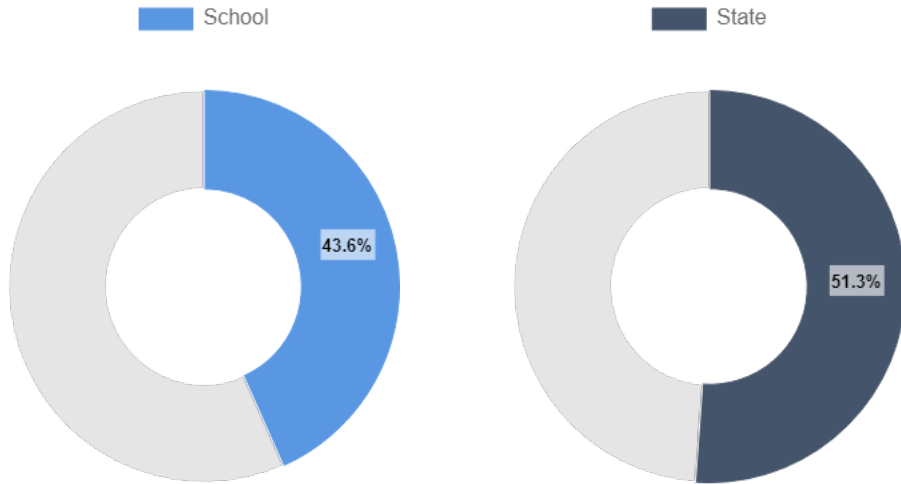

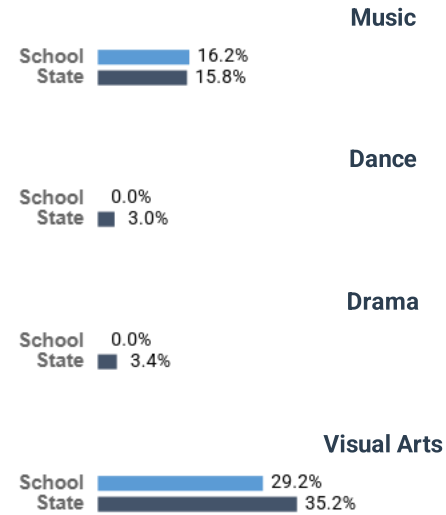

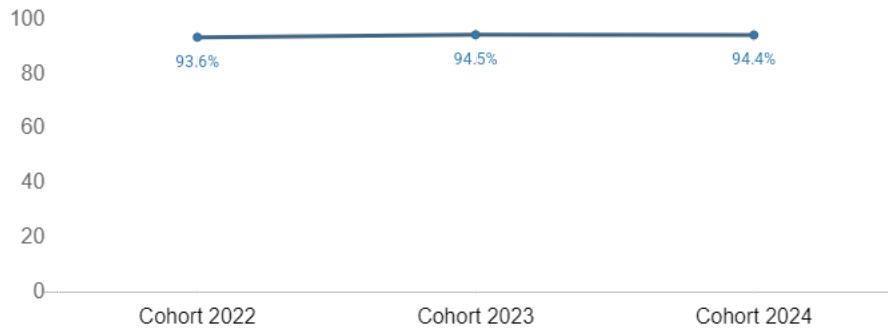

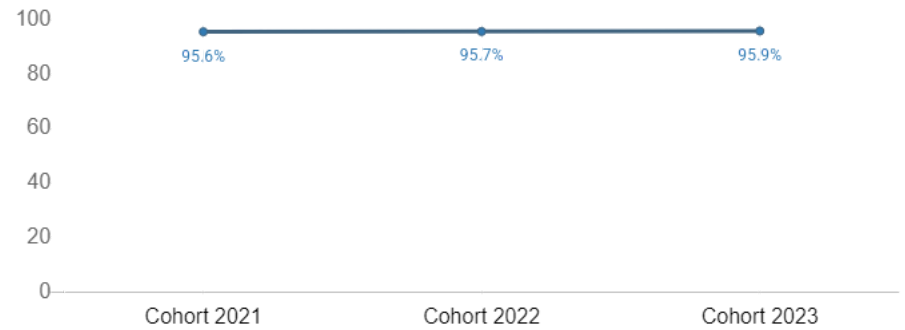

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

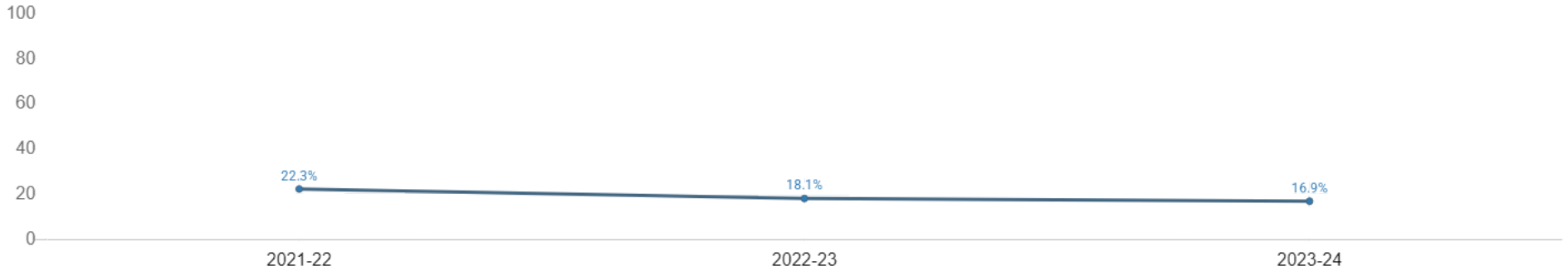

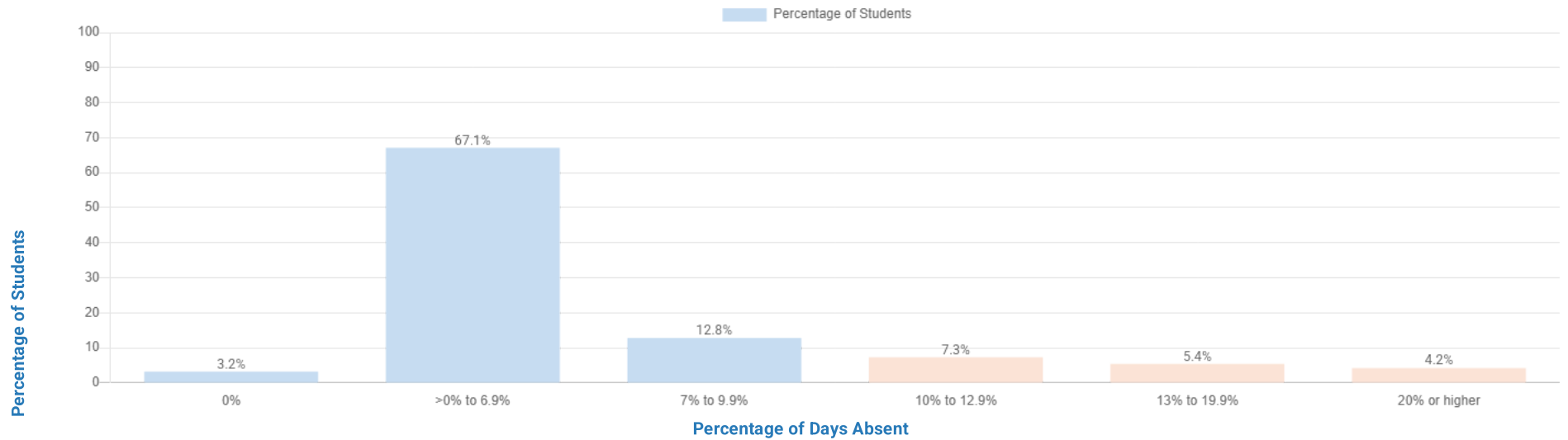

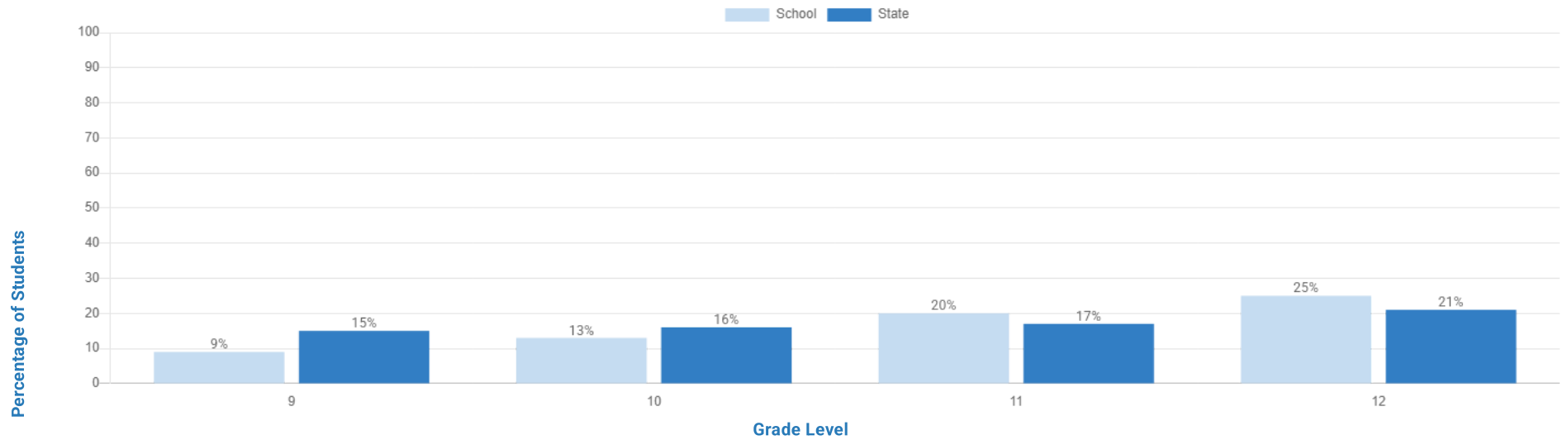

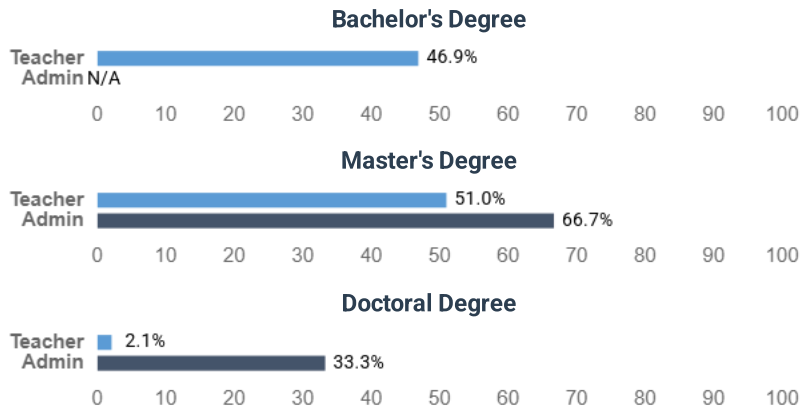

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Facilities:

Recent upgrades and renovations in school facilities includes the installation of several new energy efficient HVAC units with all being centrally controlled by the BMS program. A significant upgrade has been made to the hot water heating systems at the school with the installation of four (4) new highly efficient boilers in the mechanical rooms. These units will be able to controlled remotely as they are integrated in the BMS system to increase their efficient operation. Further, the district also installed new energy efficient LED lighting at the highly used stadium football field. New asphalt and traffic arrows has been installed in highly traveled areas of the entrance area of the school eliminating many deteriorating drive way concerns. Finally, there have also been upgrades/modifications to 35 classroom doors with new locking mortice's with thumb turn locks which replaced an intruder keyed mortice for a more quicker, efficient way to lockdown in case of emergencies.



School Safety:

The School Security Committee at Eastern High School steers the districts security policies and procedures in an effort strengthen school security. Stake holders serving on the committee include students, parents, community members, school staff and our local police. With the support of our Board of Education, the school security committee recommends and implements the following security enhancements: annually evaluate, establish and revise visitor procedures, refine strategies to strengthen our school perimeter and strengthen our interior lockdown strategies.
