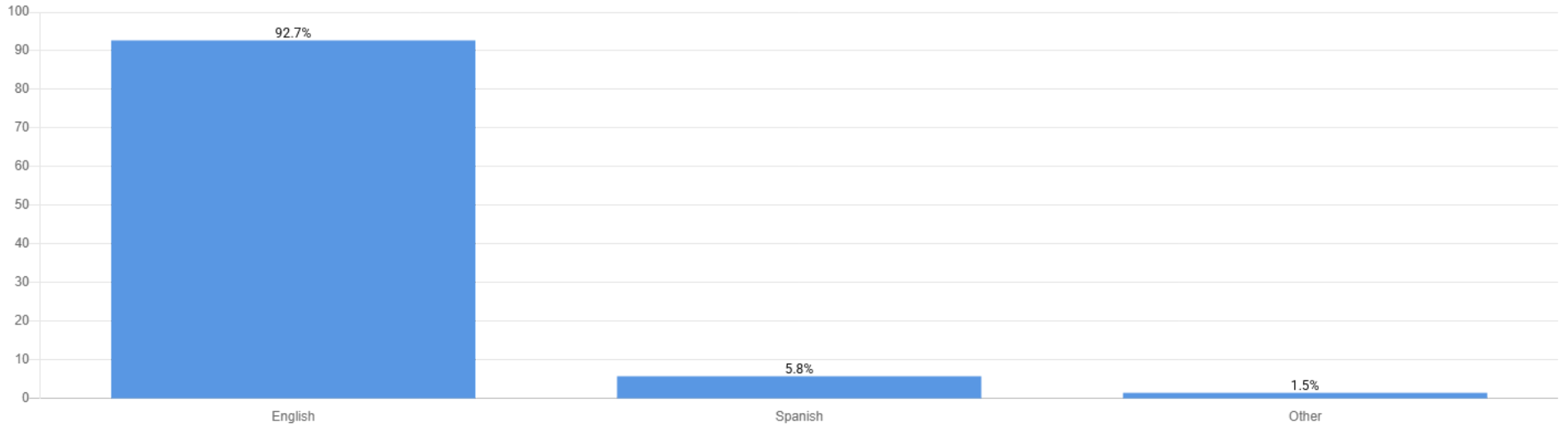

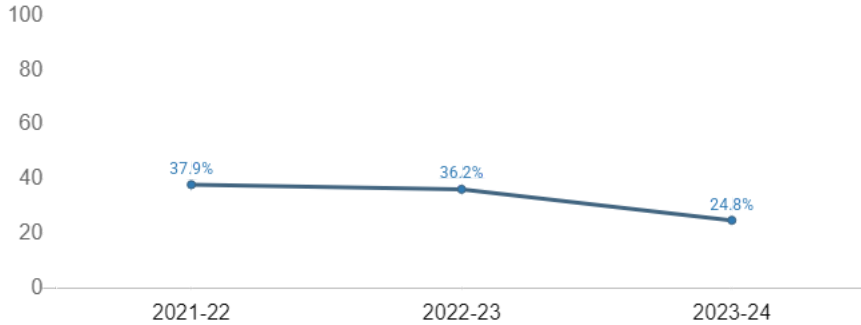

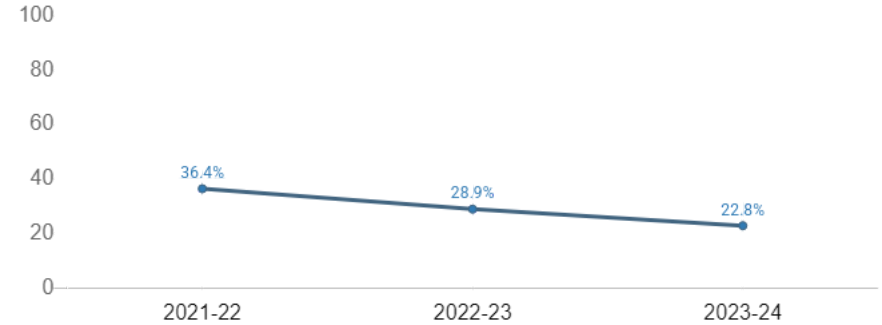
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 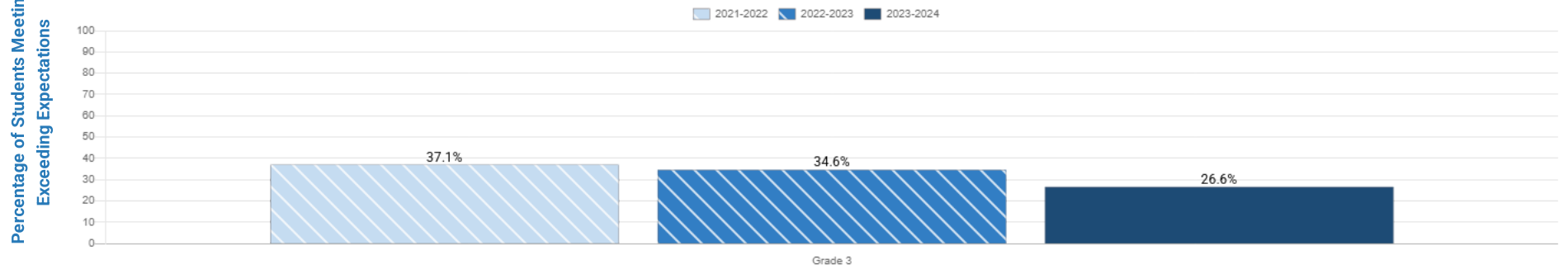

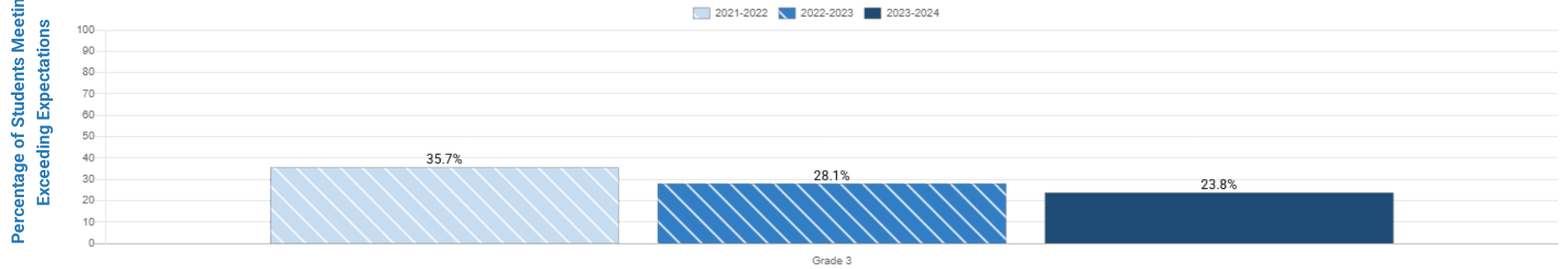

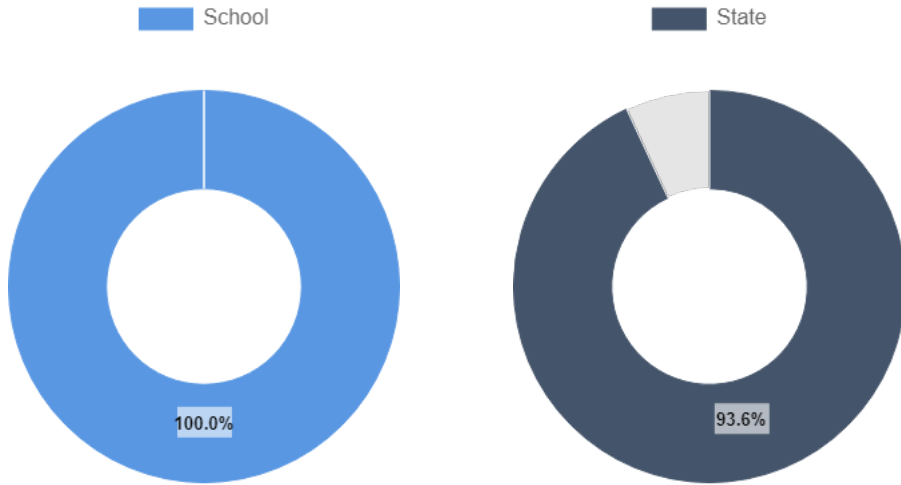

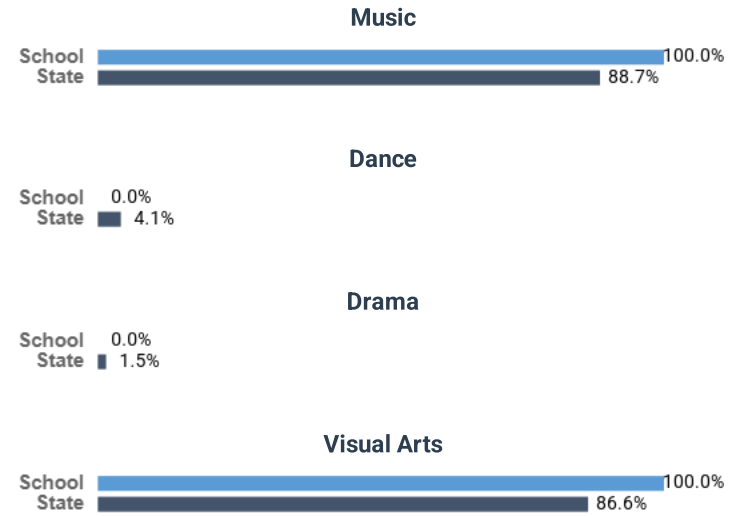

Students enrolled in one or more classes by discipline:



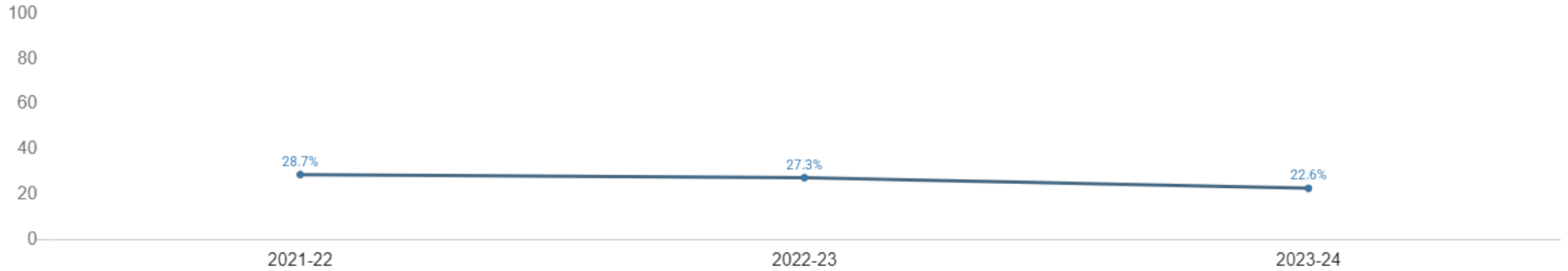

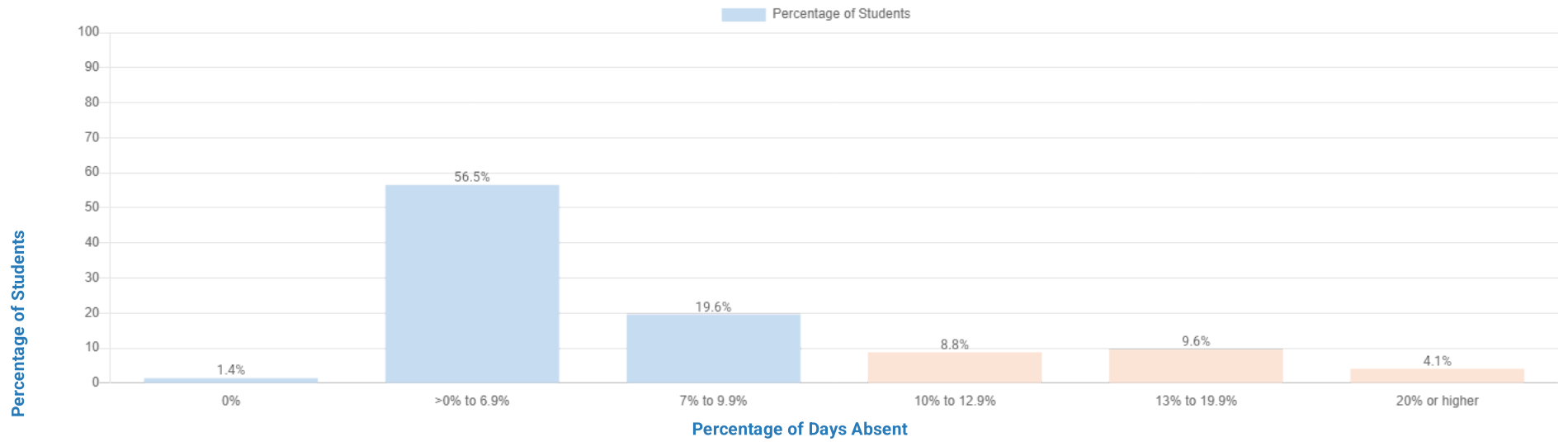

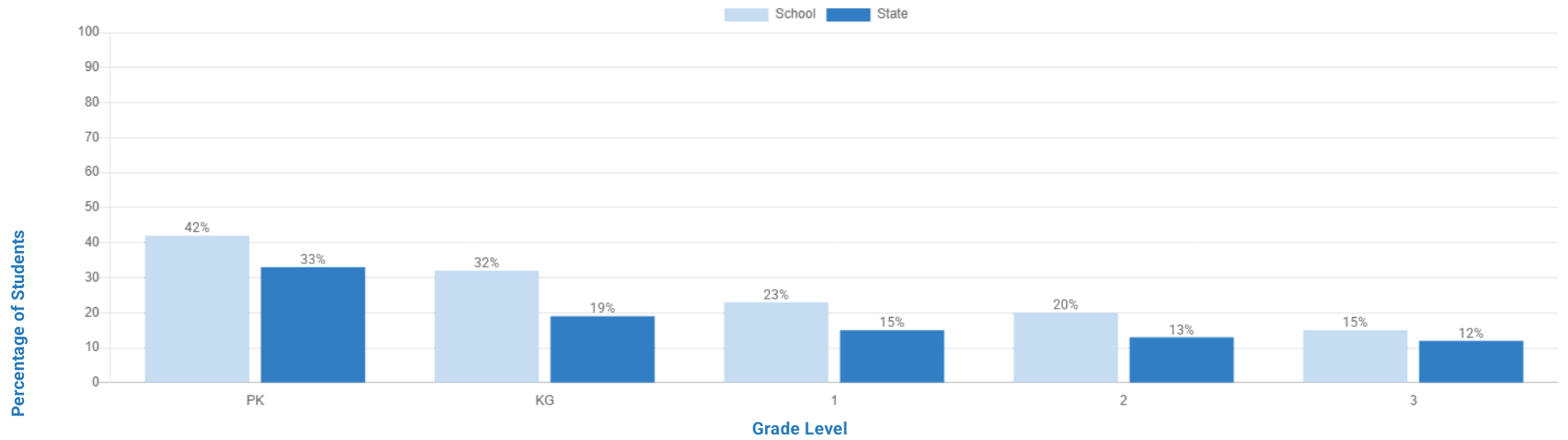

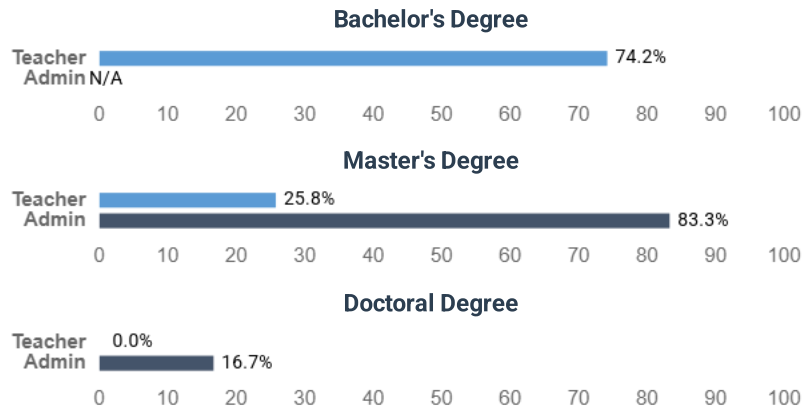

Cold Springs School K-3 has an I&RS committee that meets biweekly. The Early Childhoods Center has a PIRT team that meets monthly to help students and teachers with strategies and support for the classroom. Cold Springs School has two guidance counselors.



Student Health and Wellness:

Our lunch program is run by Nutri-serv providing students with healthy breakfast and lunch choices. Menus are published monthly and posted on the school website. Each student is provided with the required amount of physical activity throughout the school day. Nurses maintain accurate health records and annual health screenings. Teachers utilize responsive classroom practices to support students' social and emotional needs.



Parent and Community Involvement:

The ECC Preschool classrooms offer monthly family engagement events and activities. There are also four ECAC meetings a year as well as three available parent workshops throughout the year on an array of topics such as behavior support, nutrition, and early literacy. Grades K-3 classrooms host one family engagement activity or event yearly where parents are invited to come into the classroom and do an activity with their child. CSS has a very dedicated and active PTO that meets monthly and hosts family nights.

Climate Surveys:

The committee then uses the results to plan parent engagement activities as well as parent workshops and support. Curriculum Supervisors send out an annual Title 1 Climate Survey to parents.



Facilities:

CSS and ECC both have a fully functioning kitchen to provide breakfast and lunch for our students. CSS has a cafeterium and a multi-purpose room. ECC has a multipurpose room that can be utilized for parent engagement activities and indoor gross motor play. CSS has two playgrounds for students, one at our Preschool wing and one at the main building wing.



School Safety:

There are security guards at each of the two entrances at Cold Springs School. The local police department has provided the district with available staff in the building throughout the school day. There is one armed police officer in the building daily. Raptor is a security system that has recently been installed at each entrance. This system allows for the scanning of visitors' licenses and does a quick background check before printing out an ID badge. School Safety Committee meetings are conducted two times a year and discipline is addressed and recorded according to the district disciplinary guidelines. District security meetings are held with the Gloucester City Police Department and building administration.

Technology and STEM:

CSS is in its fourth year of the 1:1 initiative which includes Preschool this school year. Programs such as Kami Pear Deck and Classroom are used by teachers to enhance student learning. Teachers use Class Dojo and Remind to maintain communication between home and school. Each classroom in Preschool through Third grade has a smartboard for interactive instruction. Students work to improve their basic skills through the use of Lexia IXL and Prodigy. We have grown immensely in the area of technology and continue to strive to Go Green by going paperless. Our school clubs with the exception of the book club are completely paperless. Teachers and administrators have been issued Surface Pros to complete assignments and interact with students and parents.



Early Childhood Education:

Cold Springs School Early Childhood Center is a full-day preschool program for three and four-year-old children residing in Gloucester City. The program is state-funded through the PEA Grant. The current preschool program consists of 18 inclusive classrooms and one PSD classroom. All preschool classrooms are housed in the ECC wing of Cold Springs School. All preschool classrooms have a certified teacher and a paraprofessional with a class size no larger than 15 students. The school day is about 6.5 hours and includes breakfast, lunch, and rest time. The program follows the Creative Curriculum for preschool, which provides opportunities for students to have choice time, read aloud, music and movement and gross motor play. The district does not contract with private providers.
