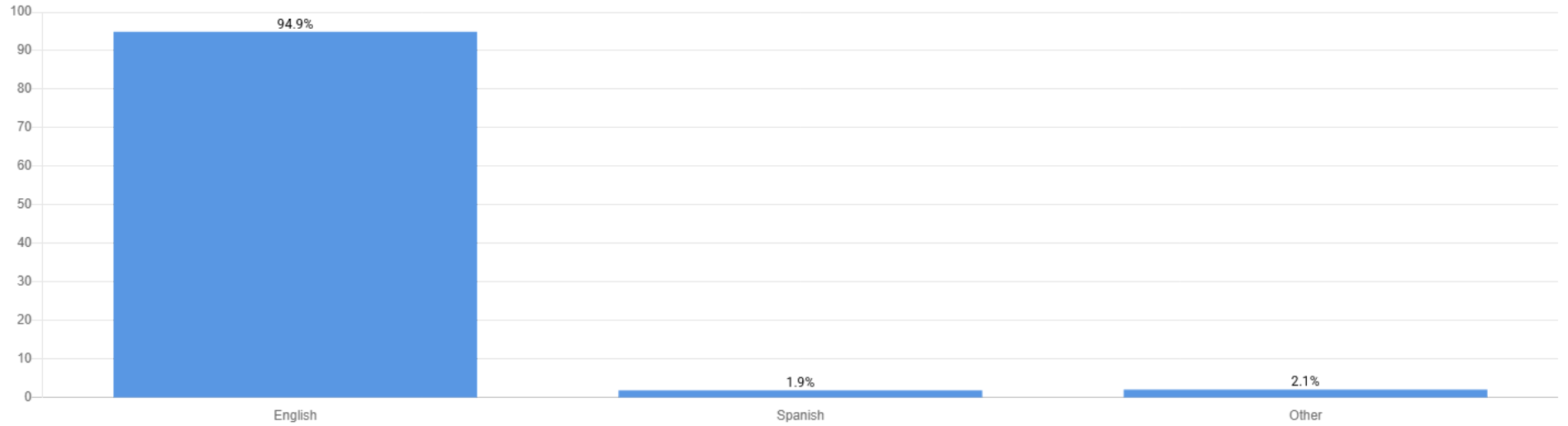

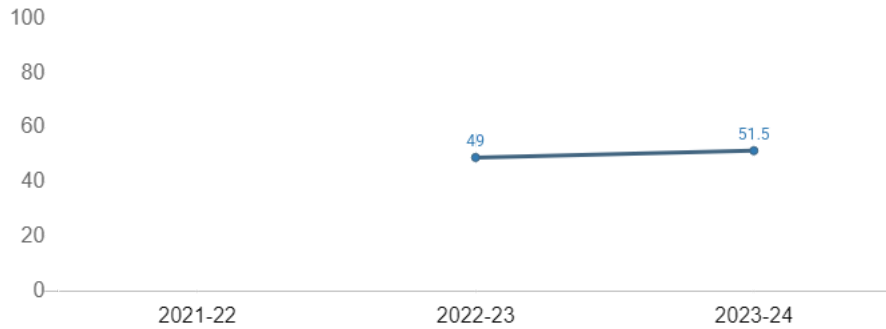

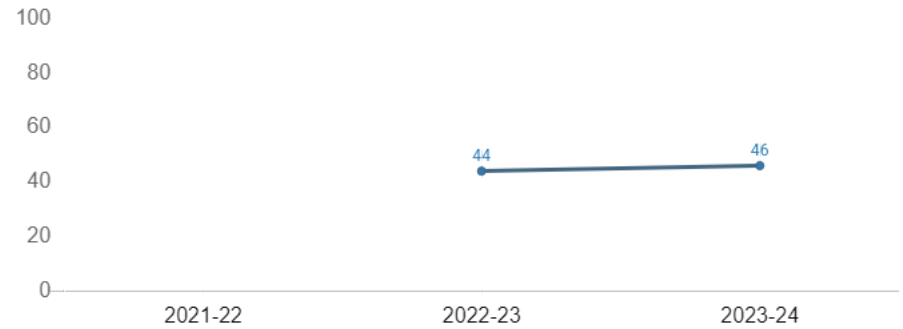

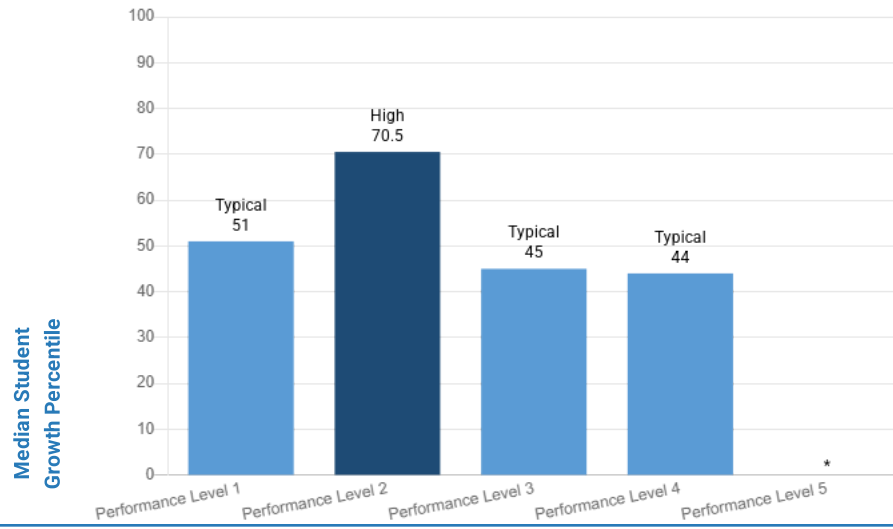

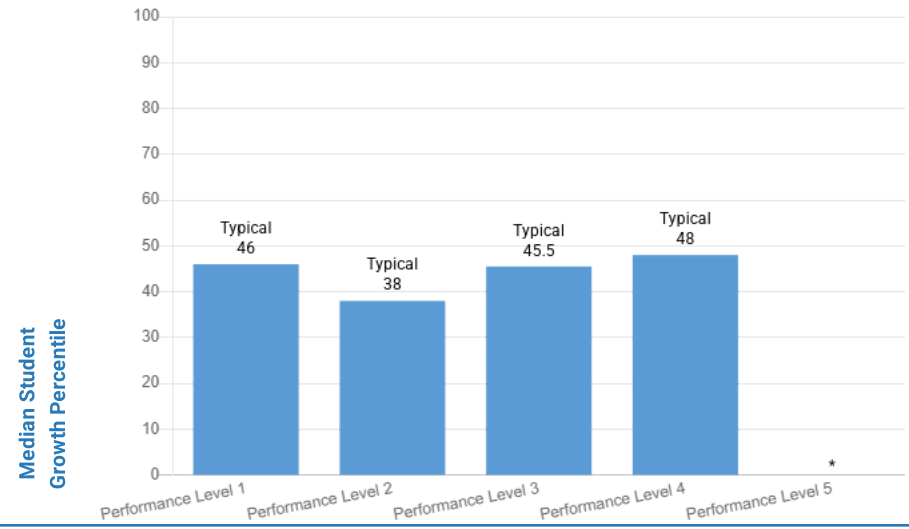

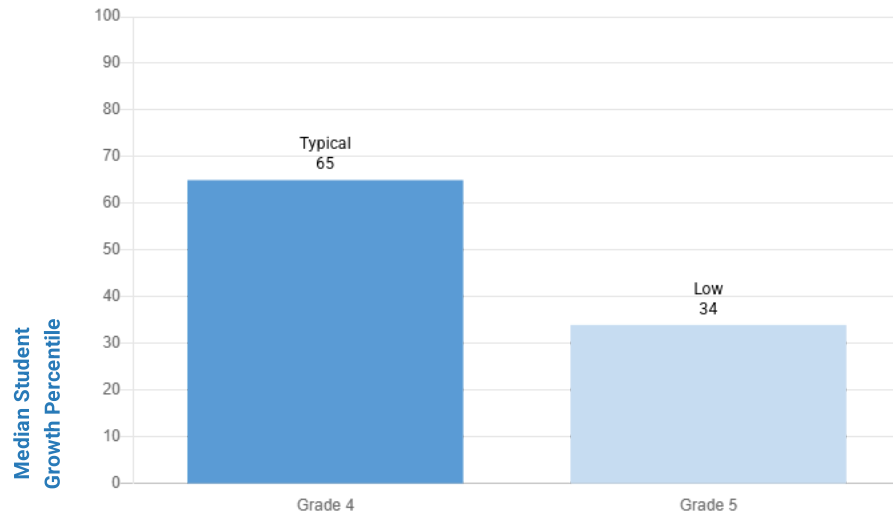

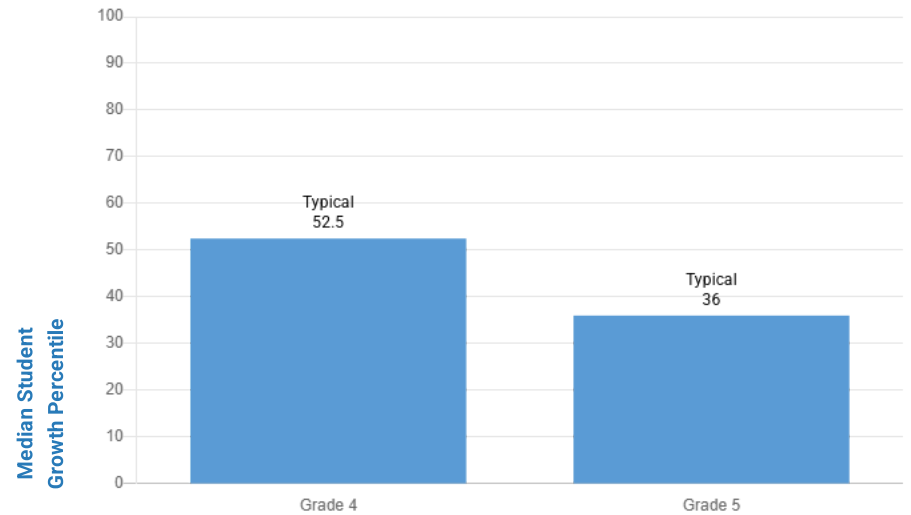

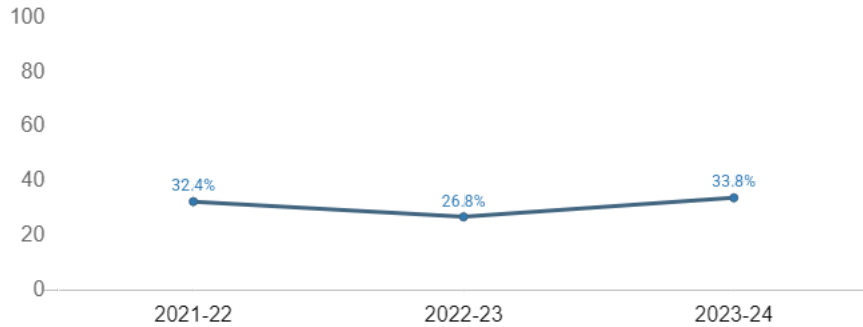

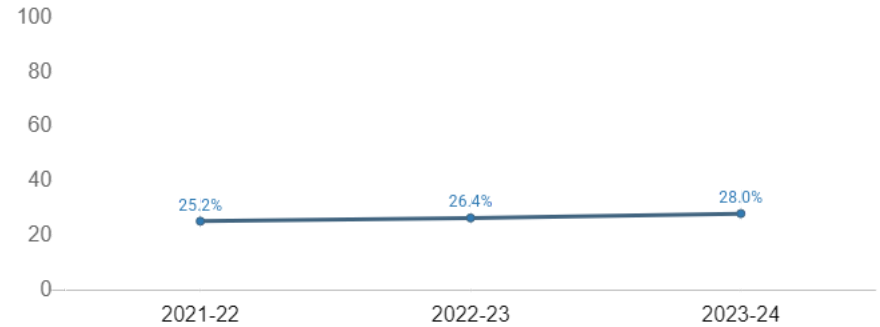
English Language Arts and Mathematics Performance Trends

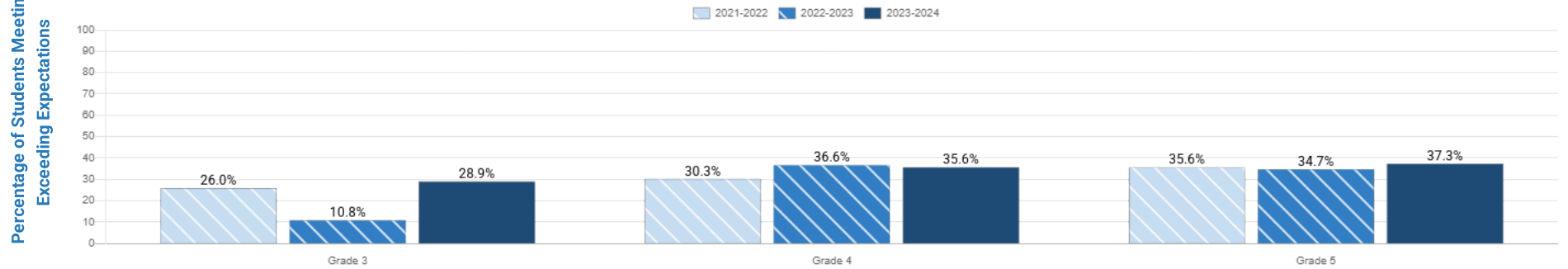

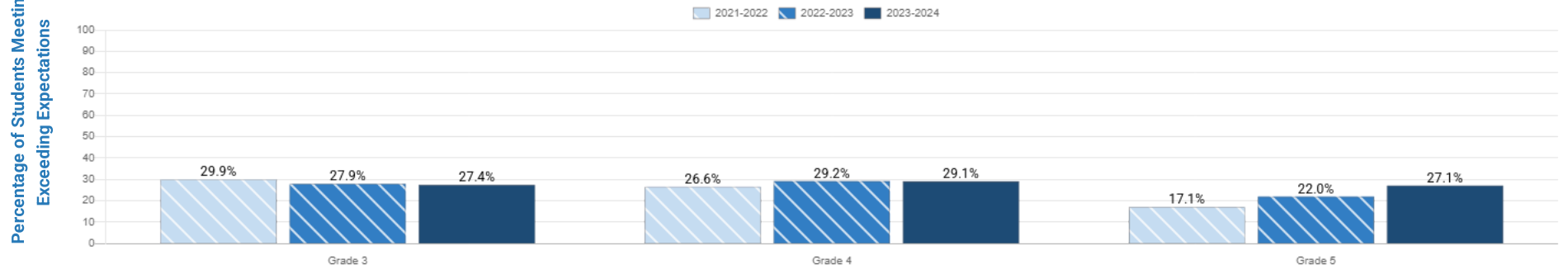

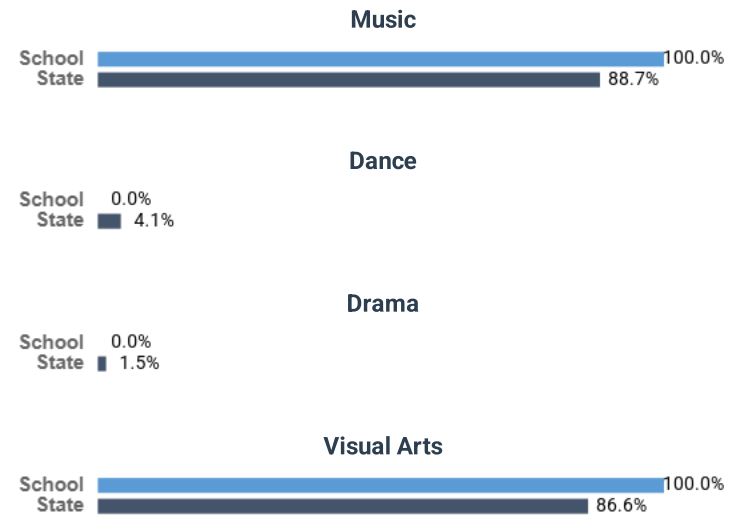

Students enrolled in one or more classes by discipline:



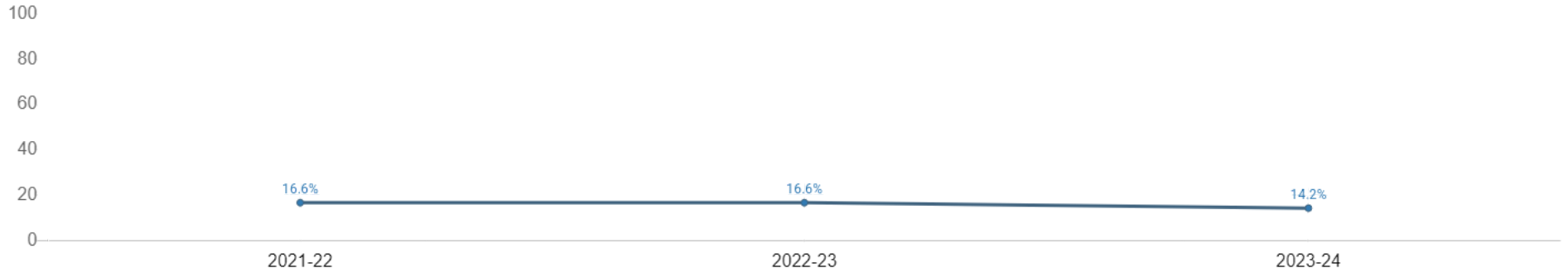

A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

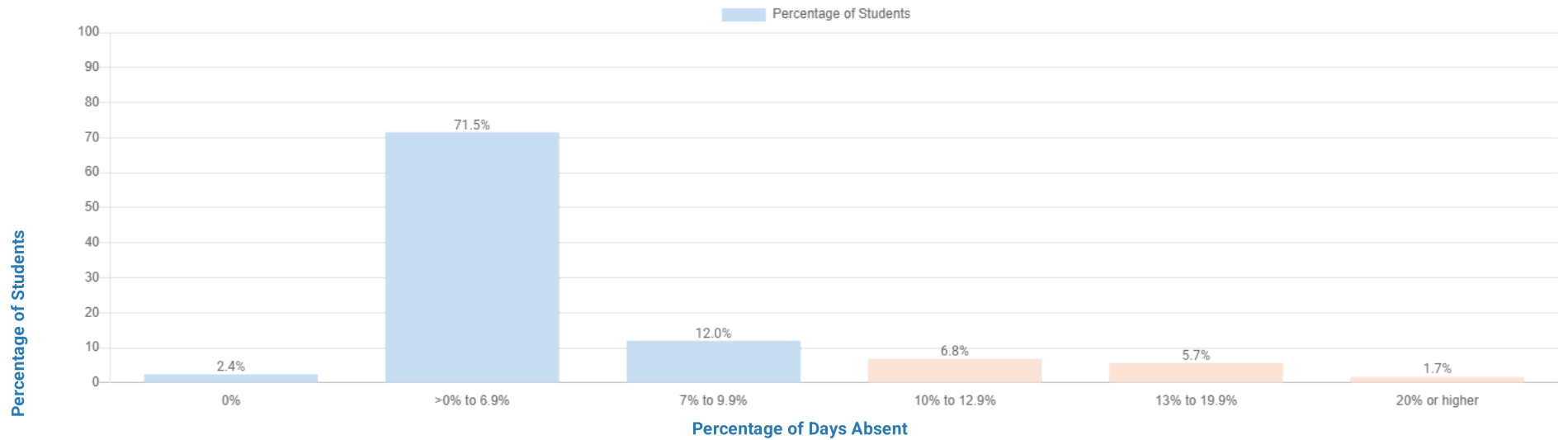

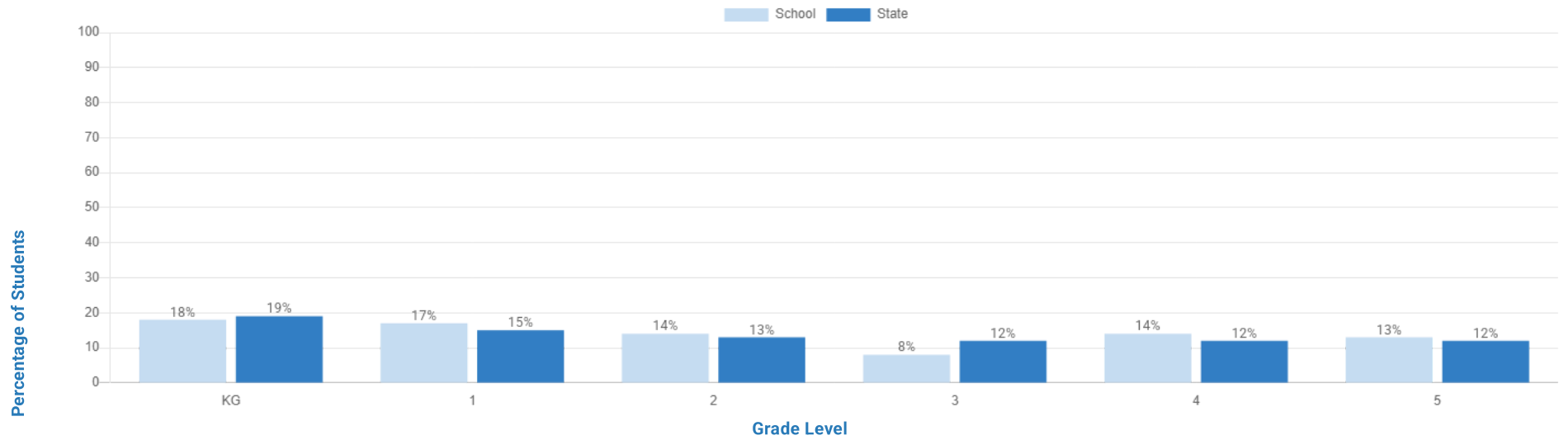

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

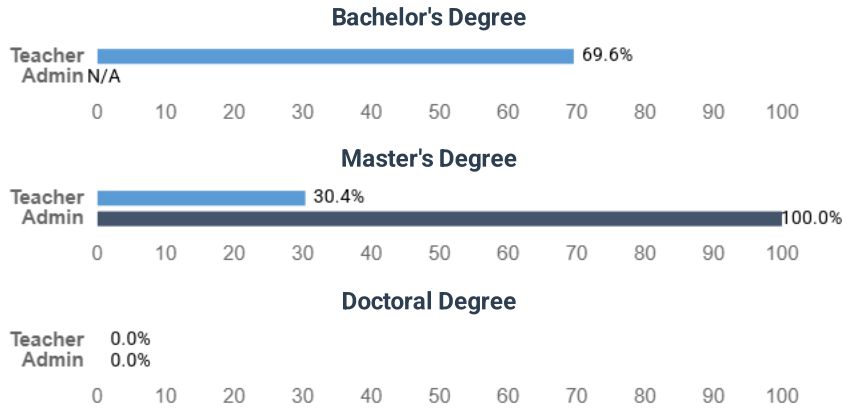

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. The students rotate through the 6 related arts classes using a 6 day cycle. Throughout the 6 day cycle students will have a different related arts on each of the 6 days. The students shall receive 30 instructional days for each related arts. The Science and Social Studies is facilitated through TCI.

Clubs and Activities:

Students in grades 1 and 2 in addition to our intervention program may receive tutoring by our lunchtime tutors. Students in grades 3-5 have the opportunity to participate in 1 of our 5 after-school club offerings: Strategic Board Games, Yearbook, Newspaper, Book, and Health and Physical Education clubs. These clubs are offered in two sessions.



Before and After School Programs:

Students have access to a Latch-Key Program that provides before & after care during the school year and the summer months. Title I services may be accessed by the school and include a Summer Bridge Program for students entering K with no Pre-K experience.



Staff and Professional Learning:

Teachers are provided with professional learning as organized by our SCIP Committee. Administration ensures that staff is provided with in school professional learning to support district initiatives. This year staff members will be educated and trained in MTSS/PBIS-Rewards and Tier 1 and 2 behavioral interventions for students that struggle with basic school expectations.

Student support services include Response to Intervention (RTI) Intervention & Referral Services Committee (I&RS), Child Study Team, Resource Room & In-Class Support instruction, Speech, Occupational and Physical Therapies and Guidance Counseling.

Our students are offered a breakfast and lunch program at a reduced/free rate. We have a Health and Safety Committee to promote the health and well being of our students. The nurse offers a screening for sight and hearing. We have utilized a county program that supports families in purchasing glasses. Students are offered physical education and open recess where students take advantage of ropes, balls, soccer nets, and basketball nets. Games are painted on the surfaced areas of the play area.

Blackwood School is supported by an outstanding home & school organization called Parent Teacher Organization. The PTO has monthly meetings and is responsible for fund raising activities and develops projects that enhance the student's school experience. Parents are also able to attend many school events such as Steam Day, Field Day, Fun Day, Math Night, Literacy Night, Parents Night, and activities for American Education Week.

Technology and STEM:

Blackwood is 1 to 1 with student chromebooks Kindergarten through 5th grade. Blackwood has also purchased a state of the art vinyl cutter which it plans to use to provide students with practical experience with industrial tools to become College and Career Ready. This year will make the third straight year that Blackwood facilitates STEAM Day. STEAM Day engages students in critical thinking games and activities that incorporate team work, ingenuity, and hands-on activities to complete a STEAM related task.



Early Childhood Education:

The district was awarded a state funding opportunity. As a result, Blackwood Elementary is able to offer the Pre-school Expansion Program. This entitles students of ages 3 and 4 an opportunity to participate in the new full day preschool program. However, the students from Blackwood Elementary School who participate in this program do so at one of our sister schools at Erial Elementary or Glen Landing Middle School, where these programs are facilitated.



Attendance:

Blackwood Elementary School has a K-2 and a 3-5 grade level school counselor. Having 2 counselors helps to provide students with additional academic, social and emotional supports.

Blackwood opens its doors at 8:20. Students have breakfast or organize for the day until 8:45 when instruction begins. Instruction ends at 2:42 and dismissal is at 2:45. The specials (Art, Music, Library, Spanish, PE, and Computers) are offered in cycles. Six cycles provide students an opportunity to in all six related arts. School safety drills are conducted twice a month this includes fire, bomb and intruder drills. A police officer is present at all drills for feedback purposes. We have smartboards in grades kindergarten through five. Chromebooks are 1:1 in grades kindergarten through five. Communication is strong. There is a calendar on the school website with all activities for the entire year, a monthly list of activities is emailed to all parents, a weekly phone call goes out every Sunday evening, teachers email by class daily or at the least weekly.
