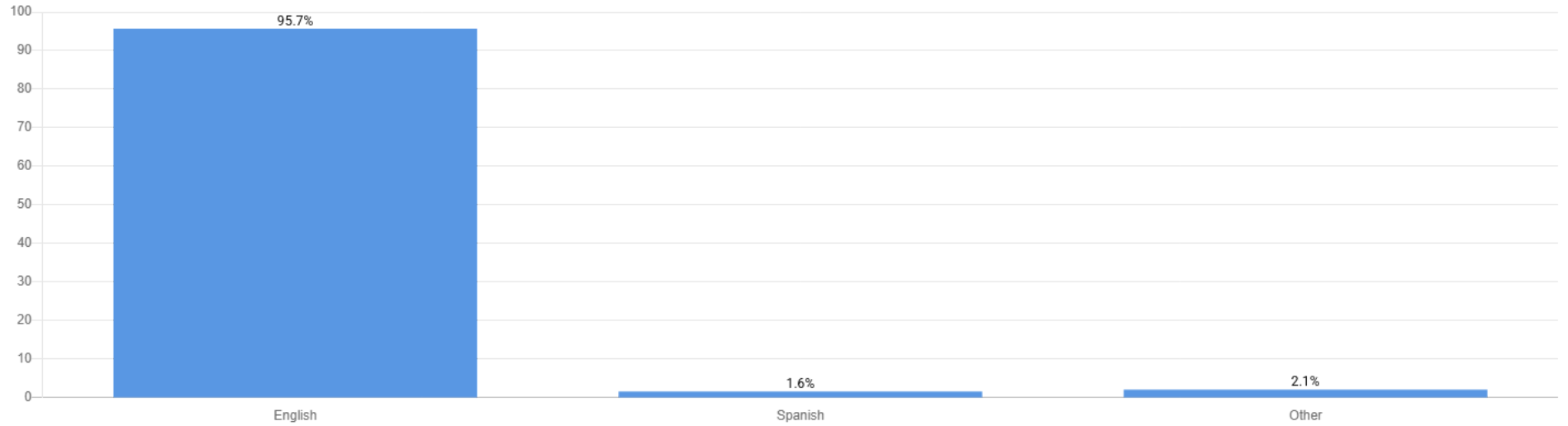

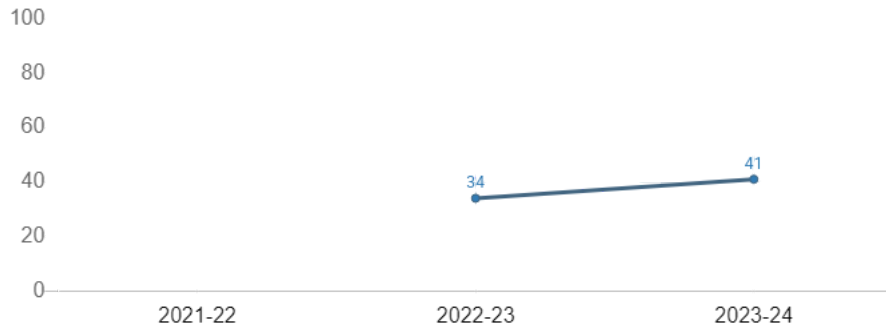

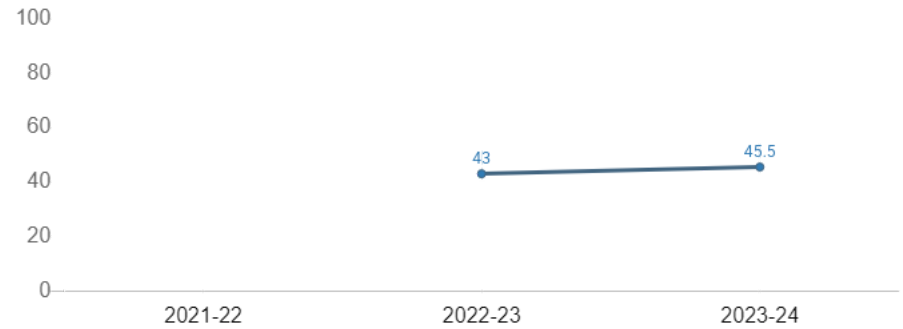

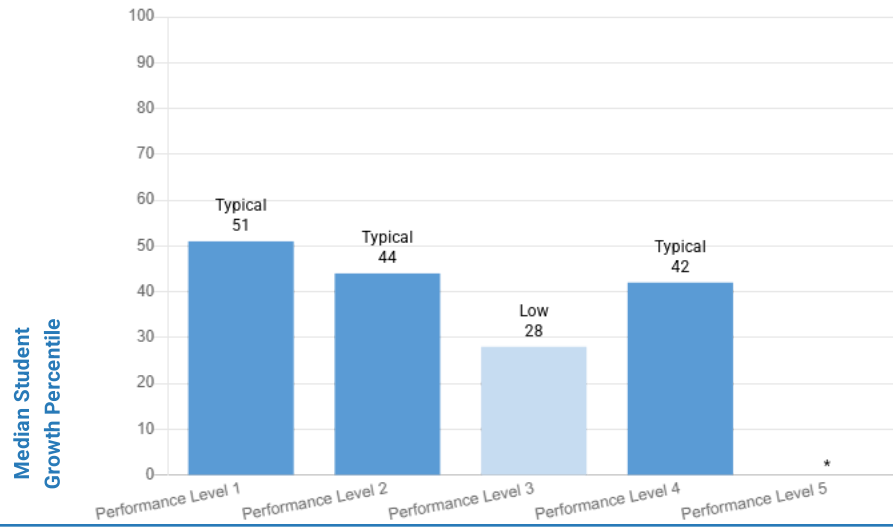

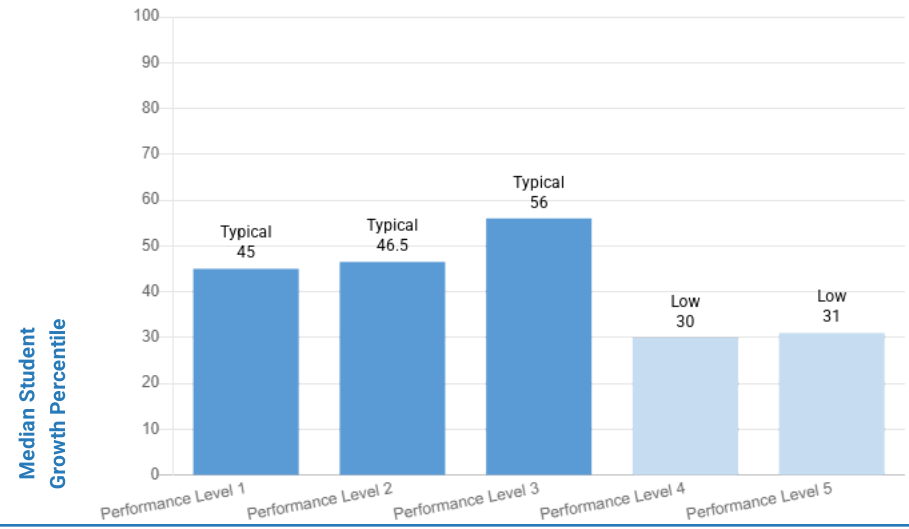

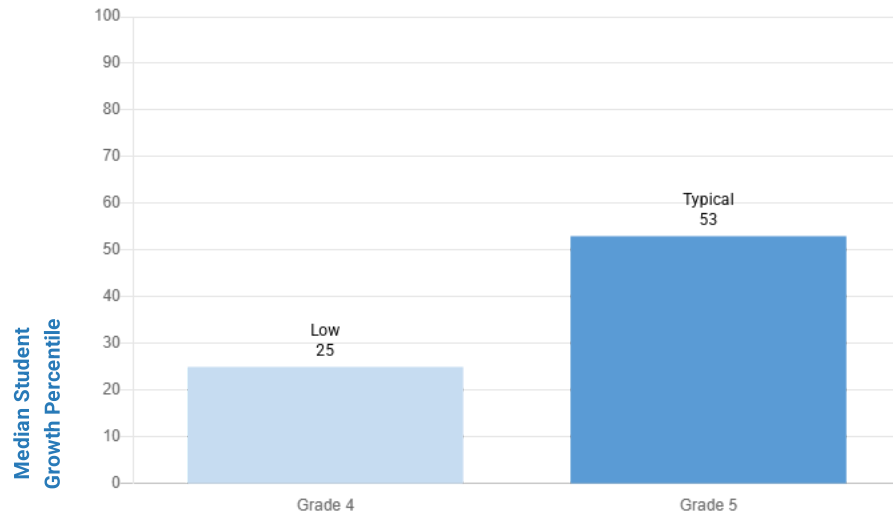

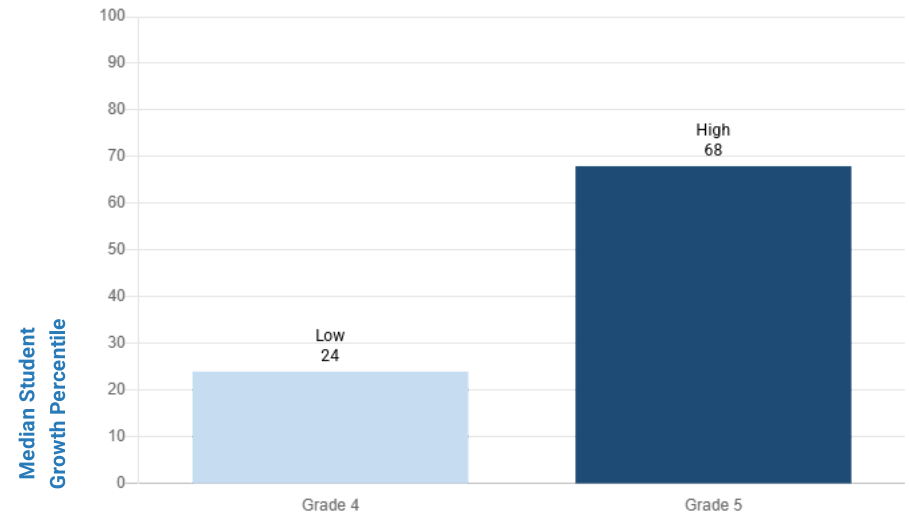

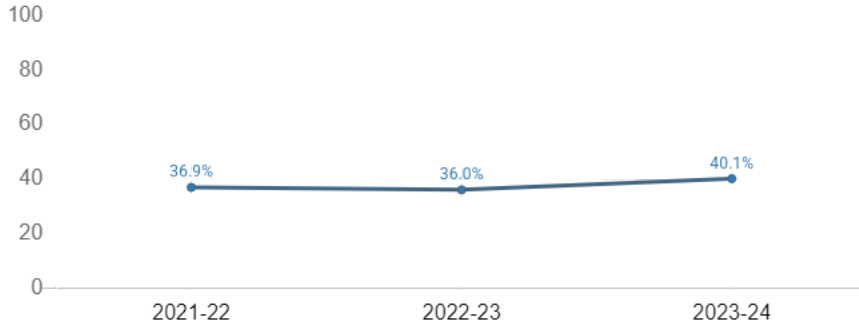

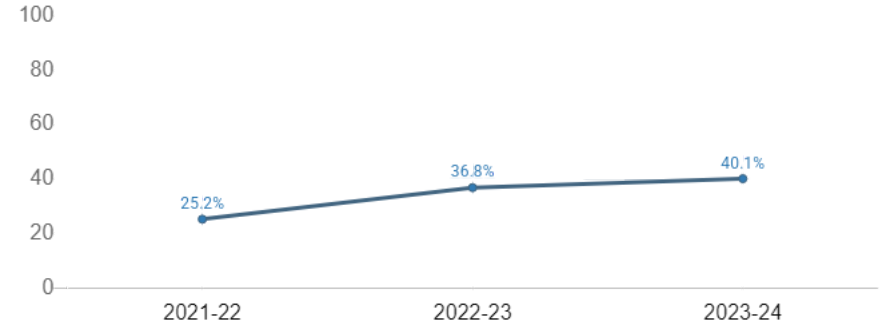
English Language Arts and Mathematics Performance Trends

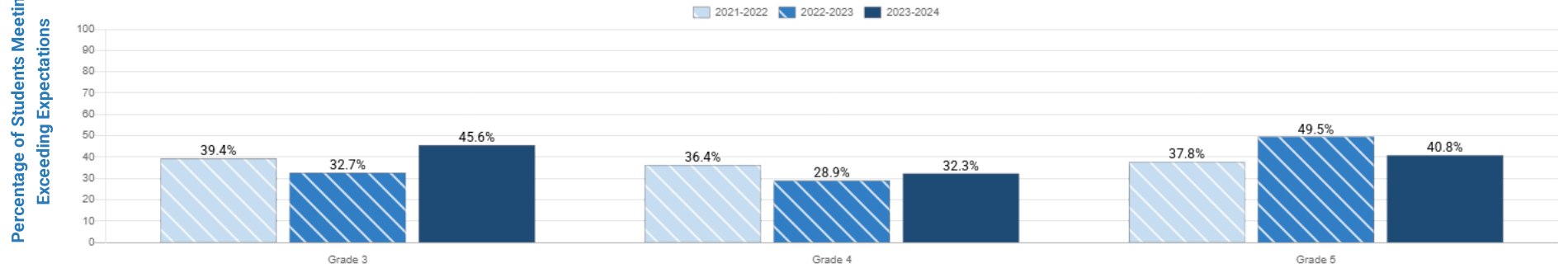

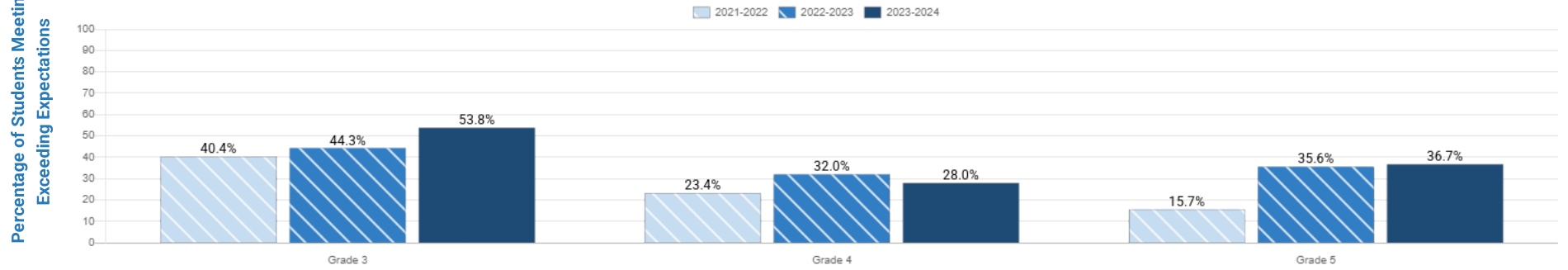

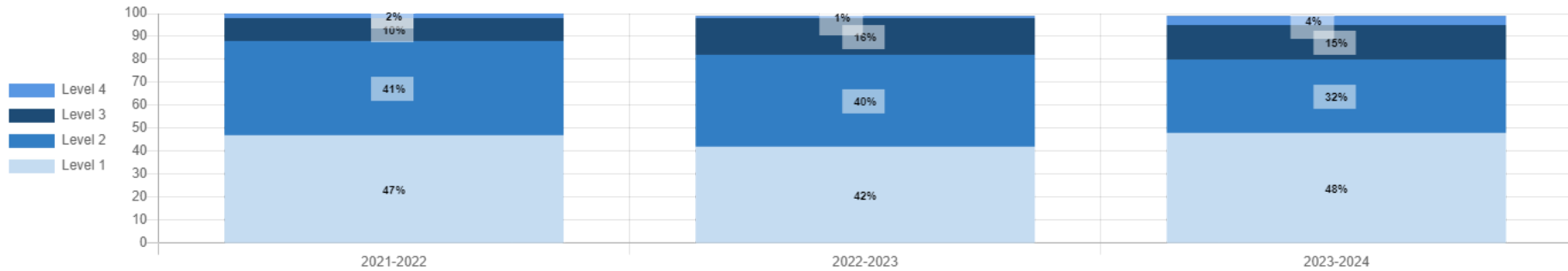

Students enrolled in one or more classes by discipline:



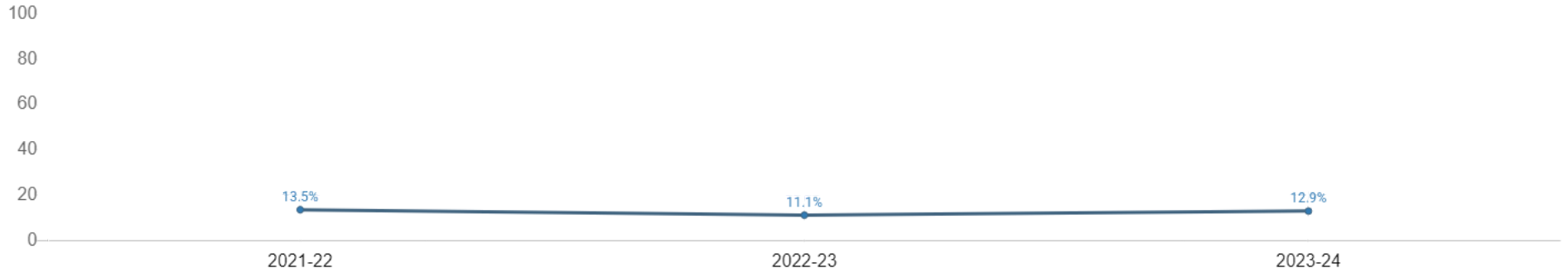

A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

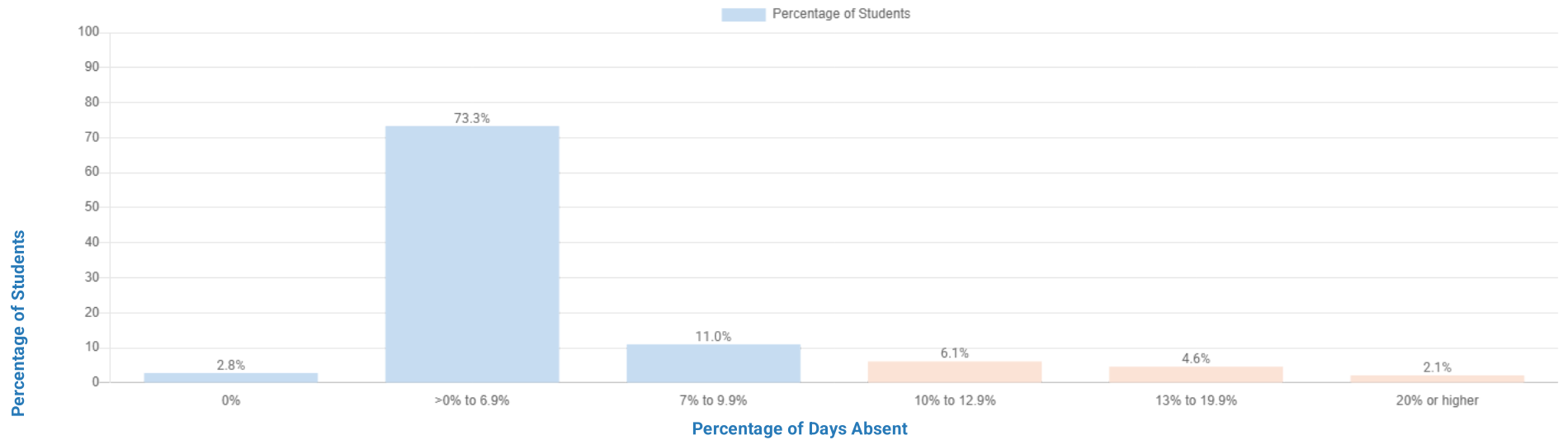

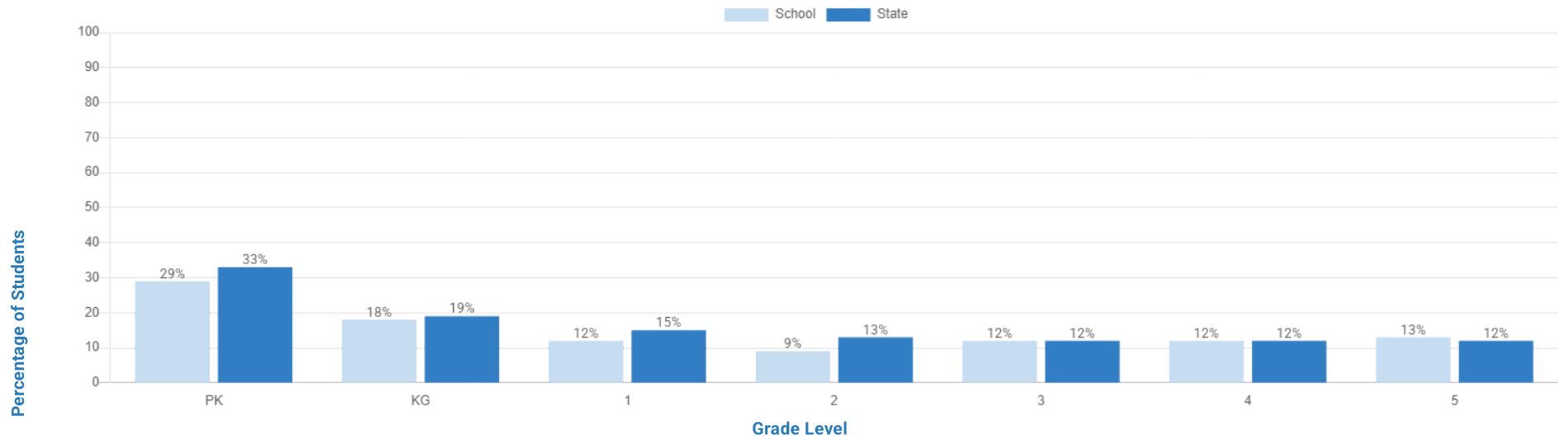

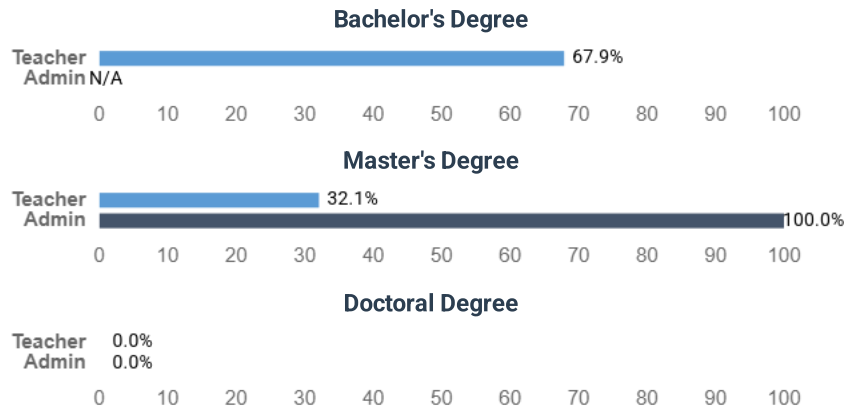

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. NJ state curriculum standards are delivered by the Super Kids Literacy Program (Zaner-Bloser), the Wit & Wisdom Literacy Program (Great Minds), the Eureka Math Program (Great Minds), and TCI Program in Science & Social Studies. Students receive instruction in 6 special areas: PE, Art, Music, Computers, Spanish, & Library. District and building programs include Special Education, Impact, and core reading & math intervention.

Staff participates in various PD including LETRS training,s, Intervention Strategies, SEL Book Clubs, & Handle with Care. Teachers turn-key PD with our staff and district through In-An-Hours.
