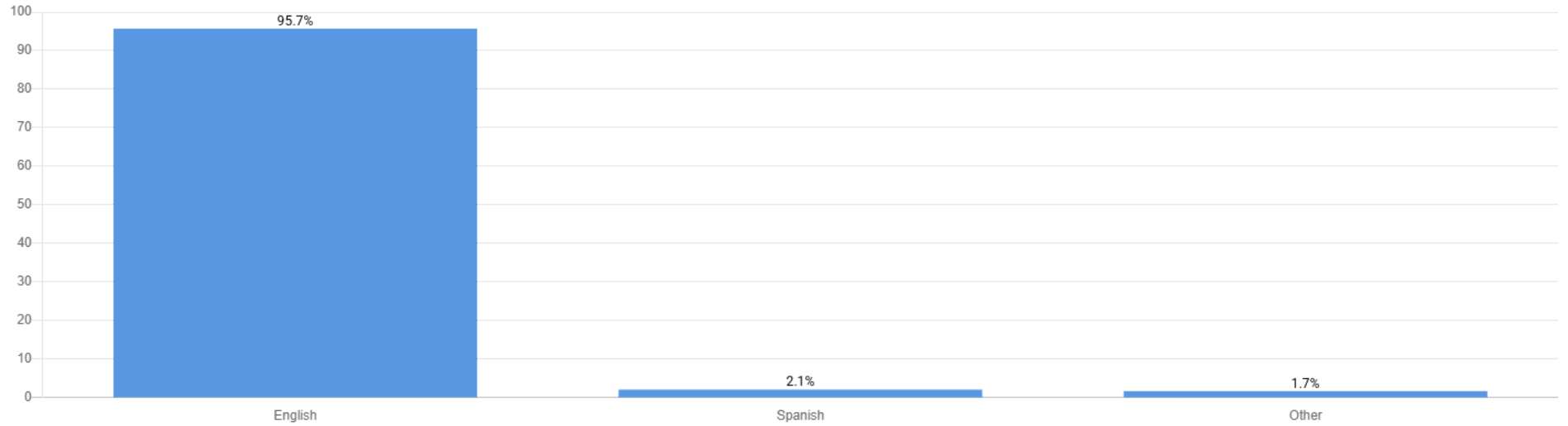

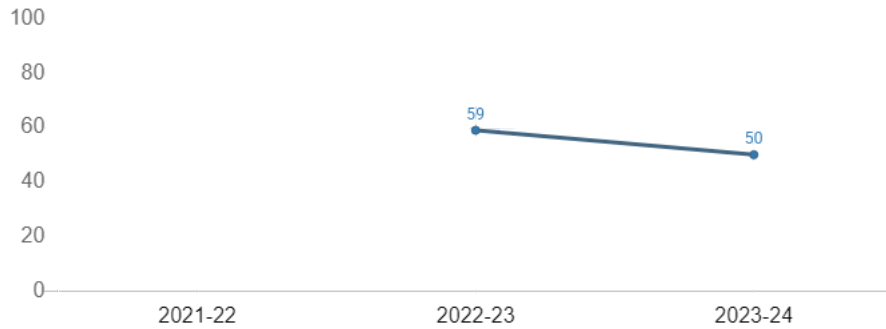

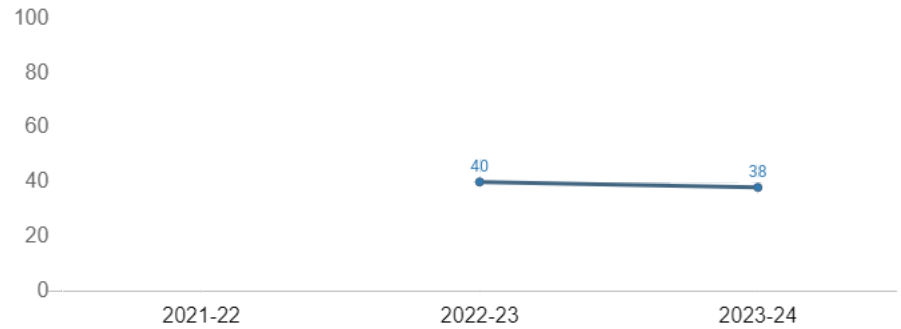

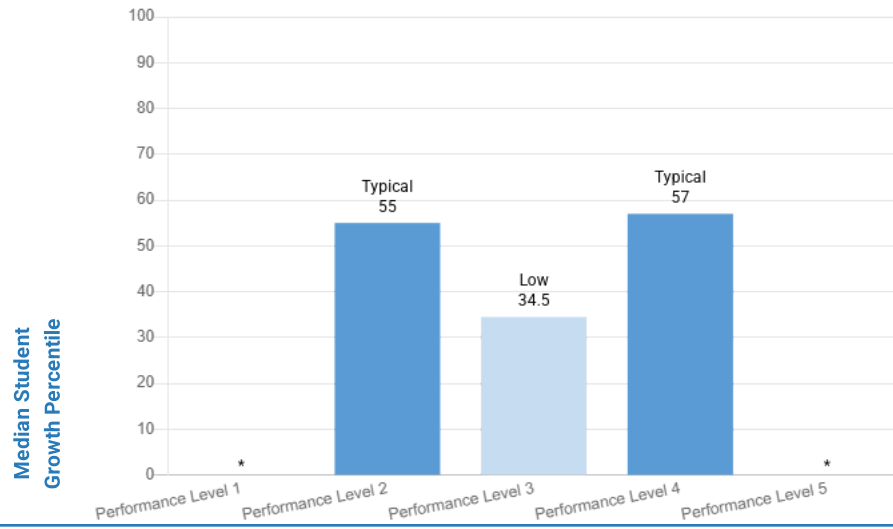

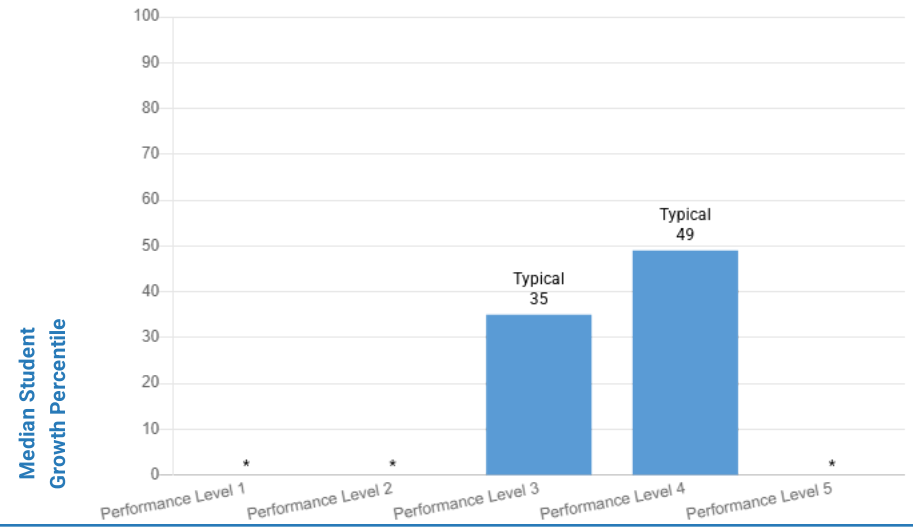

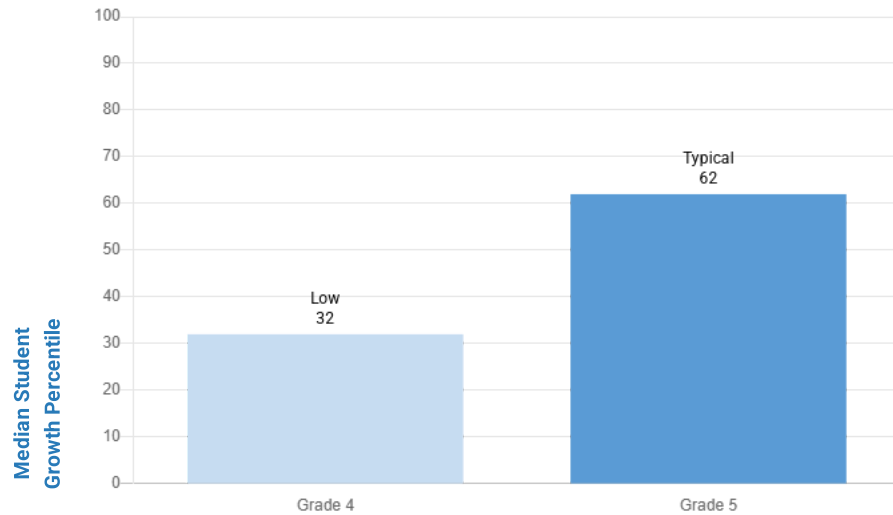

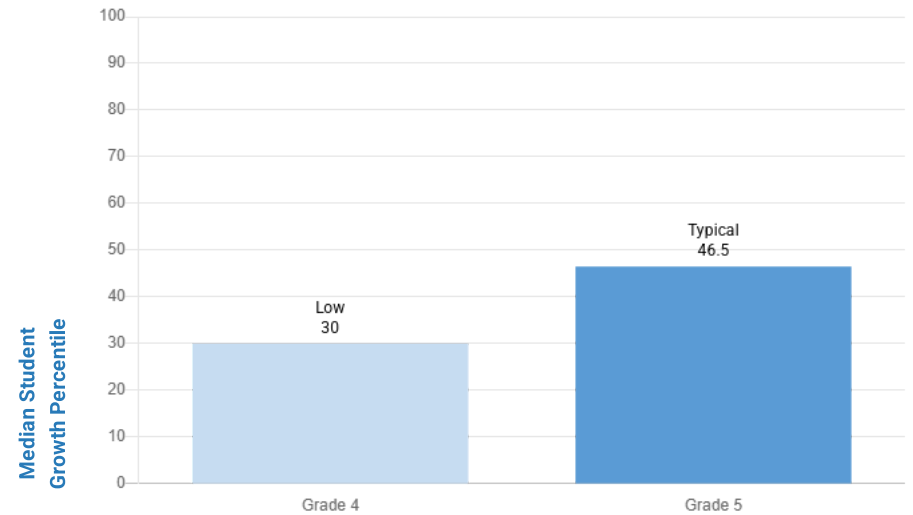

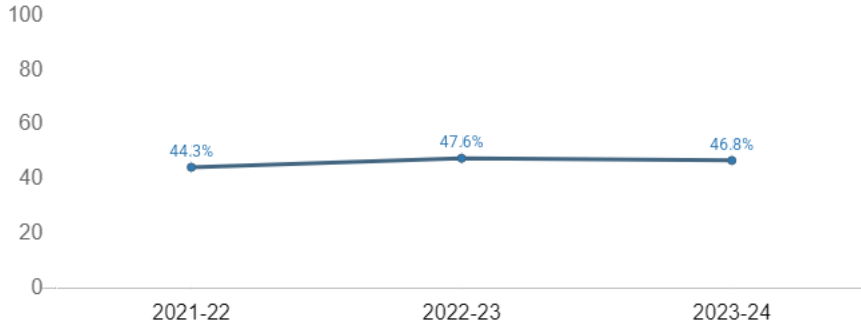

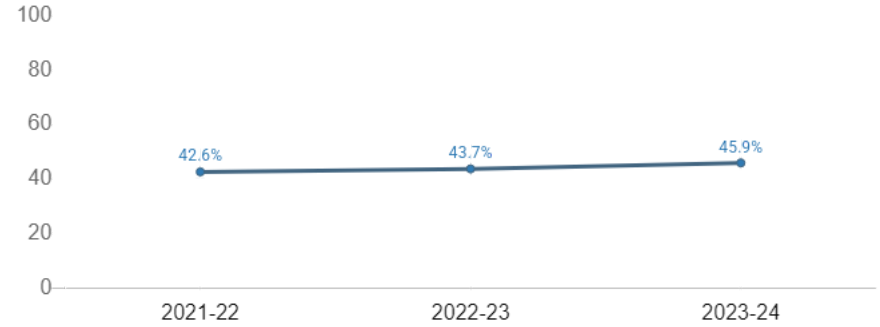
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 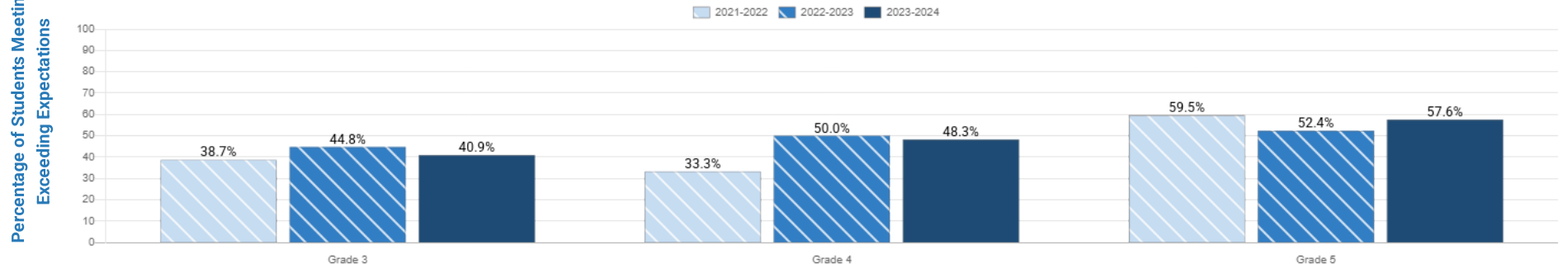

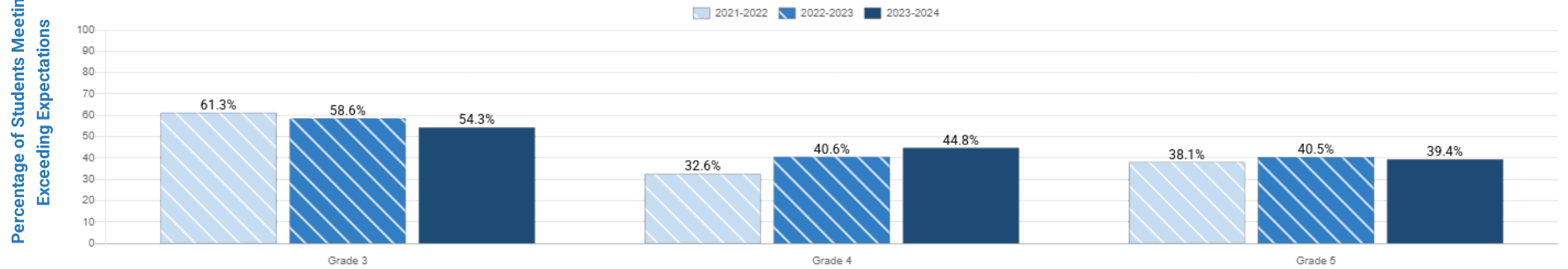

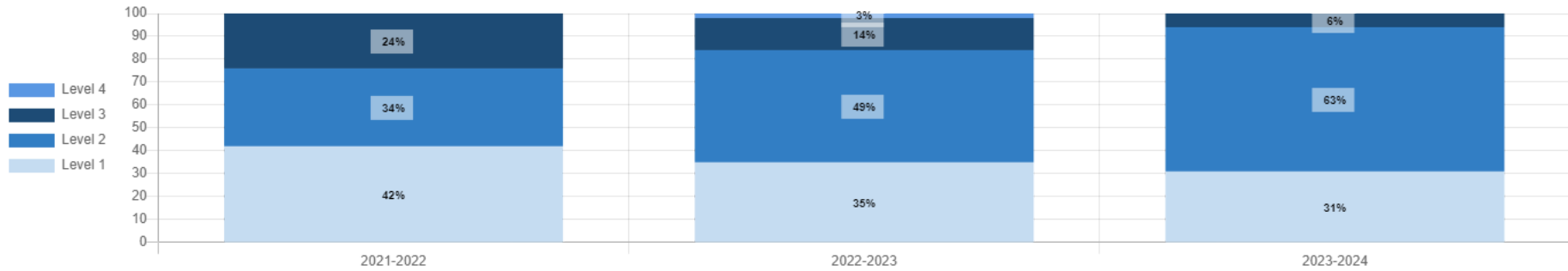

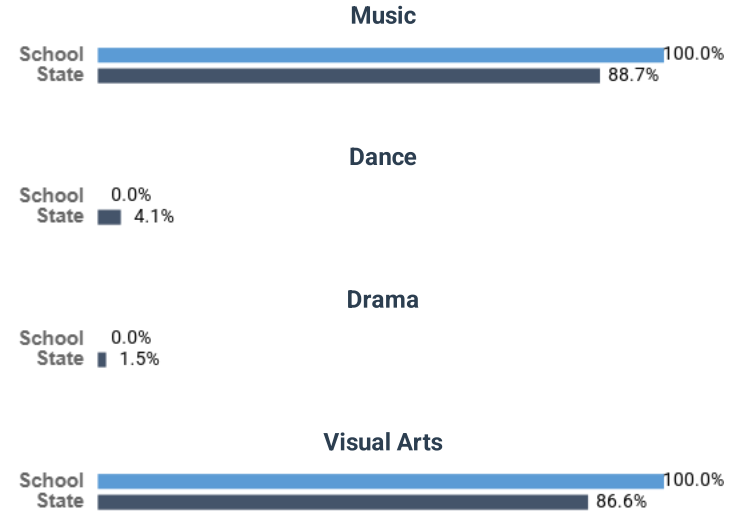

Students enrolled in one or more classes by discipline:



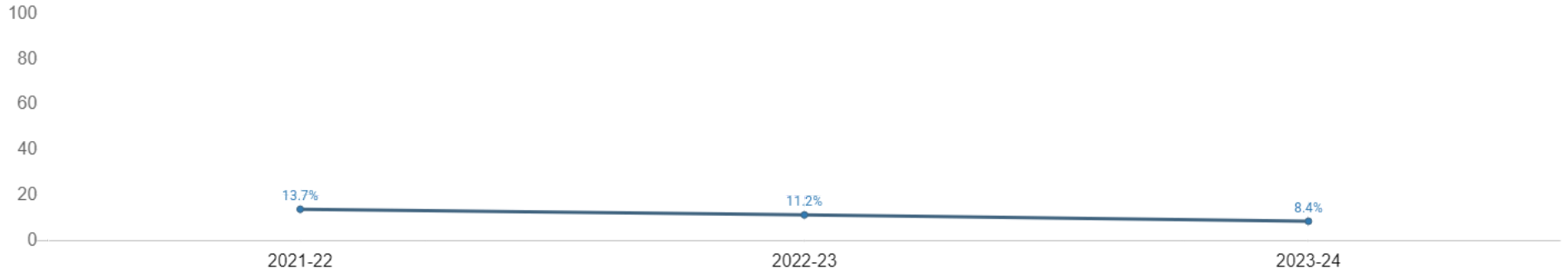

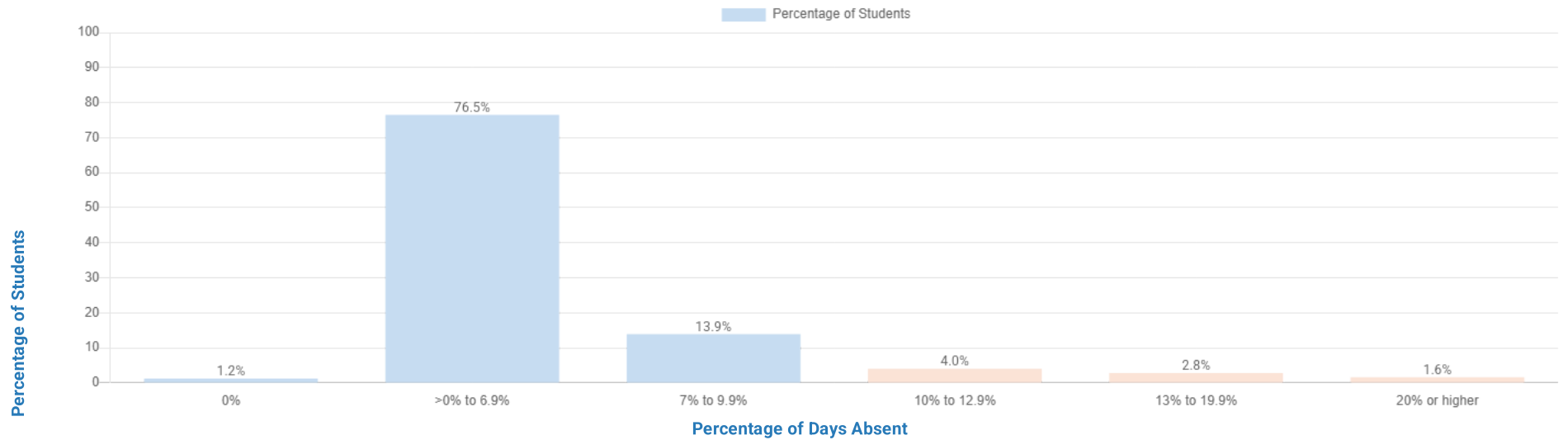

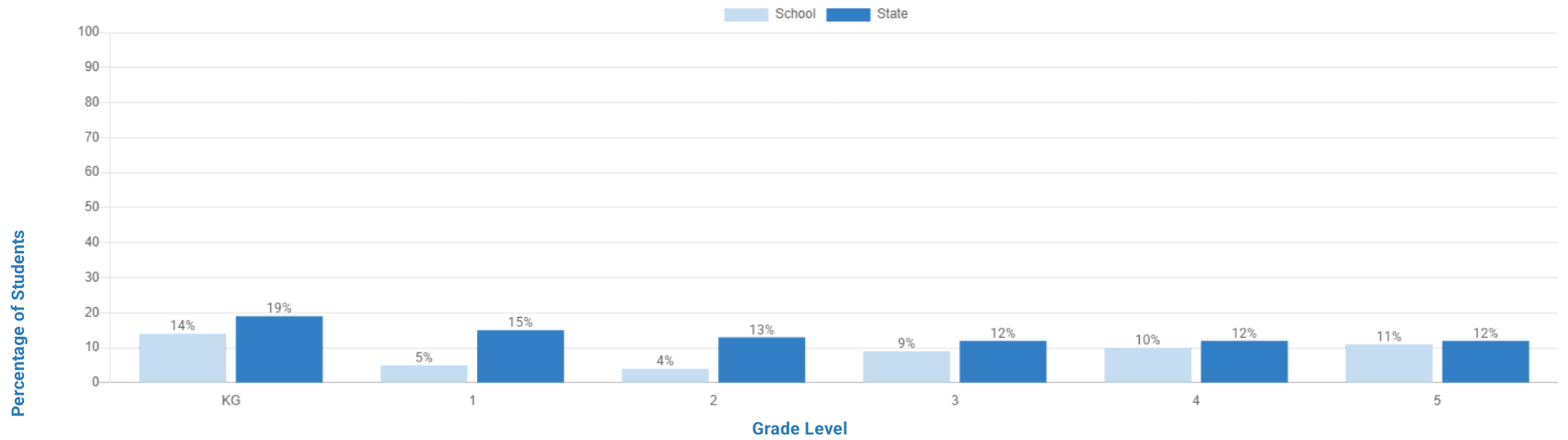

Staff

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 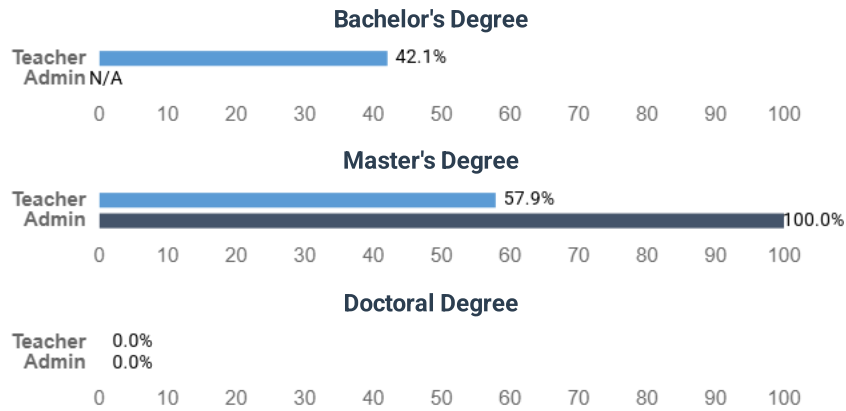

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Glendora Elementary School is a Kindergarten through Grade Five building with a long tradition of service to the community. Courses, Curriculum, Instruction:

NJ state curriculum standards are met through the utilization of the Superkids and Wit & Wisdom Reading Programs, the Eureka Math Program, and TCI Programs in Science & Social Studies. Students receive instruction in six special areas: Art, Computers, Library, Music, Physical Education, and Spanish. Intervention is provided to further meet the individual students' needs through IMPACT for advanced learners, Special Education for those with different abilities, Corrective Reading support, and Basic Skills Math support. Students also participate daily in recess and a Health and Physical Education (HPE) block which provides social and emotional lessons to further enhance a well-rounded educational experience.



Clubs and Activities:

Glendora Elementary School offers after-school clubs called CHAMPS. These club offerings for Grades 4-5 include Dance Club, Dungeons & Dragons Club, Disc Golf Club, News Media Club, Chess Club, and Self-Care Club. Glendora Elementary School offers a Support-On-Site(SOS) Program. This program meets monthly for both new and veteran teachers to obtain ideas and support from their colleagues. Professional development is also offered during staff faculty meetings and at grade-level PLCs.



Student Supports and Services:

Student support services include Intervention & Referral Services Committee (I&RS), Child Study Team (CST), Special Education Services , Speech, and Guidance Counseling. The school is also able to provide families with connections to support from outside resources and services.



Parent and Community Involvement:

Glendora Elementary School's Parent Teacher Group (PTG) holds monthly meetings and is responsible for leading our fundraising activities. The PTG develops projects that enhance the students' school experience. The PTG sponsors Spirit Day prizes, assemblies, holiday activities, family nights, class trips, and Field Day.

Facilities:

During the past few years, Gloucester Township Public Schools has invested a significant amount of resources into Glendora Elementary School. These include a new boiler and air conditioning units for all classrooms; an entirely new roof for the building; a security vestibule at the main entrance to control the admittance of visitors into the building; and a new parking lot and playground blacktop with new activities painted onto the surface for the students to engage in cooperative games. This year the building received upgrades to their fire and security alarms, as well as to the wireless internet infrastructure.



School Safety:

Gloucester Township Public Schools and the Gloucester Township Police Department engage in a mutually beneficial partnership. Glendora benefits from a police officer serving as a School Resource Officer(SRO). The SRO provides a positive presence at Glendora Elementary School, connecting with the students and providing access to resources for families and administration. The SRO attends the scheduled monthly security drill and provides insight on how best to protect our students and staff. There is also a Law Enforcement Against Drugs(LEAD) officer who teaches lessons to Grades K-4 covering topics such as stranger danger; the dangers of vaping; and internet safety. The LEAD officer also teaches a series of lessons to students in Grade 5 and facilitates a LEAD Graduation. During Police Appreciation Week, the police department provides demonstrations for our students including meeting the K9 unit; touring a police car; seeing the Special Response Team(SRT) gear; and a visit by McGruff.



Technology and STEM:

Glendora Elementary School has dedicated itself to engaging students through the utilization of technology. Chromebooks are available to students in all grades. In Grades K-5, carts with devices to utilize are available in each classroom. These students are assigned their own device, which remains in school. Also, classrooms are equipped with interactive Smartboards for staff to engage students with the curricula.
