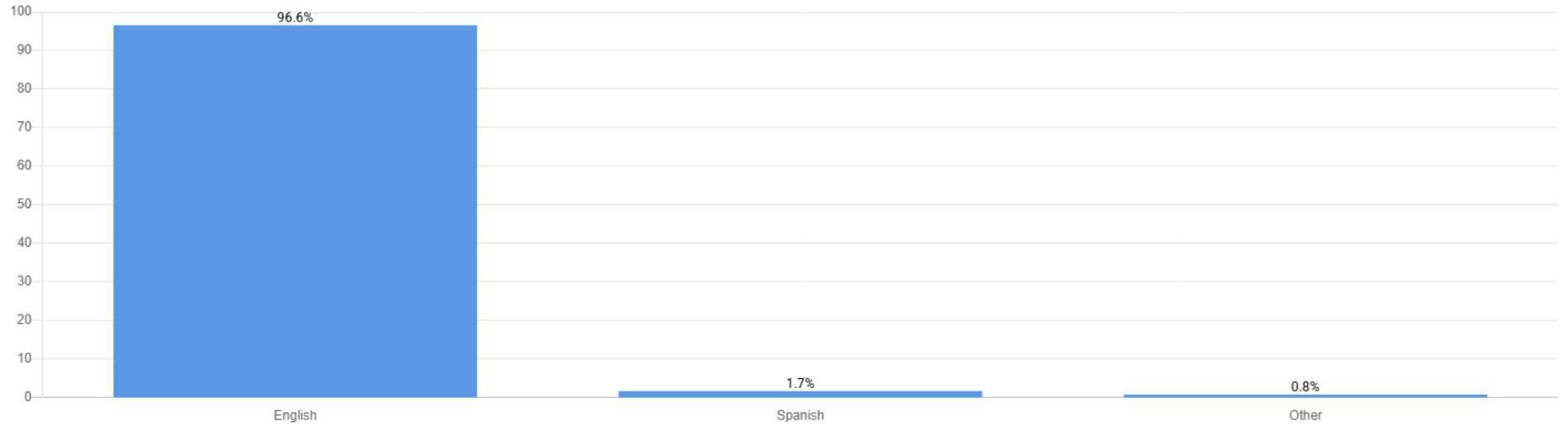

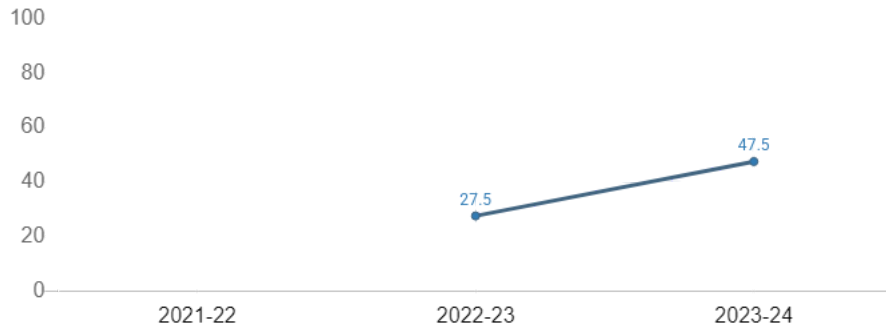

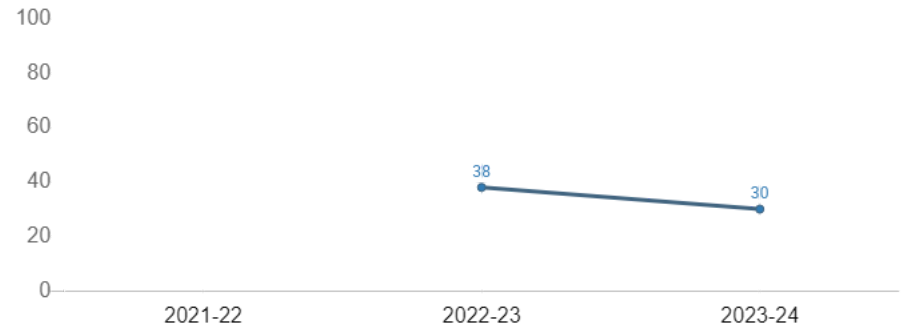

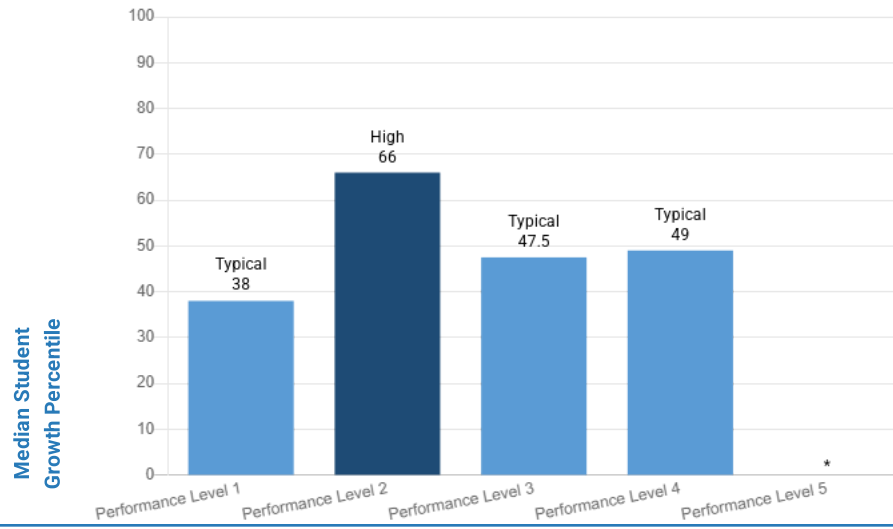

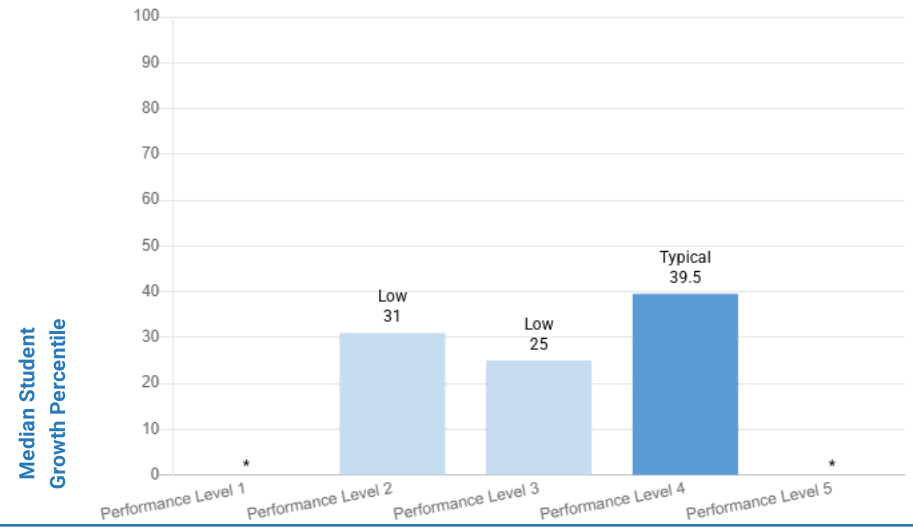

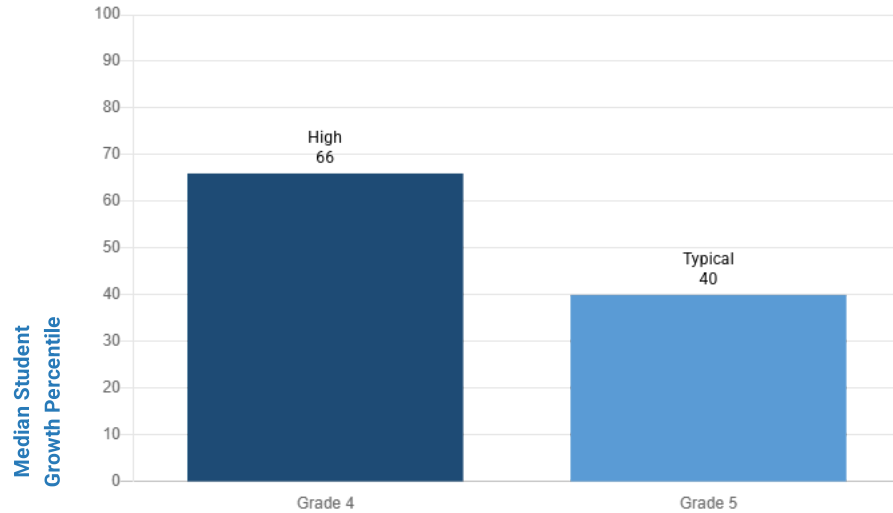

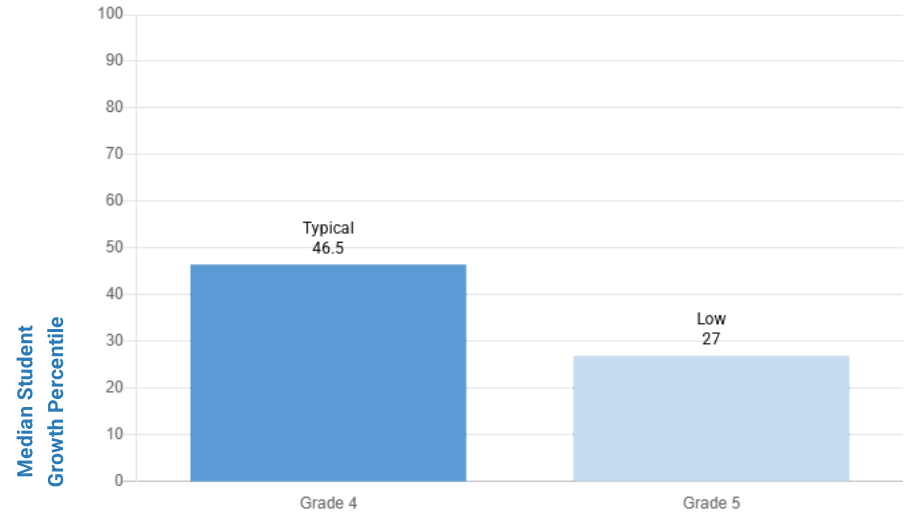

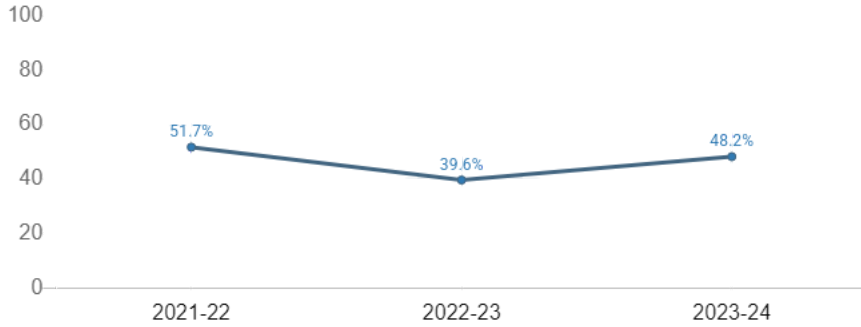

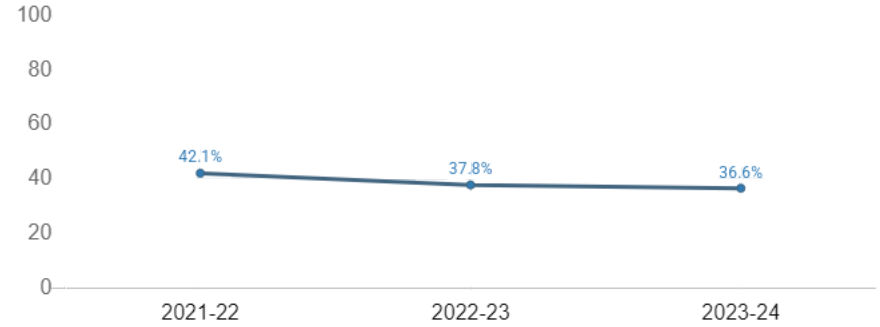
English Language Arts and Mathematics Performance Trends

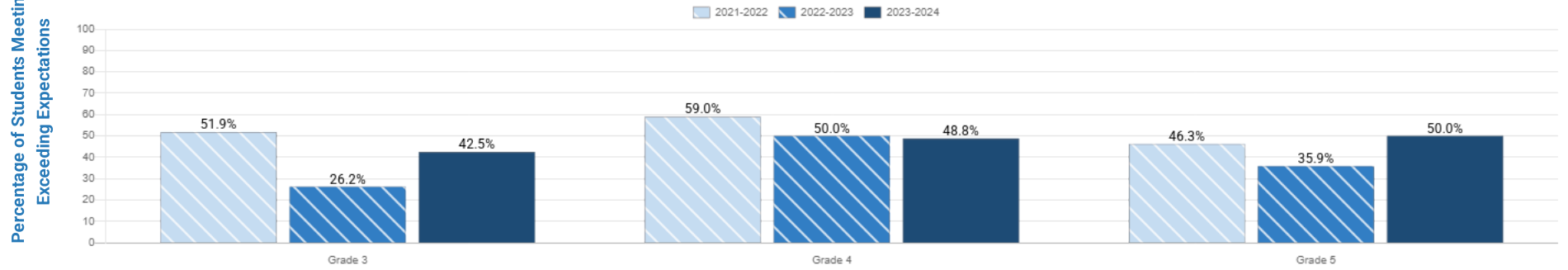

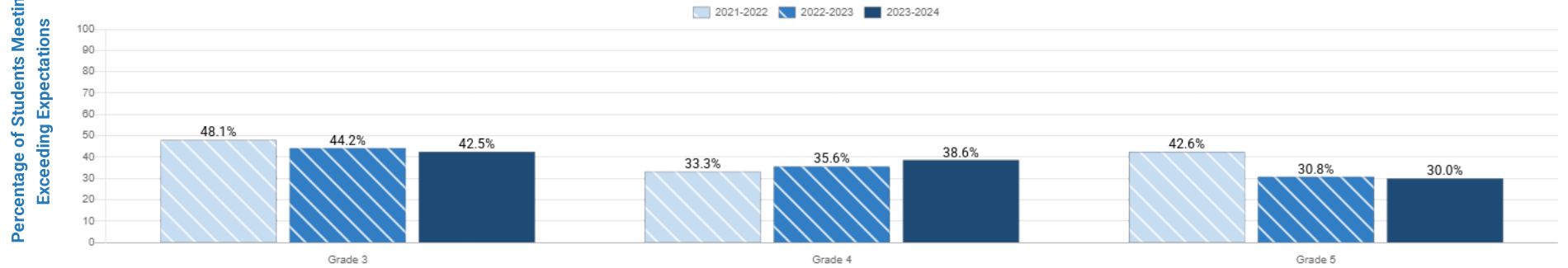

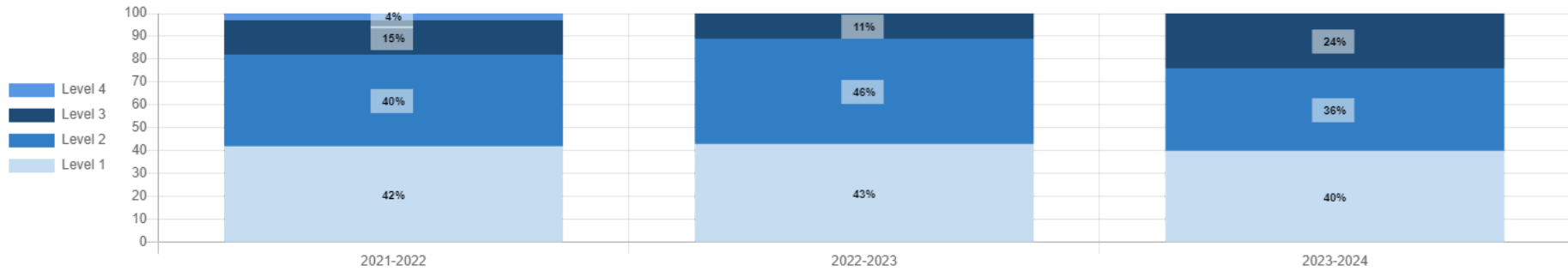

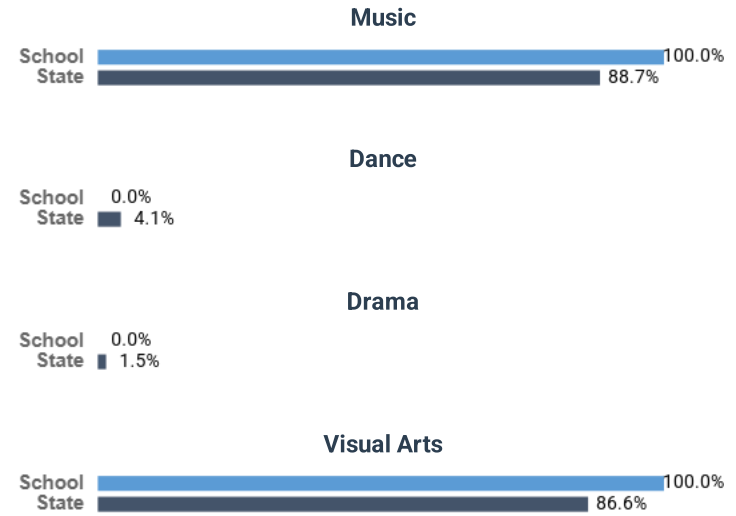

Students enrolled in one or more classes by discipline:



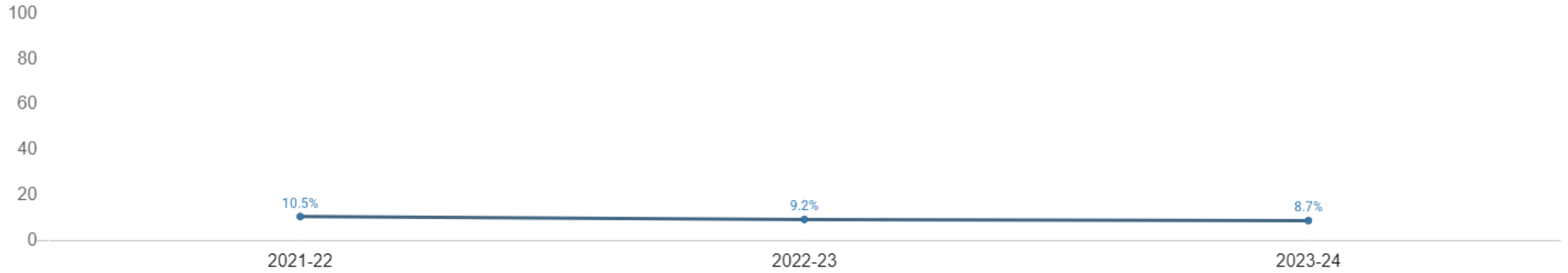

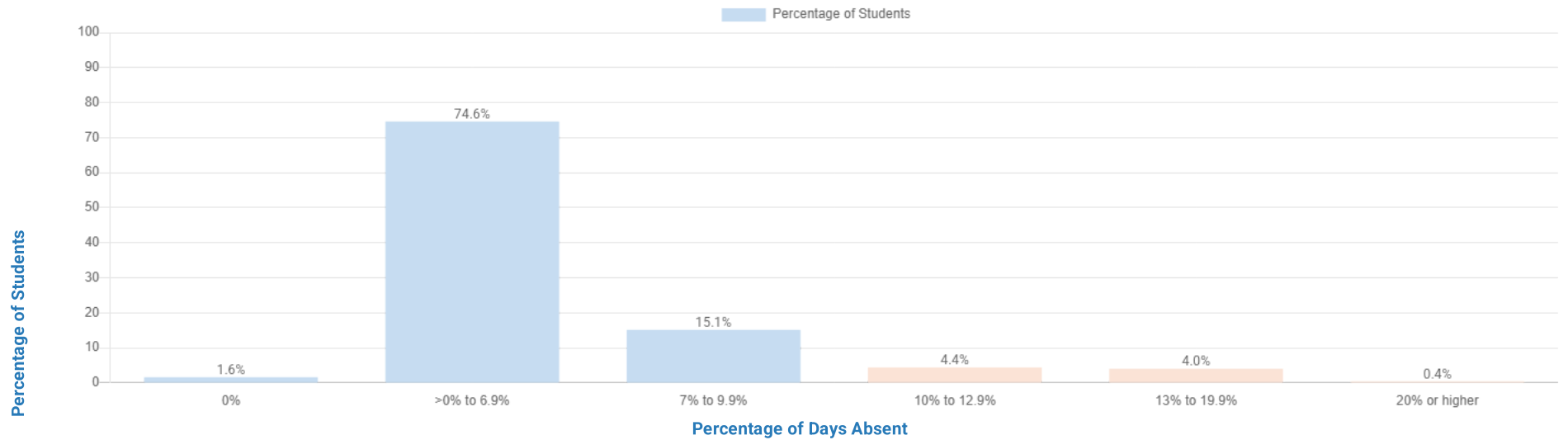

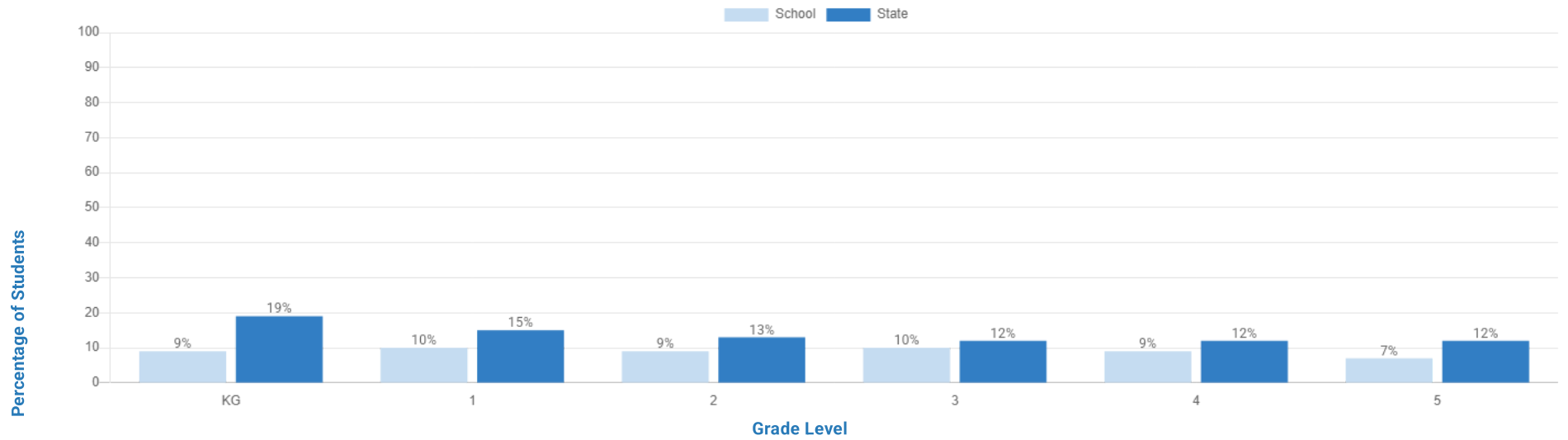

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 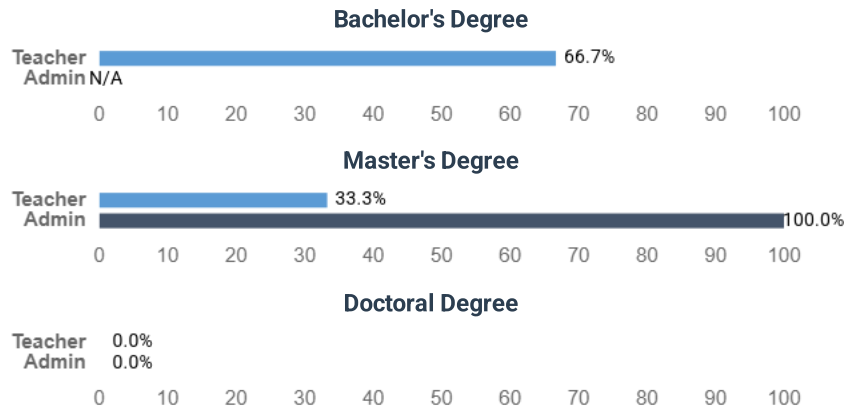

Staff and Professional Learning:

GTES's 2 County Teachers of the Year, 2 NJ Achievement Coaches, and its 2 National Bd. Certified Teacher provide professional development on a school & district level. A Support-On-Site Program (SOS) meets monthly for teacher advisement. The staff support one another though on-site, teacher led professional development opportunities.



Student Supports and Services:

Student support services include Intervention & Referral Services Committee (I&RS), Child Study Team, Resource Room & In-Class Support instruction, Speech, and School Counseling. A well managed Character Education Program- Character Strong joins an incentive/achievement program focused on Kindness, Hard Work, and Perseverance. GTES also fully implements the tenants of PBIS in conjunction with our character education programs.



Student Health and Wellness:

GTES makes use of a Health/PE block to instruct students and engaged them in conversations related to Health and Wellness. The Character Strong program is offered by our School Counselor and supported by our teachers to teach and reinforce our character education traits. Students are engaged in weekly lessons with the school counselor. GTES also boasts "The Honeycomb" which is an area in the building that students may visit if they need a moment to gather themselves, rest, reflect, or otherwise tend to their emotional well-being.
