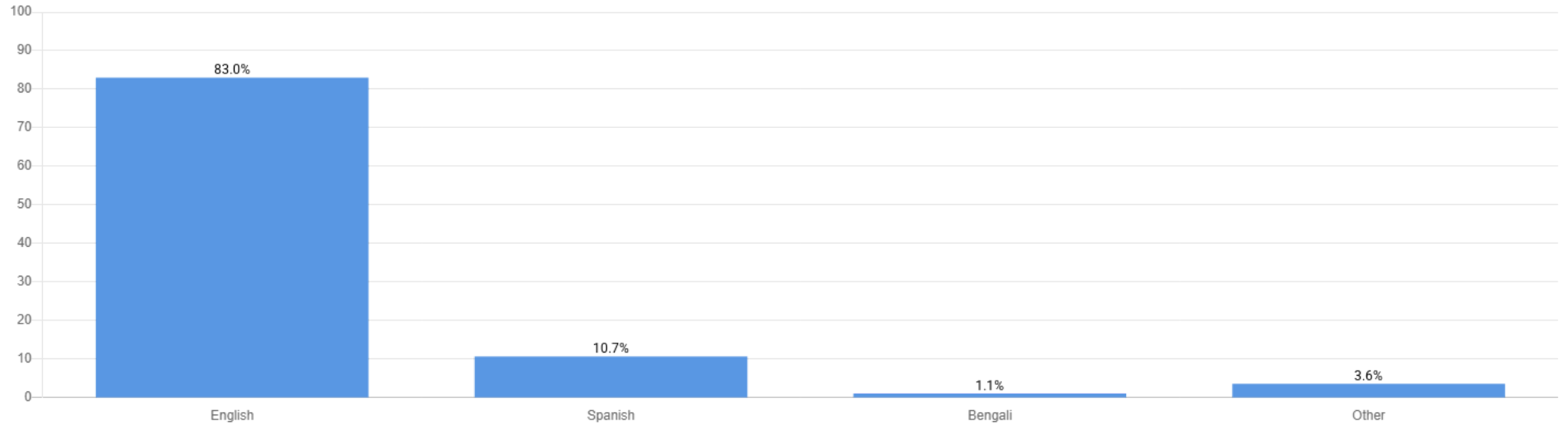

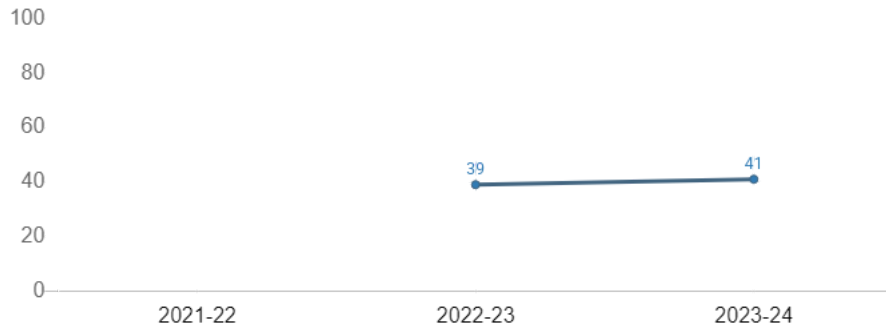

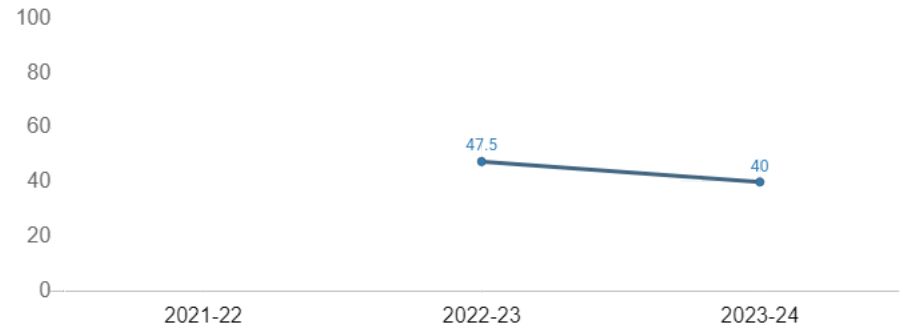

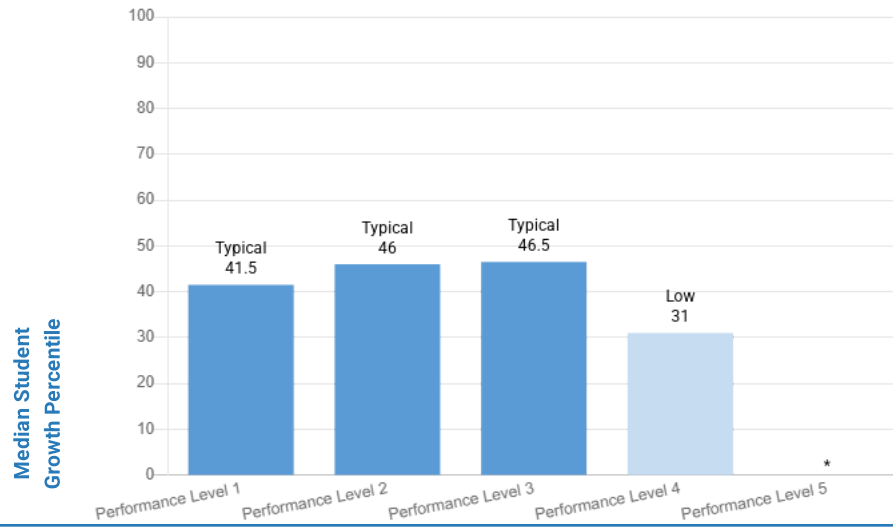

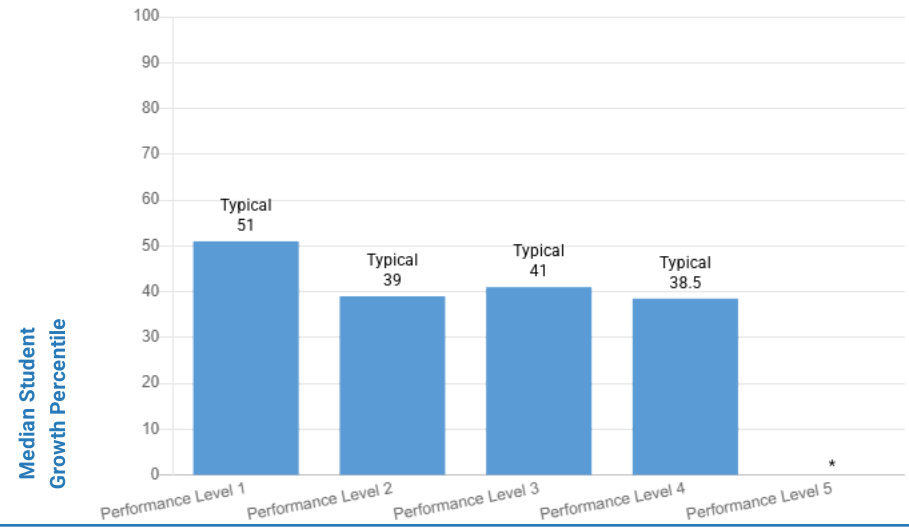

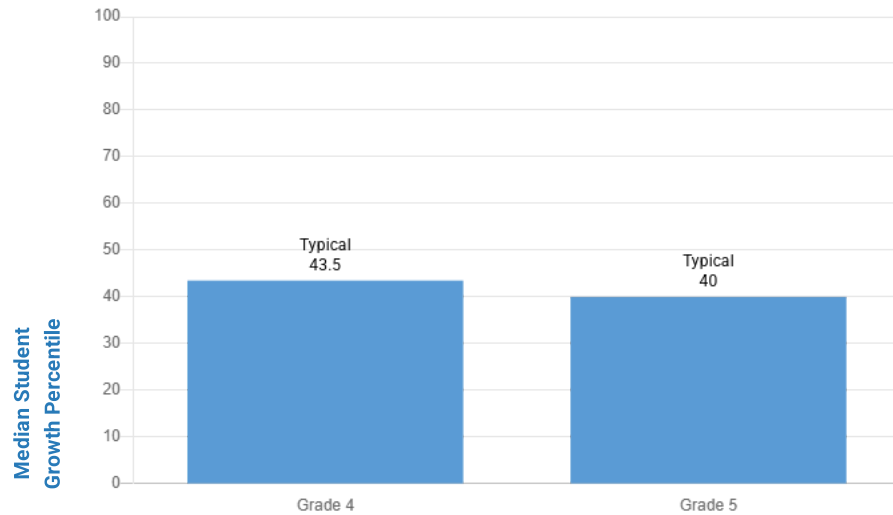

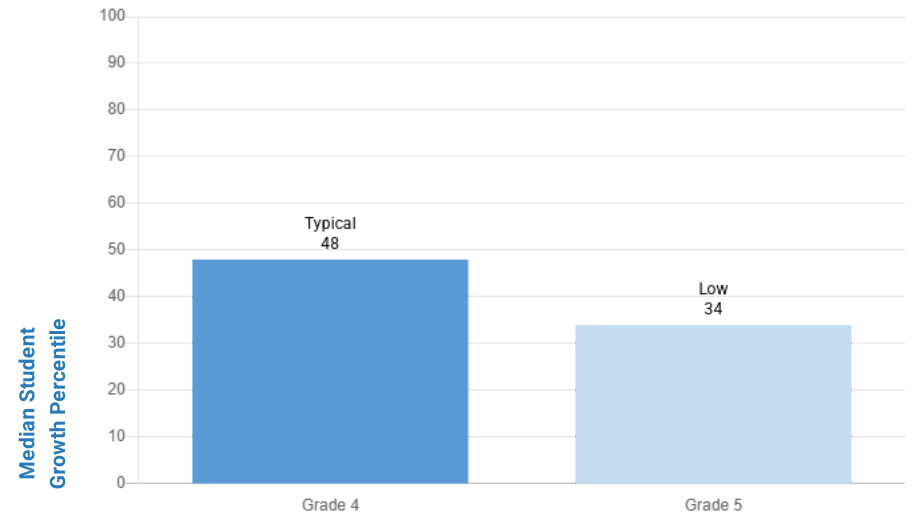

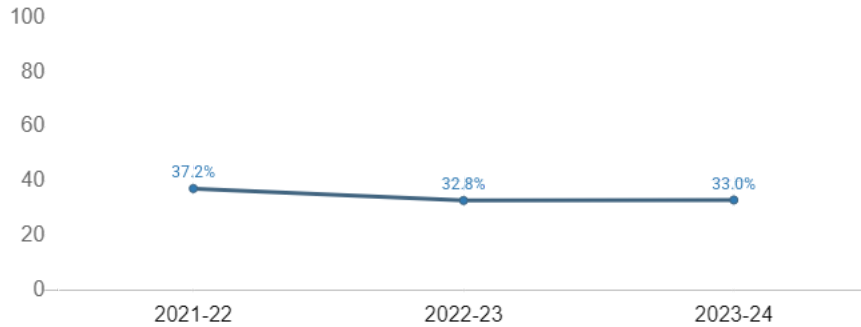

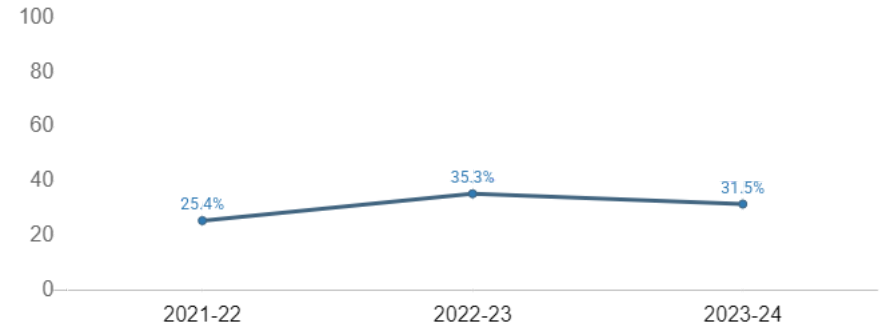
English Language Arts and Mathematics Performance Trends

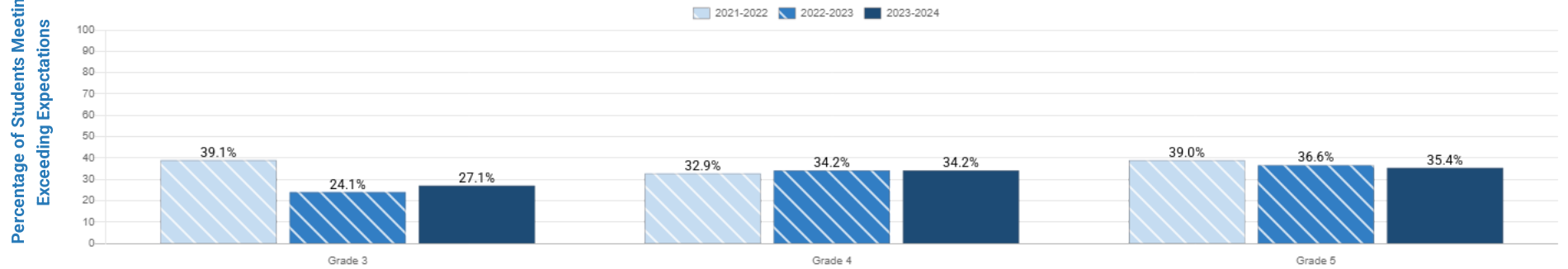

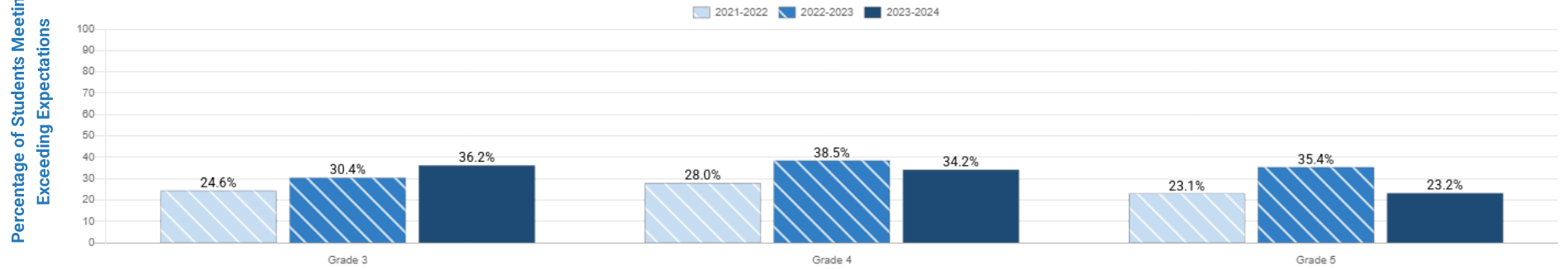

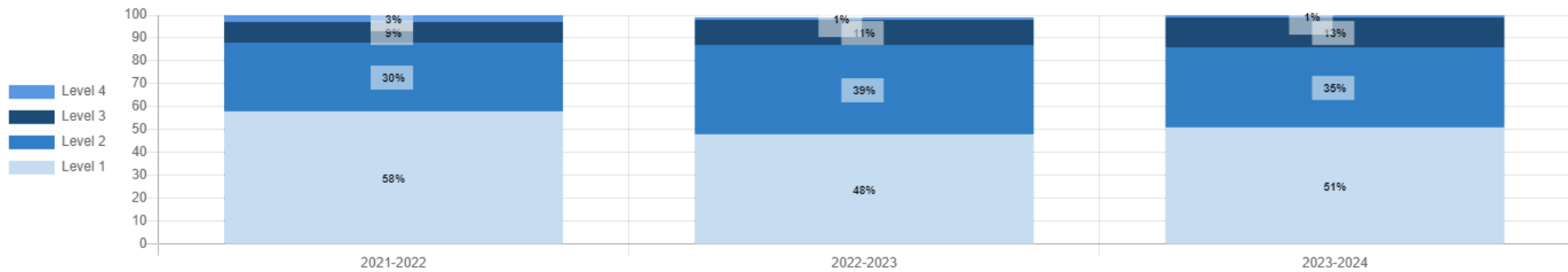

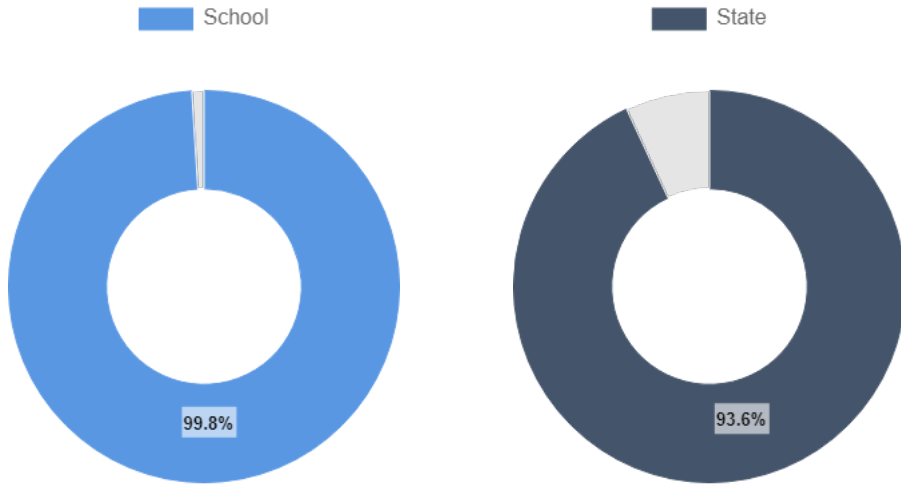

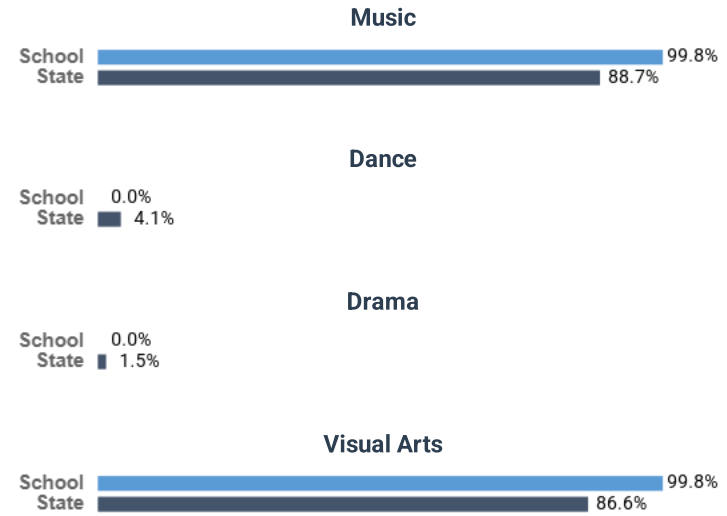

Students enrolled in one or more classes by discipline:



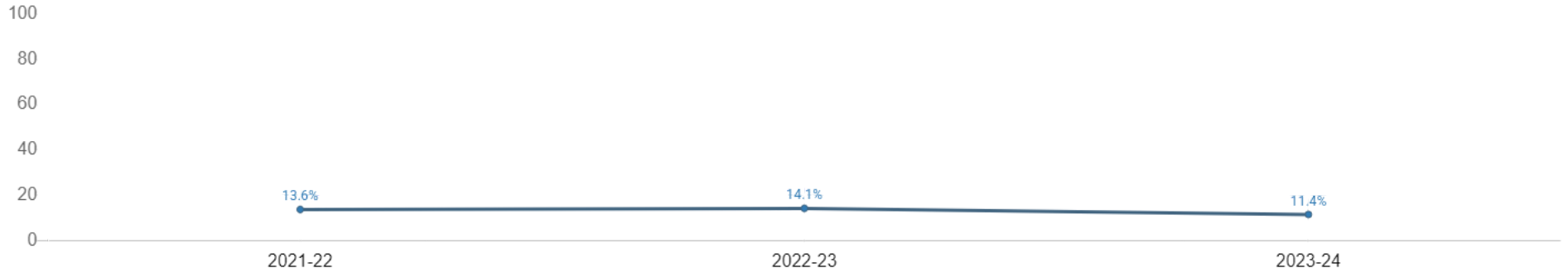

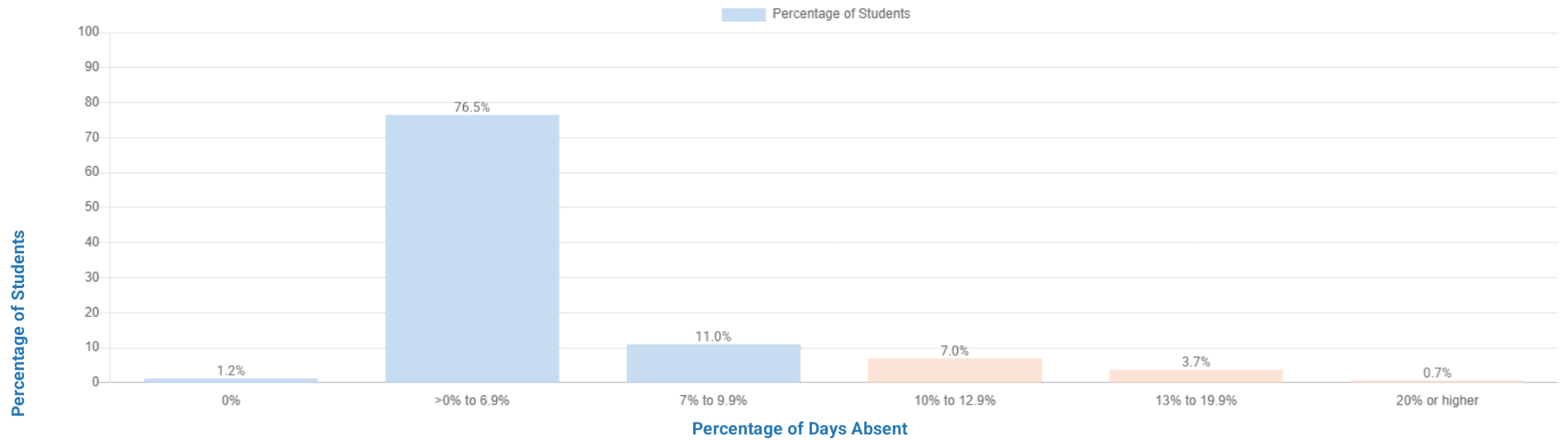

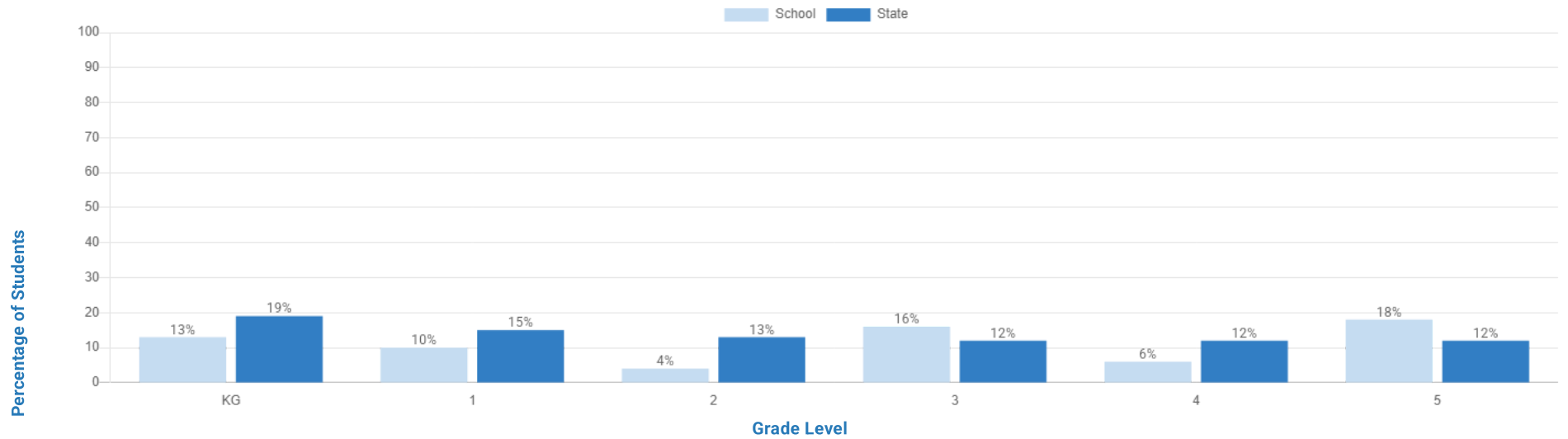

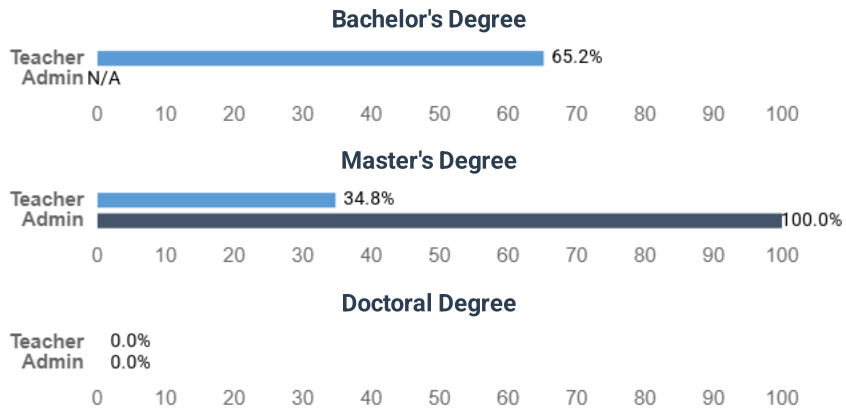

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. "Our enrollment consists of approximately 500 students in Kindergarten through Fifth grade. Classroom practices and instructional strategies are aligned with the New Jersey Student Learning Standards. We use the Superkids Reading program for grades K-2 and the Wit and Wisdom ELA program for grades 3-5. For math we utilize the Eureka Math Squared program. We also offer a gifted and talented program (IMPACT) and utilize the TCI Science and Social Studies curriculum as well. To help provide additional academic support to close the learning gaps identified by our Renaissance Learning Star online assessments and State Testing (NJSLA), online programs like Lexia, Rocket Math, and Zearn are utilized by our students on a daily basis to remediate and enhance instruction. After School remediation programs are provided as well.

Student Supports and Services:

James W. Lilley Elementary School provides a variety of supplemental services to address student and family needs. Our School Guidance Counselors work diligently to meet our students' social emotional needs. They work in conjunction with the school and community to provide resources and supplemental support for JWL families who need extra assistance. We also provide other supplement services which includes our RTI Academic Intervention program, a diverse Special Education program, and a host of other support services like speech and OT/PT to ensure that our students have the opportunity to experience success academically and socially.



Student Health and Wellness:

Health and wellness plays a major role in the students' academic performance. Age-appropriate puberty and hygiene lessons are taught during the school year by certified staff. Hearing, vision and blood pressure screenings are completed by our school nurse to promote wellness. Gloucester Township Schools also partnered with Care Solace, a confidential care coordination service to support the communities' mental health needs. We will also continue to implement the Character Strong. Our school counselors push into classrooms 2 times a month to use this program to provide instruction in Social Emotional Learning competencies and character development.



Parent and Community Involvement:

Parents and guardians are a vital part of our school community. They actively participate as members of JWL's Home and School Association. Their mission is to promote and provide the best educational opportunities possible for the children. Several fundraisers are held throughout the school year to provide additional resources and programs to JWL. School Safety:

All students at Lilley School are assigned Chromebooks on a 1:1 basis to enhance learning. There are instructional Smartboards in every classroom. STEM projects are a part of the Science curriculum. Additionally, we hold an annual STEM night for parents and students. Programs like Lexia, Rocket Math and Zearn are utilized by students/staff to remediate and enhance instruction.
