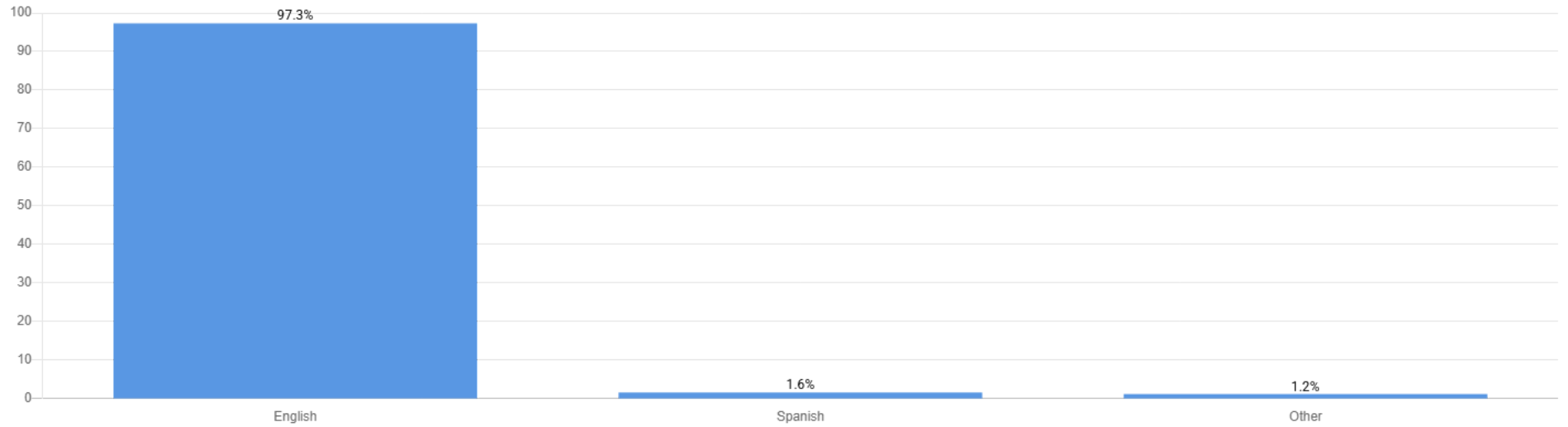

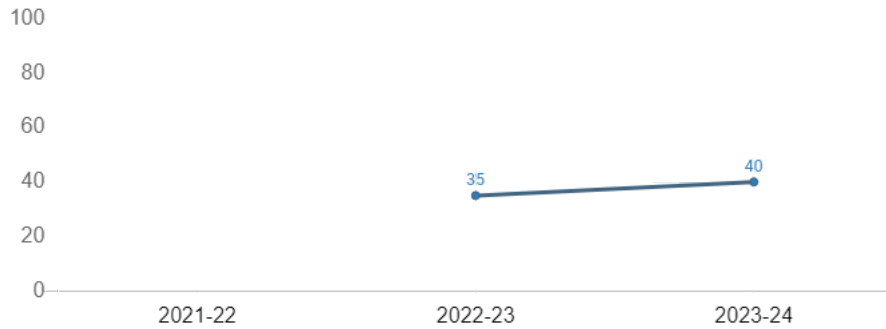

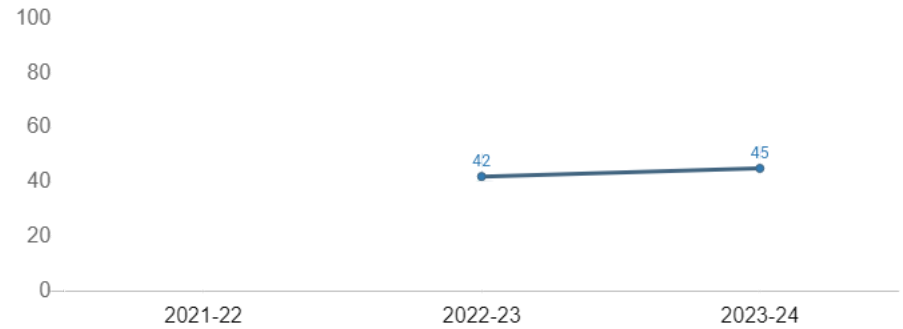

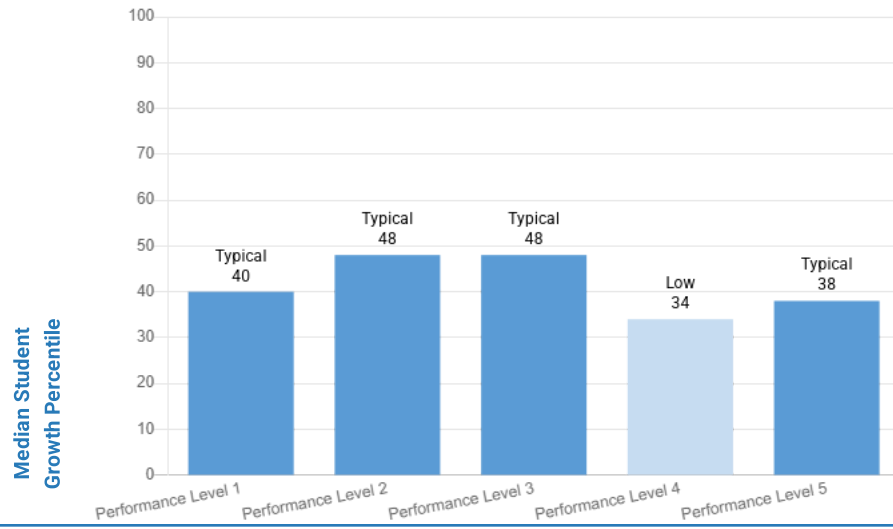

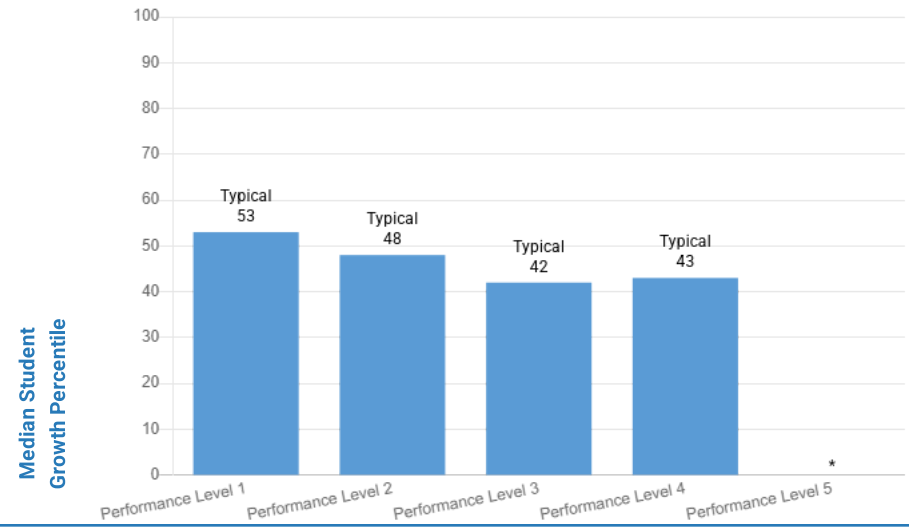

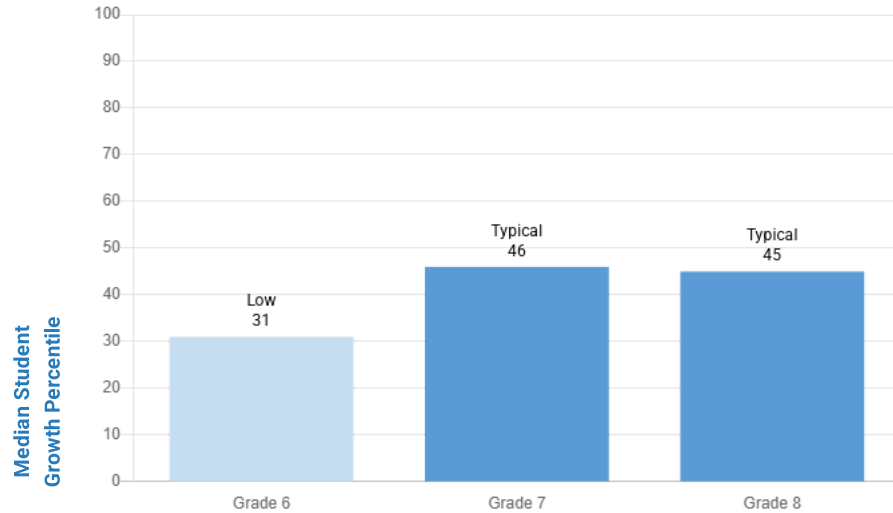

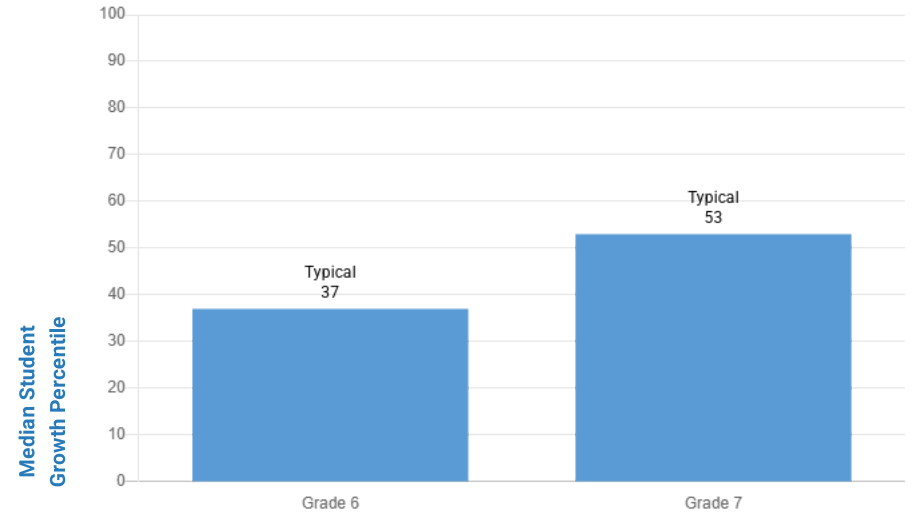

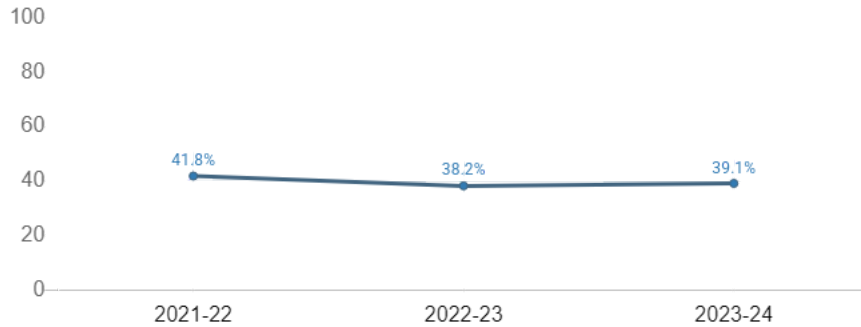

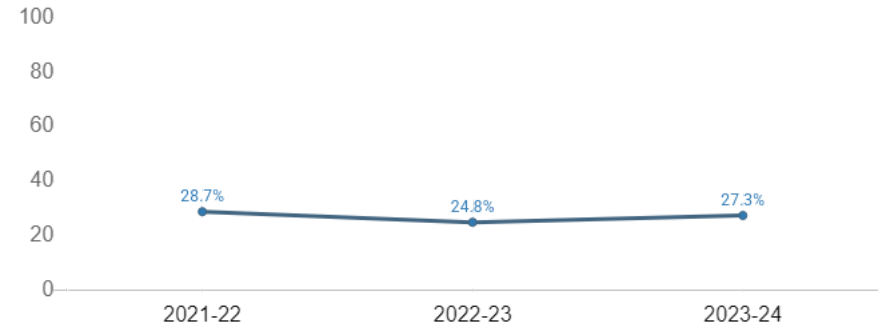
### English Language Arts and Mathematics Performance Trends

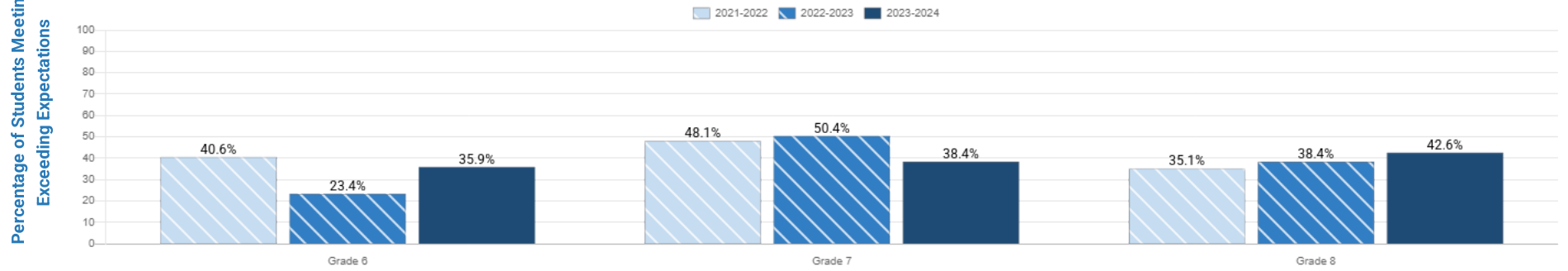

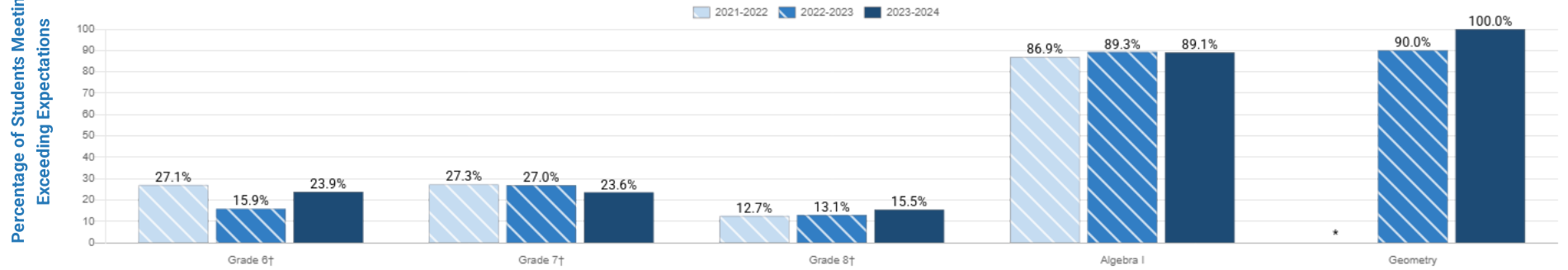

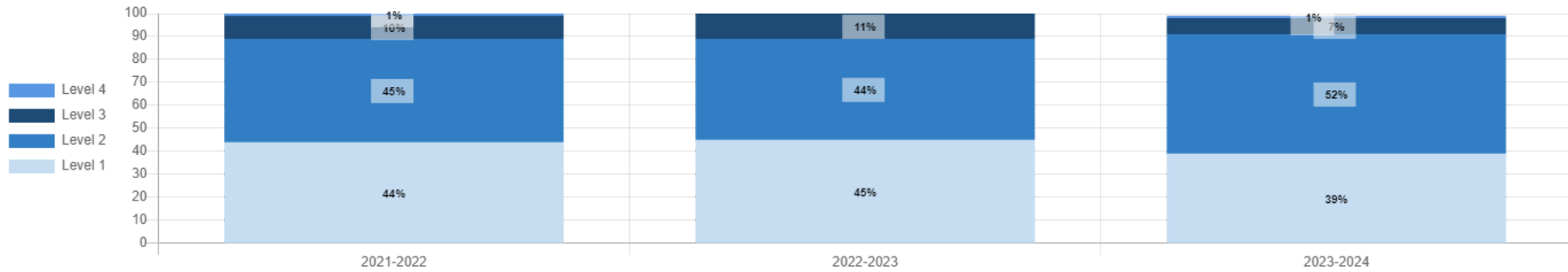

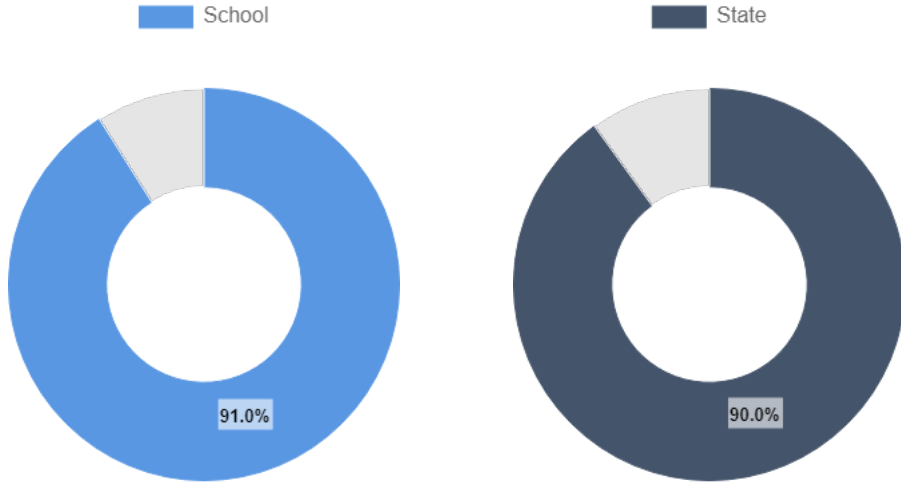

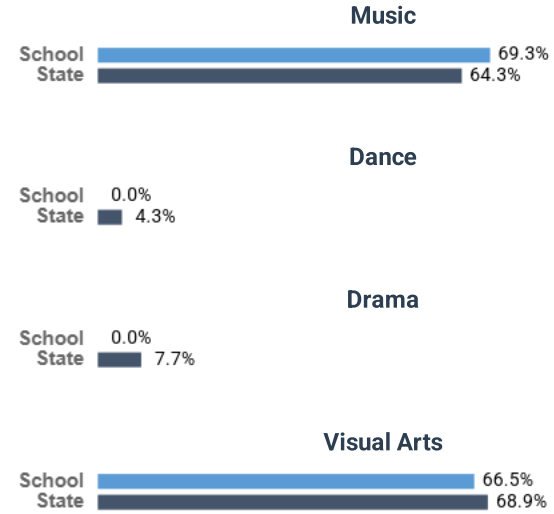

**Students enrolled in one or more classes by discipline:**



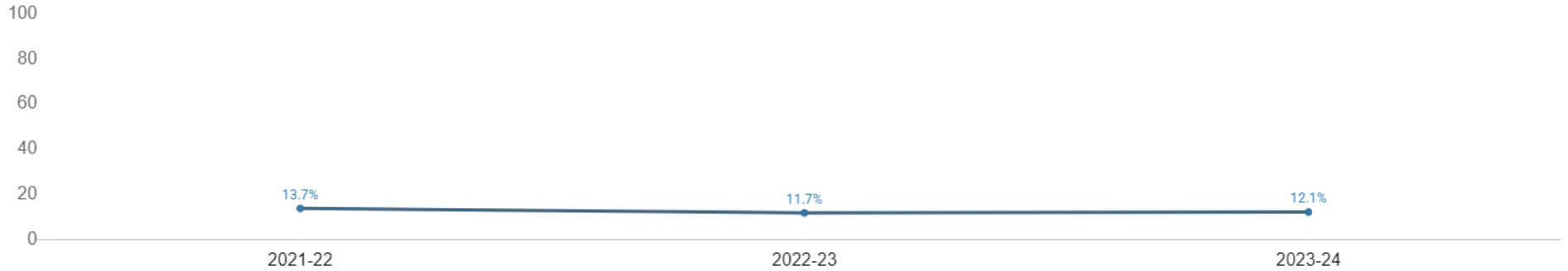

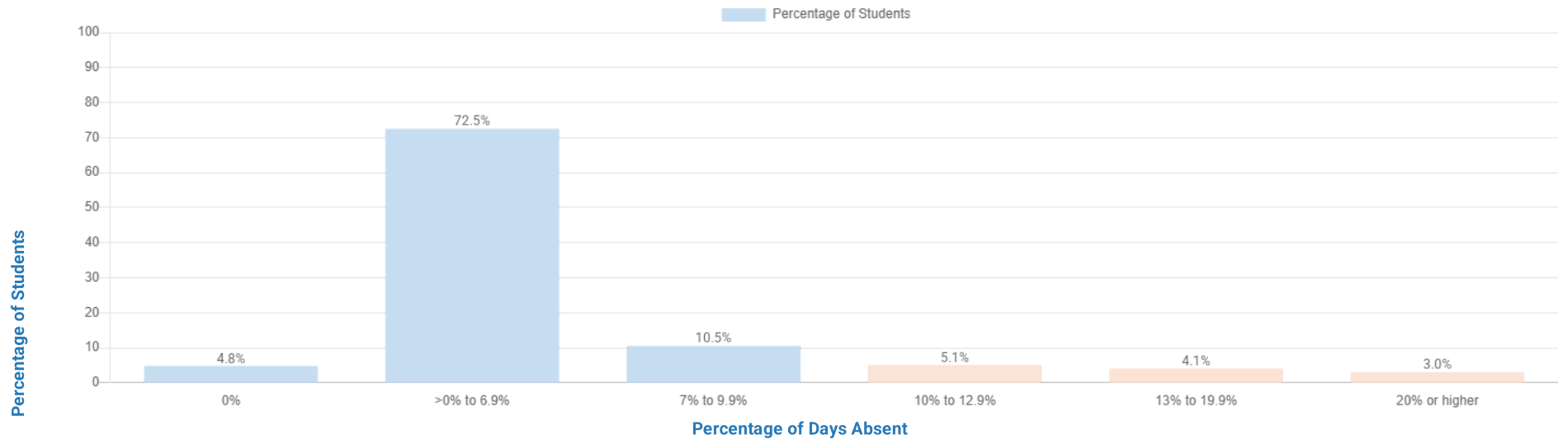

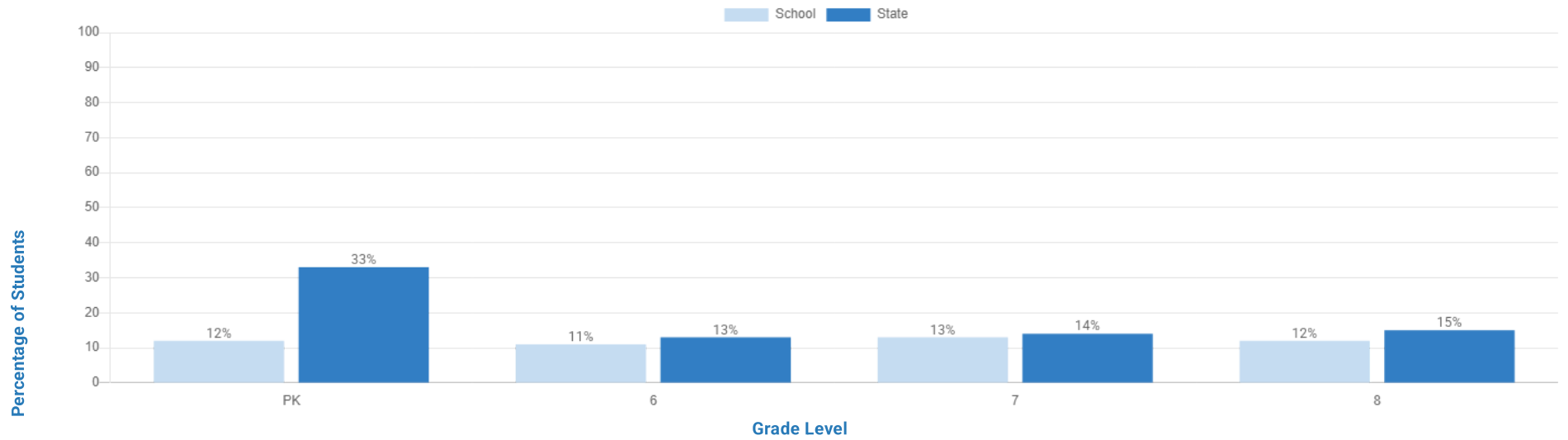

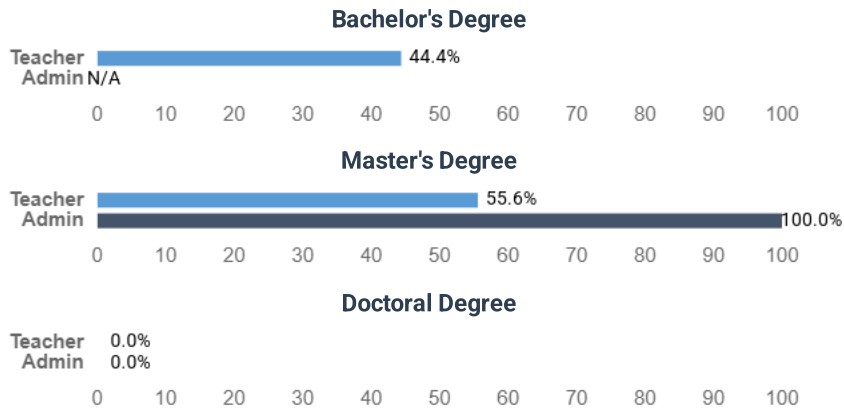

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

FIRST LEGO League (FLL ) In FLL, the children do the work; like program an autonomous robot (using the LEGO MINDSTORMS robot set) to score points on a thematic playing surface, create innovative solutions to a problem, all while being guided by the FLL Core Values. These three elements - the Robot Game, Project, and FLL Core Values - make up what we call our yearly Challenge. Teams also fundraise, create a team identity, and talk to experts in the field.

We recognize and support the diversity of our student body in age, maturity, physical and emotional development. Technology is integrated throughout the curriculum with every student possessing a district issued Chromebook. Physical education courses stress lifetime fitness, healthful living and social skills. There is an intervention program to offer extra support to students who struggle in math, and reading. We also offer an after school academic assistance program.
