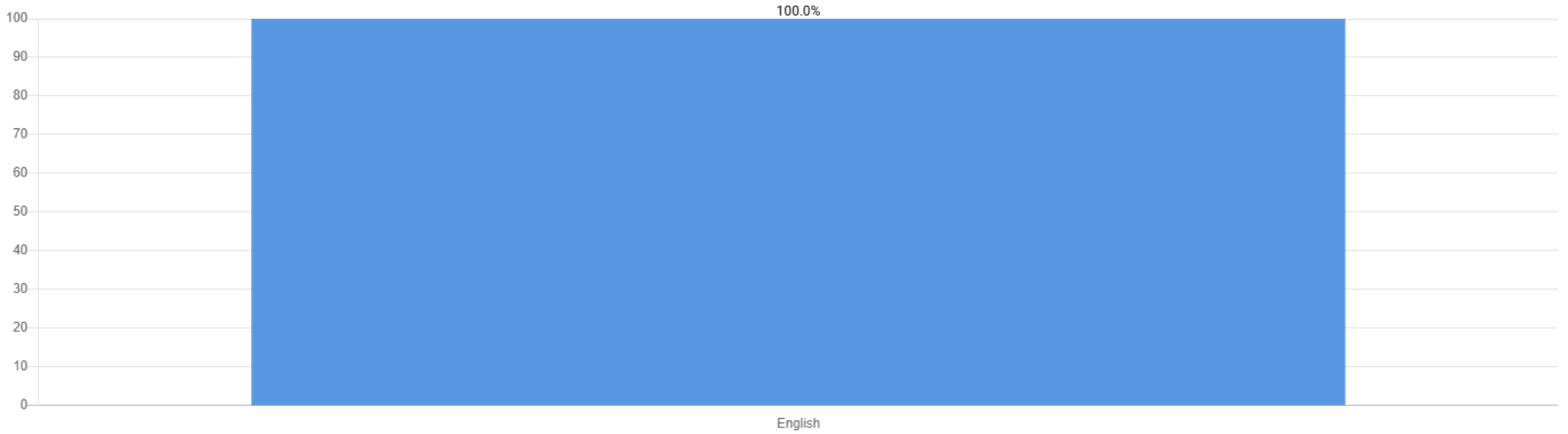

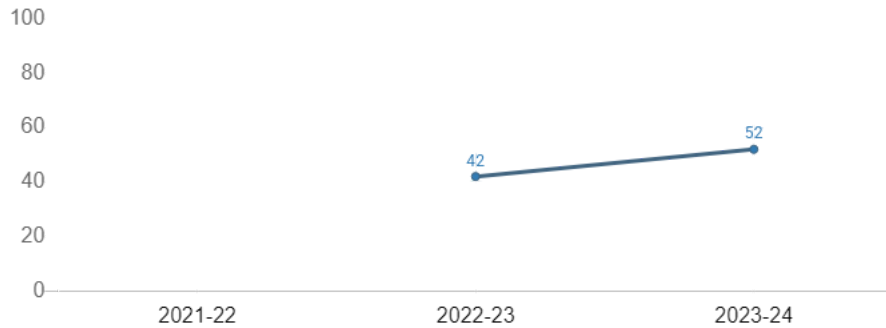

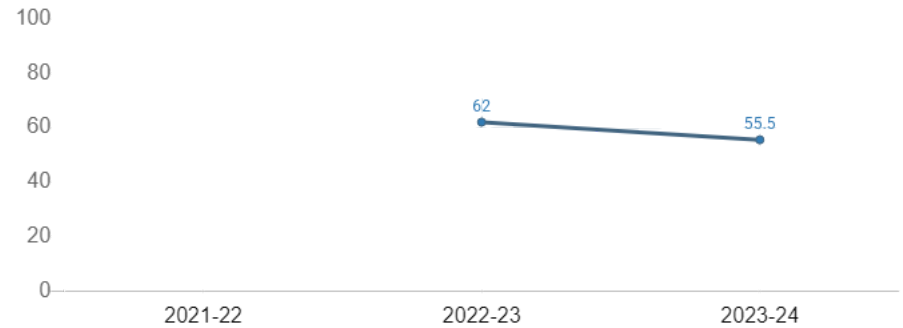

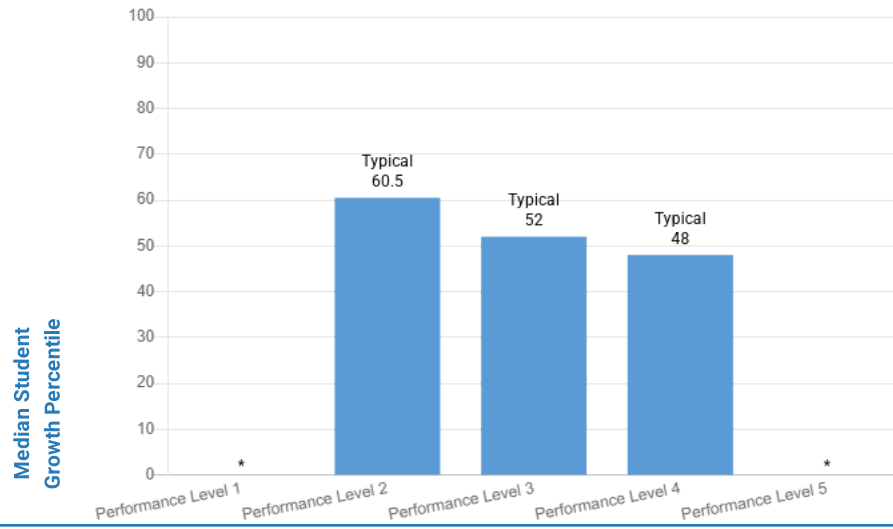

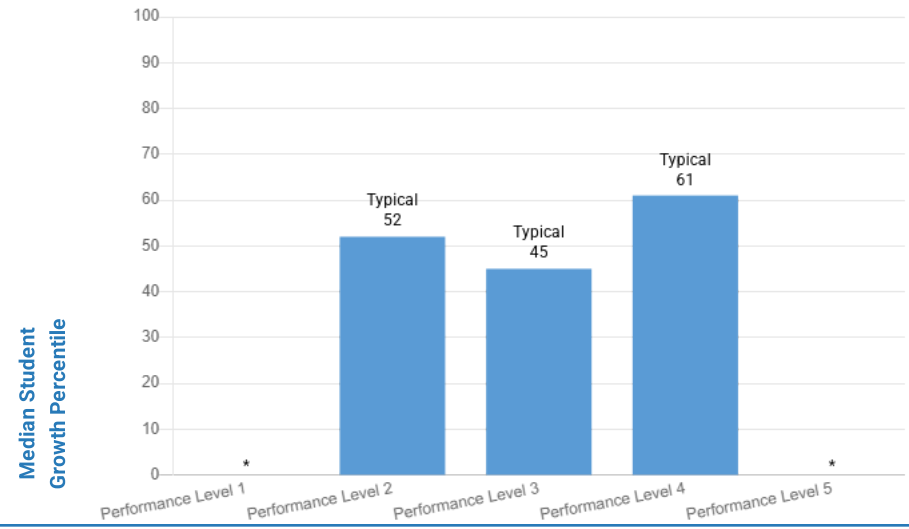

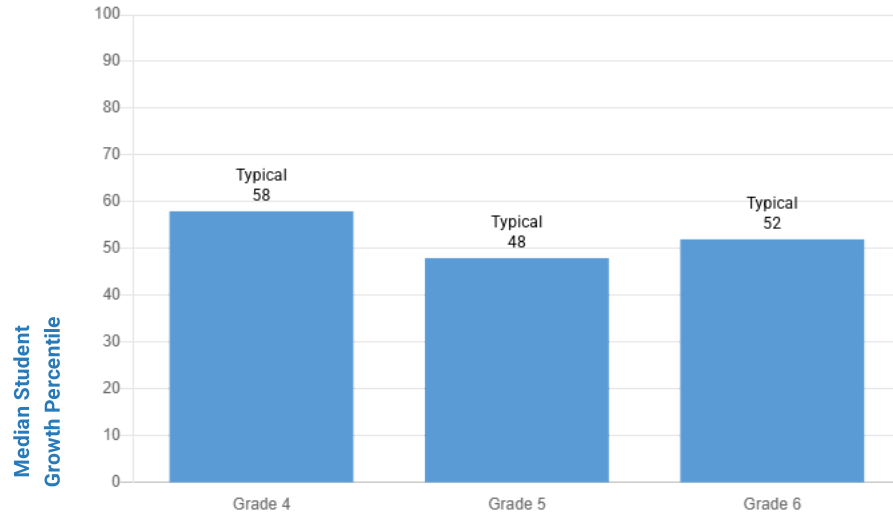

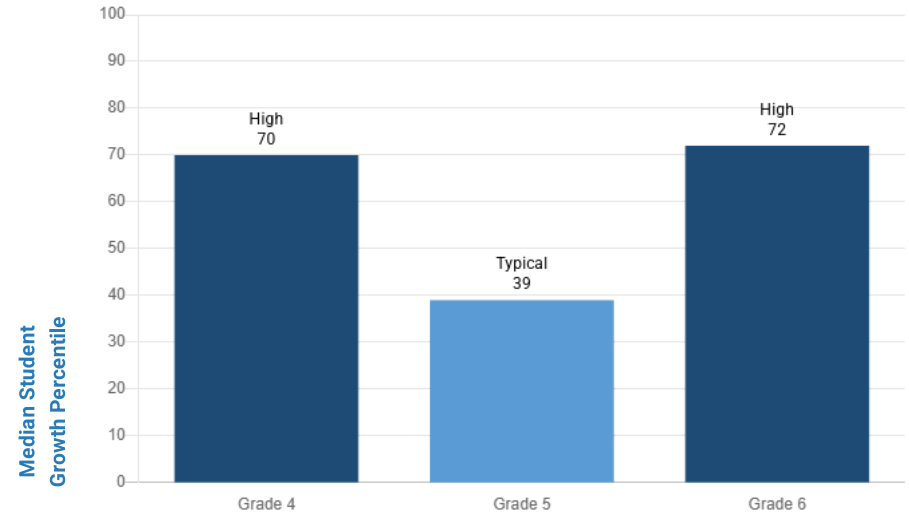

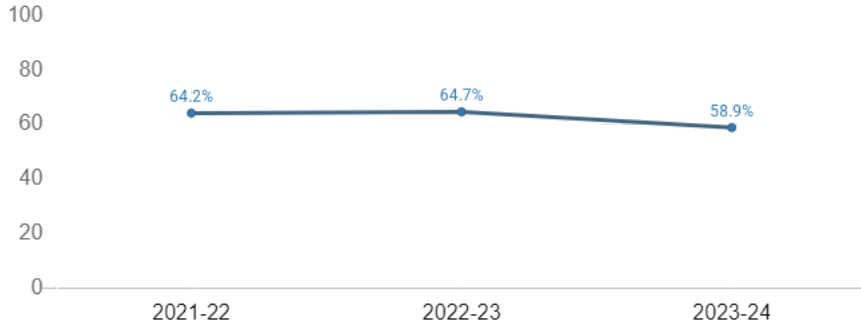

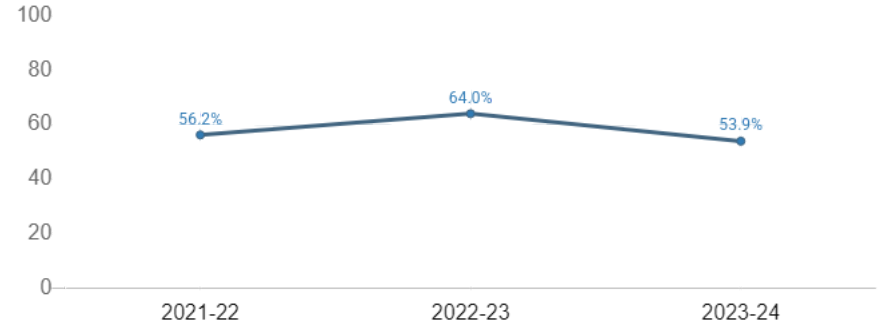
### English Language Arts and Mathematics Performance Trends

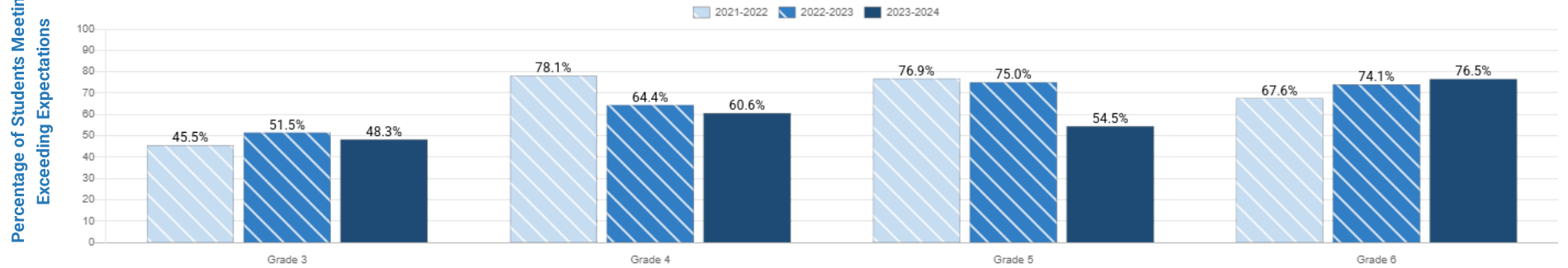

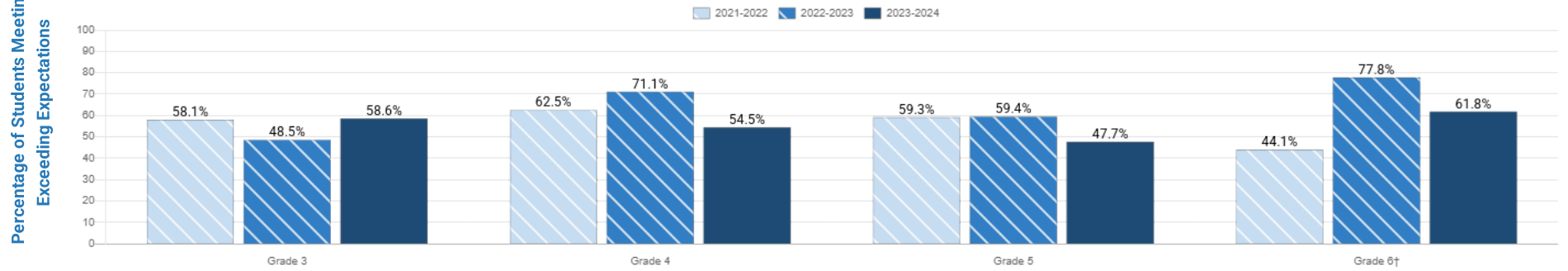

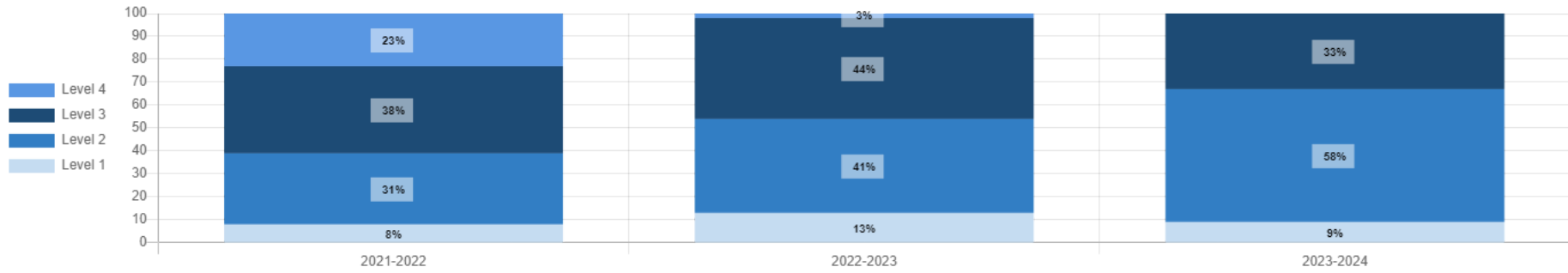

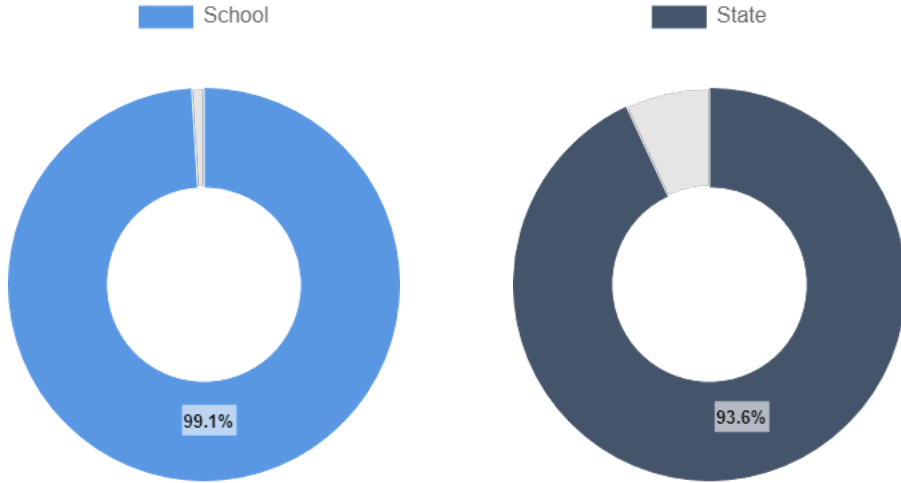

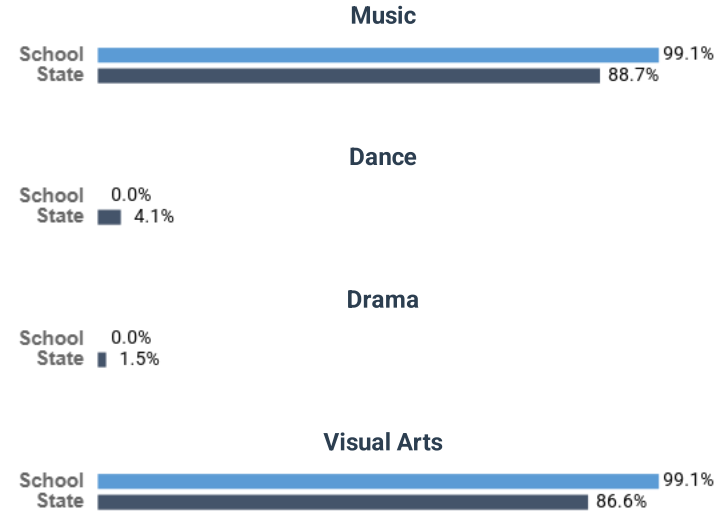

**Students enrolled in one or more classes by discipline:**



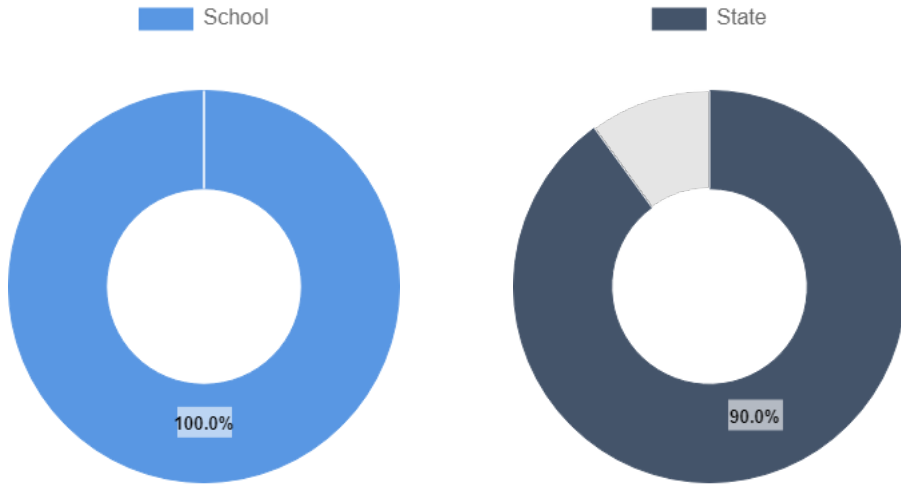

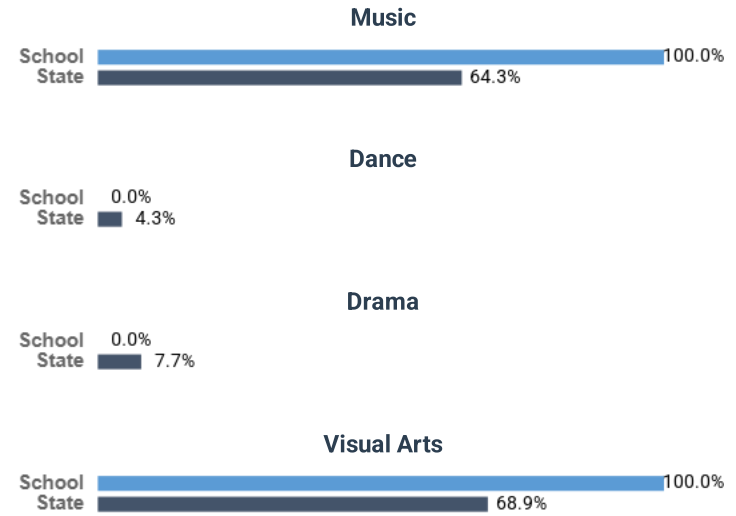

**Students enrolled in one or more classes by discipline:**



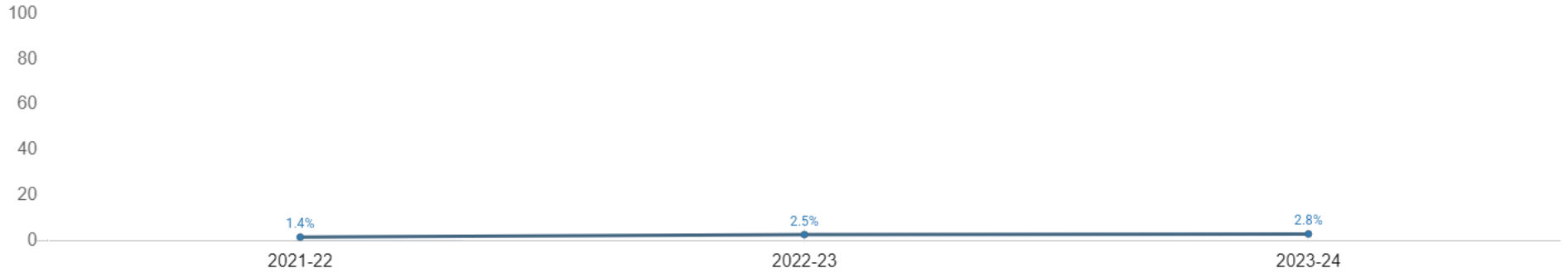

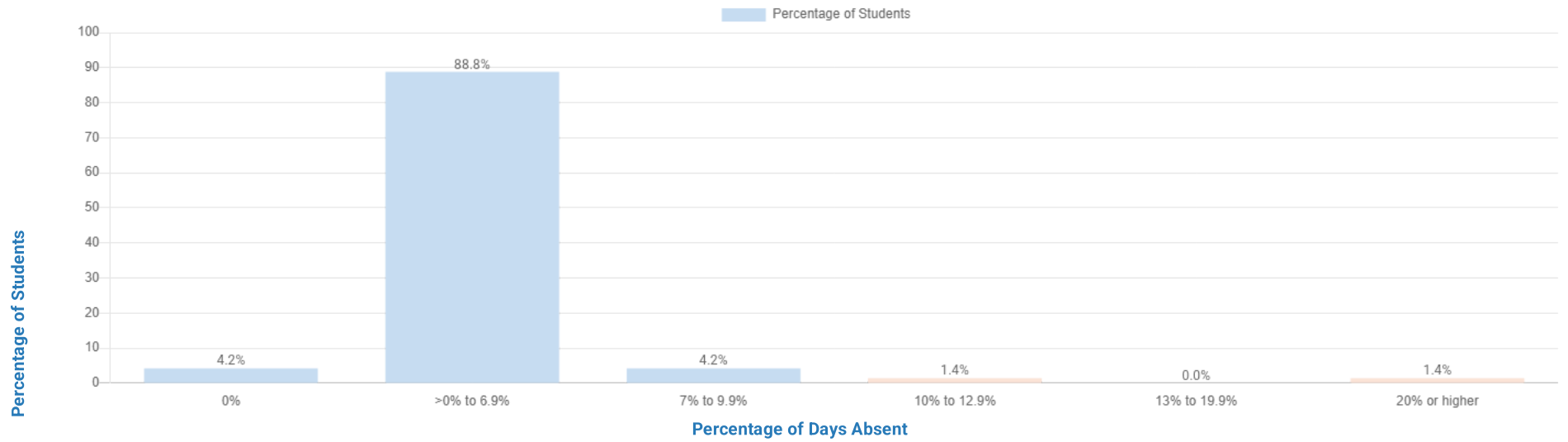

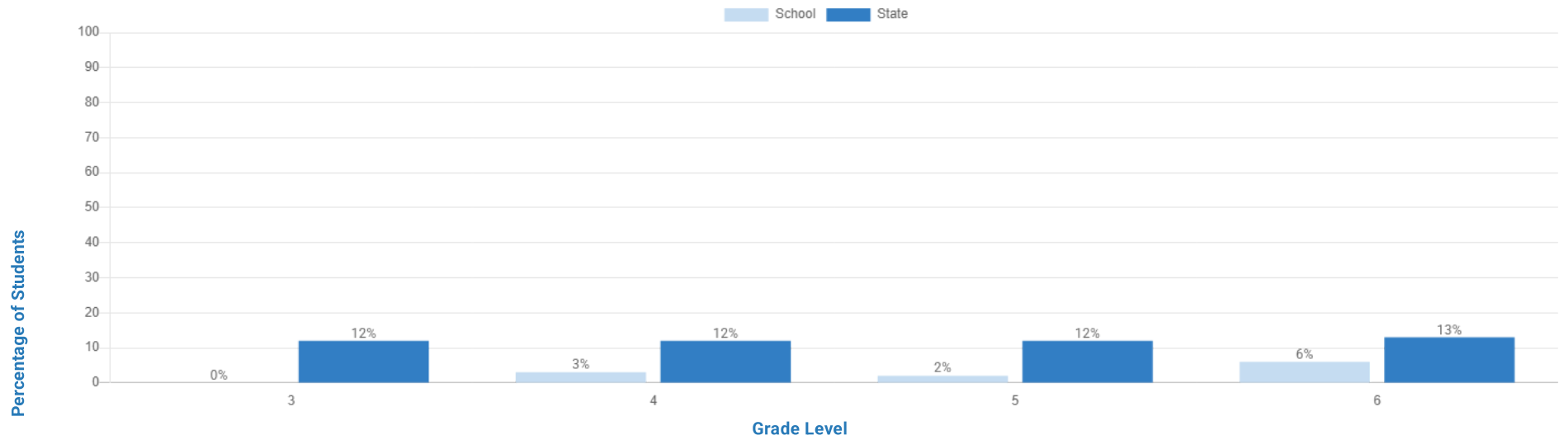

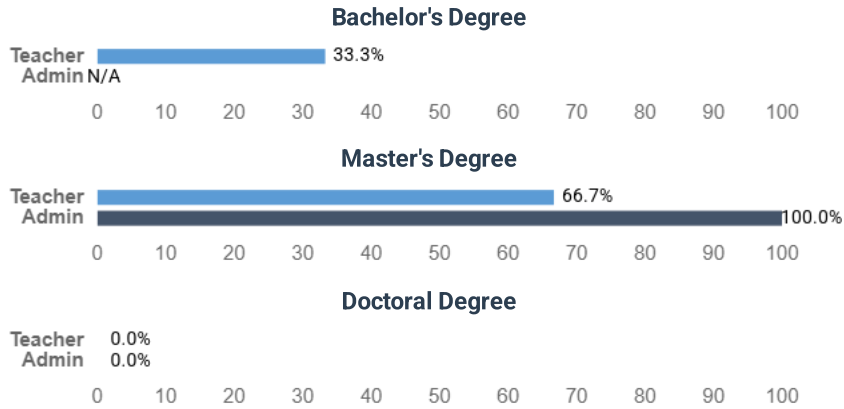

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Certified staff members assist students through individual and small group counseling, whole class lessons, an I&RS team, speech therapy, physical therapy, occupational therapy, RTI, and Child Study Team services. Classroom teachers use formal and informal data to structure lessons toward student needs. Summer tutoring in language arts and math is offered as well to our Tier 3 students.



### Student Health and Wellness:

Our students receive physical education on a rotating basis. Our school nurses communicate proactively and provide resources for families. We allow for flexible seating, including yoga balls and standing desks. Teachers utilize brain breaks where movement and dance are used.
