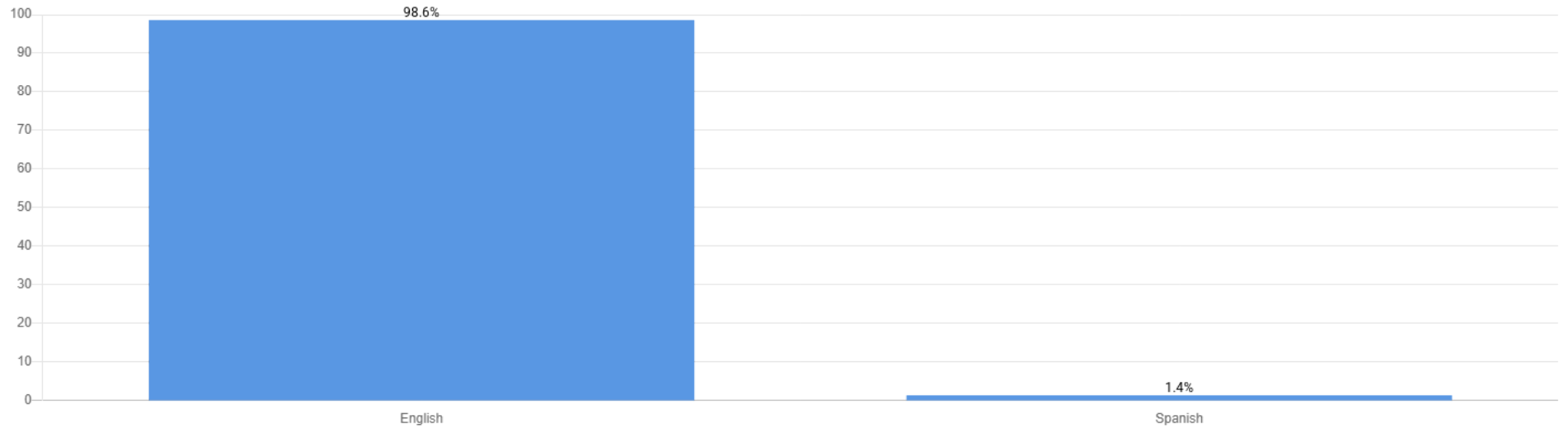

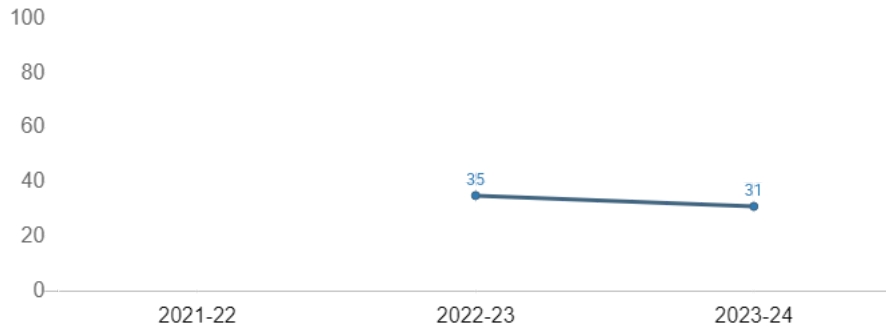

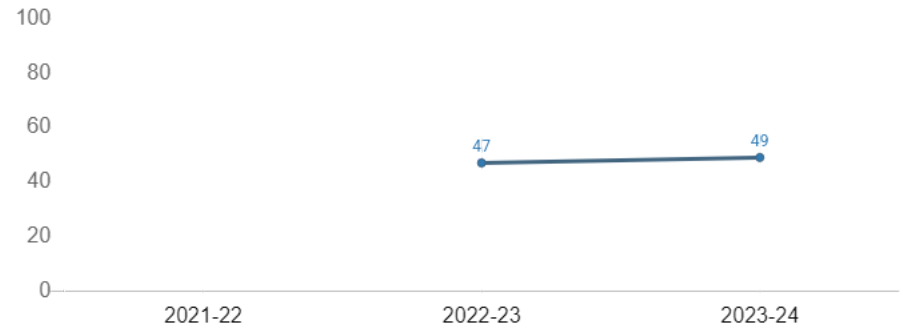

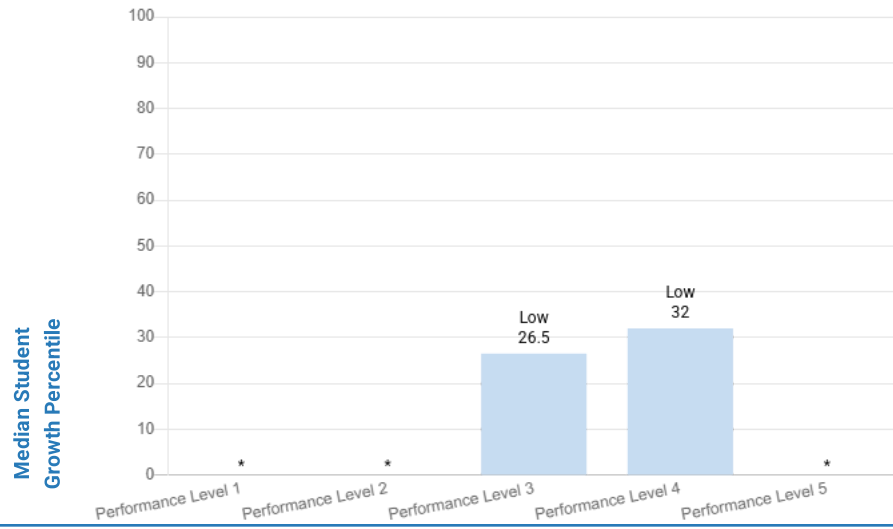

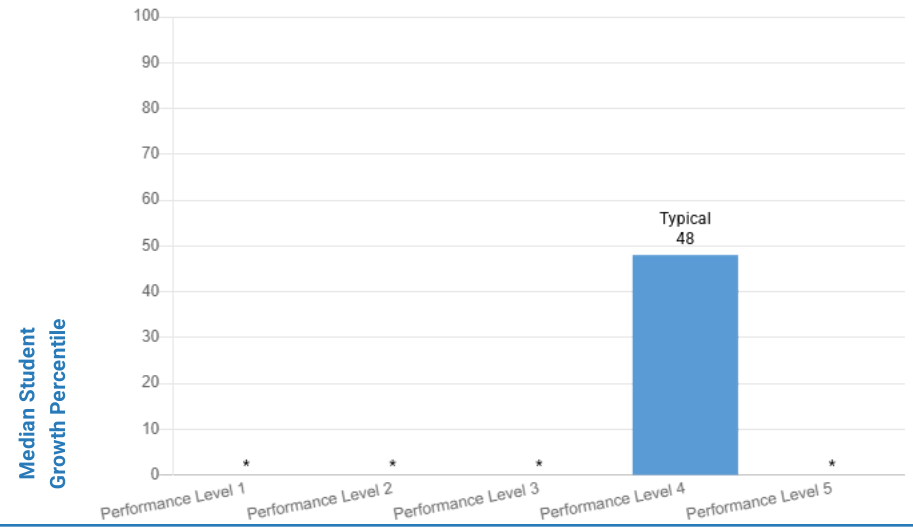

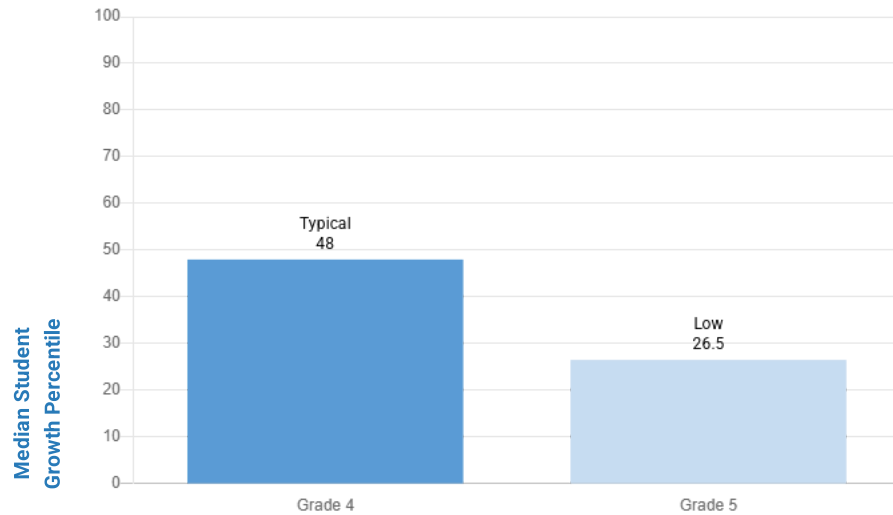

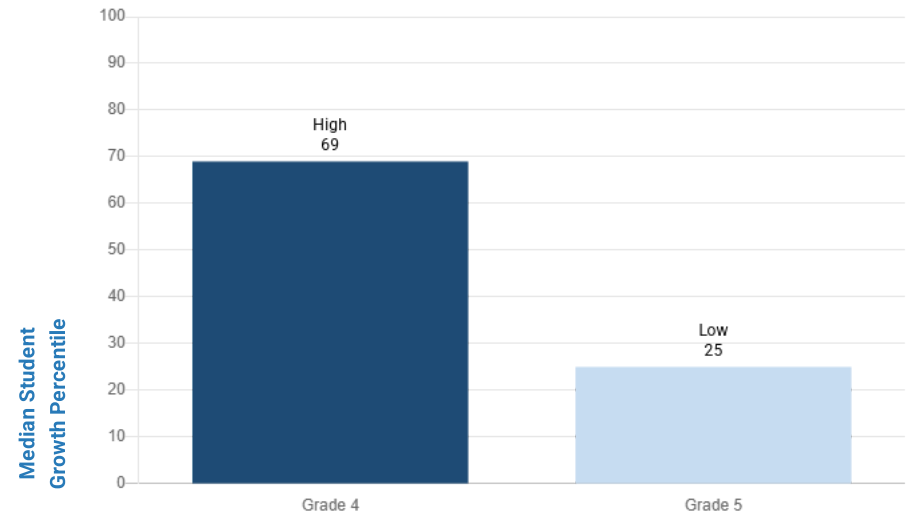

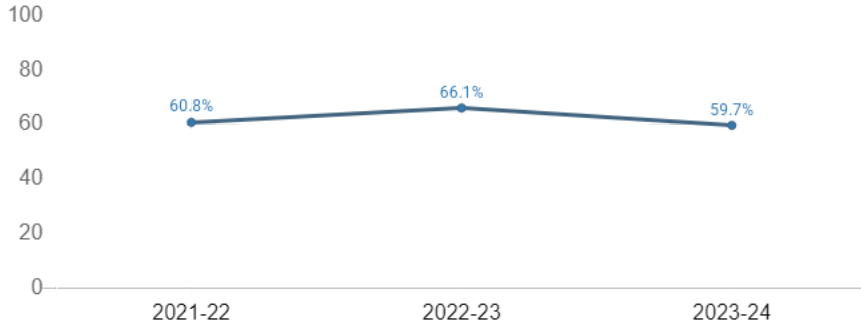

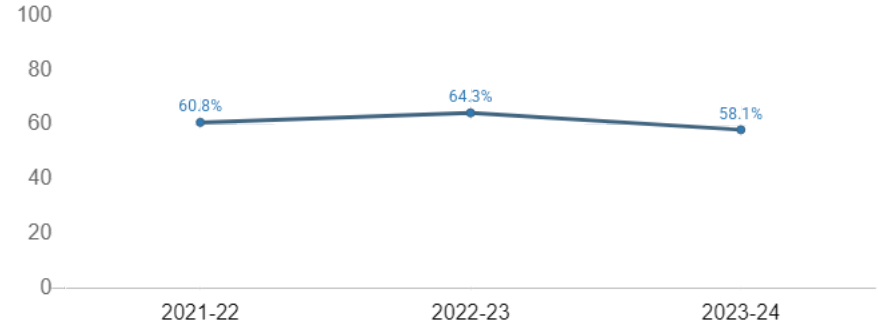
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 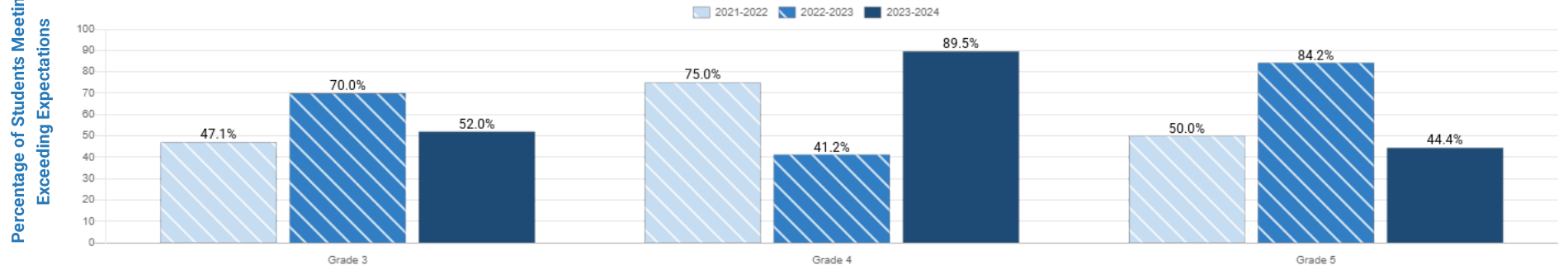

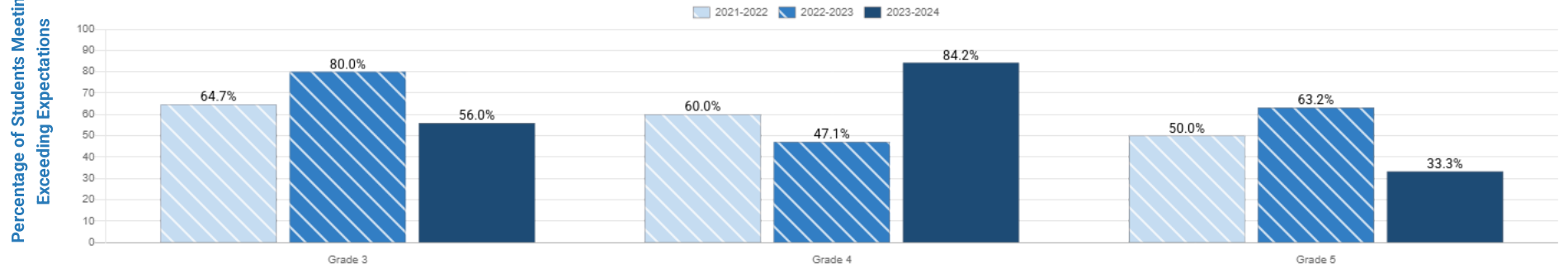

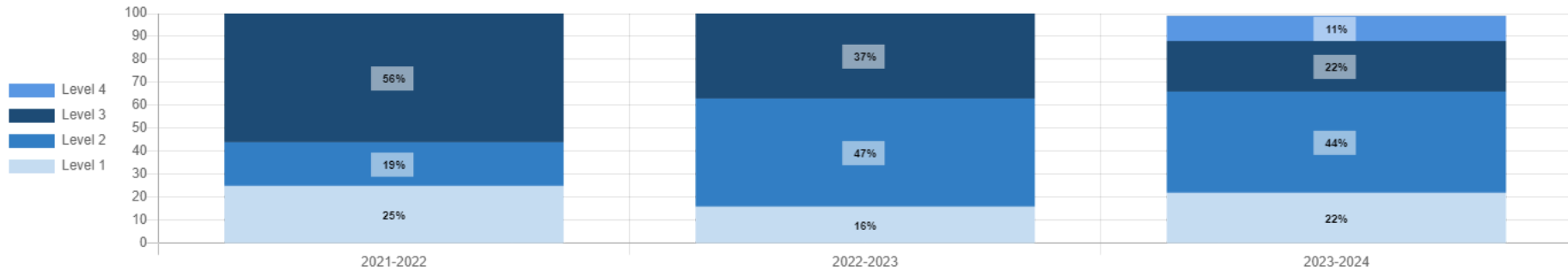

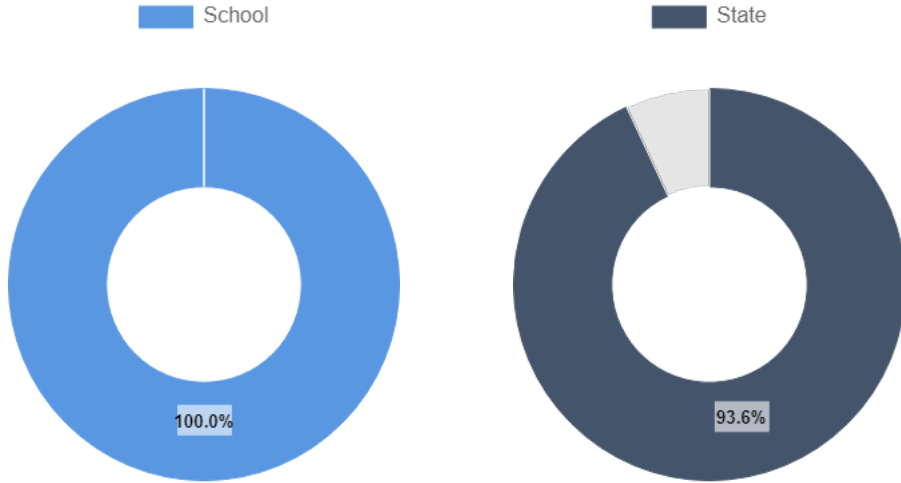

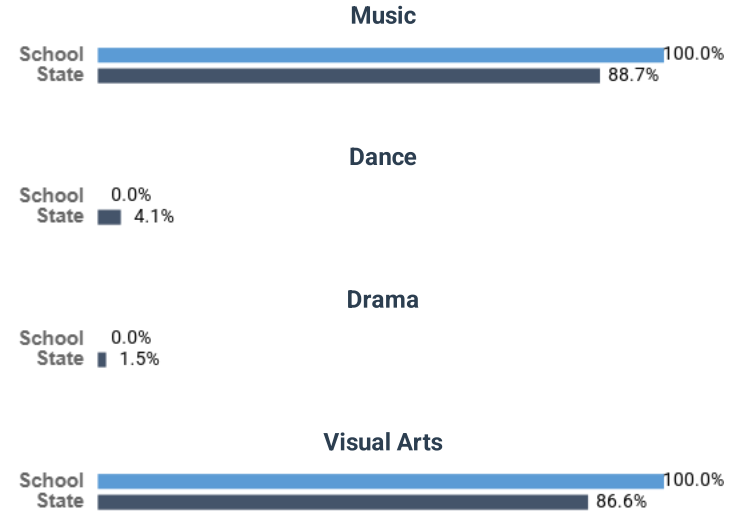

Students enrolled in one or more classes by discipline:



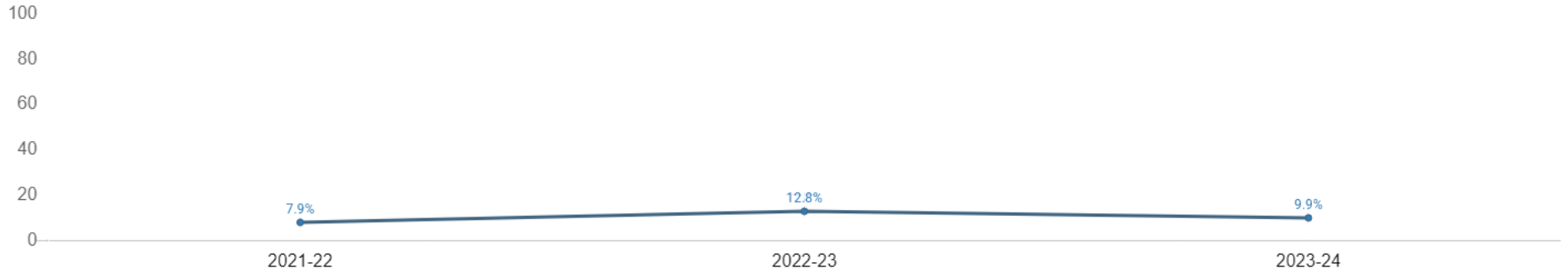

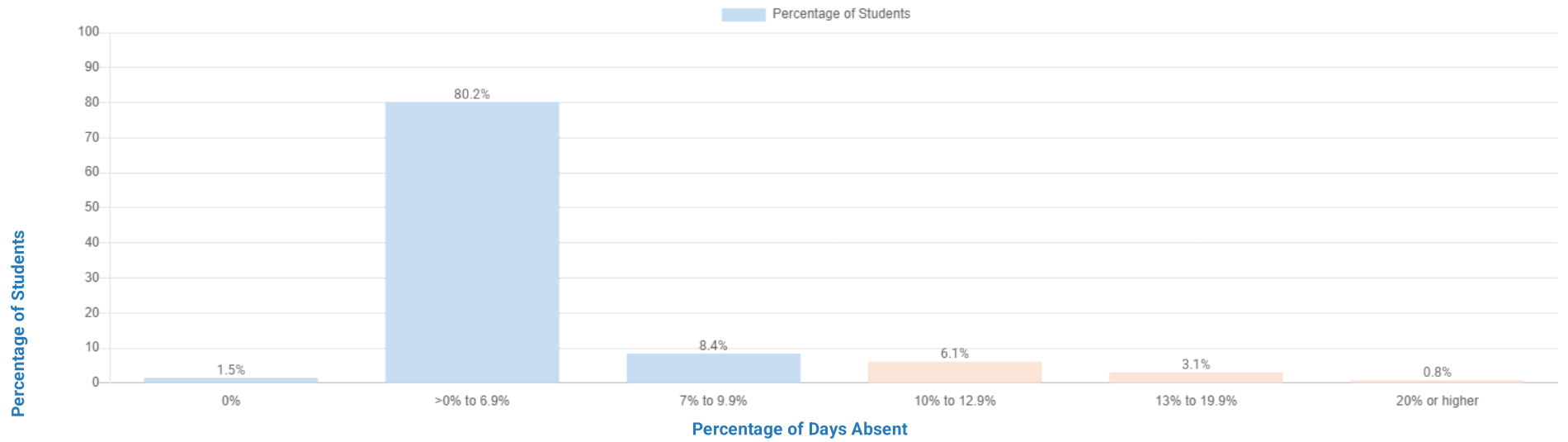

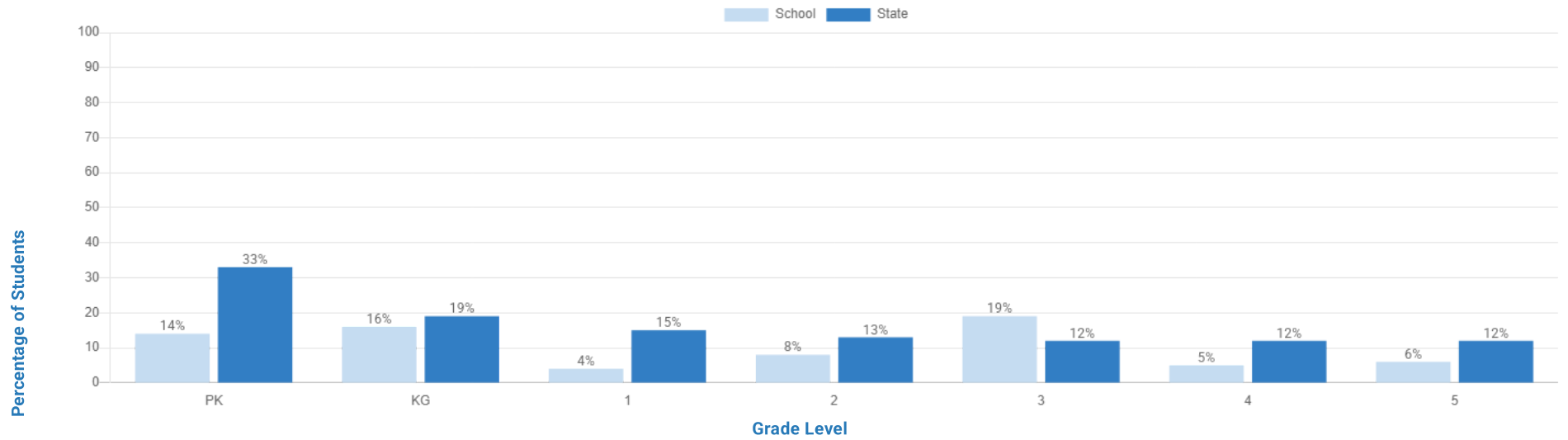

Staff

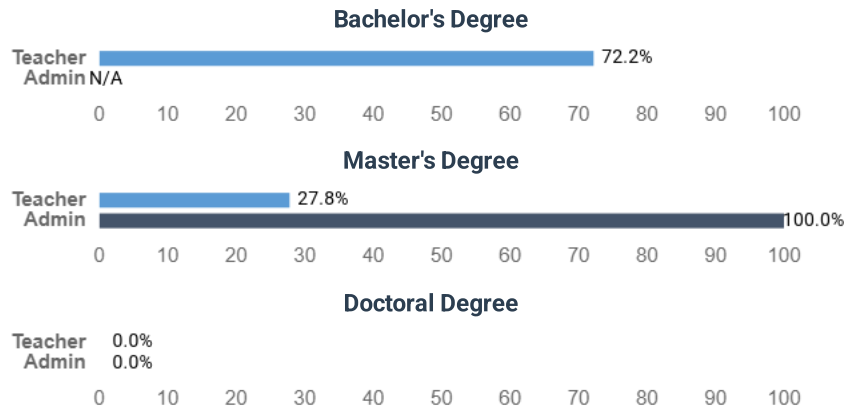

Accountability Summary by Student Group - 2023-24 School Year

We provide a rich variety of supports to target the unique needs of our diverse learners. Leveled Literacy Intervention is provided in grades K-5 for those struggling to acquire literacy skills. Non-English speaking students work daily with a specially certified teacher. A continuum of services is also provided to our students with special needs including Occupational Therapy, Physical Therapy, Speech Therapy, counseling and behavior support.
